DESCRIPTION

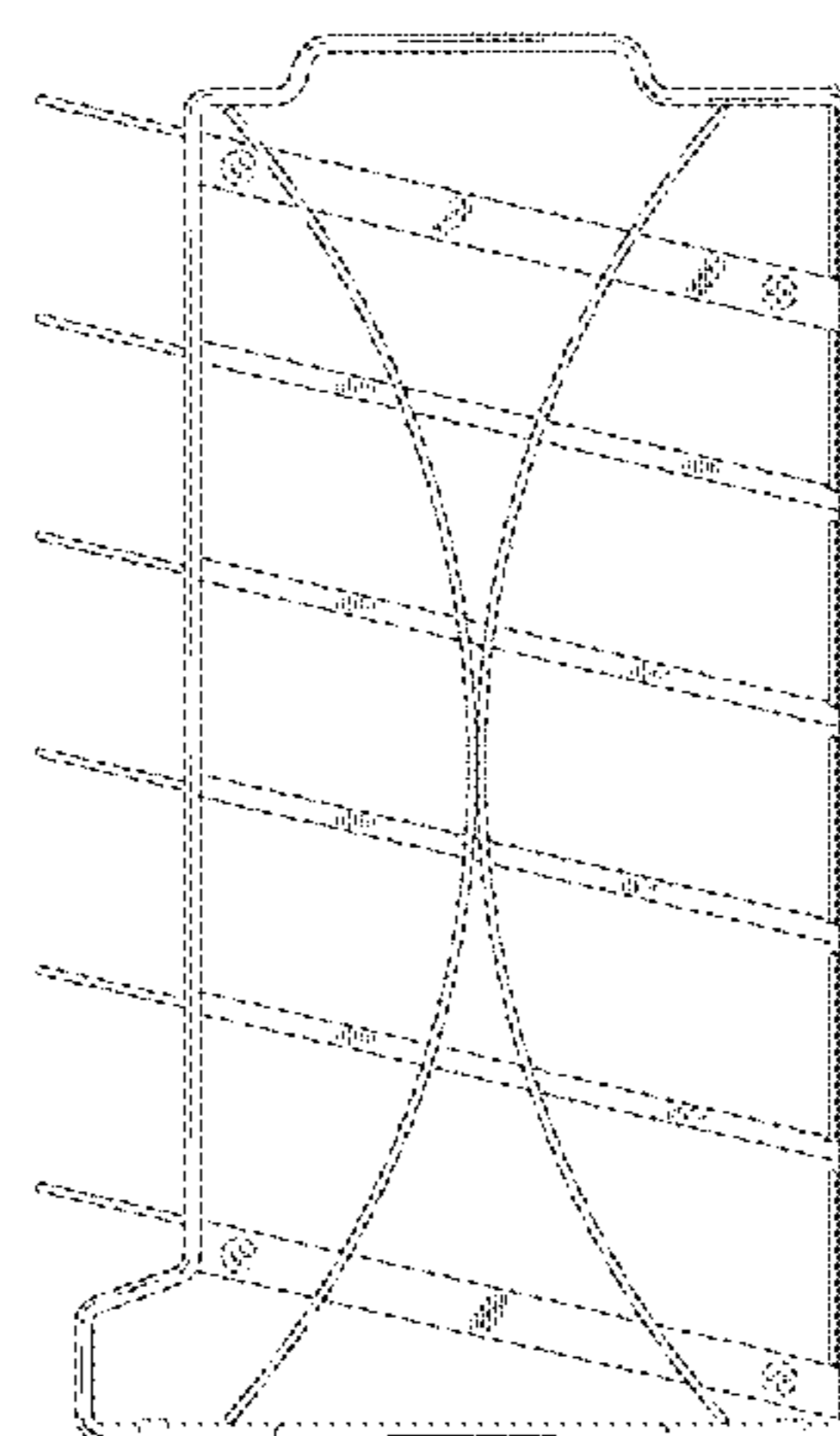
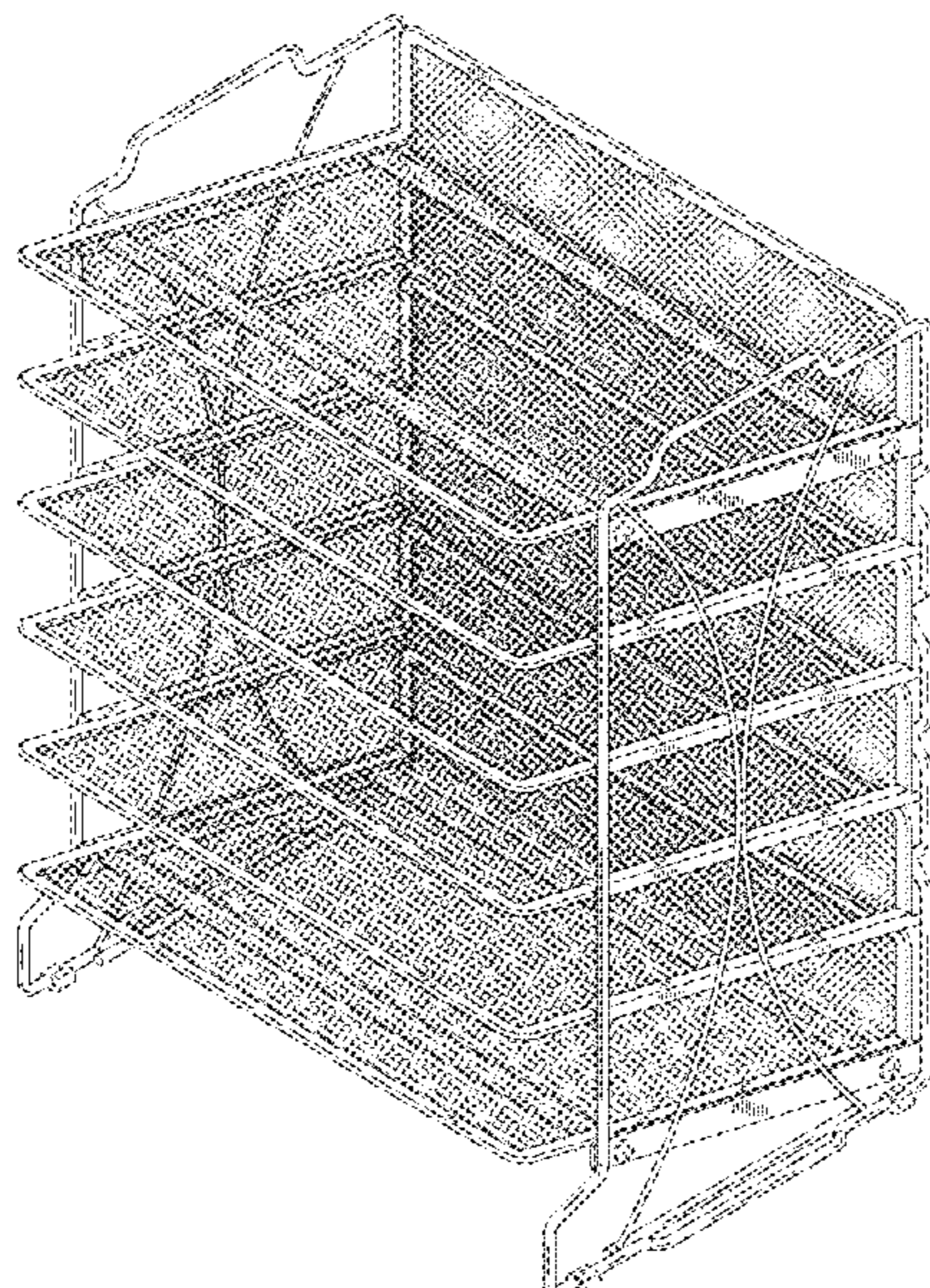
FIG. 1 is a perspective view of a desk organizer, showing the new design;

FIG. 7 is a bottom plan view thereof.
The broken lines showing the feet, cross-head screws and all the mesh are included to show portions of the desk organizer that form no part of the claimed design.

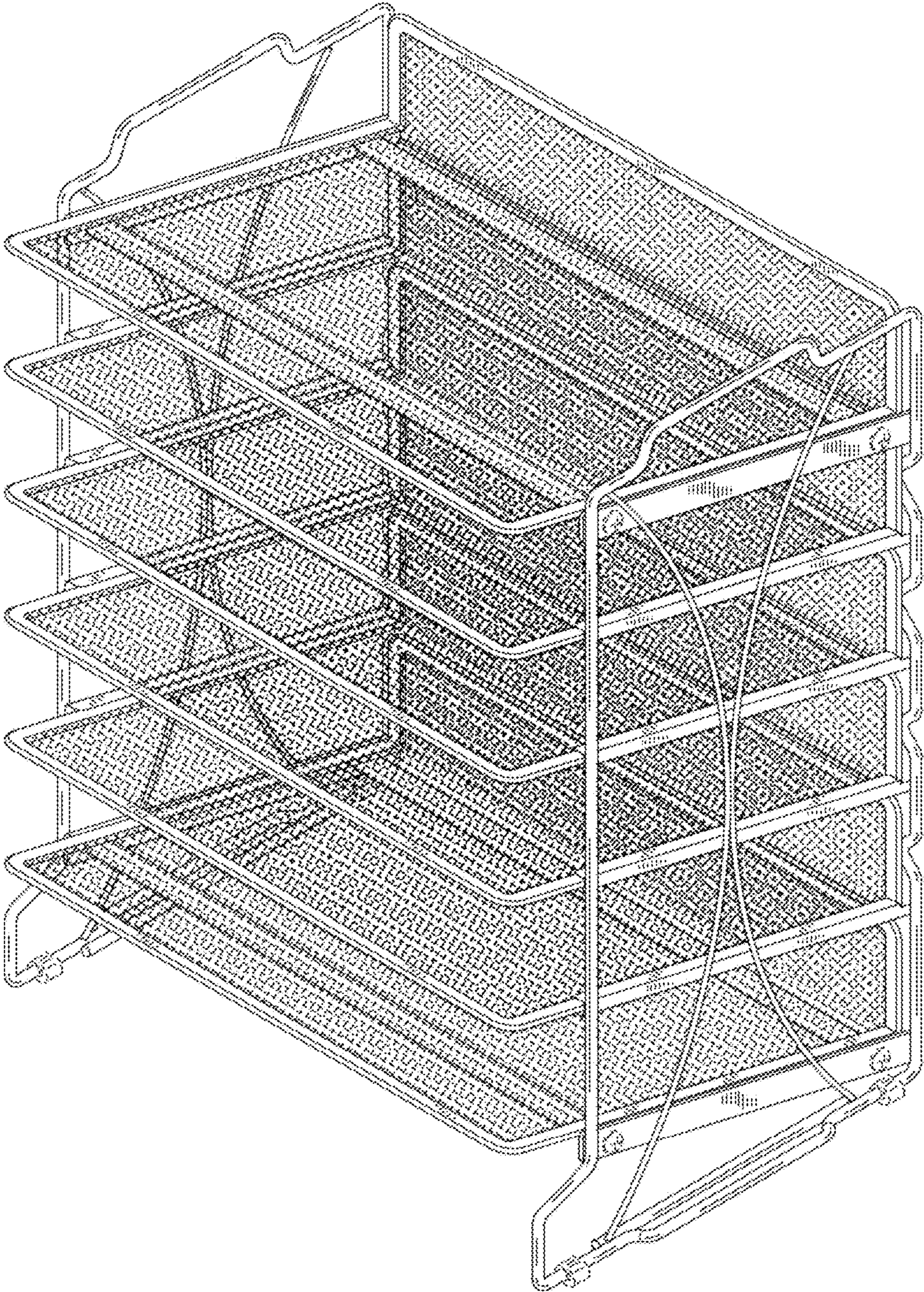

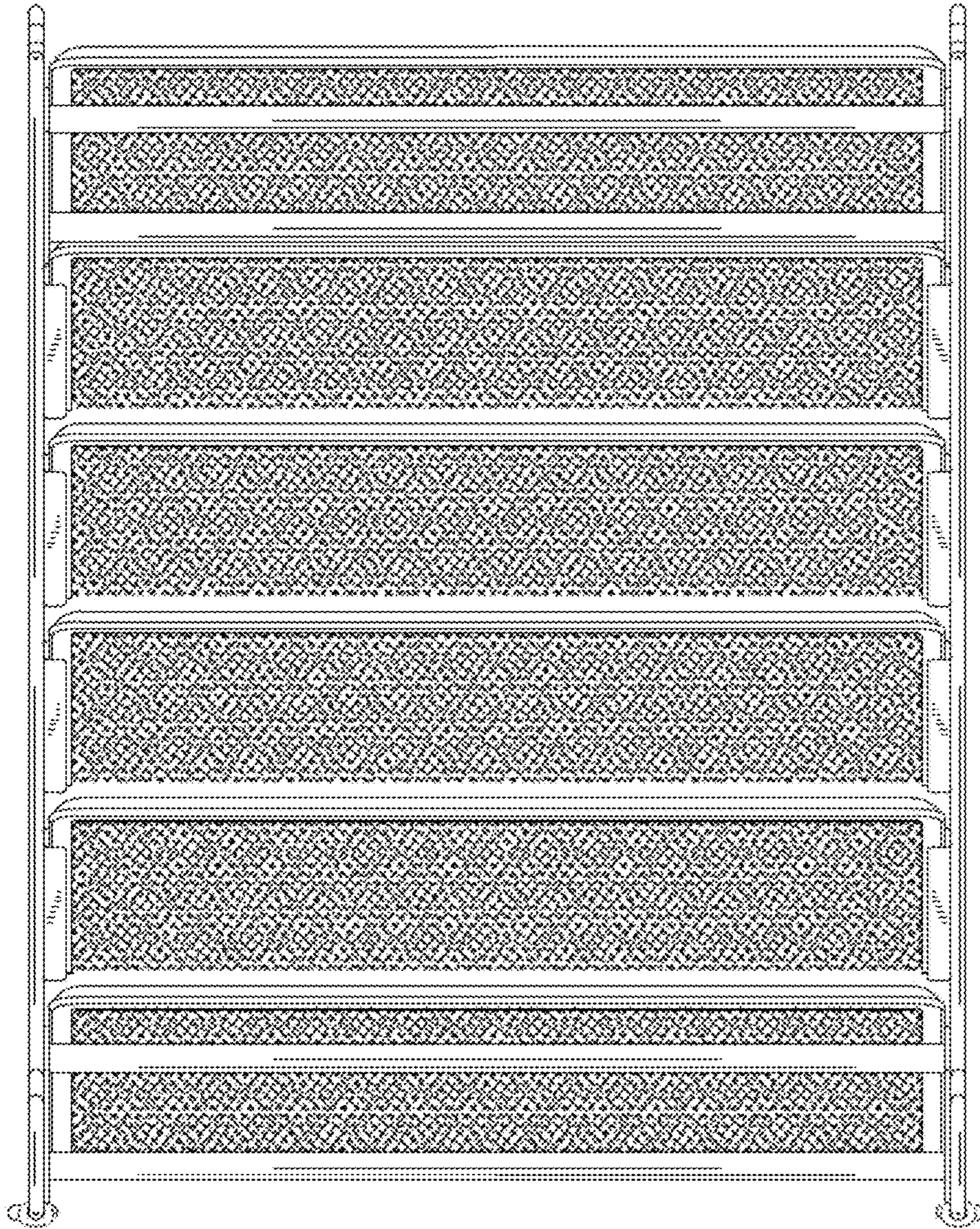

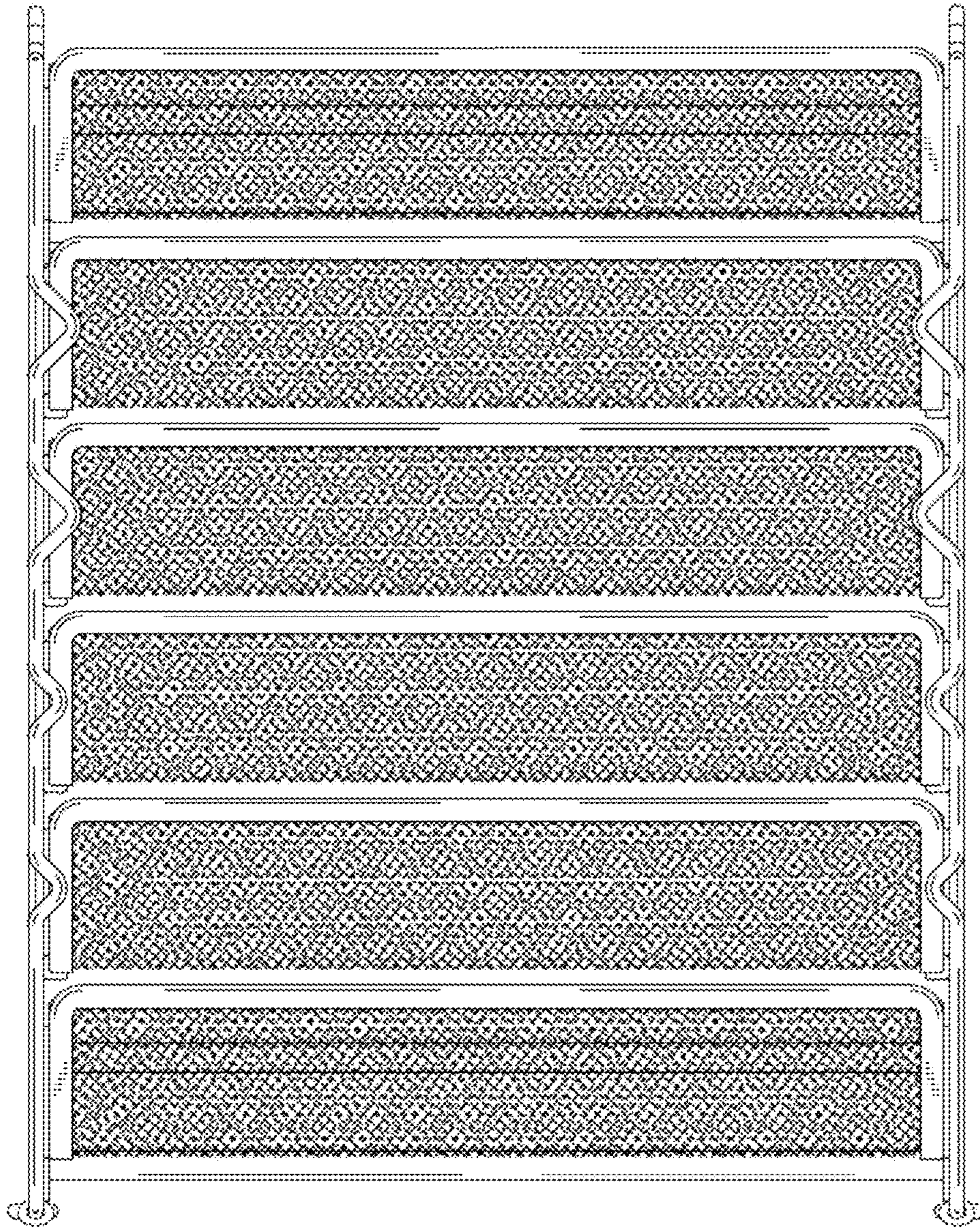

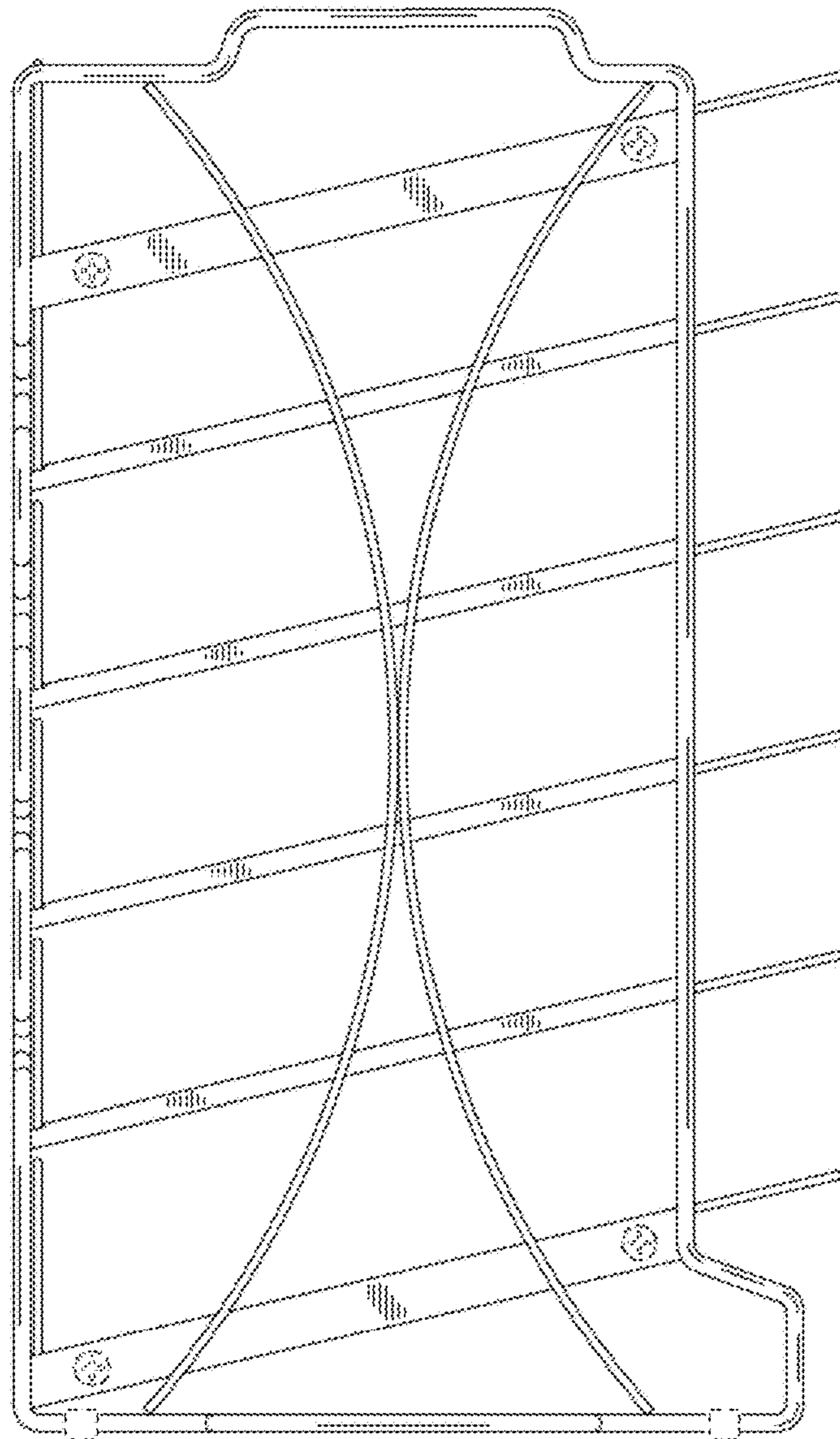

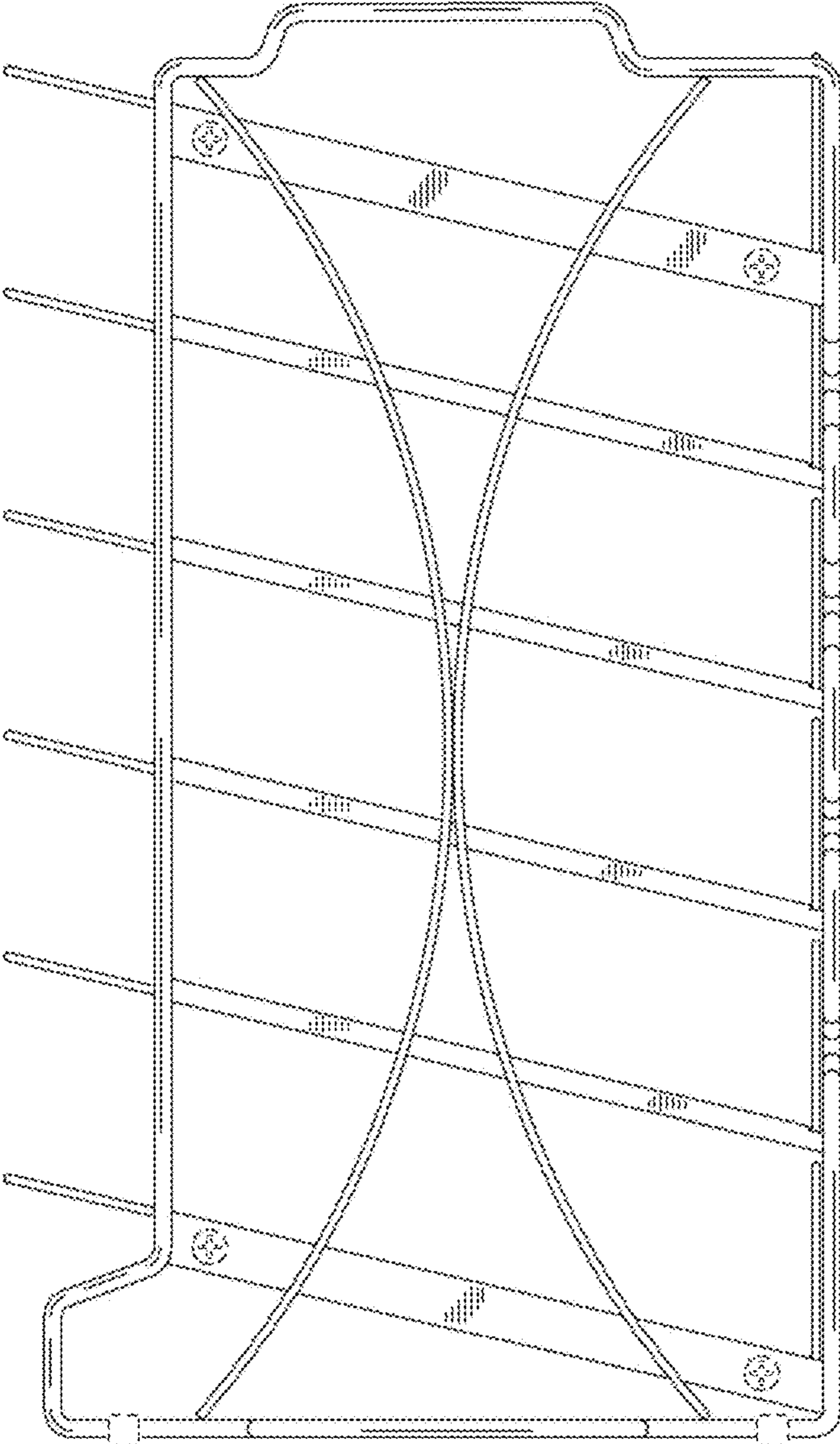

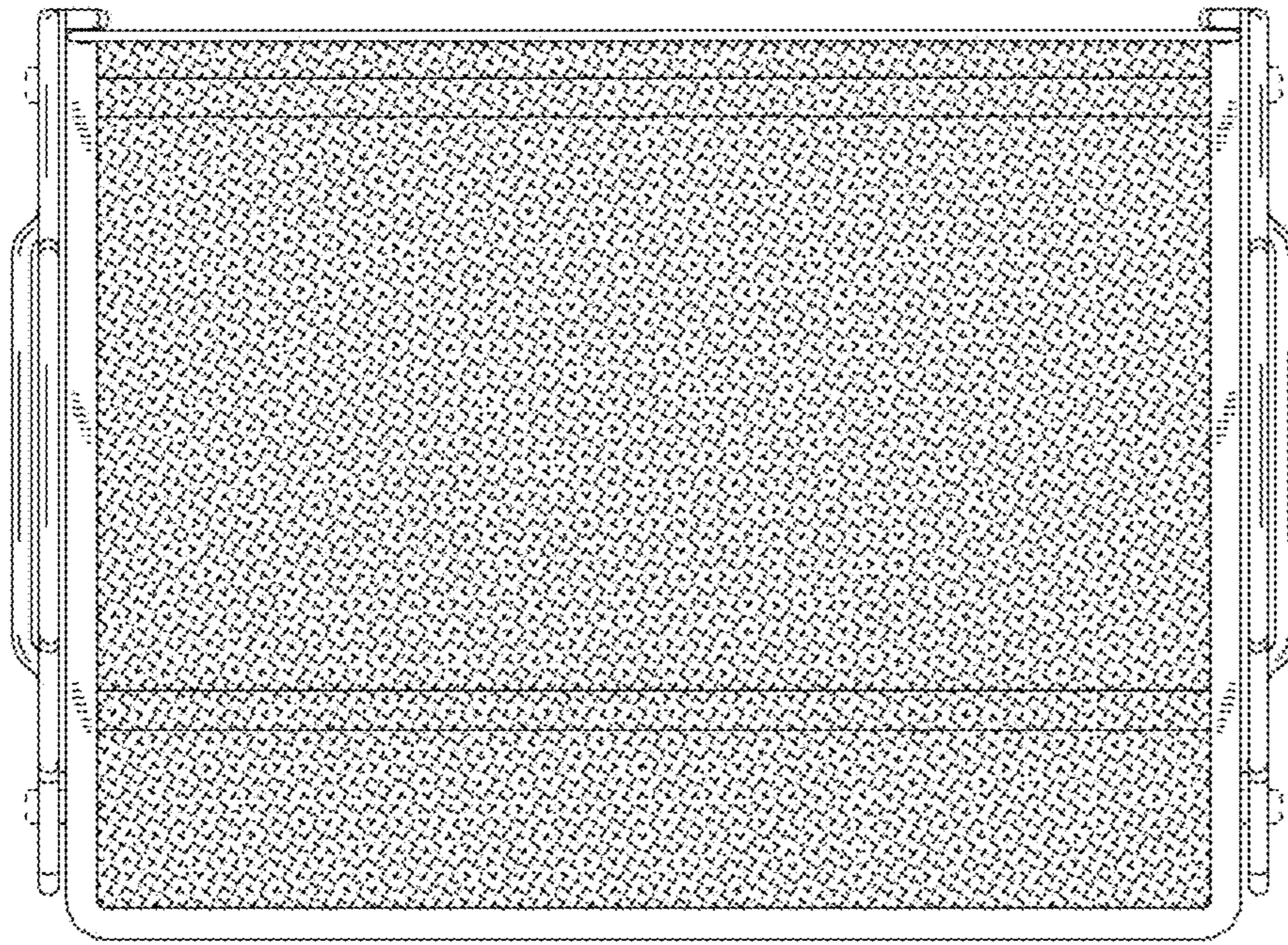

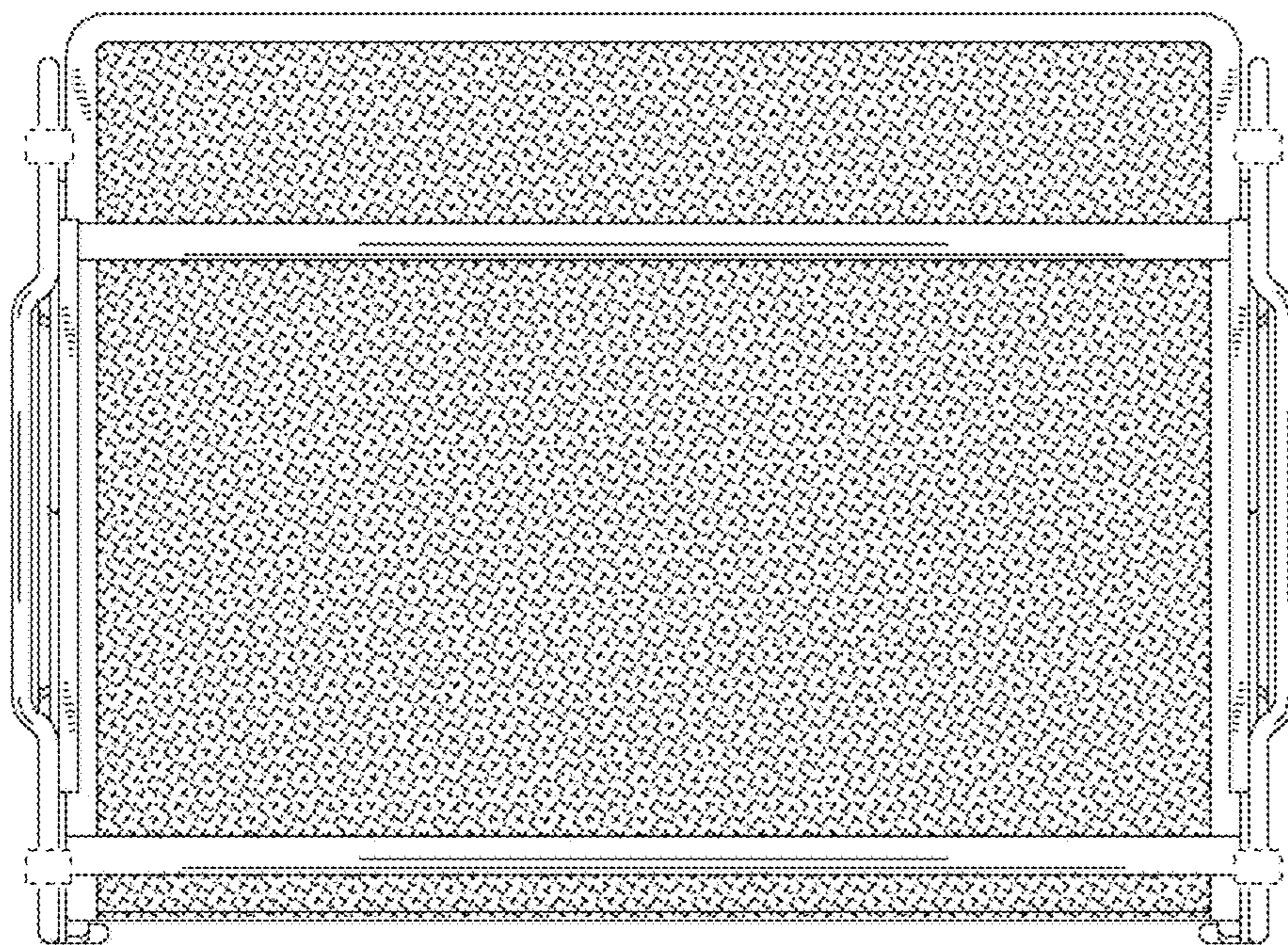
