DESCRIPTION

FIG. 1 is a front left perspective view of a marker showing my new design.

FIG. 4 is a right side elevation view thereof, with the left side elevation view being a mirror image of the right side elevation view.

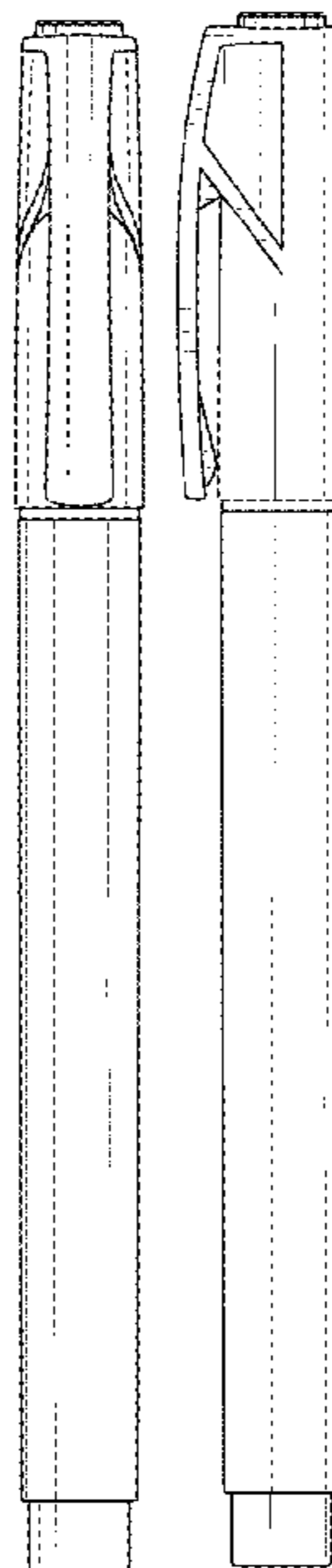
FIG. 5 is a top plan view thereof.

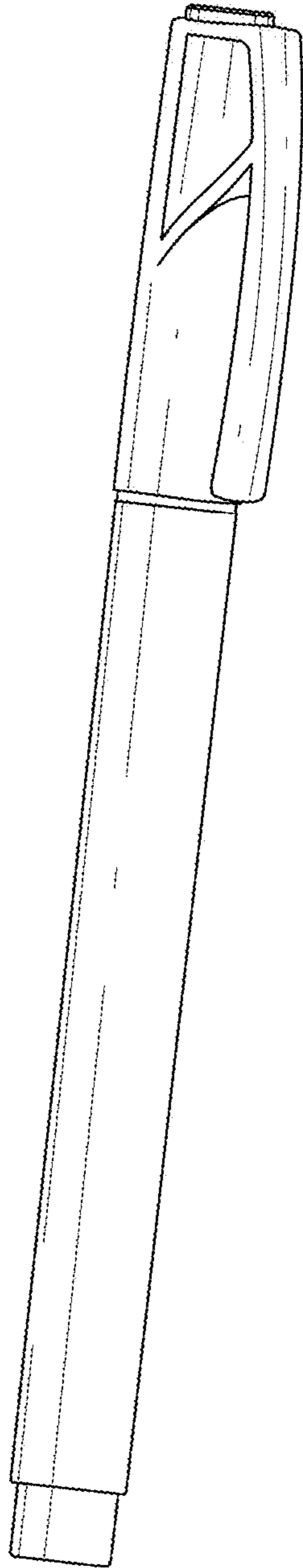

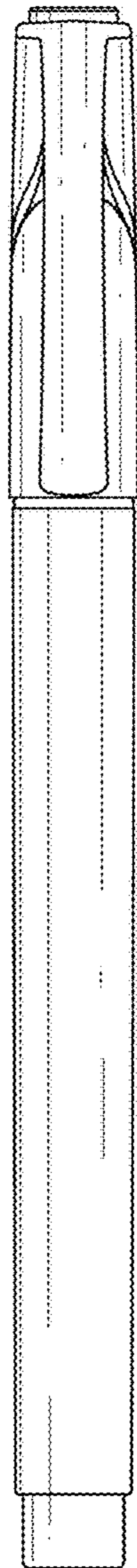

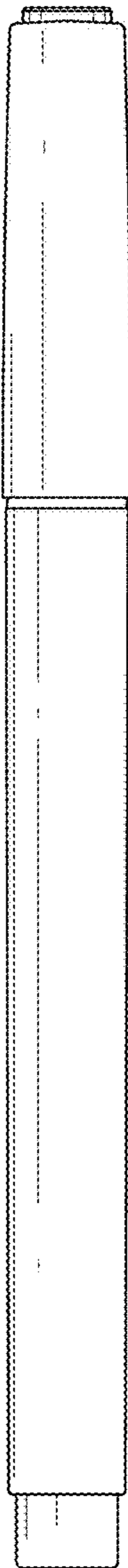

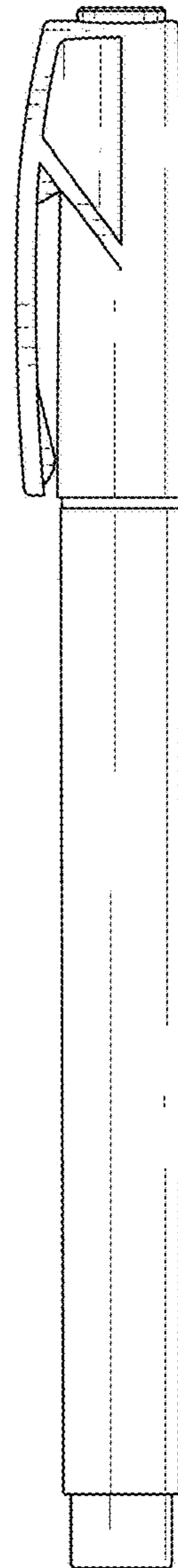

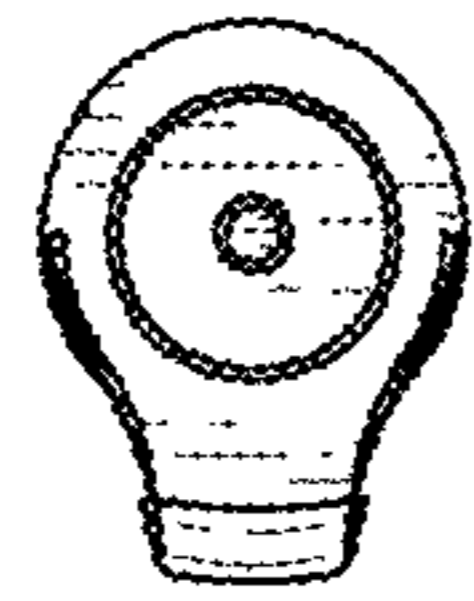

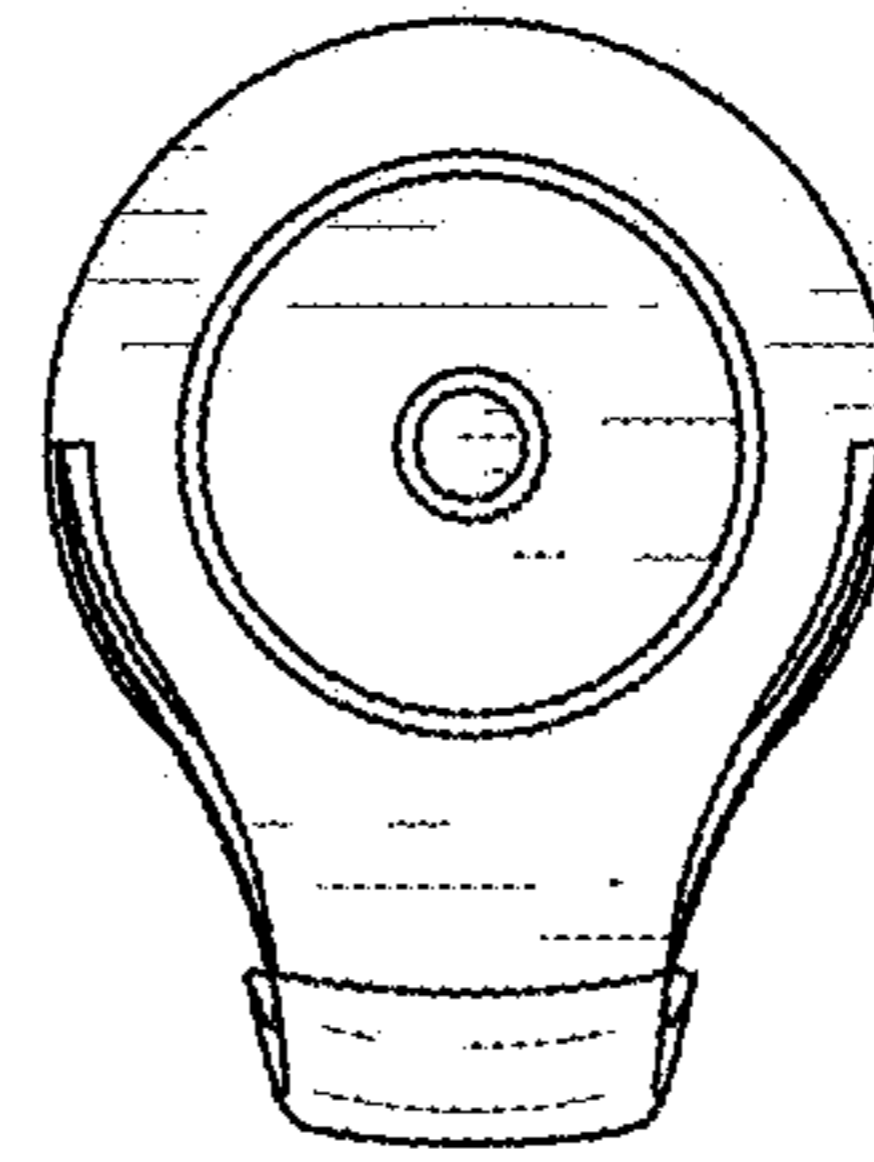

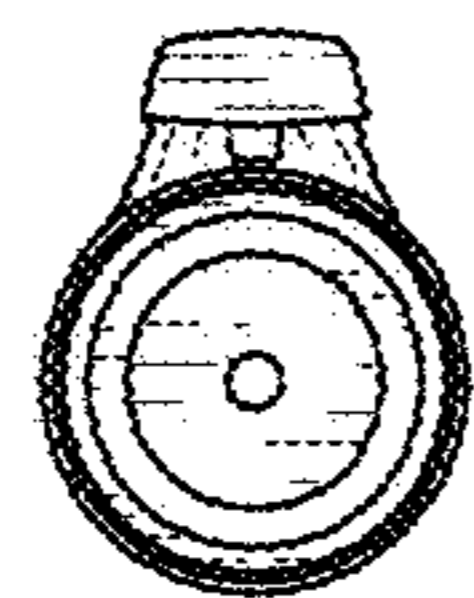

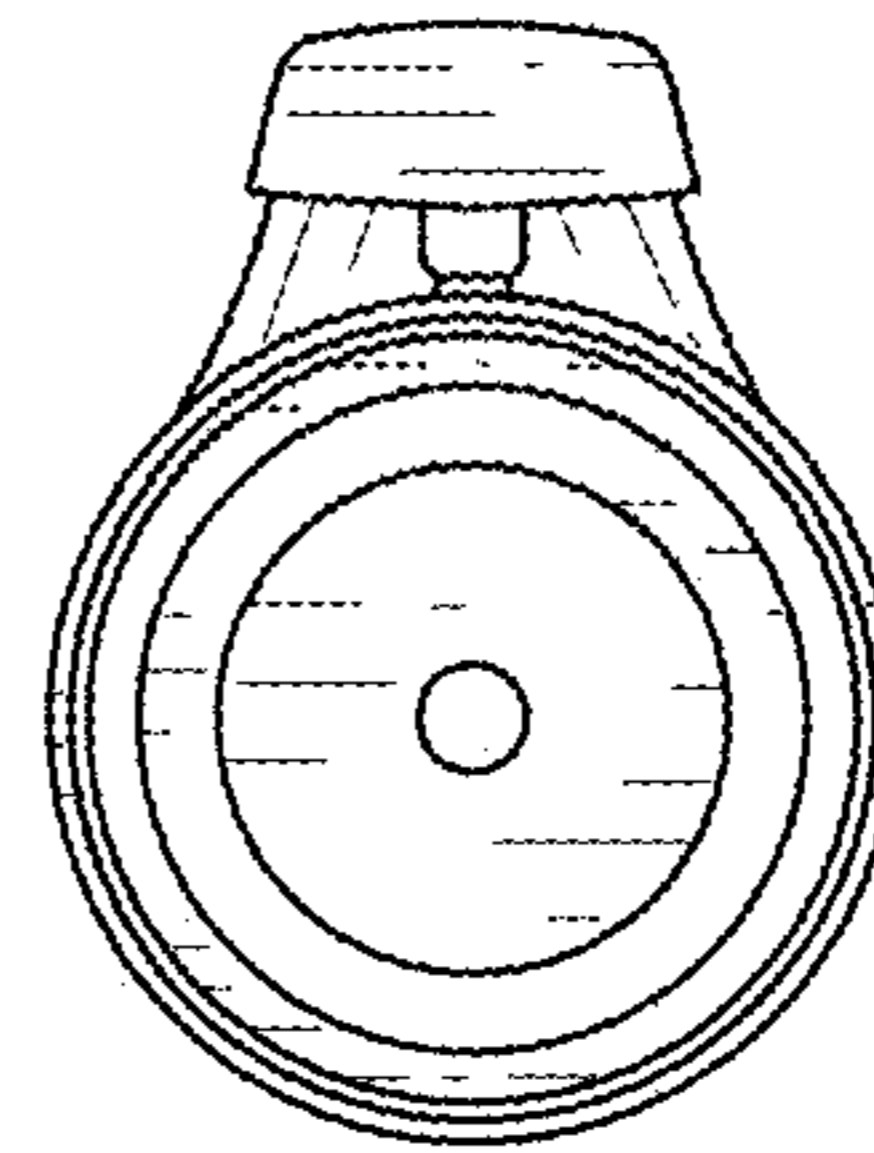
