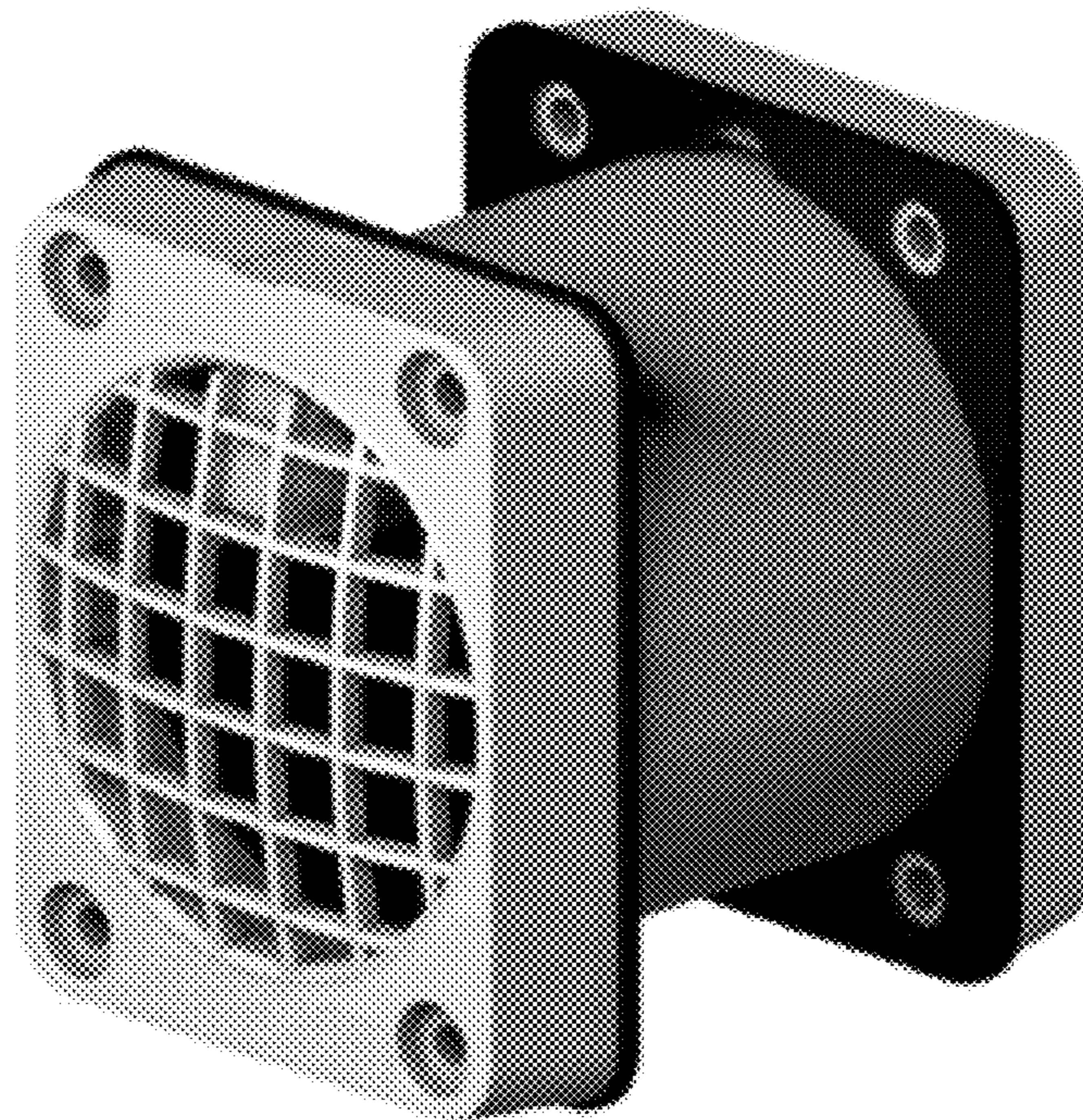
(57) **CLAIM**

The ornamental design for a pressure equalization valve for a cold room, as shown and described.

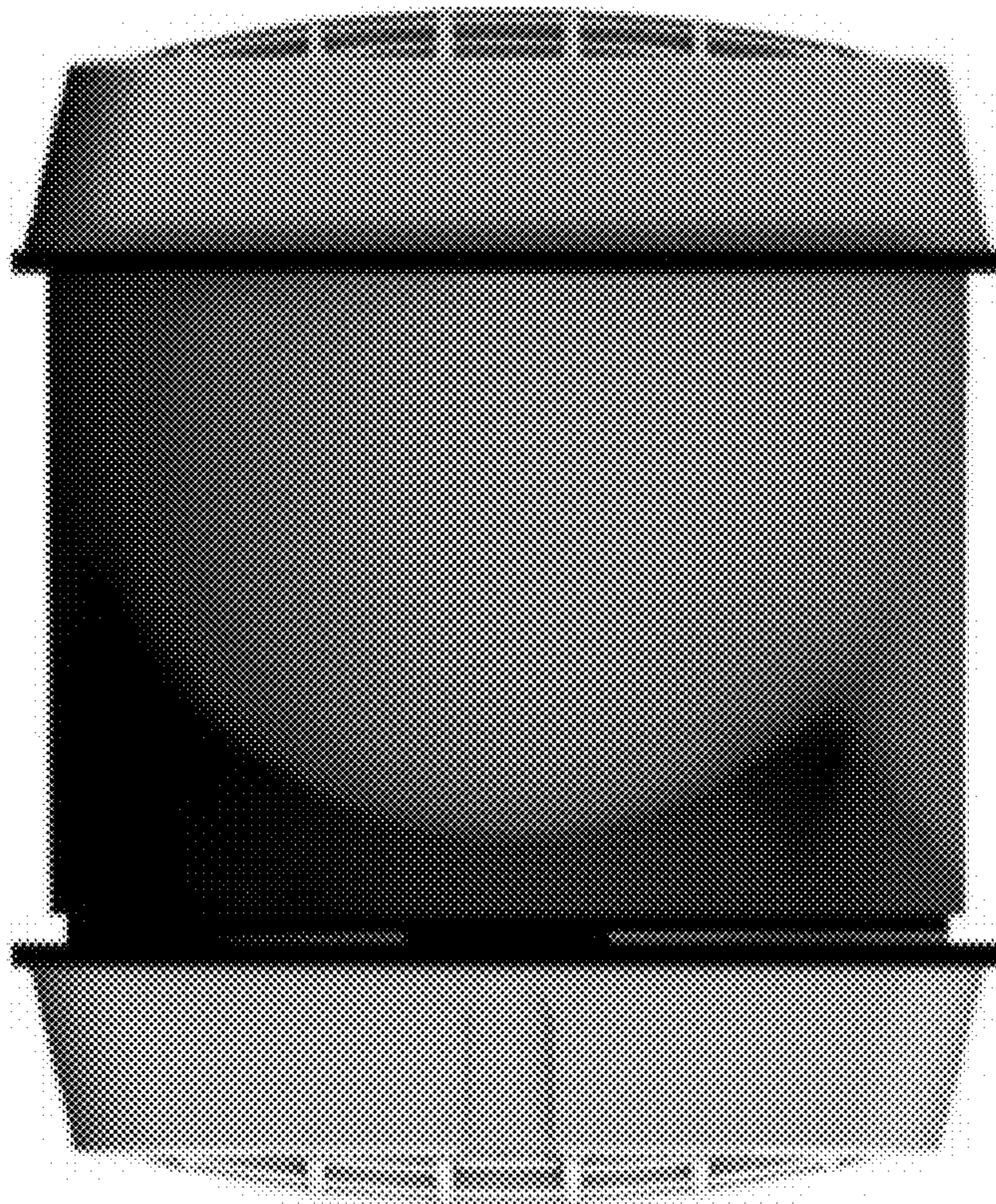
**DESCRIPTION**

FIG. 1.4 is a front elevation view thereof.

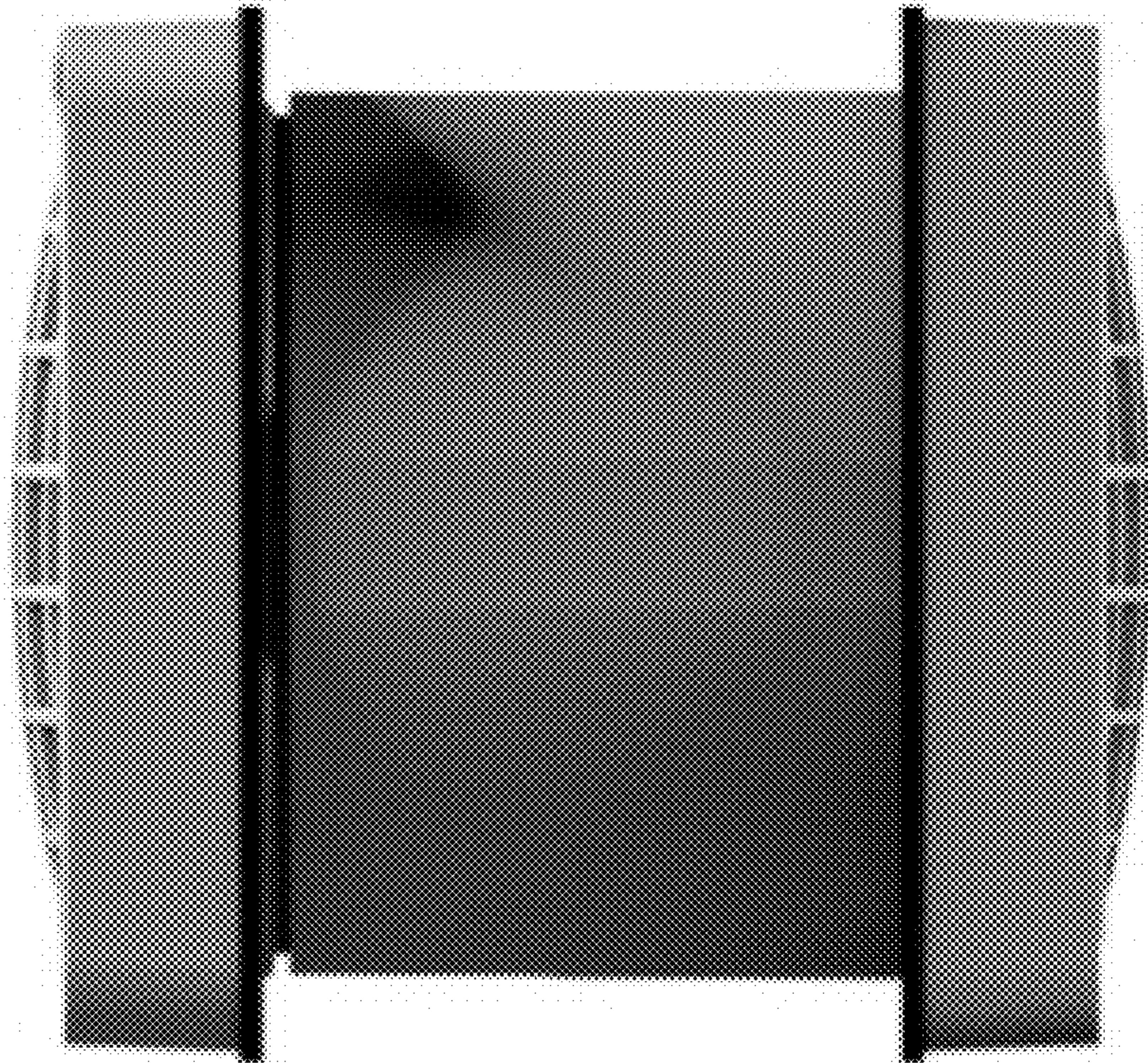

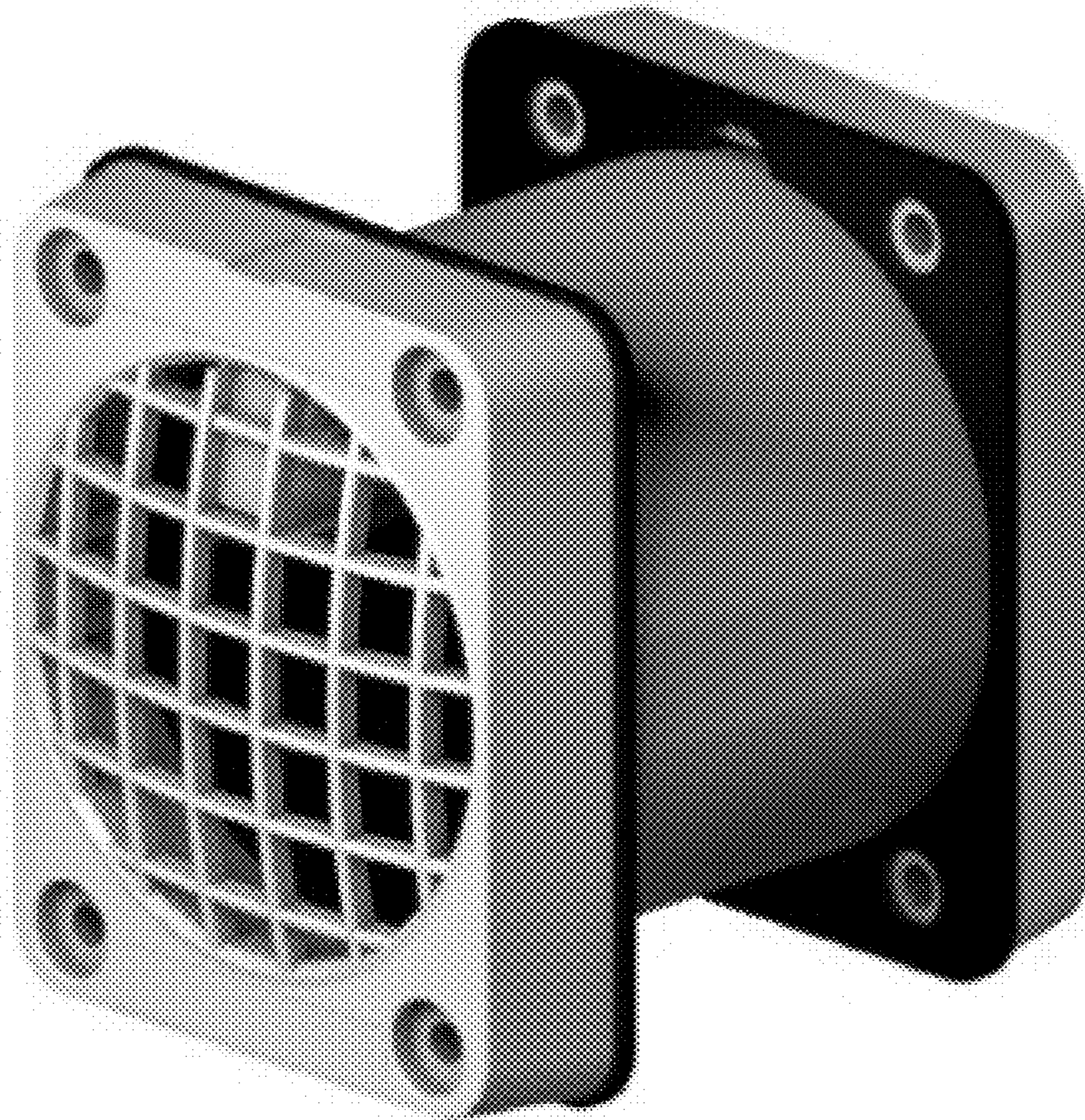
