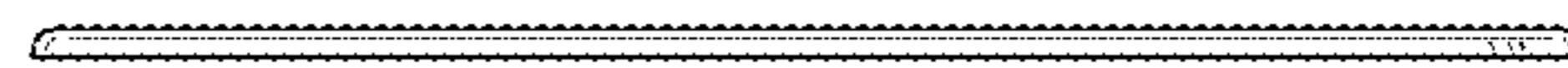
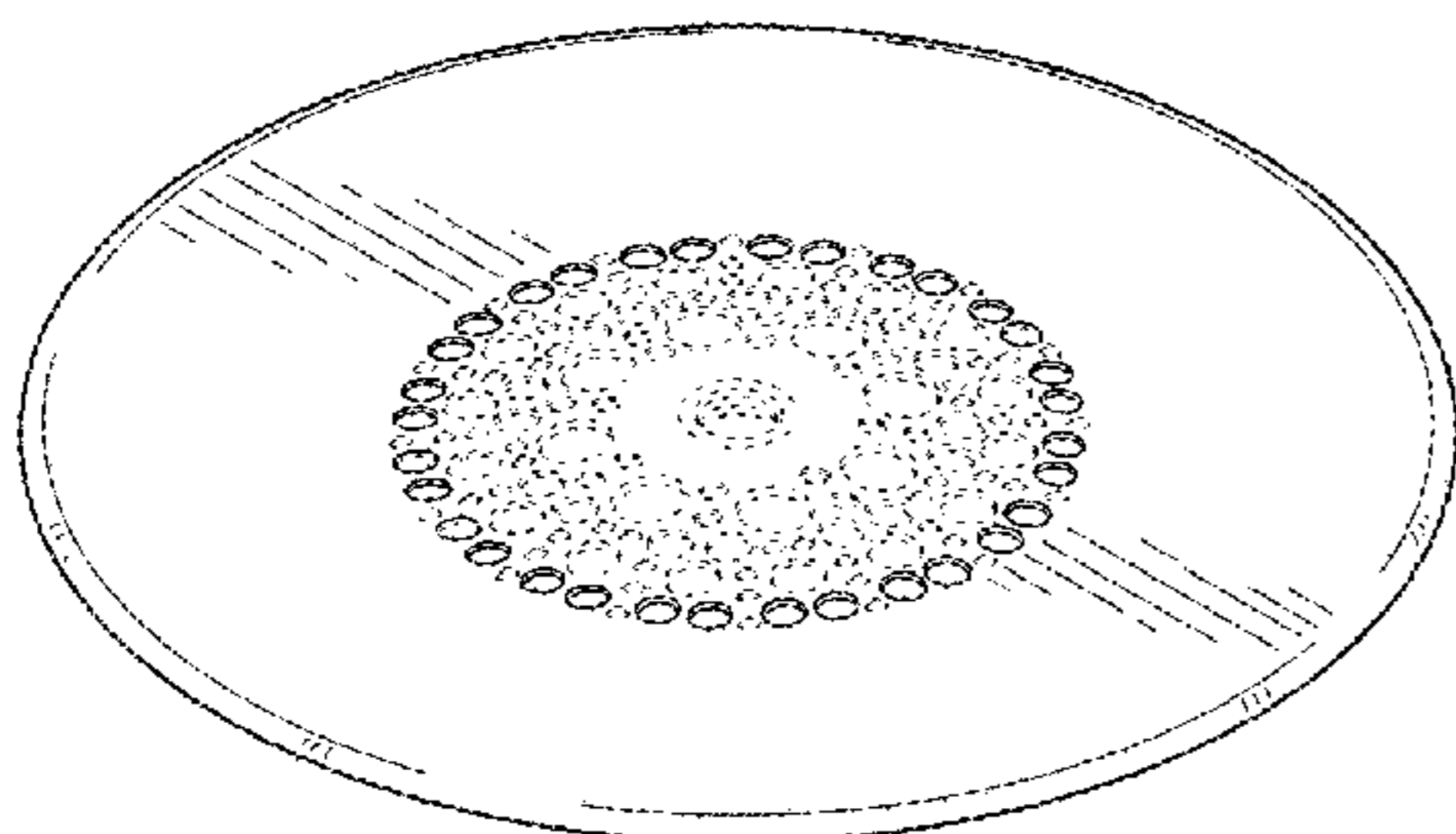
(57) **CLAIM**

The ornamental design for a device for concealing a flange, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the device for concealing a flange showing the new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a side elevation view thereof, wherein the outer perimeter is circular and all sides are identical; and,
FIG. 4 is a bottom plan view thereof.
The broken lines depict portions of the article that form no part of the claim.

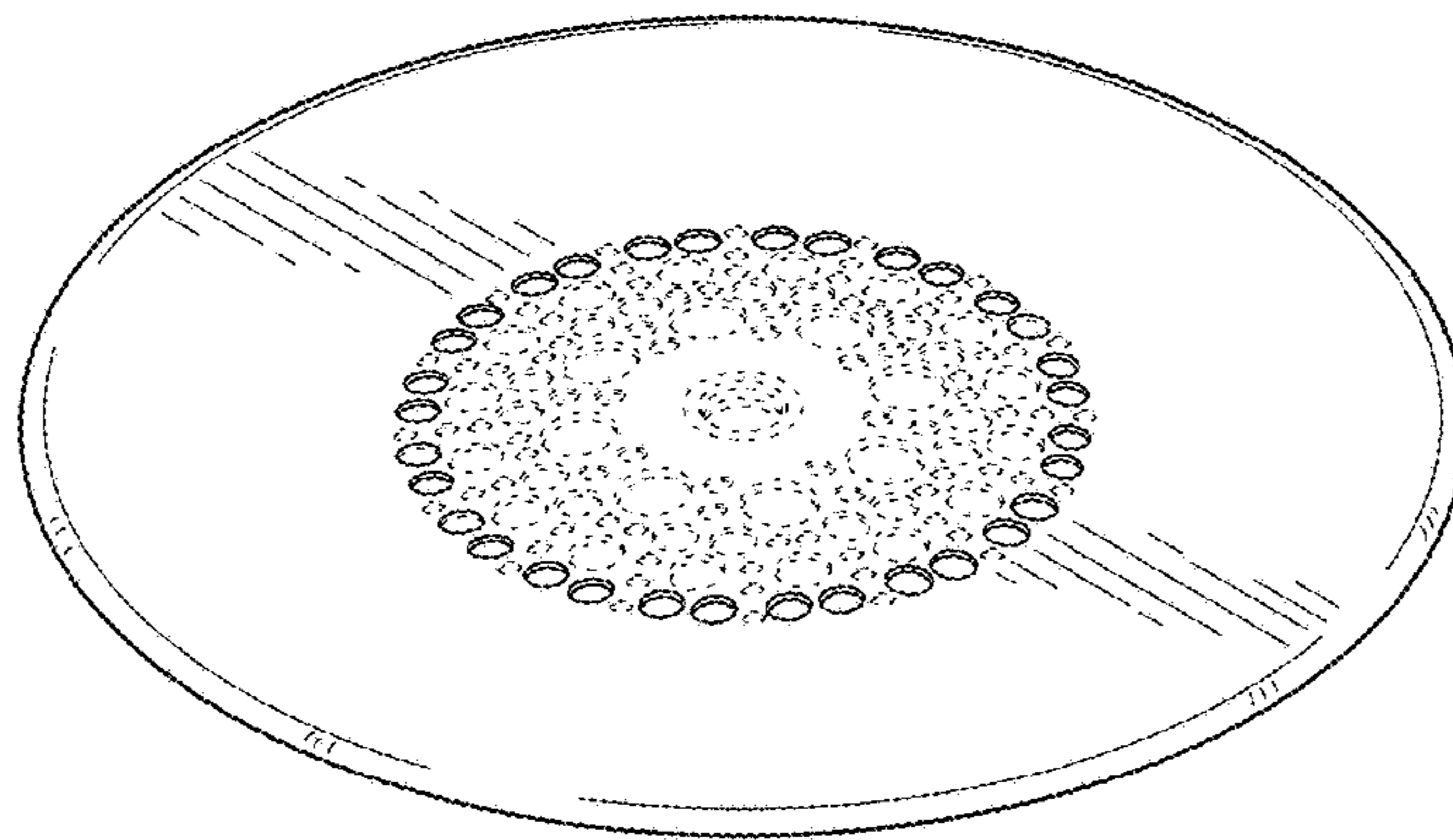

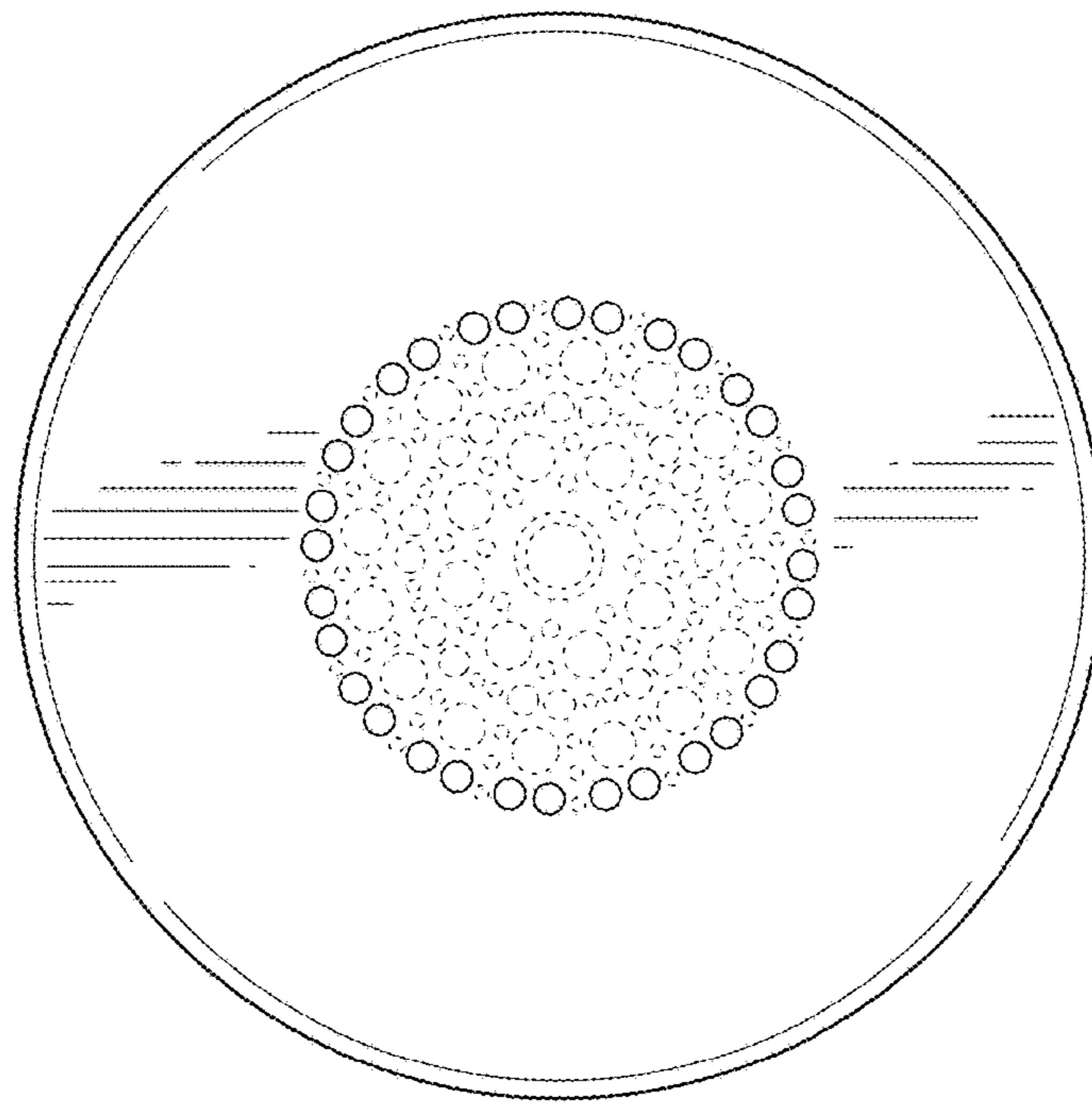

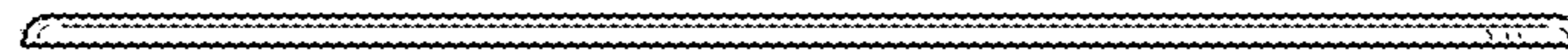

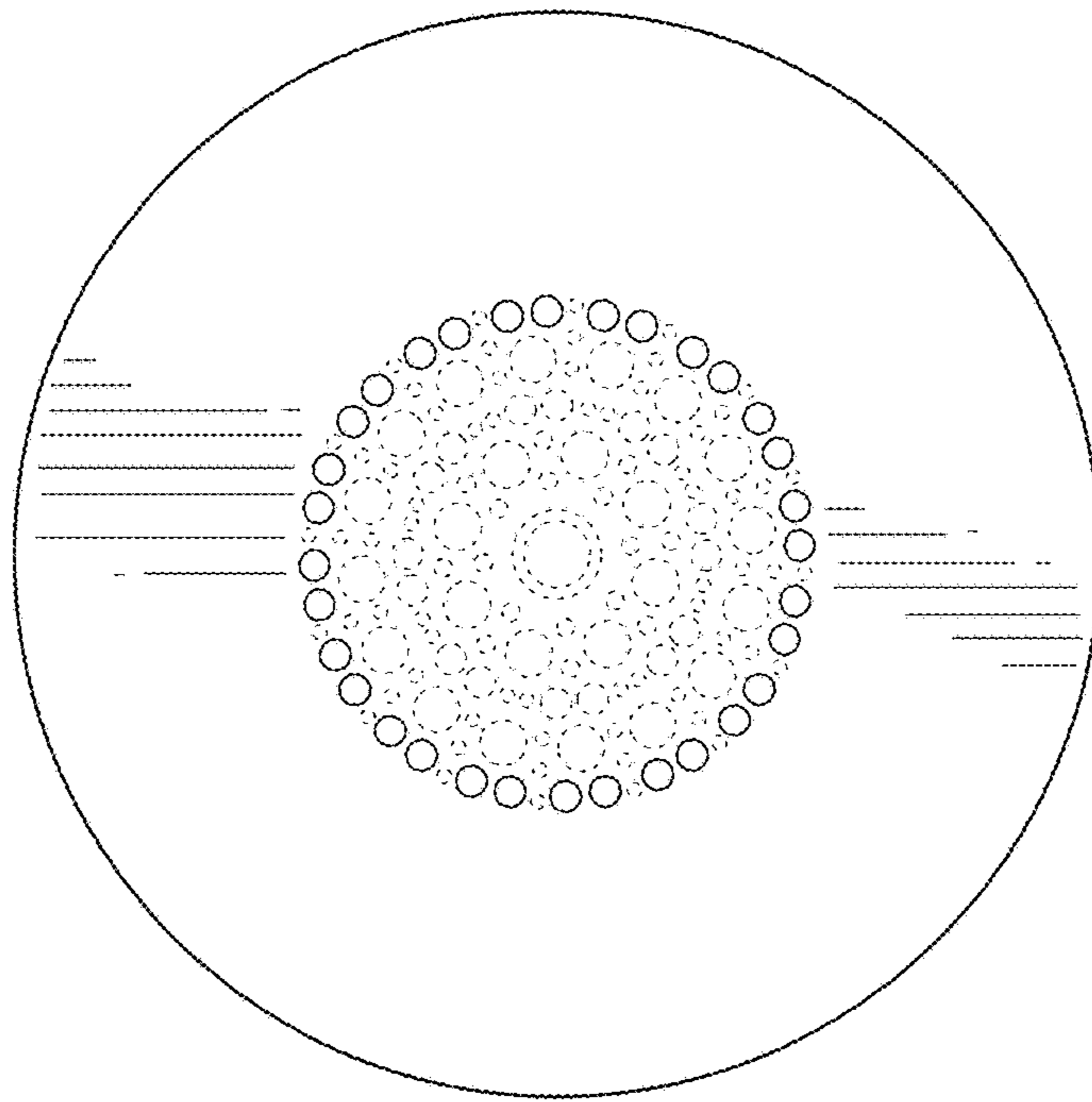
