(57) **CLAIM**

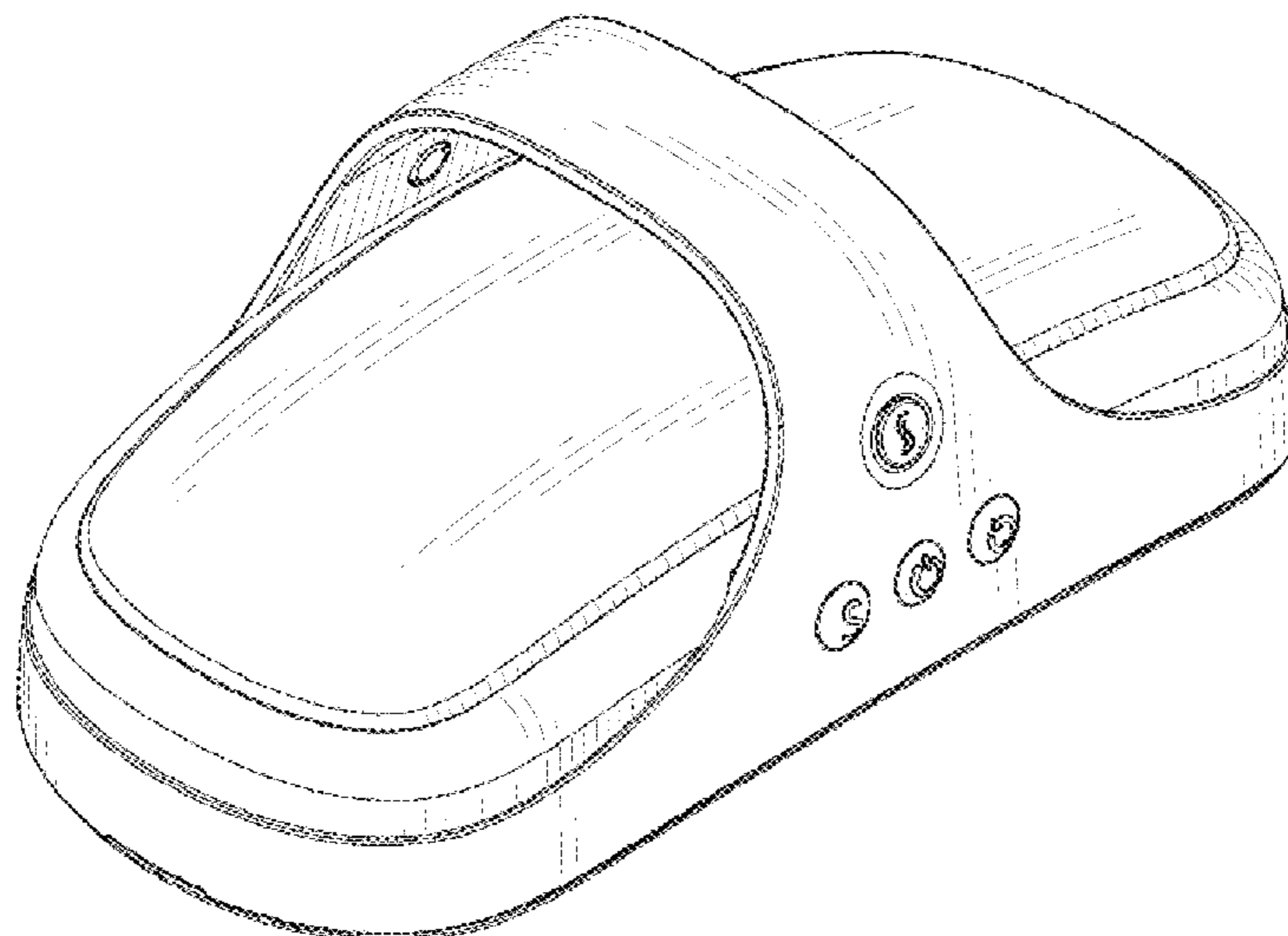
The ornamental design for a massager, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view for a massager;
FIG. 2 is a bottom perspective view of the design for a massager as seen in FIG. 1;
FIG. 3 is a right side view of the design for a massager as seen in FIG. 1;
FIG. 4 is a left side view of the design for a massager as seen in FIG. 1;
FIG. 5 is a rear view of the design for a massager as seen in FIG. 1;
FIG. 6 is a top view of the design for a massager as seen in FIG. 1; and,
FIG. 7 is a bottom view of the design for a massager as seen in FIG. 1.

The dotted lines in FIG. 2 and FIG. 7 depict a boundary defining and enclosing a portion of the bottom of the massager that is unclaimed structure and forms no part of the claimed design.

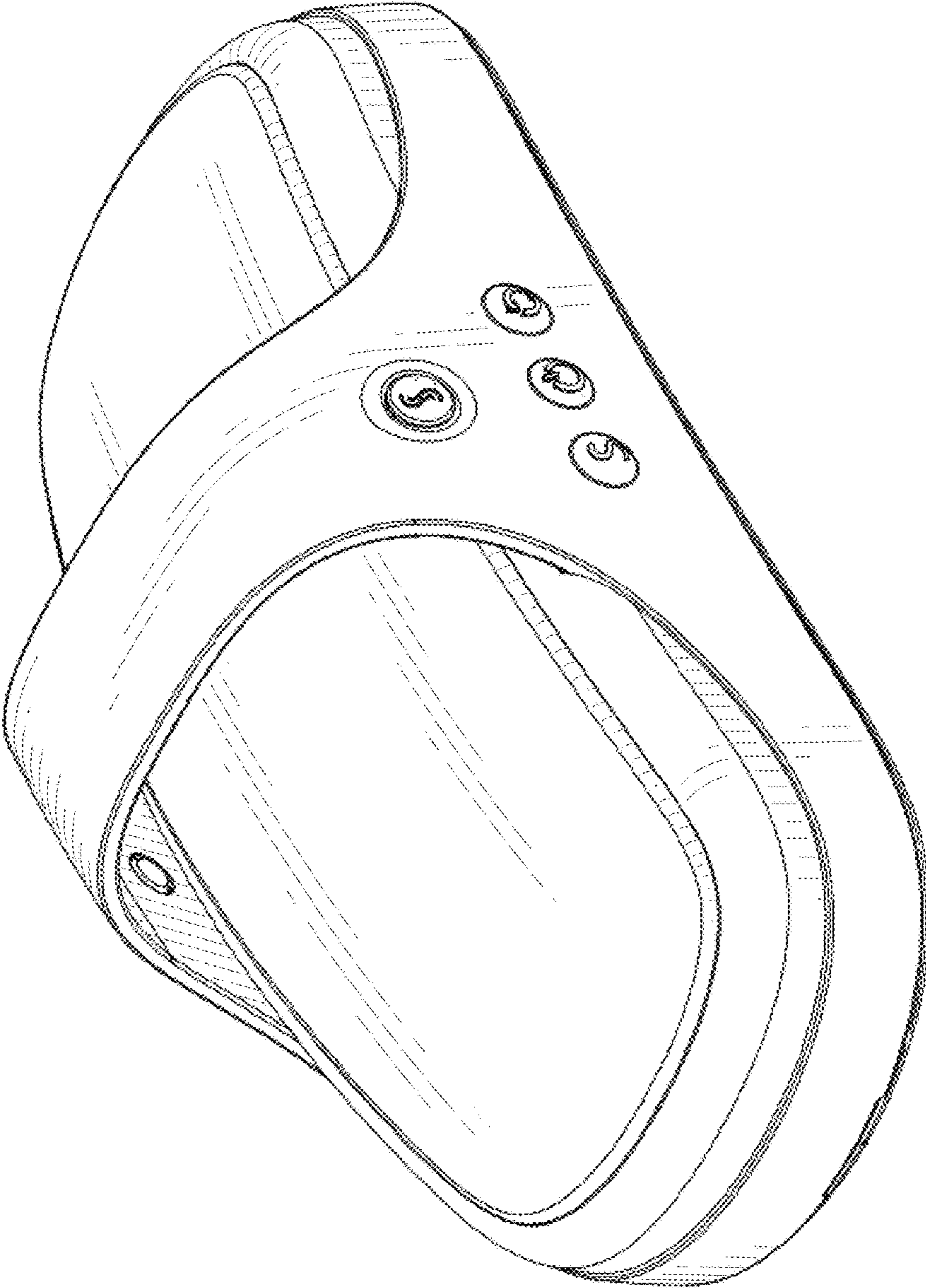

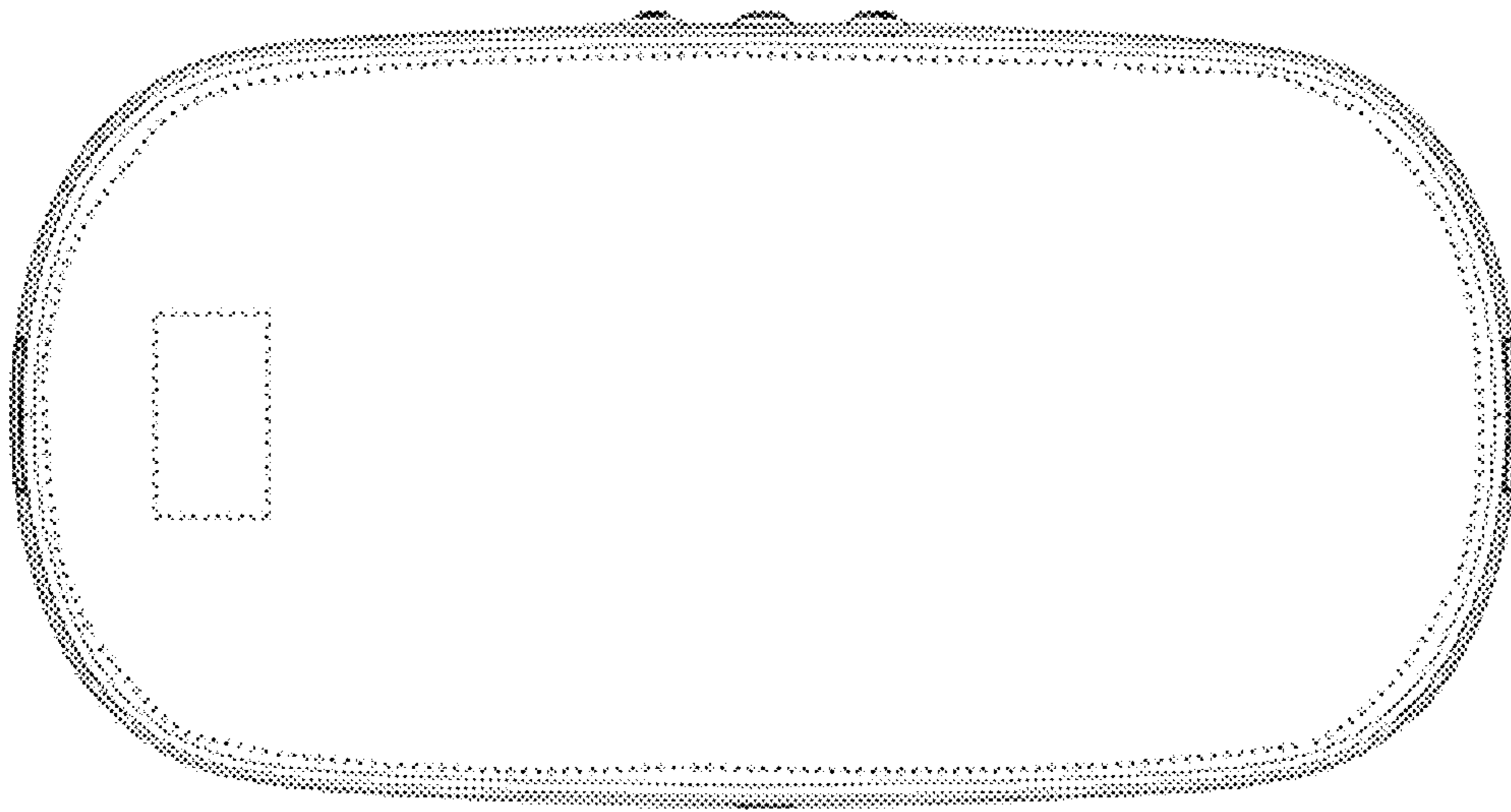

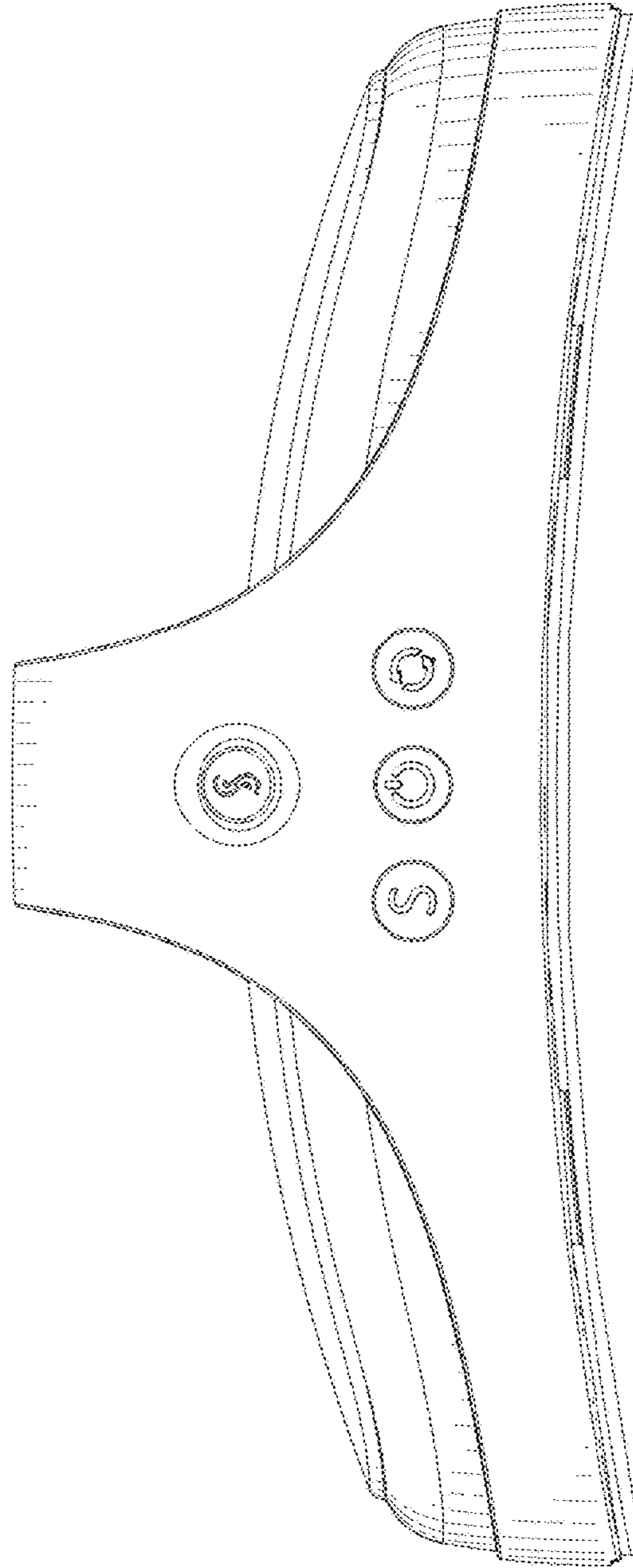

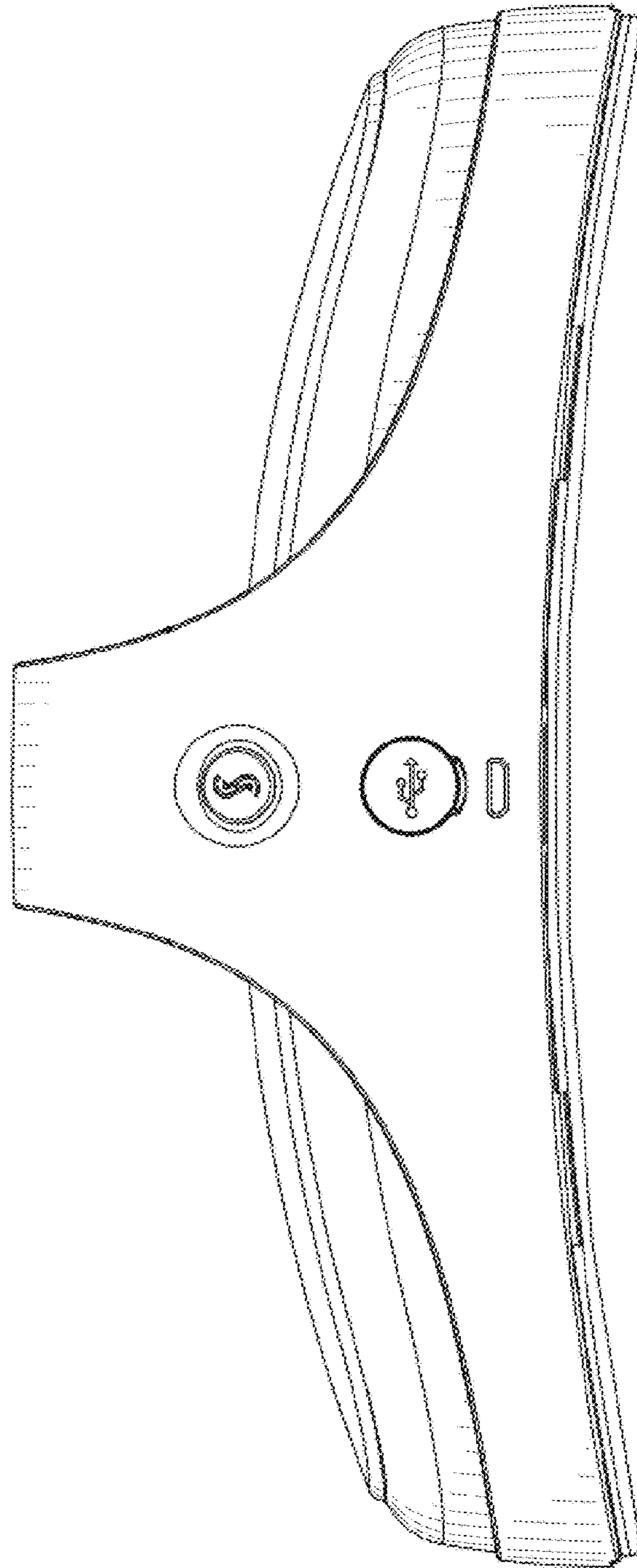

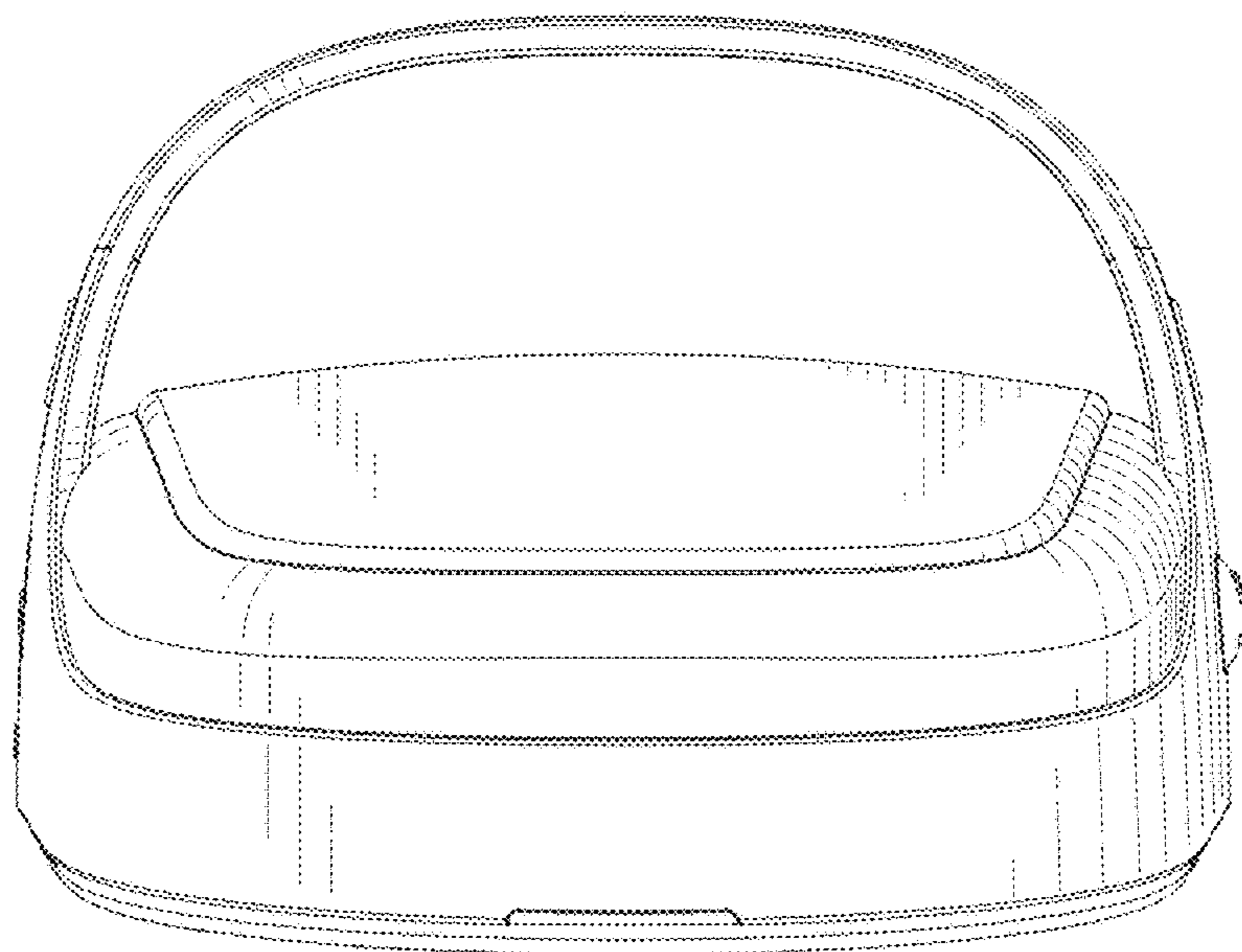

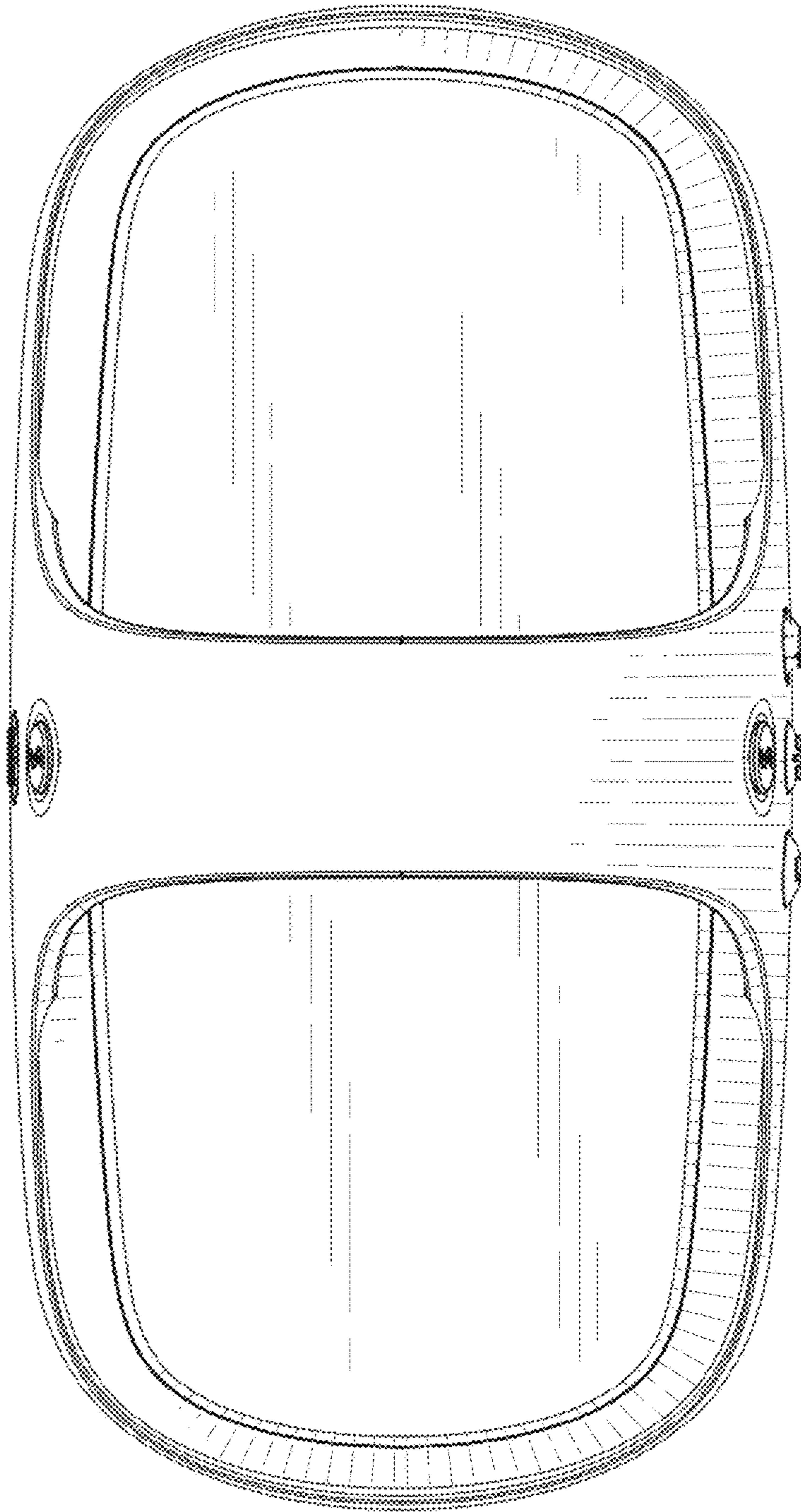

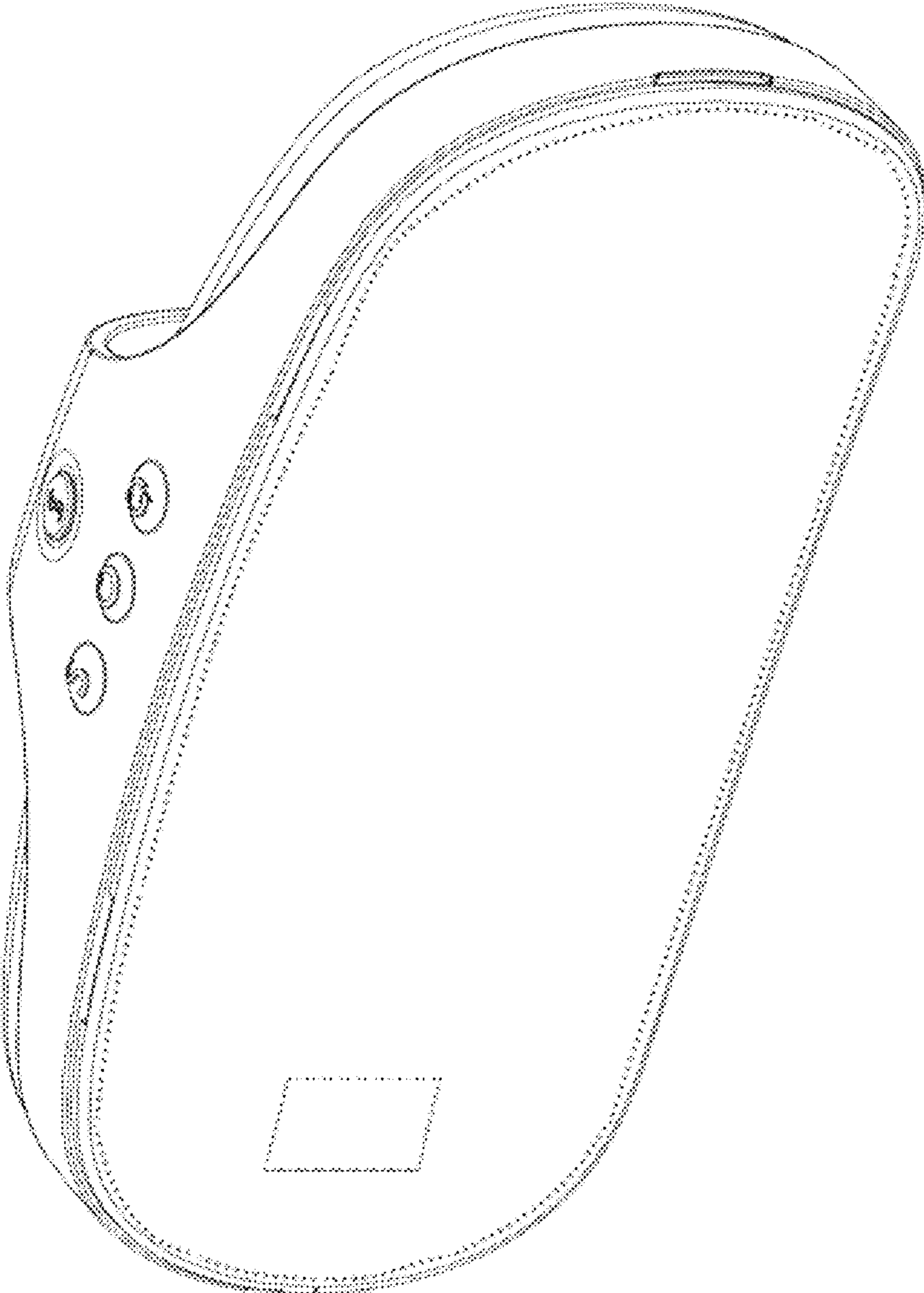
