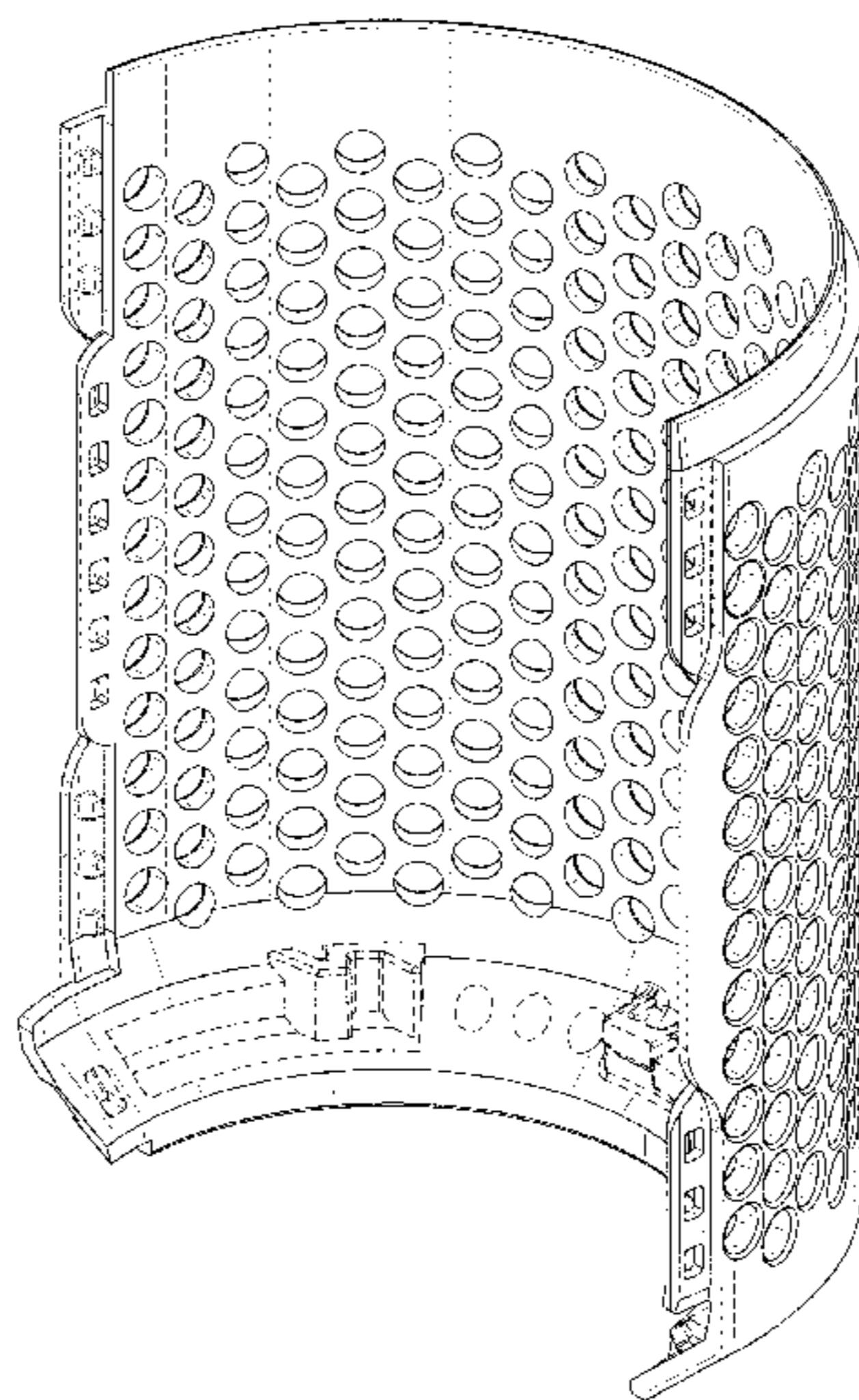
(57) **CLAIM**

We claim the ornamental design for a hairdryer filter, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a hairdryer filter showing our new design;  
FIG. 2 is a first side view thereof;  
FIG. 3 is a side view of the opposite side of FIG. 2;  
FIG. 4 is a second side view thereof;  
FIG. 5 is a side view of the opposite side of FIG. 4;  
FIG. 6 is a top view thereof; and,  
FIG. 7 is a bottom view thereof.  
The broken lines shown in the drawings illustrate portions of a hairdryer filter that form no part of the claimed design.

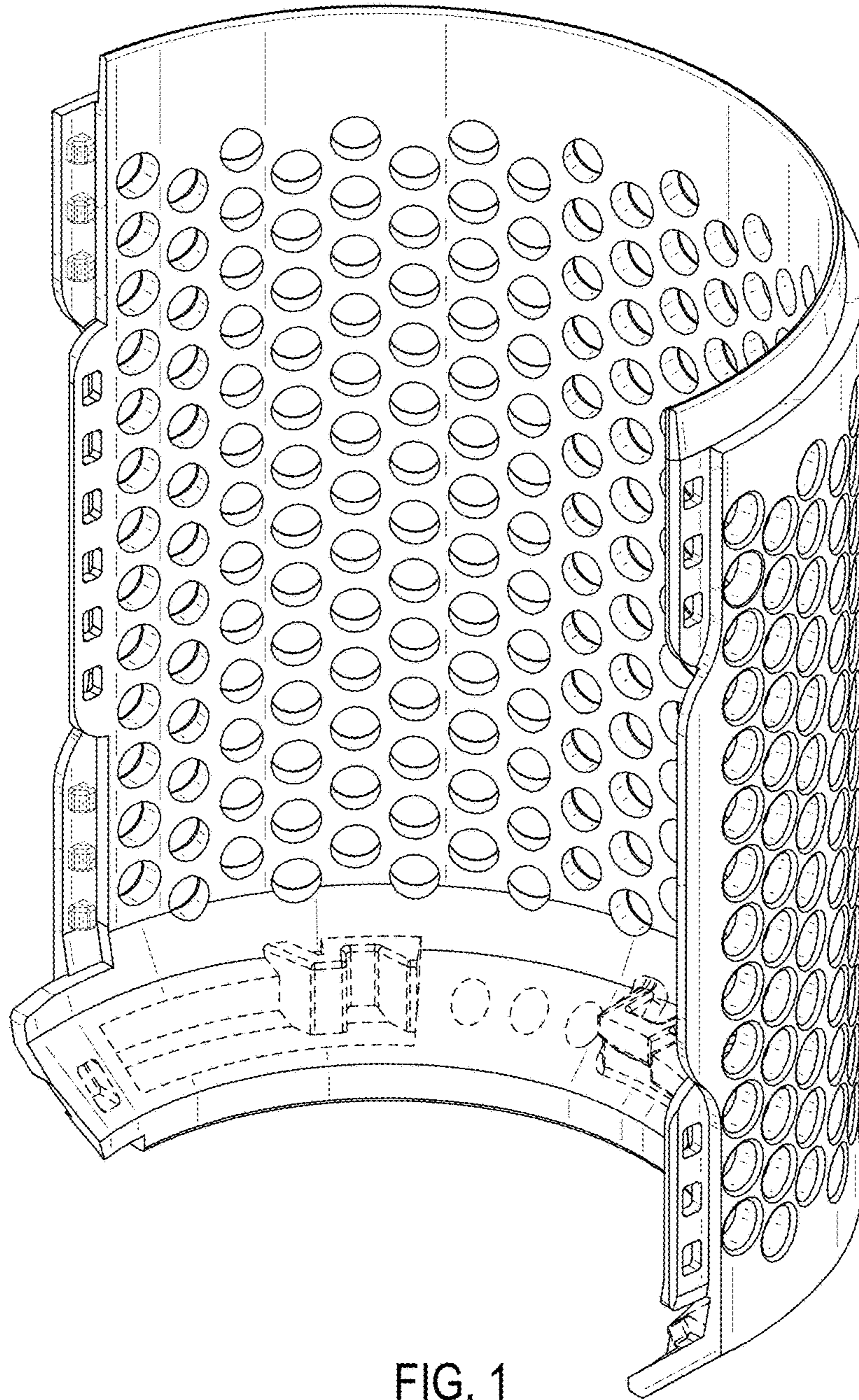

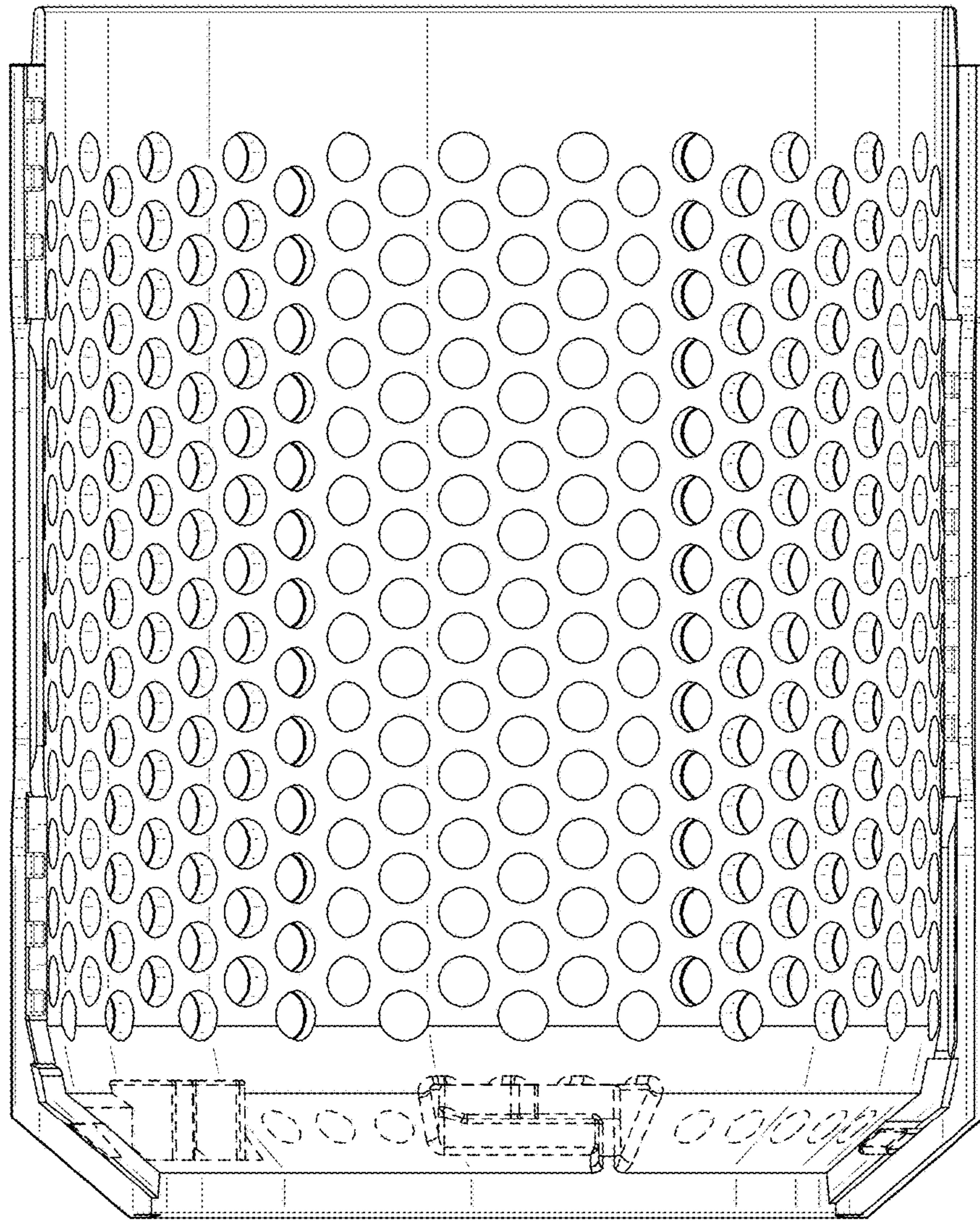

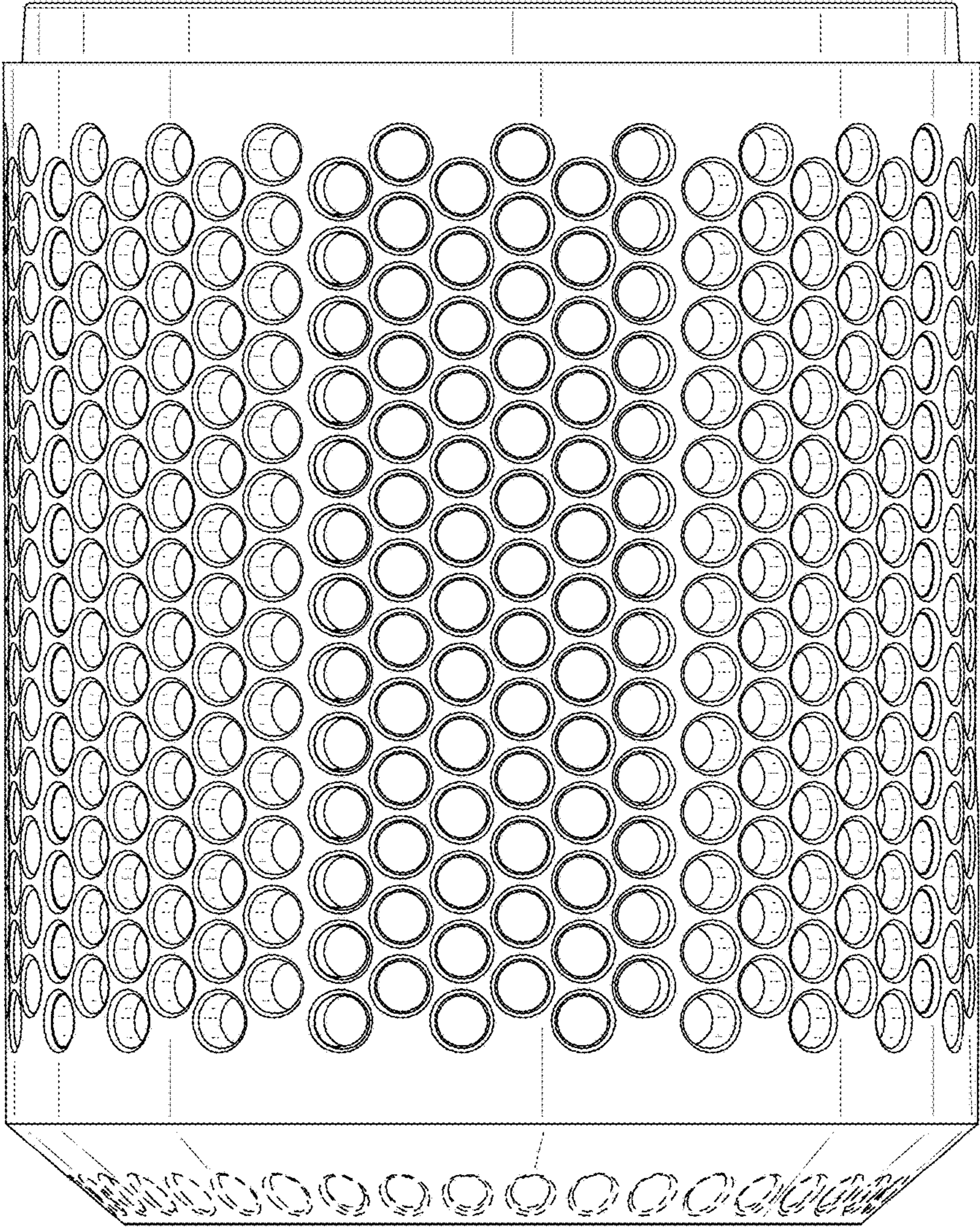

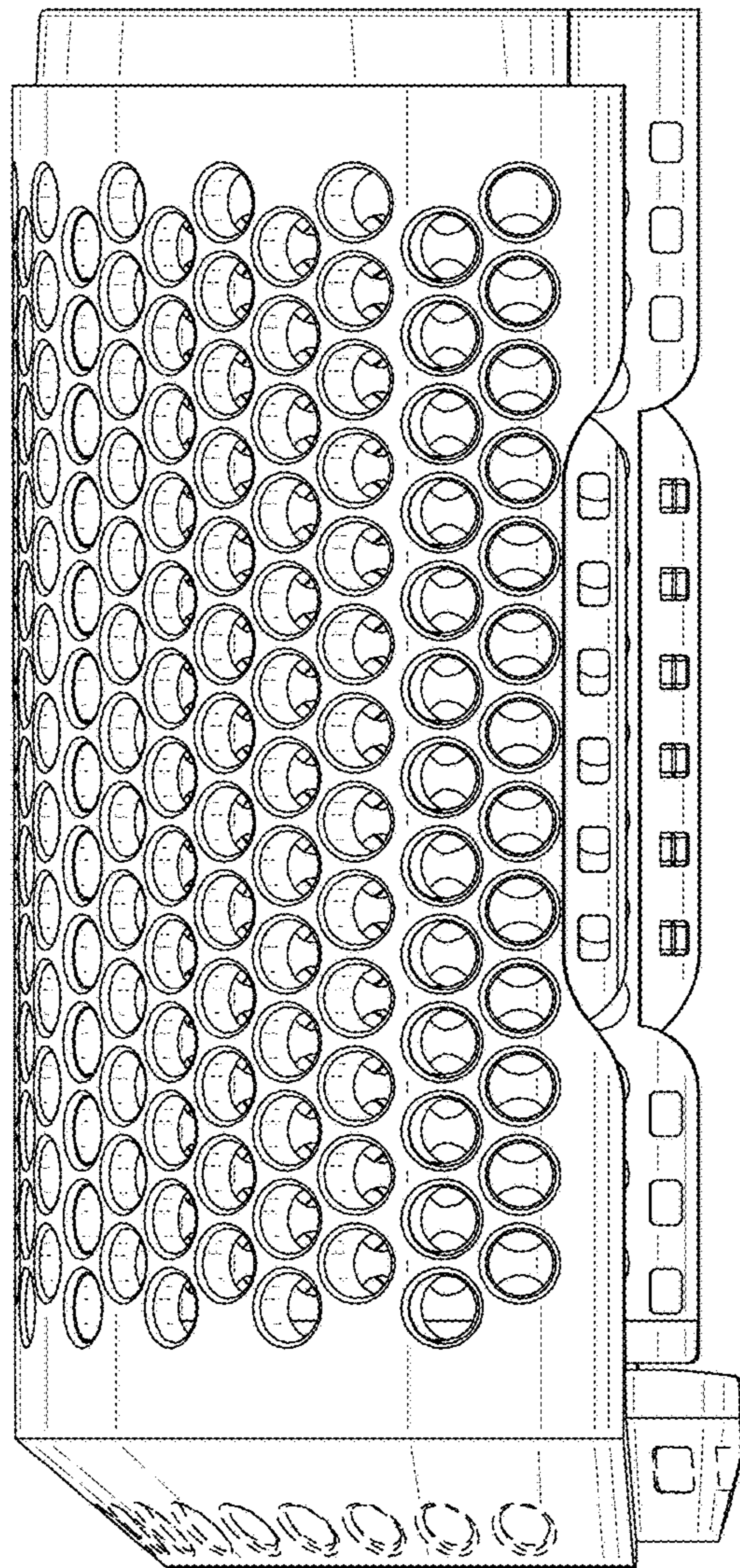

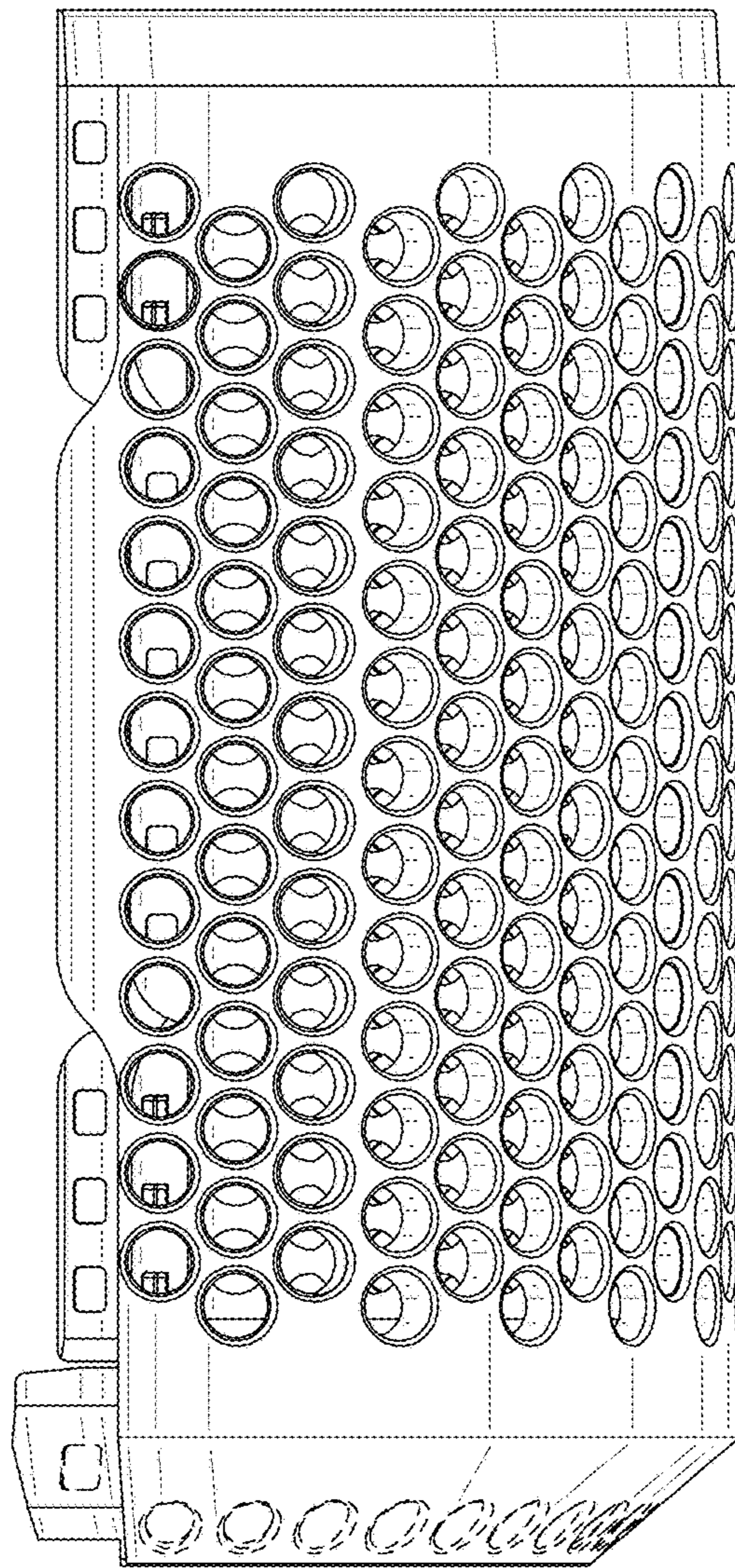

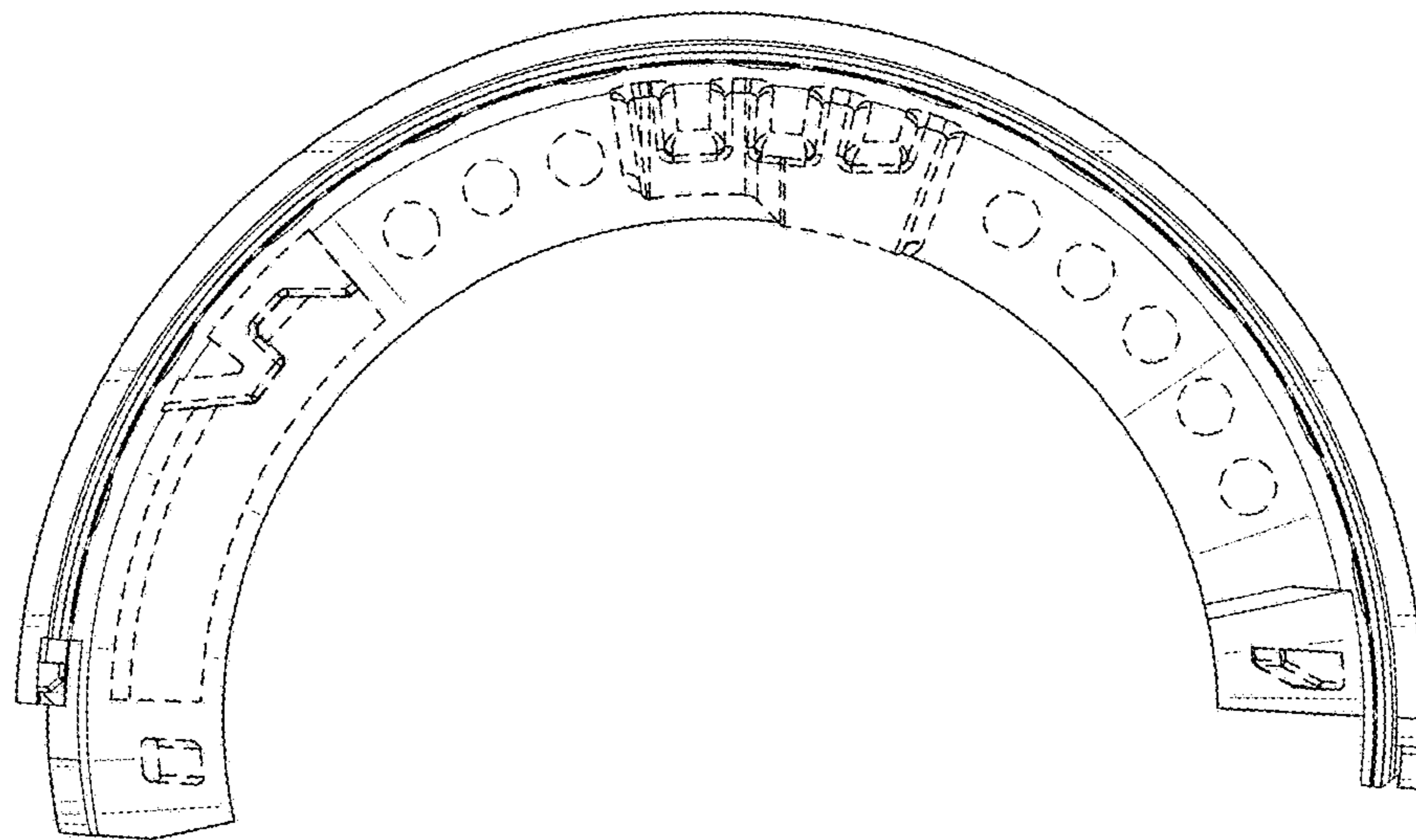

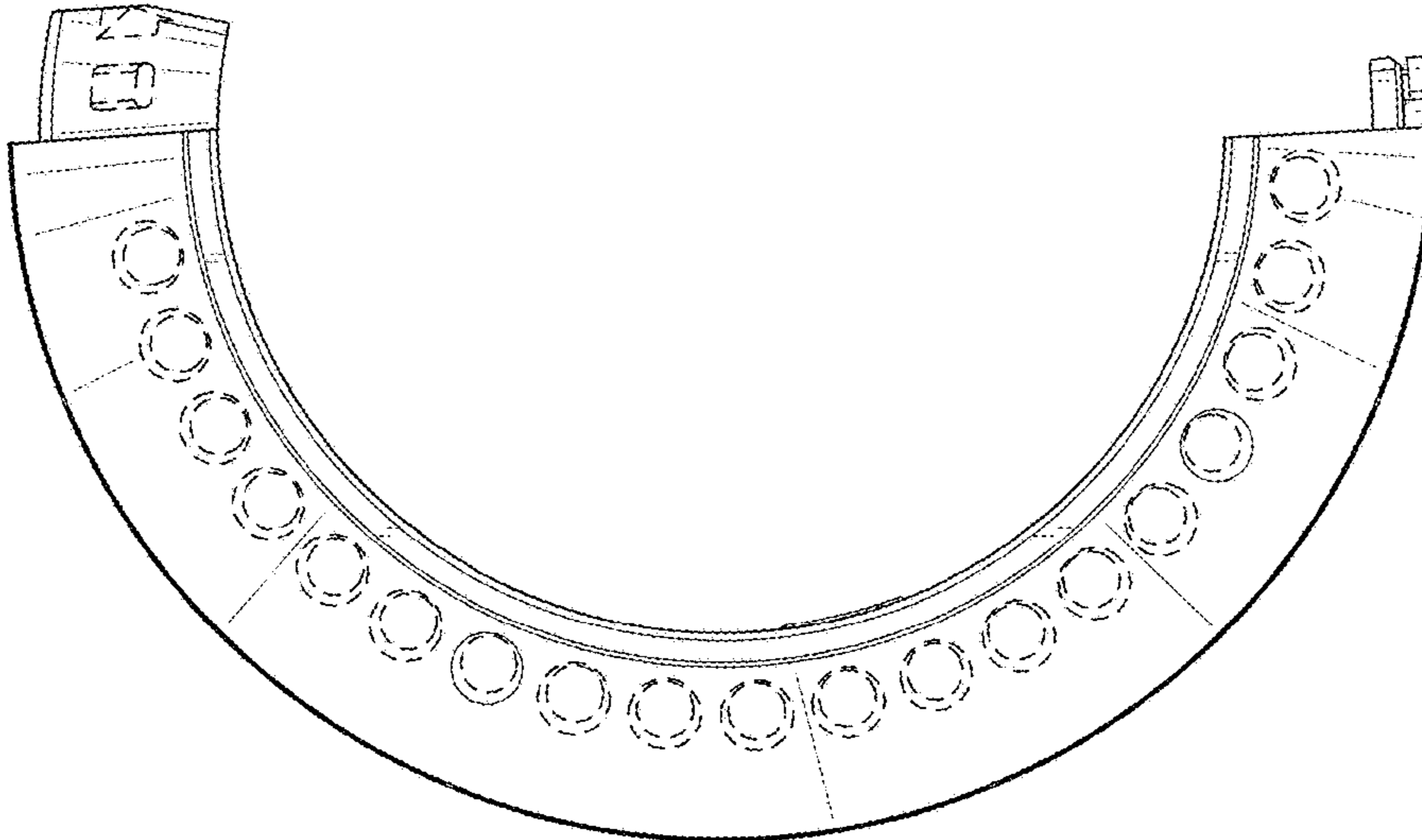
