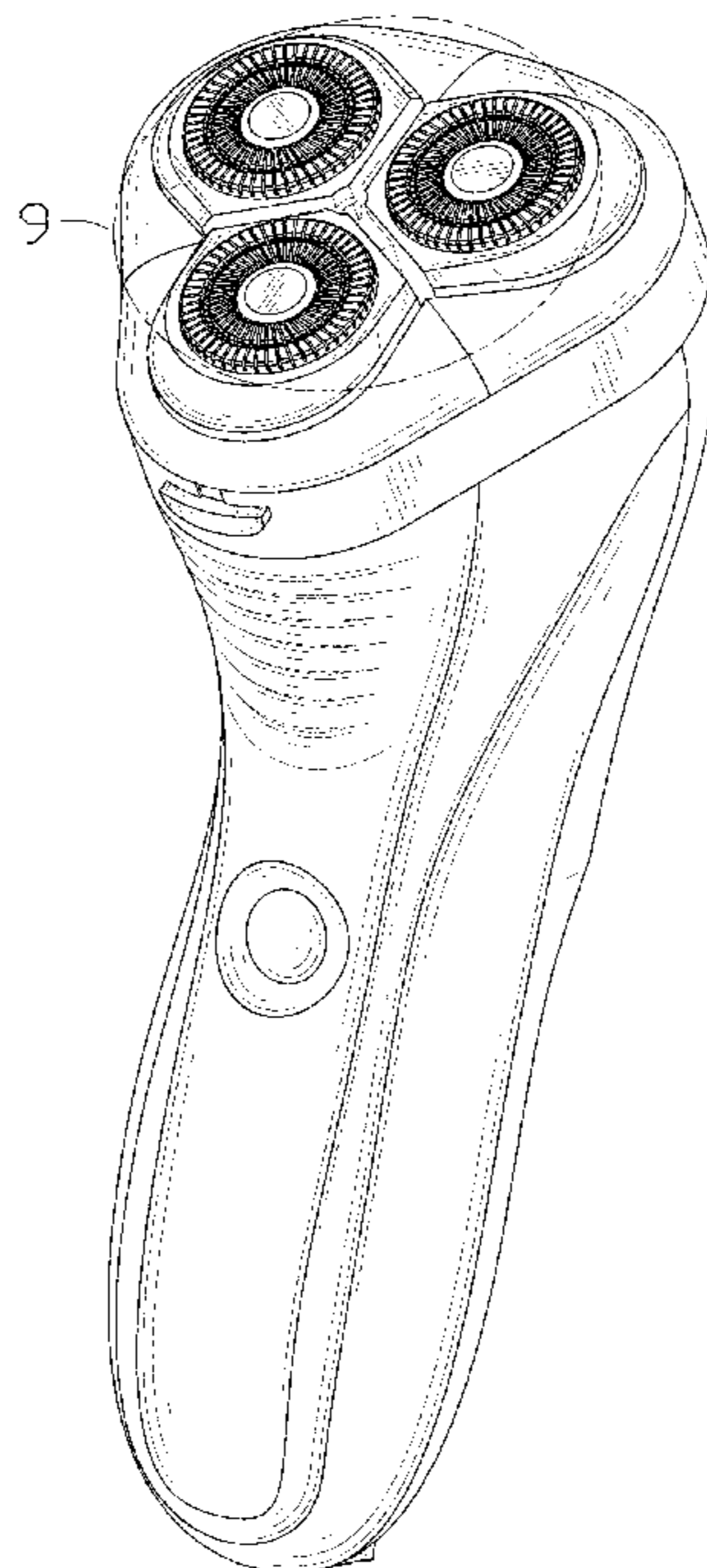
(57) **CLAIM**

The ornamental design for a shaver, as shown and described.

DESCRIPTION

FIG. 1 is a first perspective view of an embodiment of a shaver, showing the claimed new design; FIG. 2 is a second perspective view thereof; FIG. 3 is a front elevation view thereof; FIG. 4 is a rear elevation view thereof; FIG. 5 is a left side elevation view thereof; FIG. 6 is right side elevation view thereof; FIG. 7 is a top plan view thereof; FIG. 8 is a bottom plan view thereof; FIG. 9 is an enlarged view of design features comprised within circle 9 in FIG. 1; and, FIG. 10 is an enlarged view of design features comprised within circle 10 in FIG. 2. The broken lines and the unshaded areas therein illustrate portions of the shaver and form no part of the claimed design.

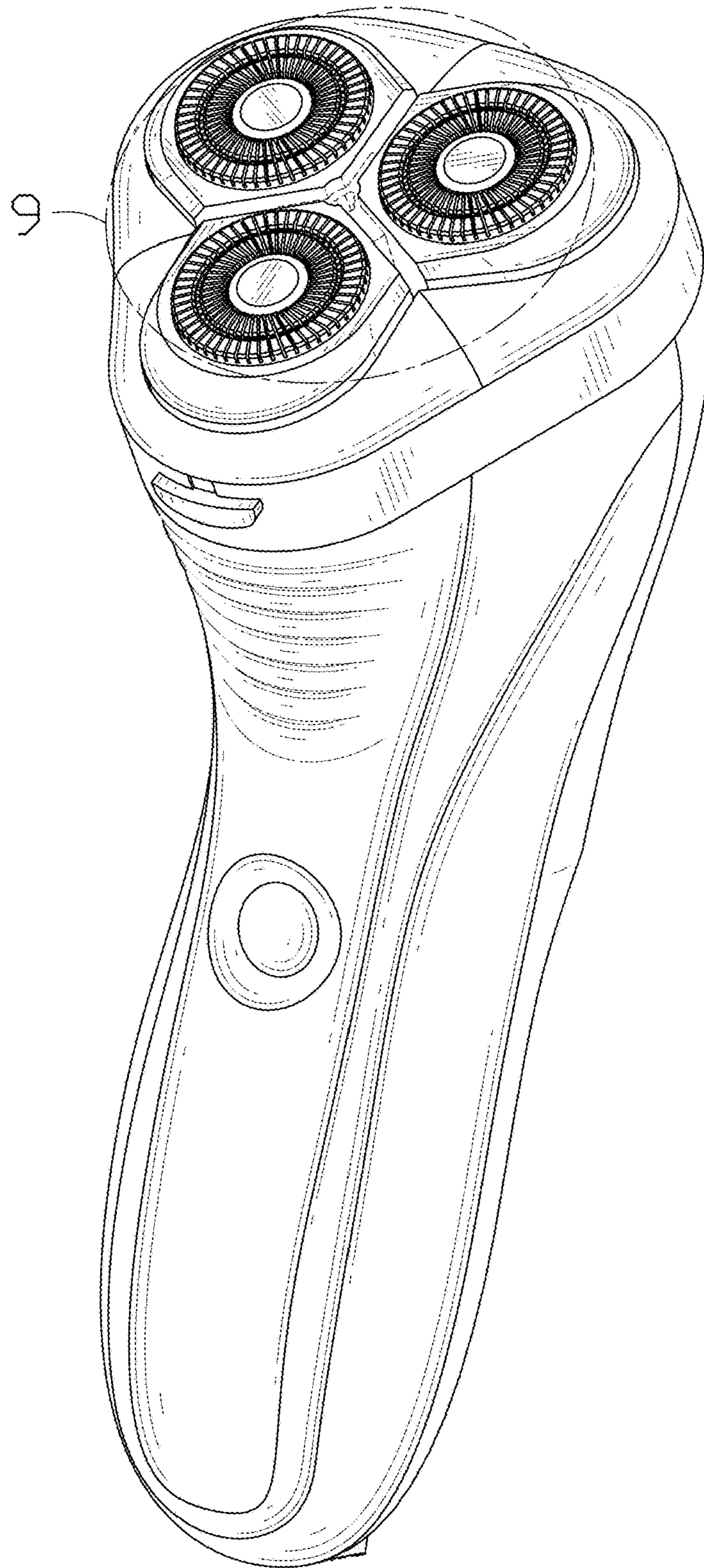

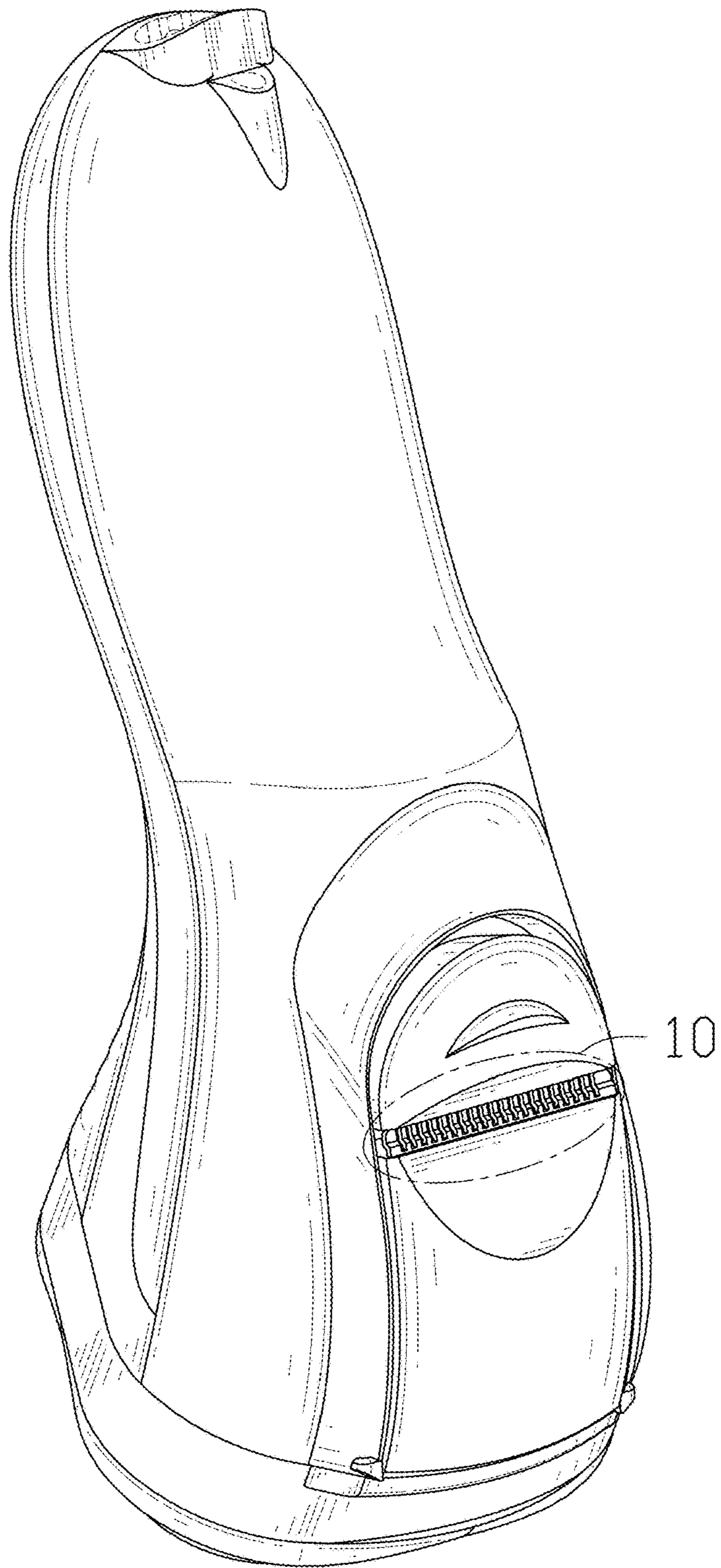

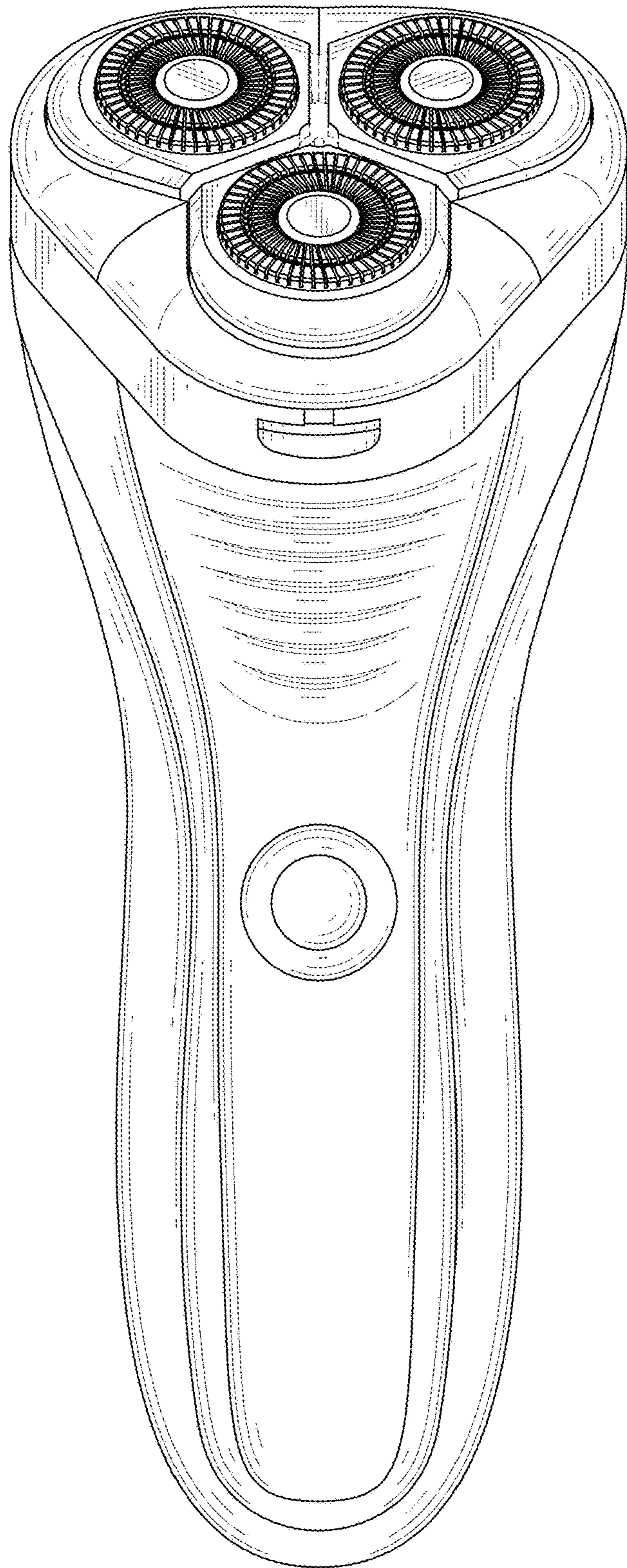

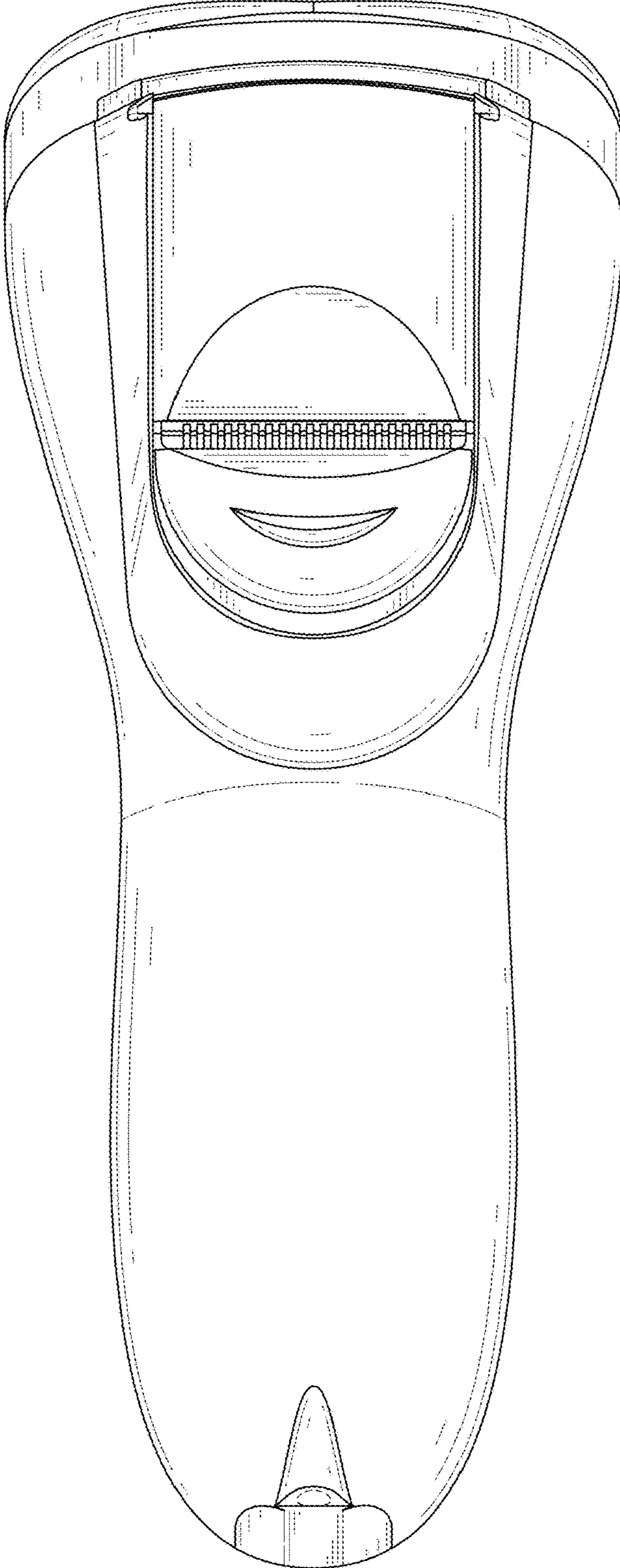

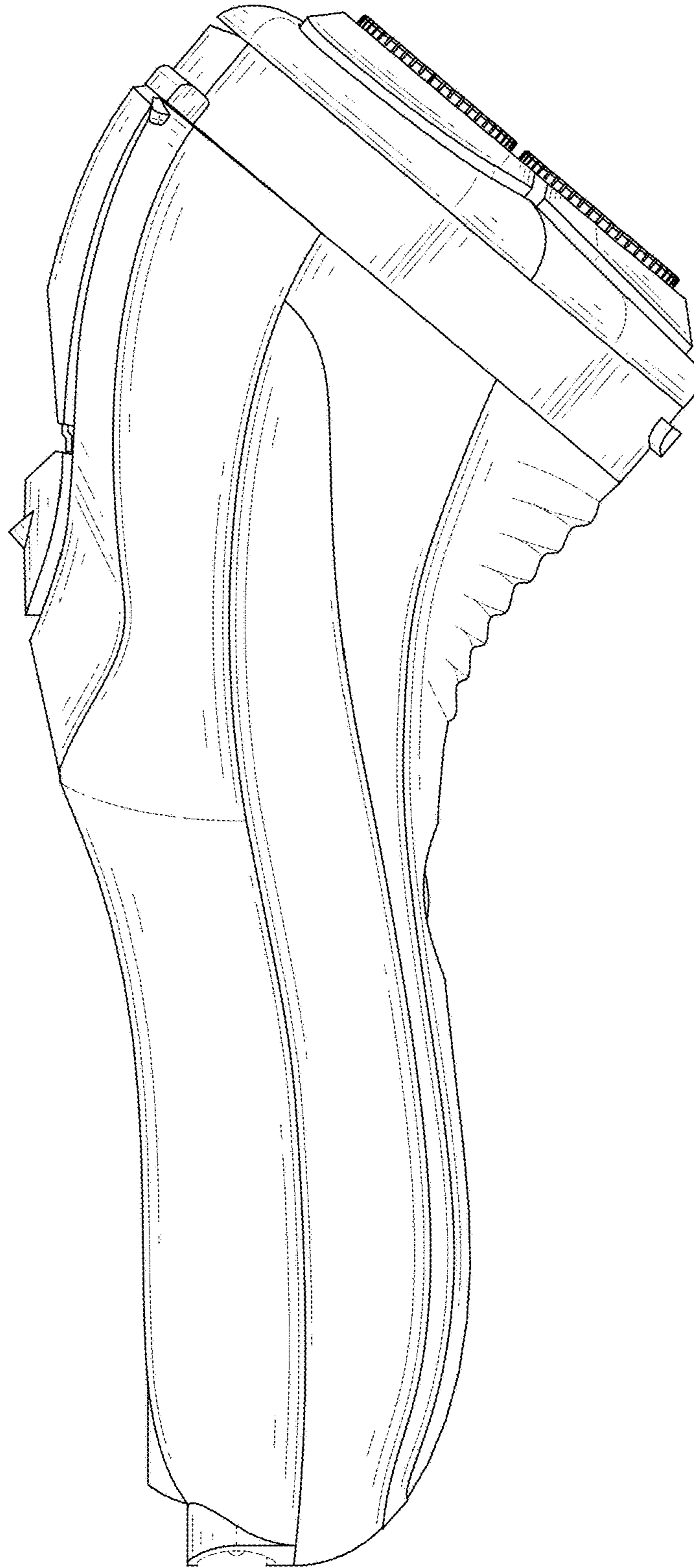

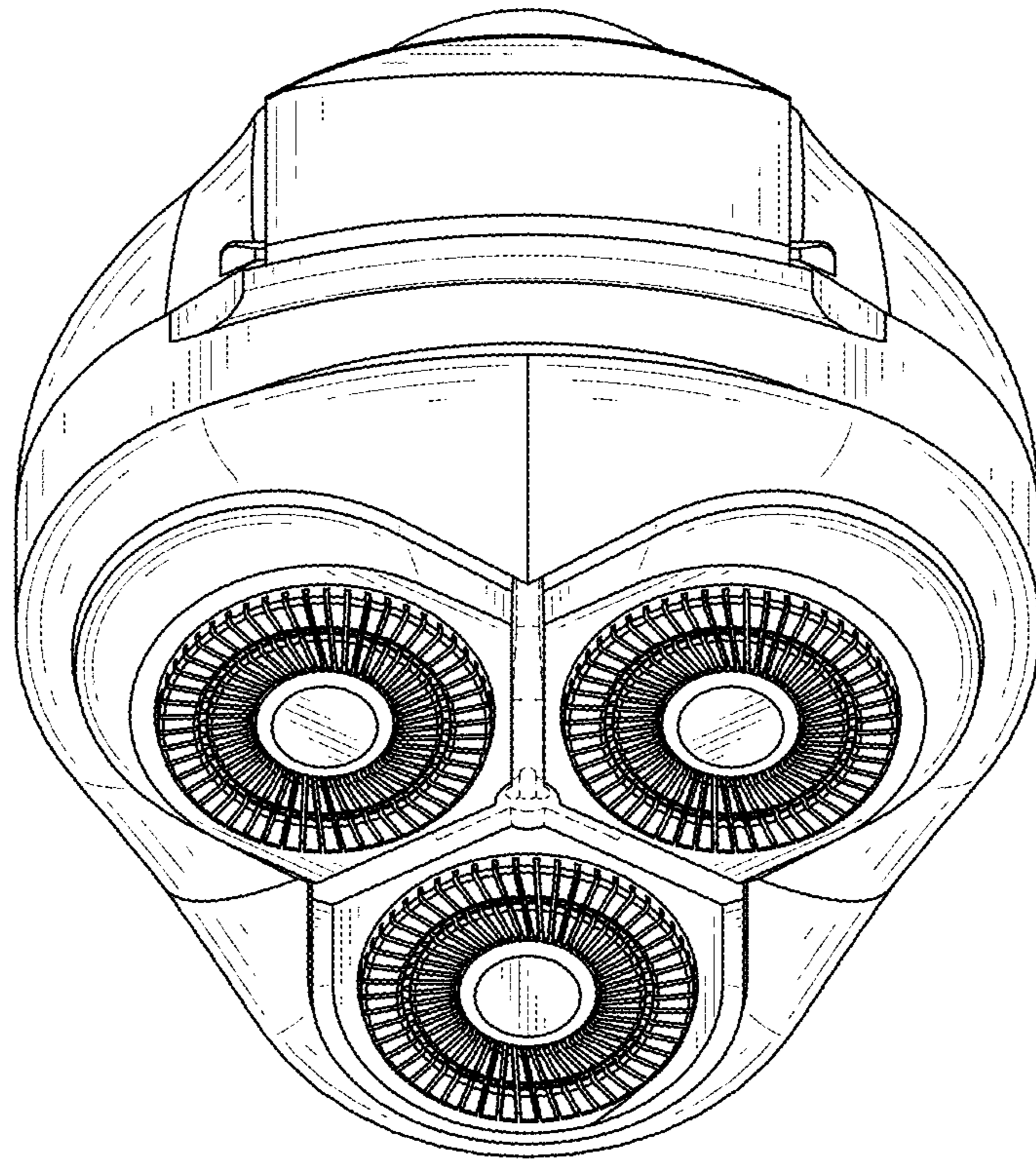

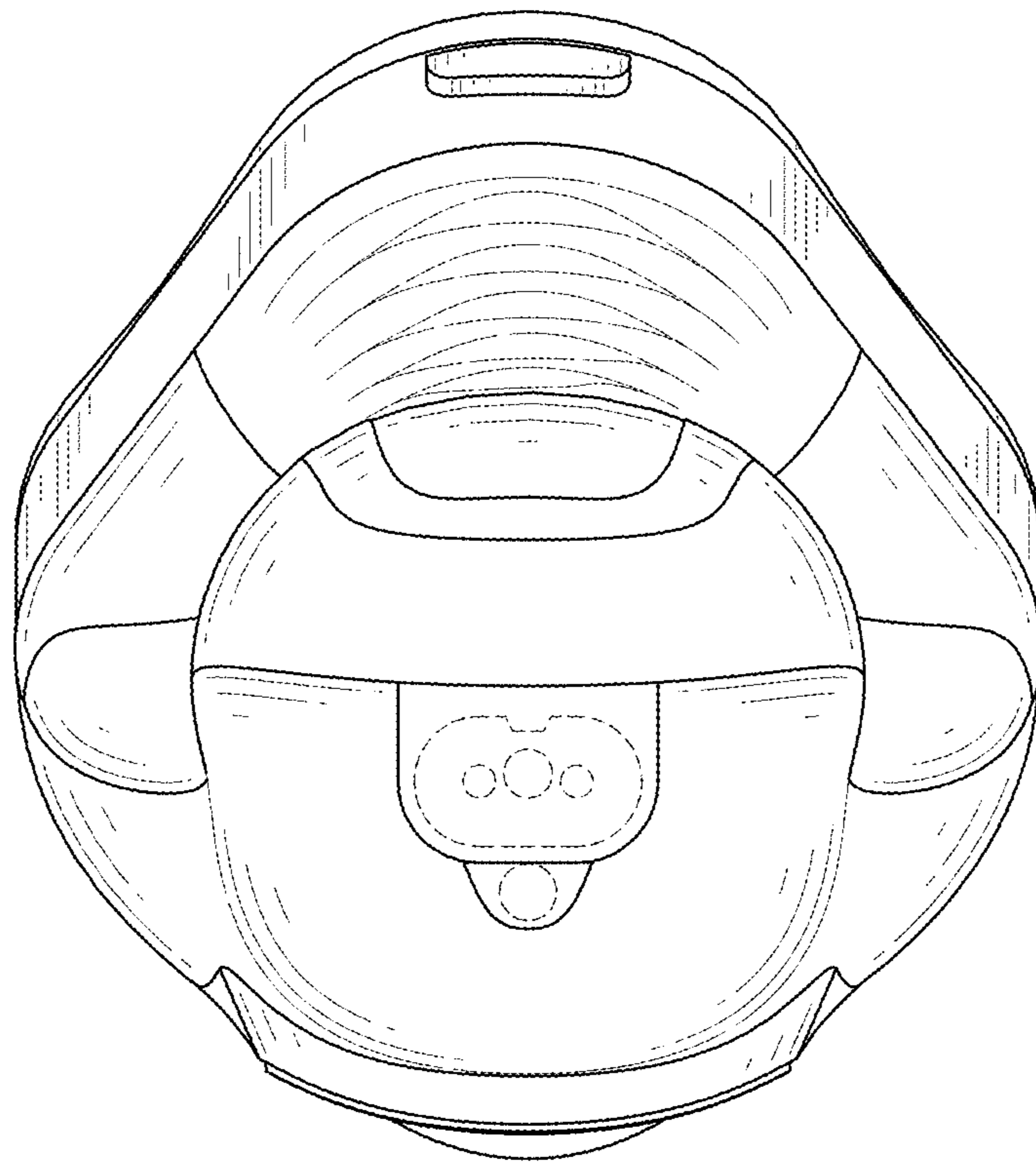

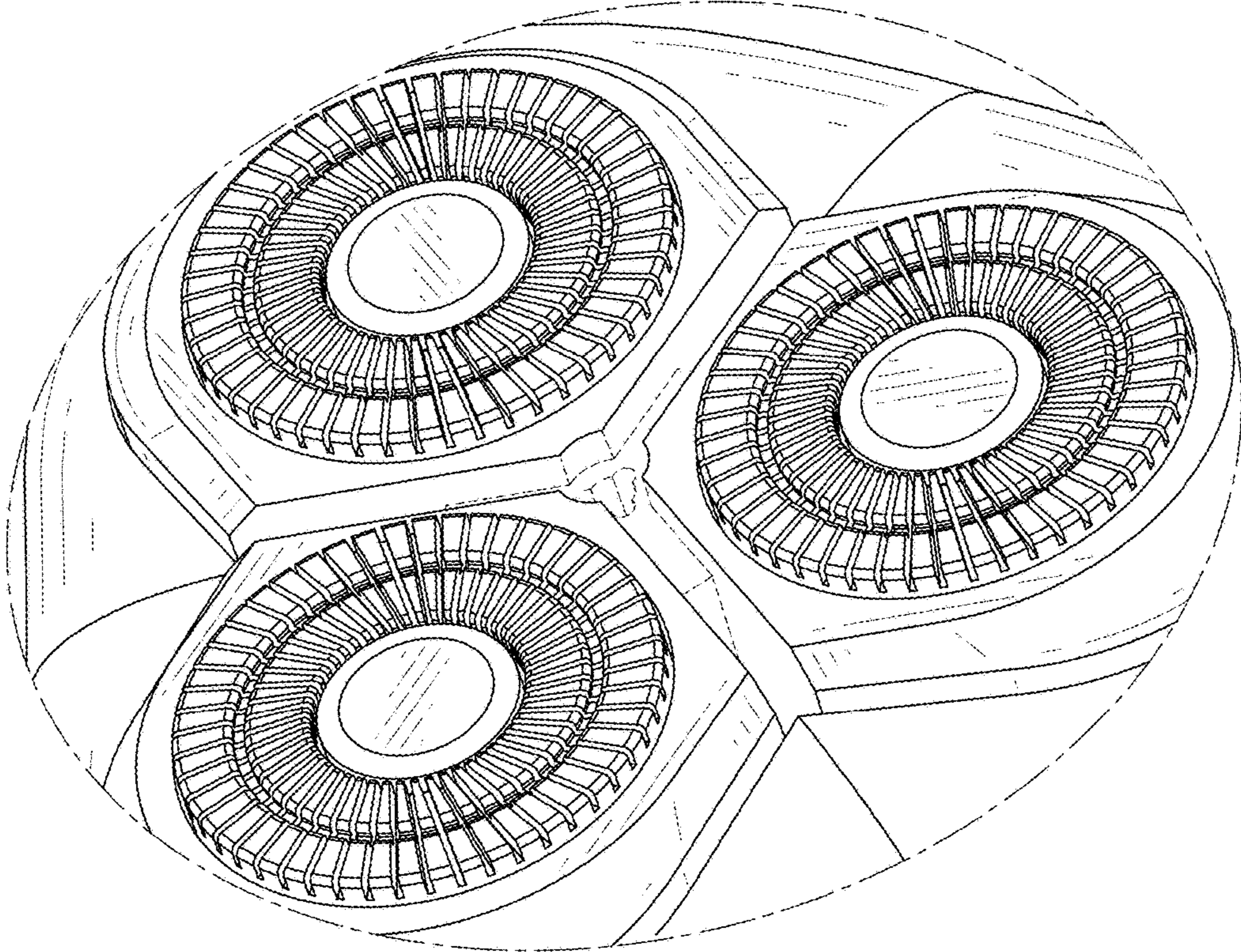

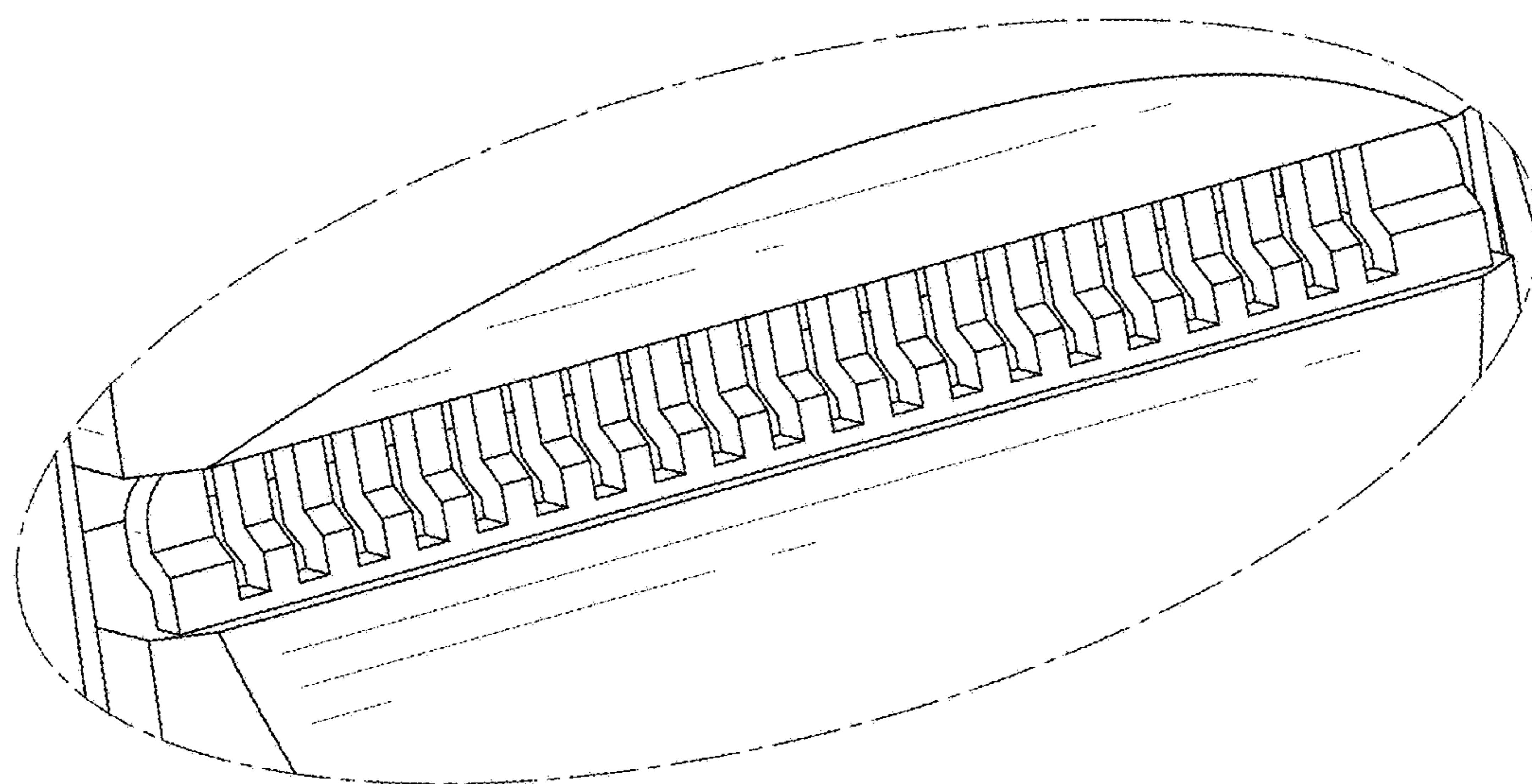
