(57) **CLAIM**

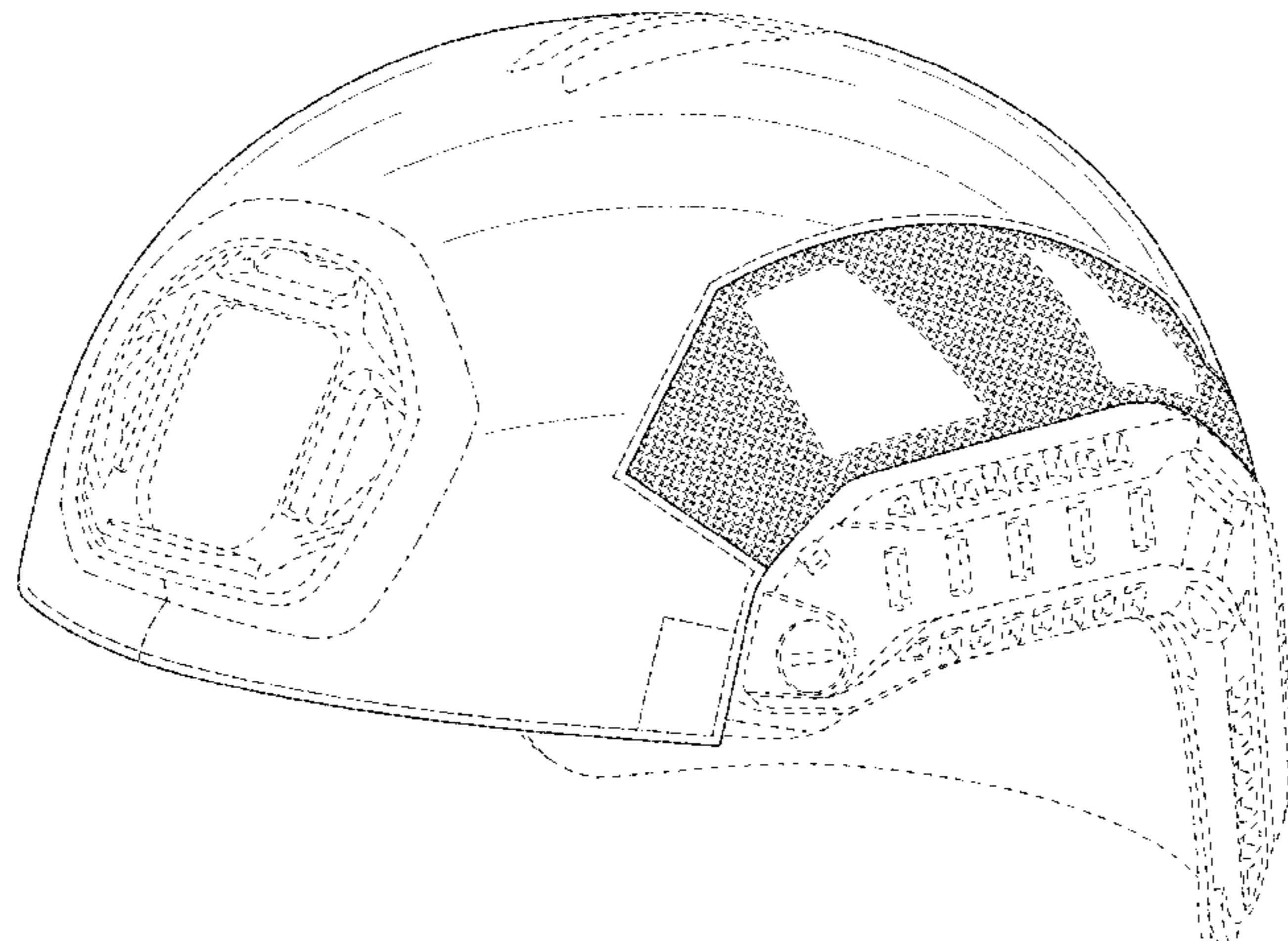
The ornamental design for a helmet cover, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a helmet cover showing my new design;  
 FIG. 2 is a rear perspective view of the helmet cover shown in FIG. 1;  
 FIG. 3 is a front elevational view of the helmet cover shown in FIG. 1;  
 FIG. 4 is a rear elevational view of the helmet cover shown in FIG. 1;  
 FIG. 5 is a left-side elevational view of the helmet cover shown in FIG. 1;  
 FIG. 6 is a right-side elevational view of the helmet cover shown in FIG. 1;  
 FIG. 7 is a top plan view of the helmet cover shown in FIG. 1; and,  
 FIG. 8 is a bottom plan view of the helmet cover shown in FIG. 1.

The broken lines immediately adjacent the shaded areas represent the bounds of the claimed design while all other broken lines are directed to environment and are for illustrative purposes only; the broken lines, including the stitching lines having a longer dash than the other broken lines, form no part of the claimed design.

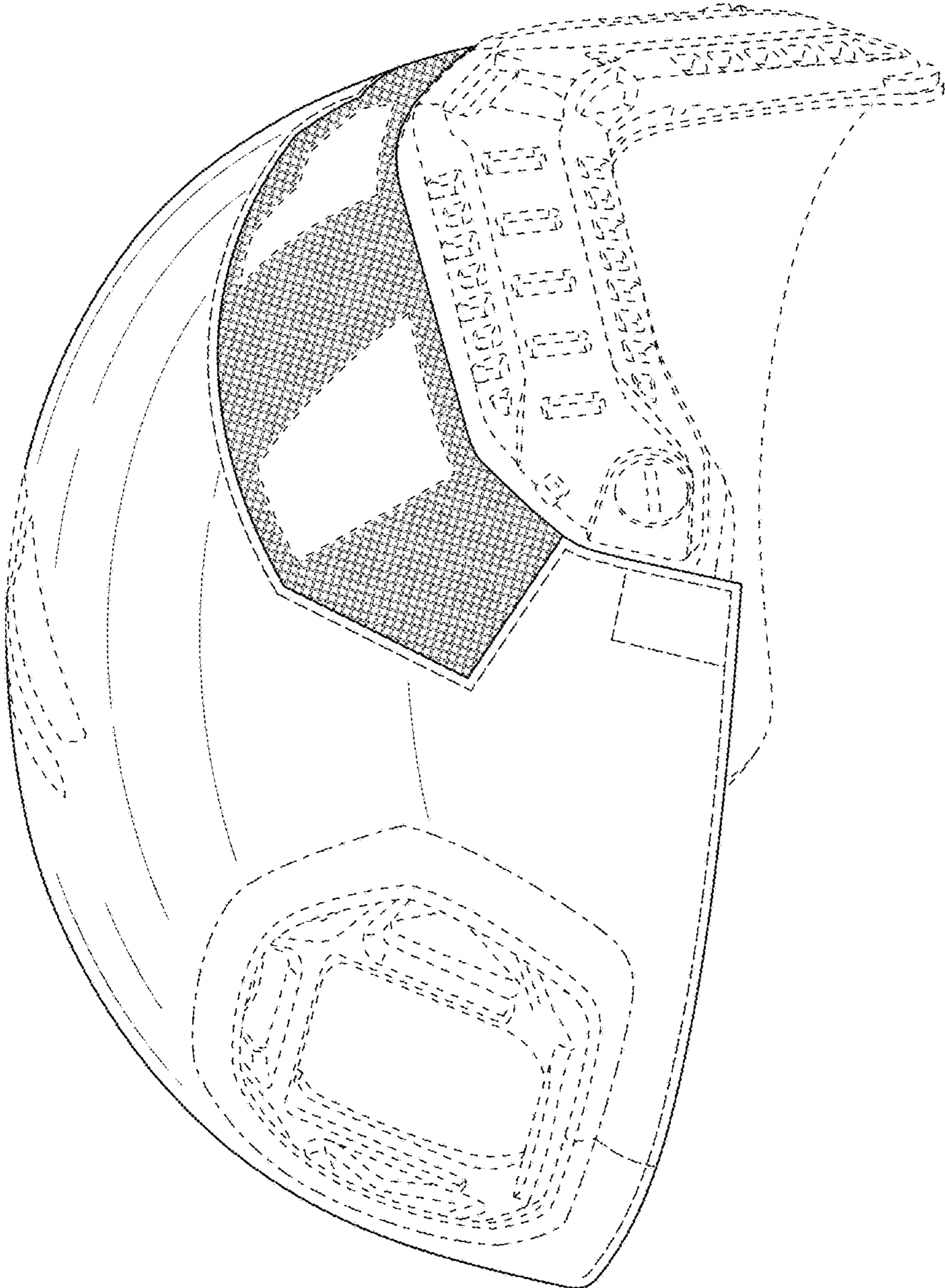

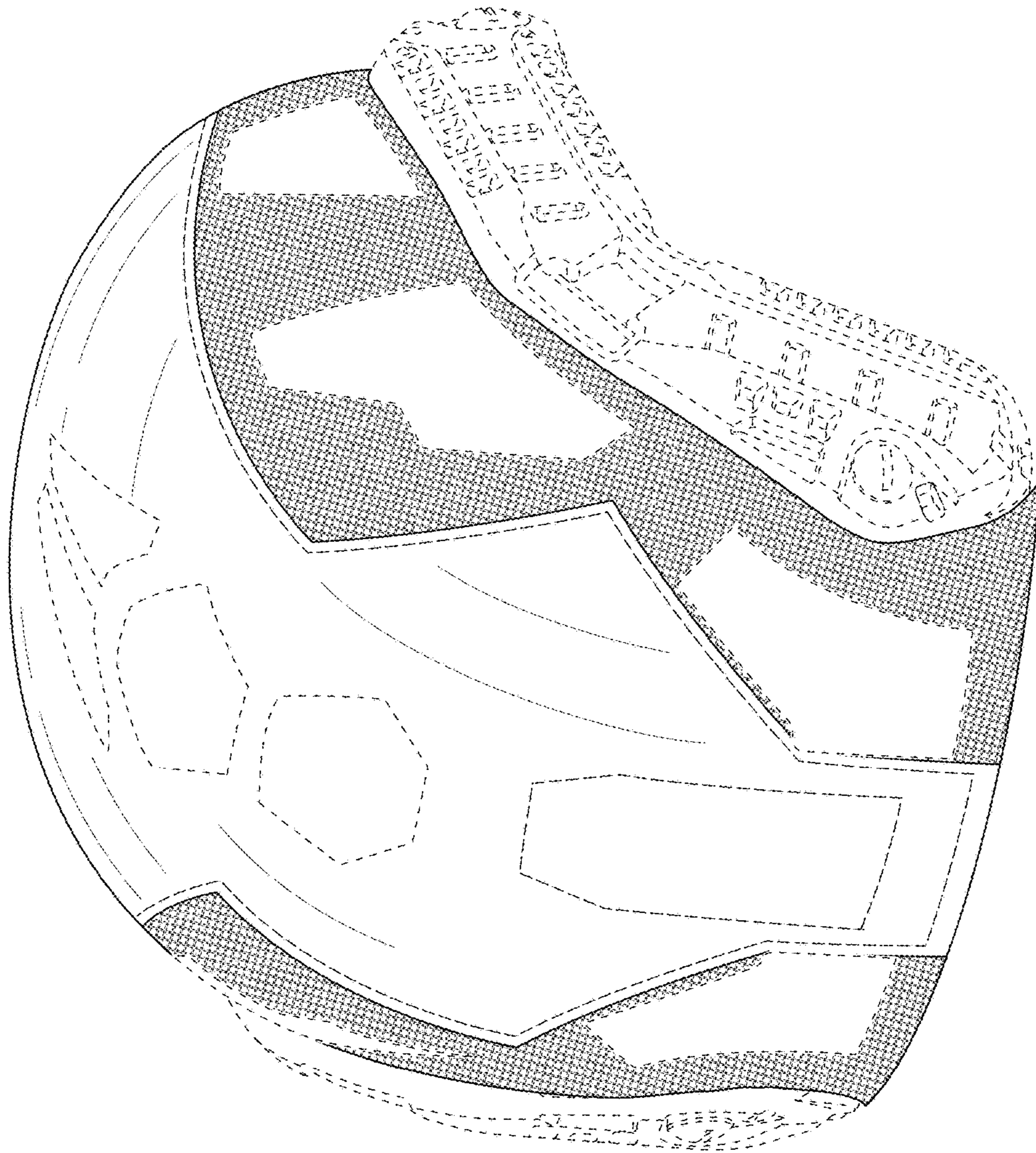

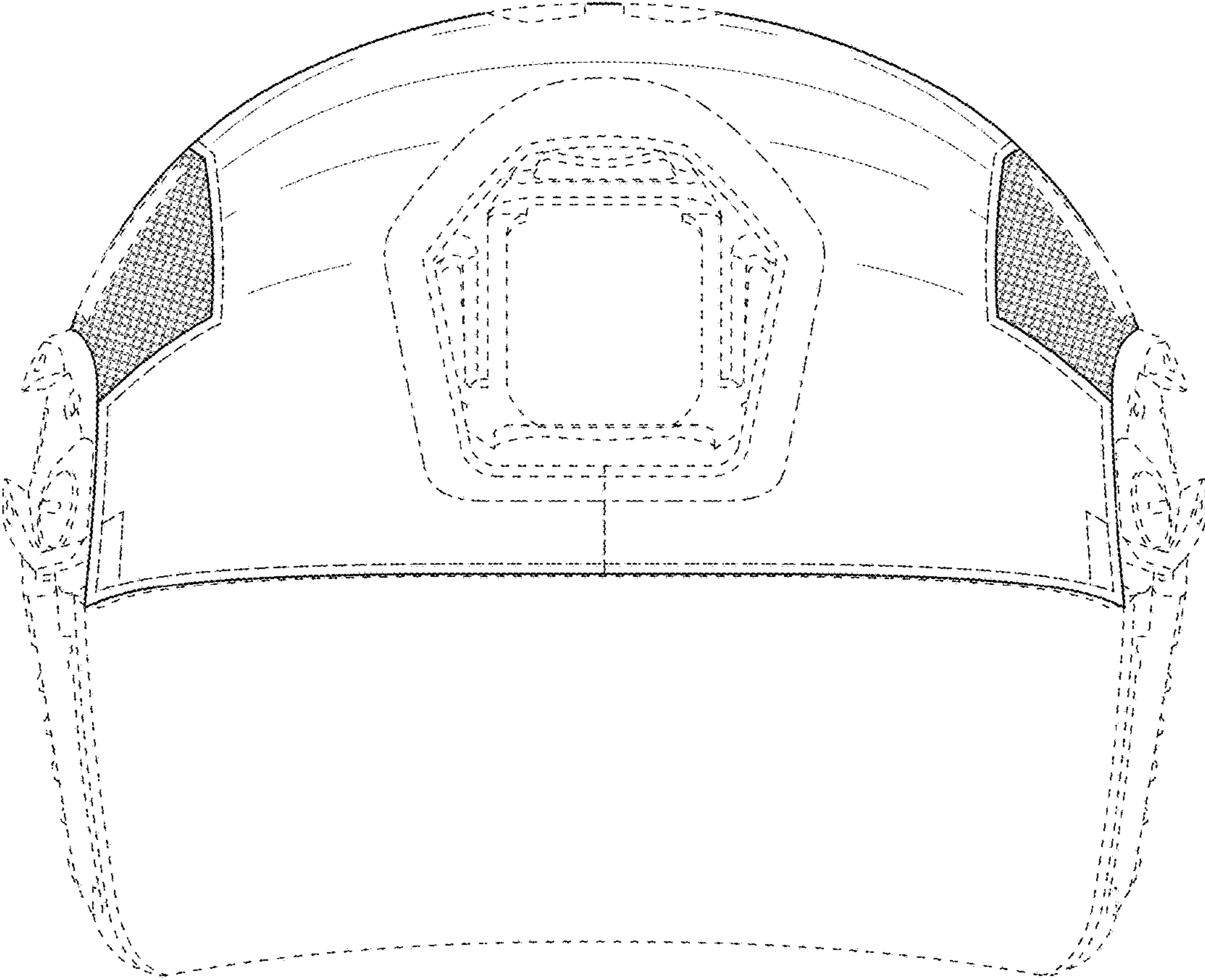

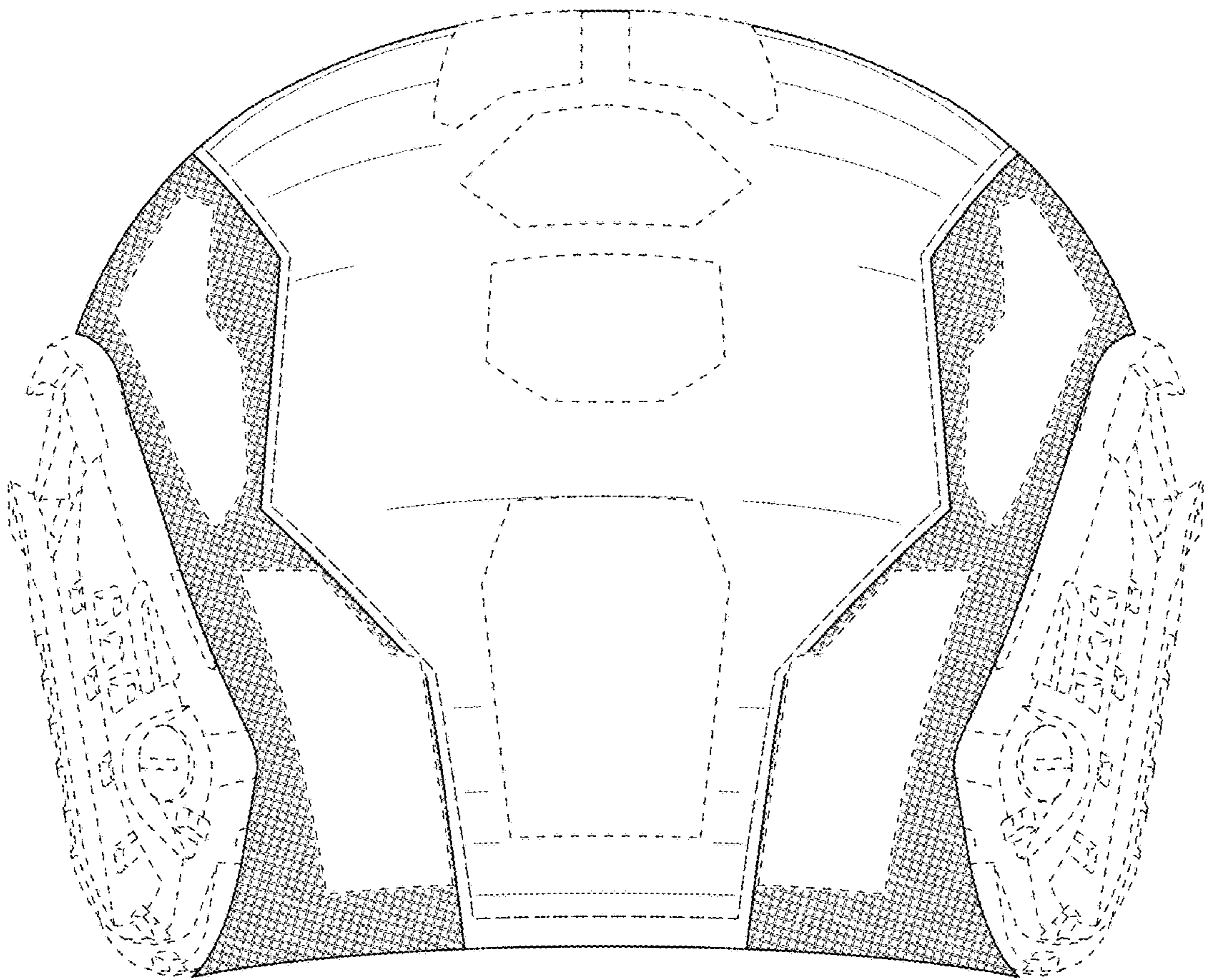

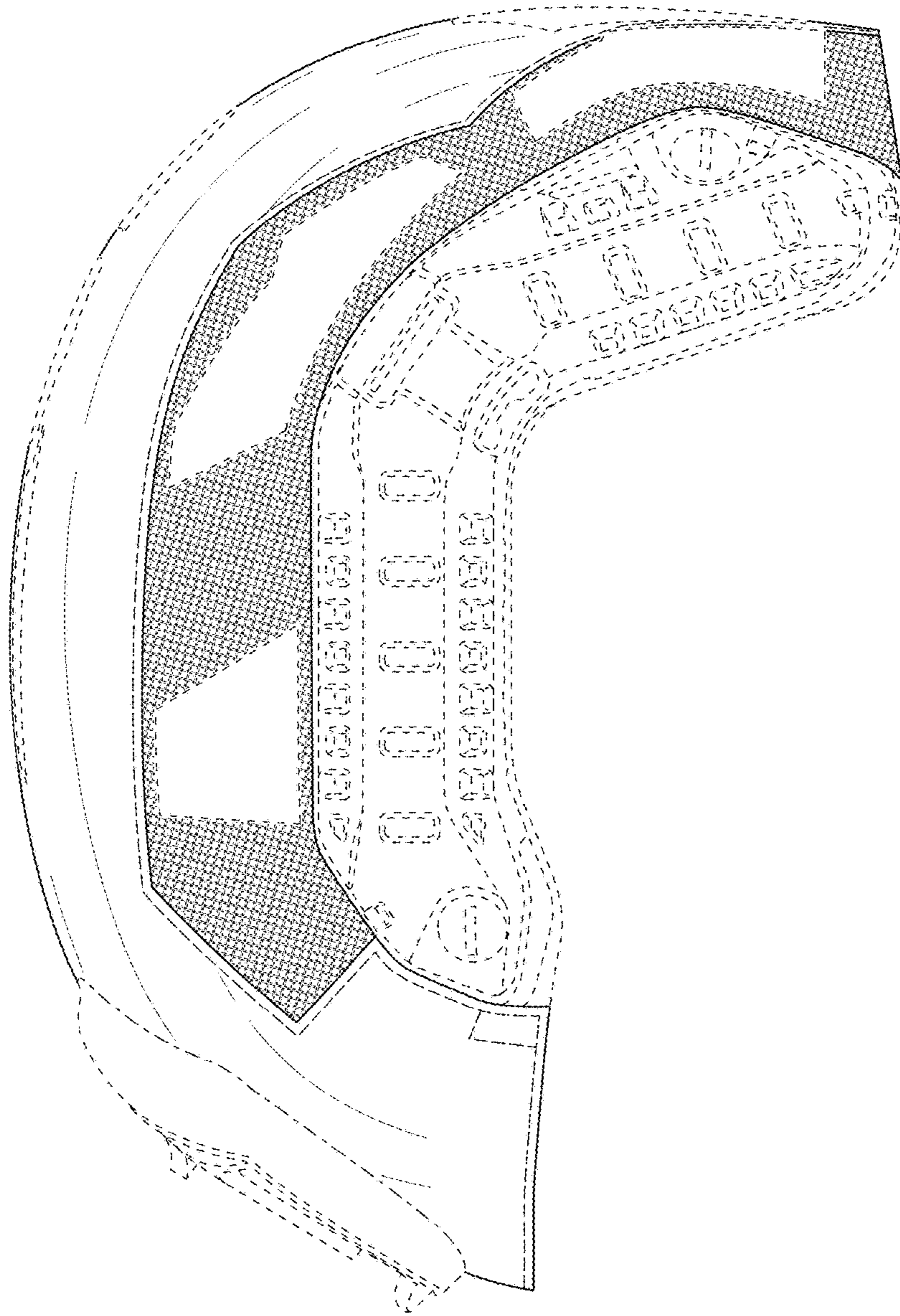

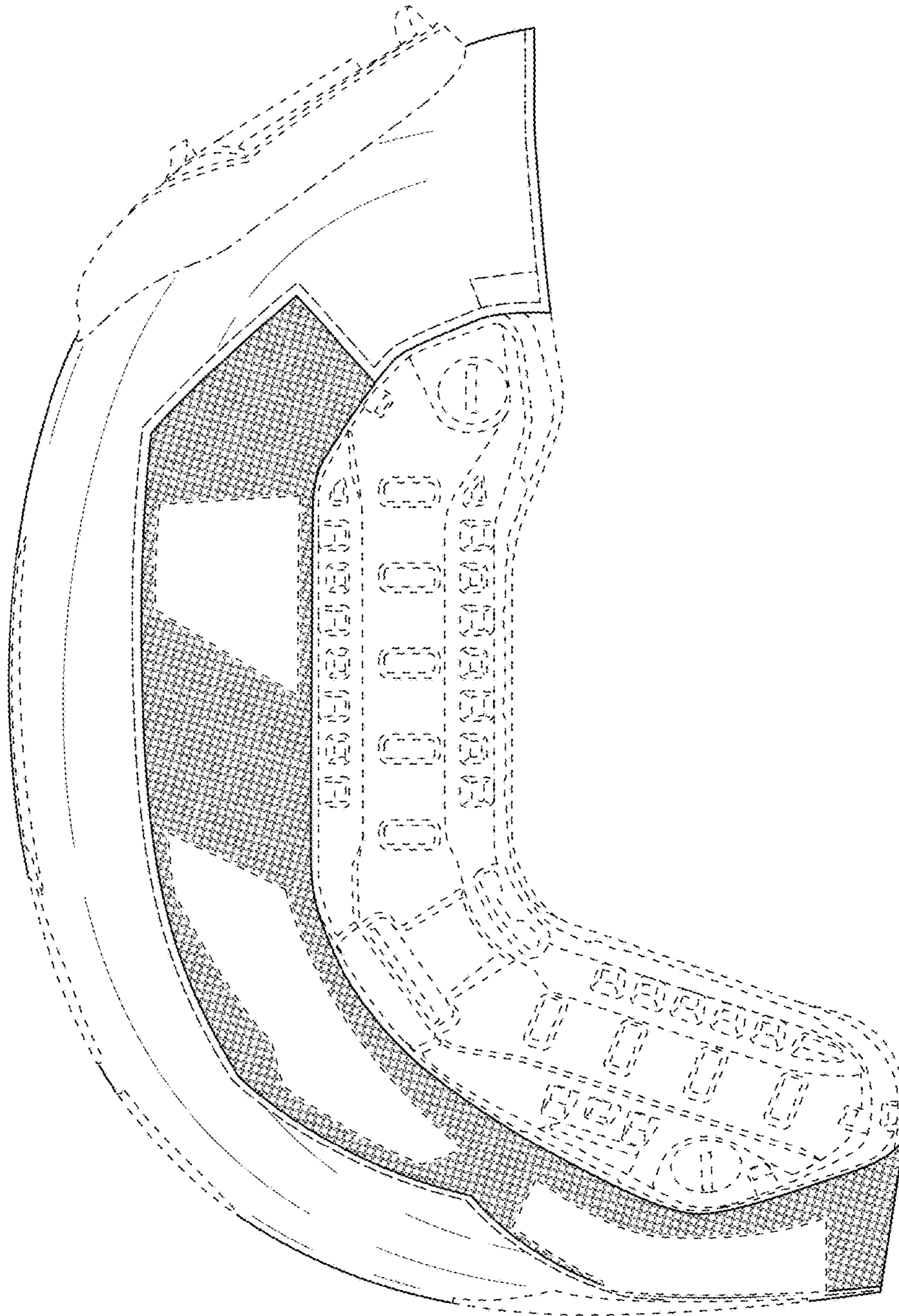

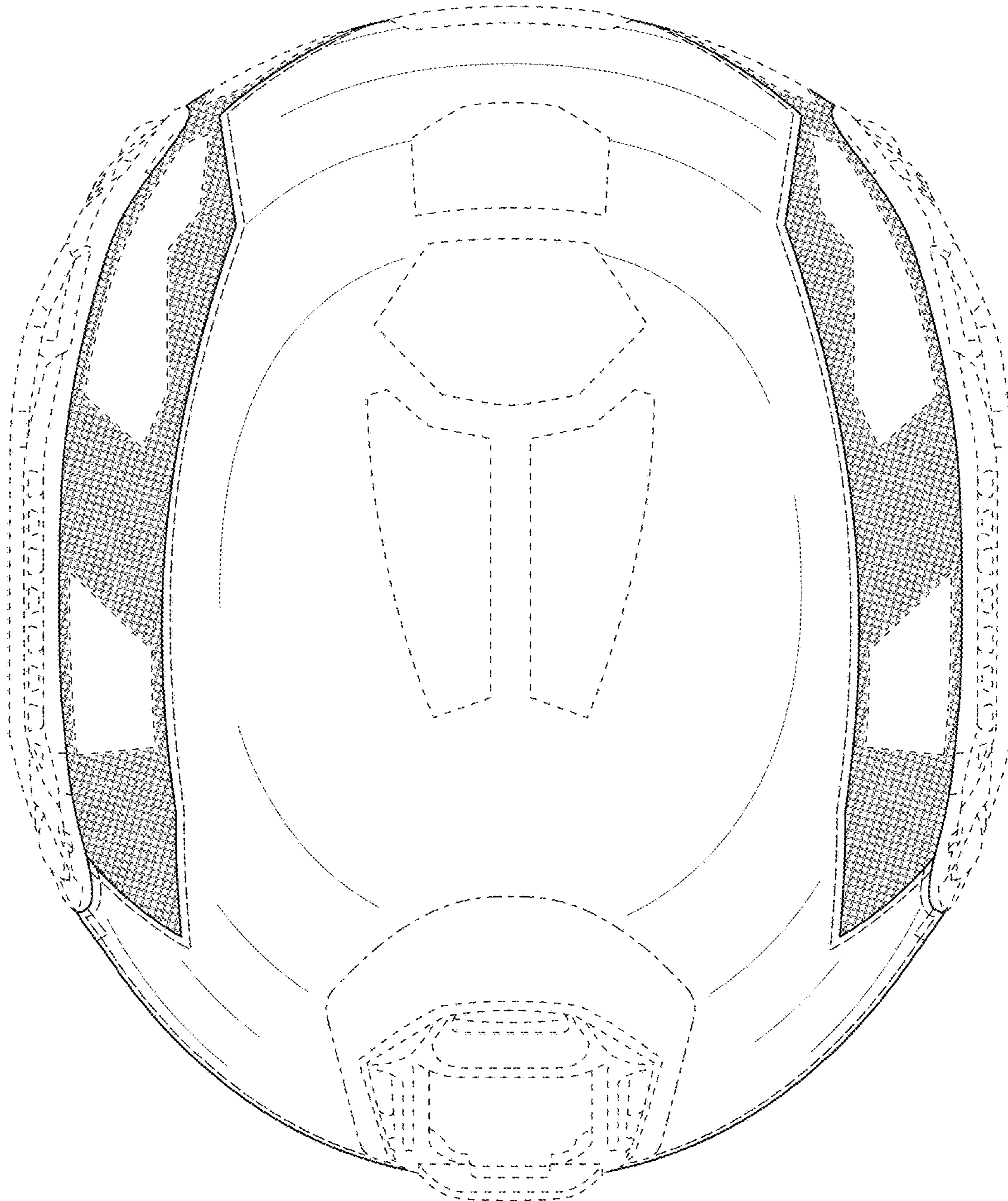

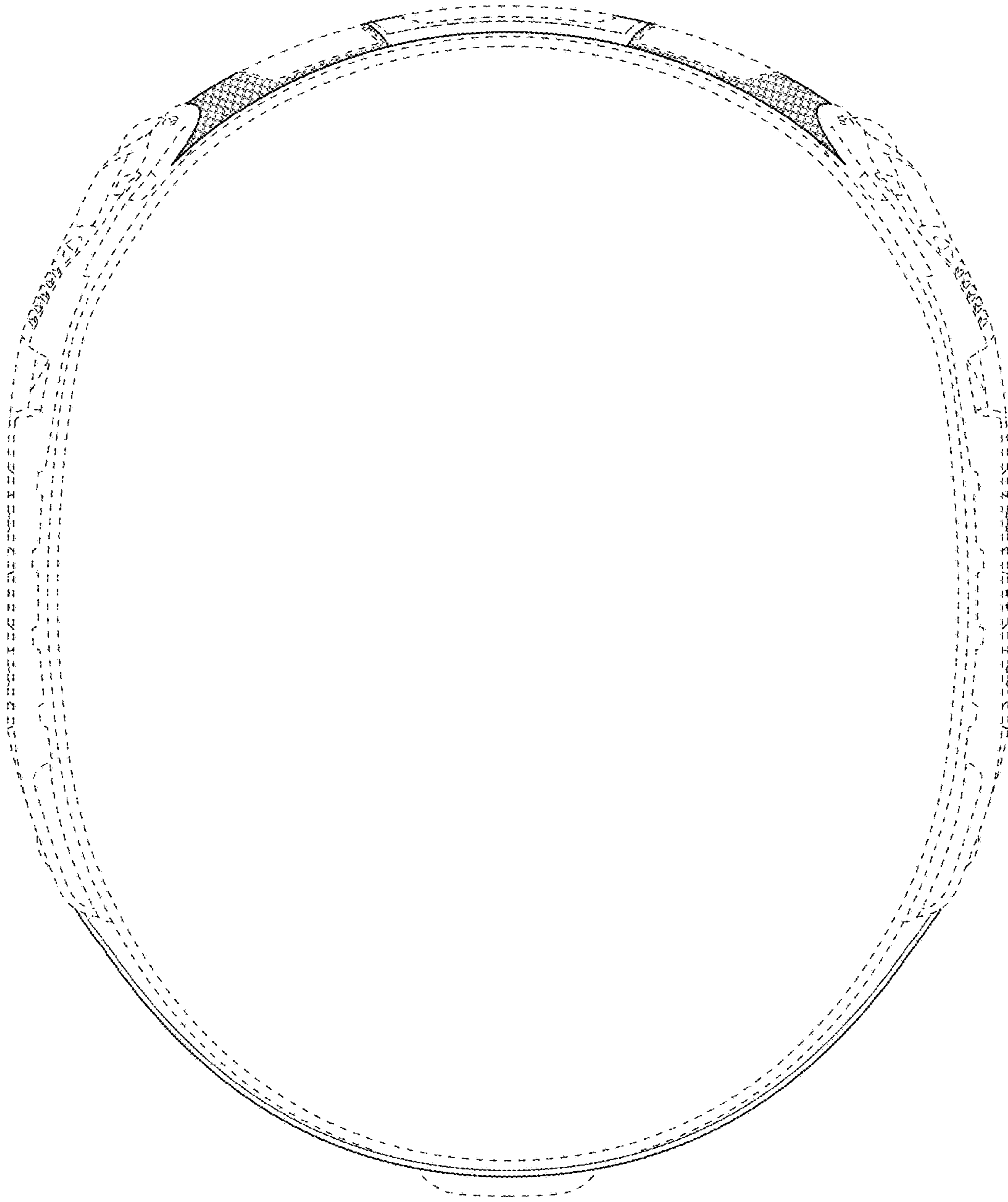
