We claim the ornamental design for a football helmet, as shown and described.

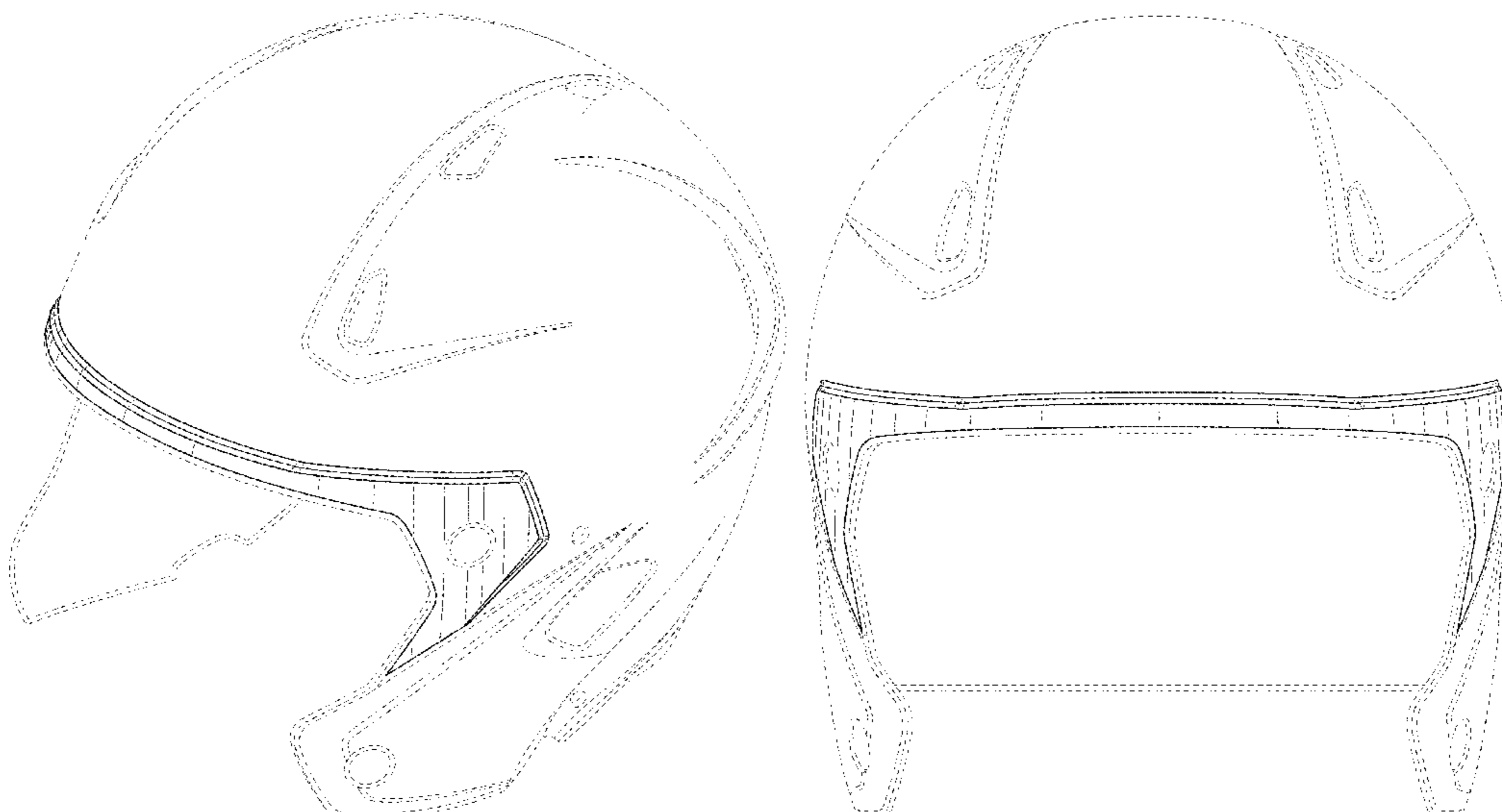
DESCRIPTION

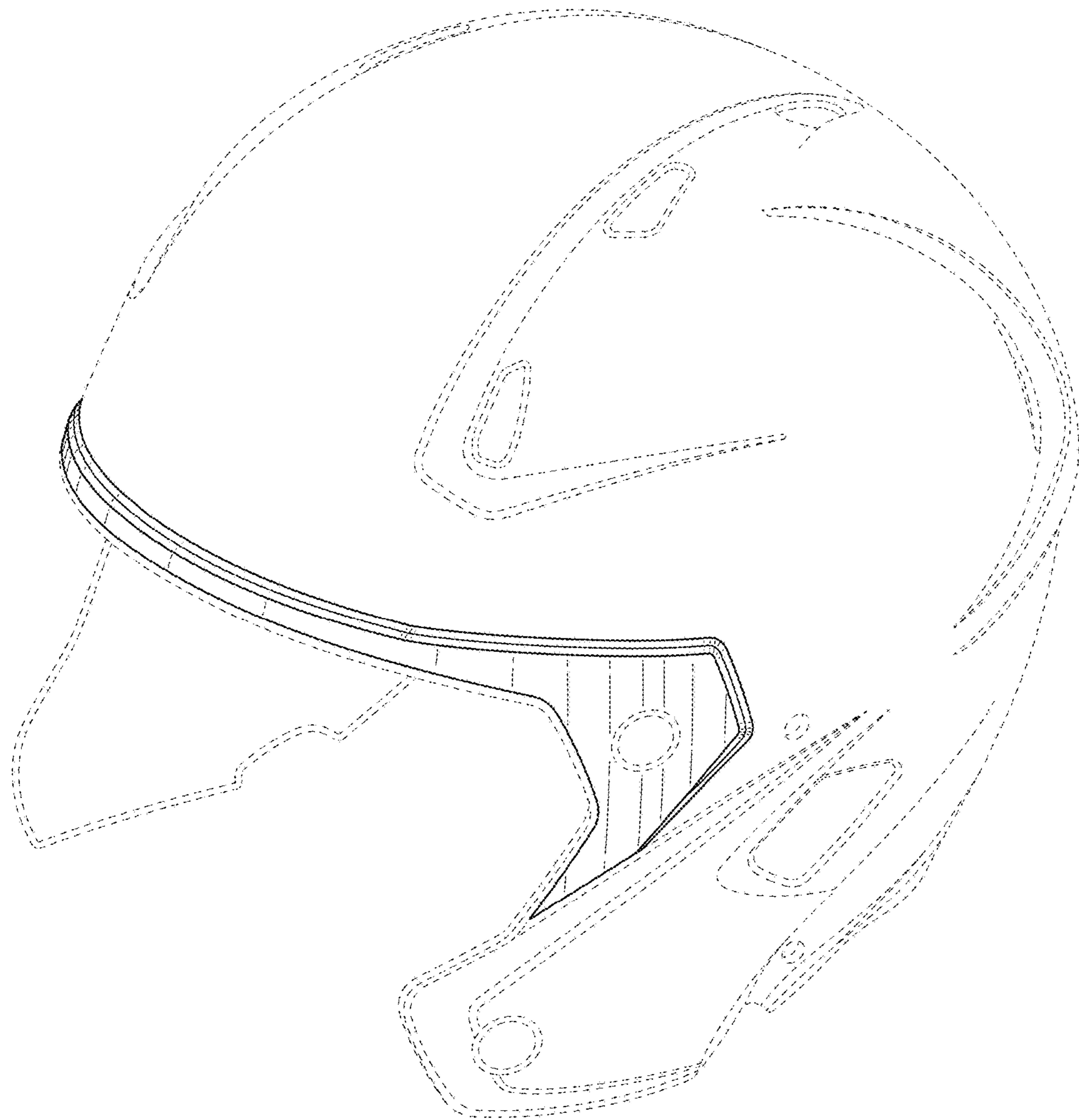

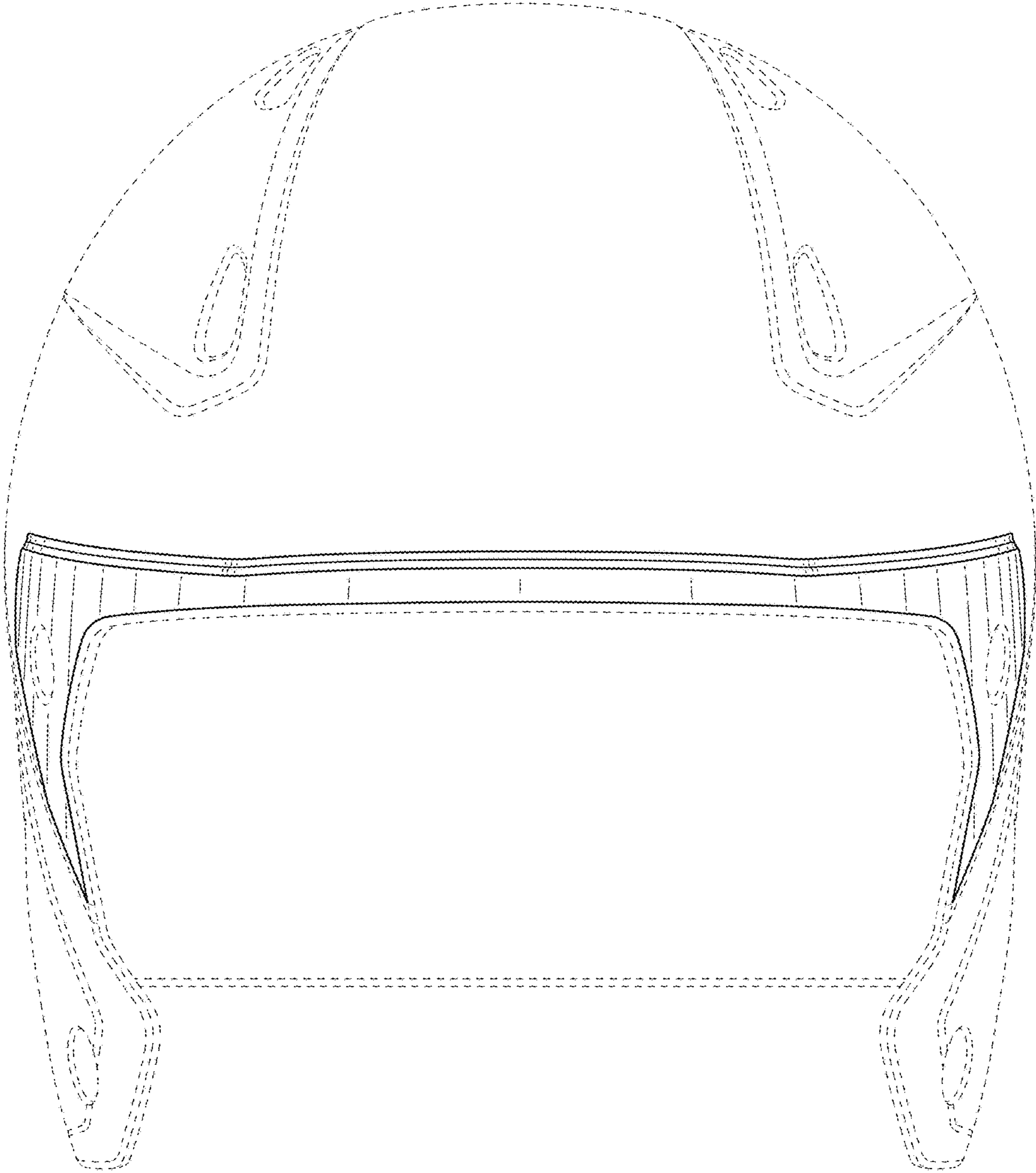

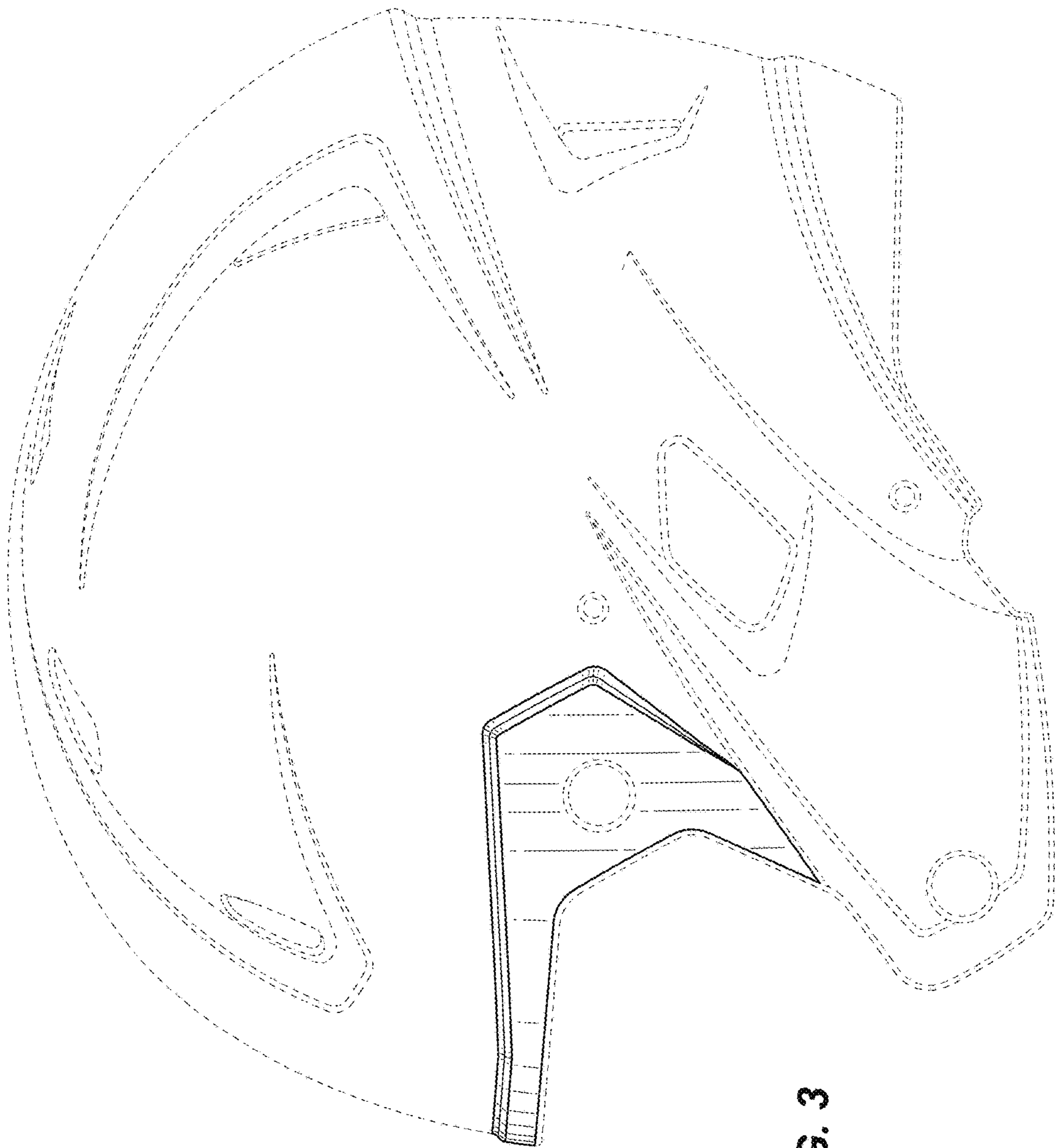

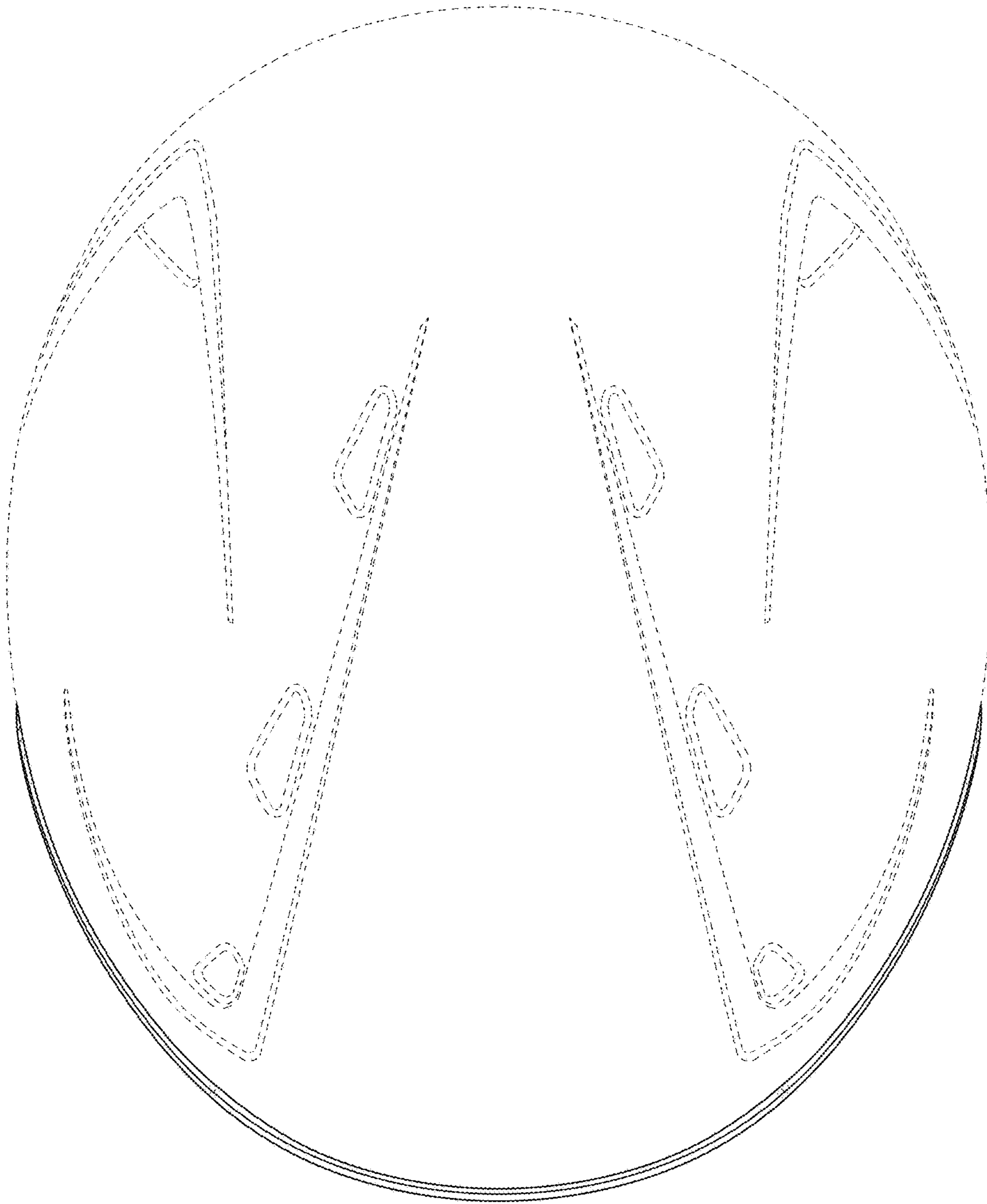

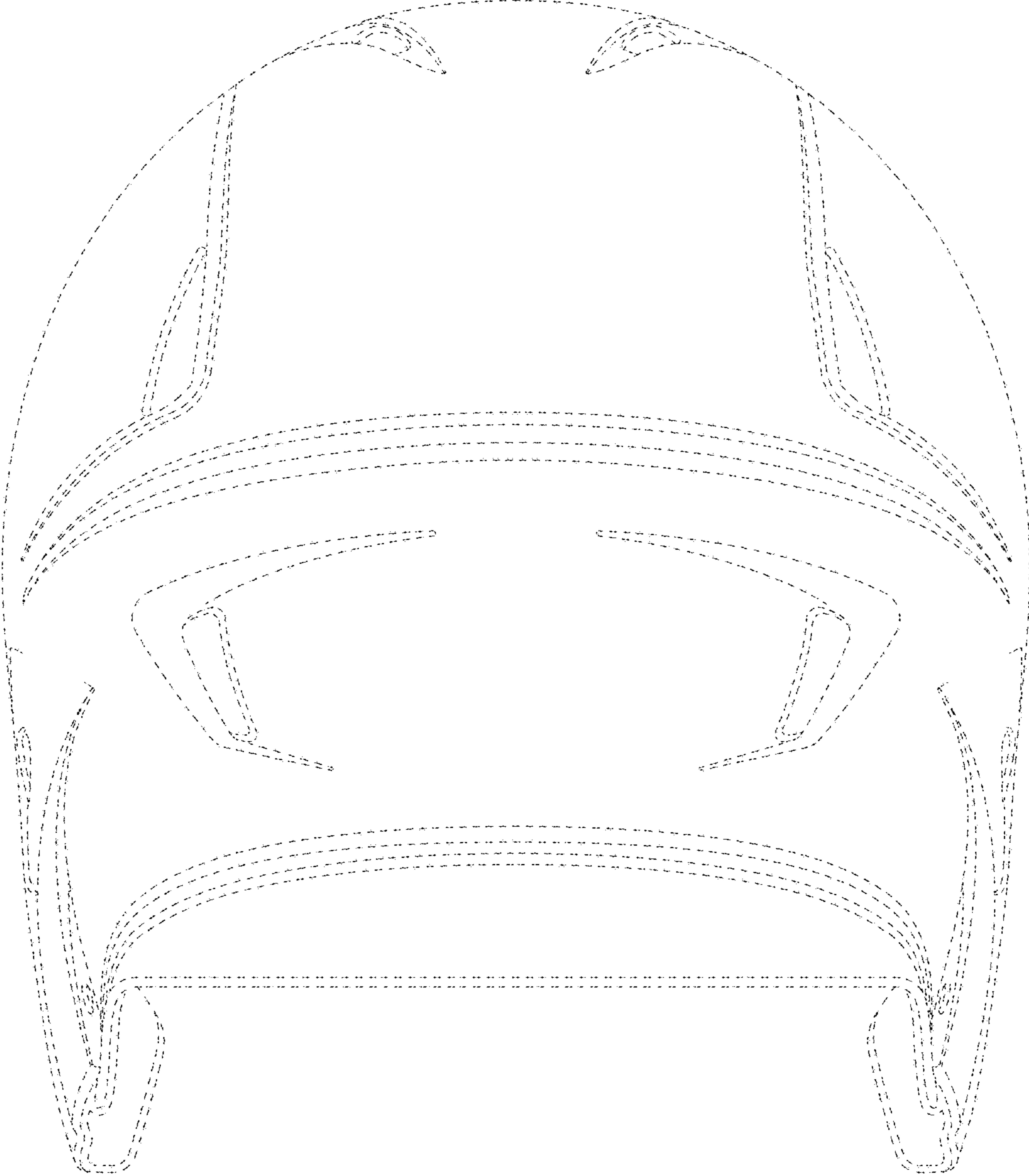

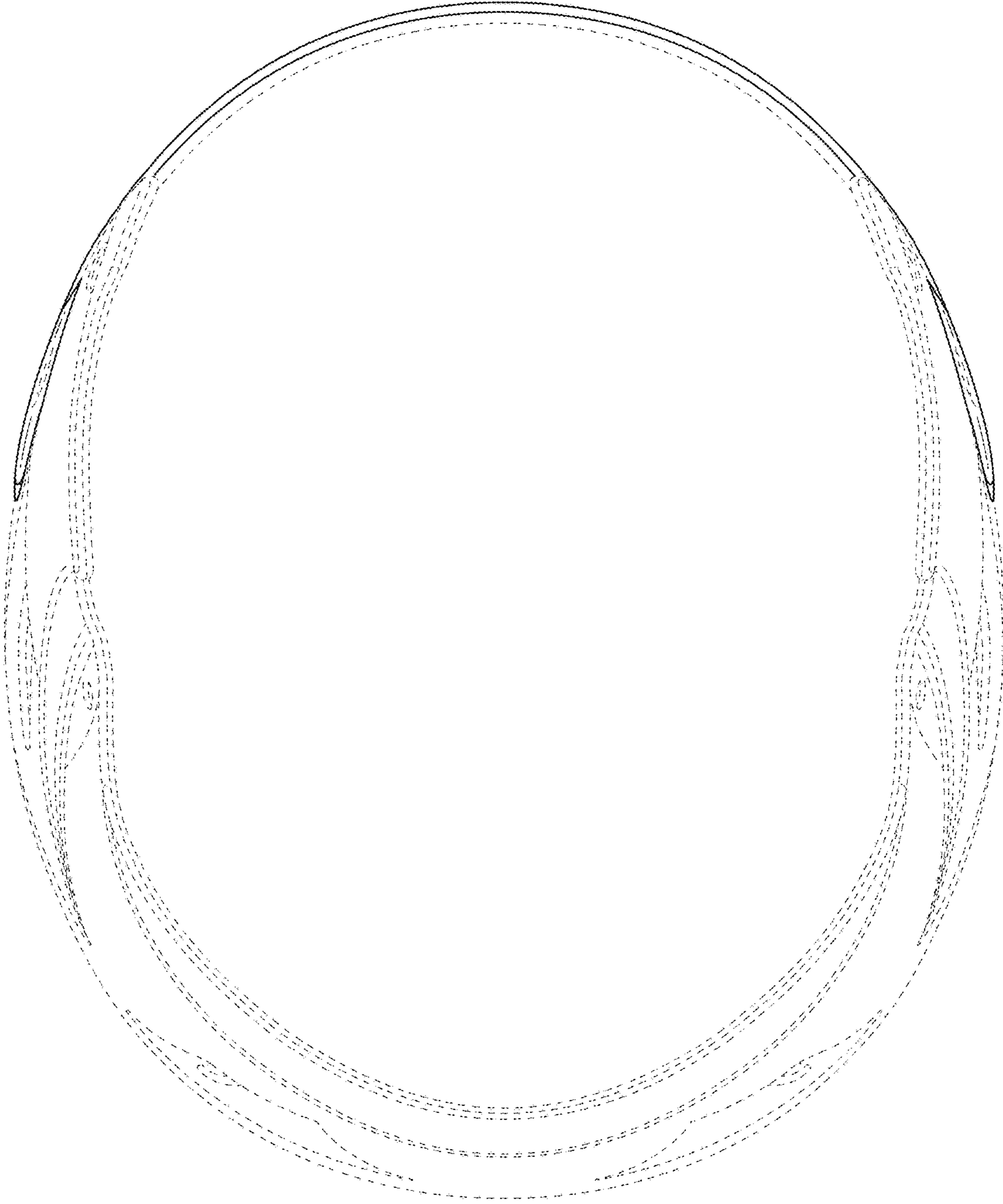
