(57) **CLAIM**

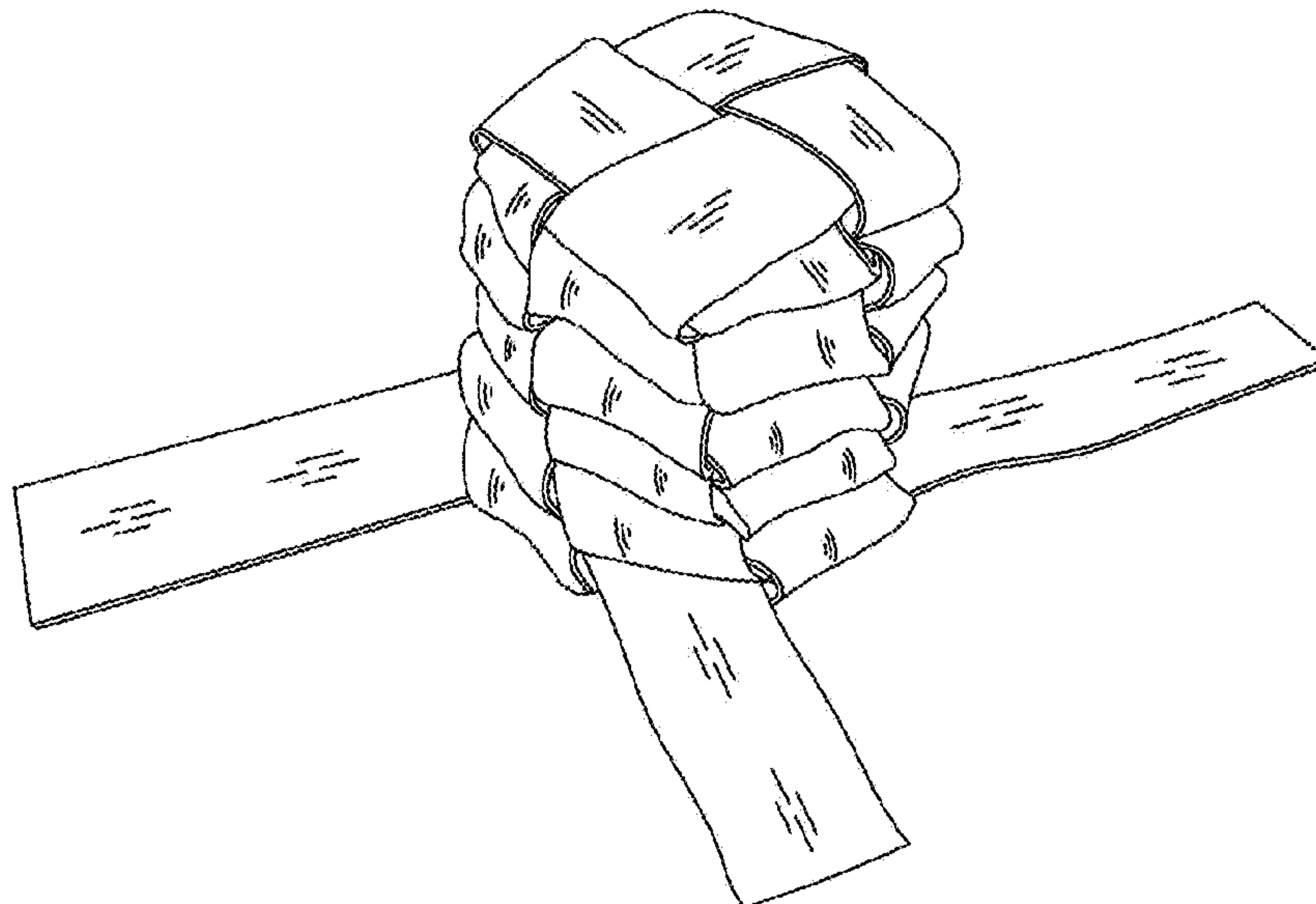
The ornamental design for a dog toy, substantially as shown and described.

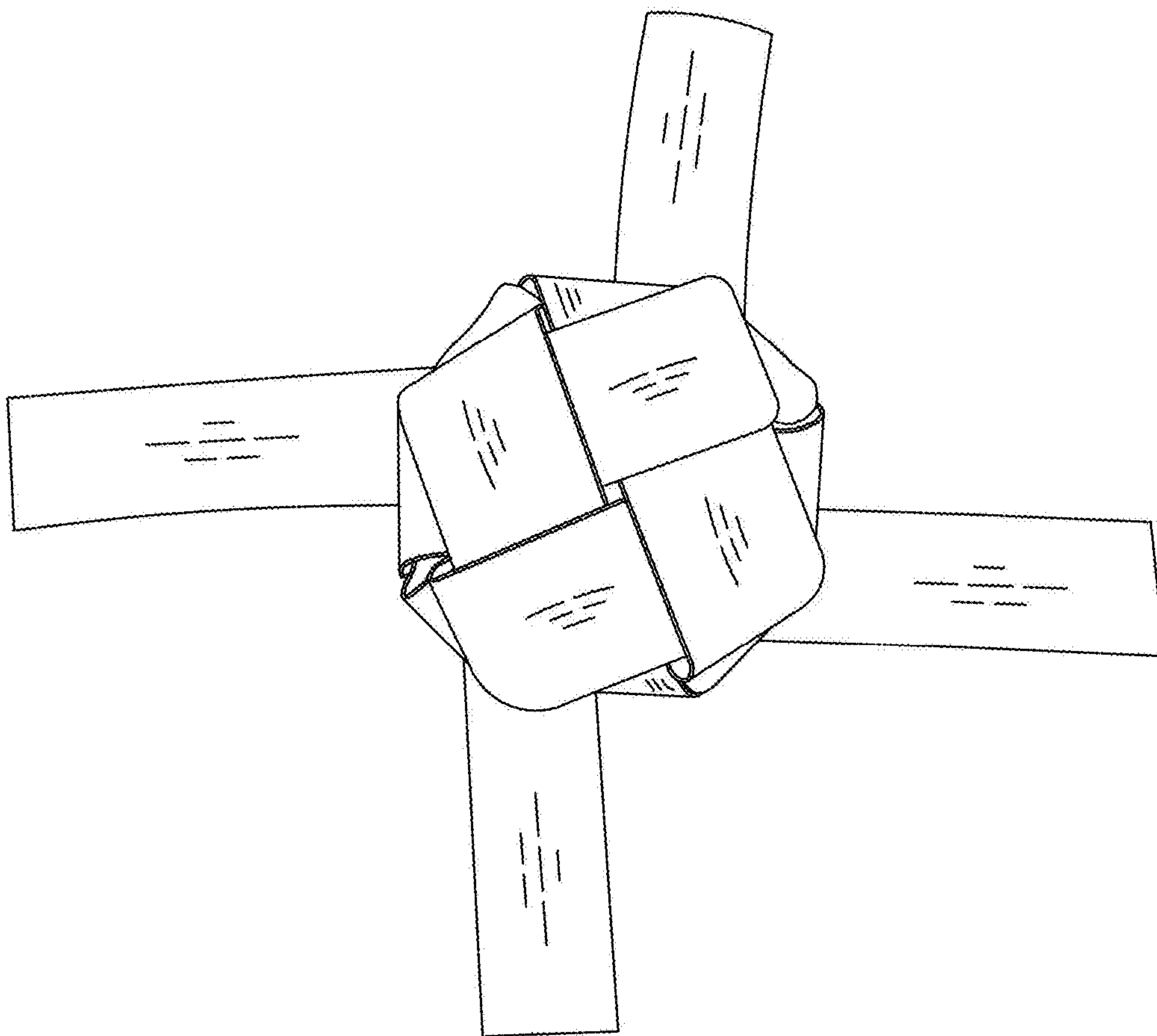

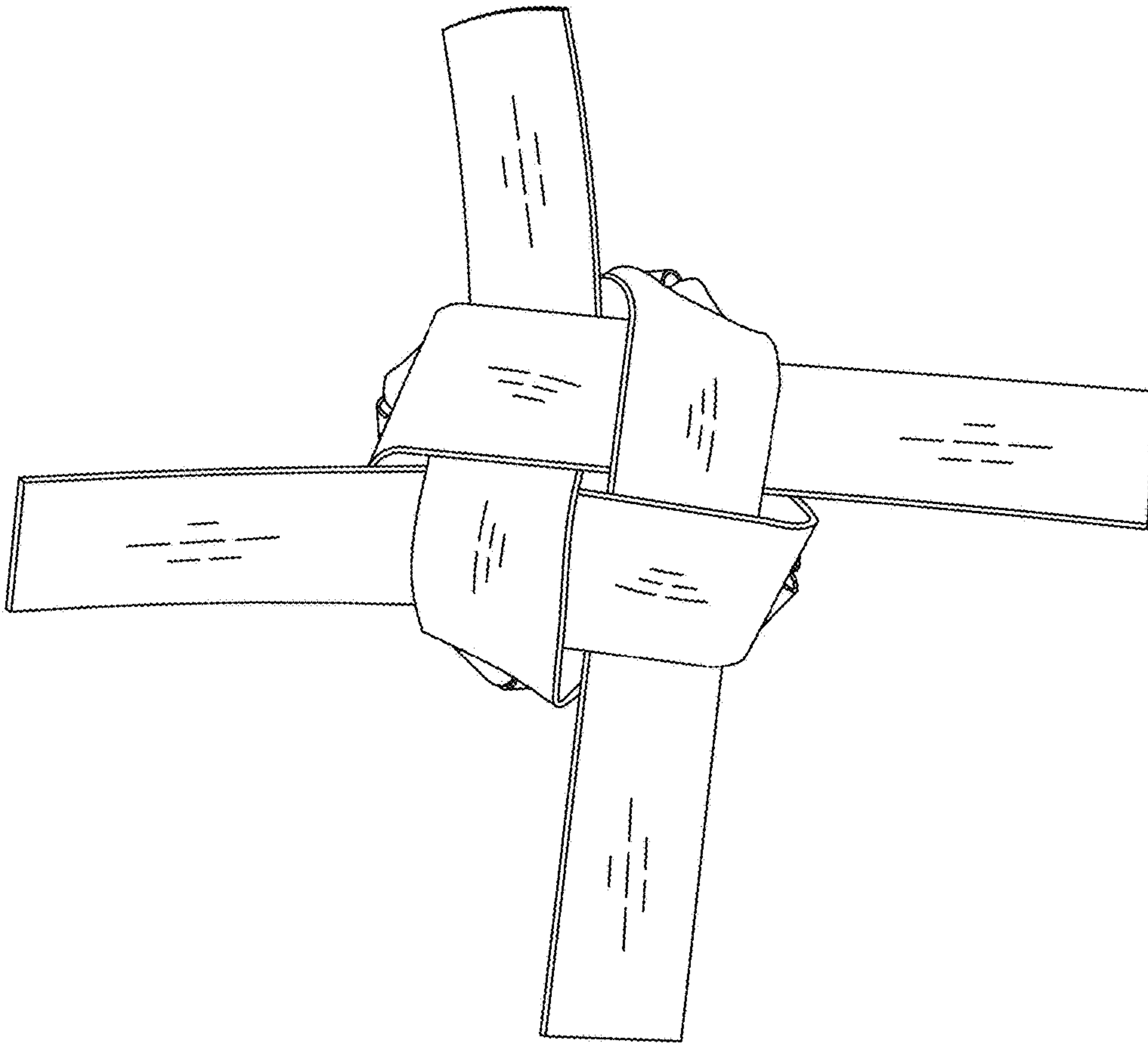

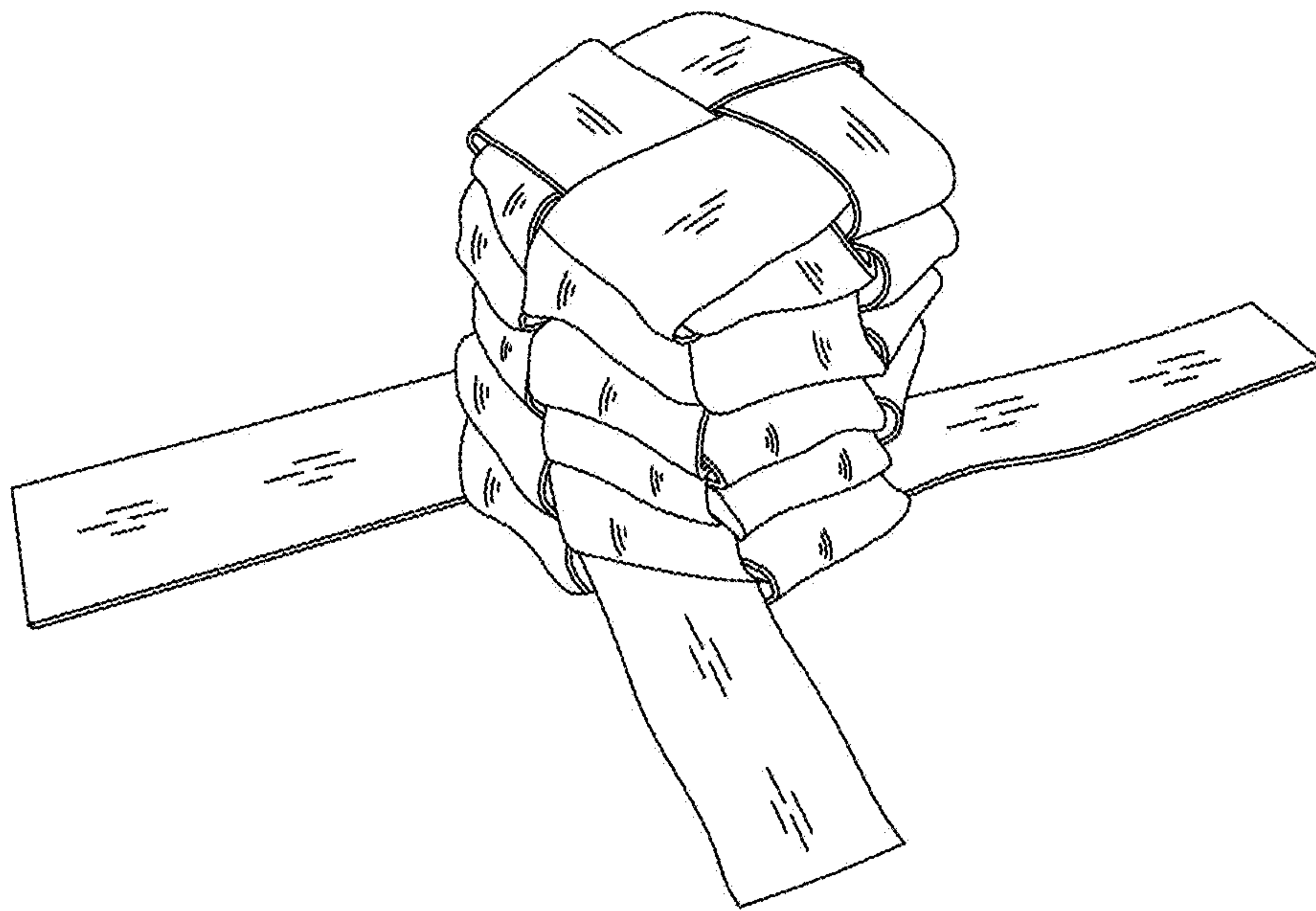

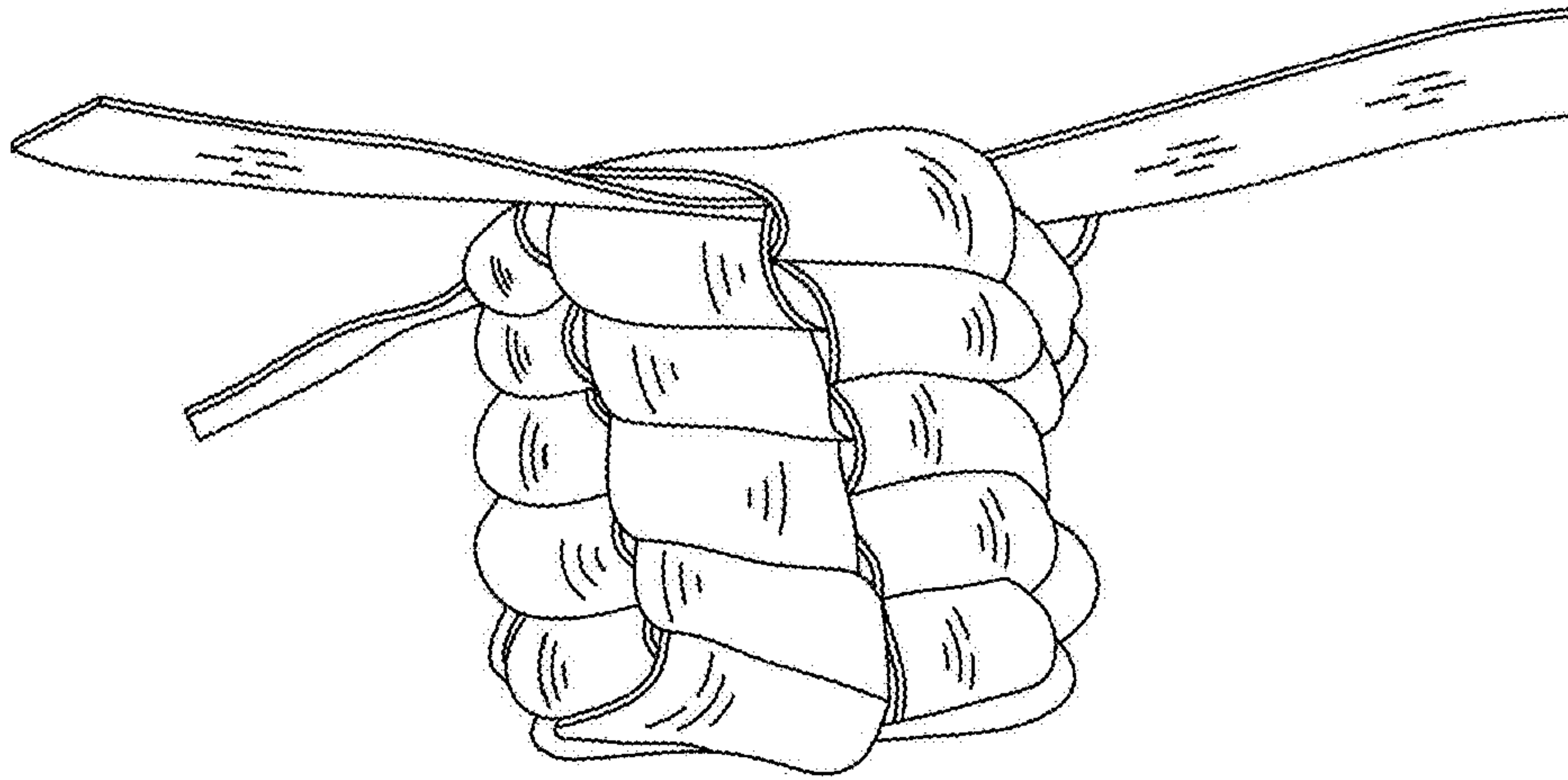
