(57) **CLAIM**

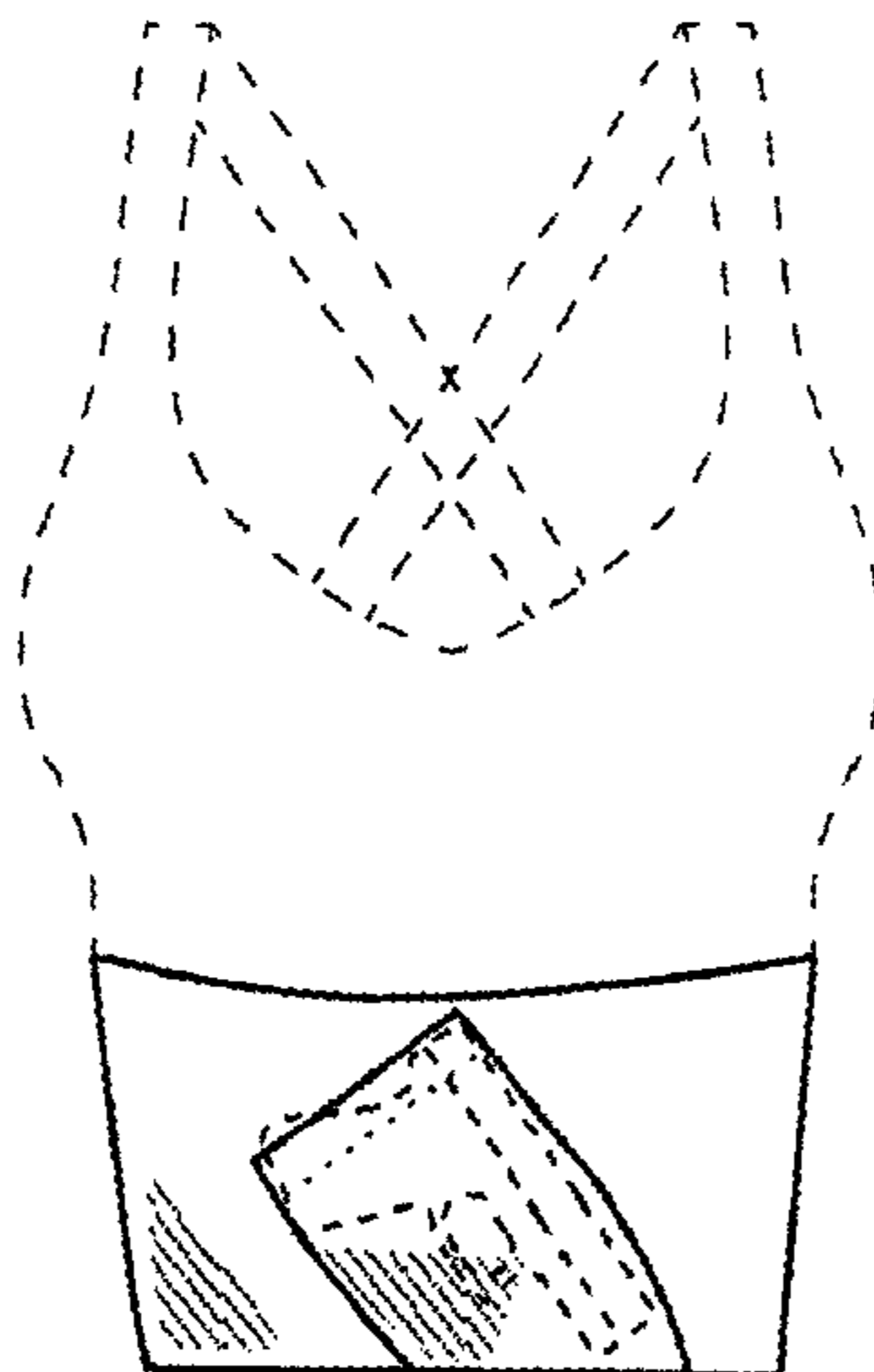
The ornamental design for a top with pocket for hand gun,
knife or spare magazine, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first embodiment of a top with pocket for hand gun, knife or spare magazine
 FIG. 2 is a rear view thereof;
 FIG. 3 is a right side view thereof;
 FIG. 4 is a left side view thereof;
 FIG. 5 is a three- quarter front view of a second embodiment of a top with pocket for hand gun, knife or spare magazine
 FIG. 6 is a rear view thereof;
 FIG. 7 is a right side view thereof;
 FIG. 8 is a left side view thereof.
 FIG. 9 is a front view of a third embodiment of a top with pocket for hand gun, knife or spare magazine;
 FIG. 10 is a rear view thereof;
 FIG. 11 is a right side view thereof;
 FIG. 12 is a left side view thereof.
 FIG. 13 is a front view of a fourth embodiment of a top with pocket for hand gun, knife or spare magazine;
 FIG. 14 is a rear view thereof;
 FIG. 15 is a right side view thereof;
 FIG. 16 is a left side view thereof.
 FIG. 17 is a right flat side view thereof;
 FIG. 18 is a flat left side view thereof;
 FIG. 19 is a top view thereof;
 FIG. 20 is a bottom view thereof.
 FIG. 21 is an embodiment of the pocket, with the hand gun outside the pocket; and,
 FIG. 22 is an embodiment of the pocket with the hand gun inserted.

In all the FIGURES, the small dashed lines shown directly on the surface of the claimed article, throughout the views, are understood to represent stitching that forms part of the claim. The broken lines showing the hand gun, garment and straps in the figures form no part of the claimed design.

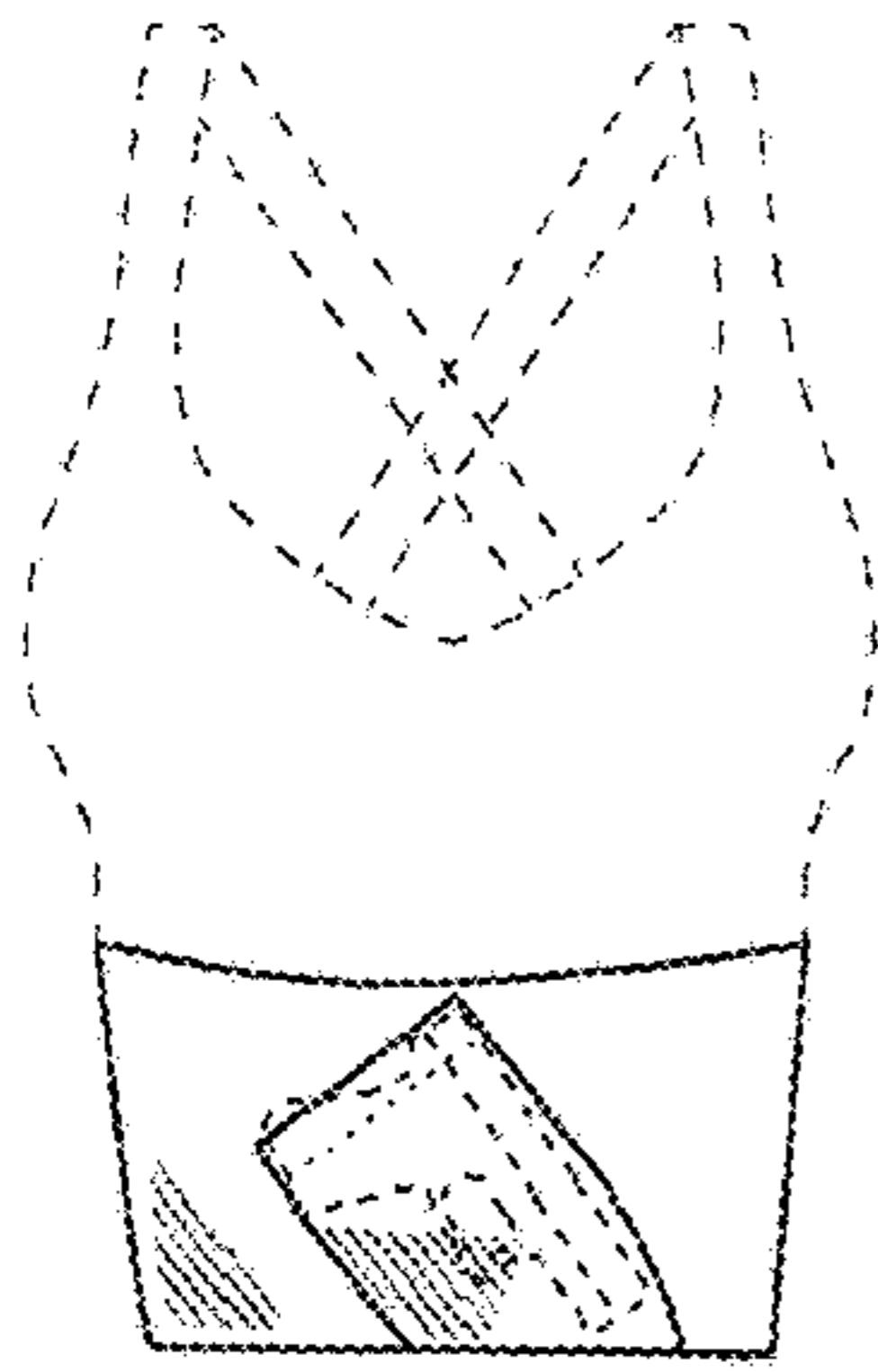

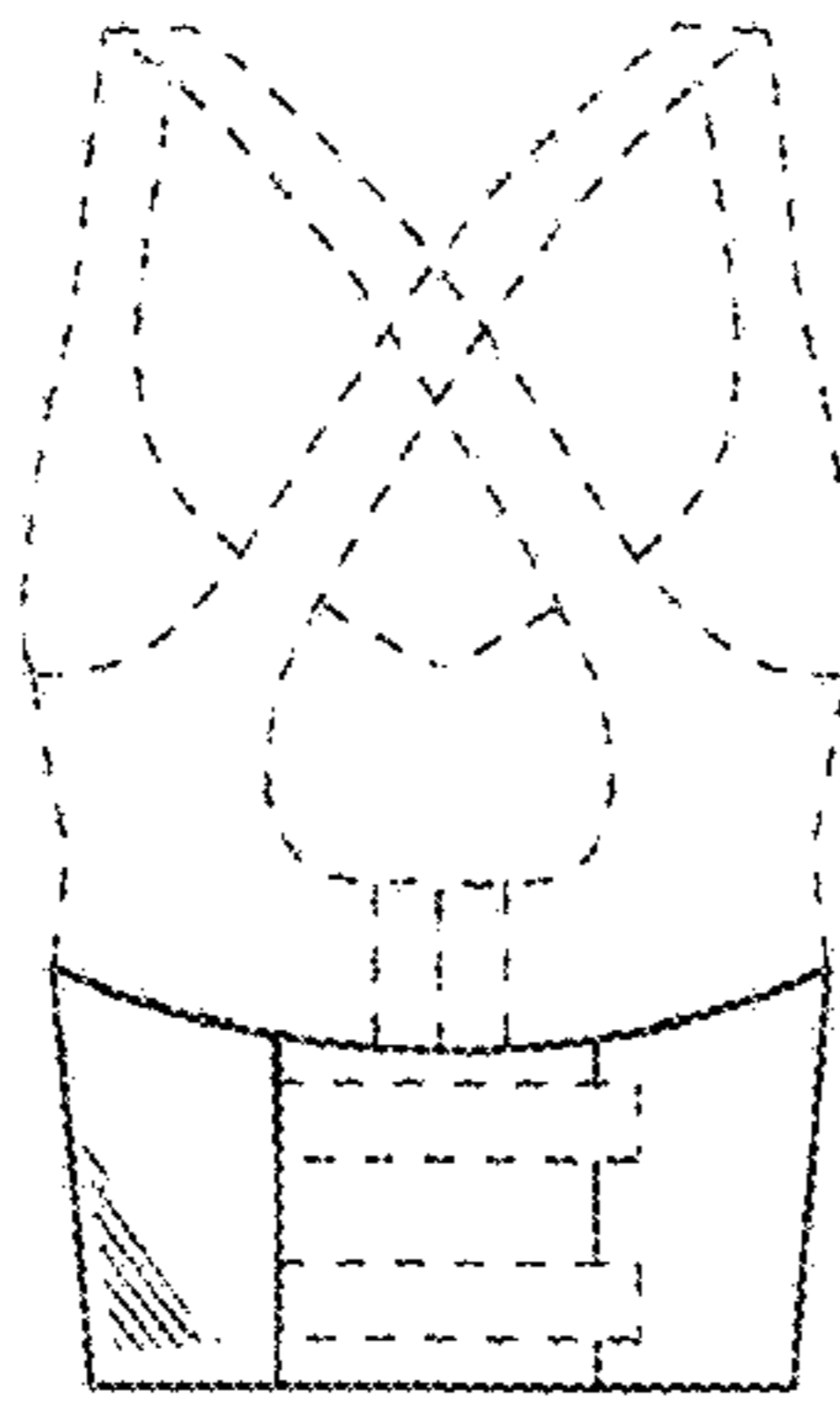

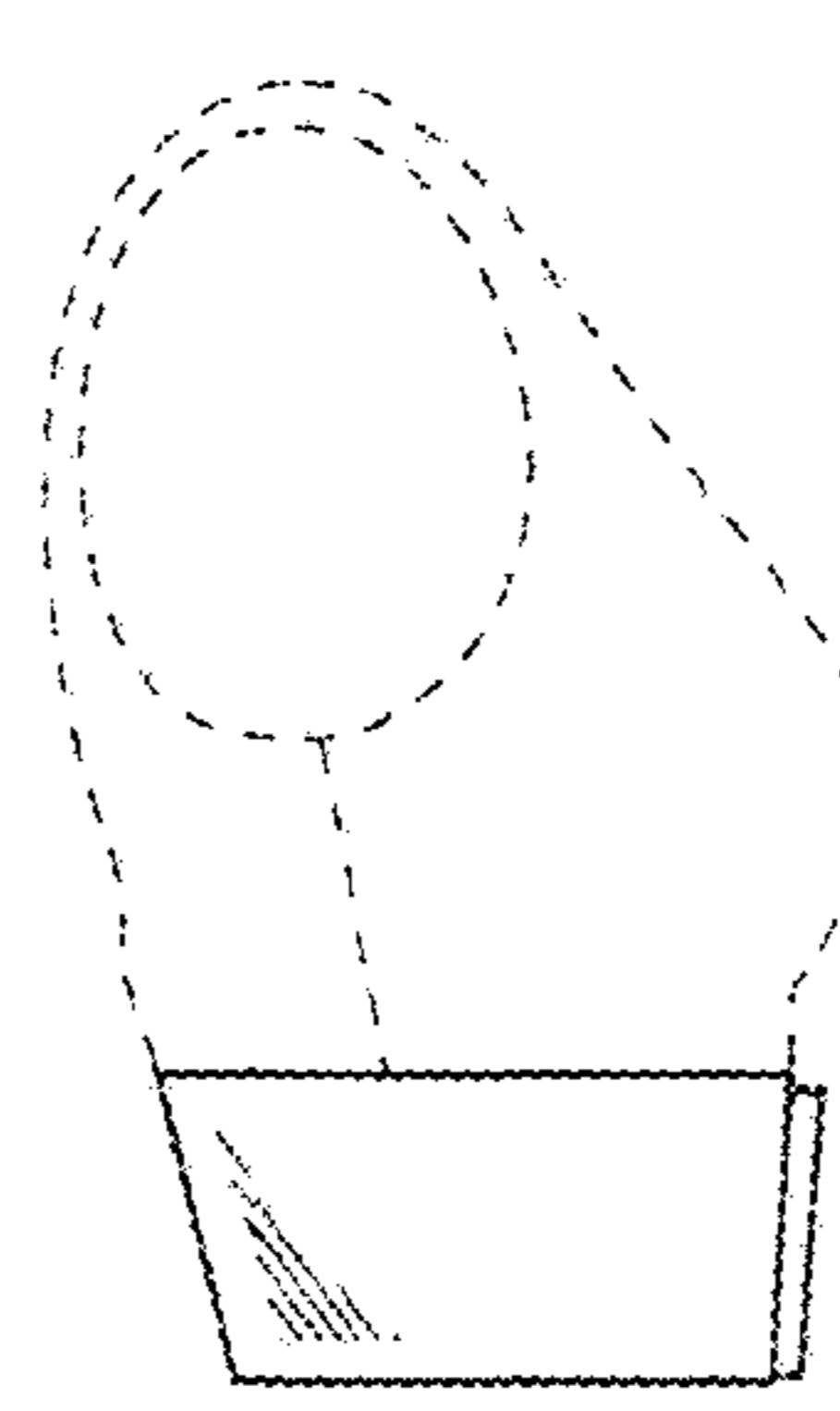

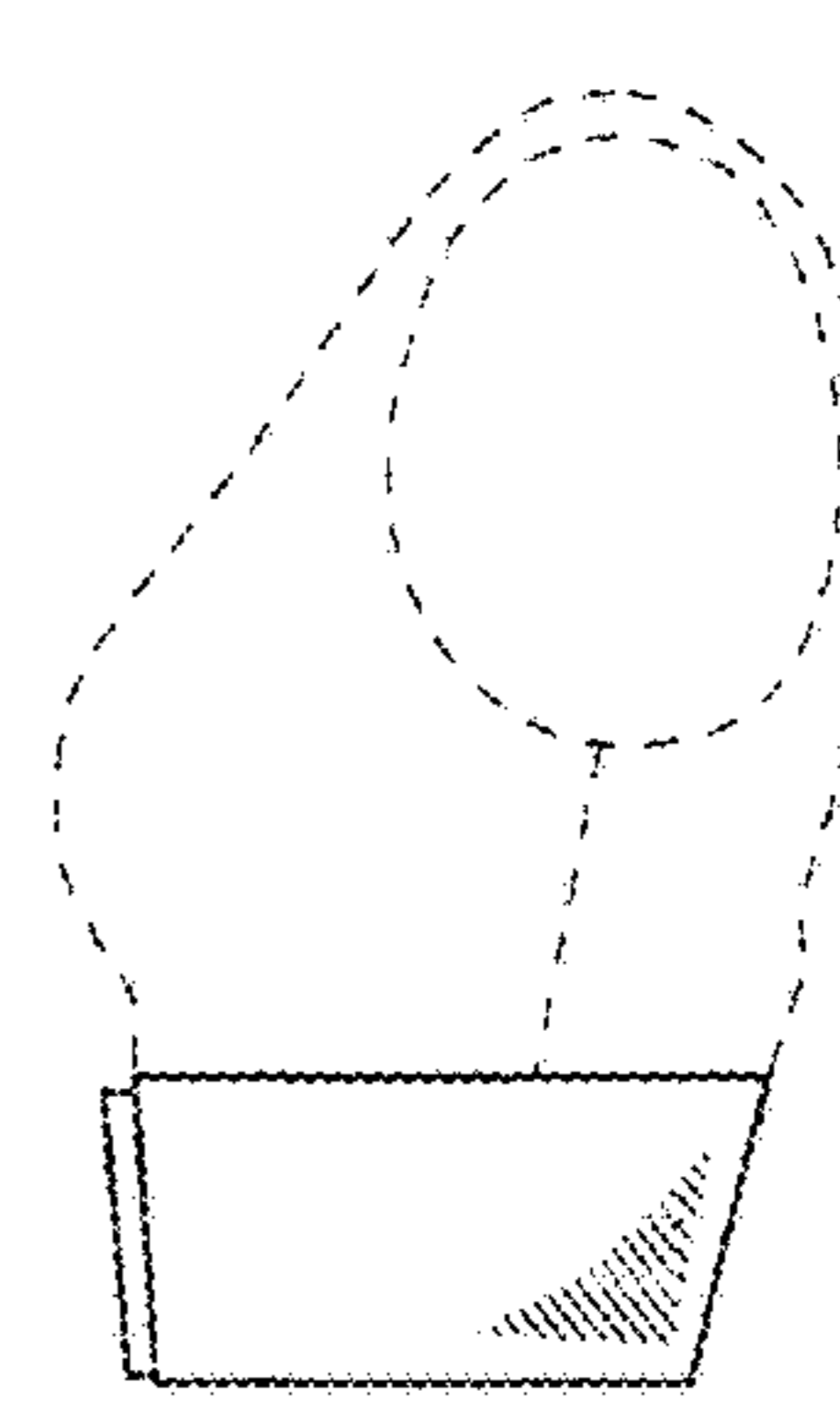

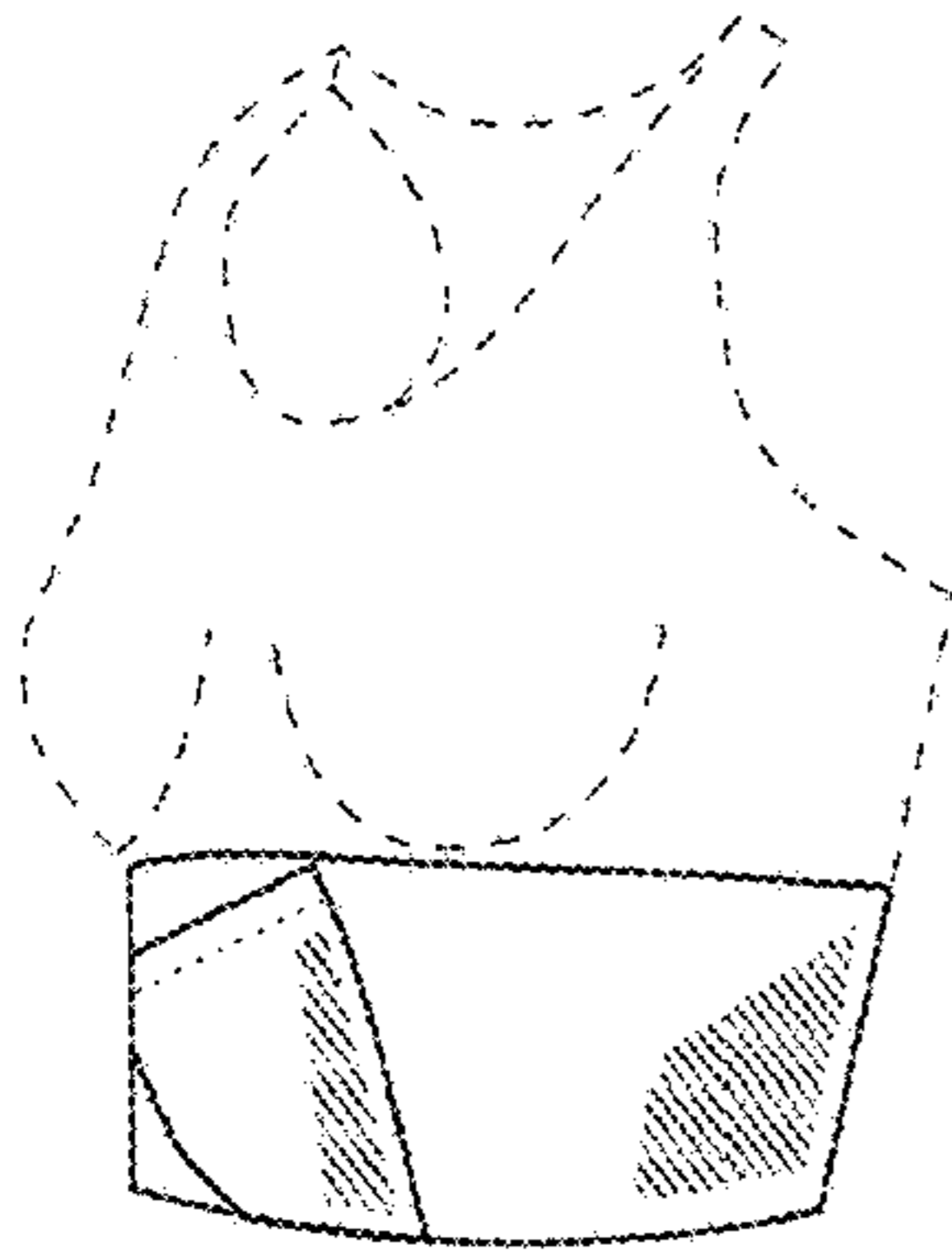

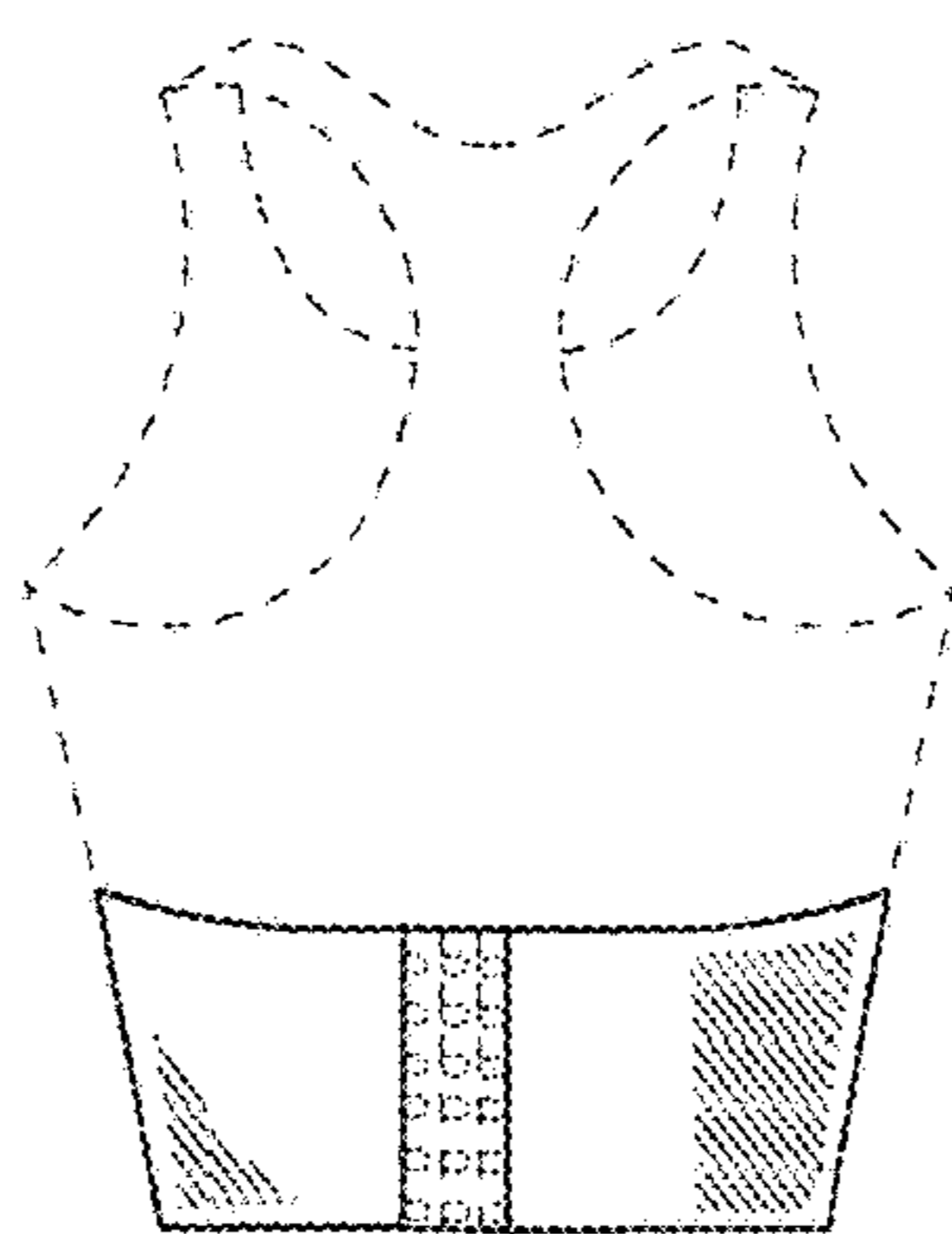

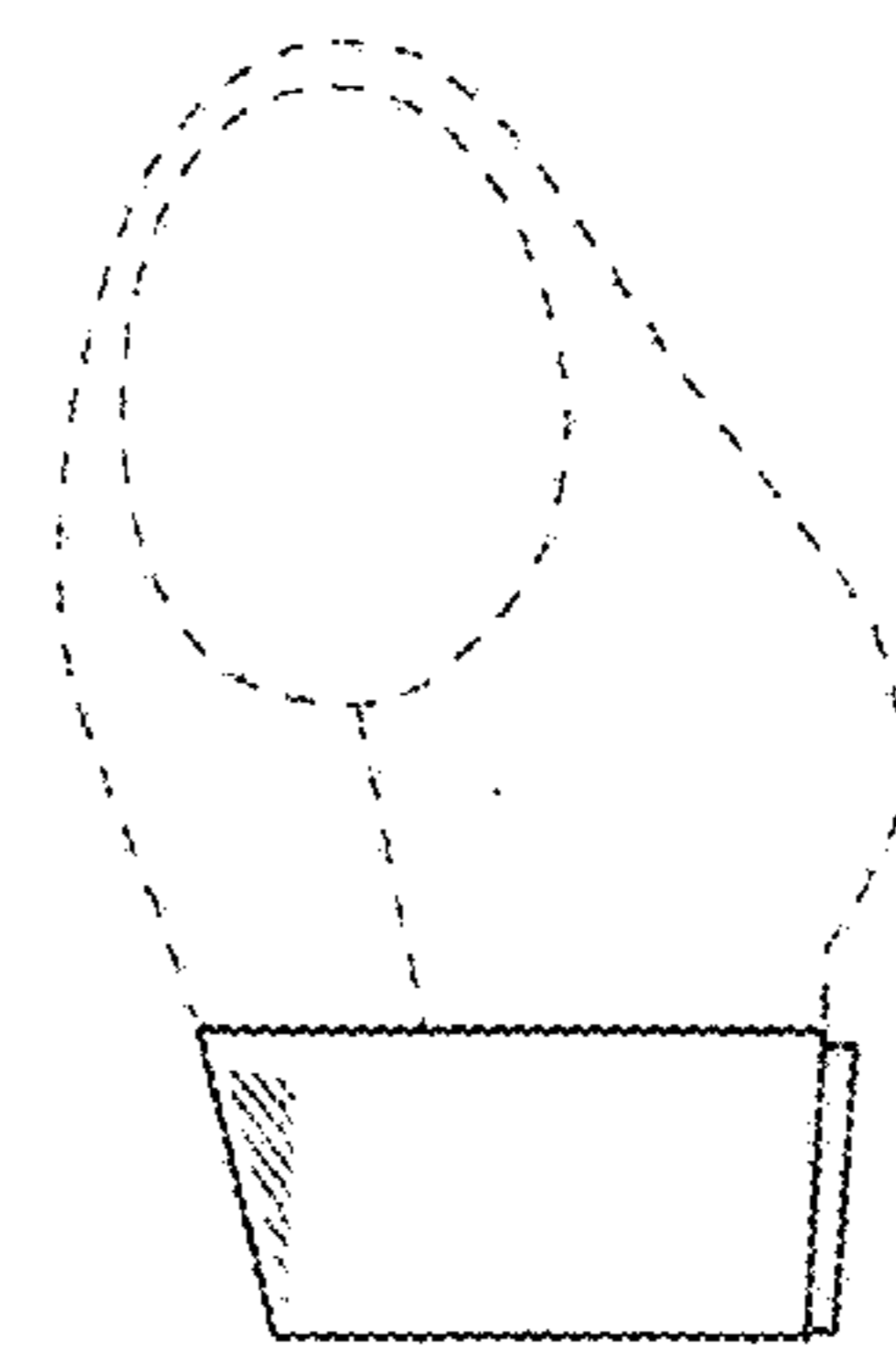

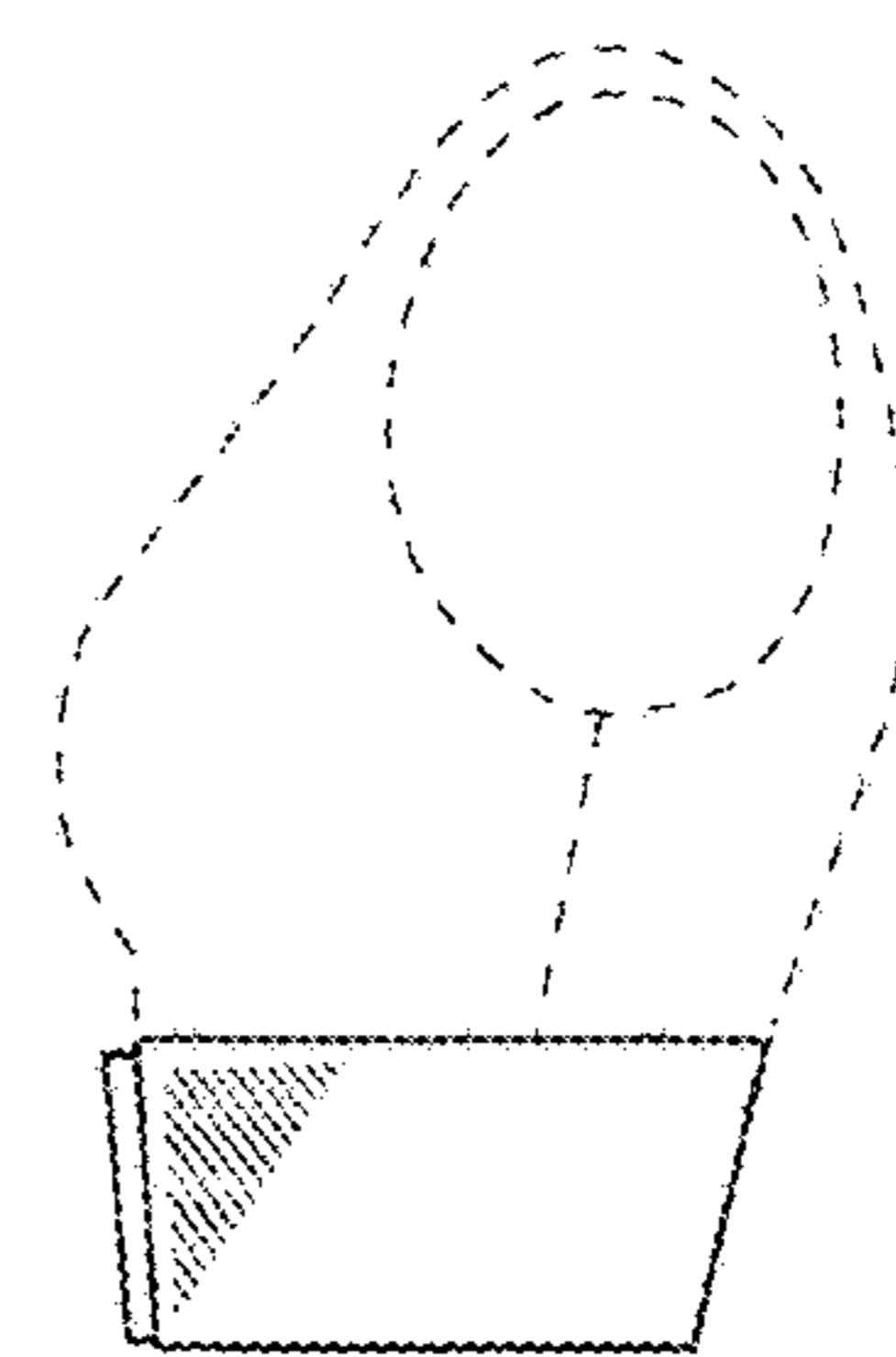

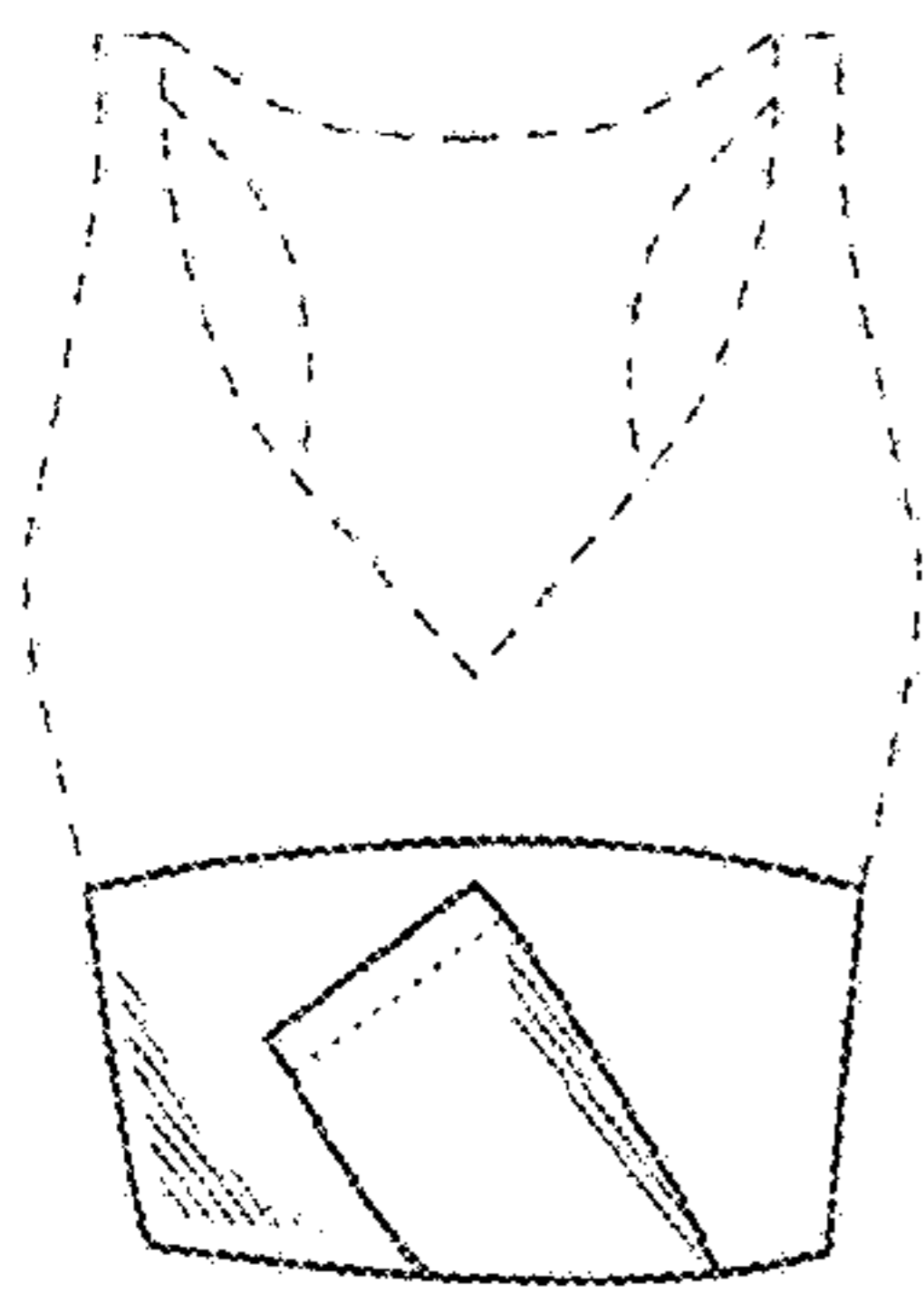

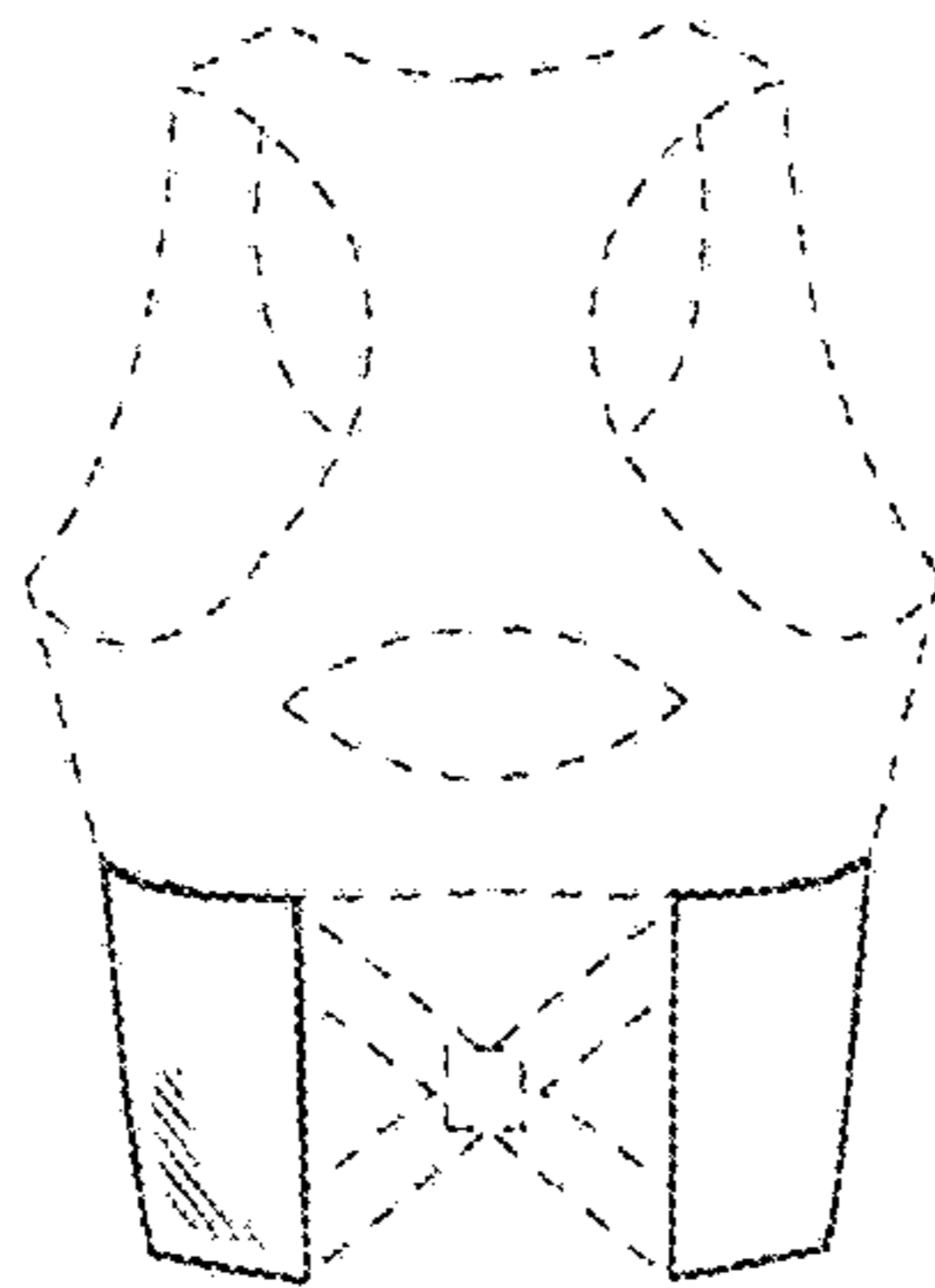

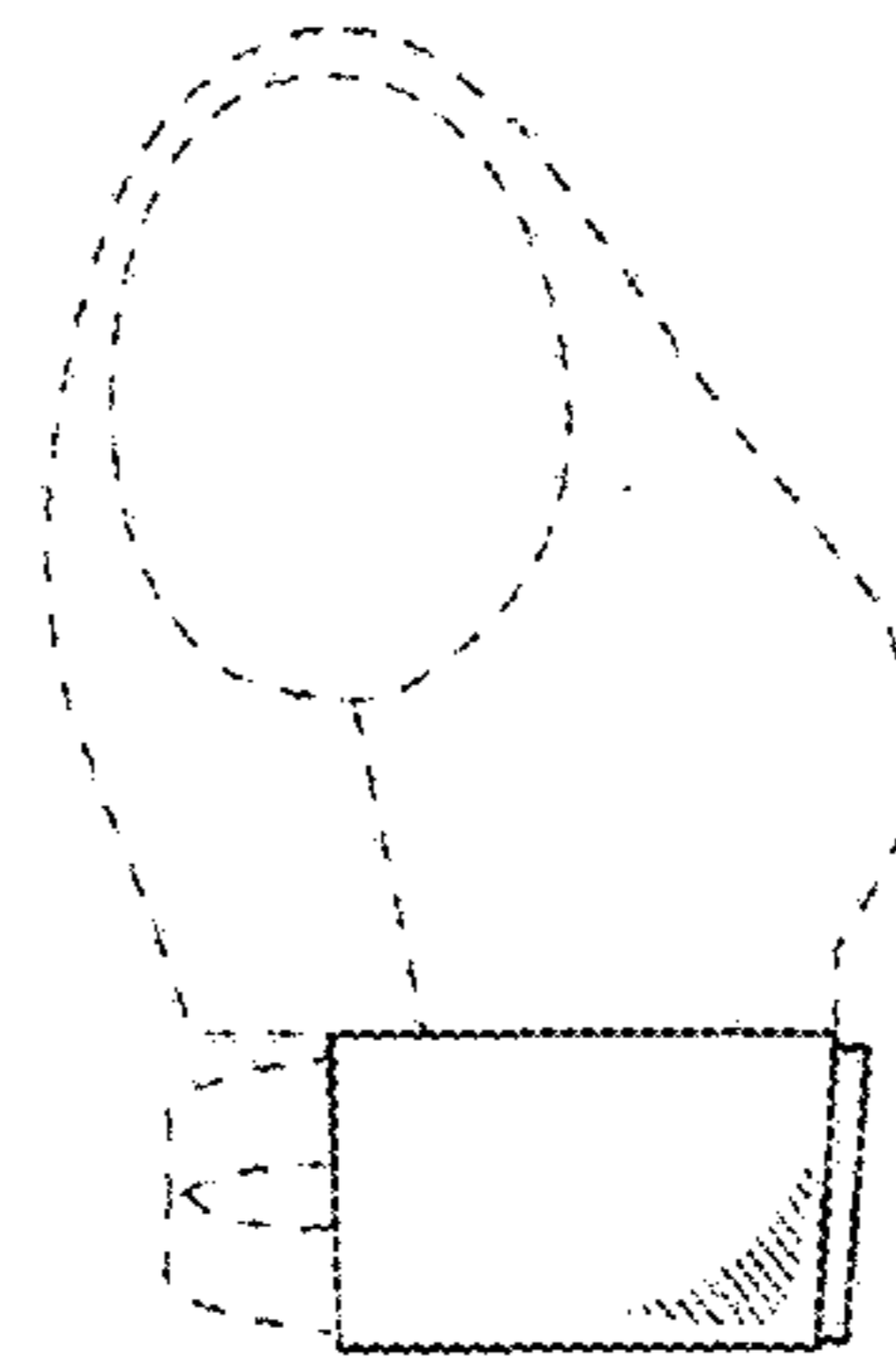

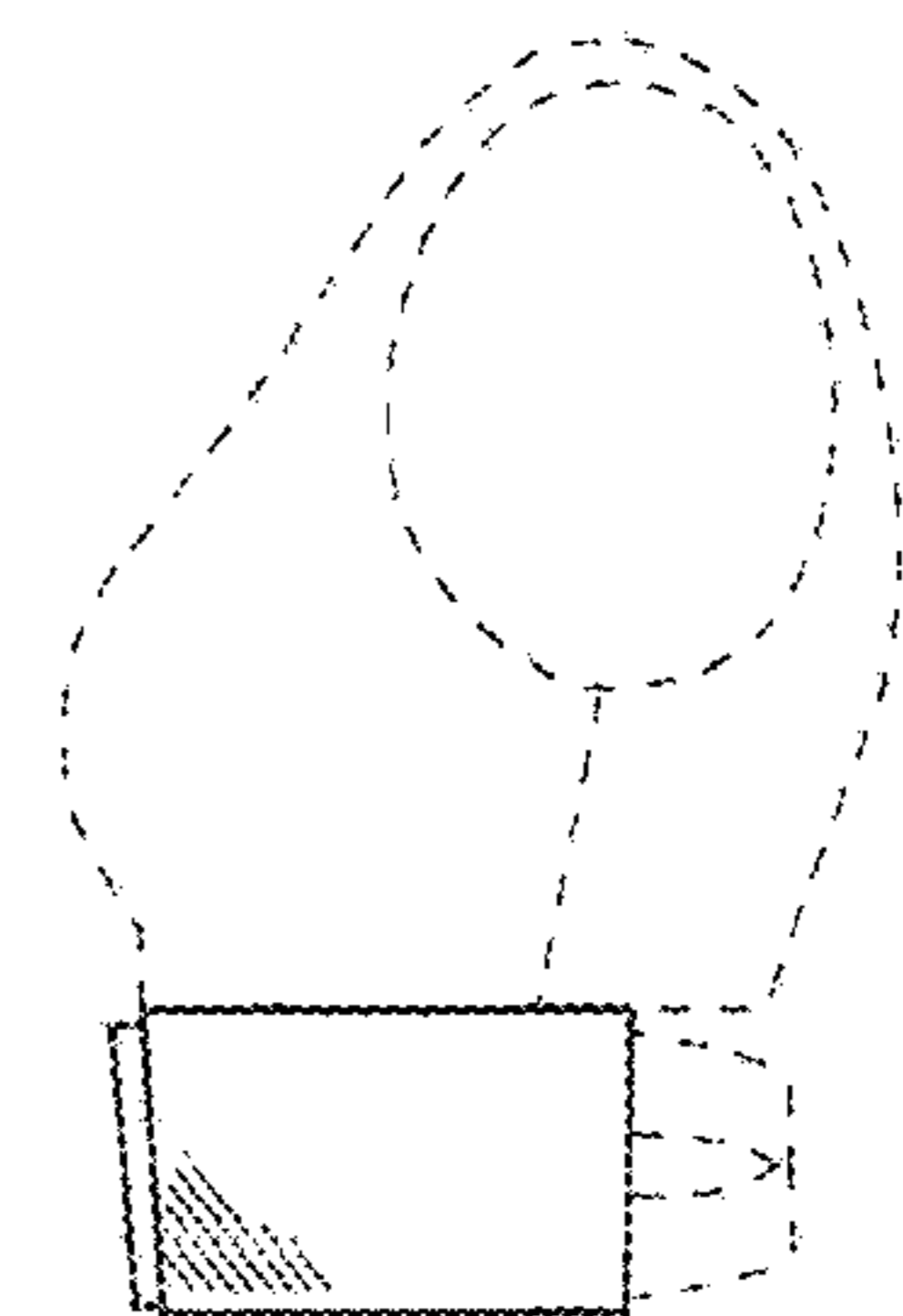

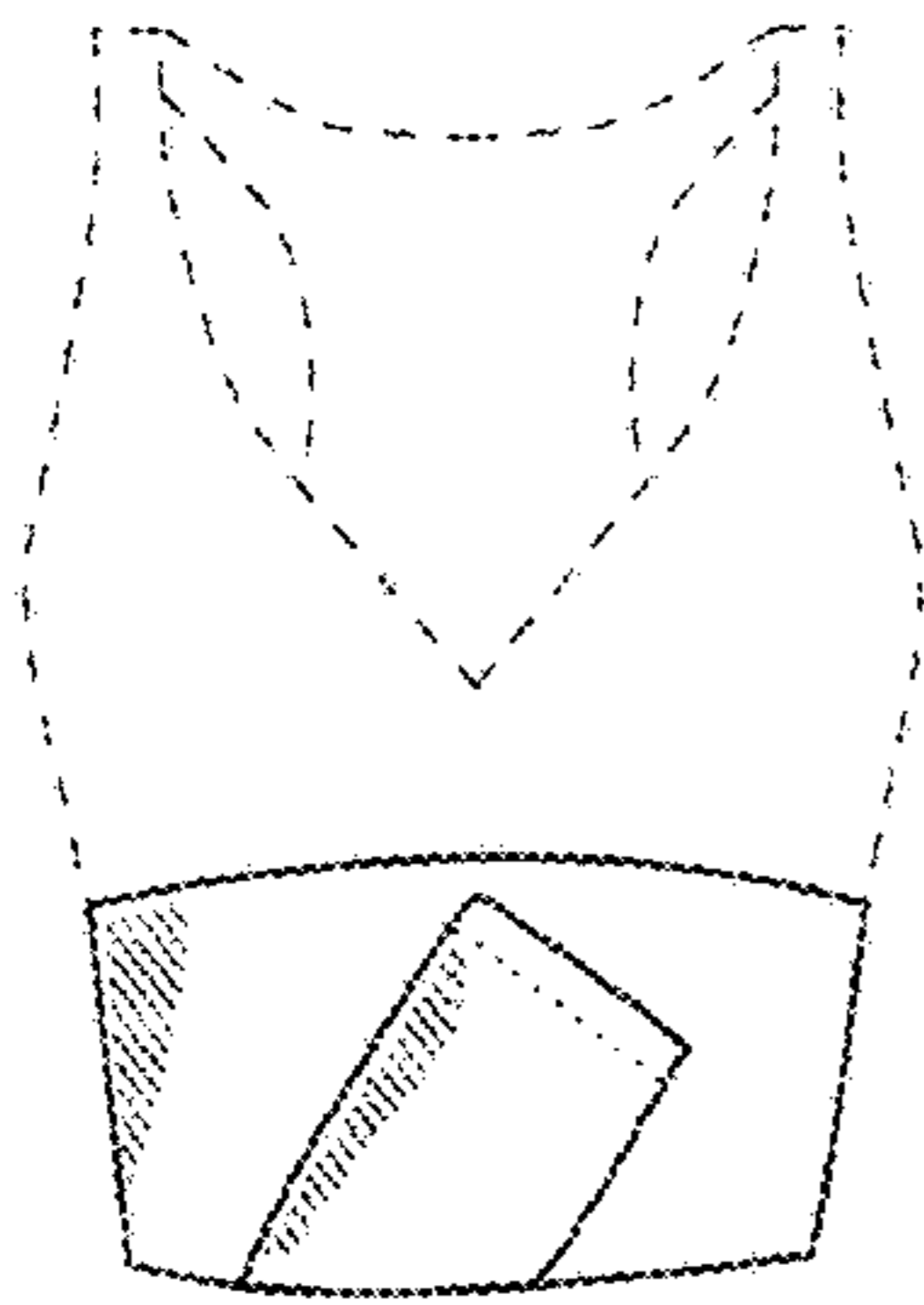

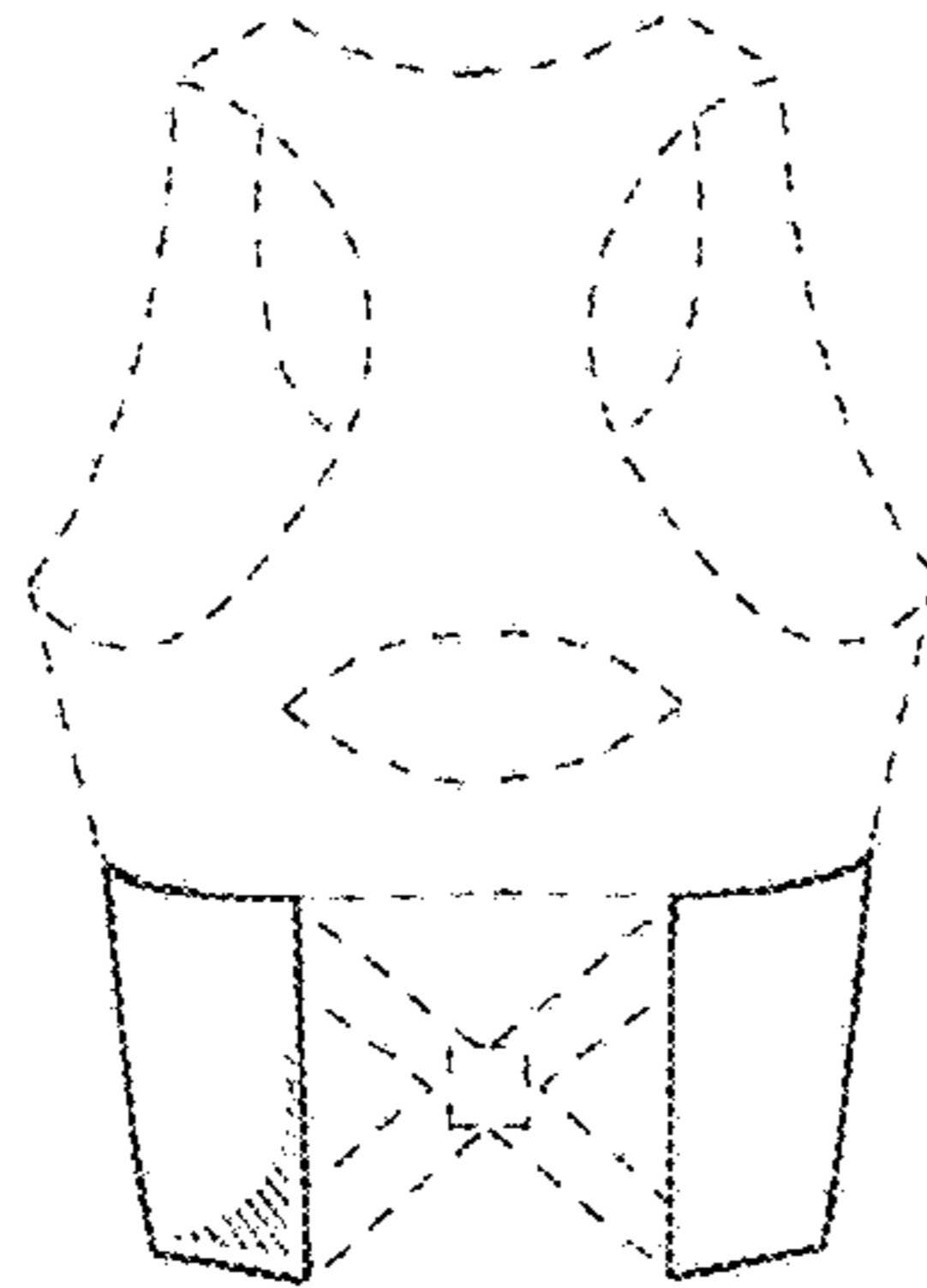

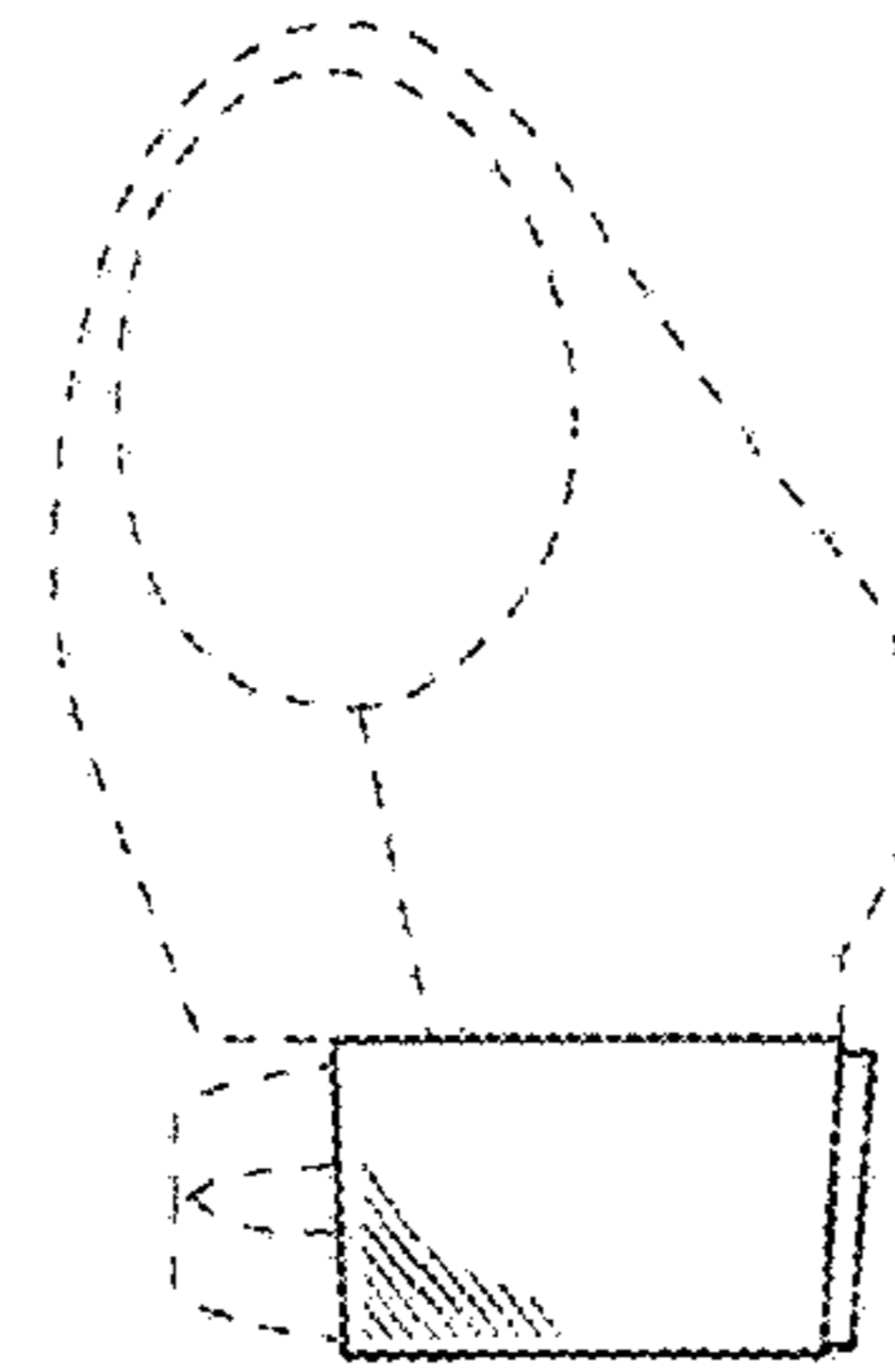

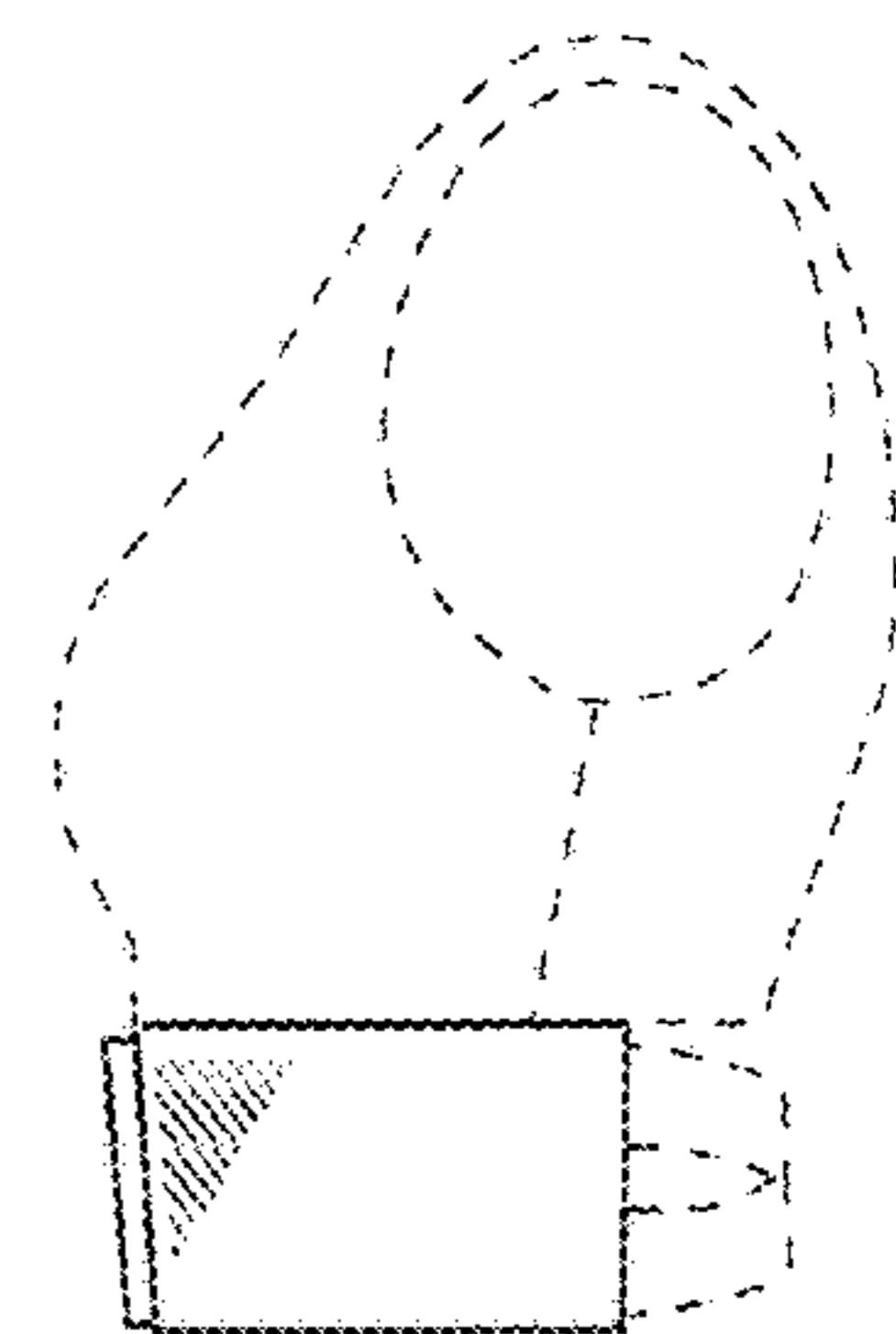

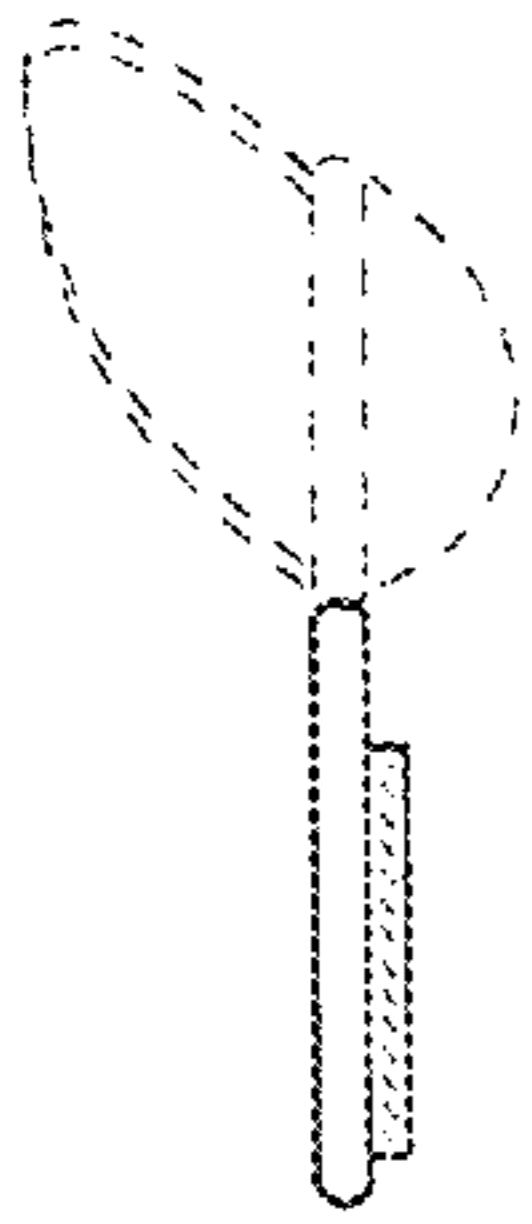

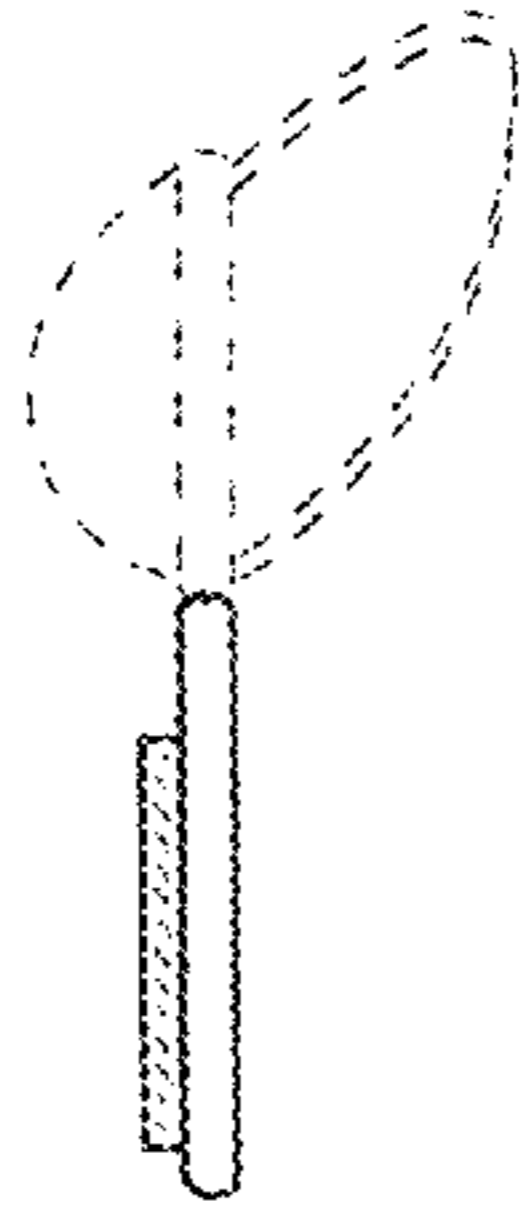

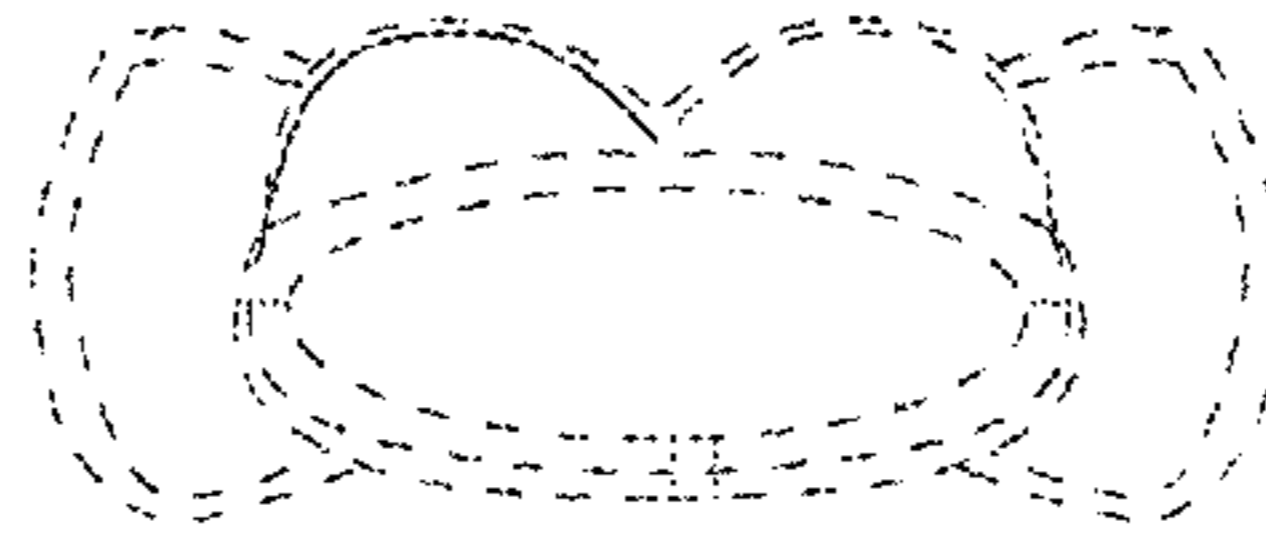

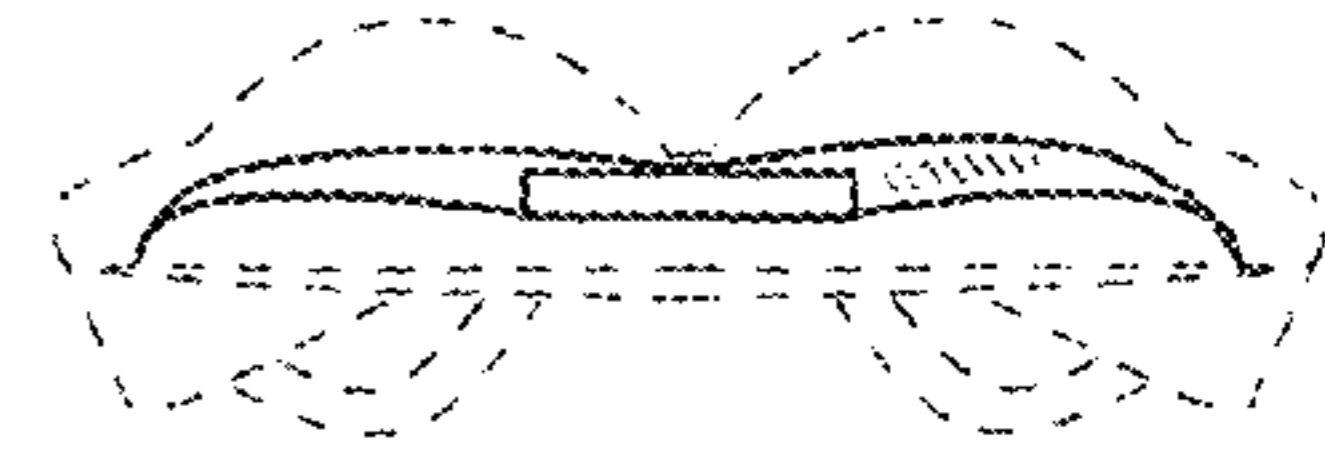

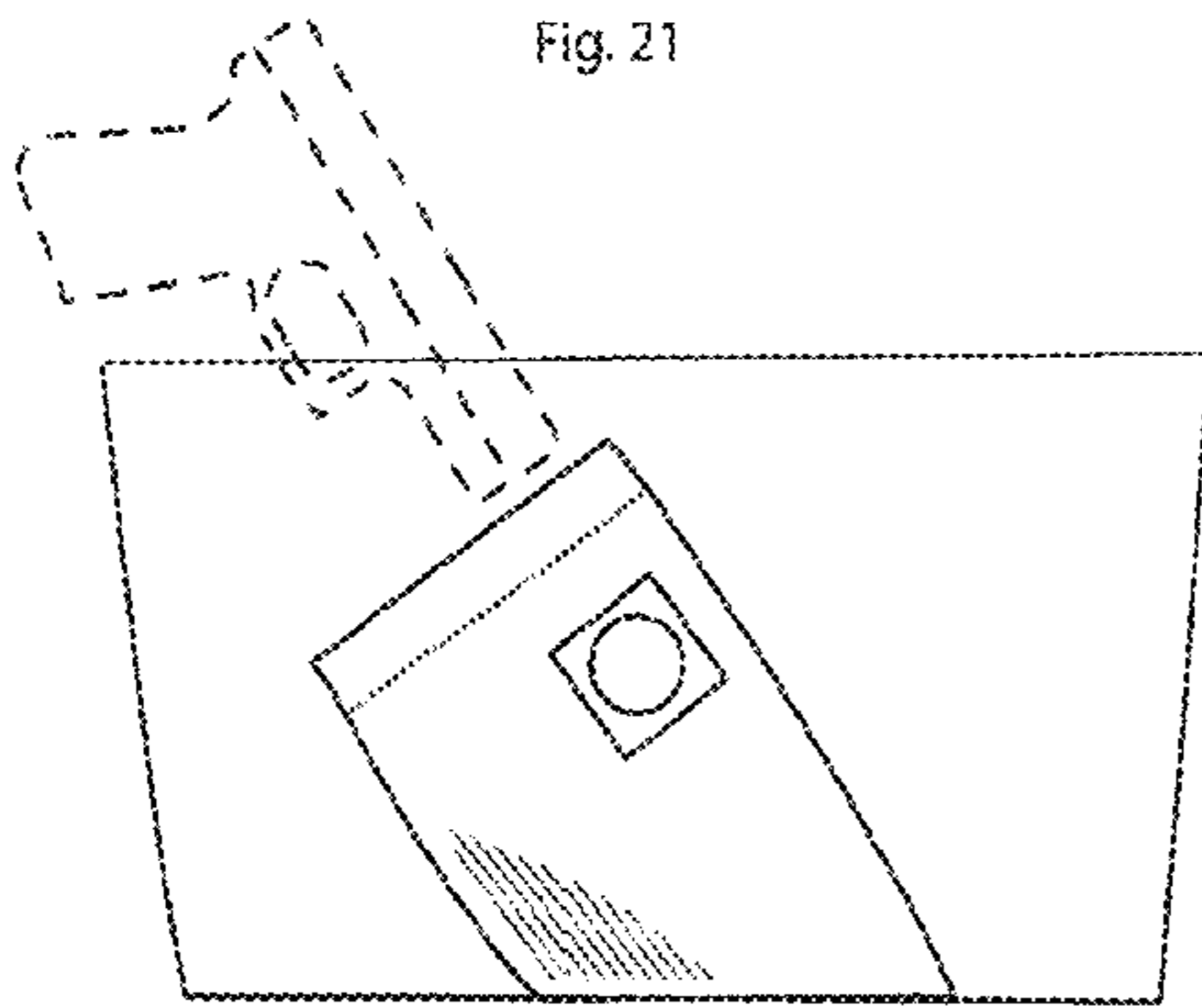
