DESCRIPTION

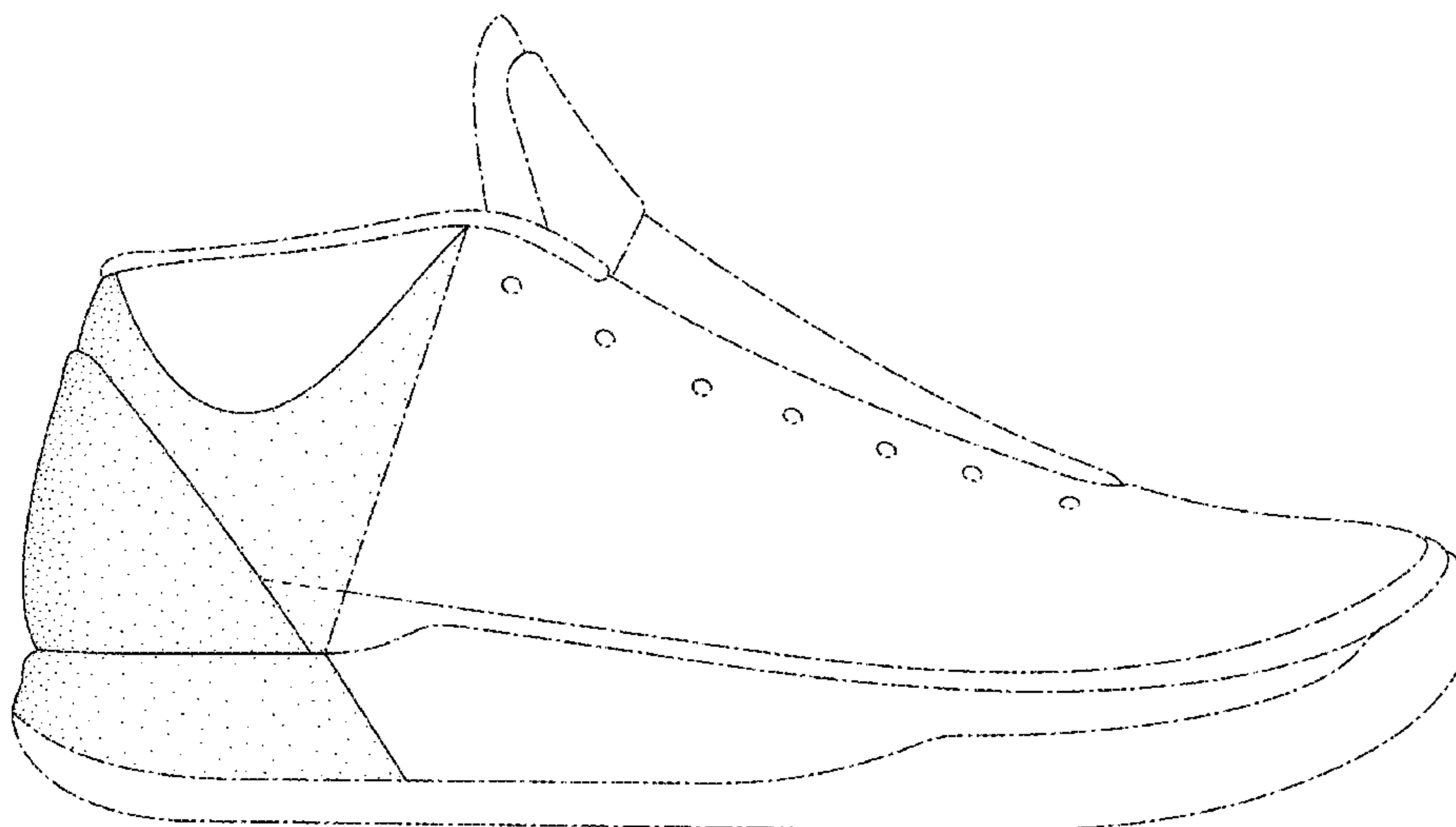
FIG. 1 is a side view of a shoe upper showing our new design;

FIG. 2 is a rear perspective view thereof; and,

FIG. 3 is a rear view thereof.

The even-length broken lines within the shaded area represent an unclaimed feature. Uneven-length broken lines immediately adjacent to the shaded area define the bounds of the claimed design and form no part thereof. The uneven-length broken lines showing the remainder of the shoe represent unclaimed subject matter and form no part of the claimed design.

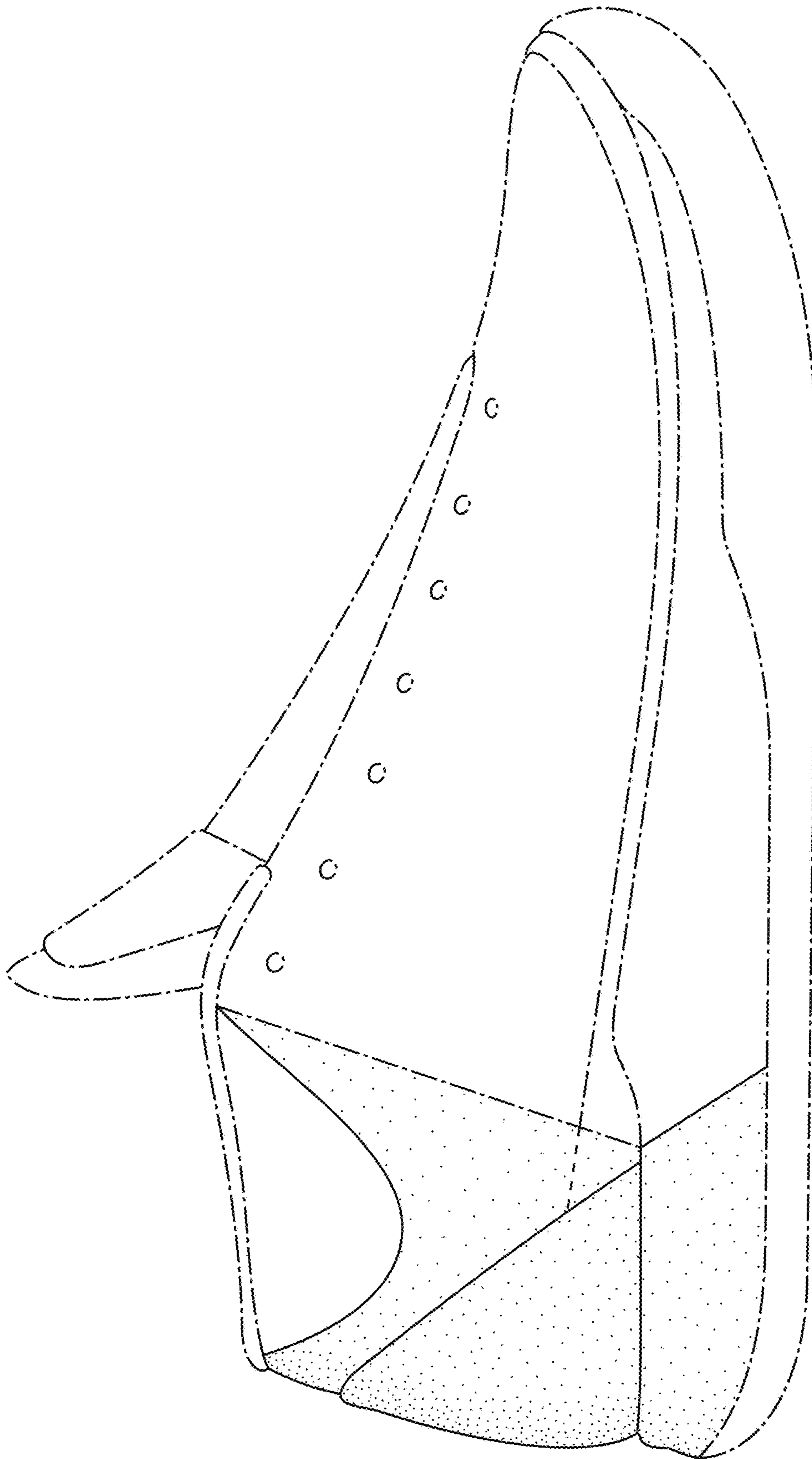

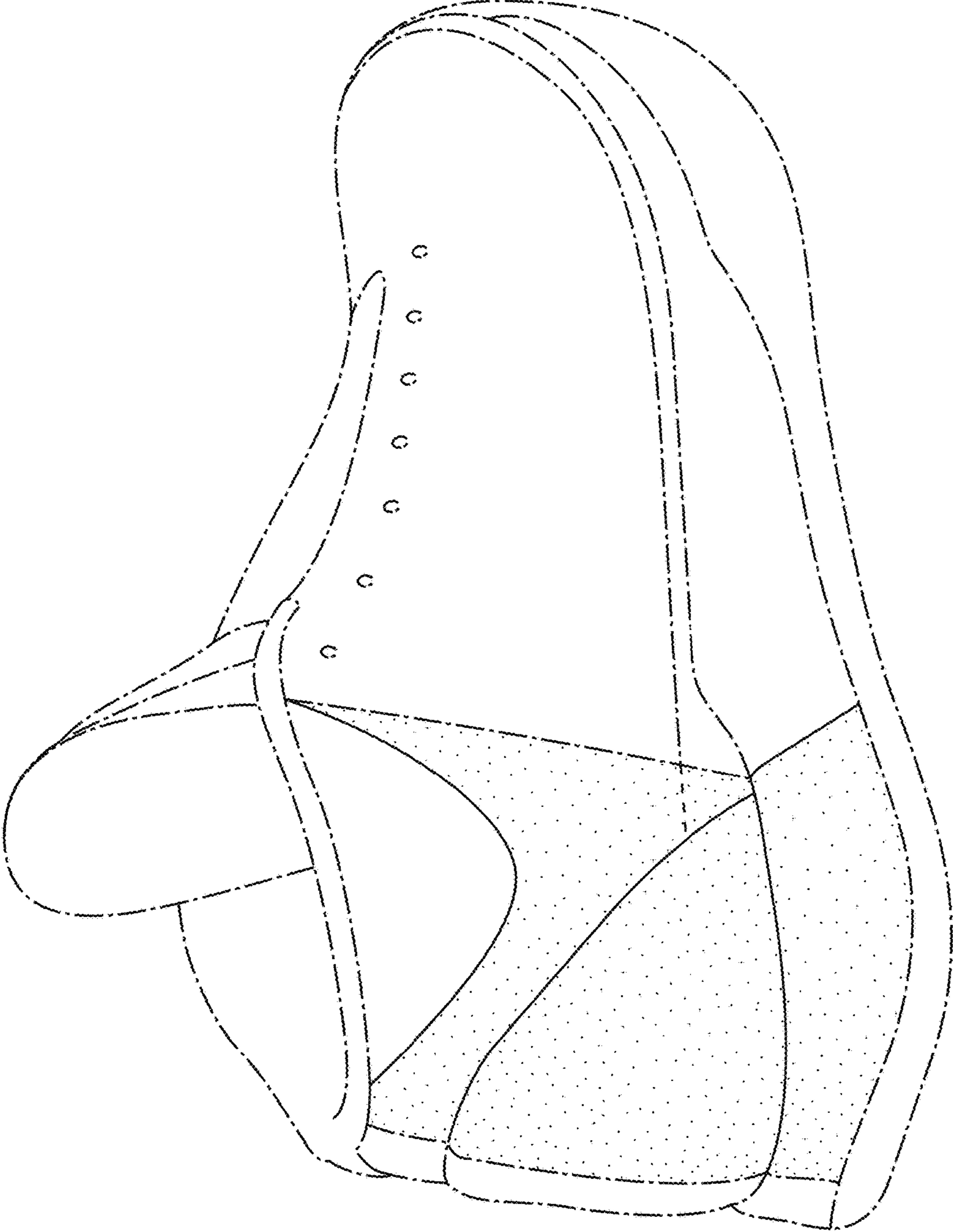

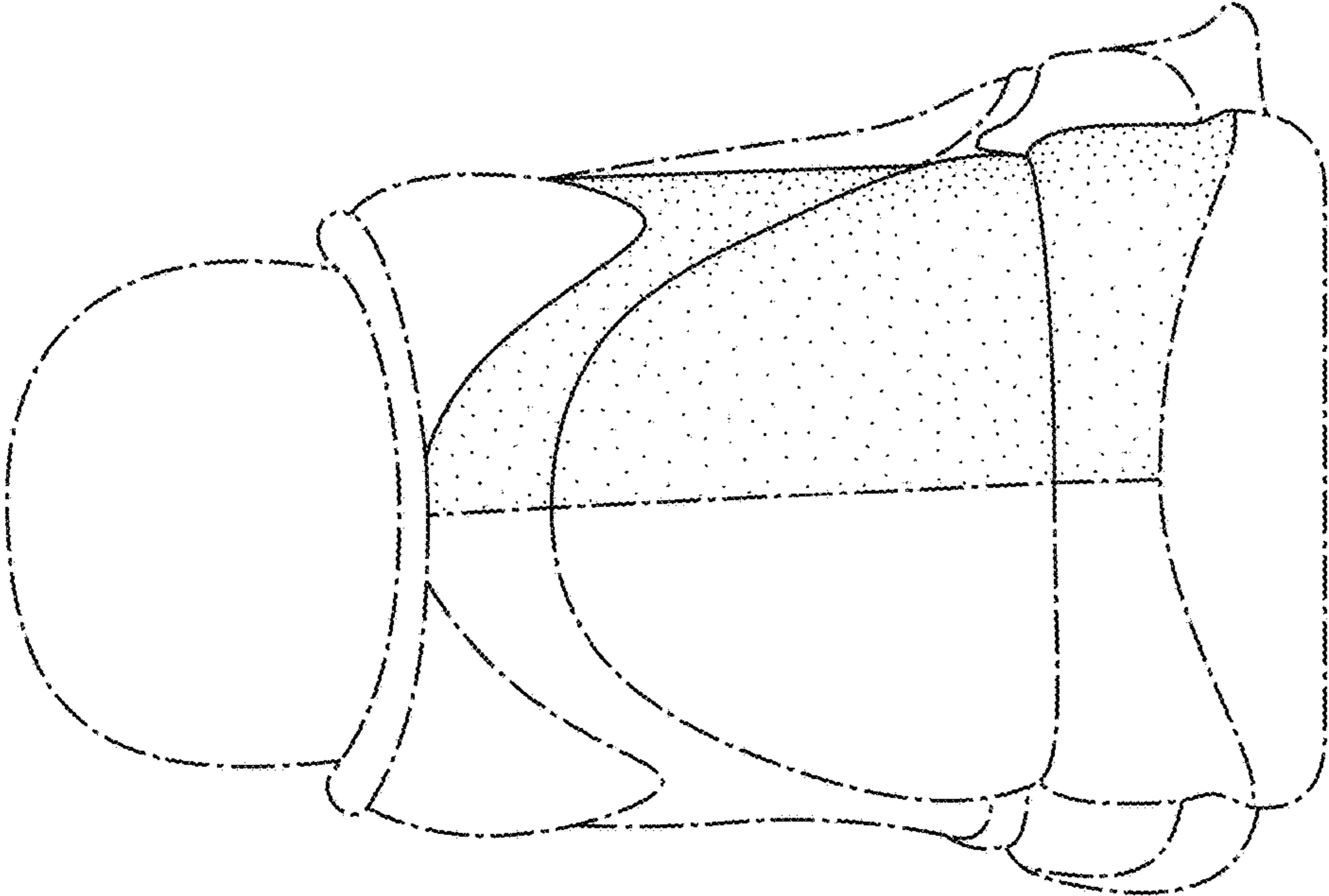
