FIG. 29 is a bottom view of the third embodiment thereof;

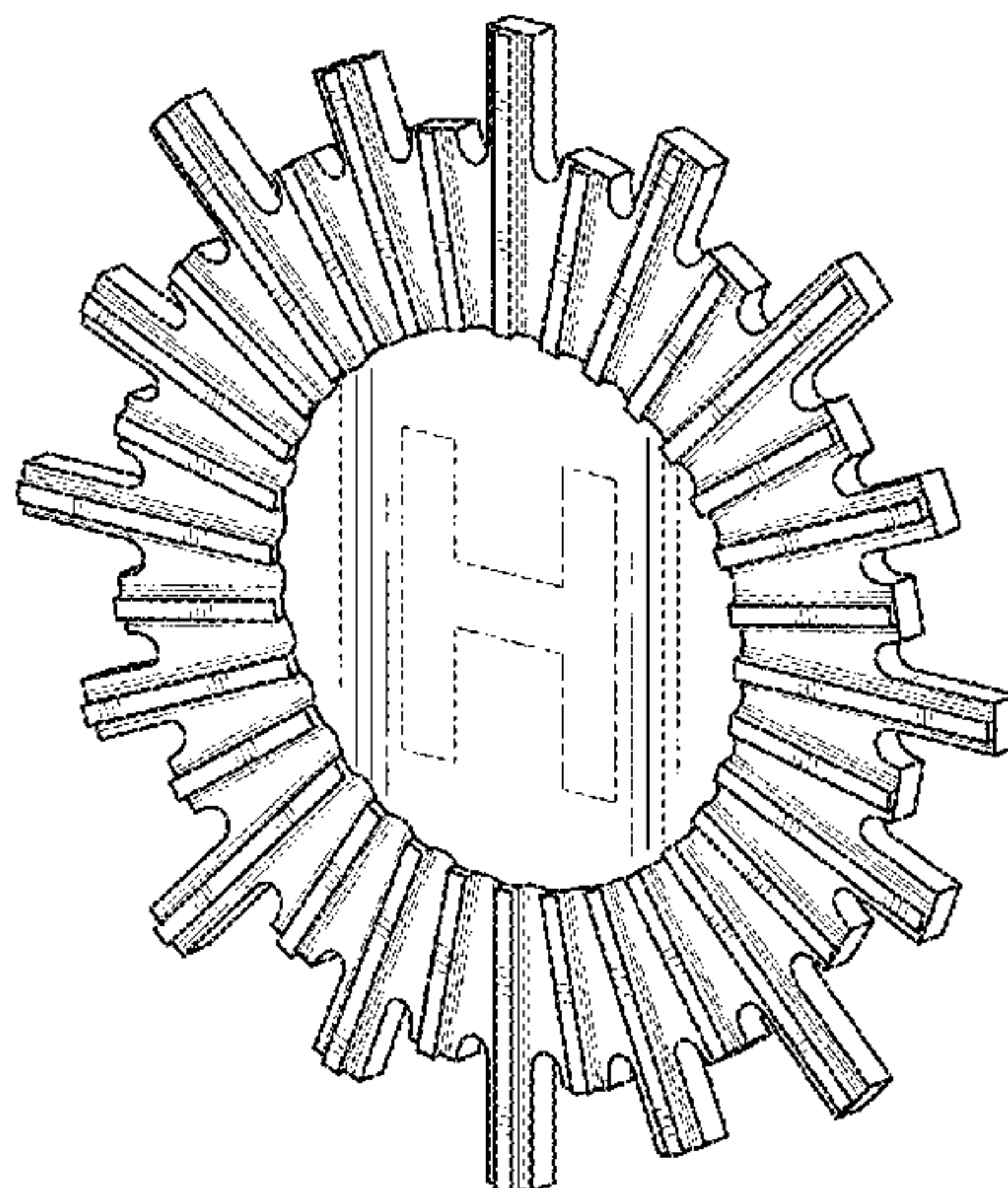
FIG. 30 is a front view of the third embodiment thereof with a fastening plate coupled thereto;

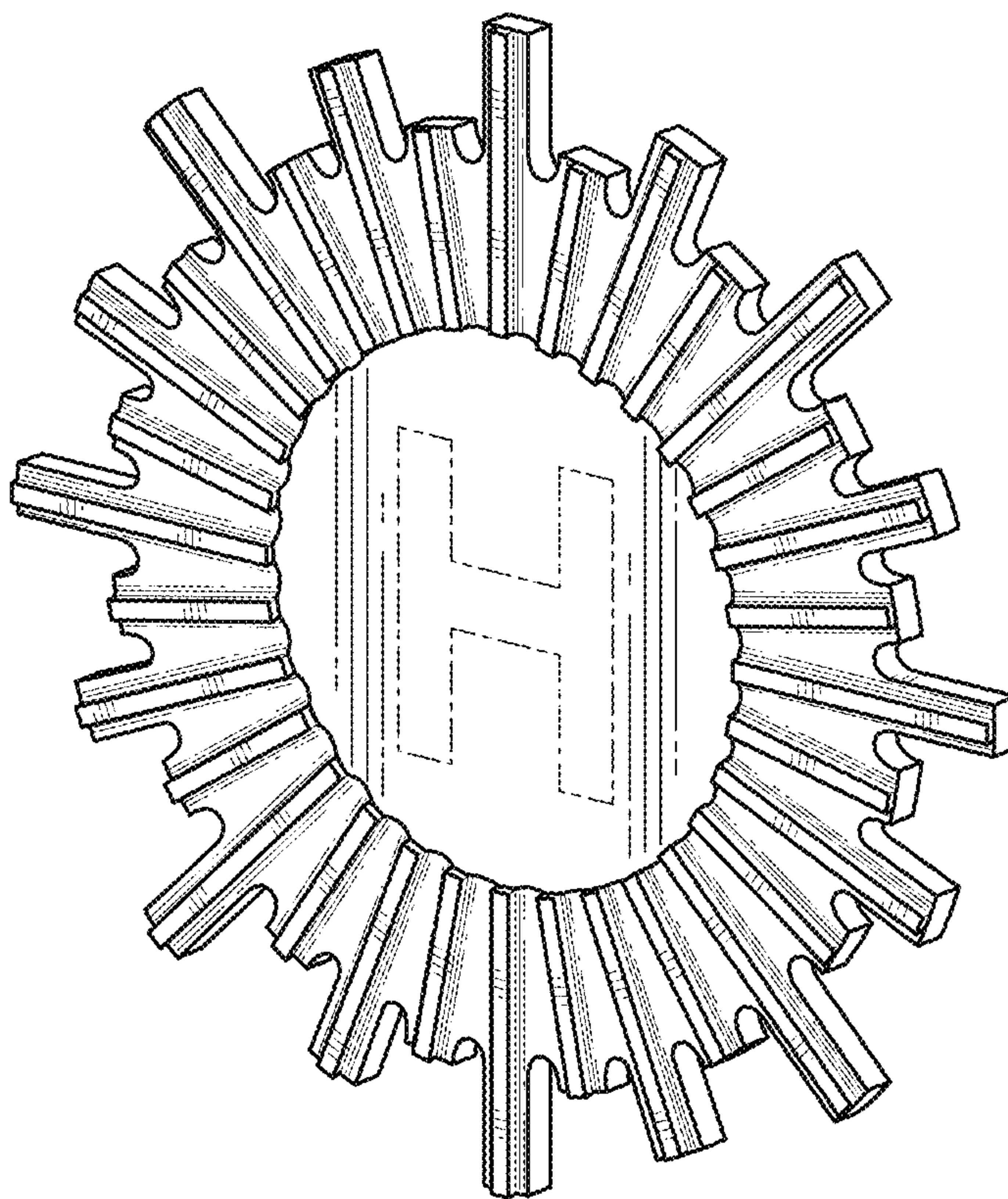

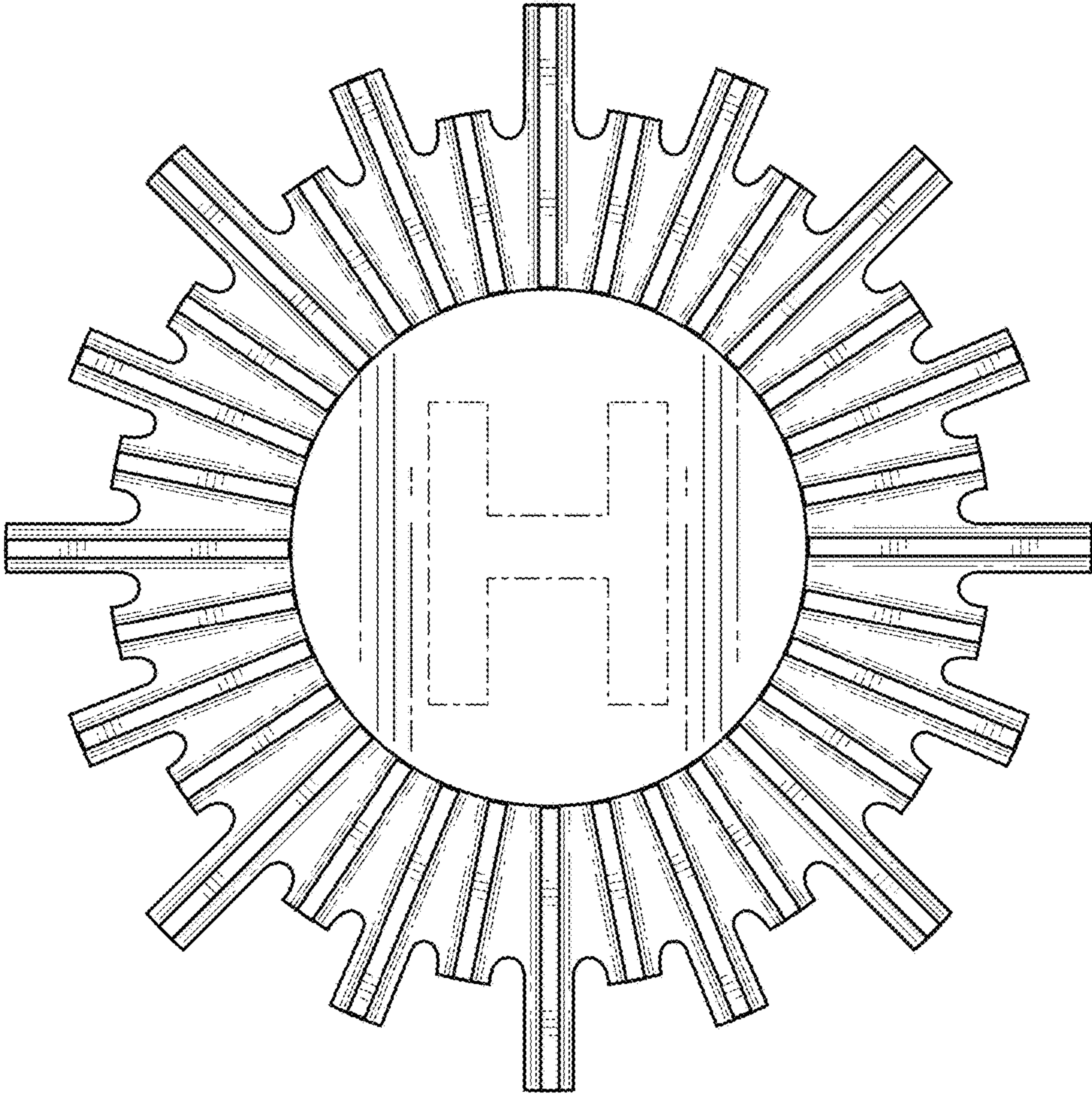

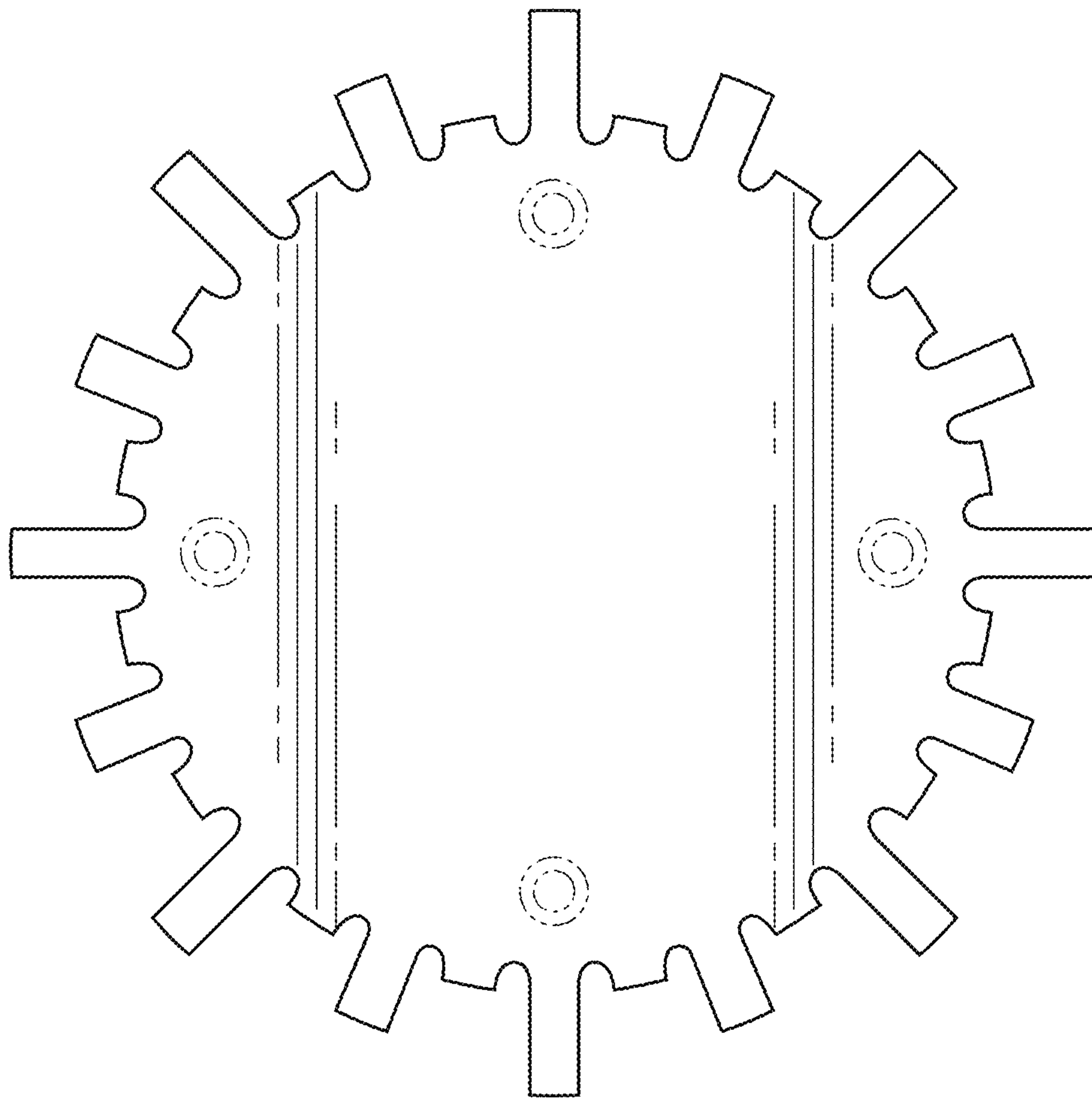

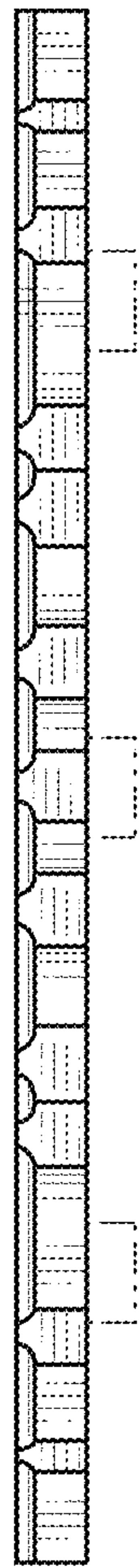

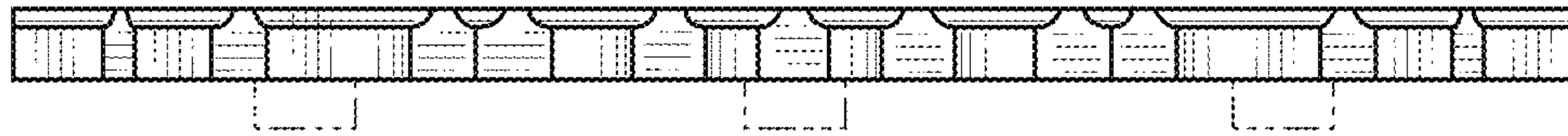

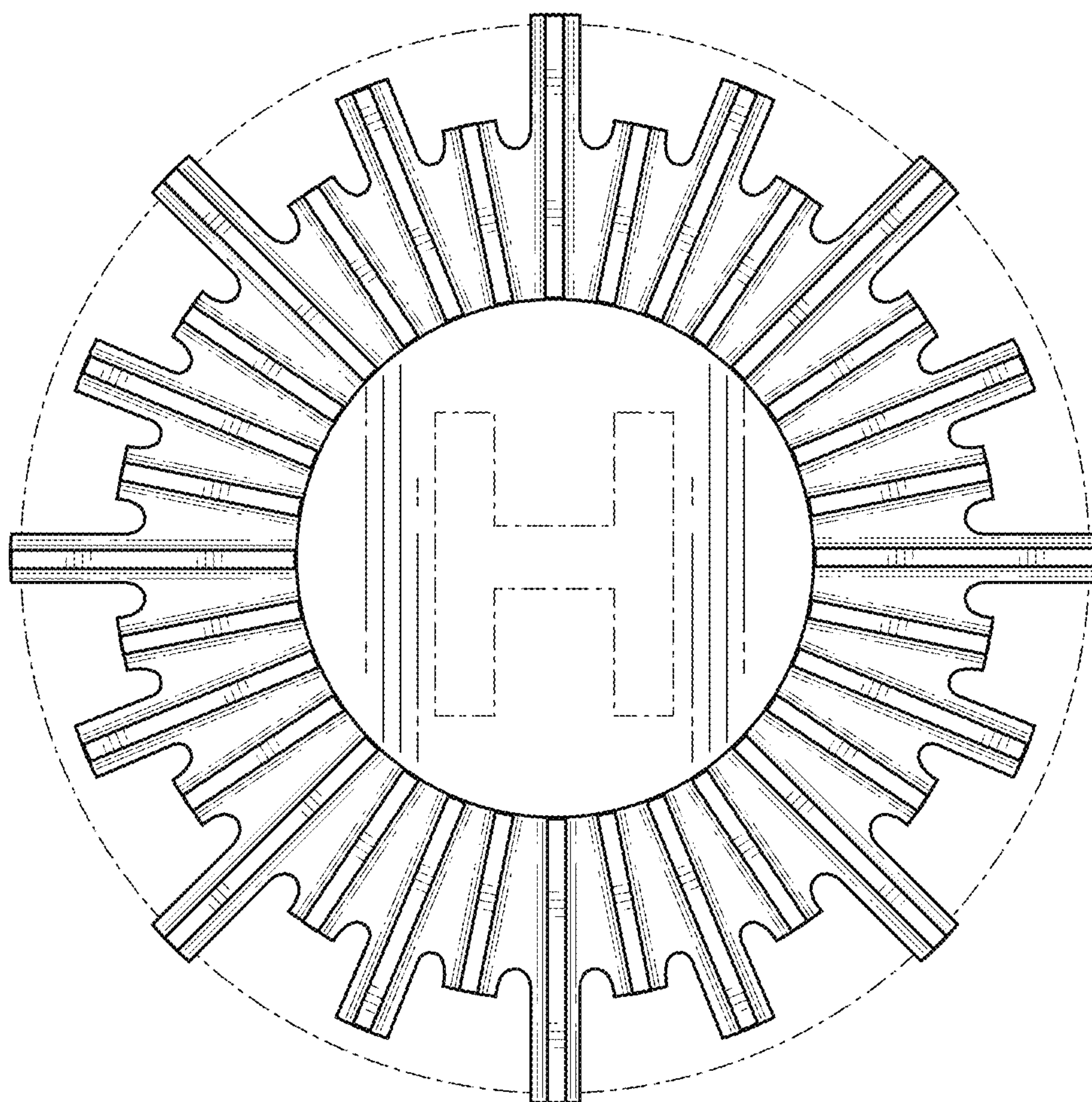

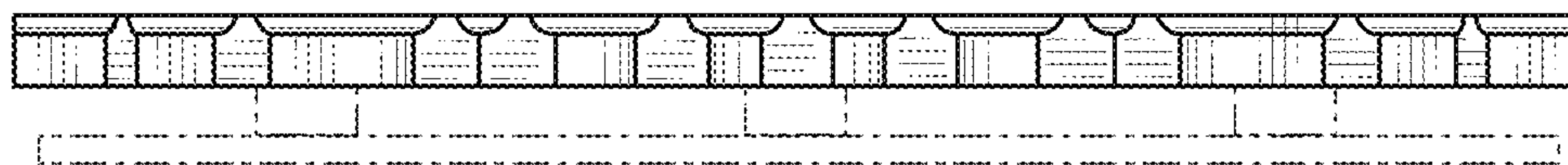

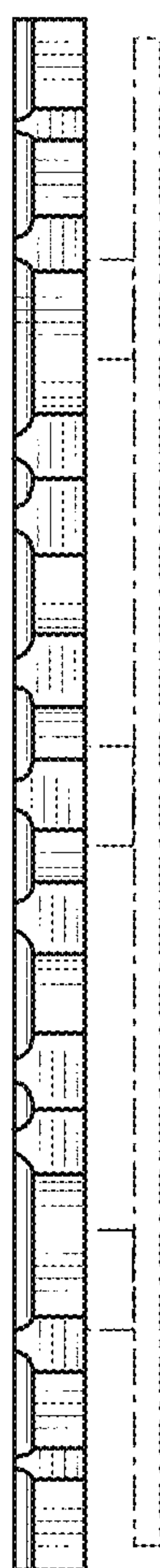

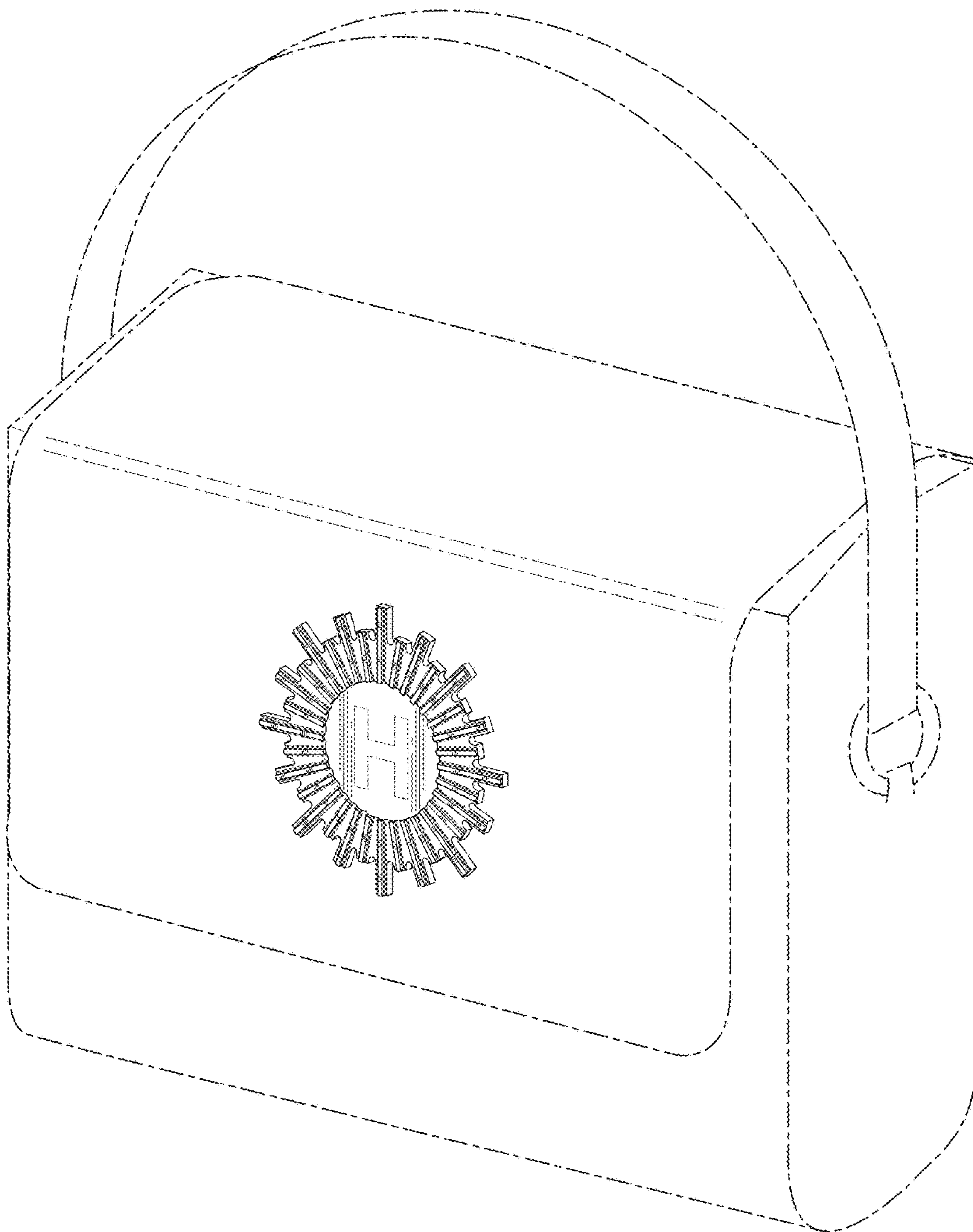

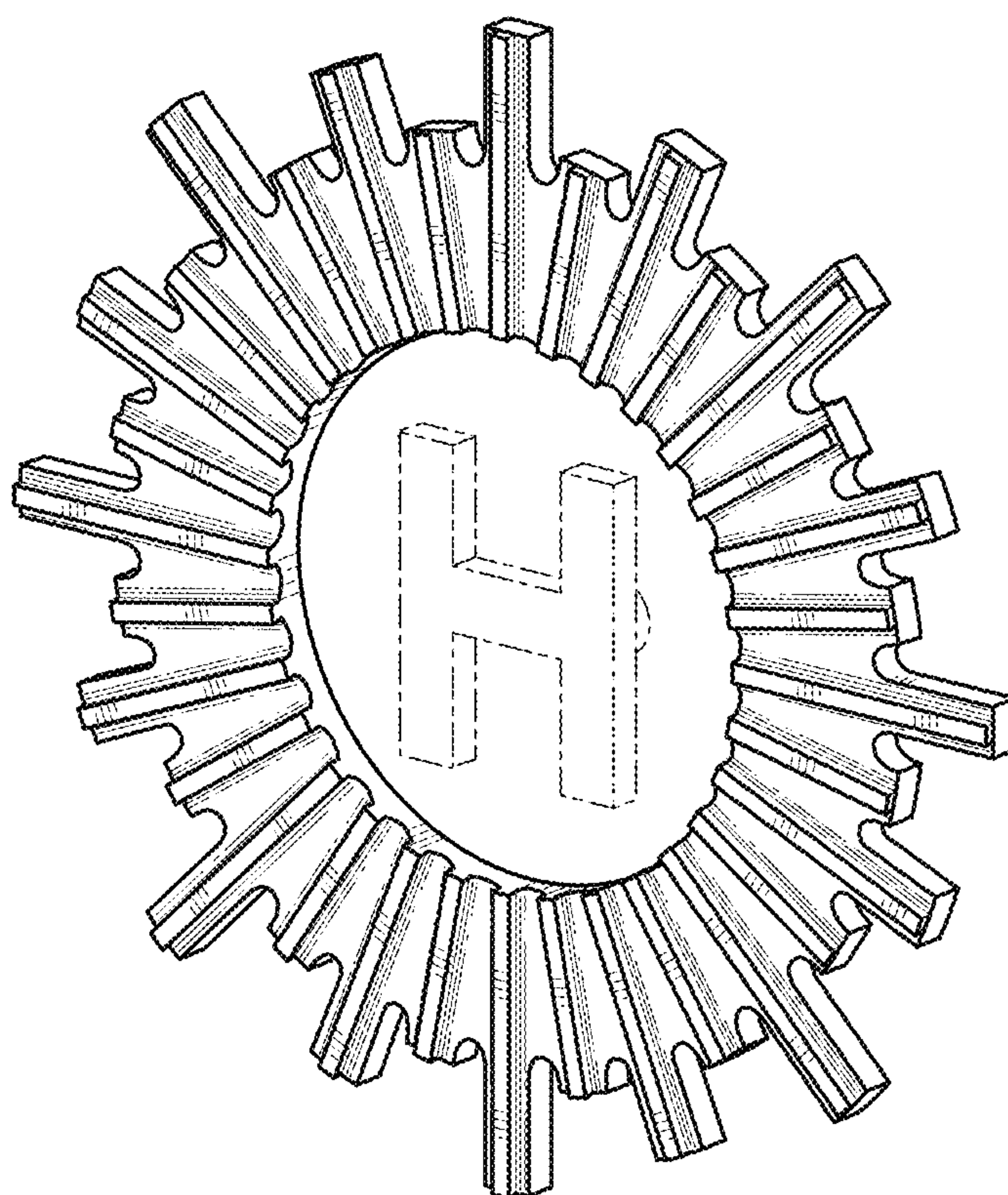

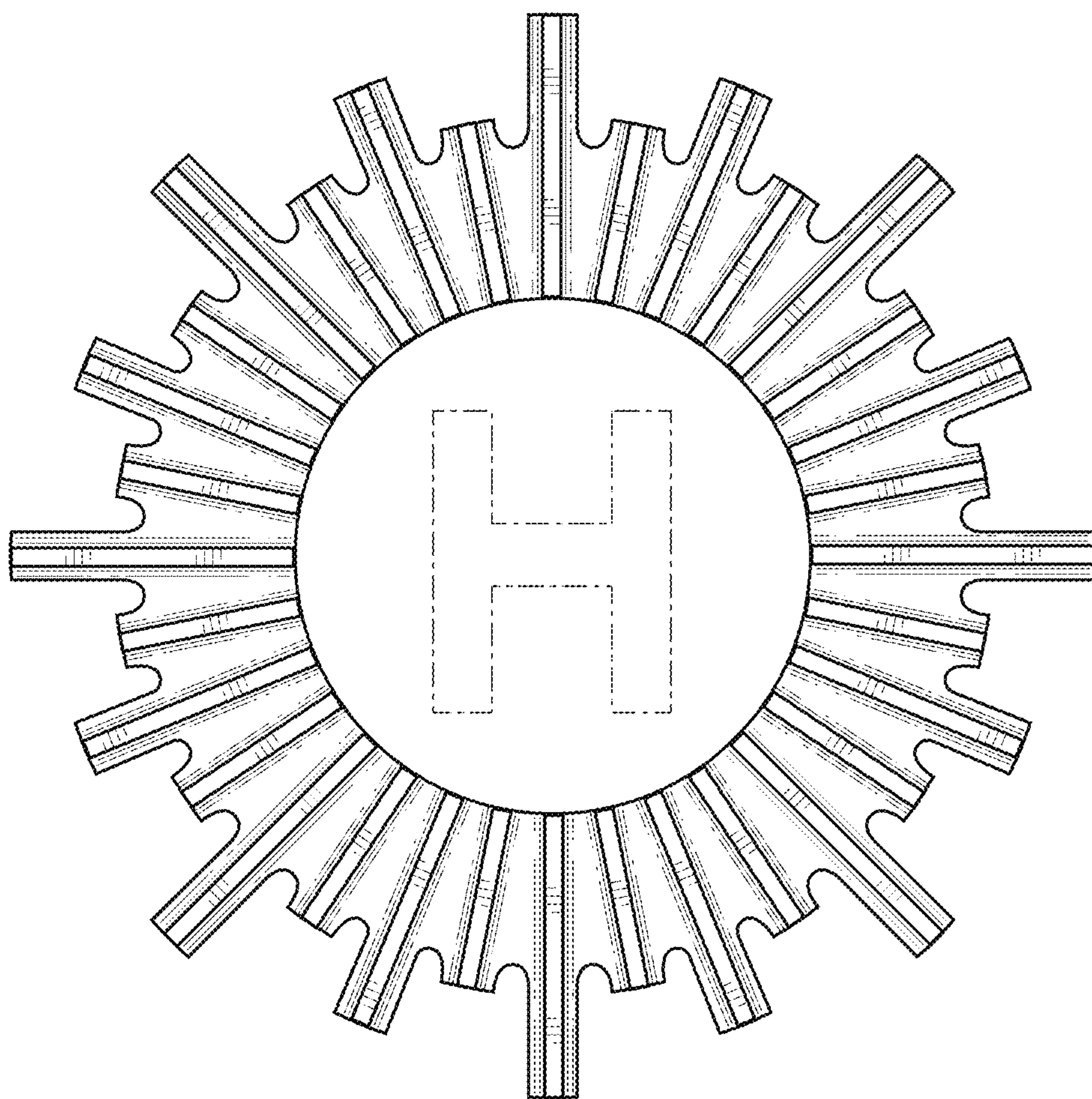

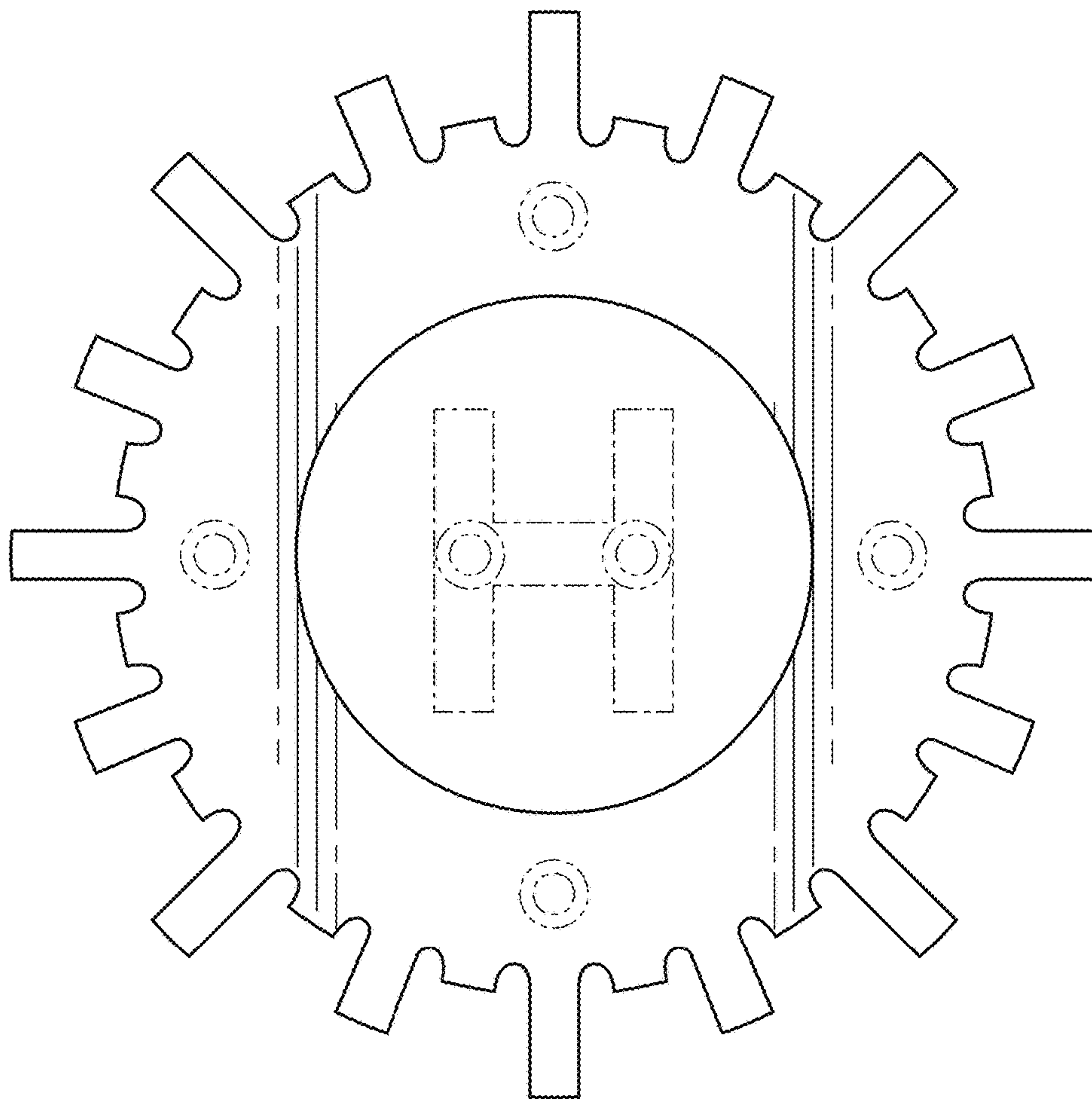

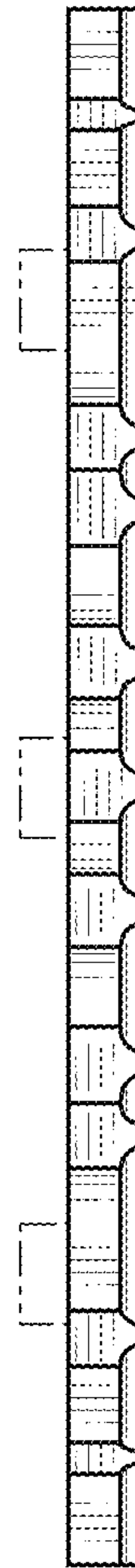

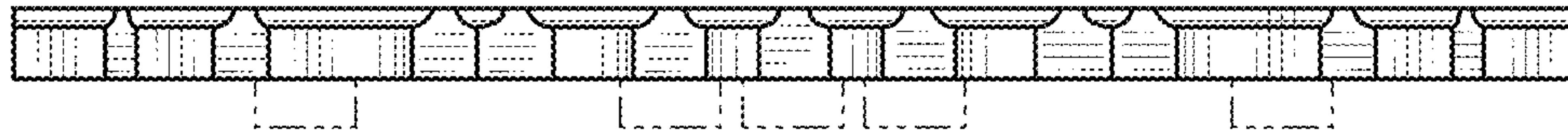

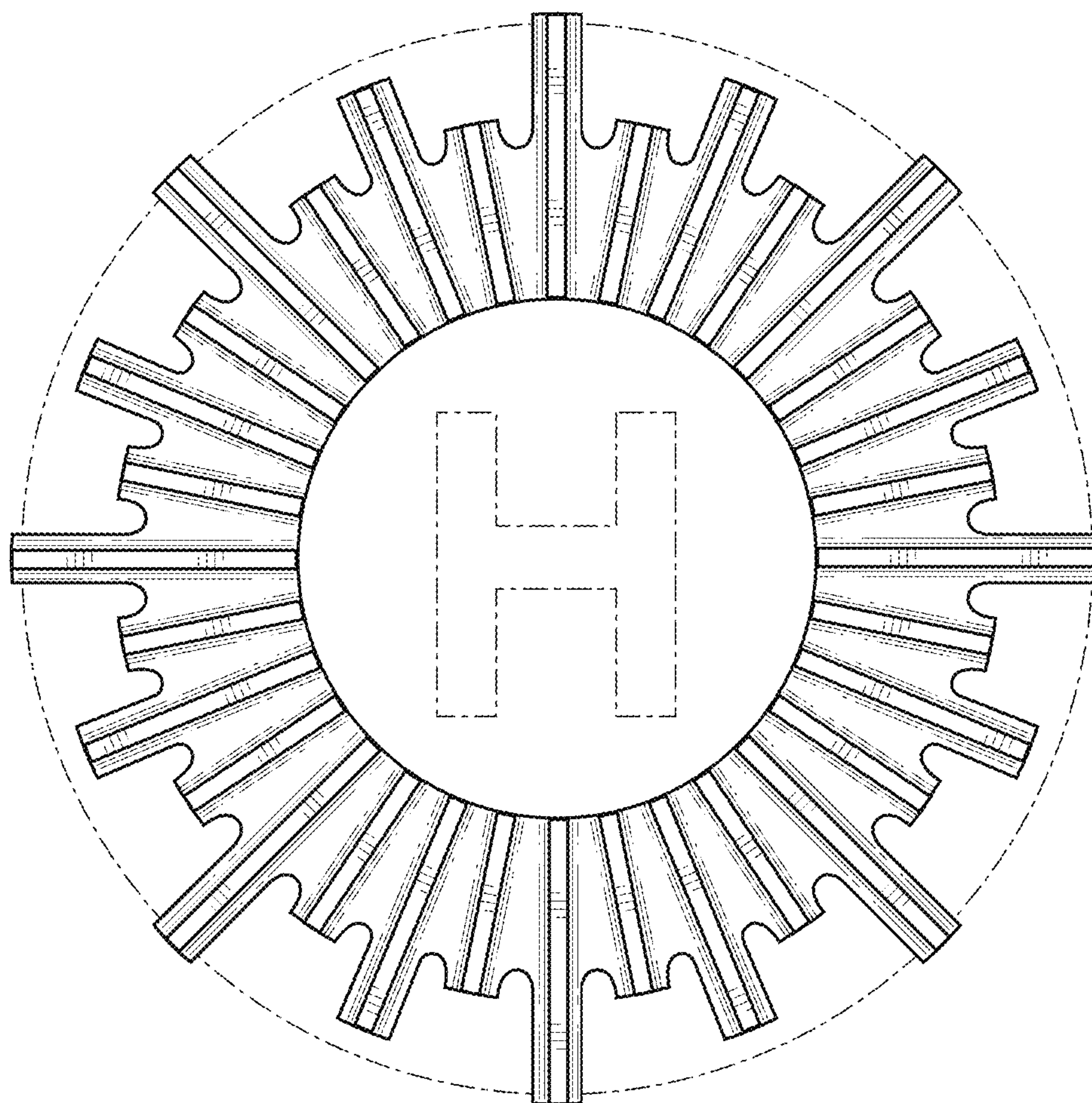

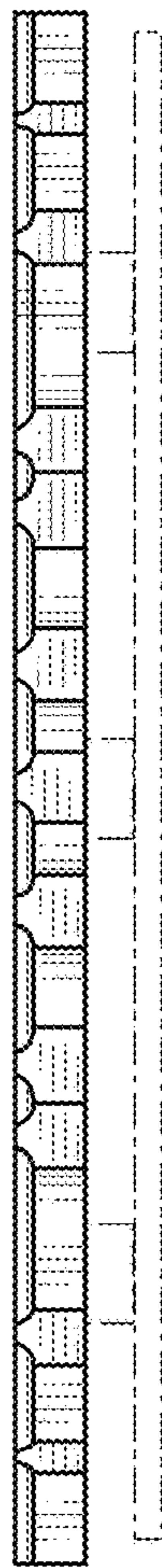

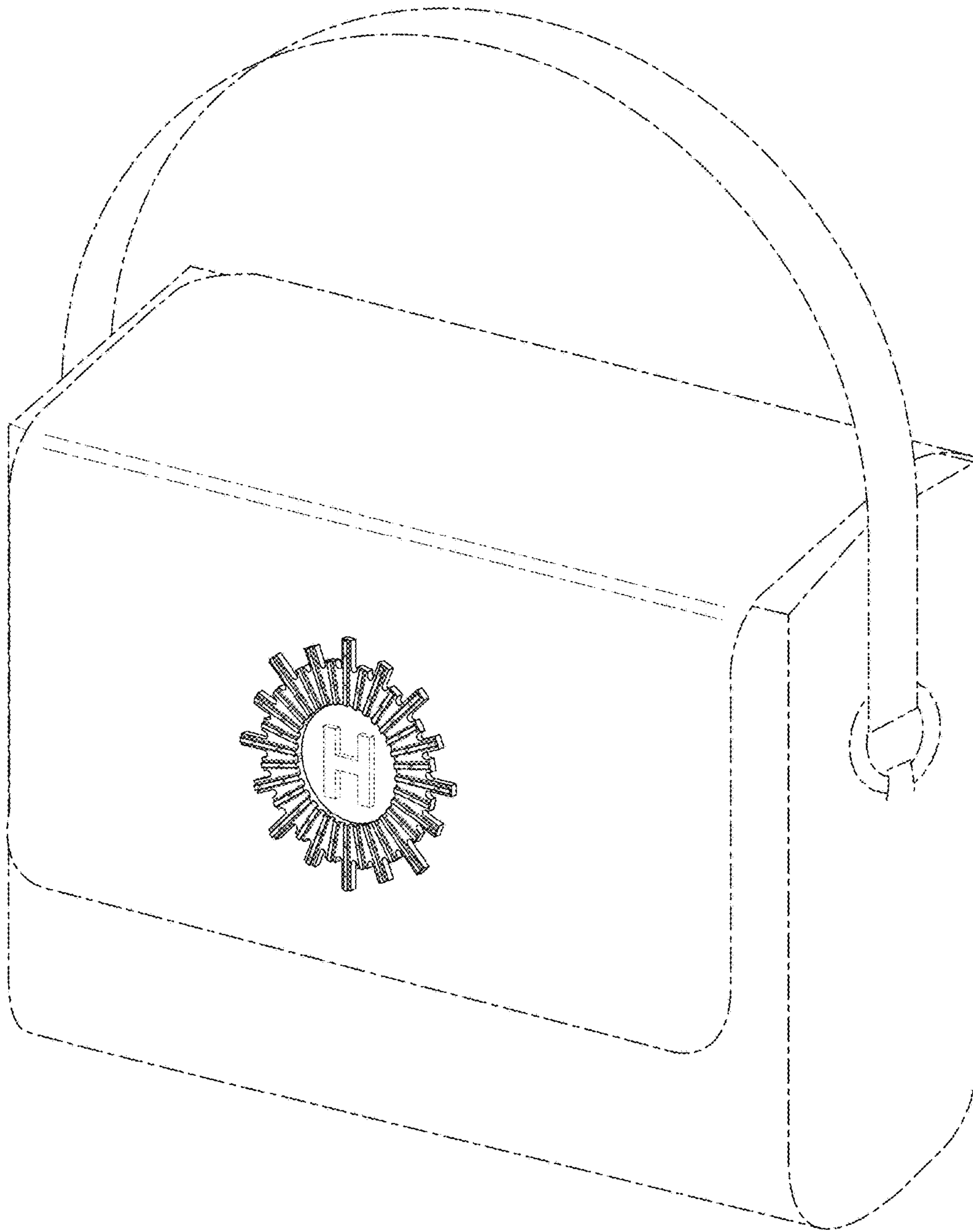

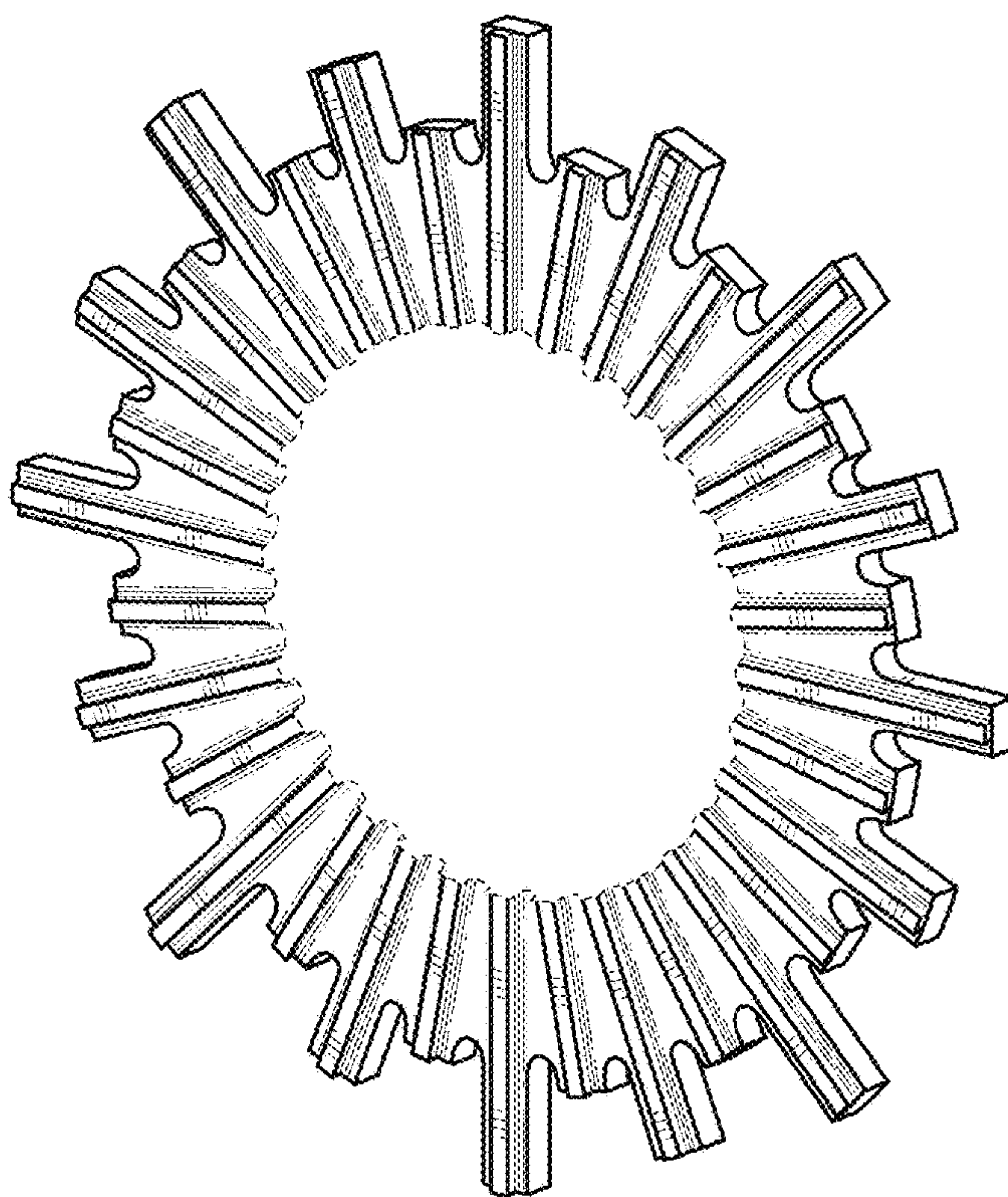

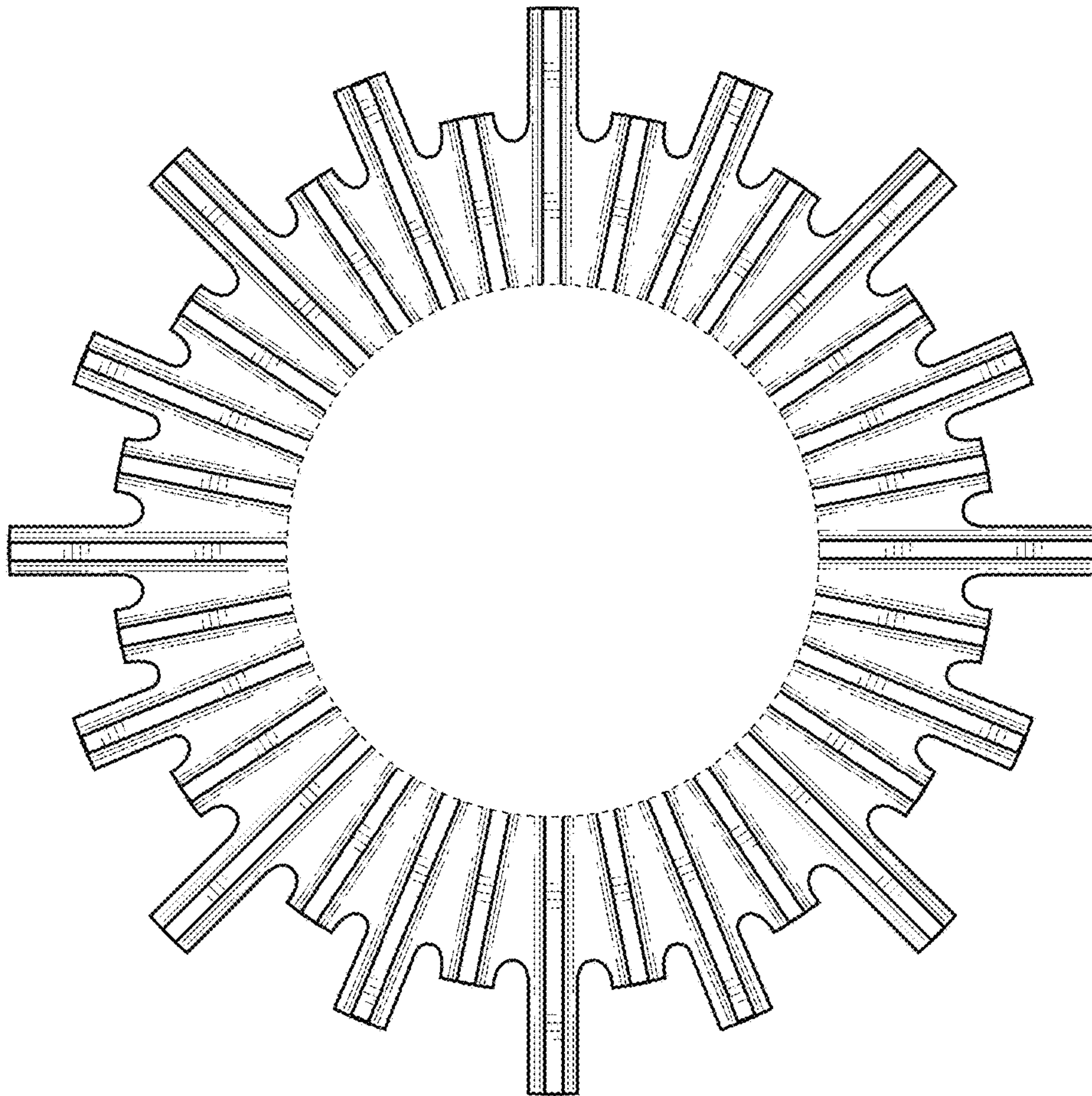

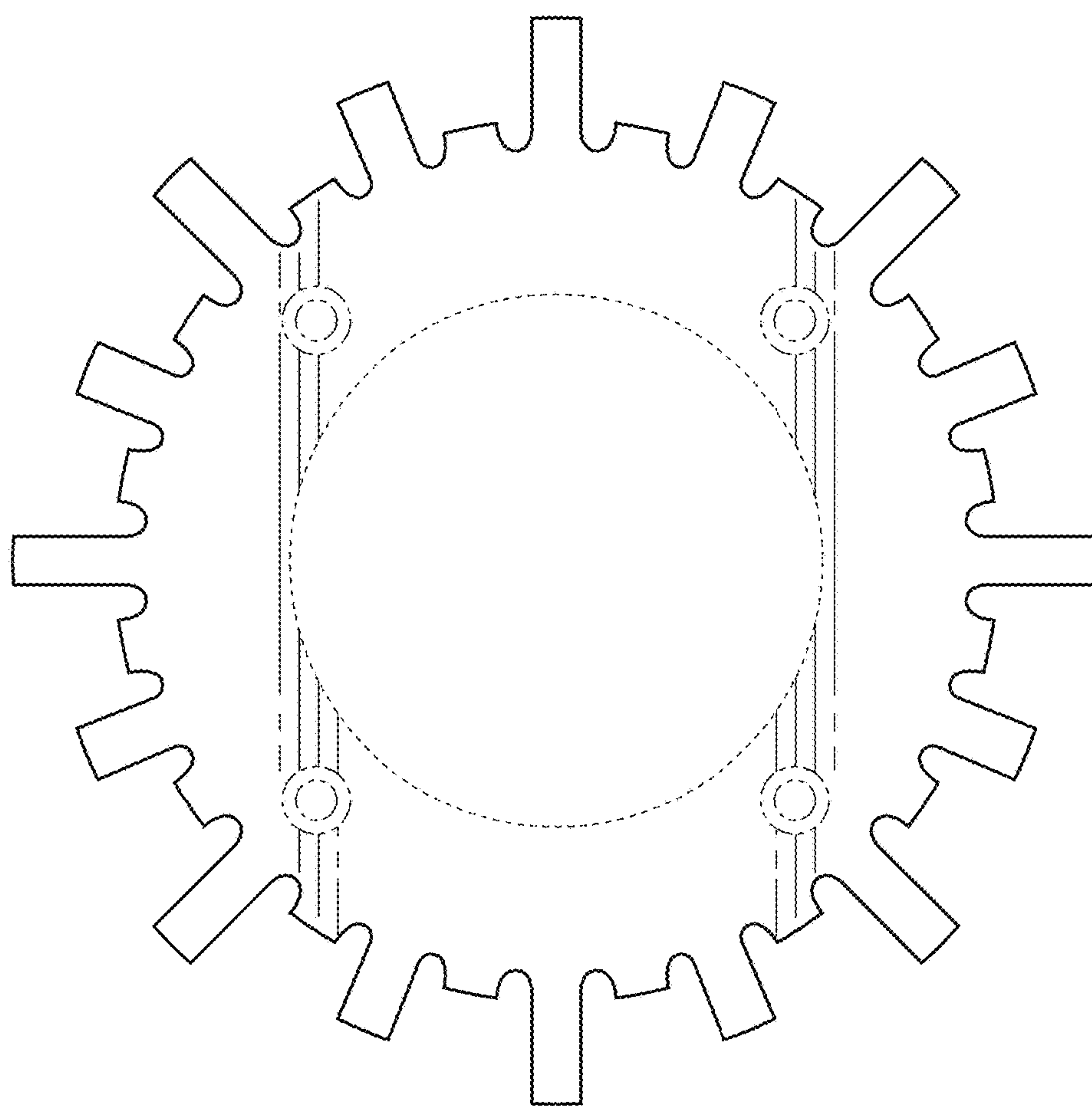

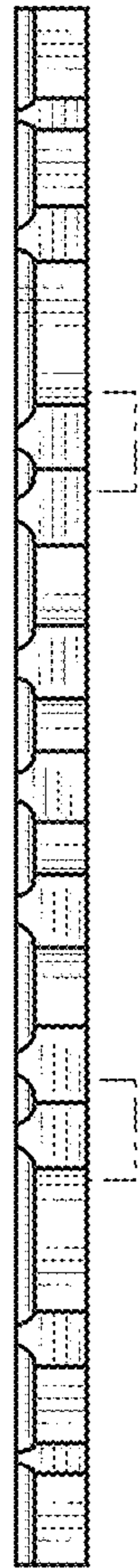

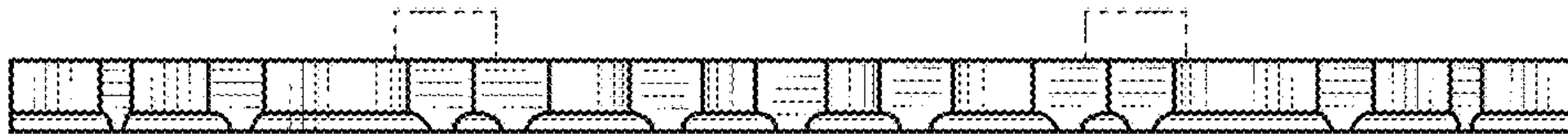

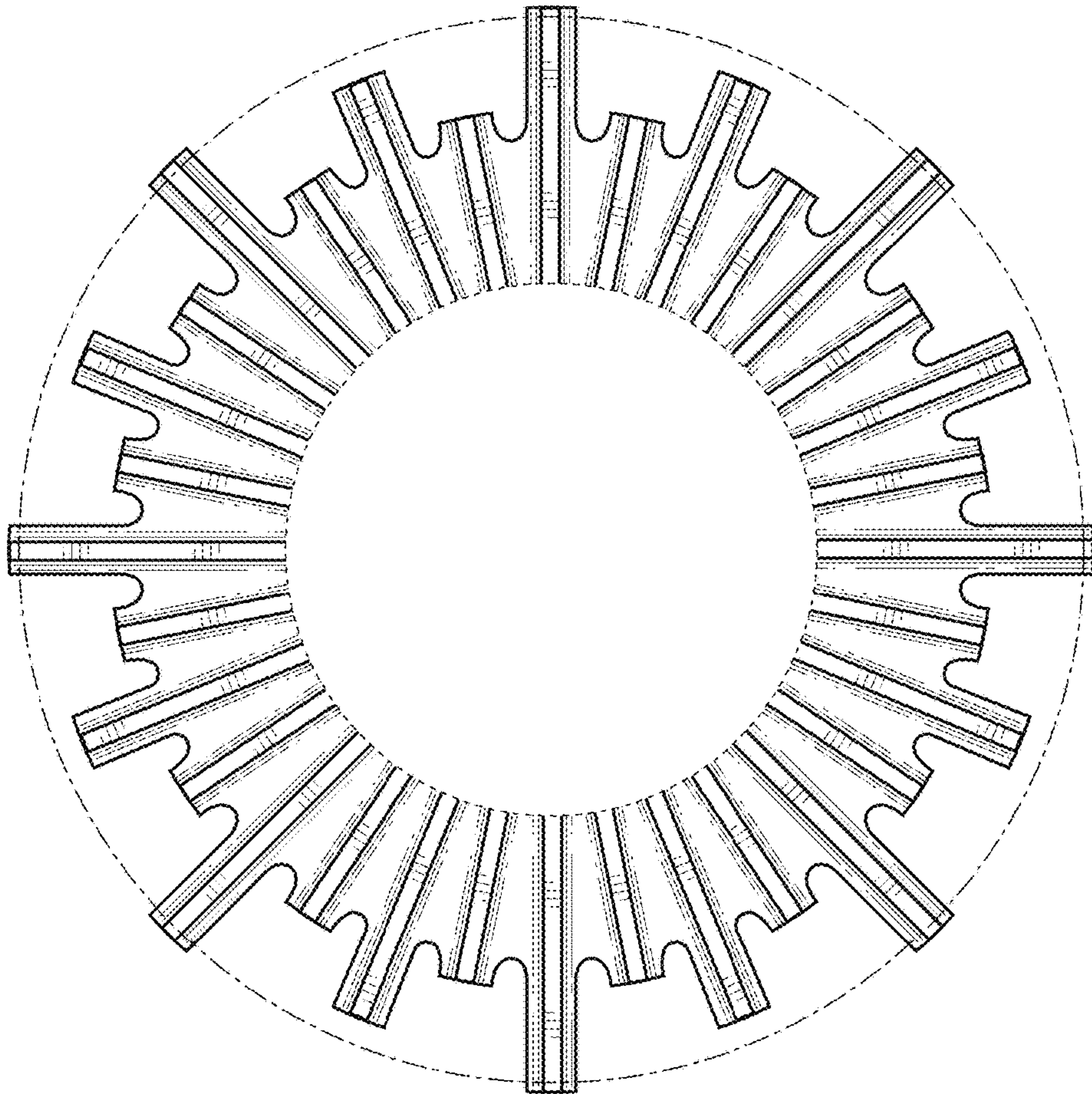

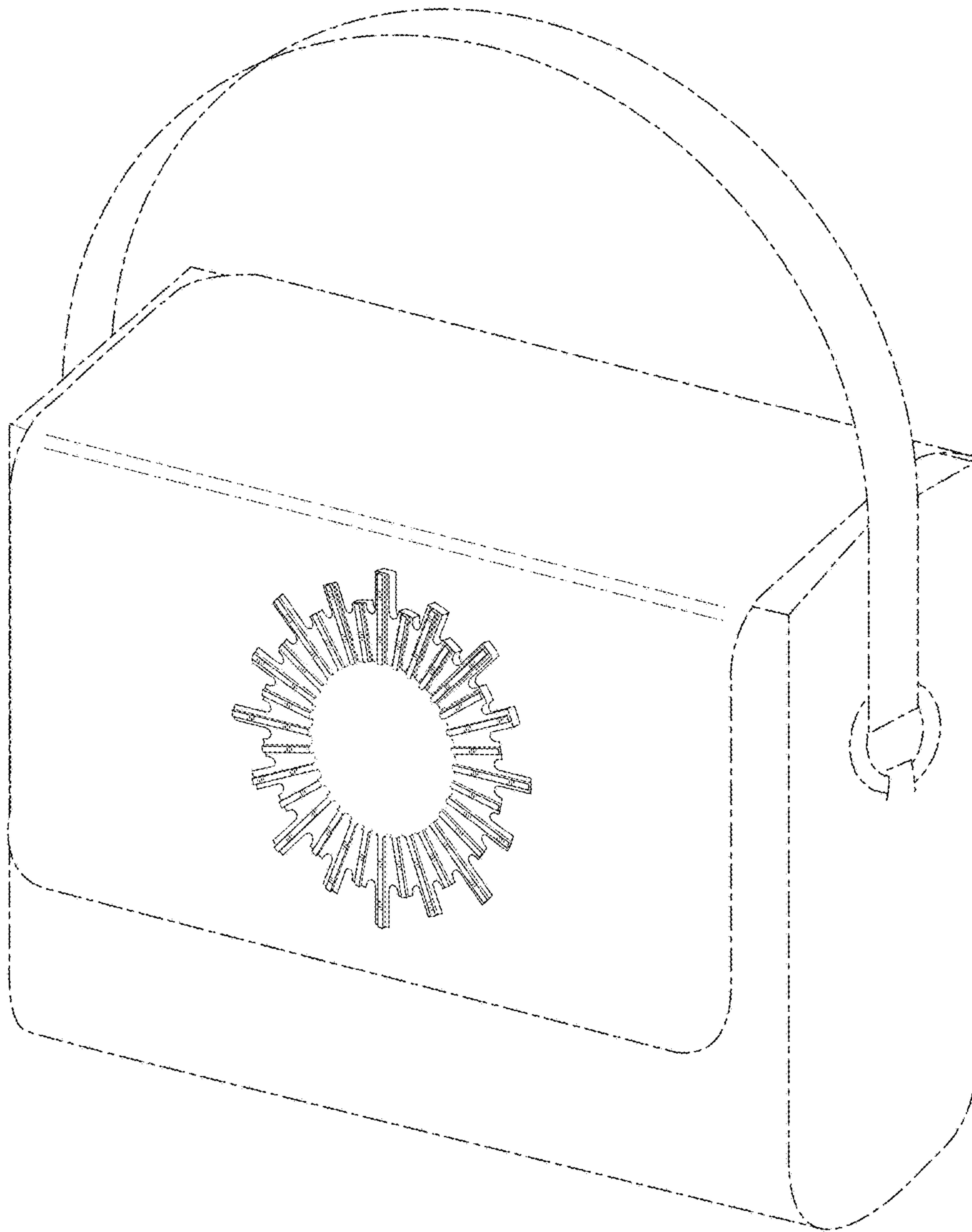
