DESCRIPTION

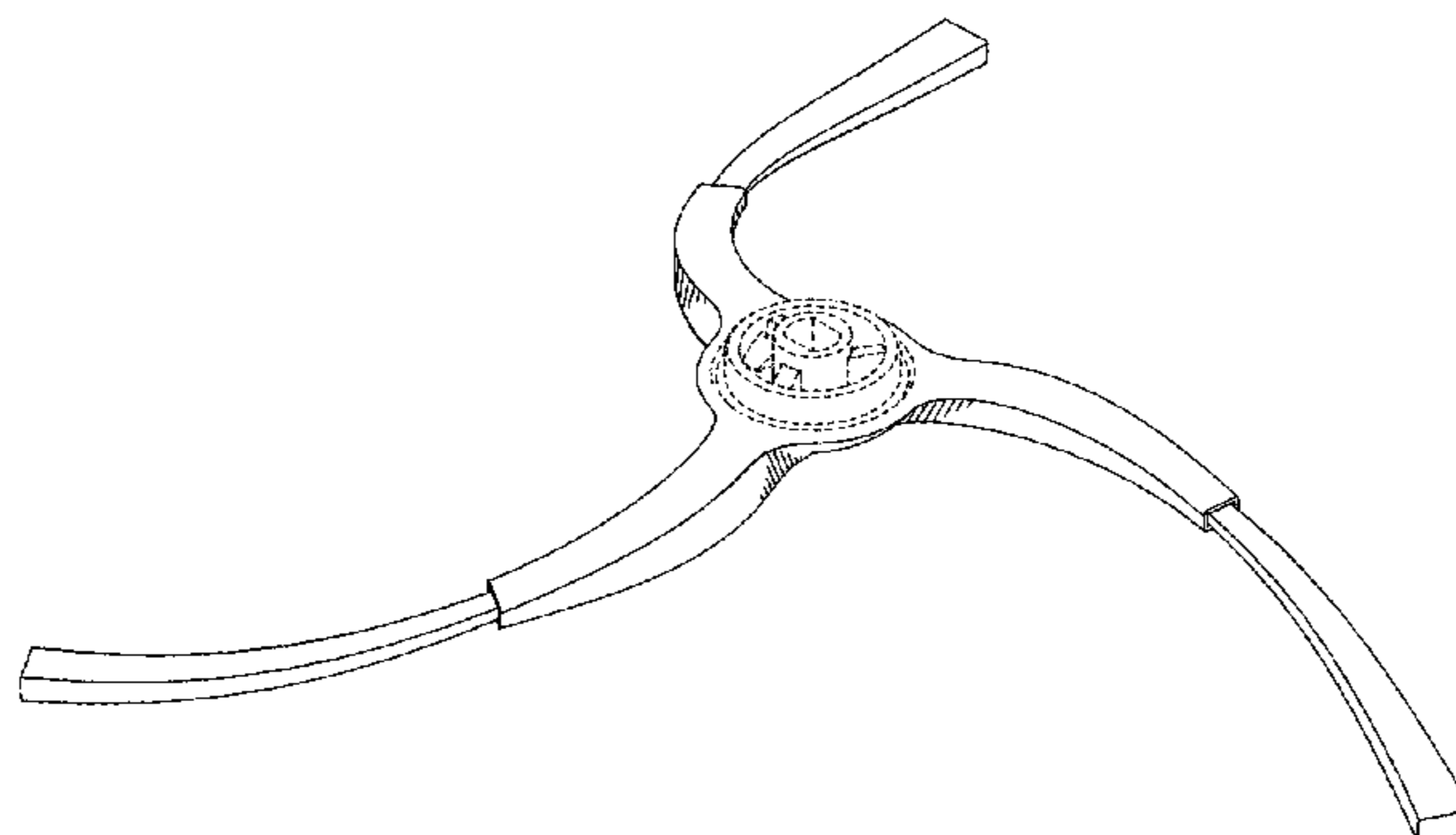
FIG. 1 is a perspective top view of a circular brush showing our new design;

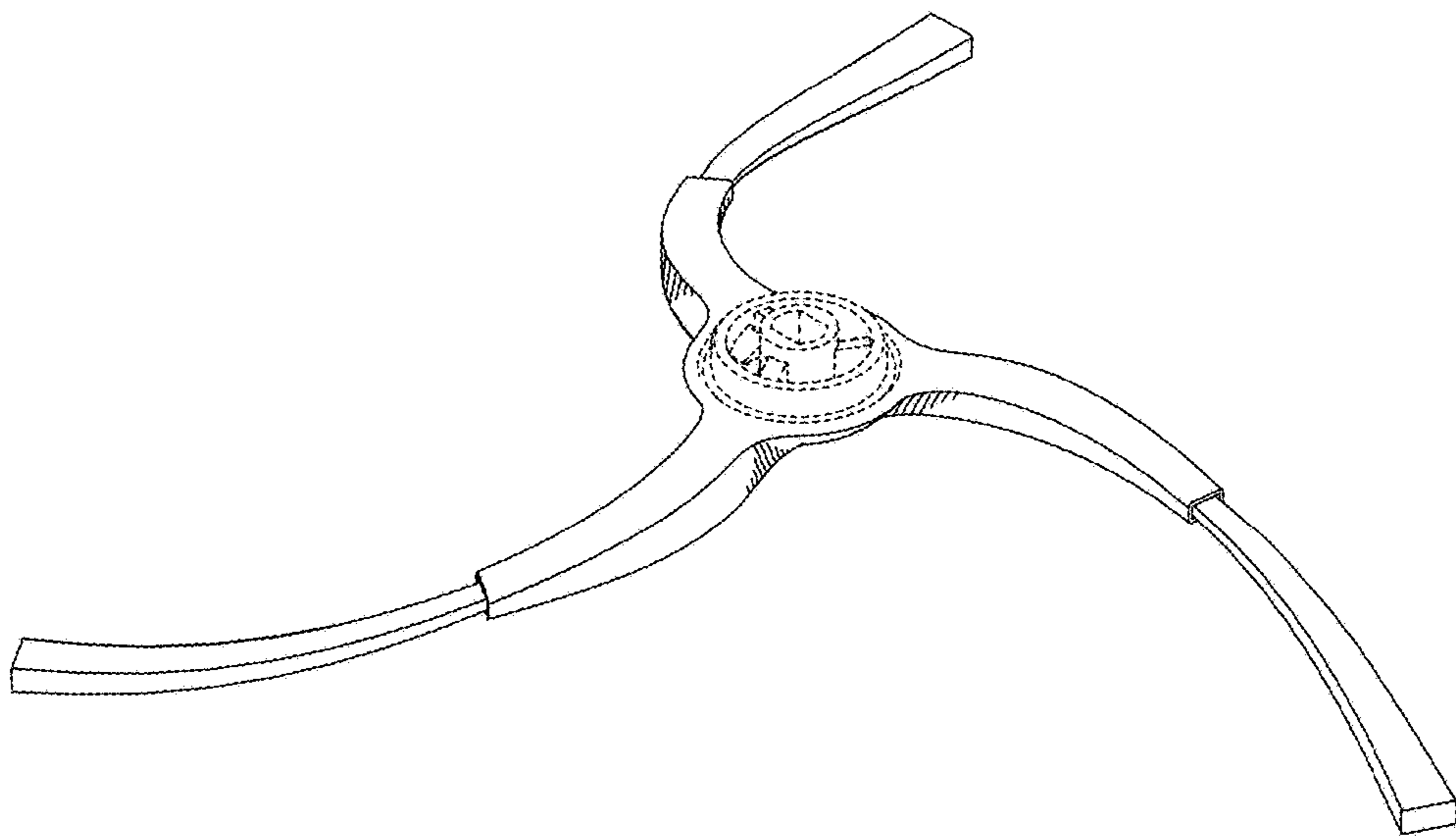

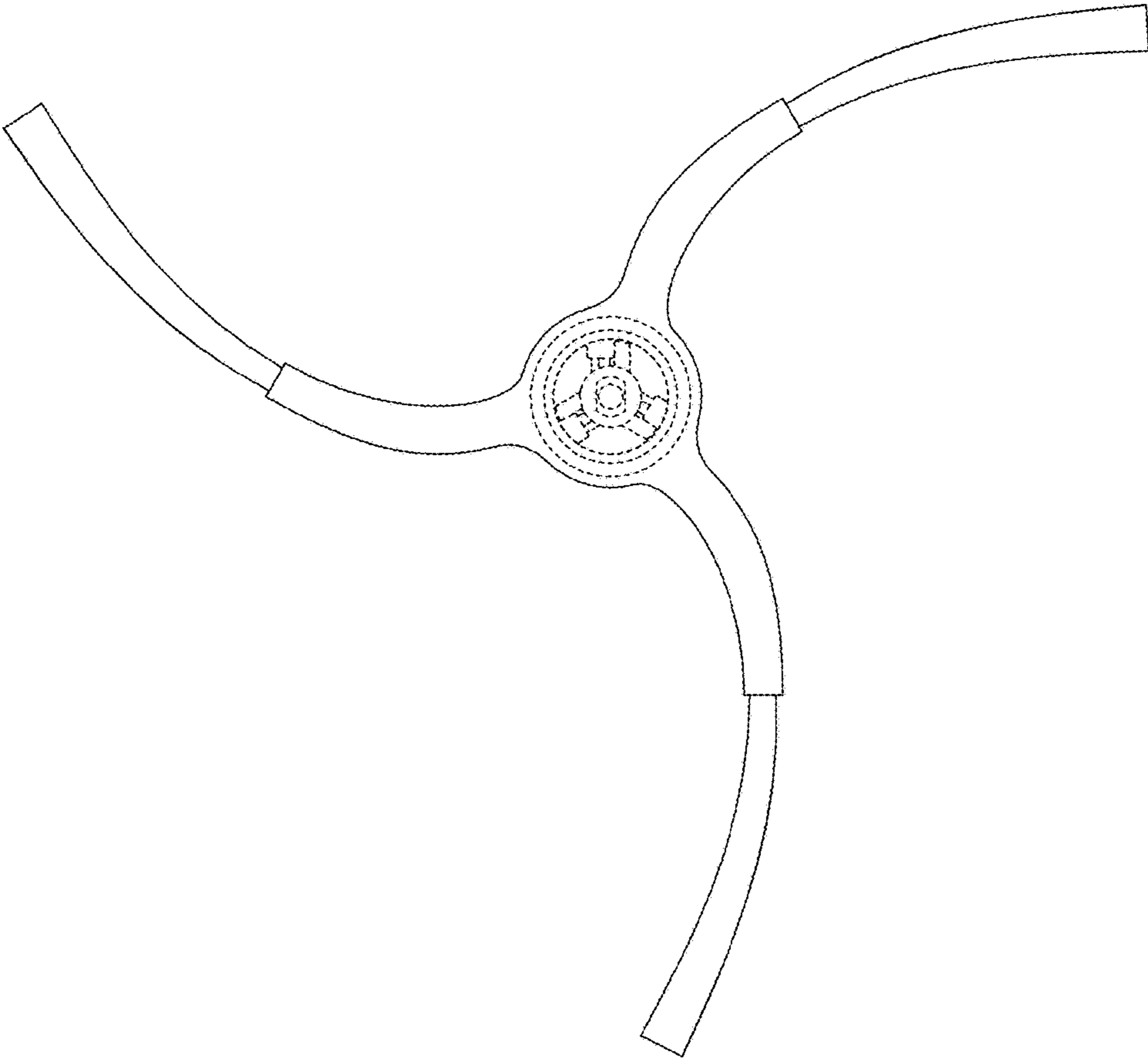

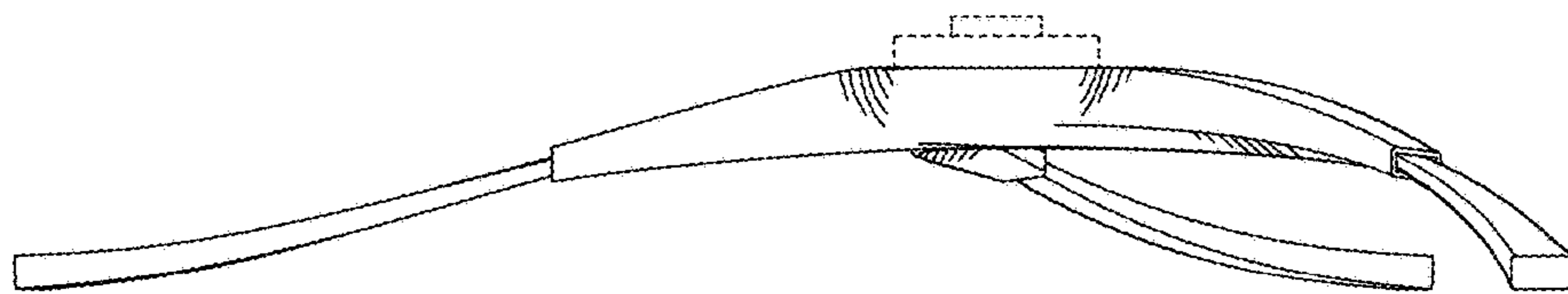

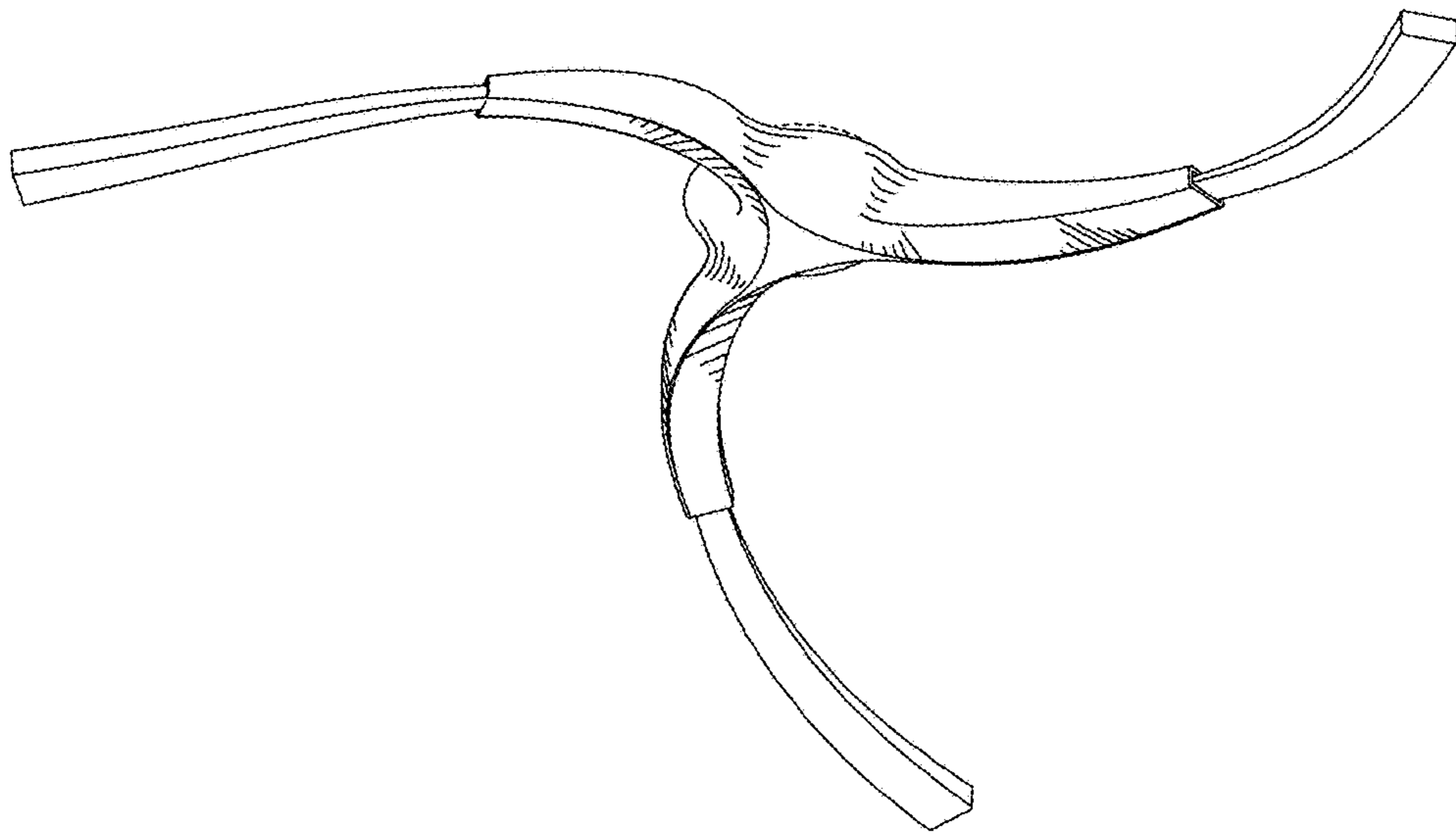
