FIG. 2 is top perspective view of the hair brush of FIG. 1. FIG. 3 is another top perspective view of the hair brush of FIG. 1.

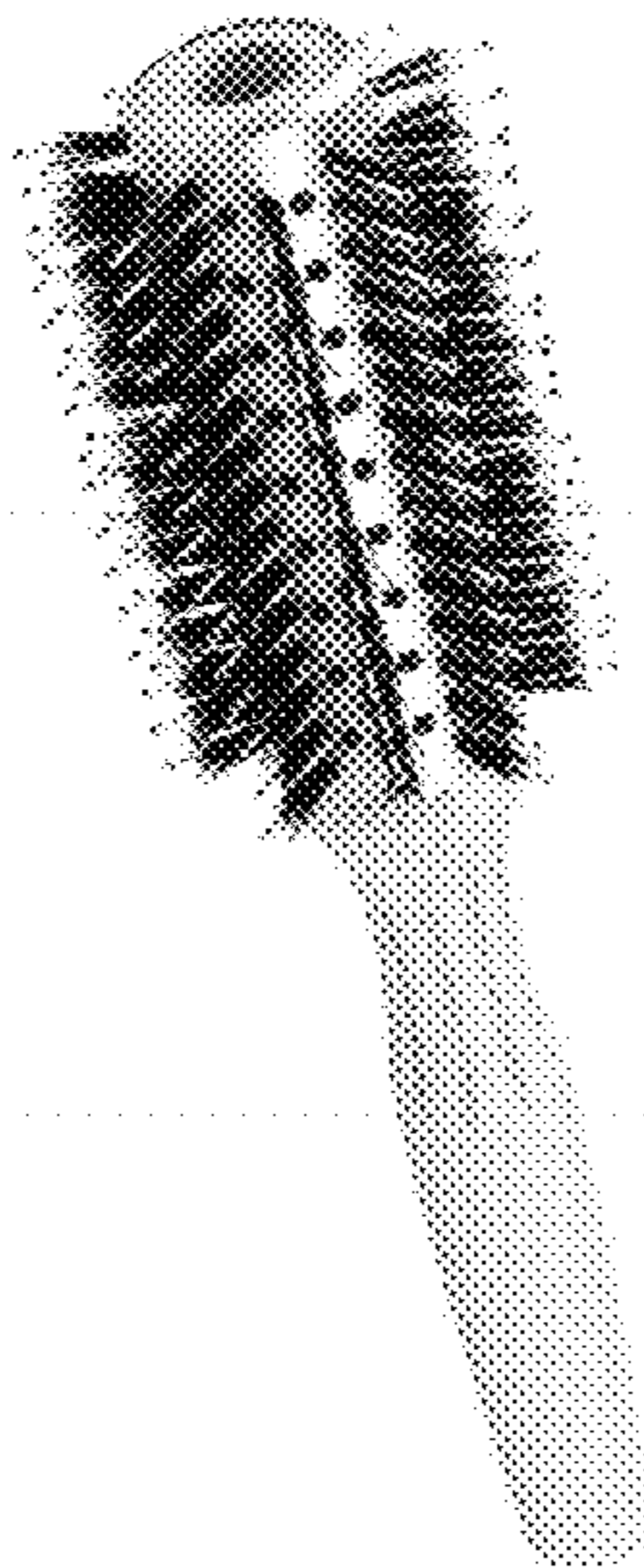
FIG. 4 is a bottom perspective view of the hair brush of FIG. 1.

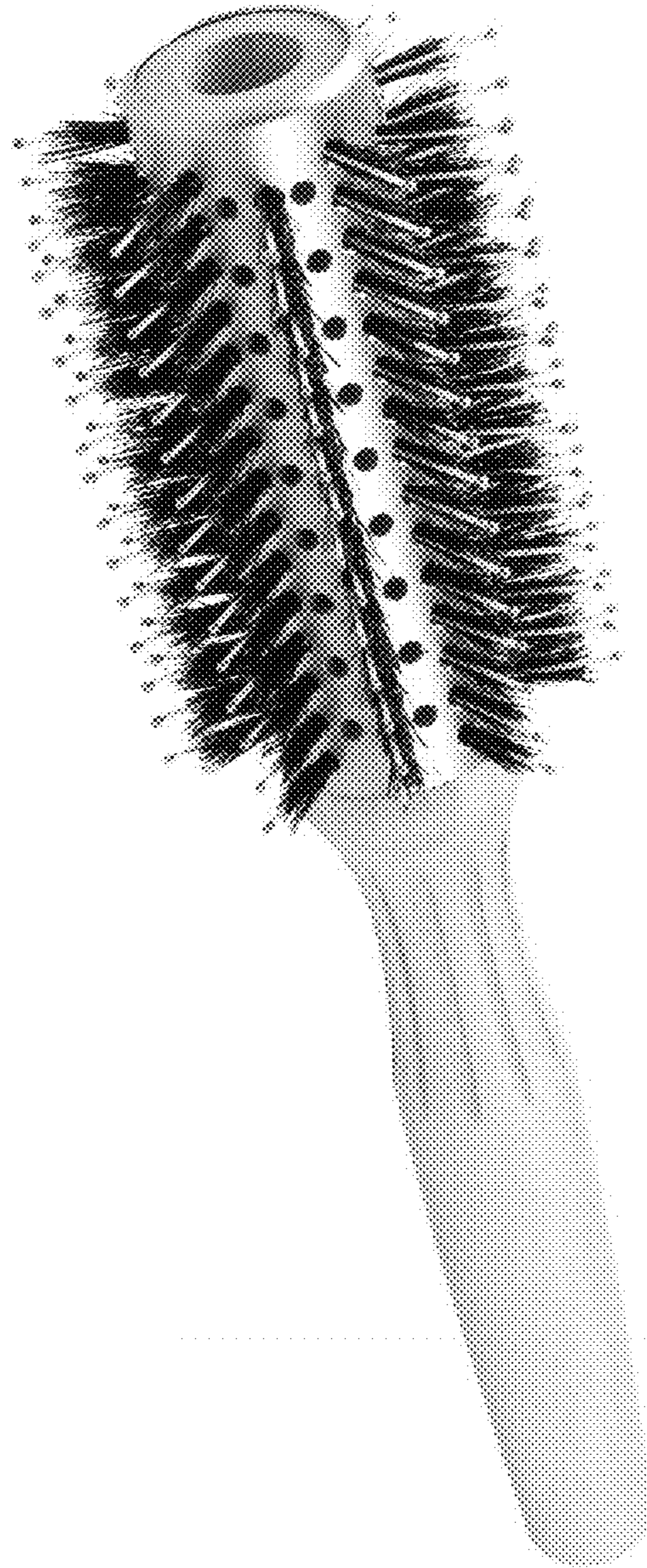

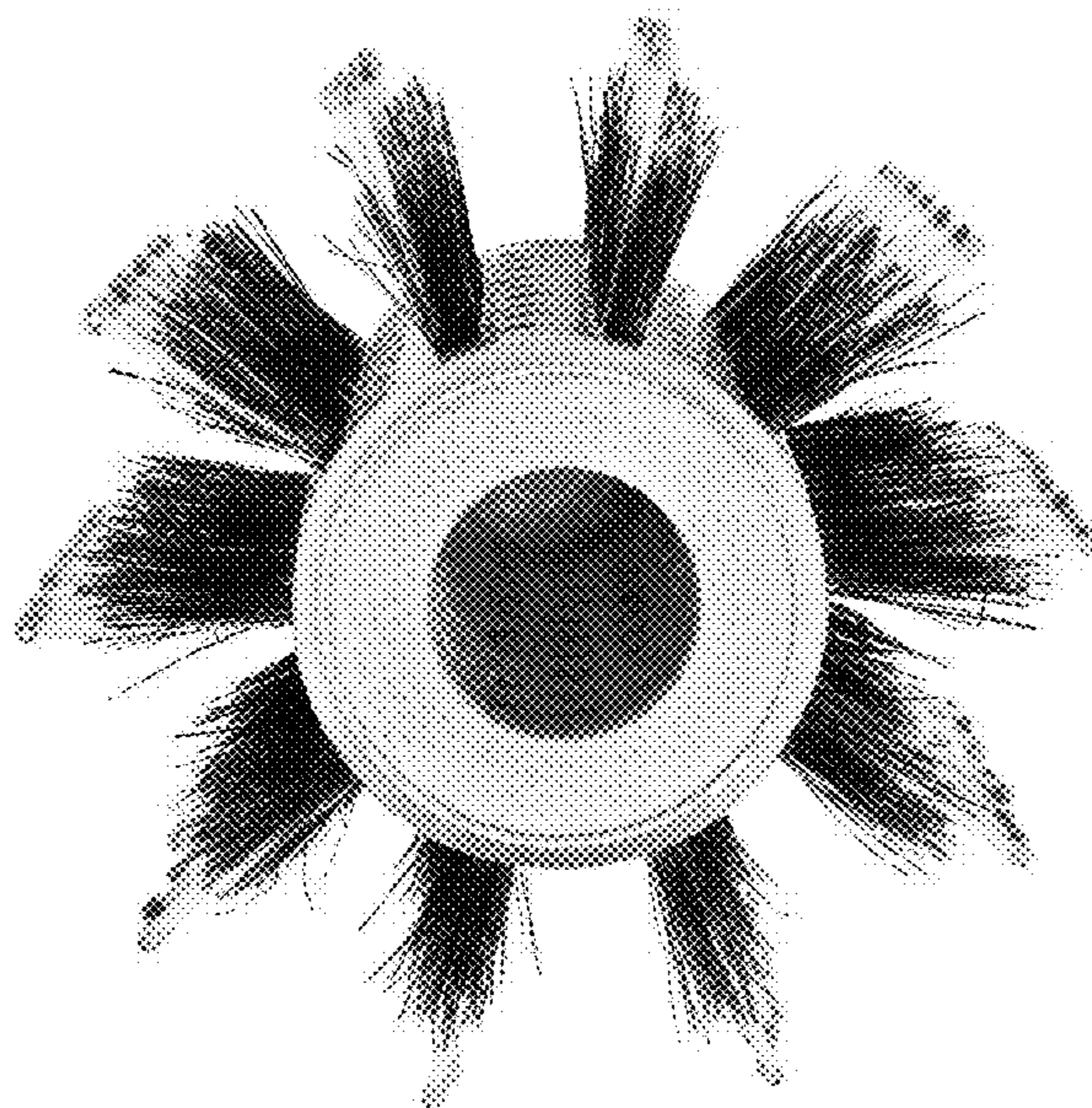

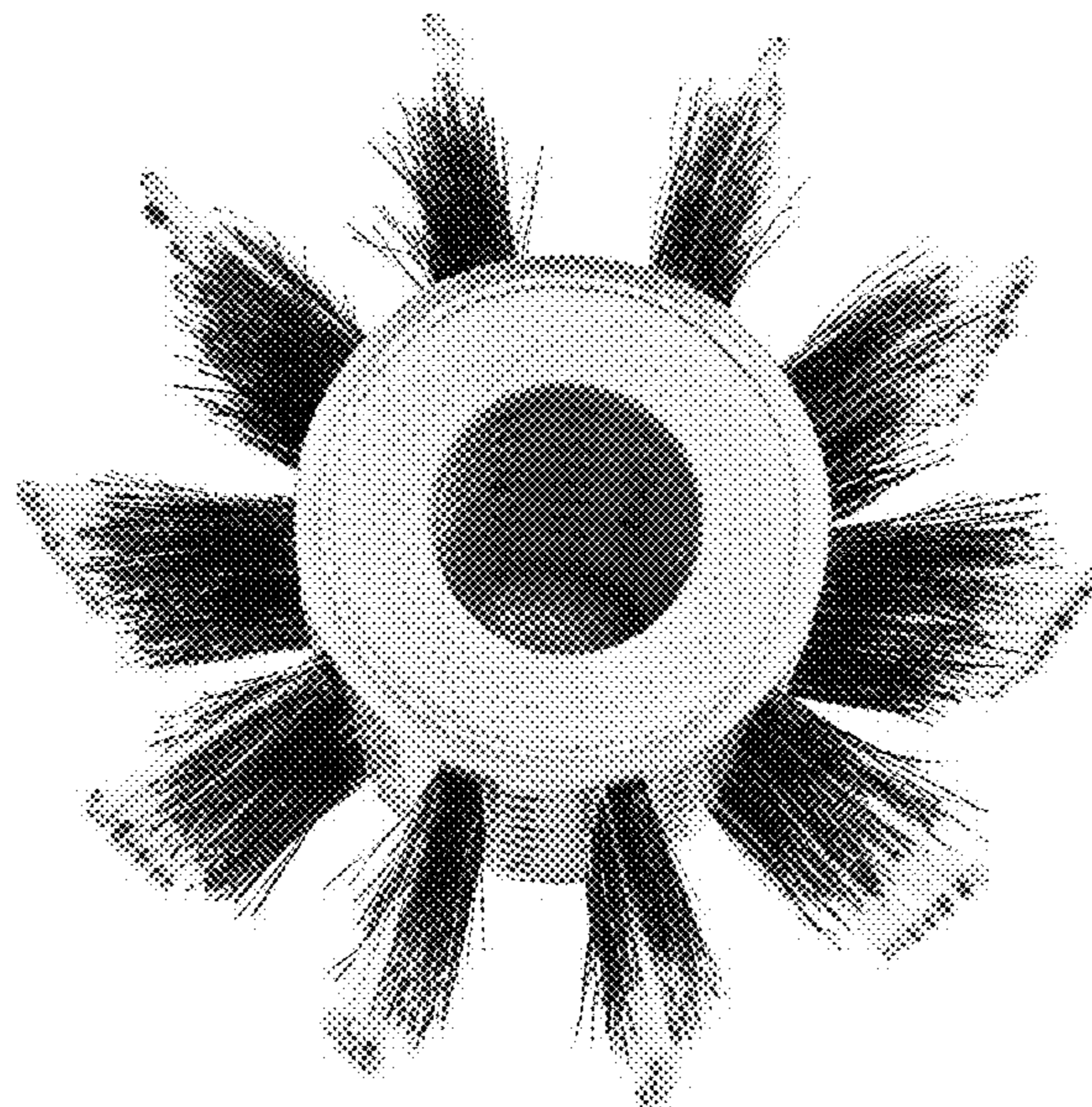

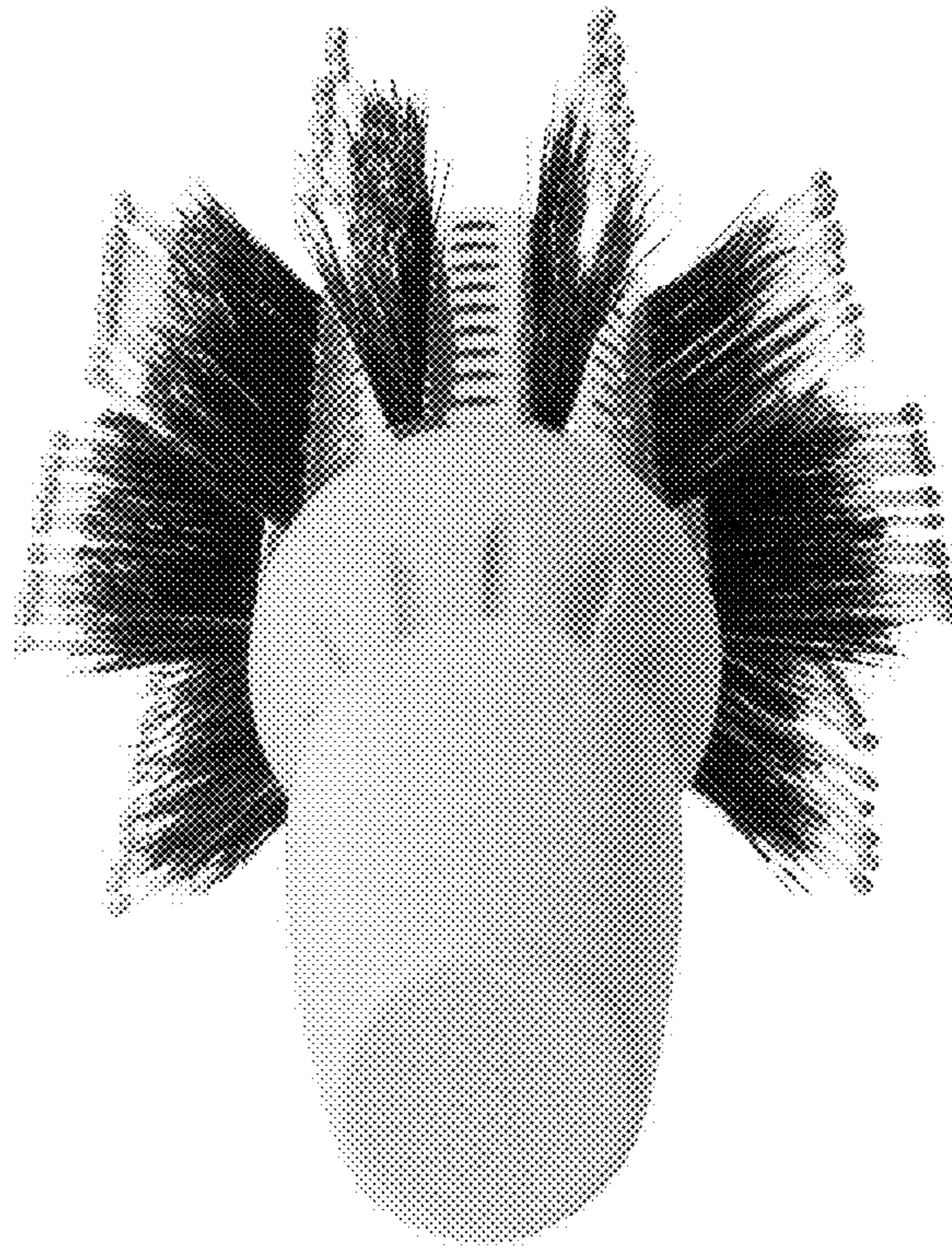

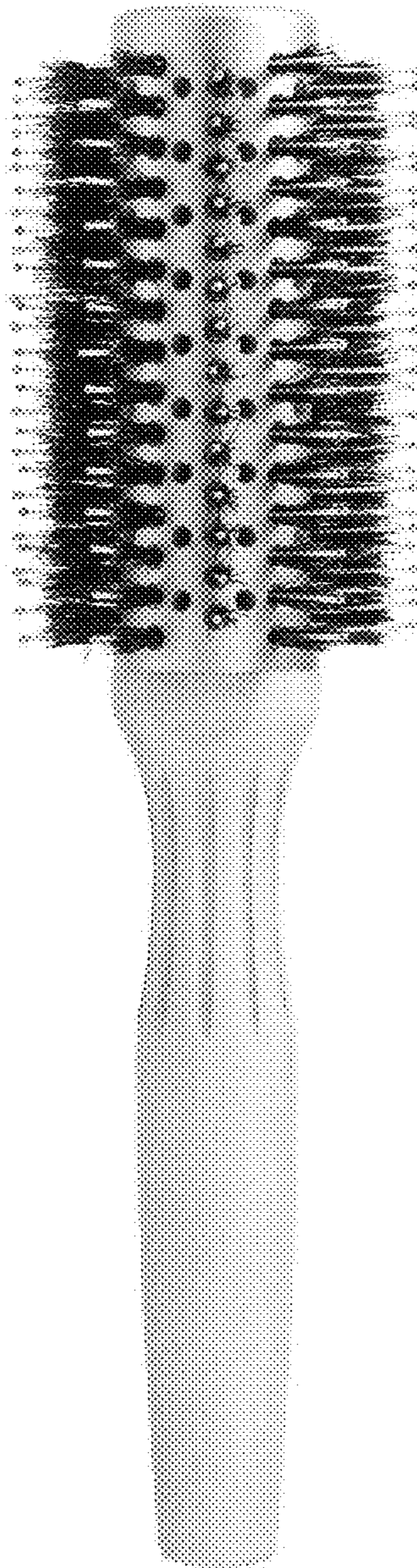

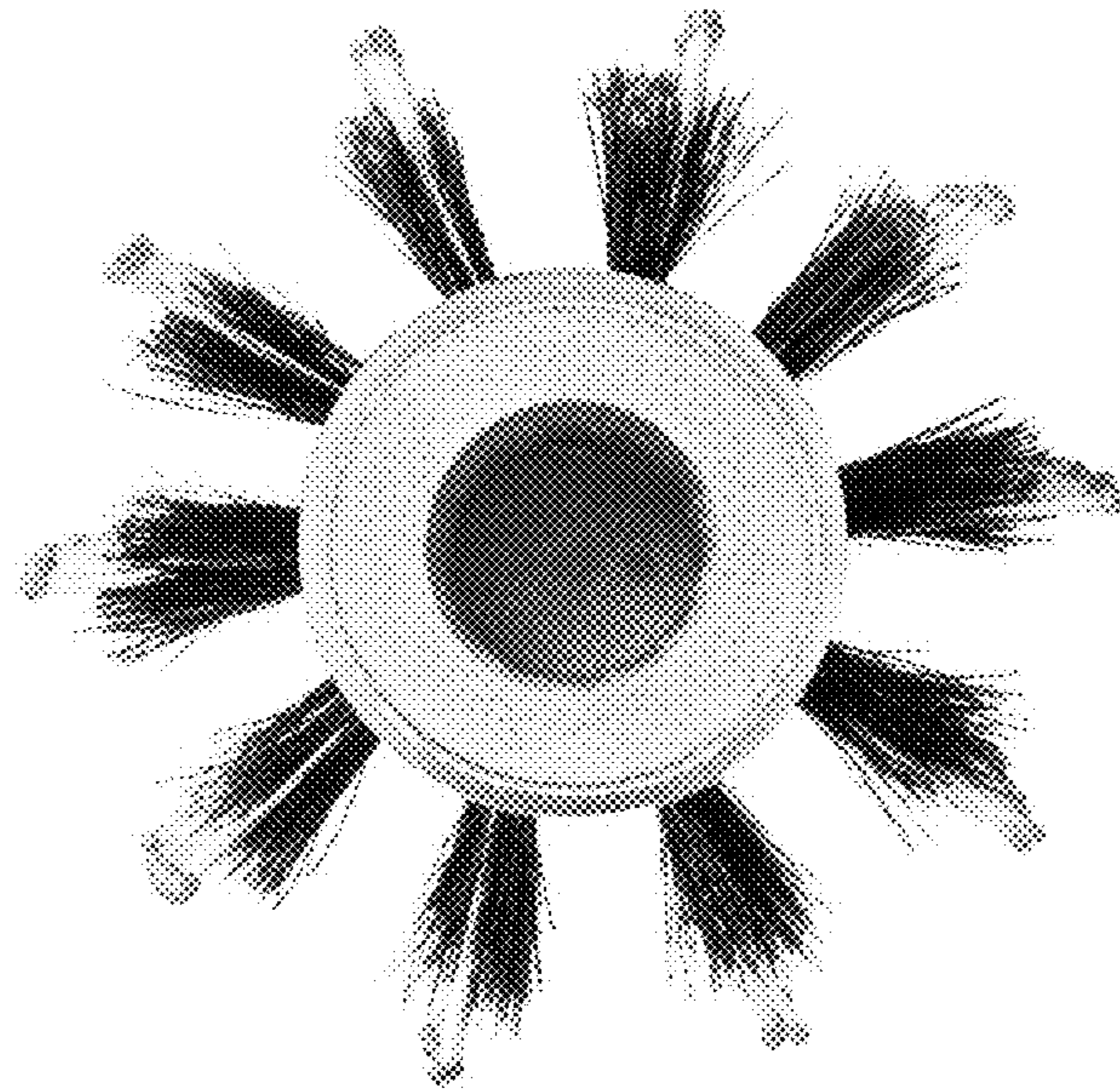

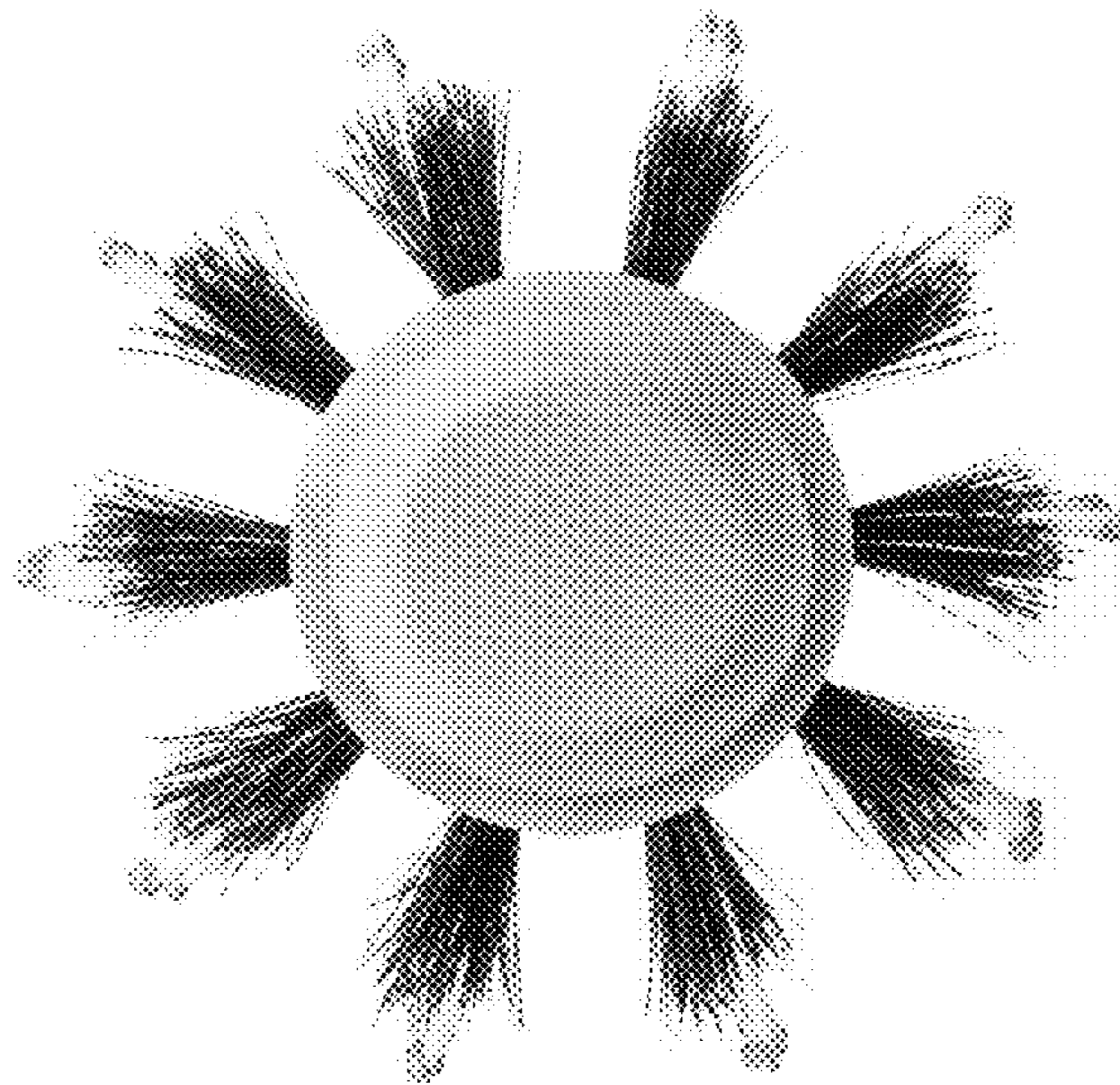
