The ornamental design for a child safety seat for motor cars, as shown and described.

DESCRIPTION

1. Child safety seat for motor cars

2.1 is a perspective view of a child safety seat for motor cars in accordance with the present invention;

2.2 is a front elevational view of the child safety seat of **2.1**;

2.3 is a rear elevational view of the child safety seat of **2.1**;

2.4 is a top plan view of the child safety seat of **2.1**;


2.5 is a bottom plan view of the child safety seat of **2.1**;

2.6 is a side elevational view of a first side of the child safety seat of **2.1**; and


2.7 is a side elevational view of a second side of the child safety seat of **2.1**.

The broken lines in the drawings depict portions of the child safety seat for motor cars that form no part of the claim.










