We claim the ornamental design for a vehicle seat, as shown (and described).

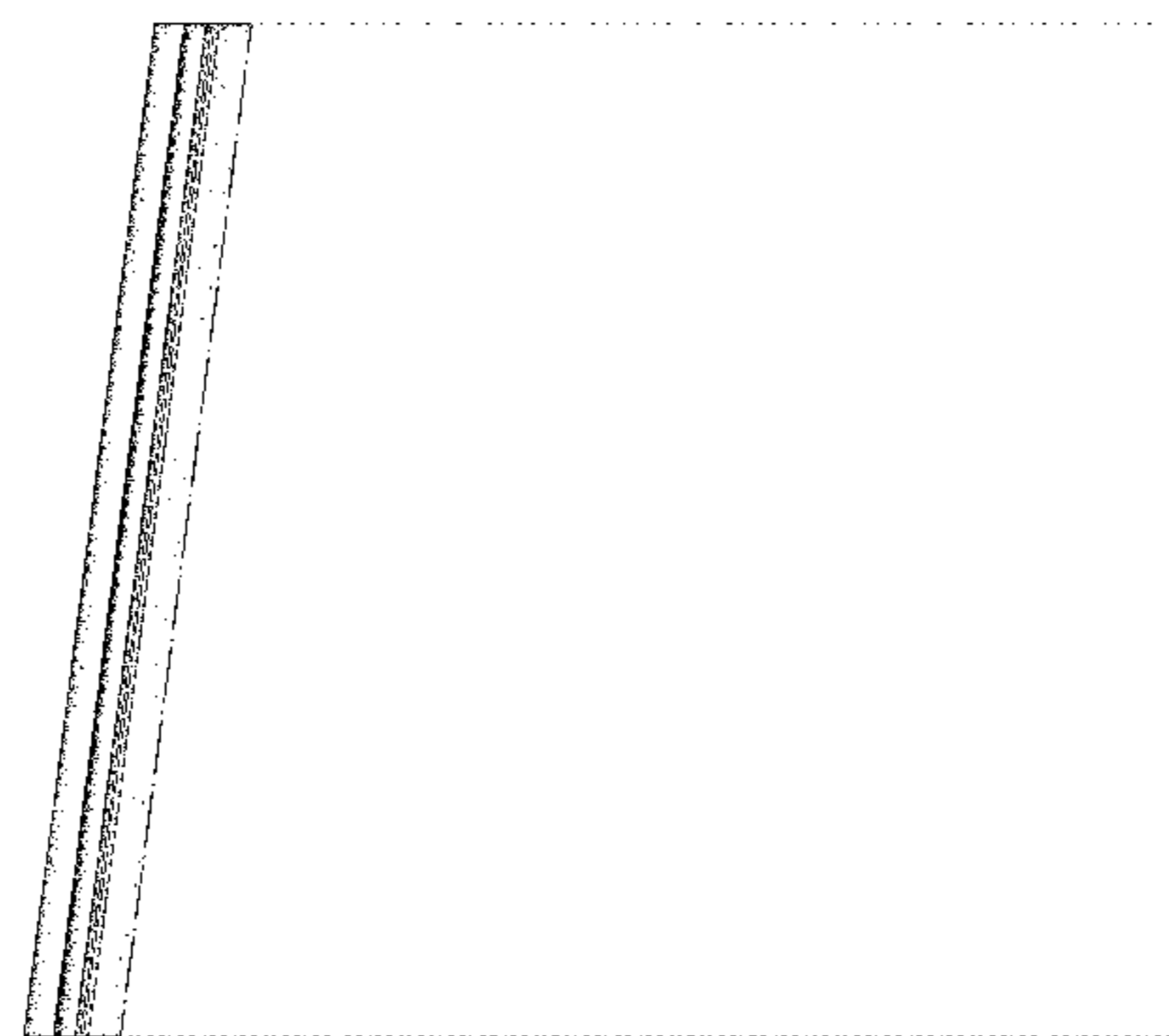
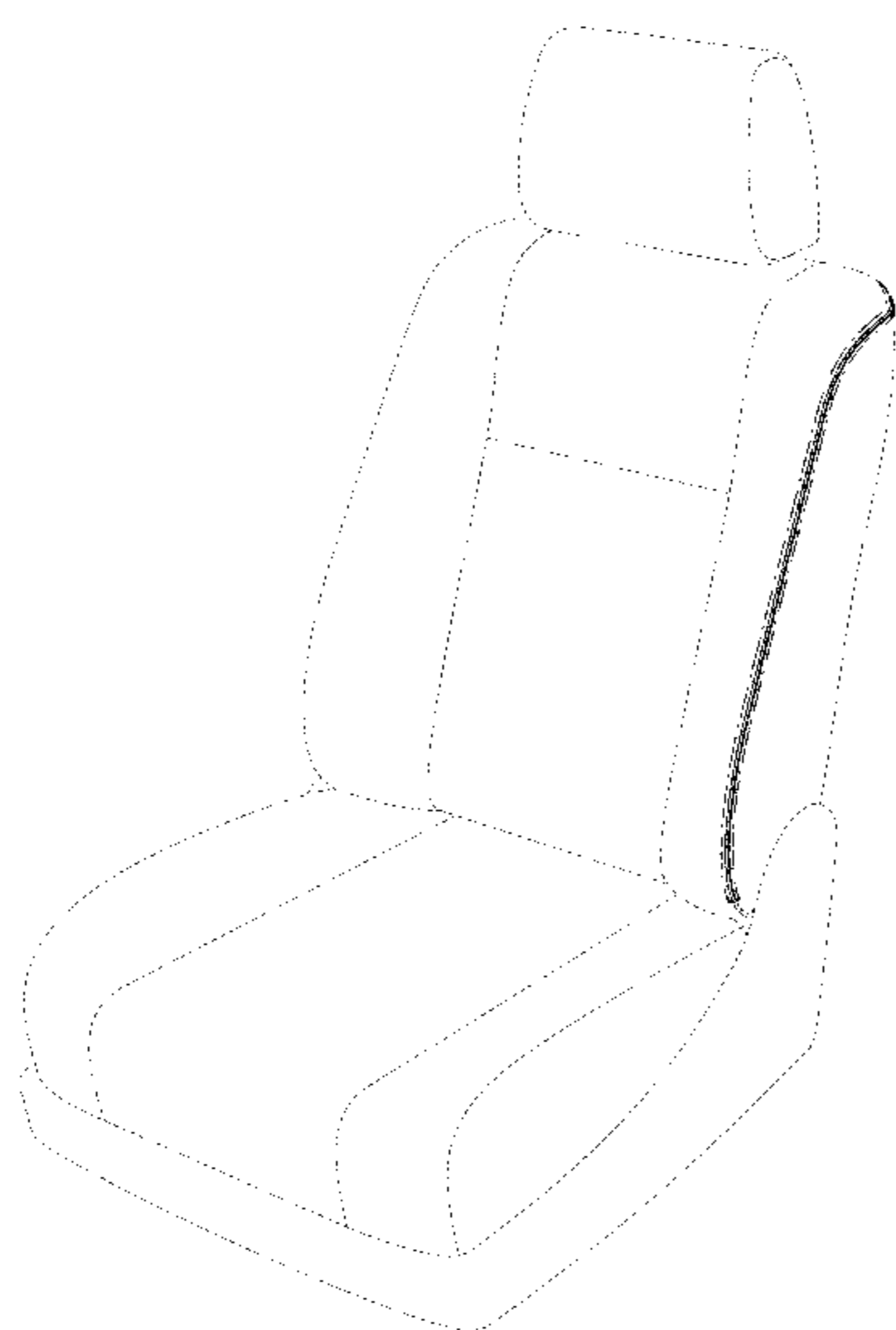
**DESCRIPTION**

FIG. 1 is a front, top and right side perspective view of a vehicle seat showing my new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a top plan view thereof;  
FIG. 5 is a bottom plan view thereof; and  
FIG. 6 is a left side elevational view thereof;  
FIG. 7 is a right side elevational view thereof;  
FIG. 8 is a cross-sectional view taken along 8-8 in FIG. 2;  
FIG. 9 is an enlarged detailed view of FIG. 8 thereof; and,  
FIG. 10 is an enlarged detailed view of FIG. 7.

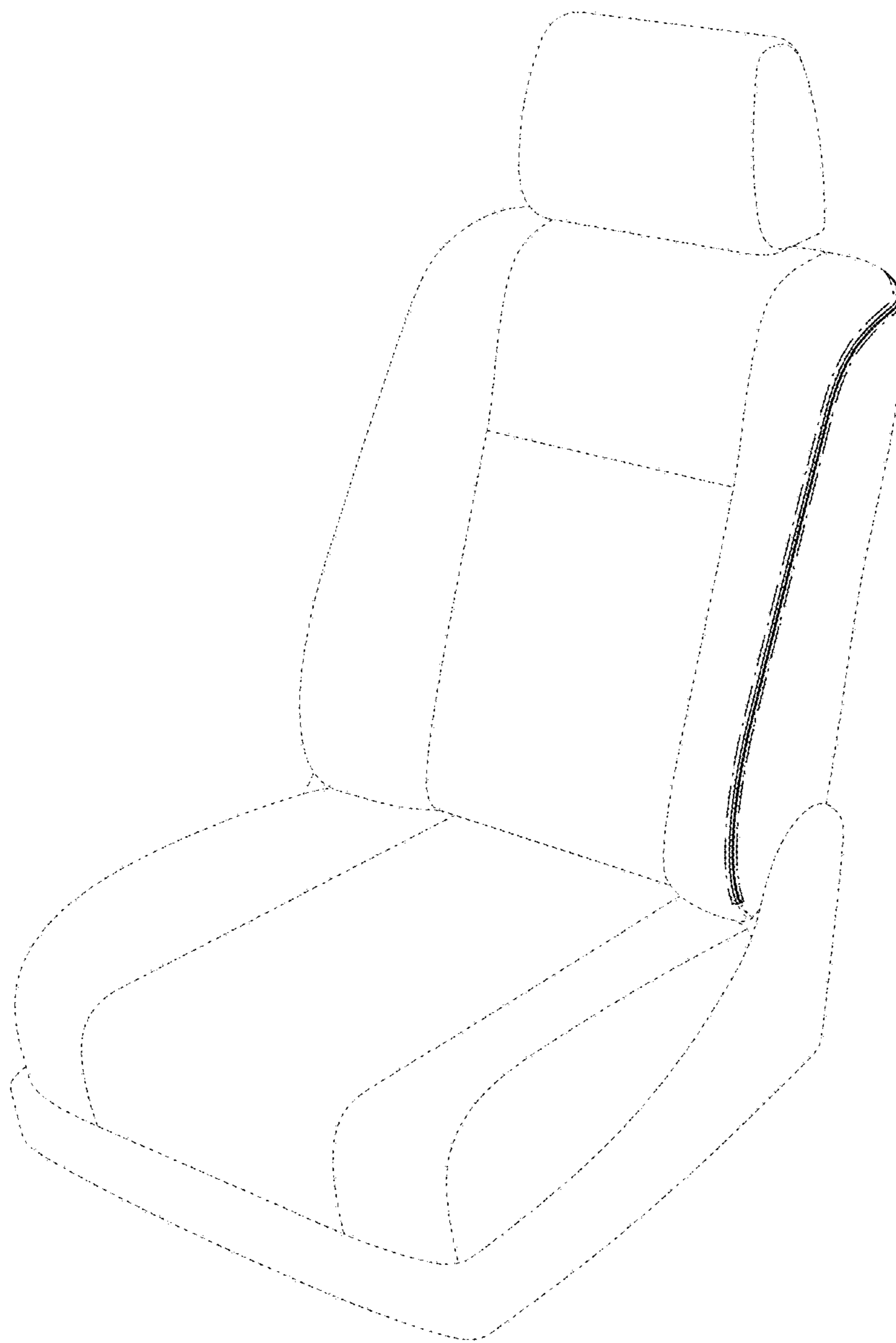

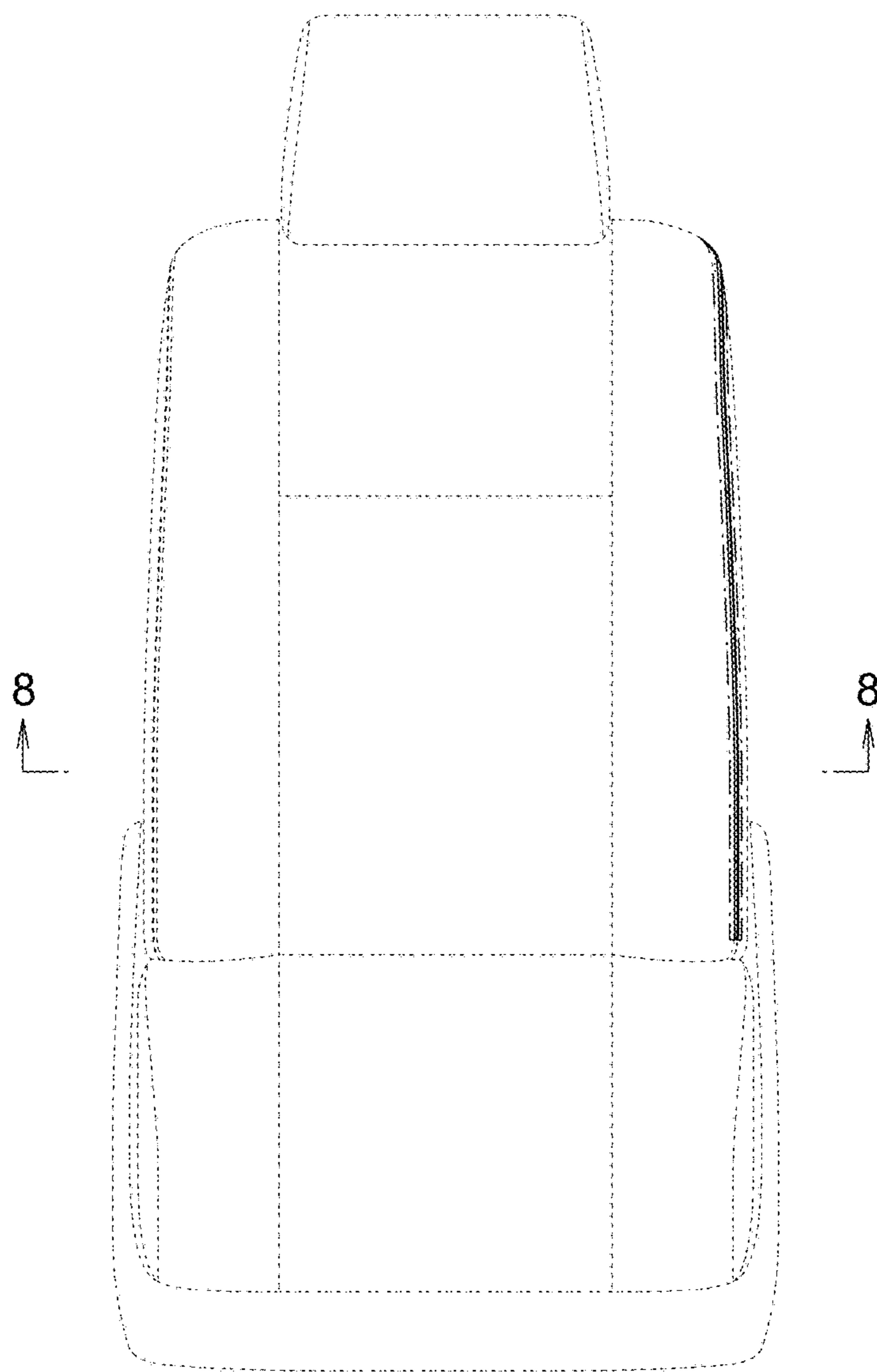

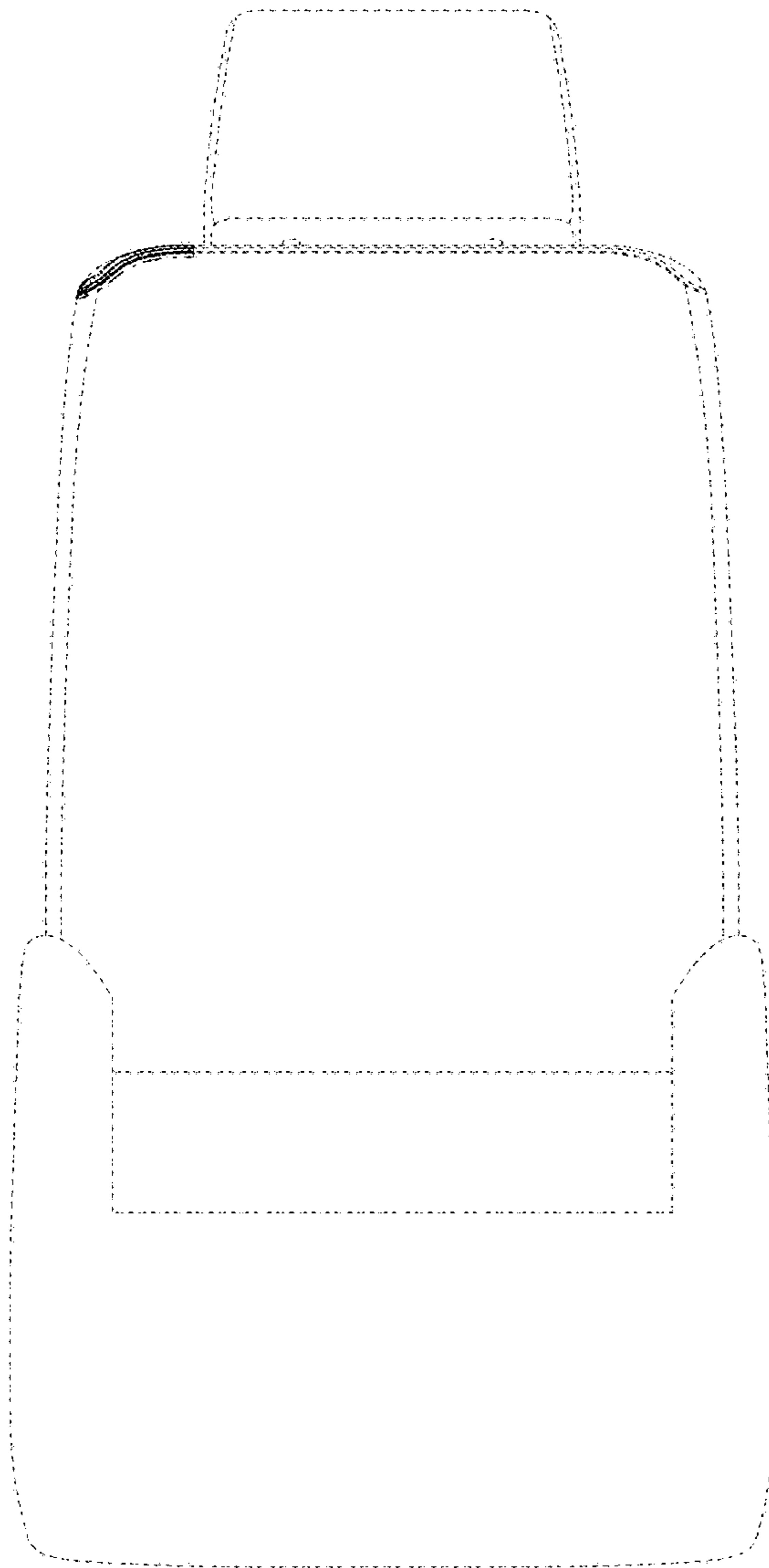

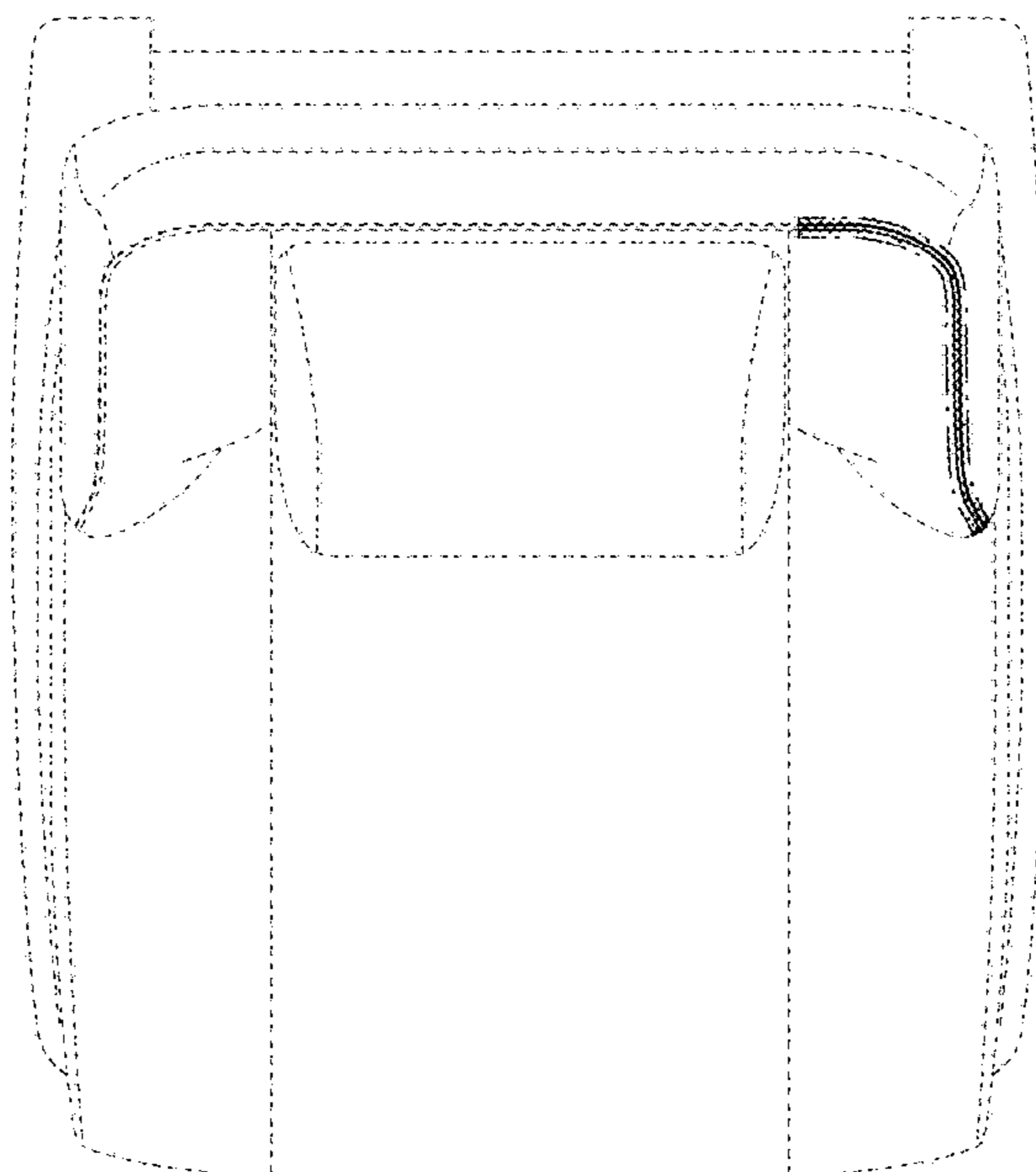

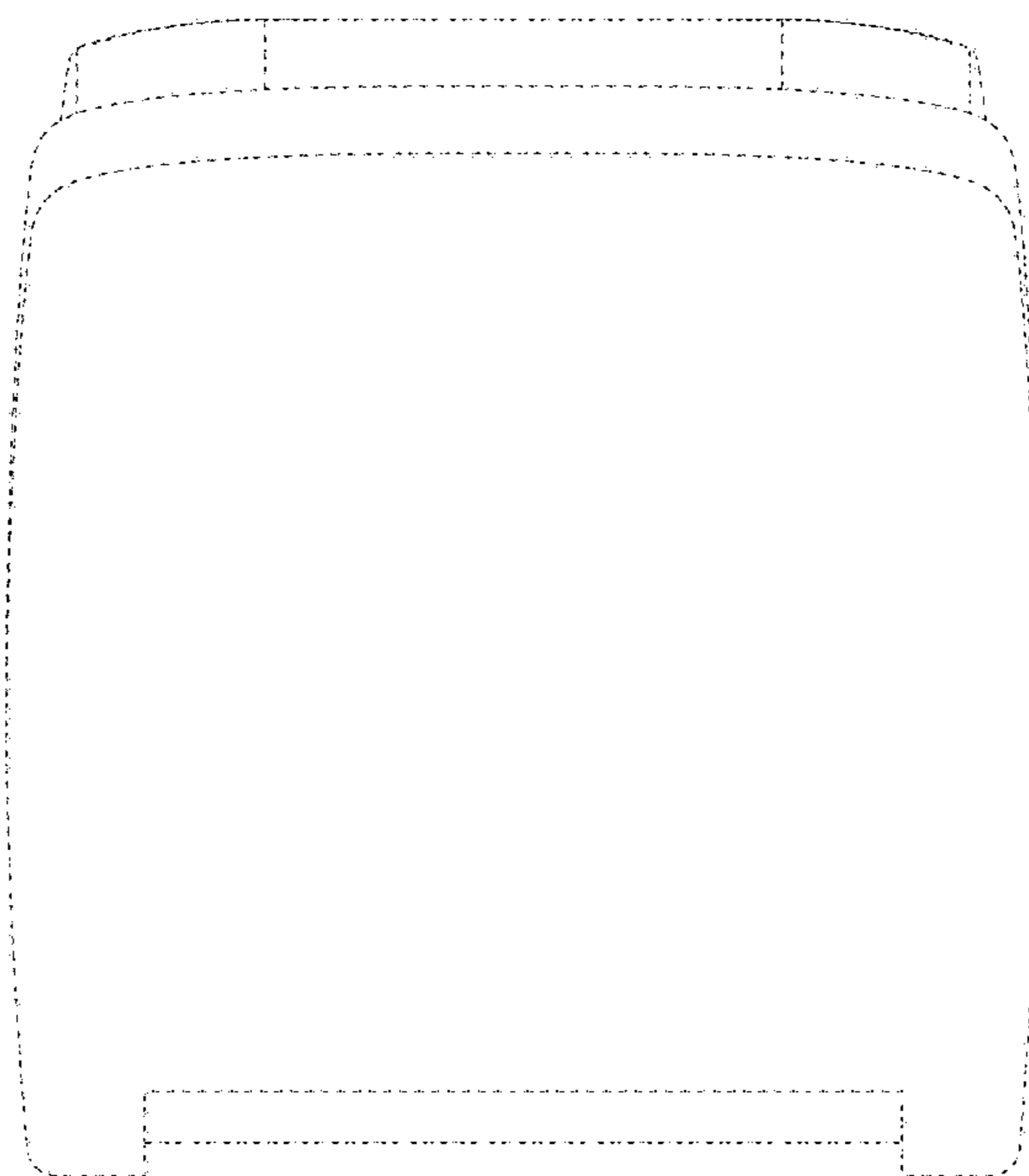

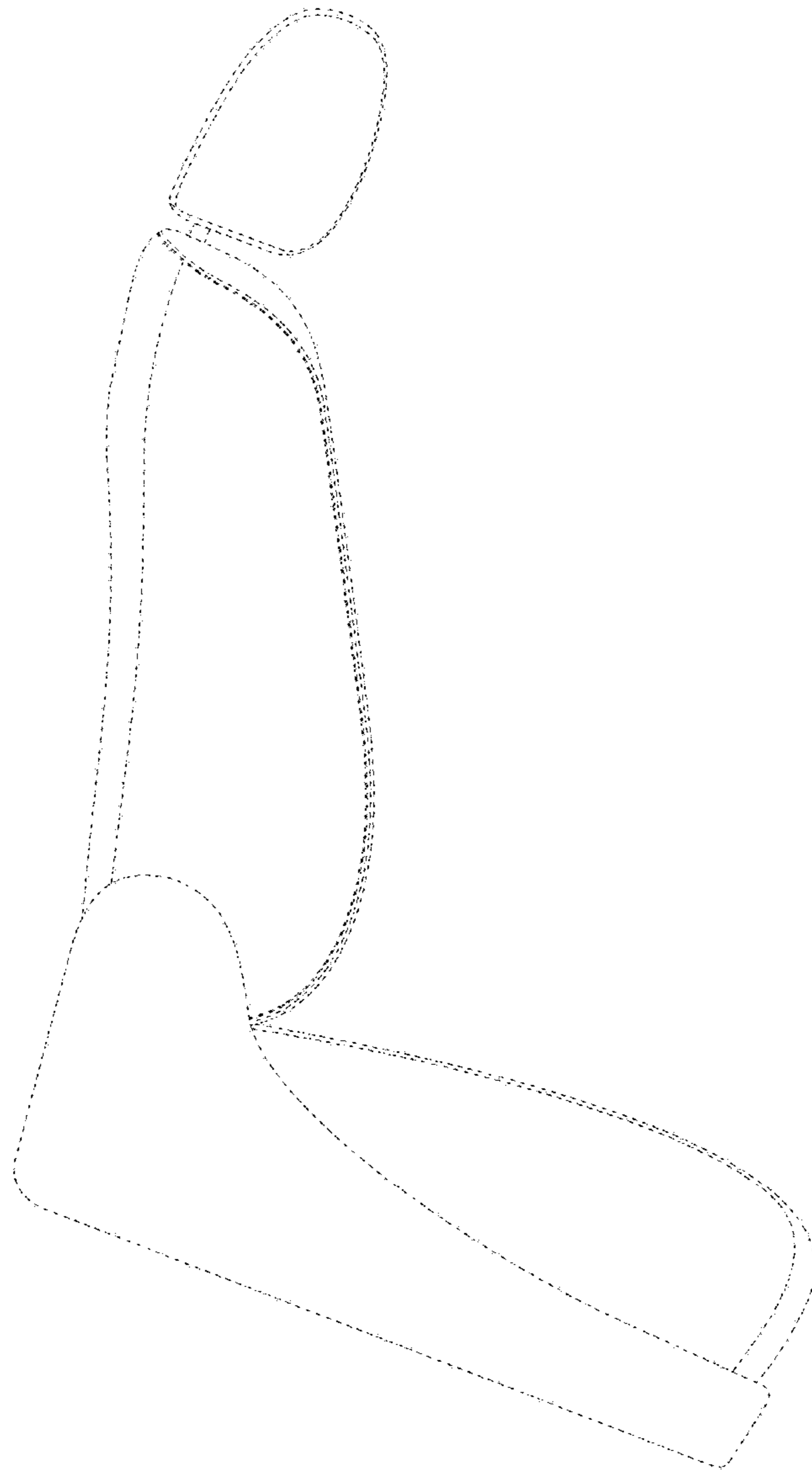

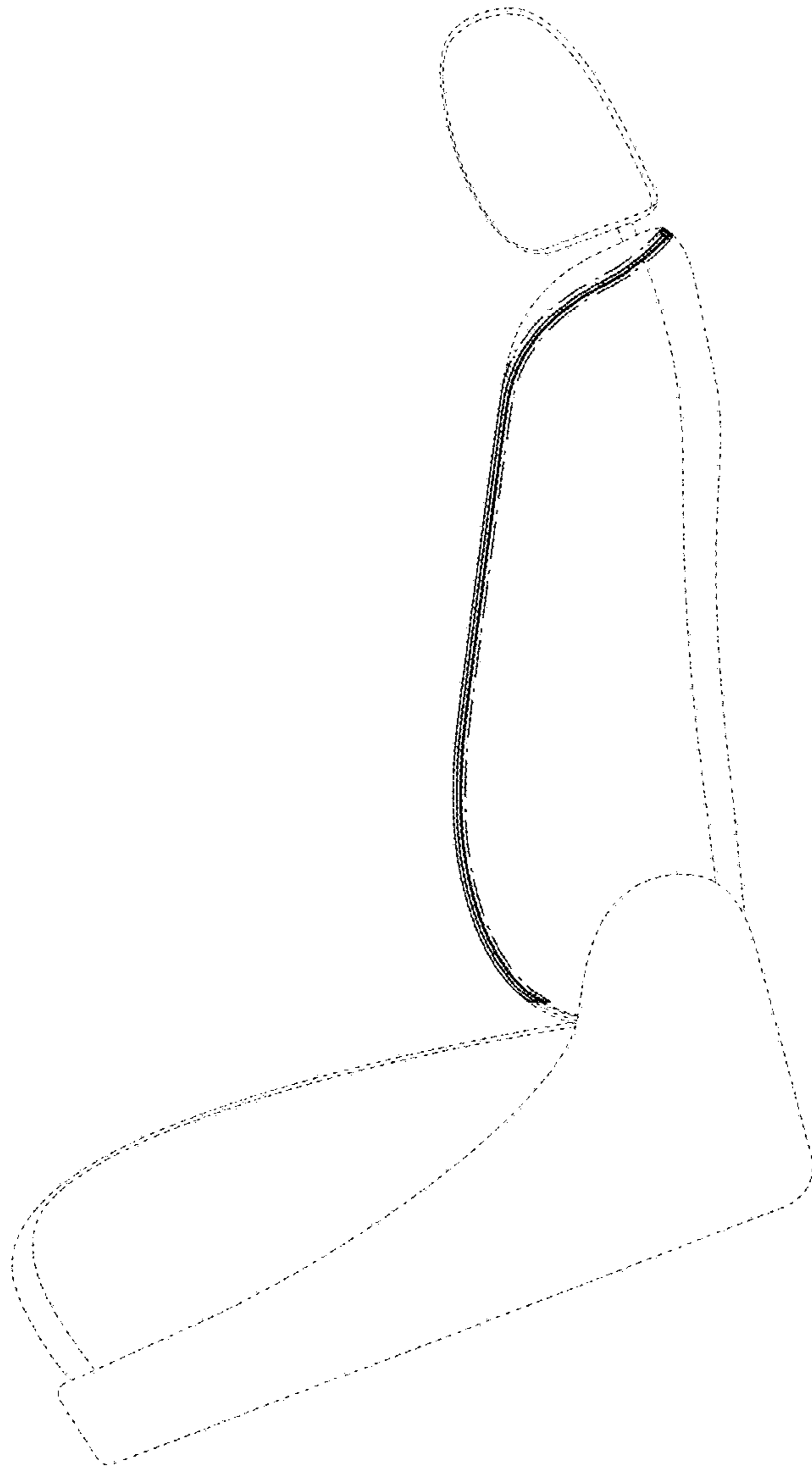

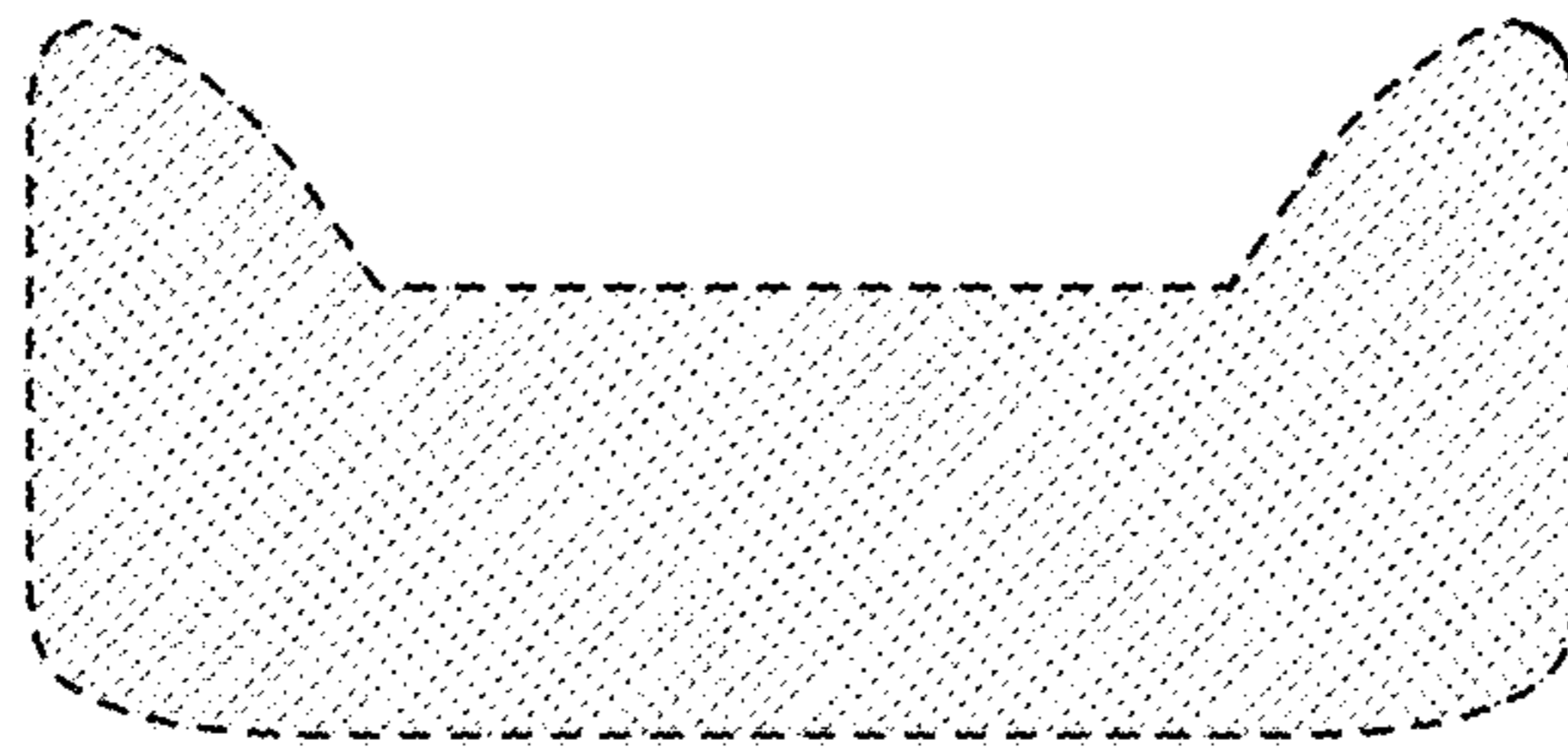

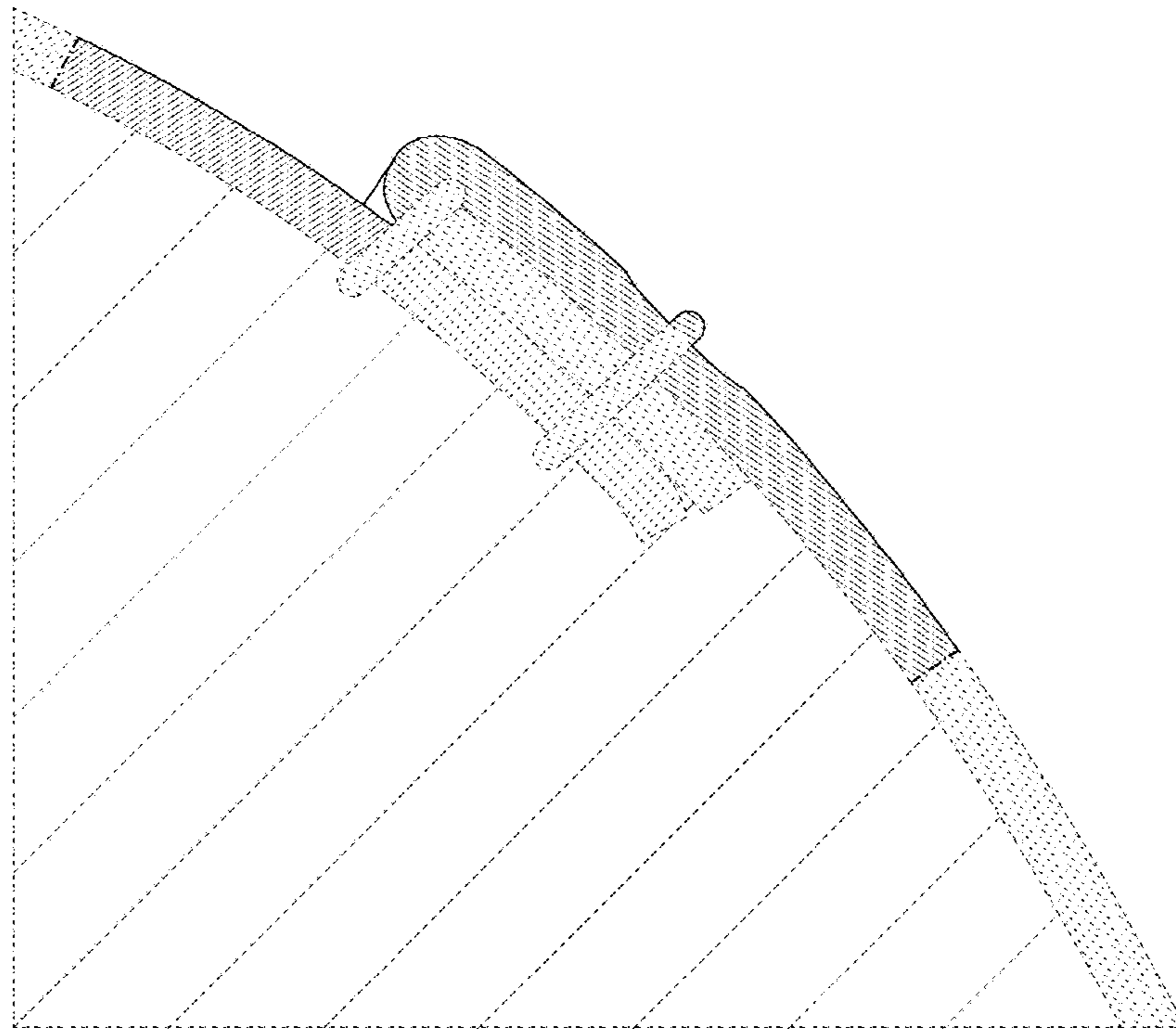

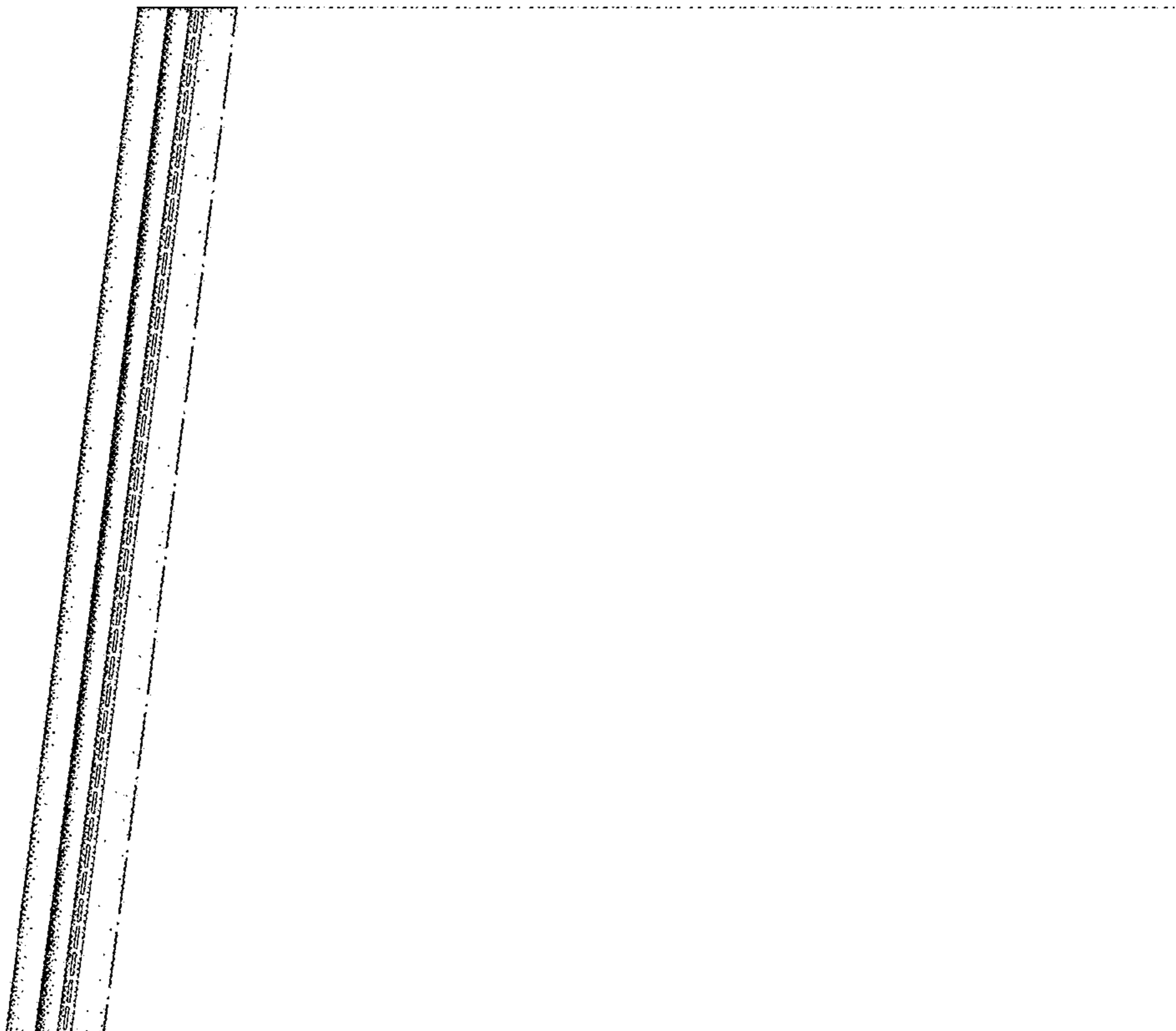
