The ornamental design for a stadium chair, as shown and described.

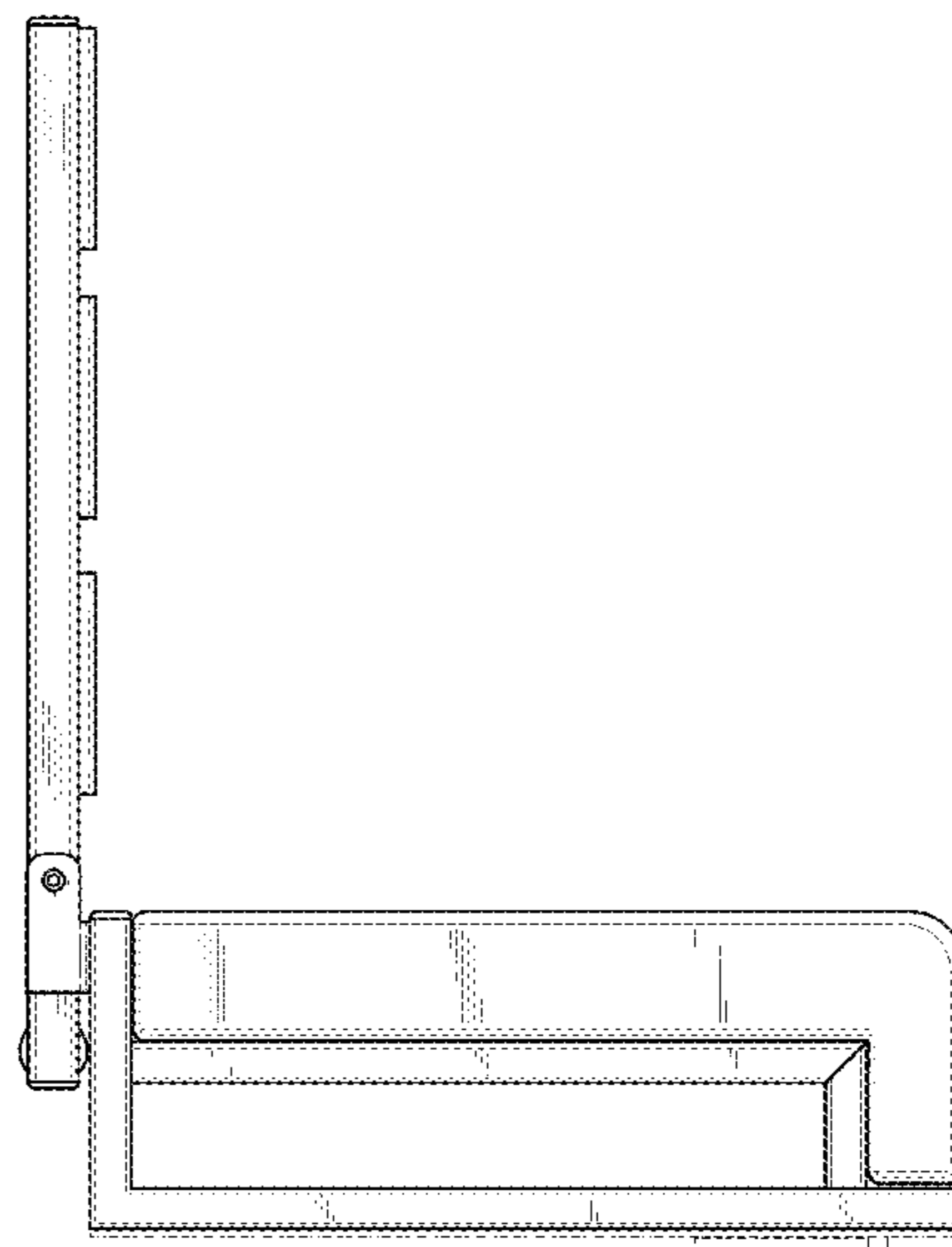
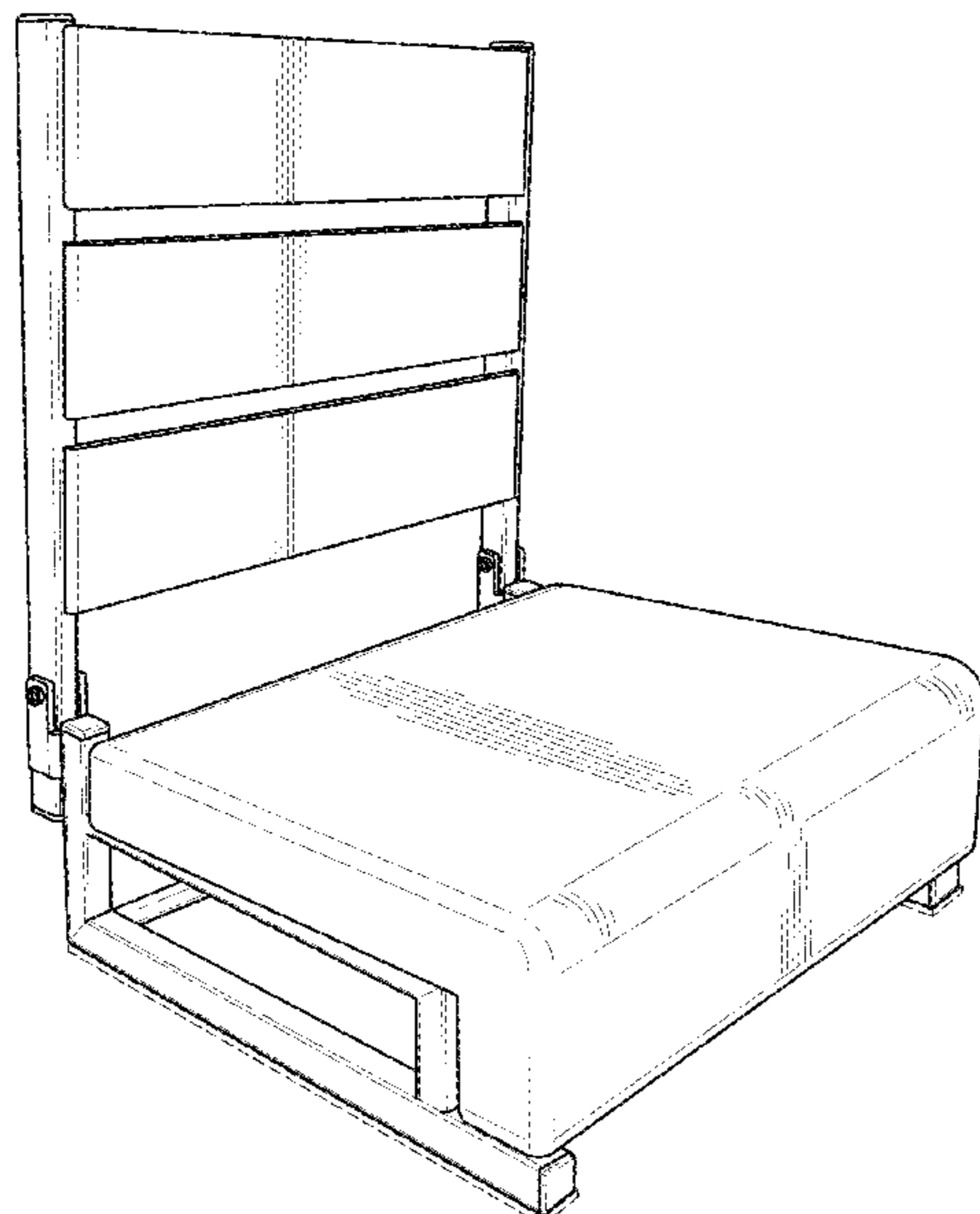
DESCRIPTION

FIG. 1 is a front and left perspective view of a stadium chair, showing my new design;
FIG. 2 is a front view thereof;

FIG. 6 is a top view thereof; and,
FIG. 7 is a bottom view thereof.

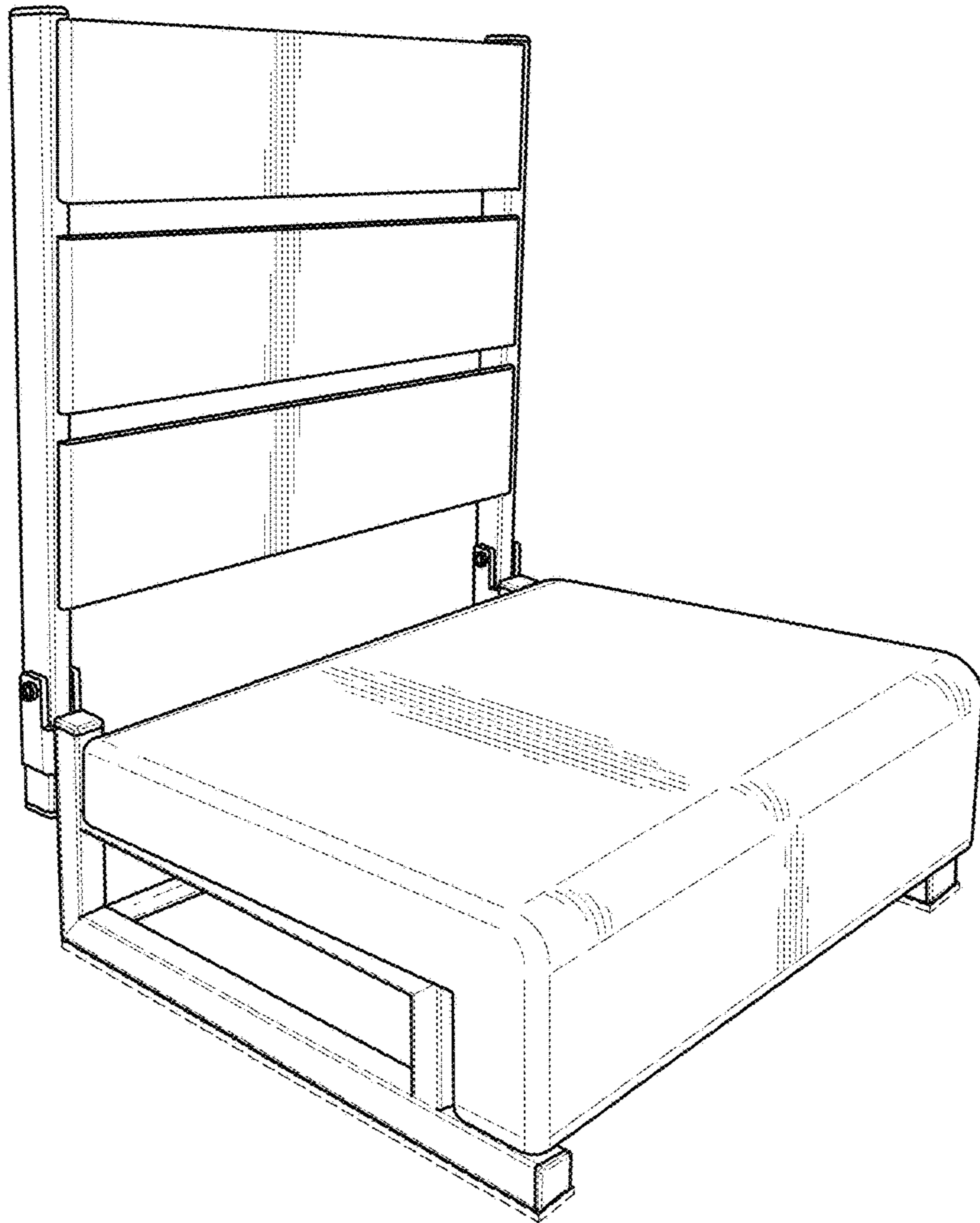

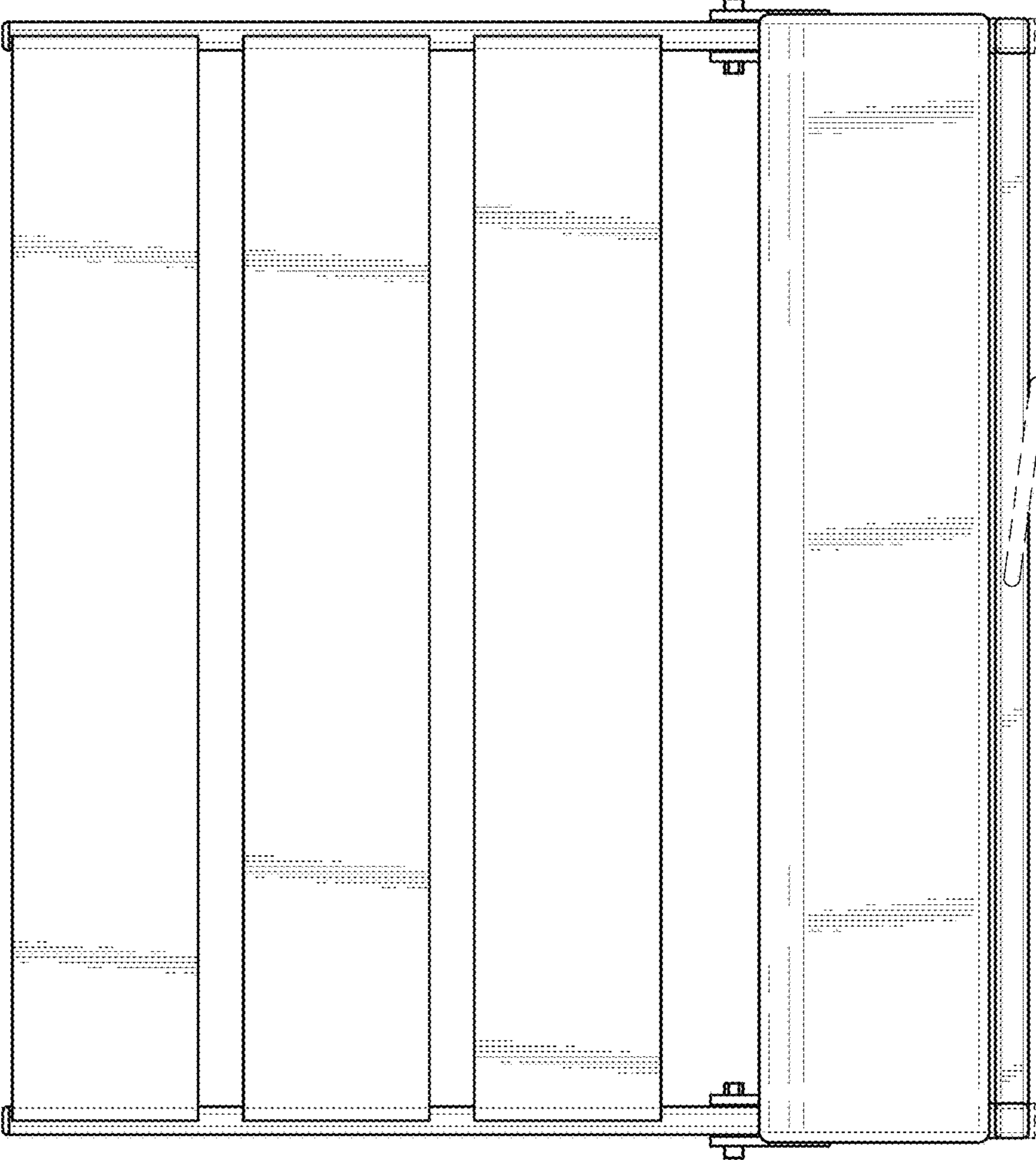

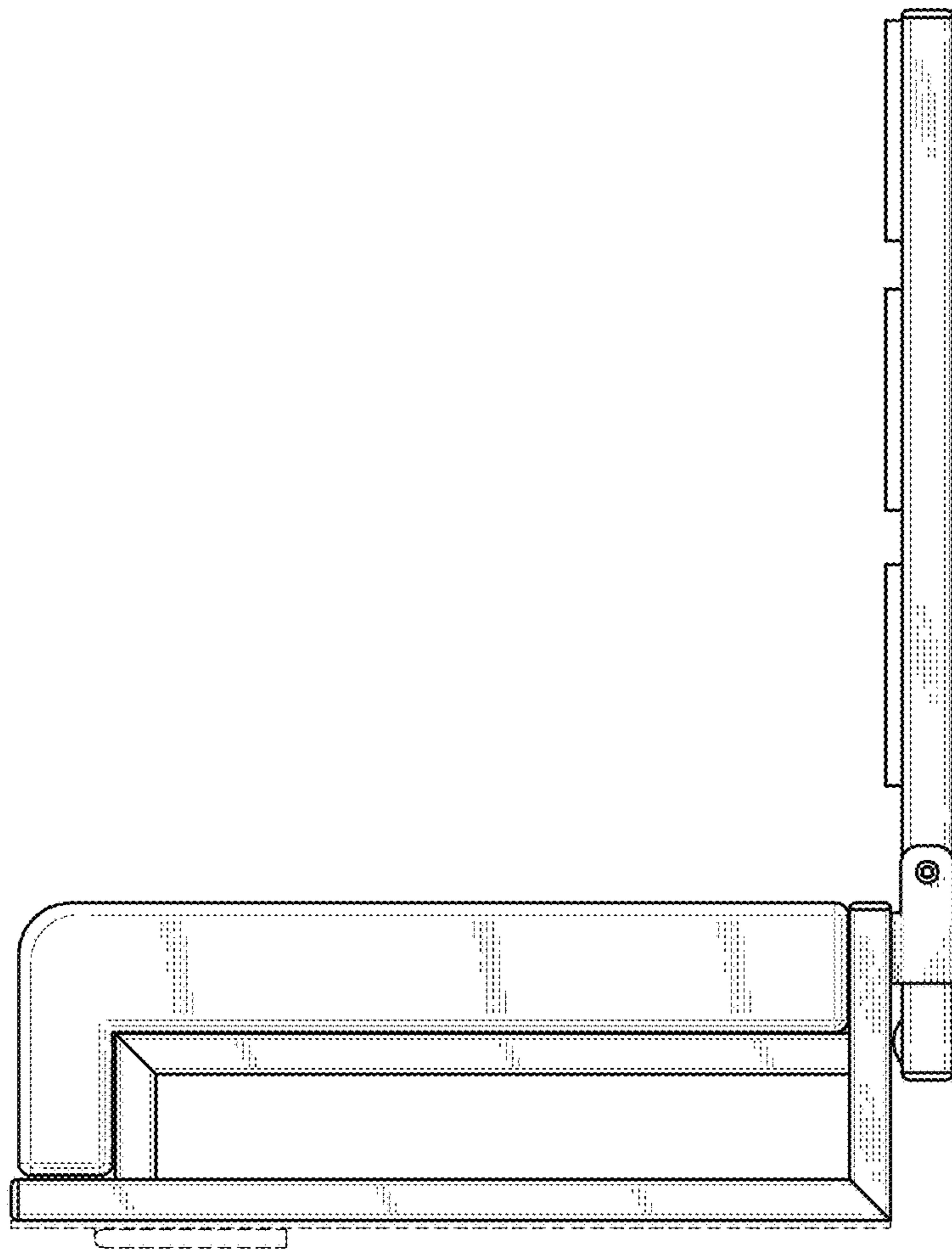

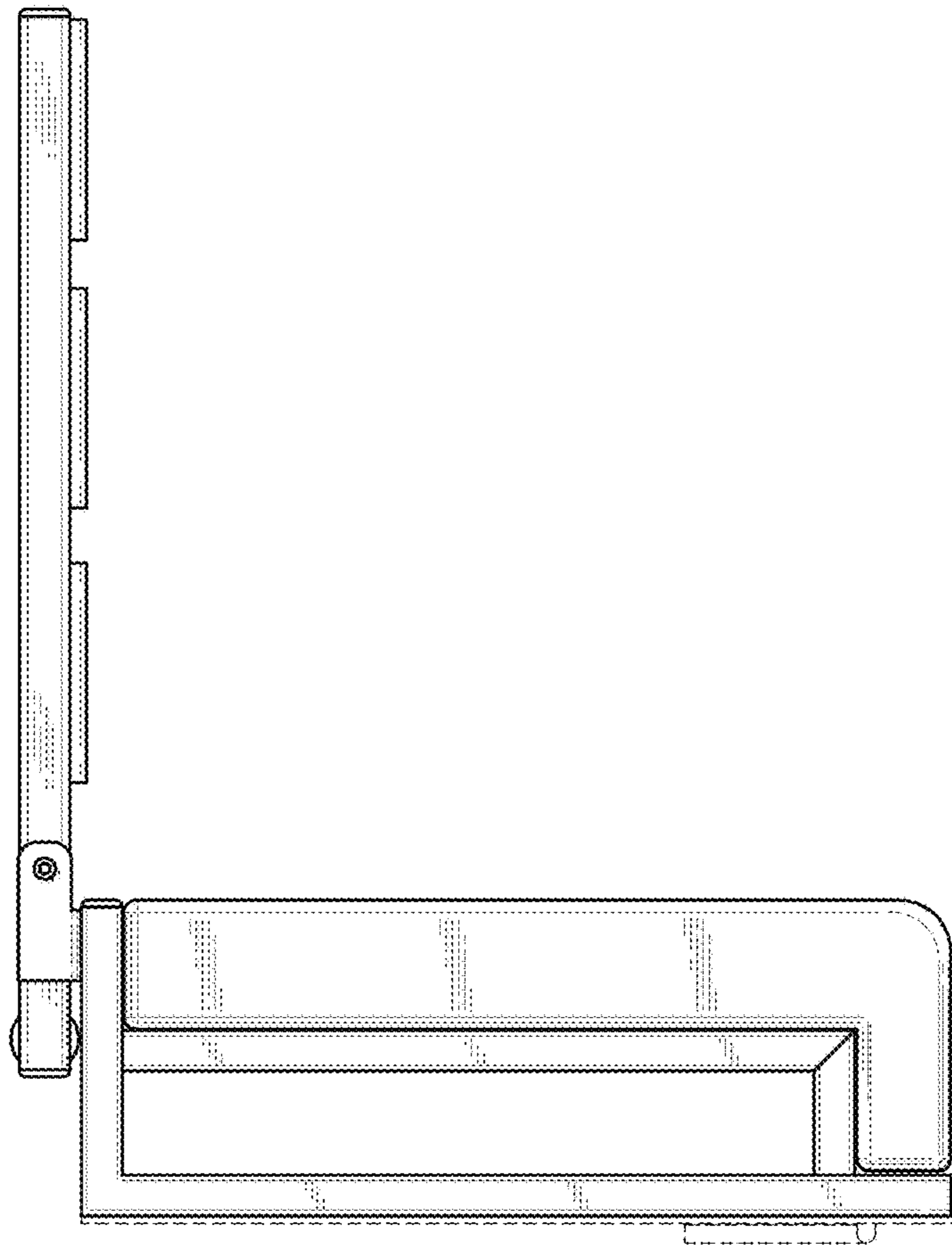

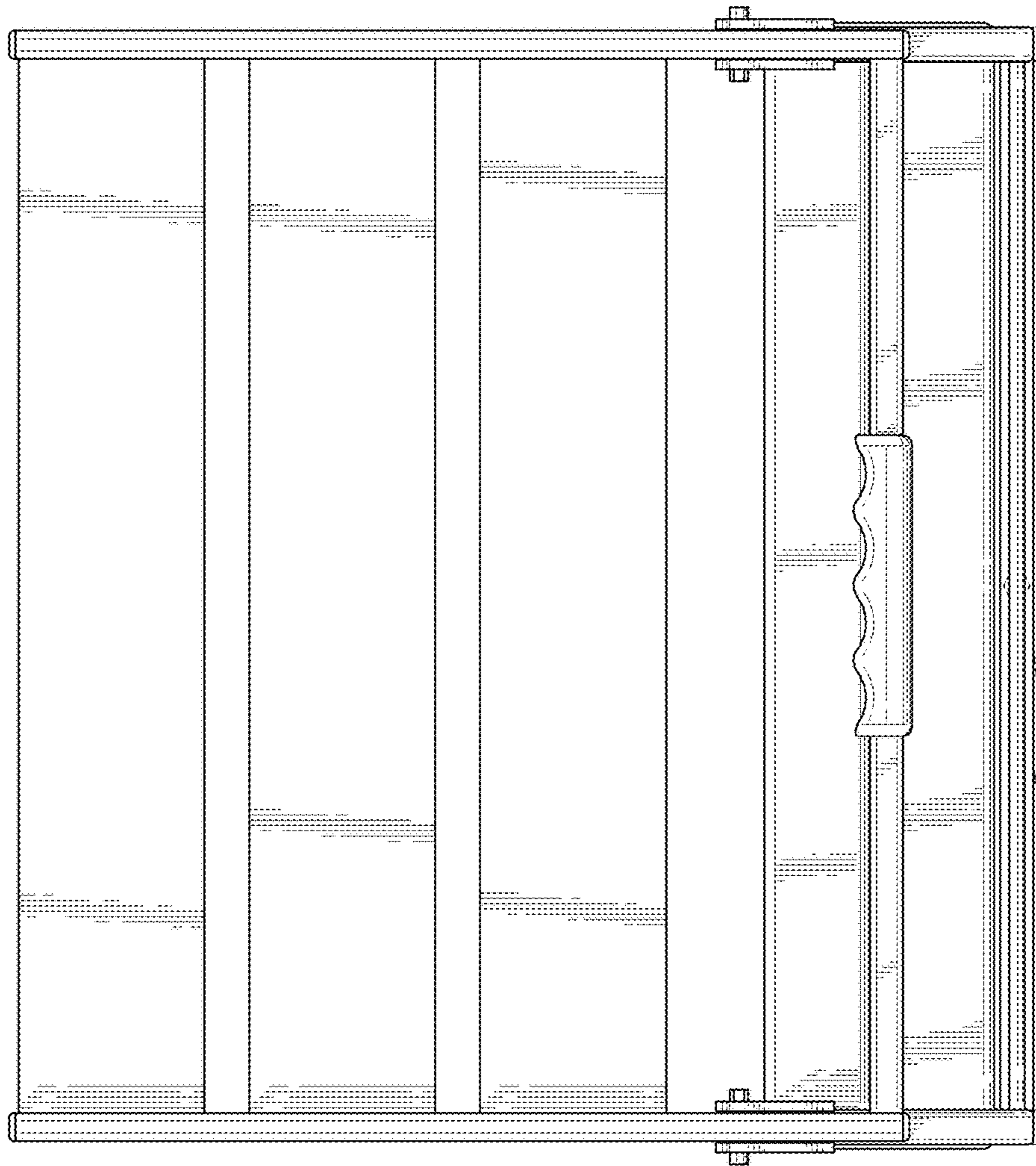

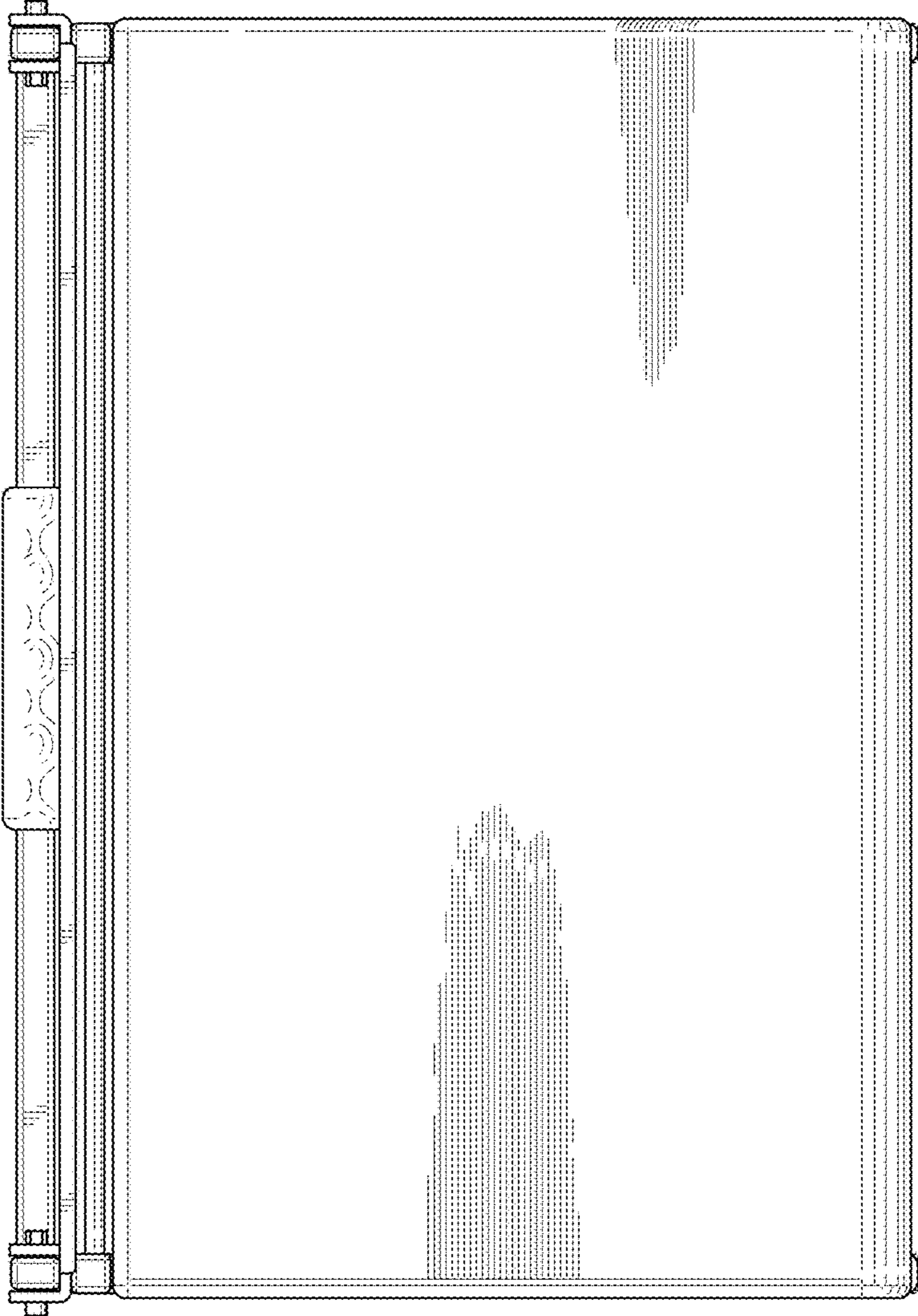

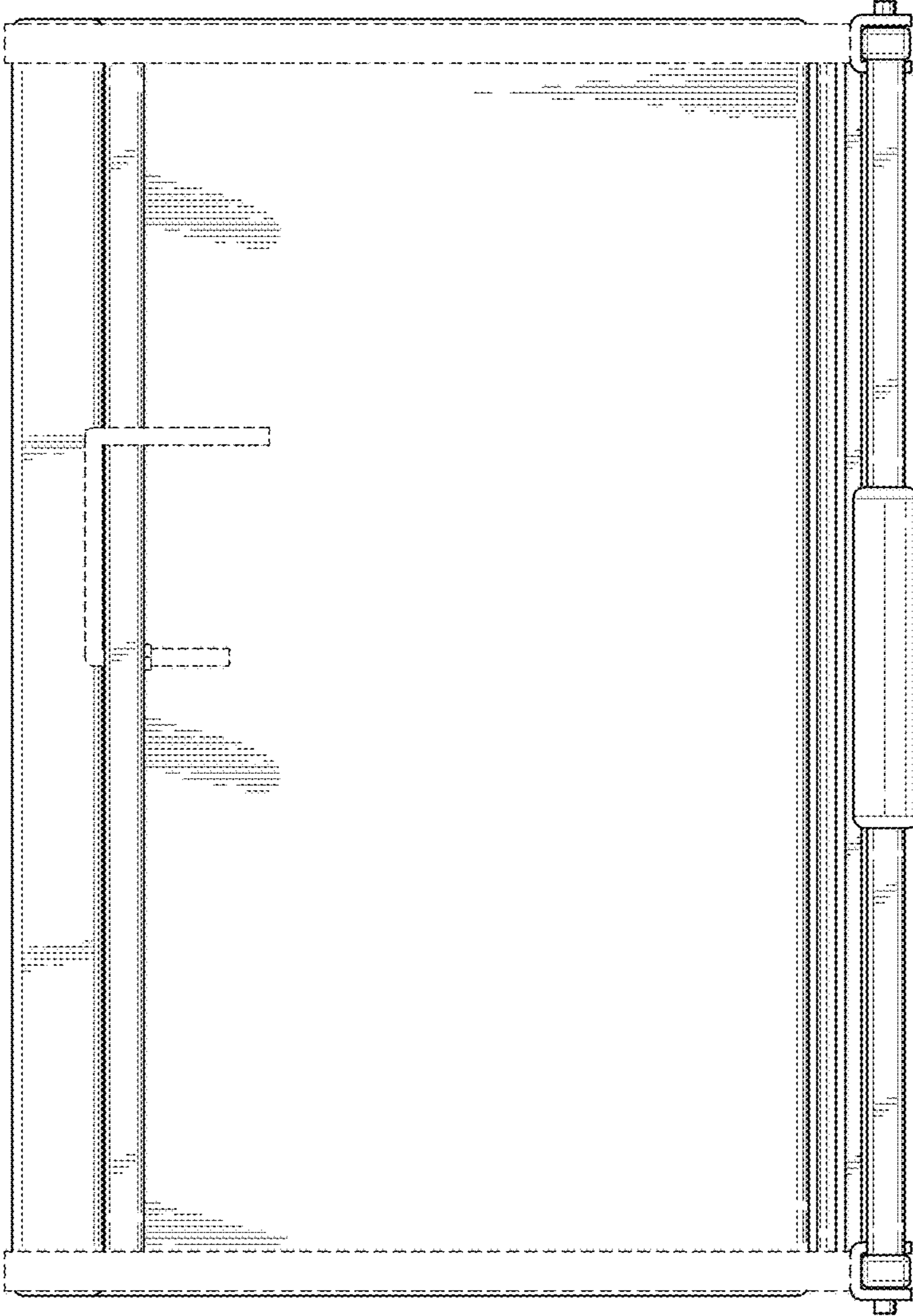
