**DESCRIPTION**

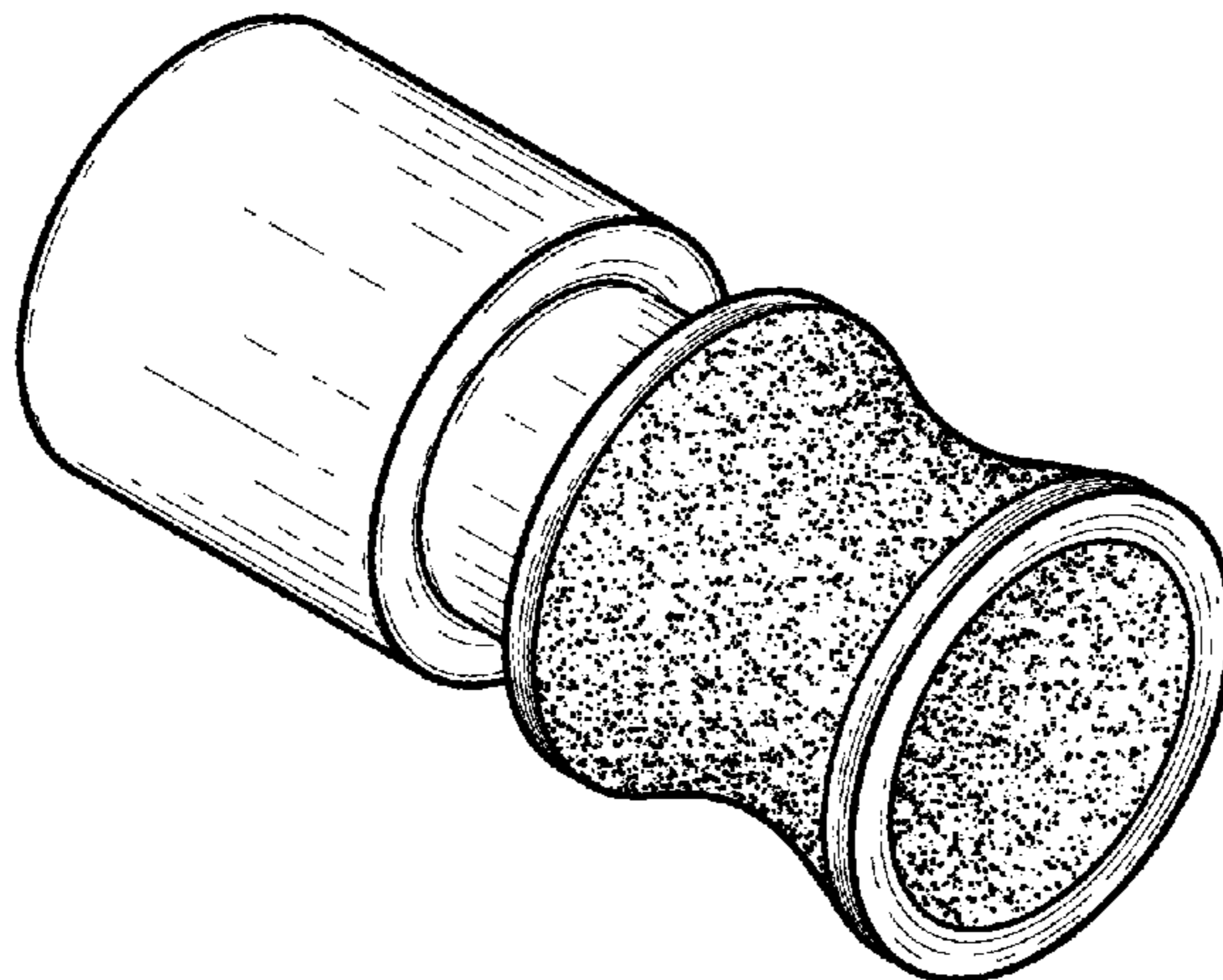
FIG. 1 is a top and side perspective view of a grinding bit for rotary tool showing my new design;

The features shown in broken lines in the drawing figures depict features that form no part of the claimed design.

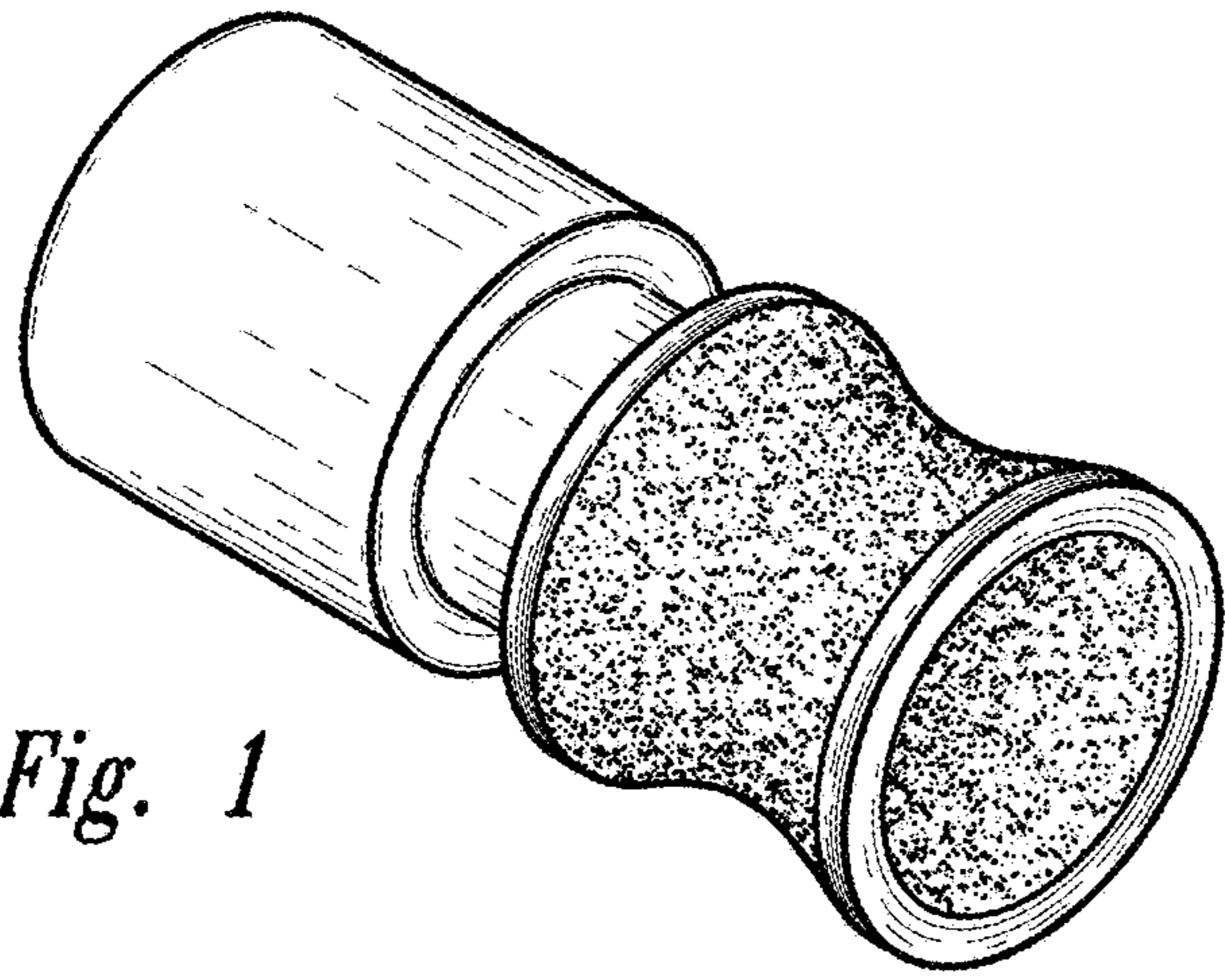

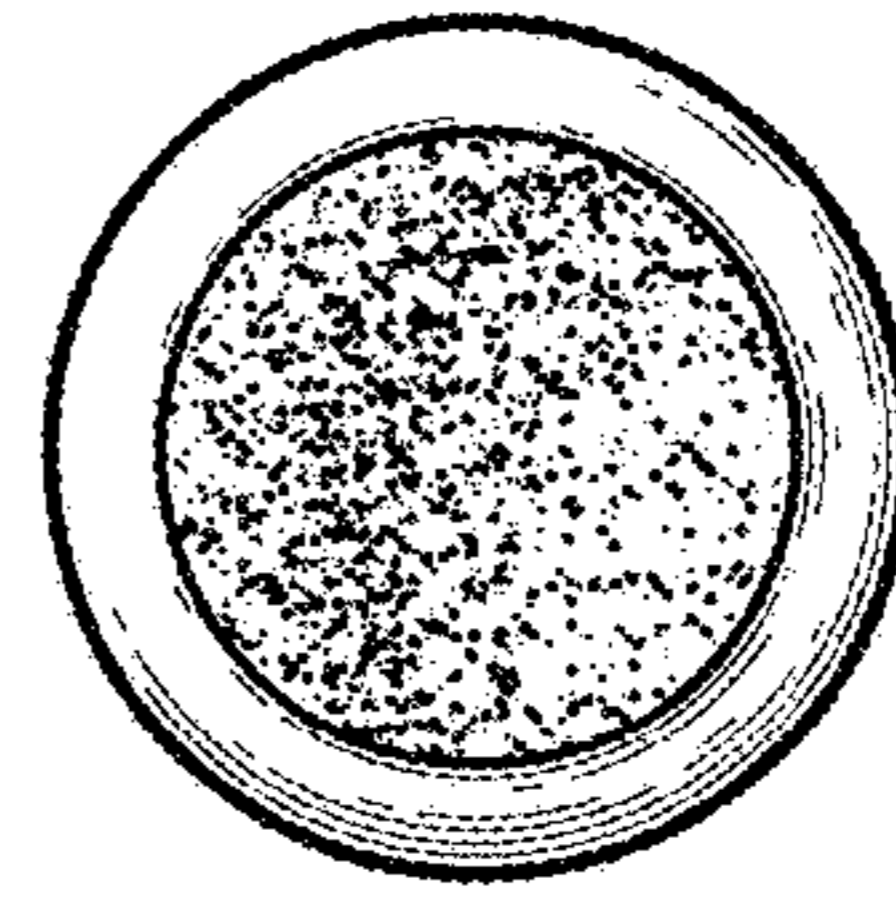

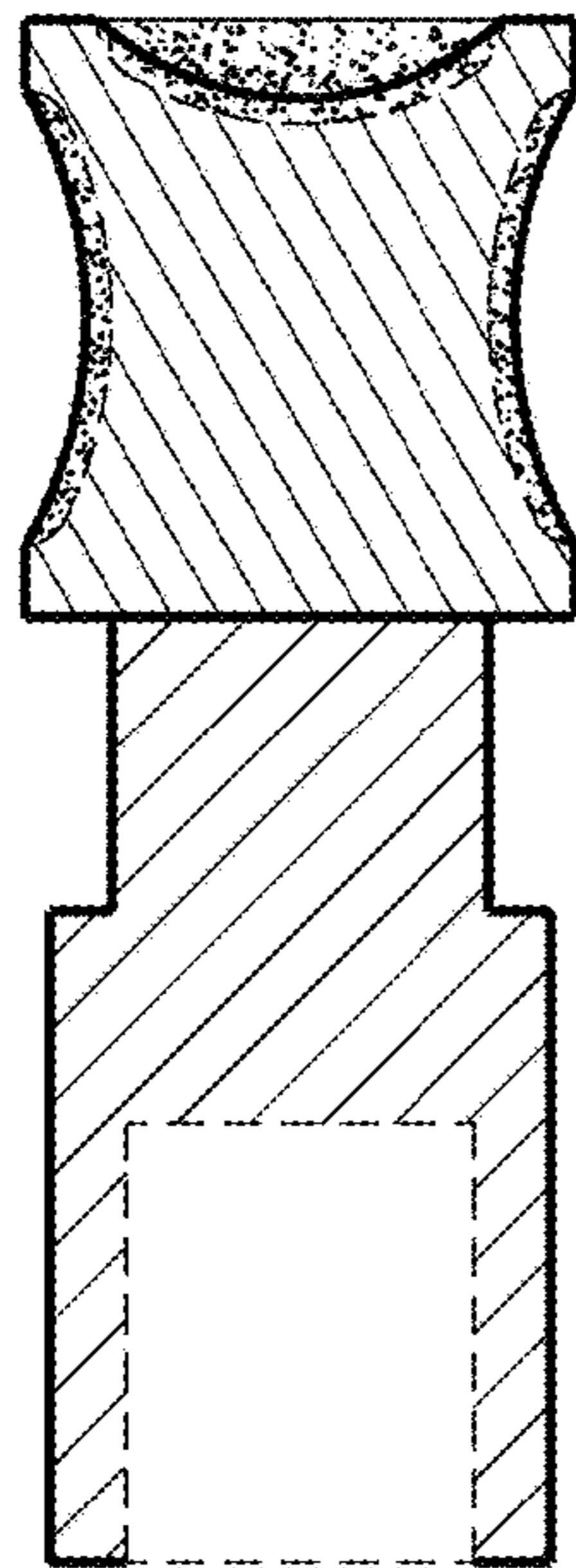




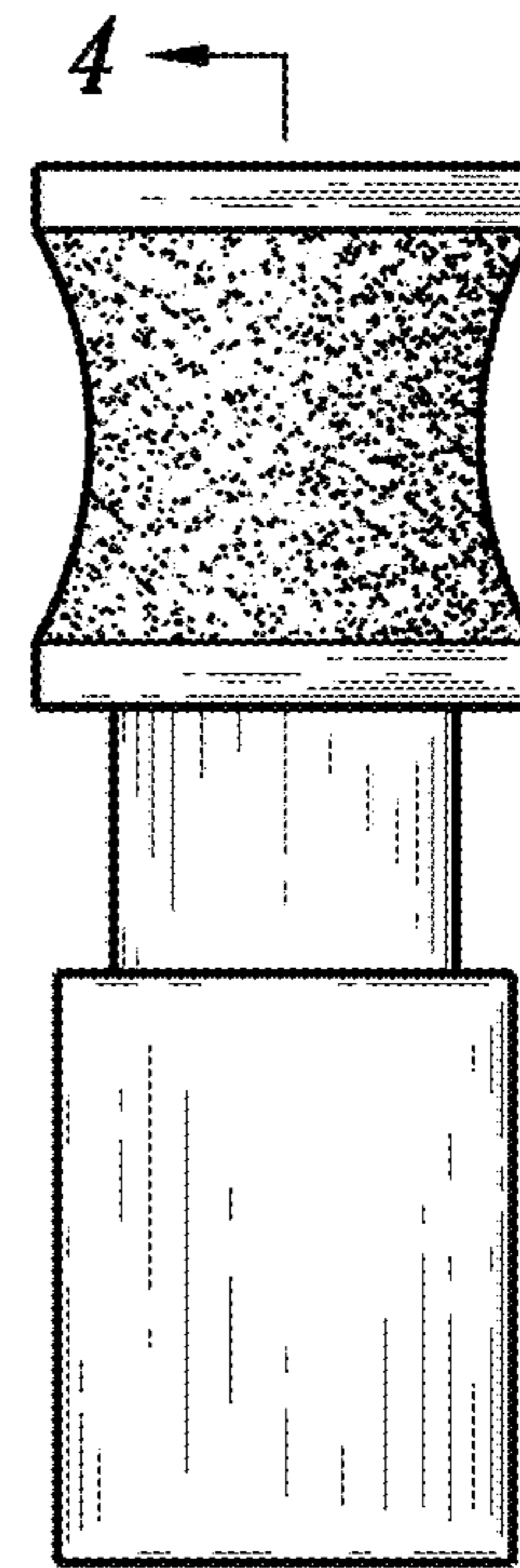

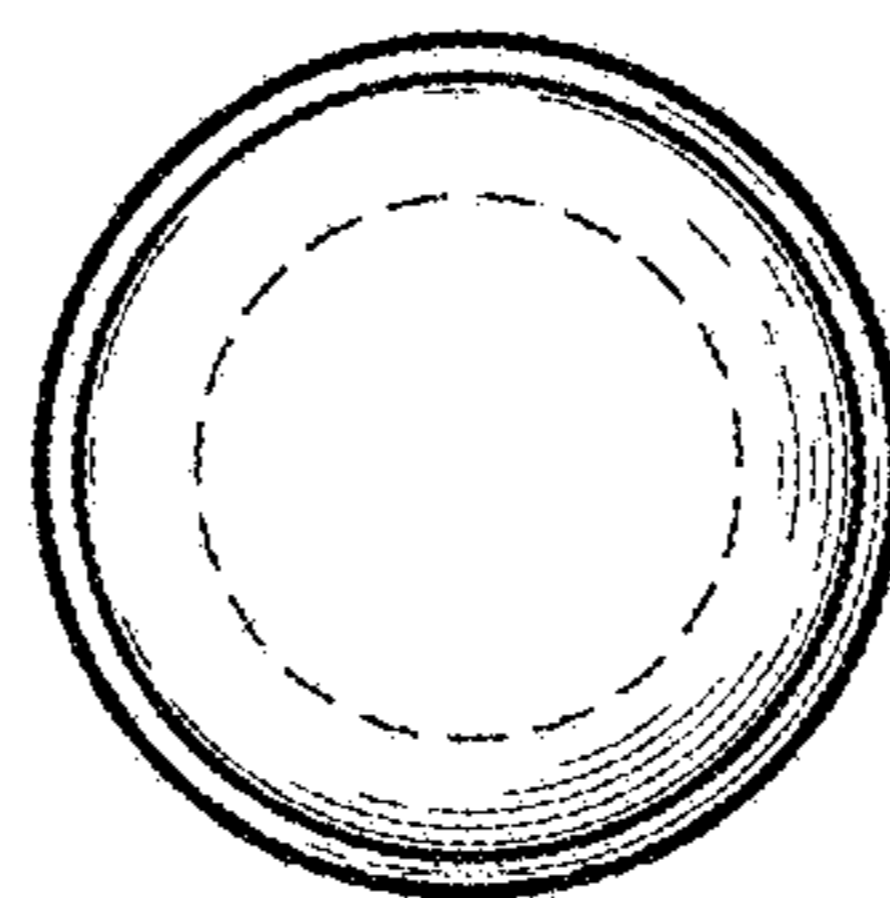
