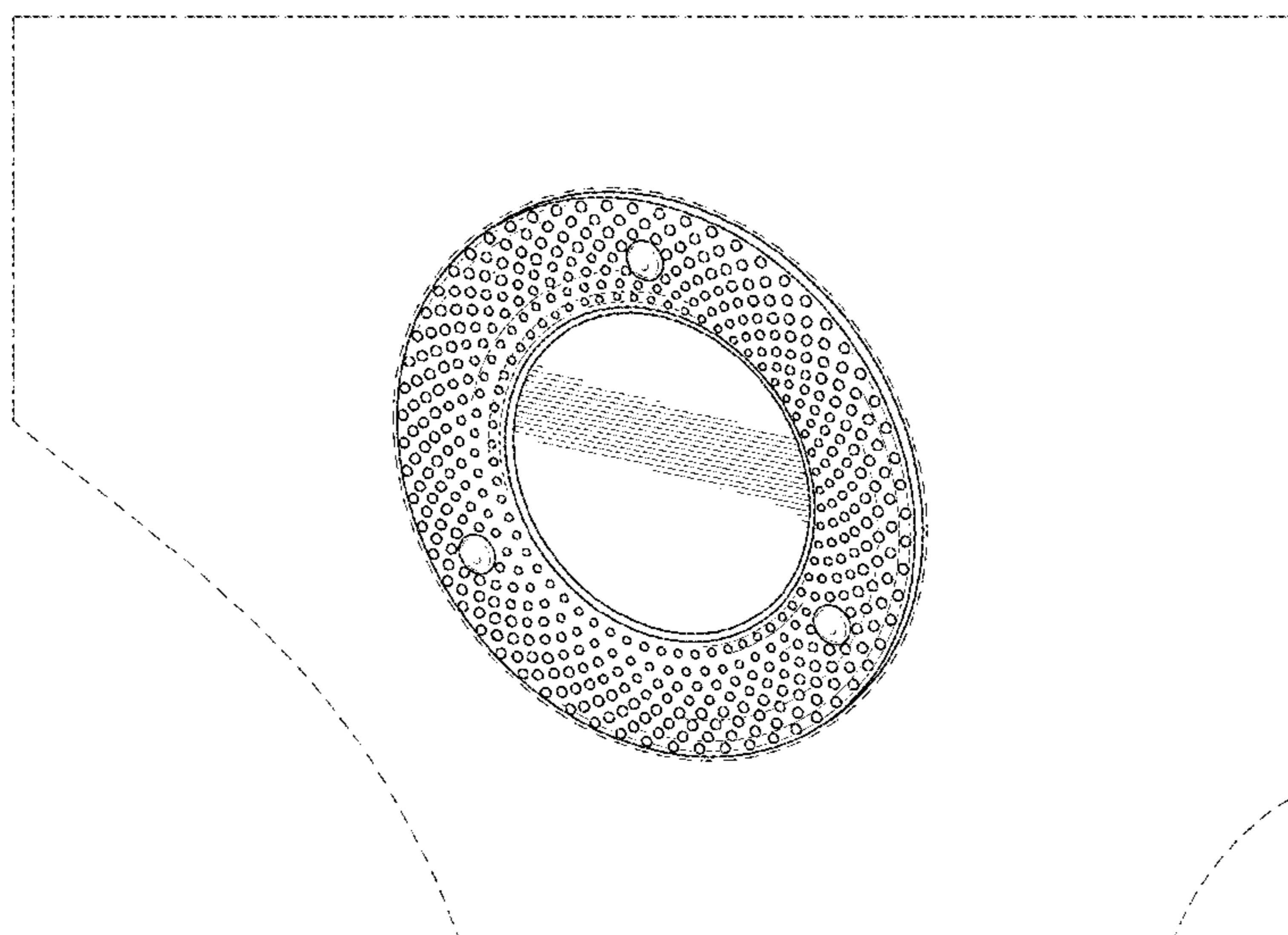
FIG. 3 is a front view of the smart active—smart active adjustment knob of FIG. 1.

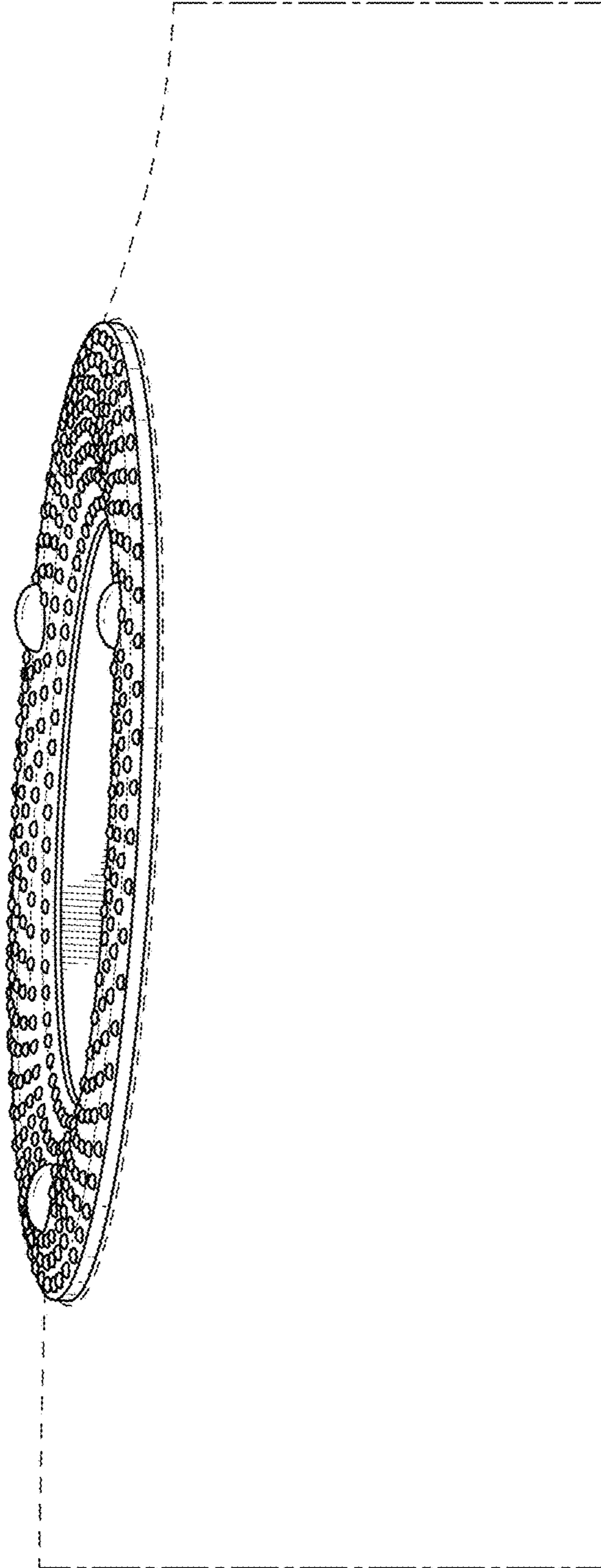

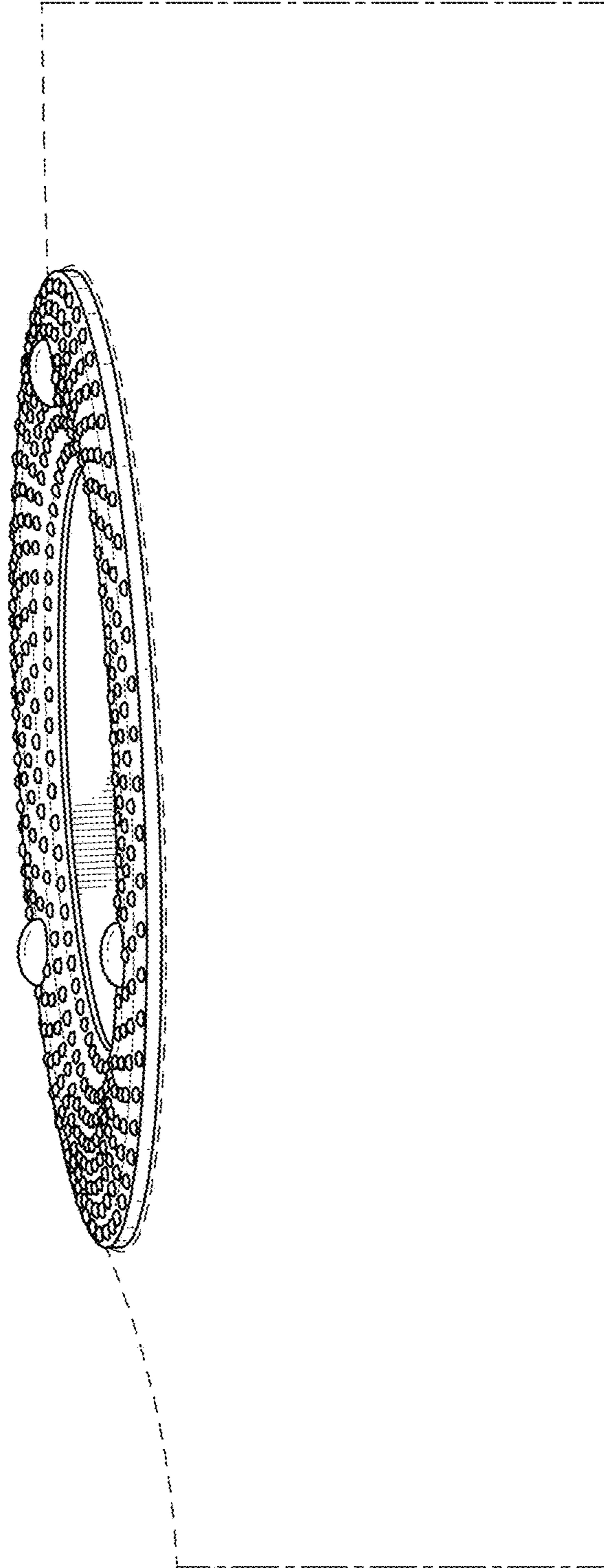

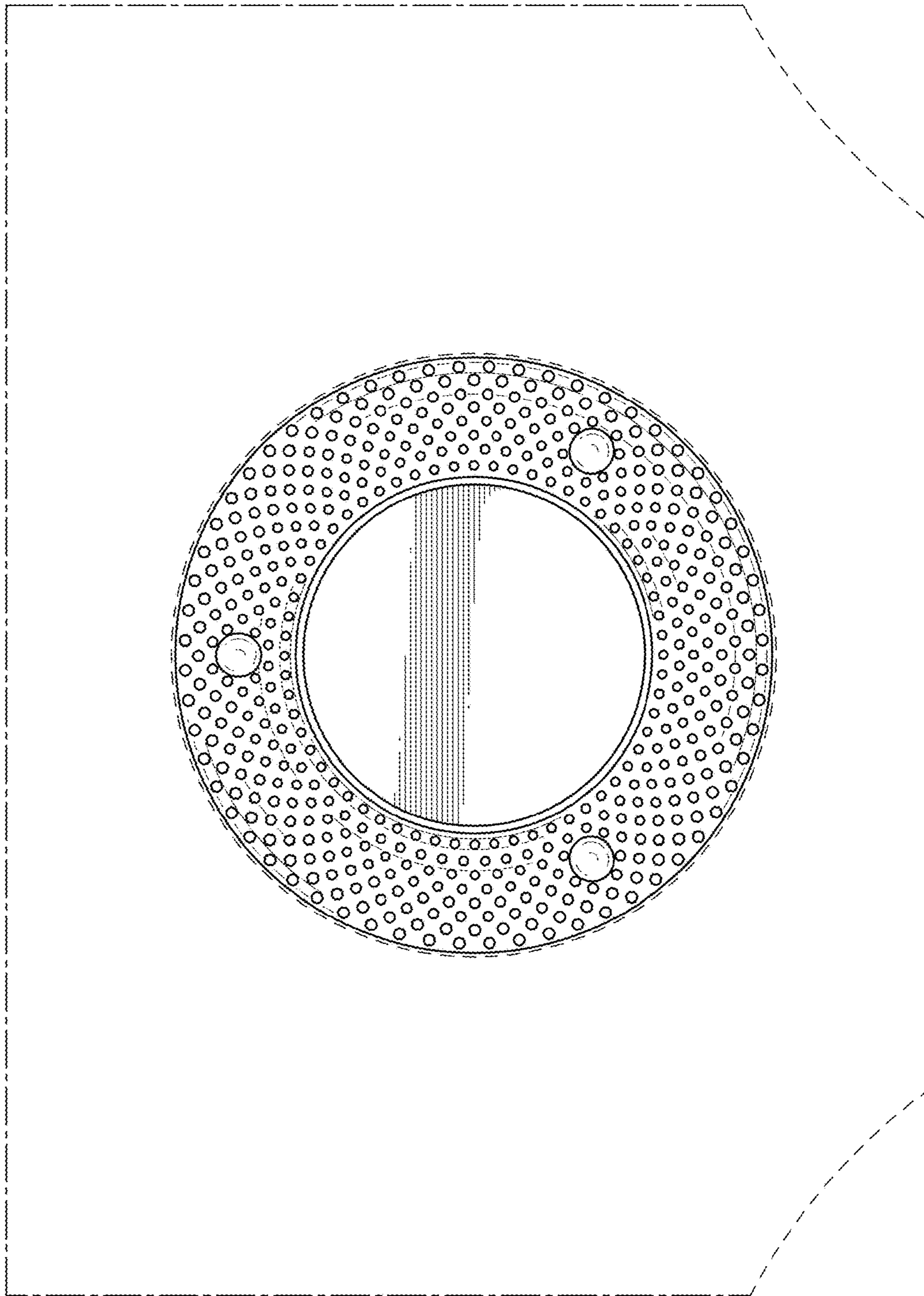

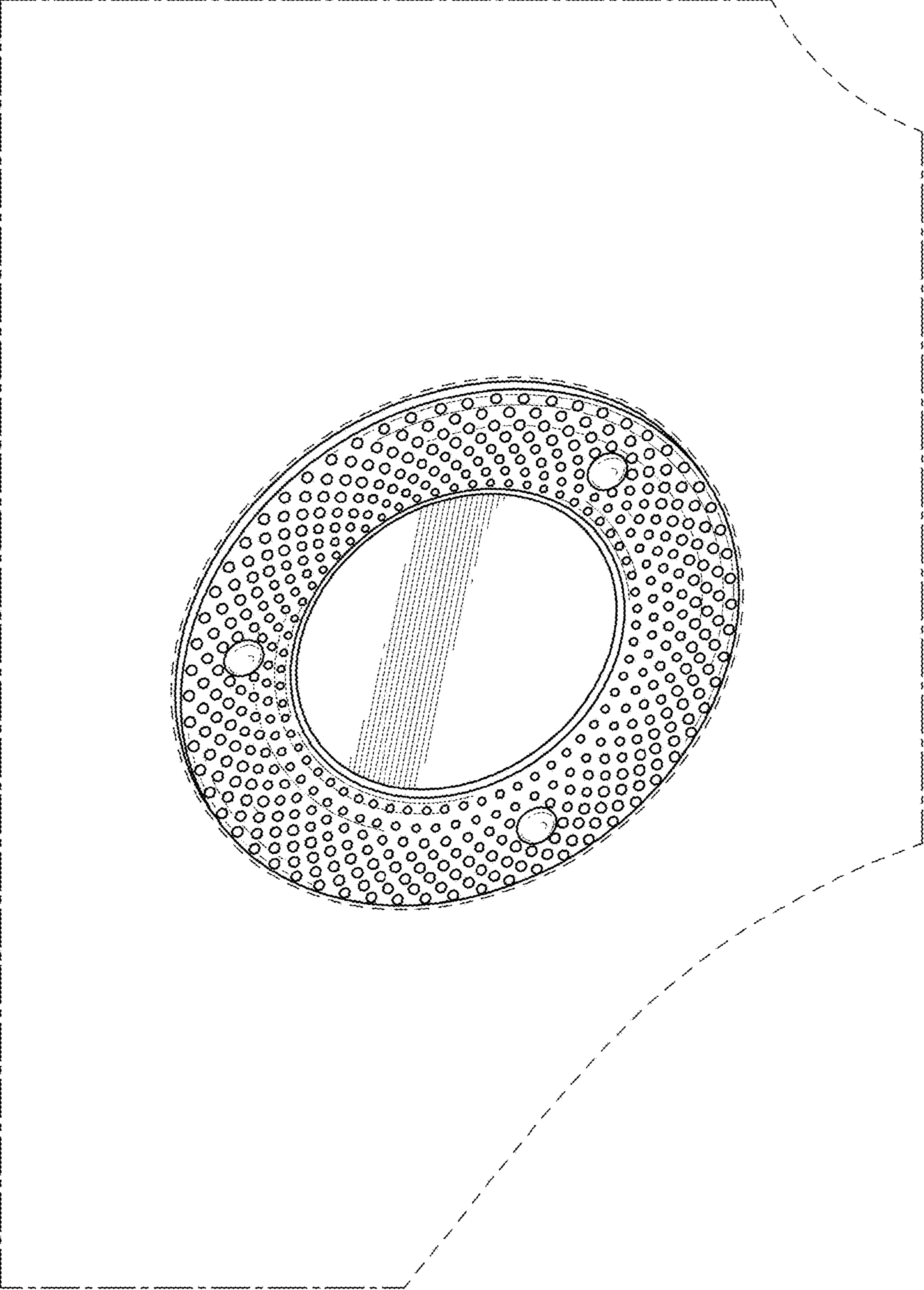

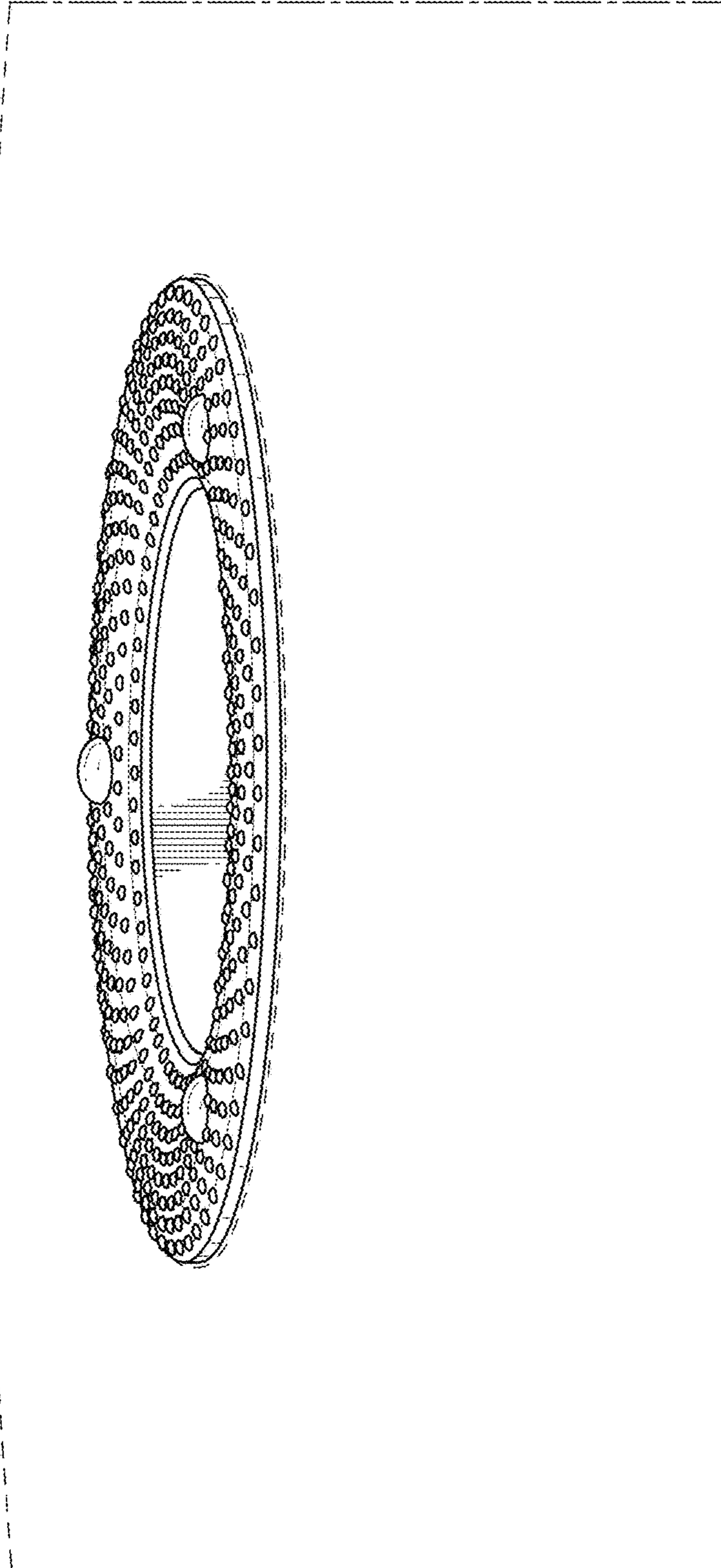
