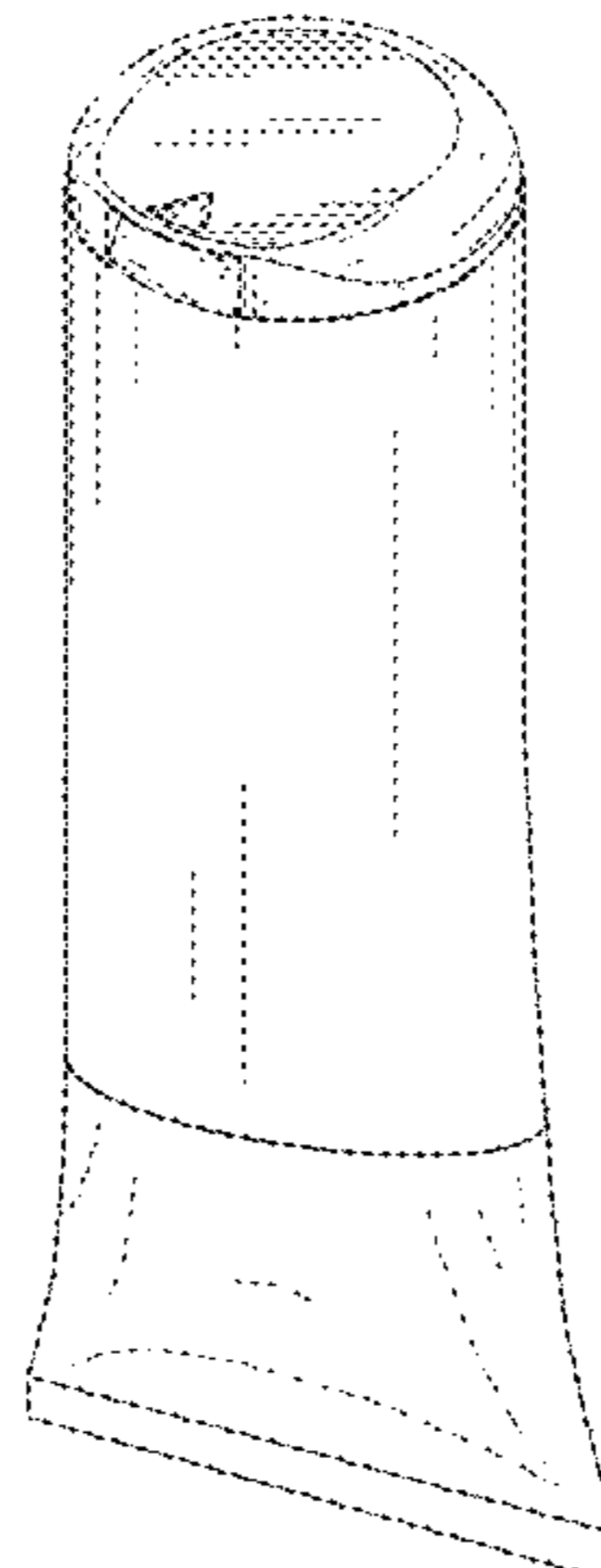
The ornamental design for tube for cosmetics or soaps, as shown and described.

DESCRIPTION

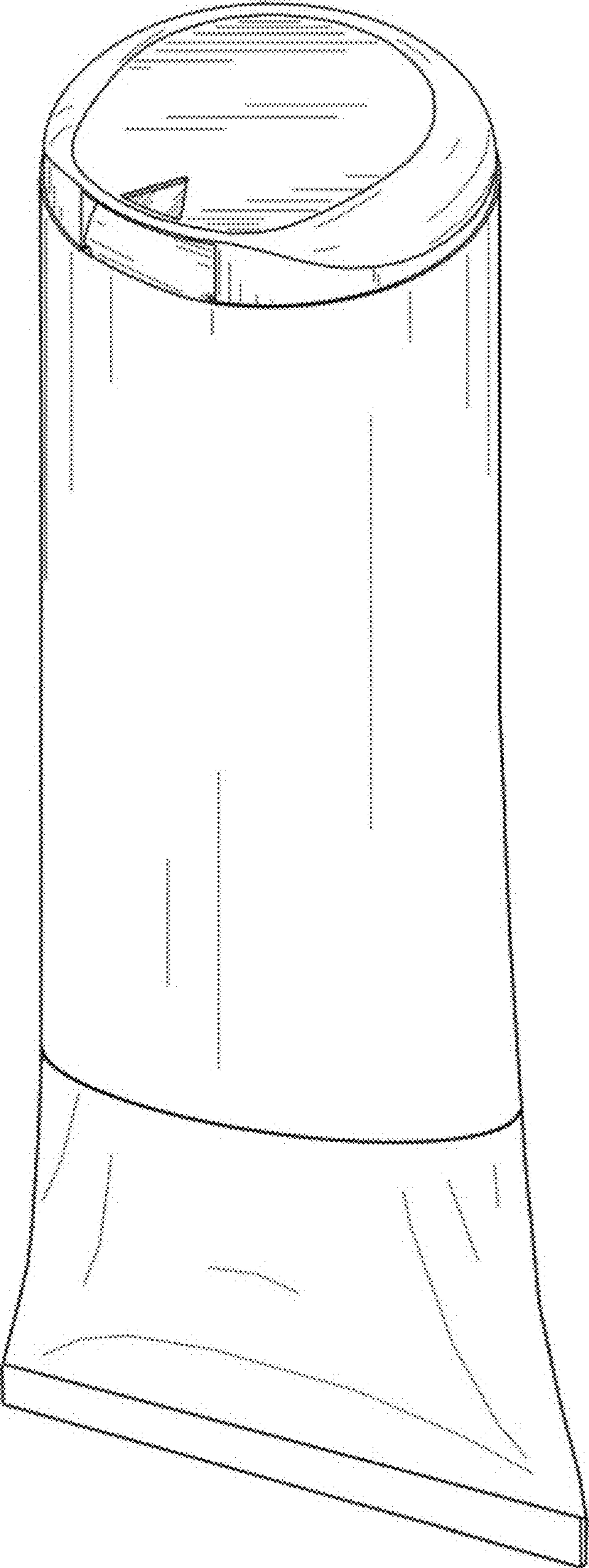
1. Tube for cosmetics or soaps

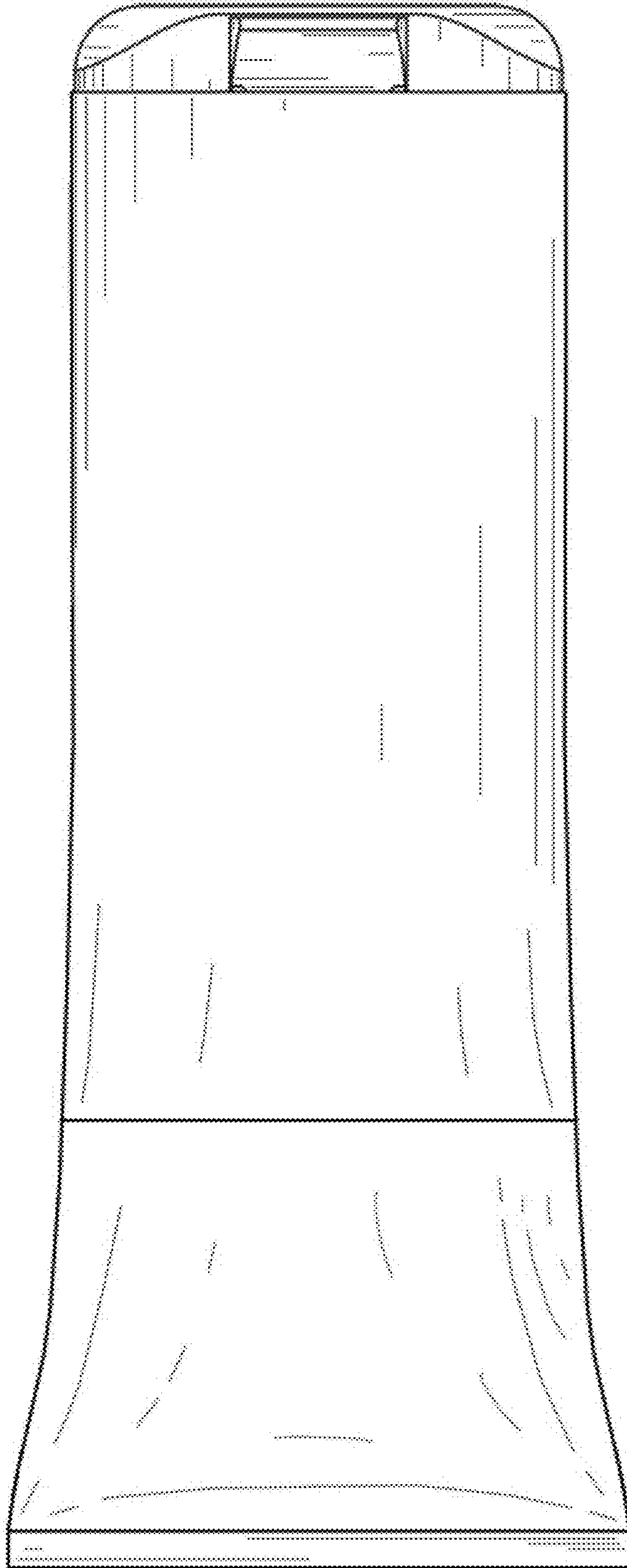

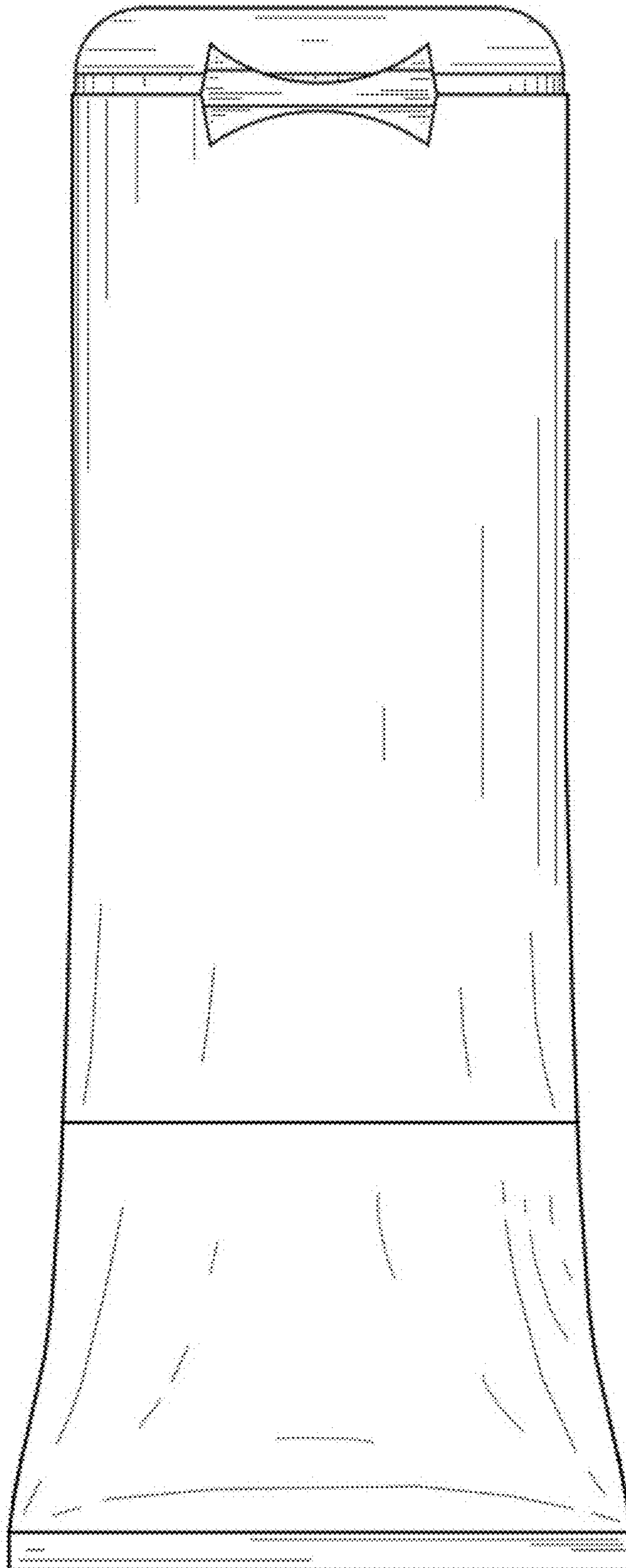

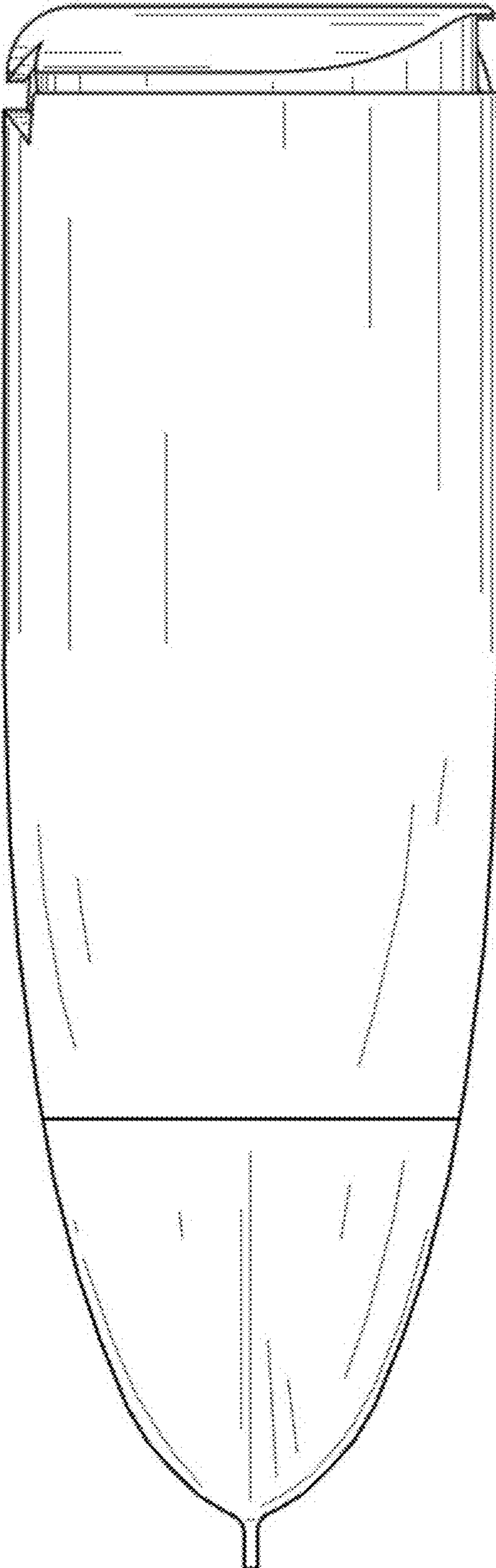
