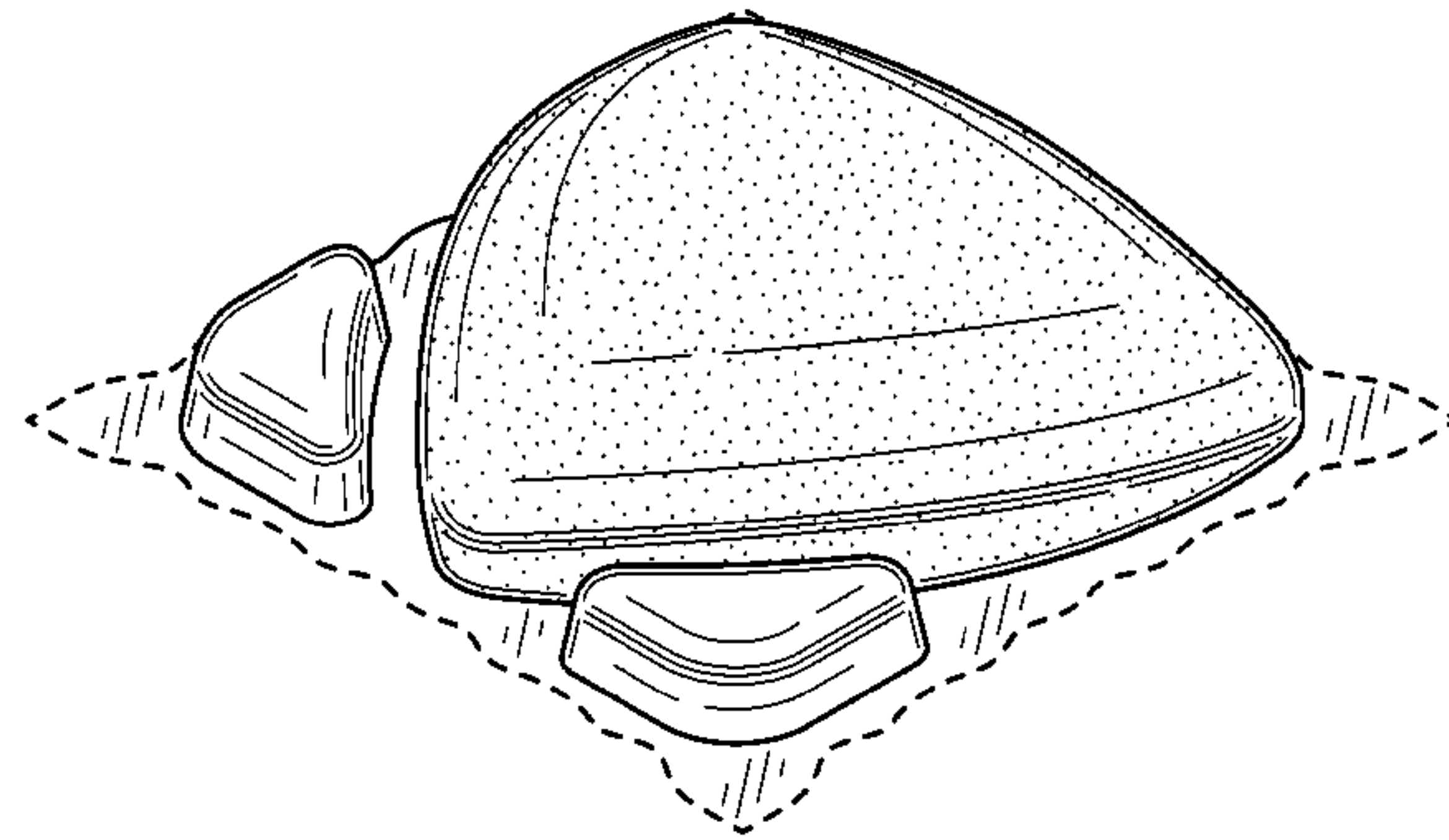
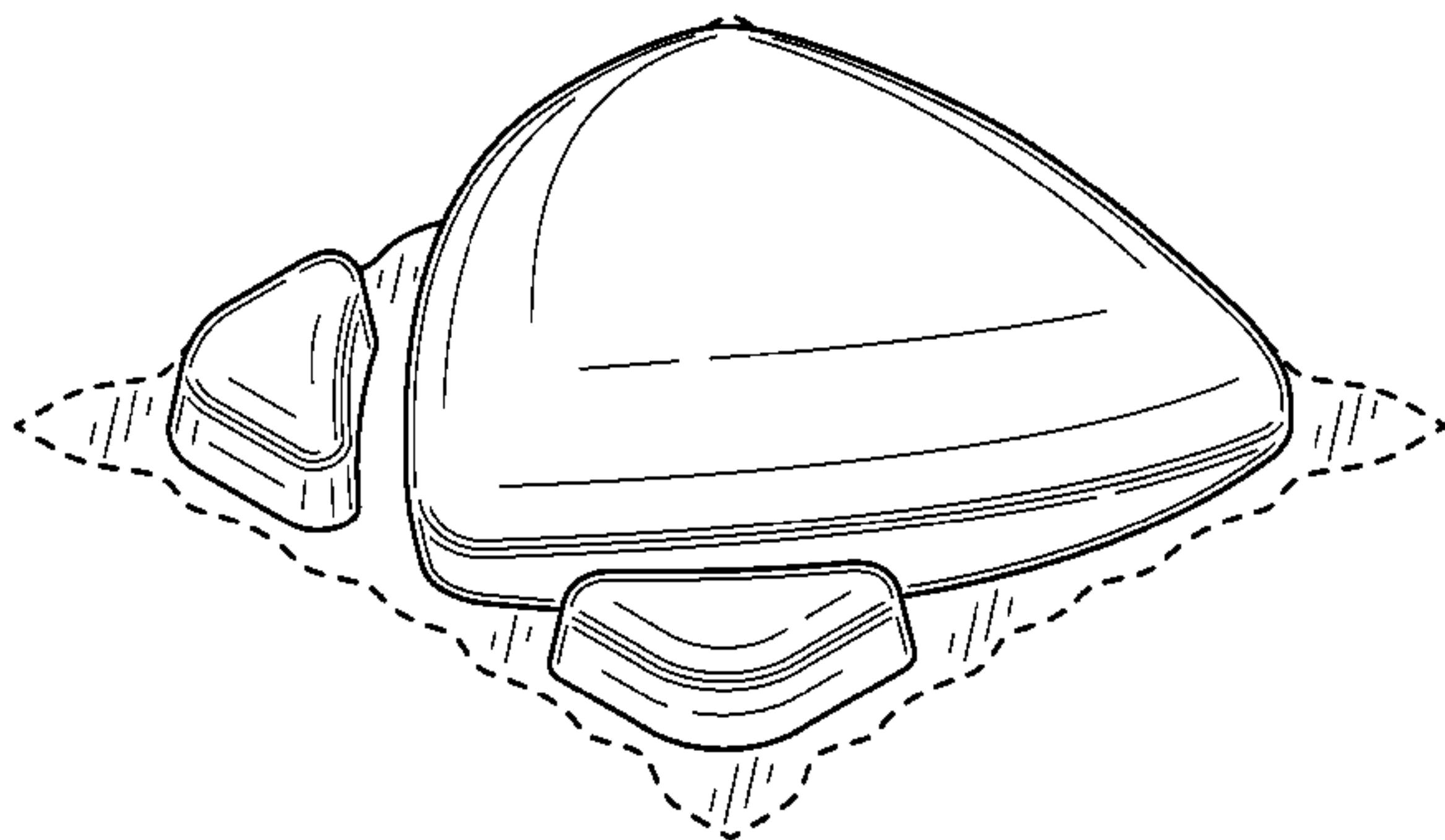
The ornamental design for a pouch and cleaning composition, as shown and described.

**DESCRIPTION**

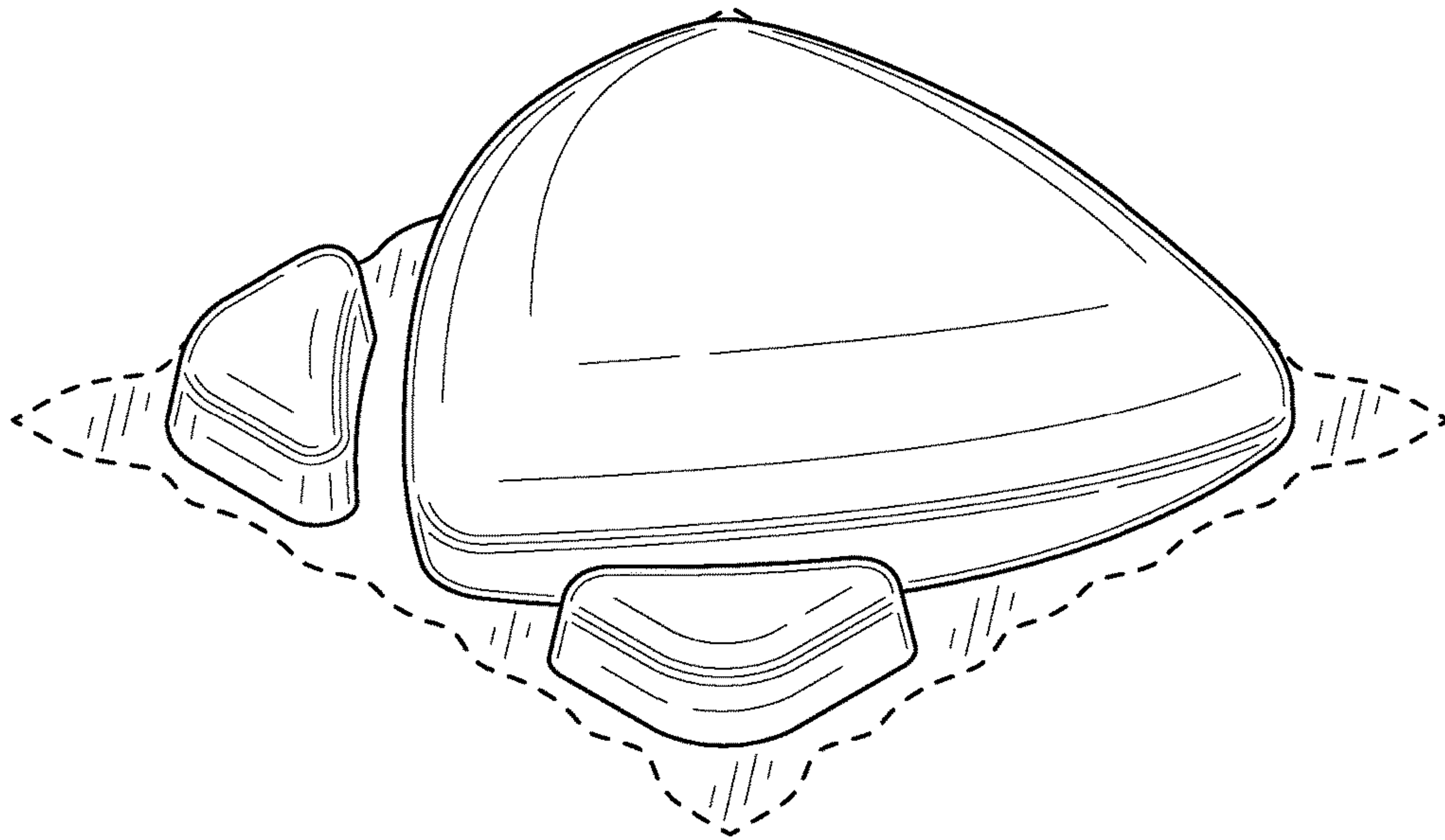

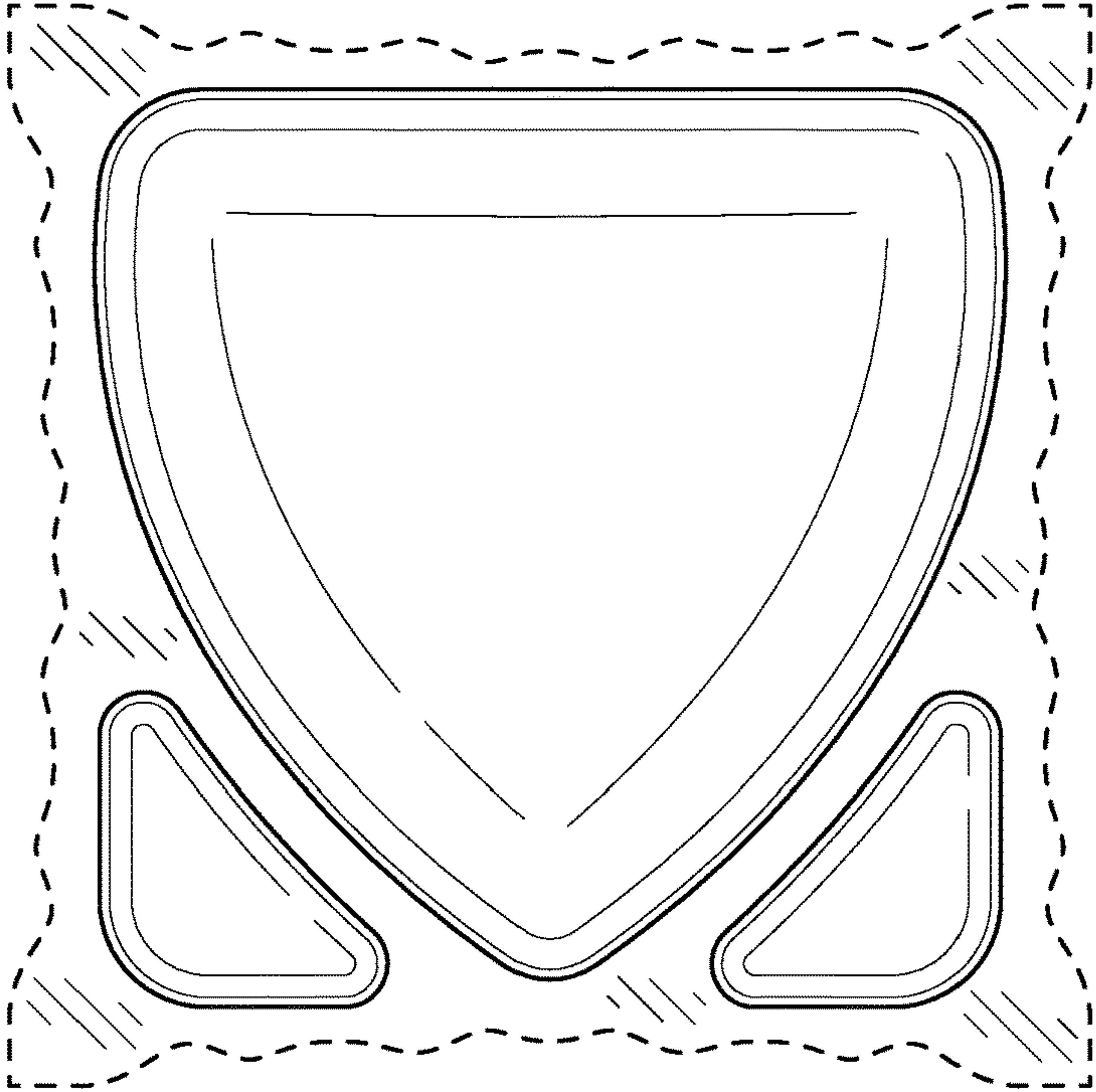

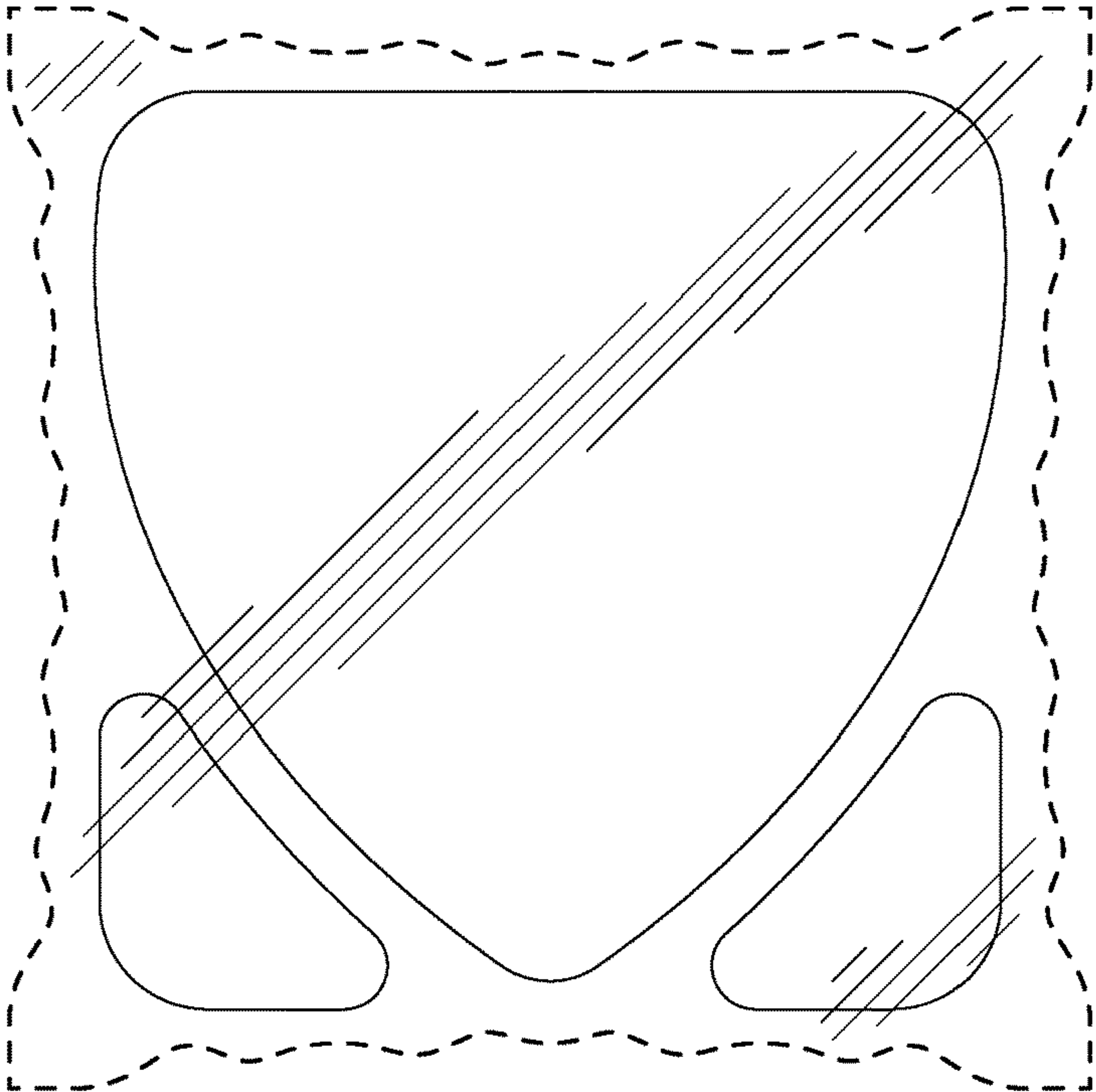

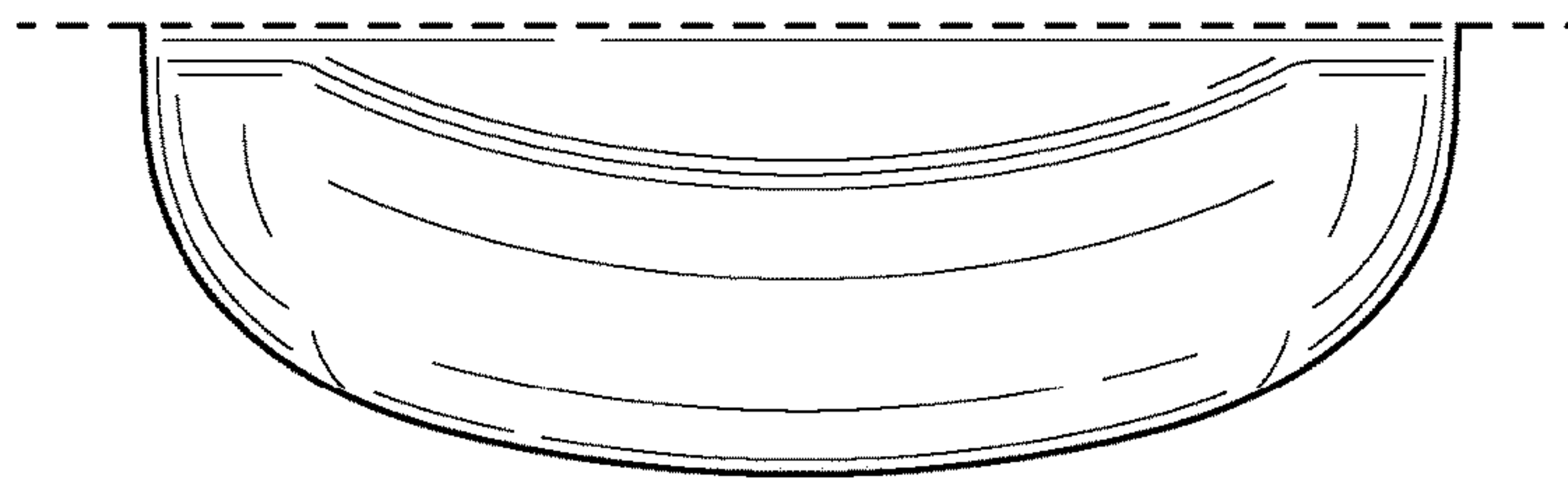

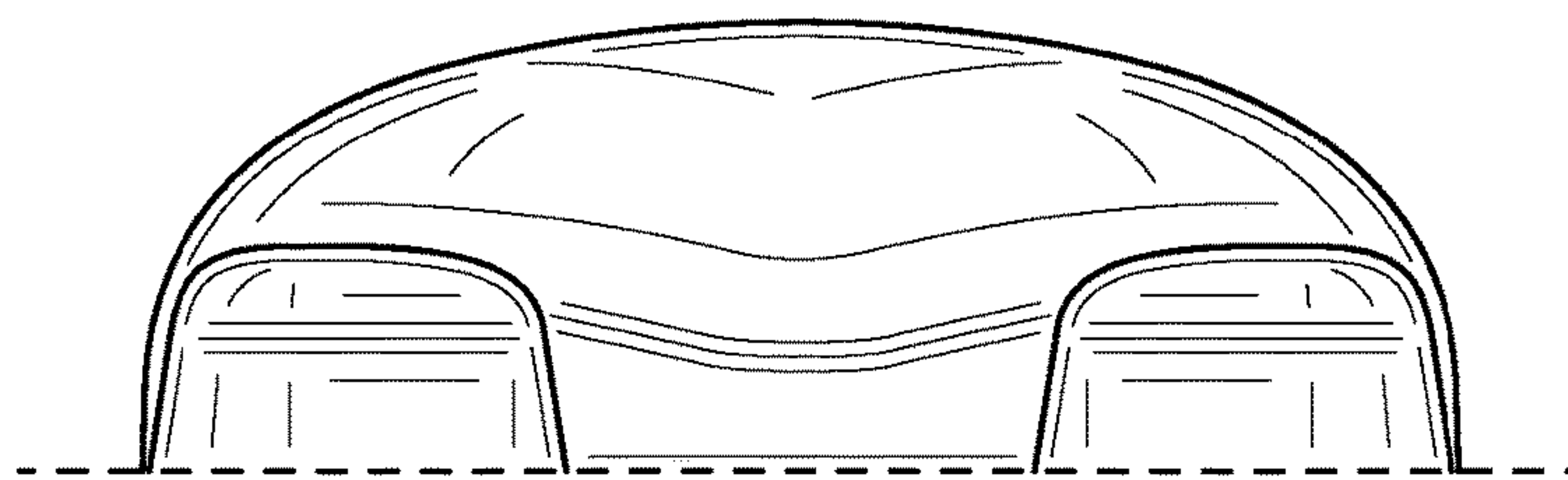

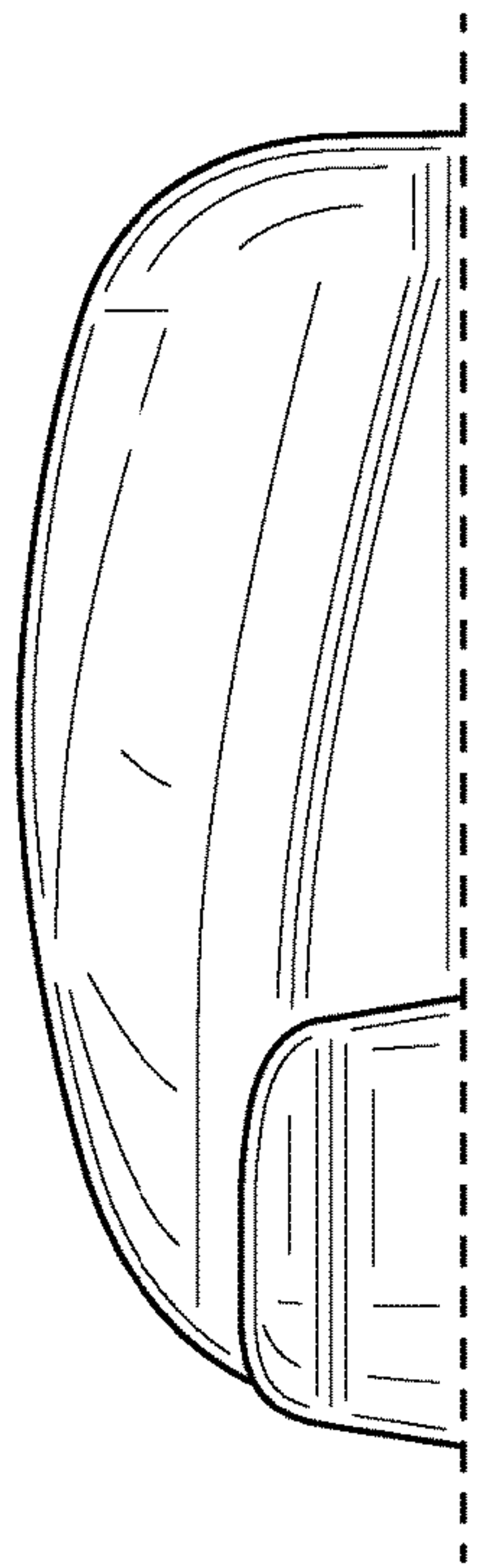

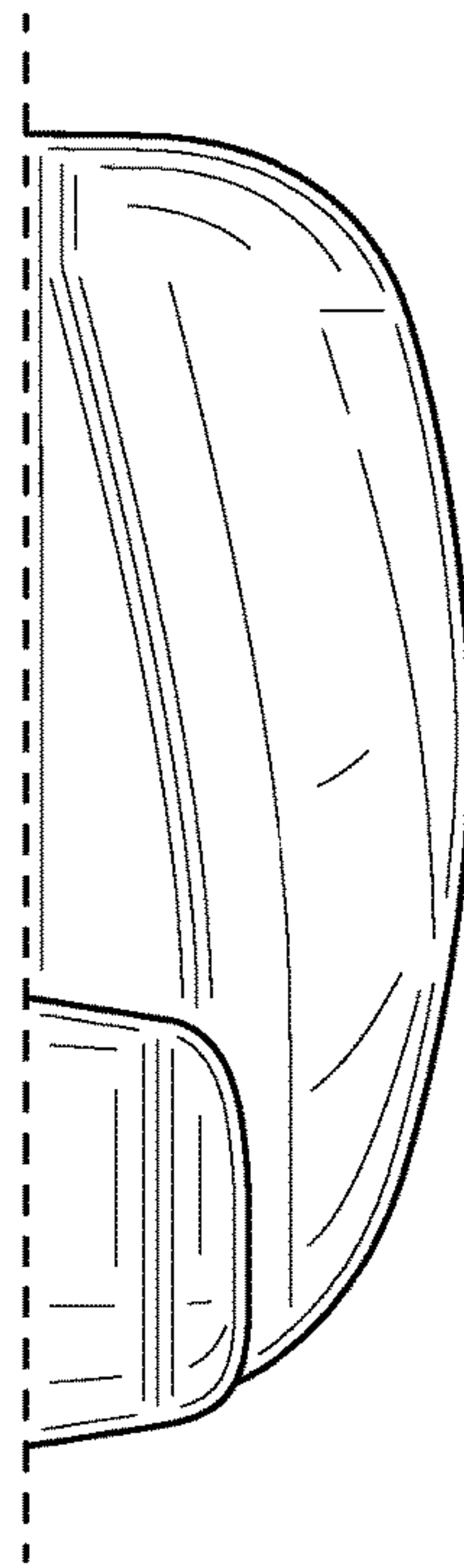

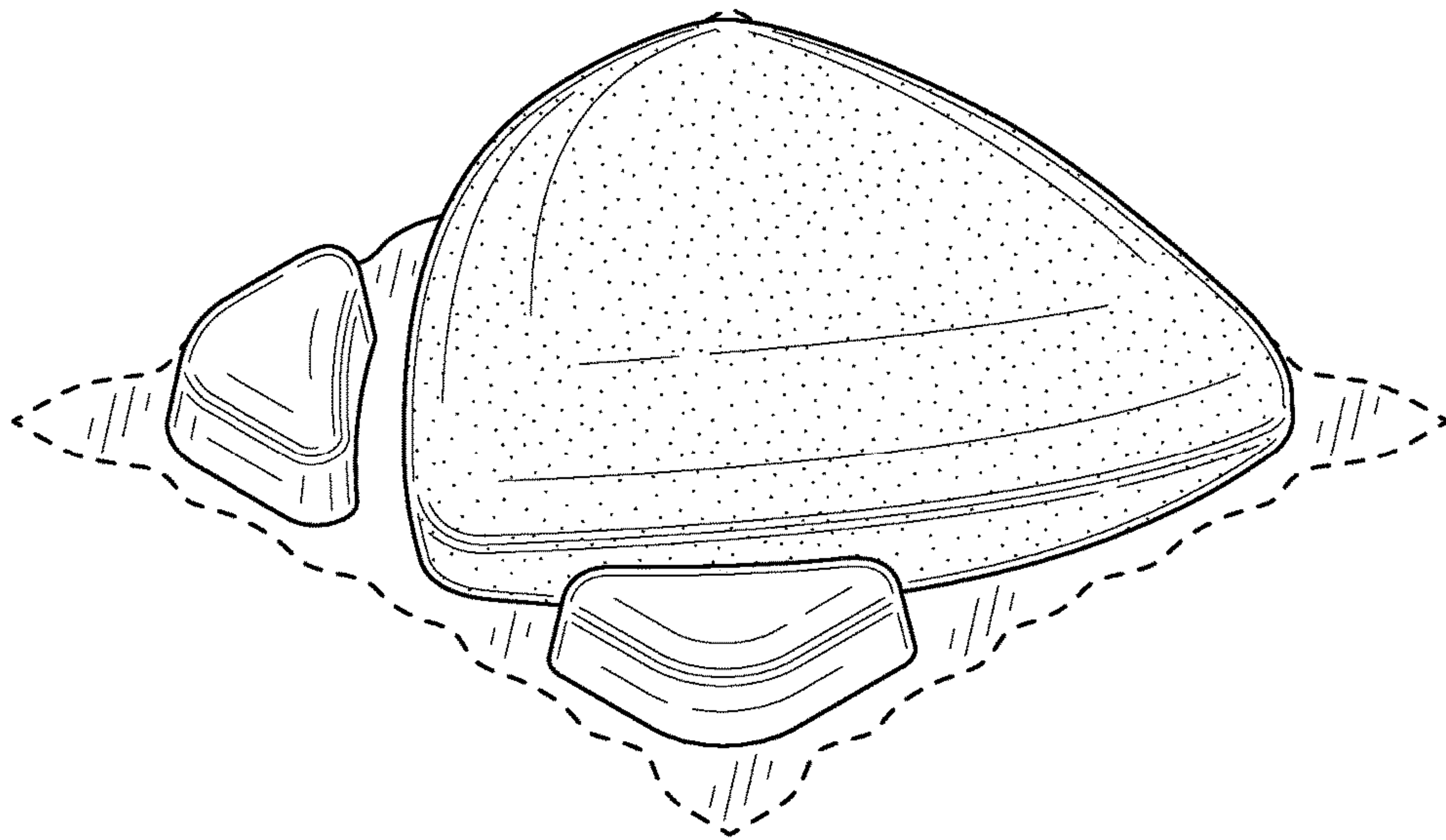

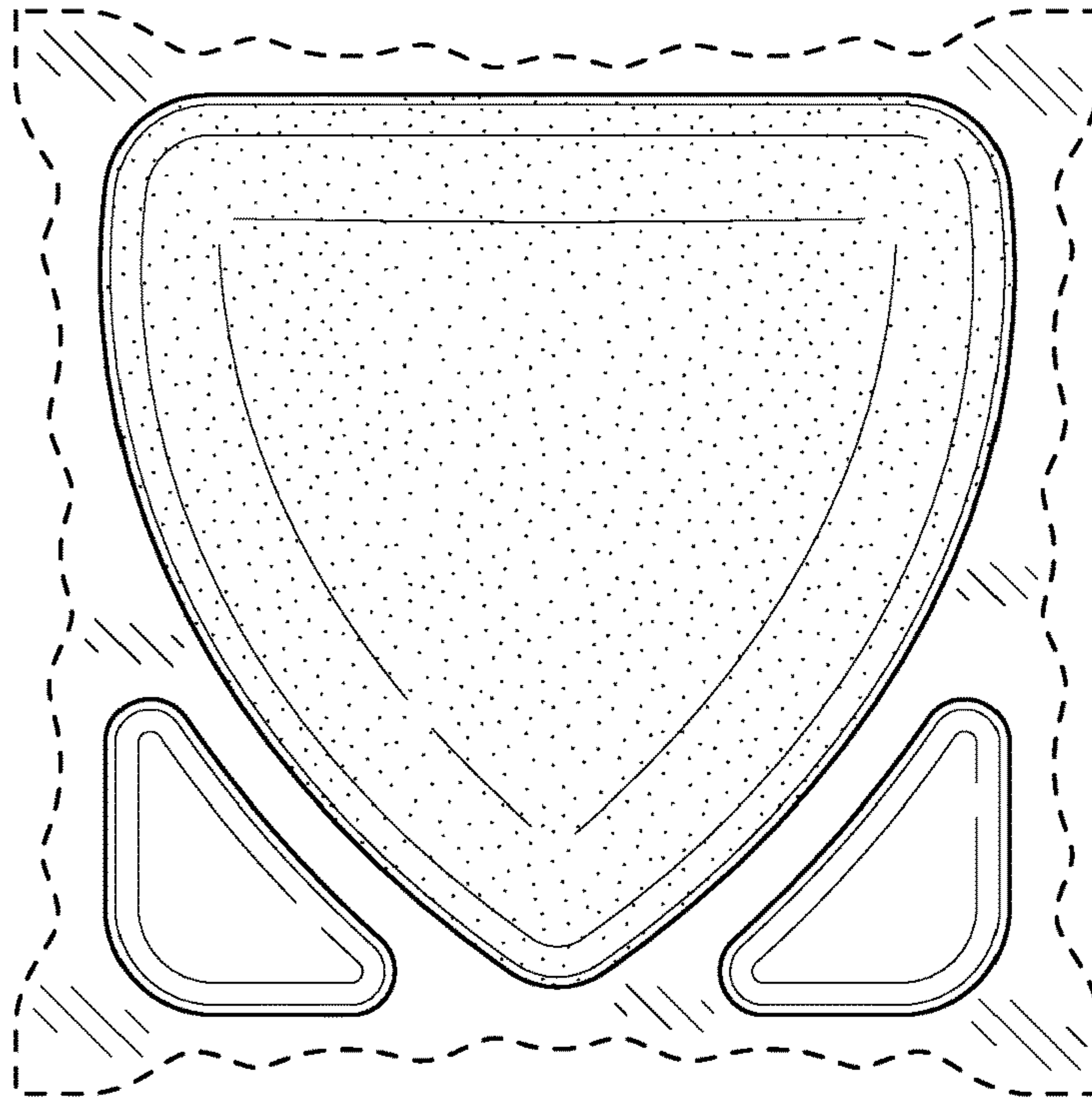

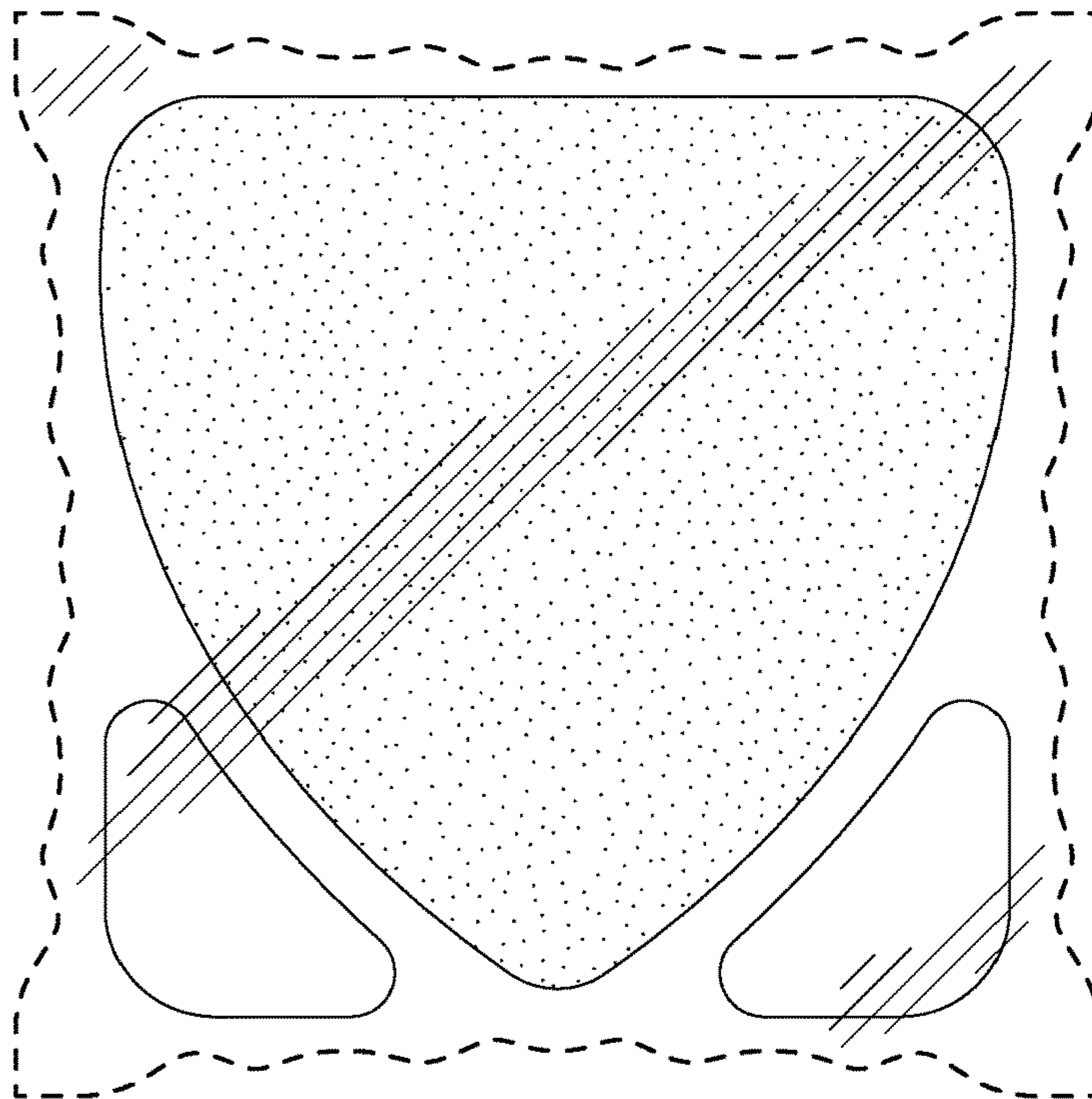

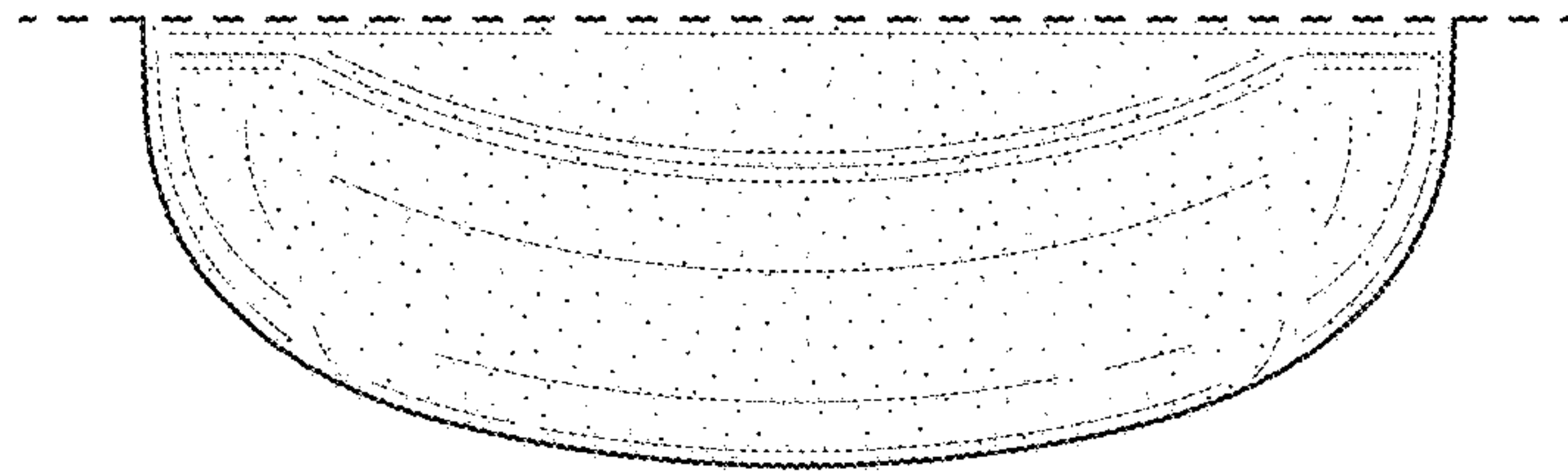

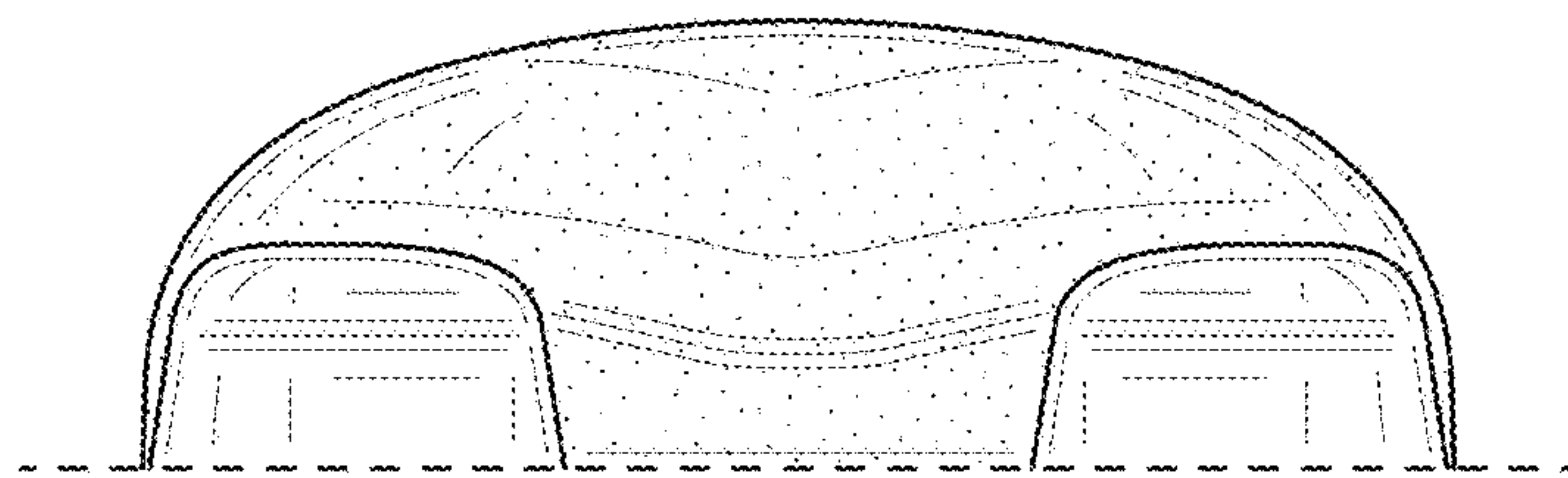

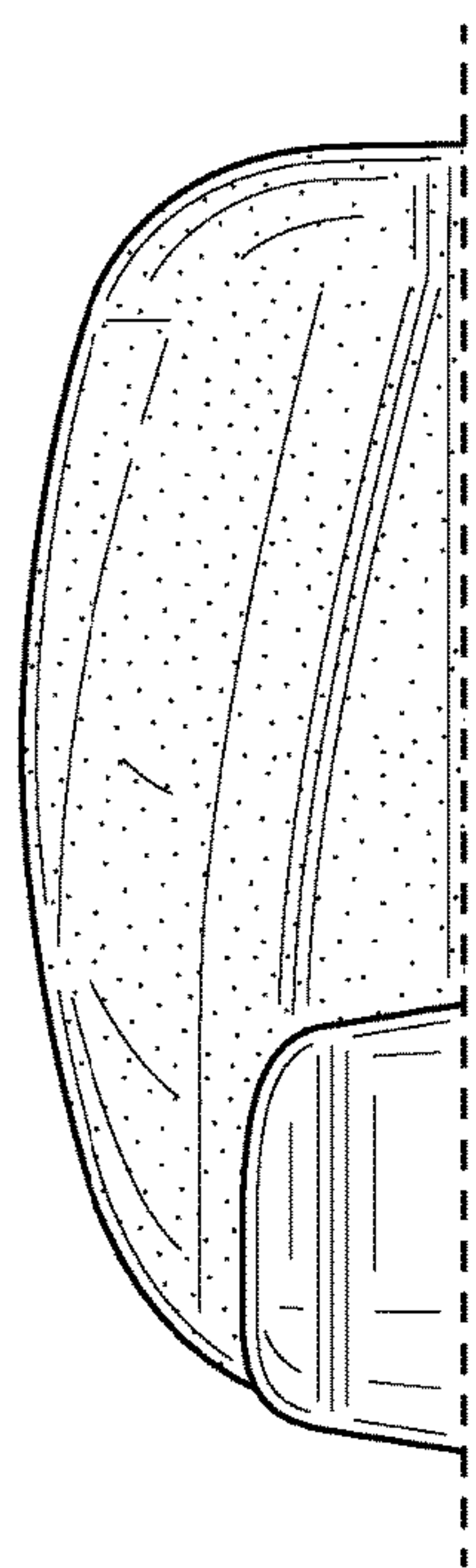

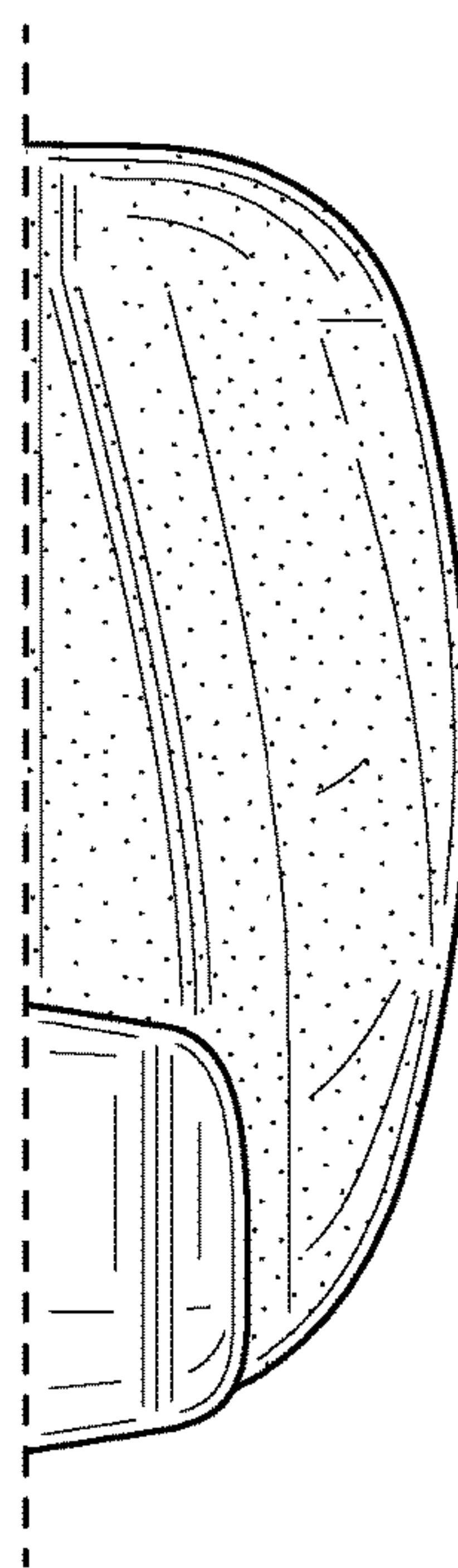
