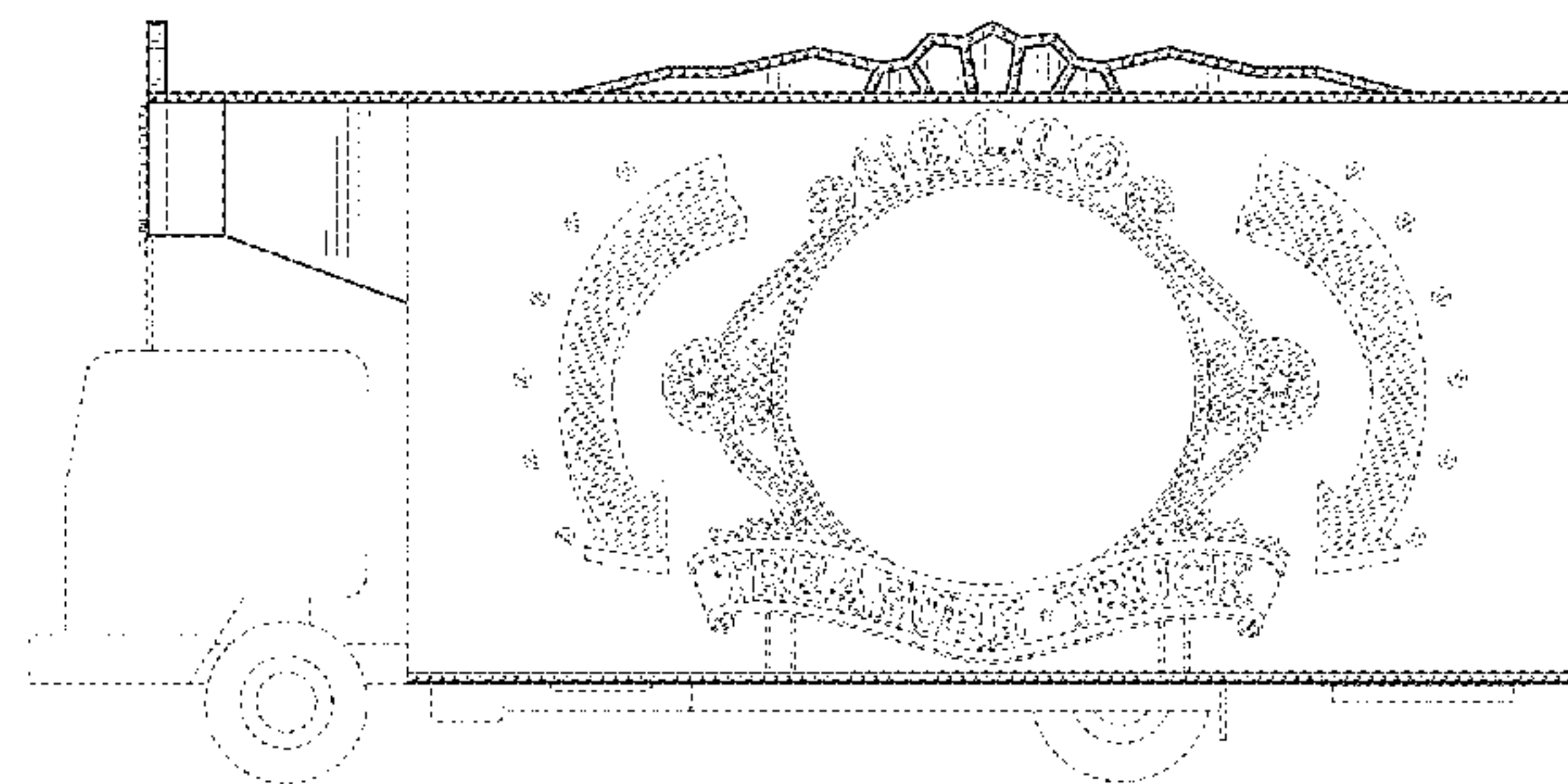
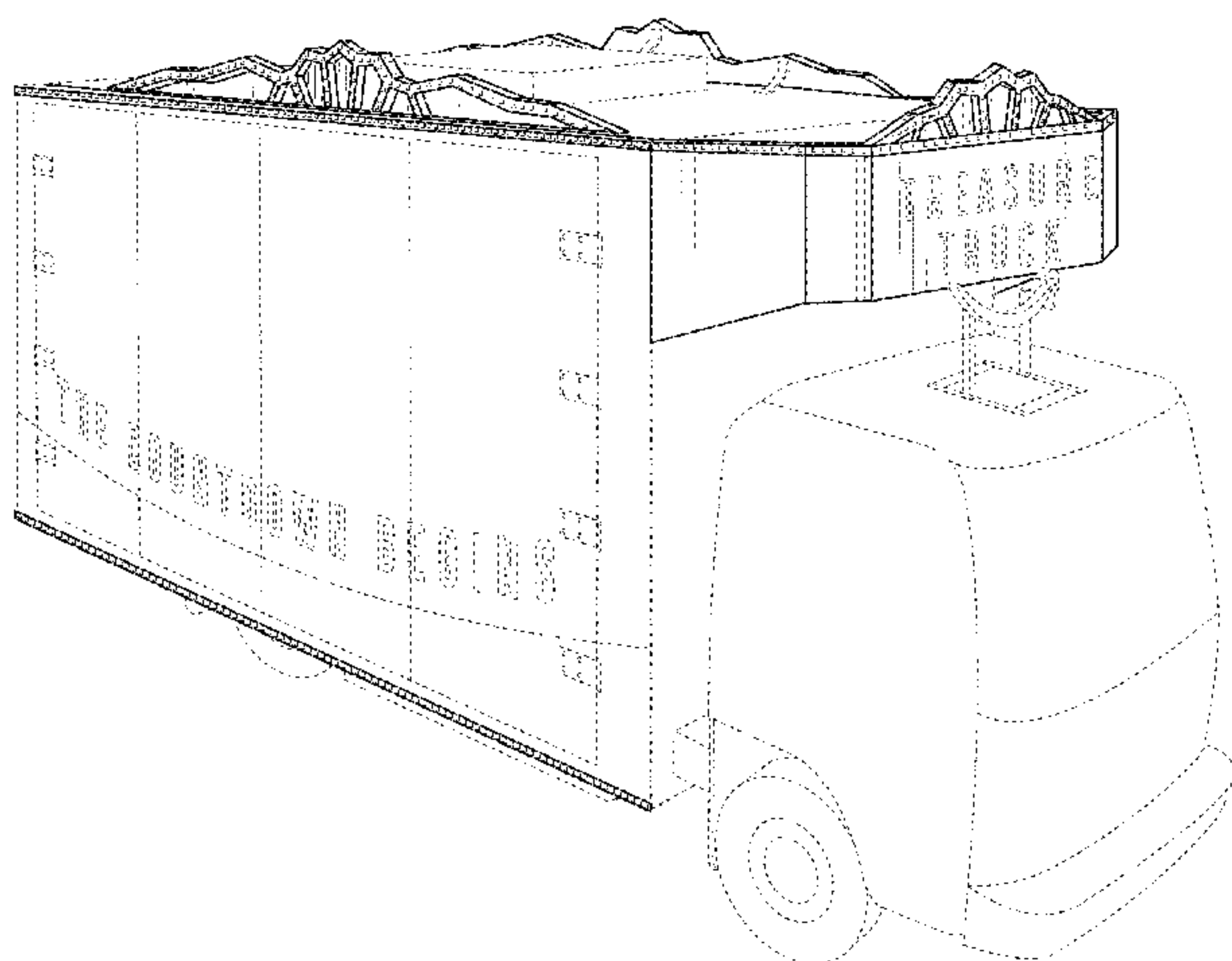
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a delivery truck box; FIG. 2 is a front view thereof; FIG. 3 is a back view thereof; FIG. 4 is a left-side view thereof; FIG. 5 is a right-side view thereof; and, FIG. 6 is a top view thereof. The broken lines depict portions of the delivery truck box that form no part of the claimed design.

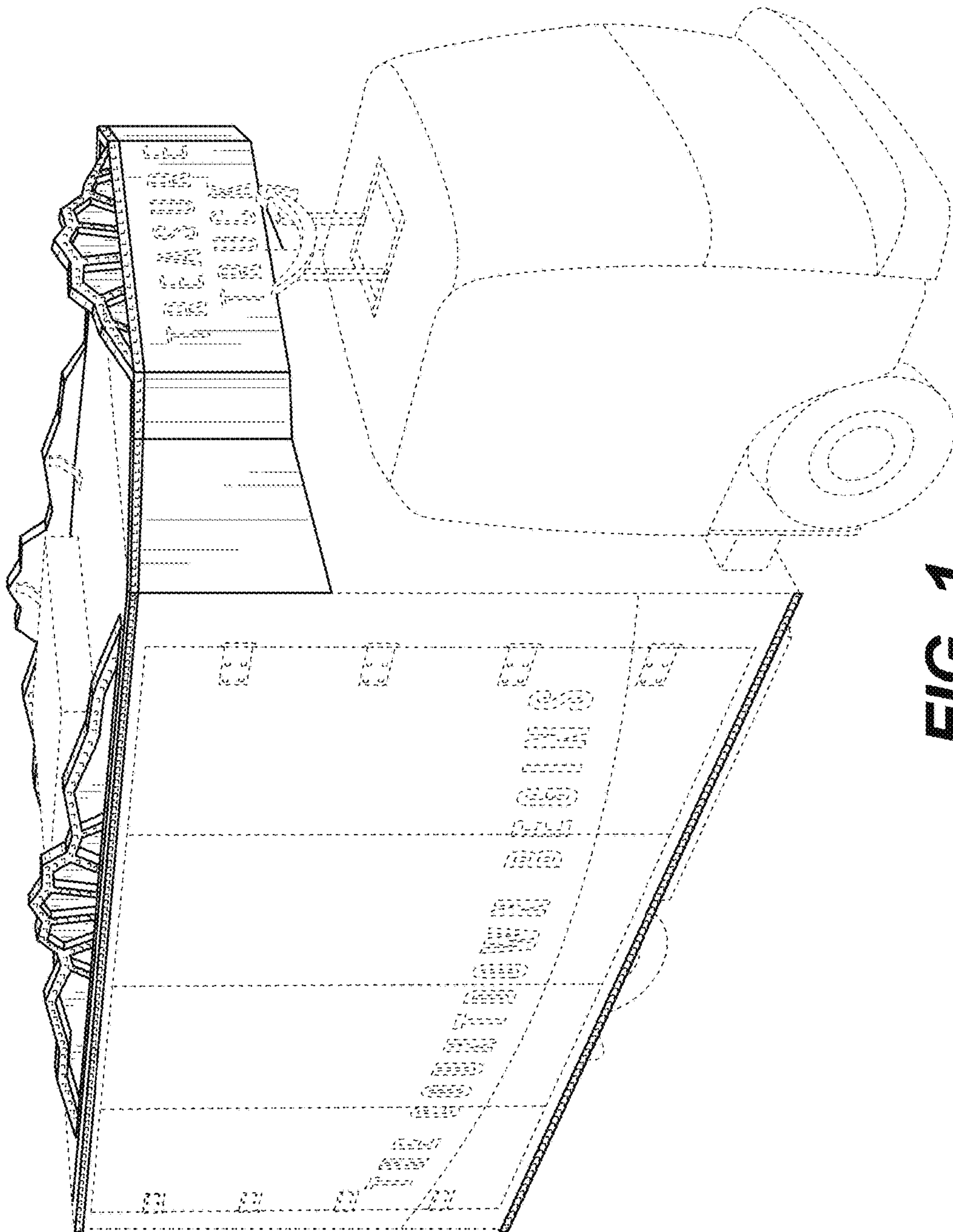

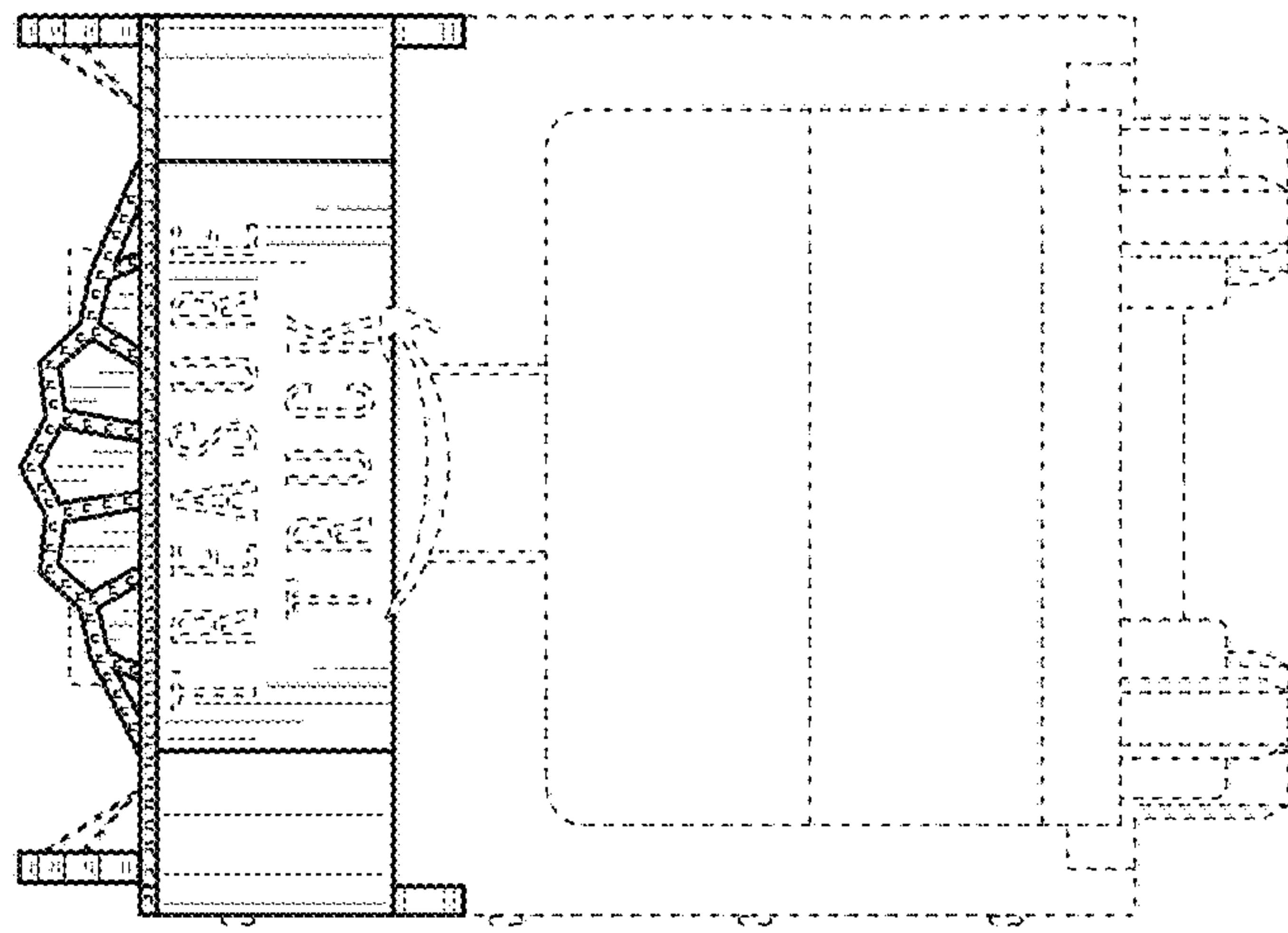

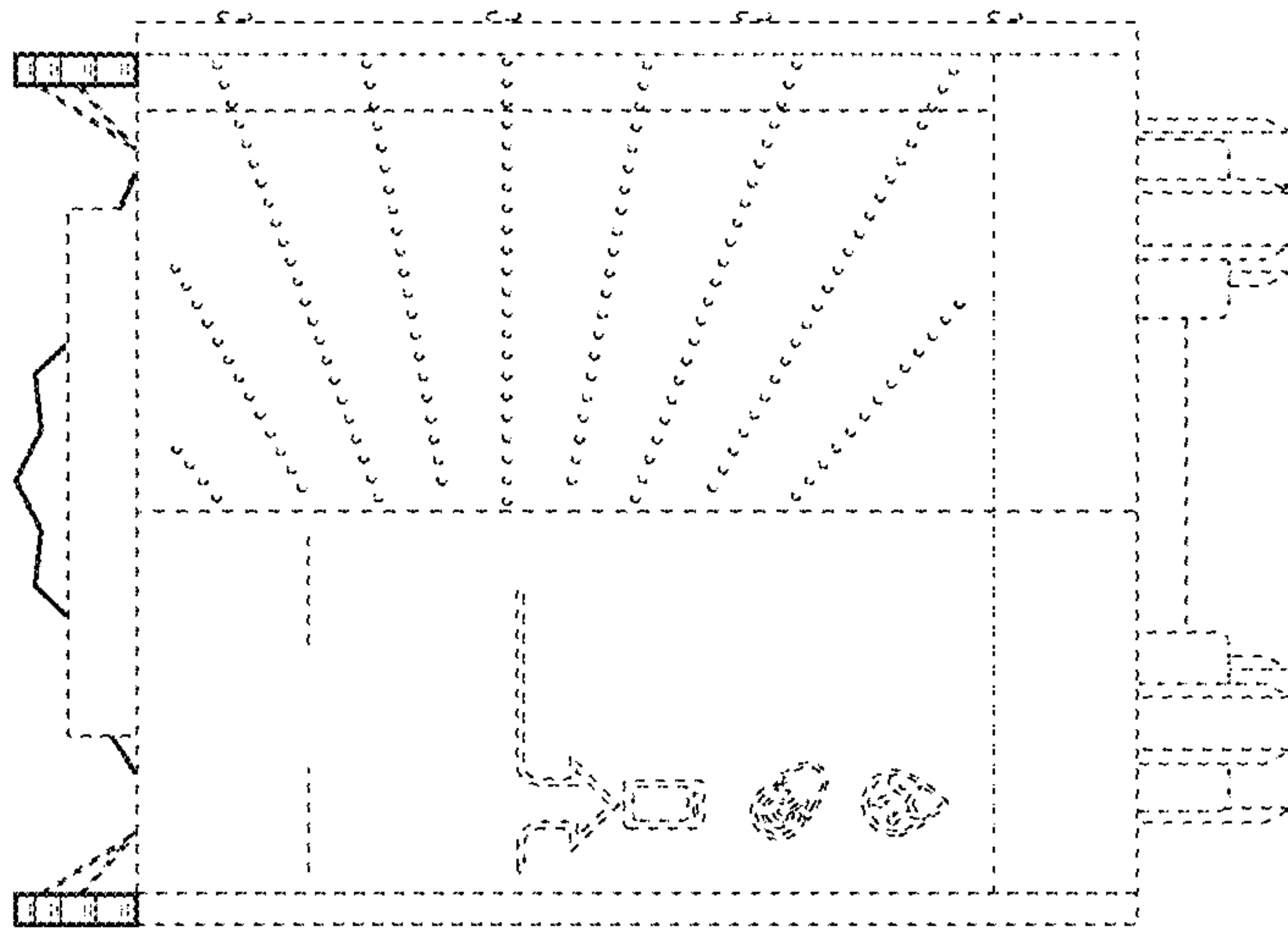

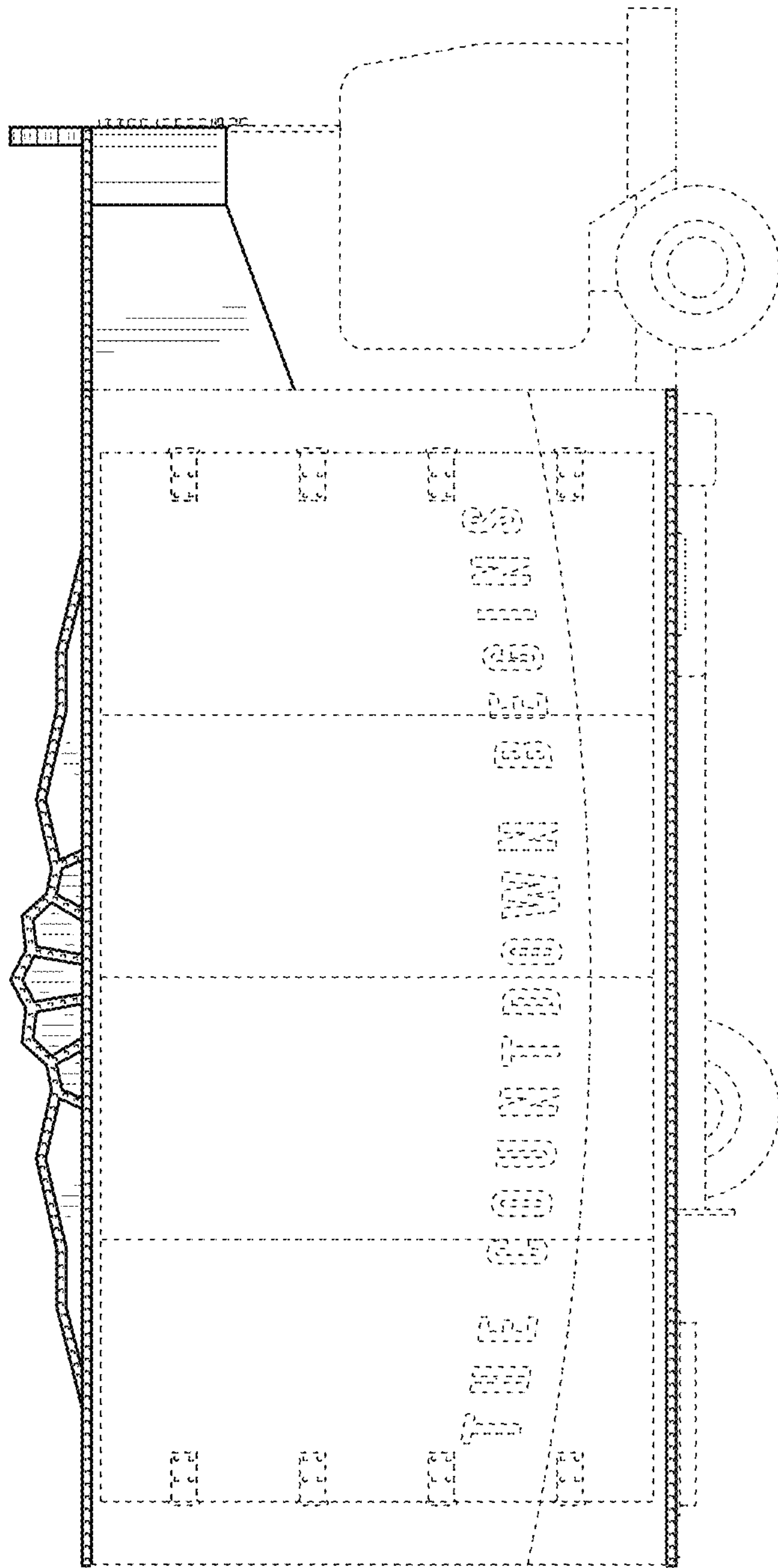

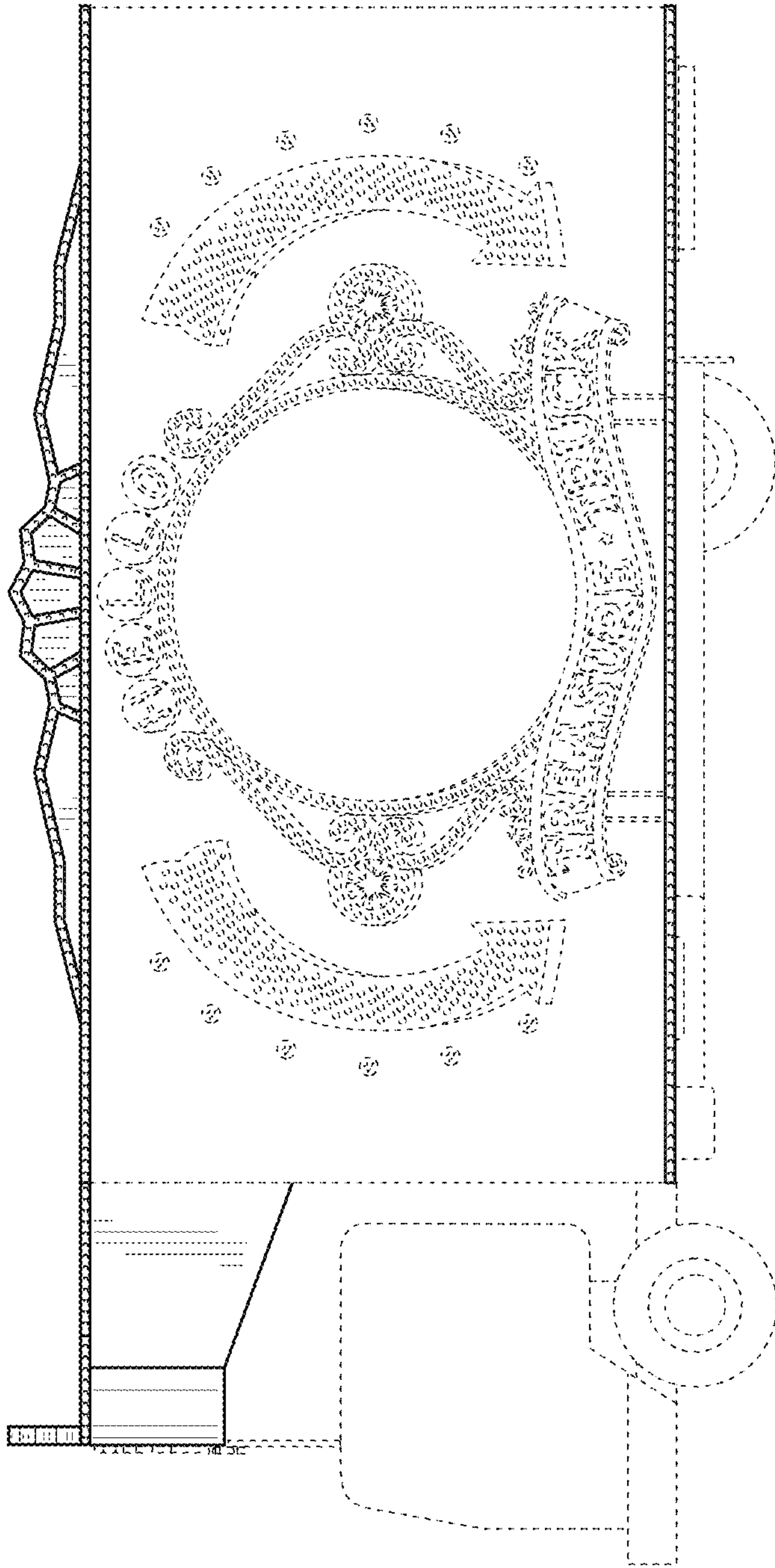

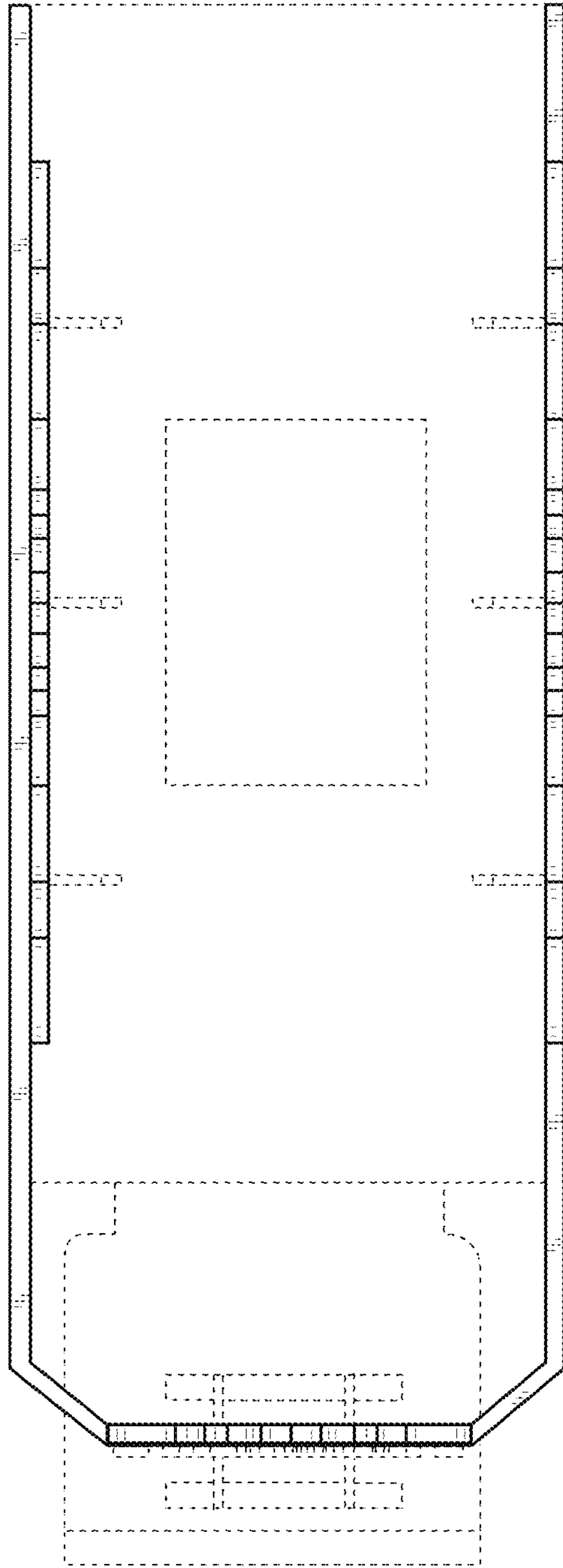
