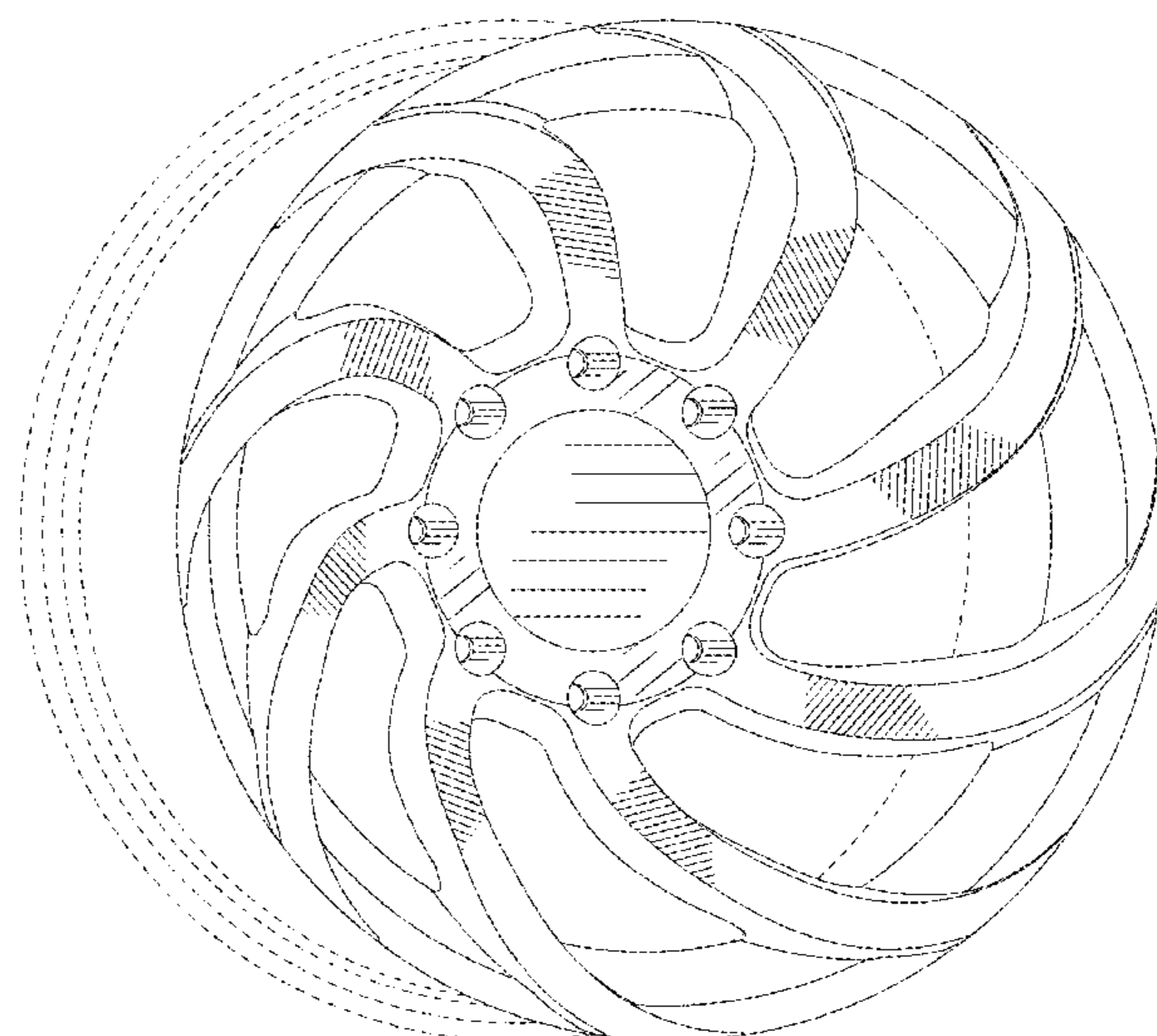
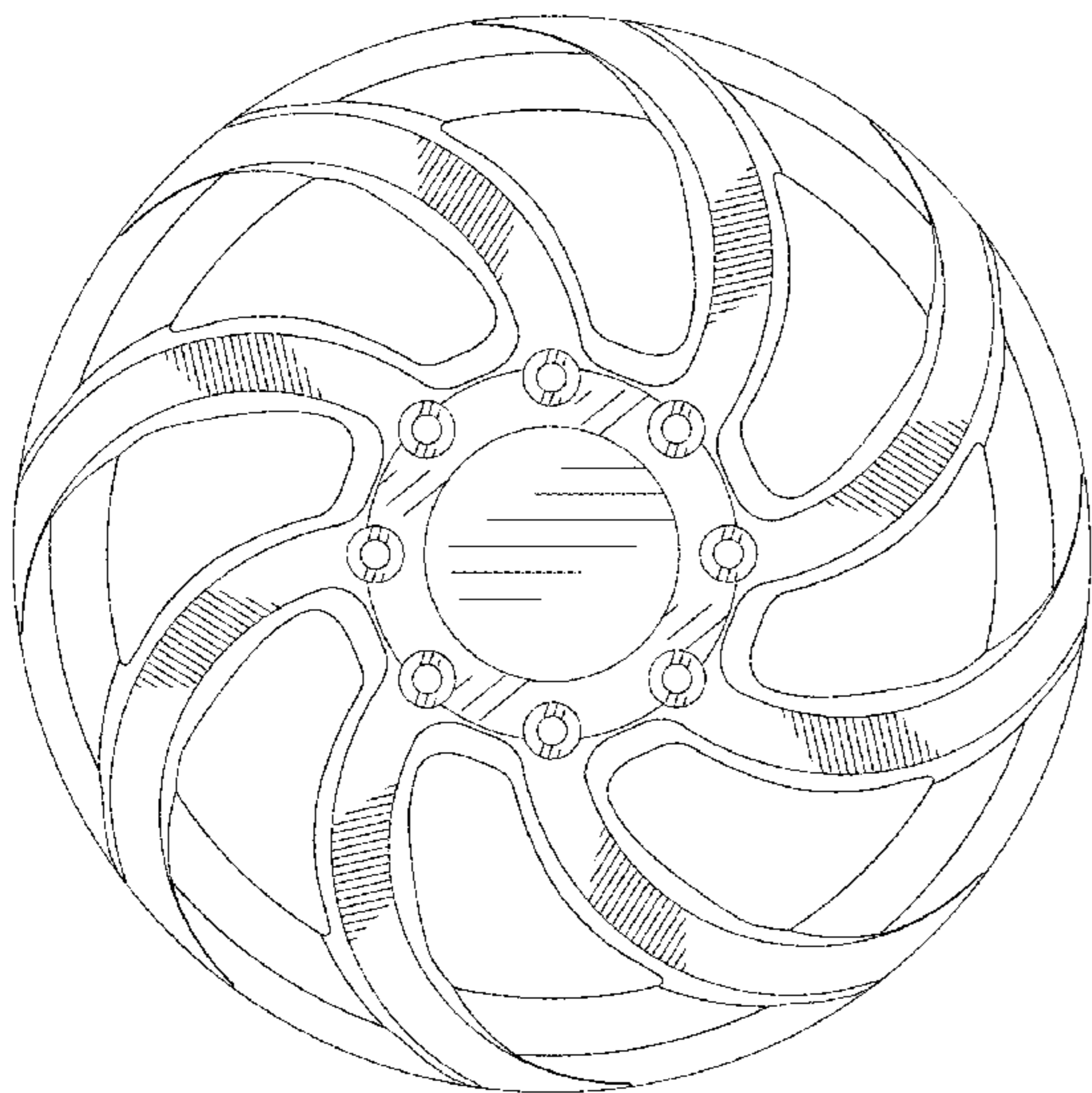
(57) **CLAIM**

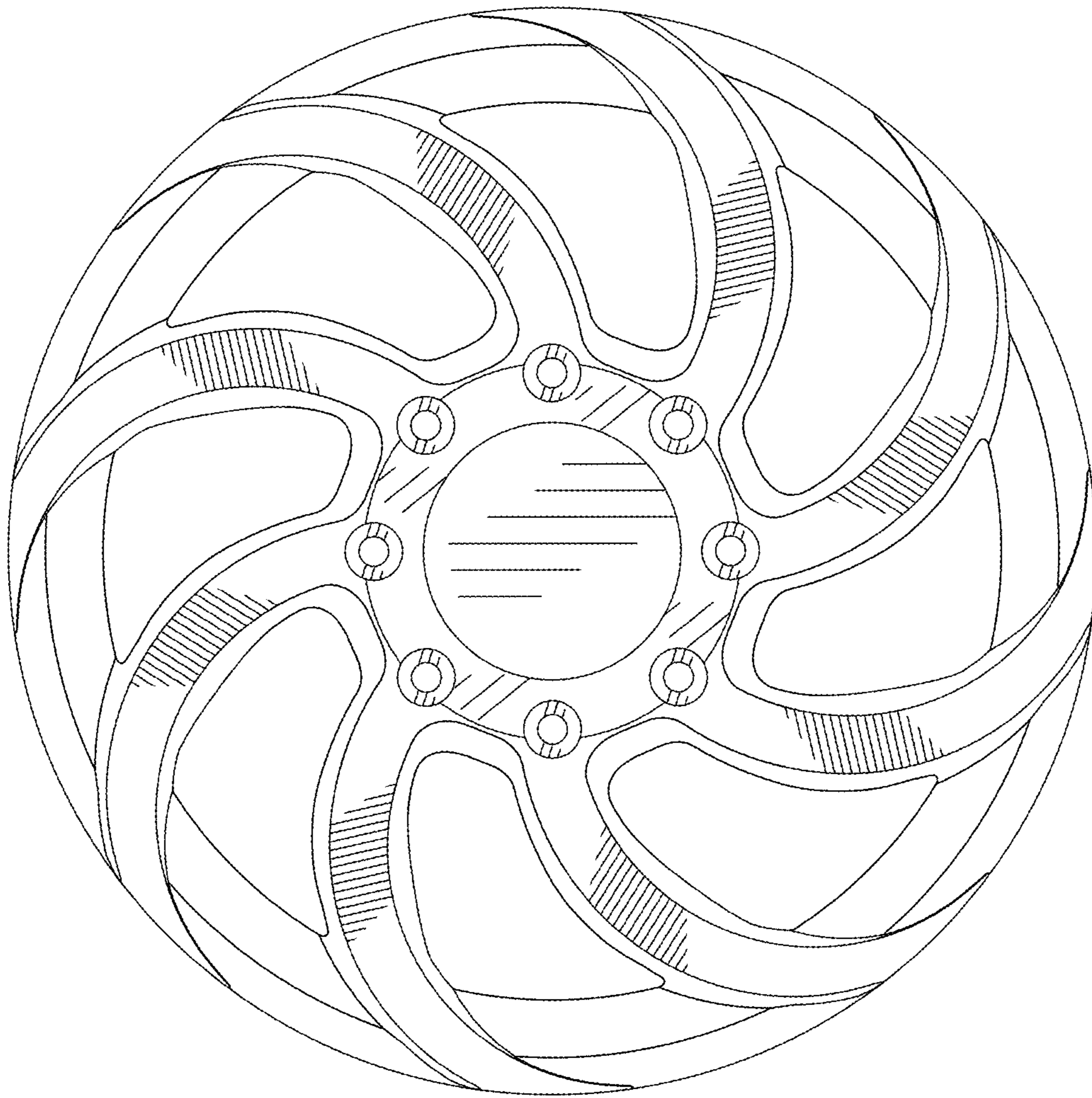
I claim the ornamental design for an automobile wheel, as shown and described.

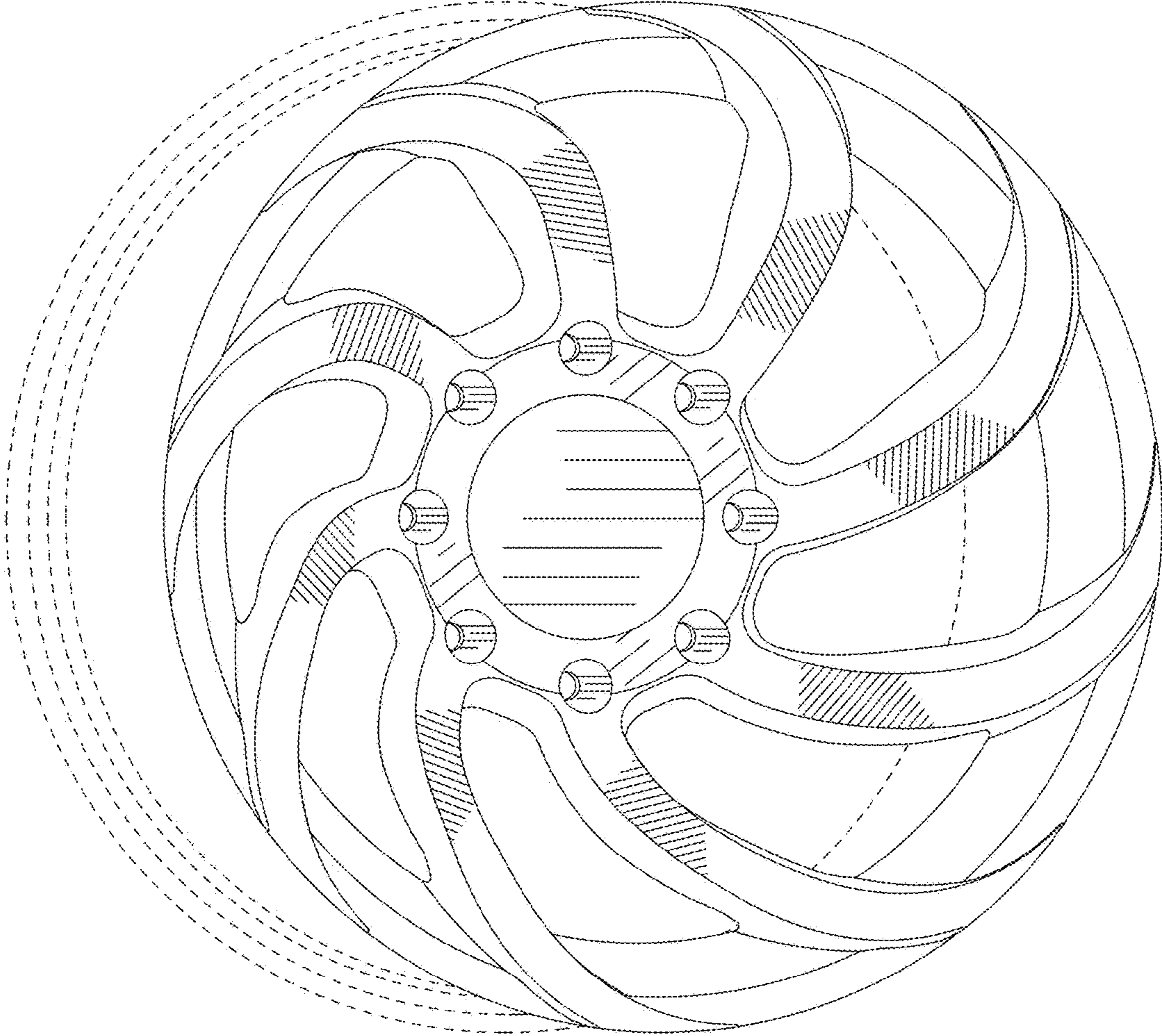
