(57) **CLAIM**

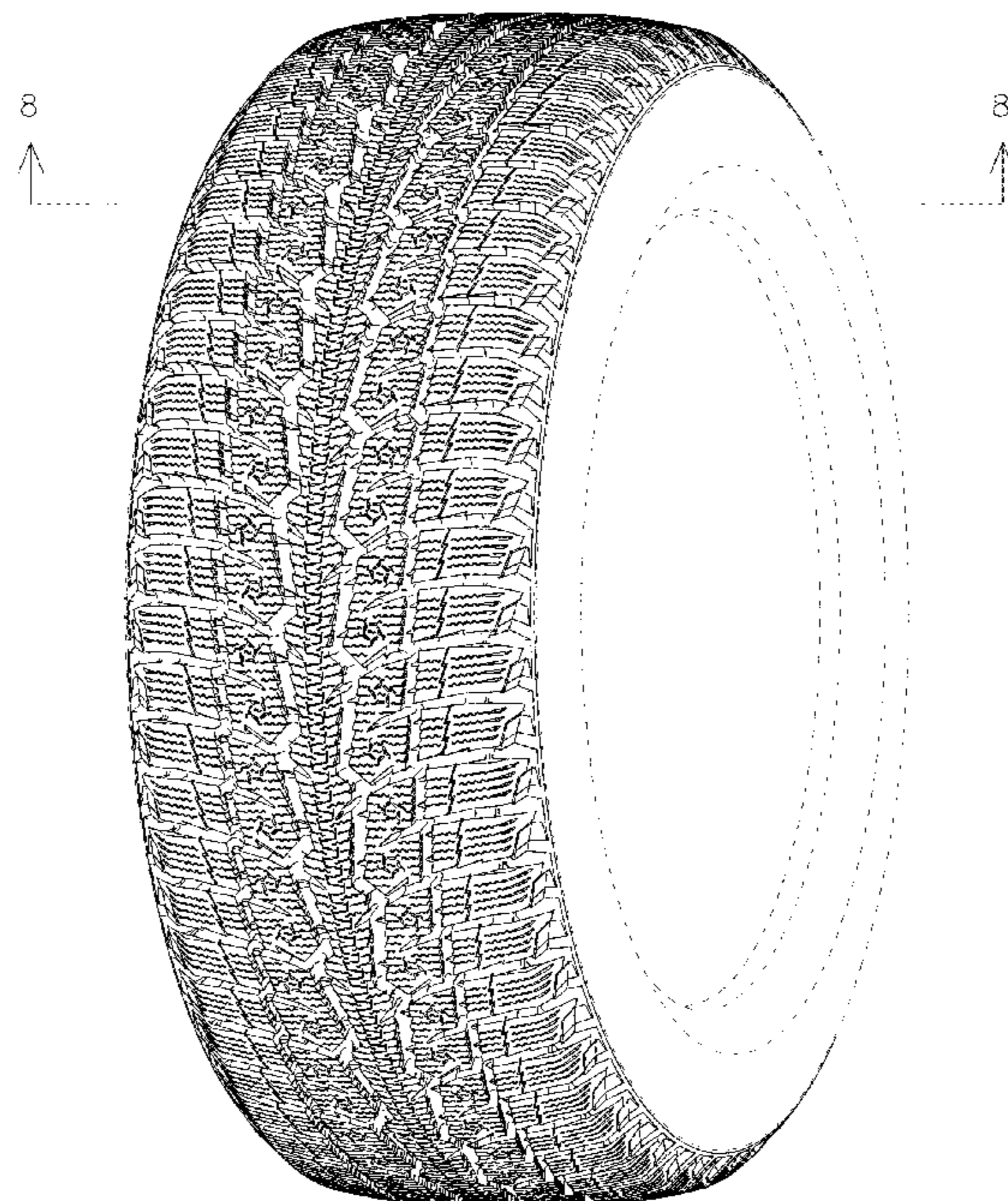
The ornamental design for a tire, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a tire showing the claimed design;
FIG. 2 is a front view thereof;

FIG. 6 is a right side view thereof;

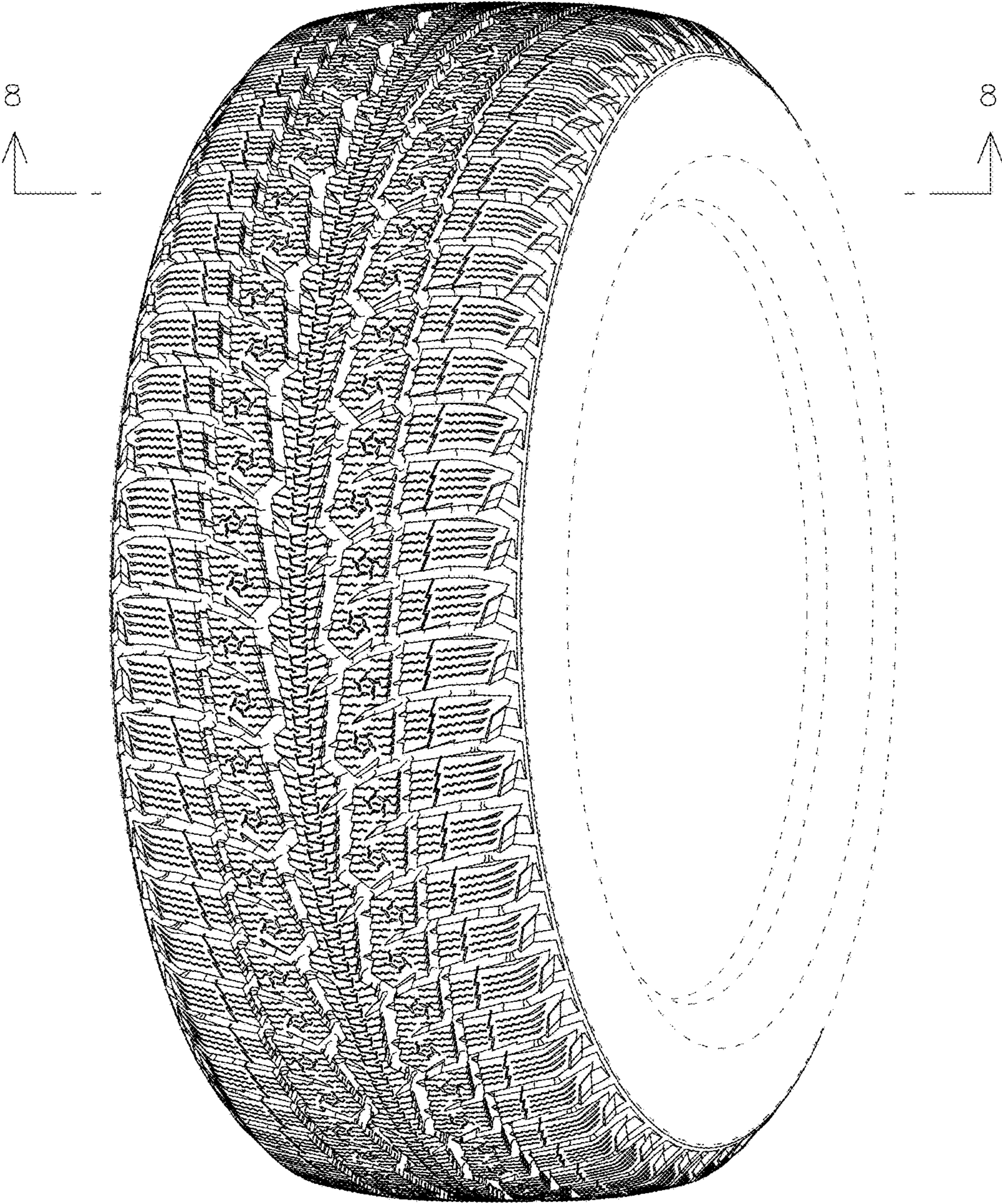

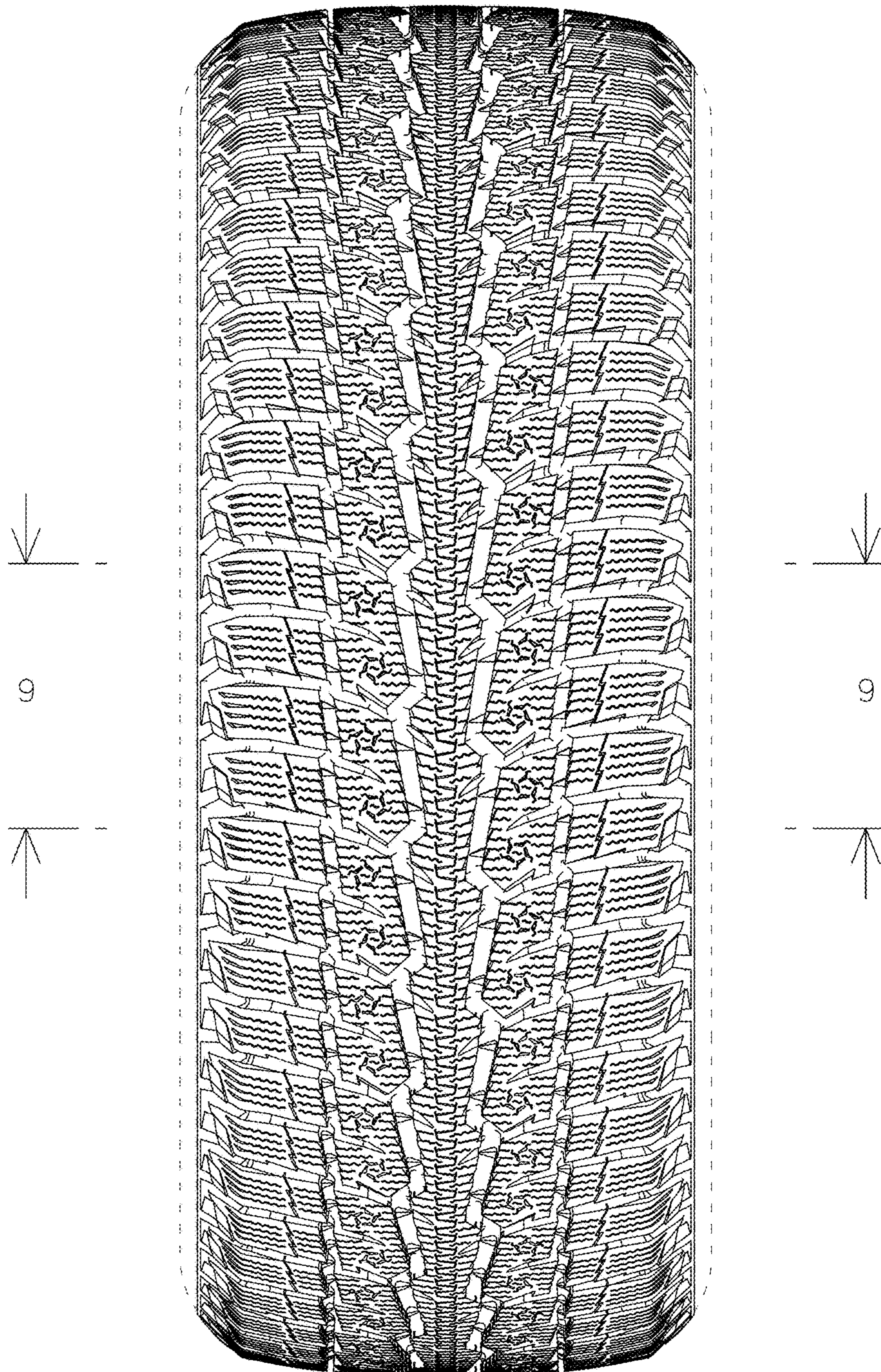

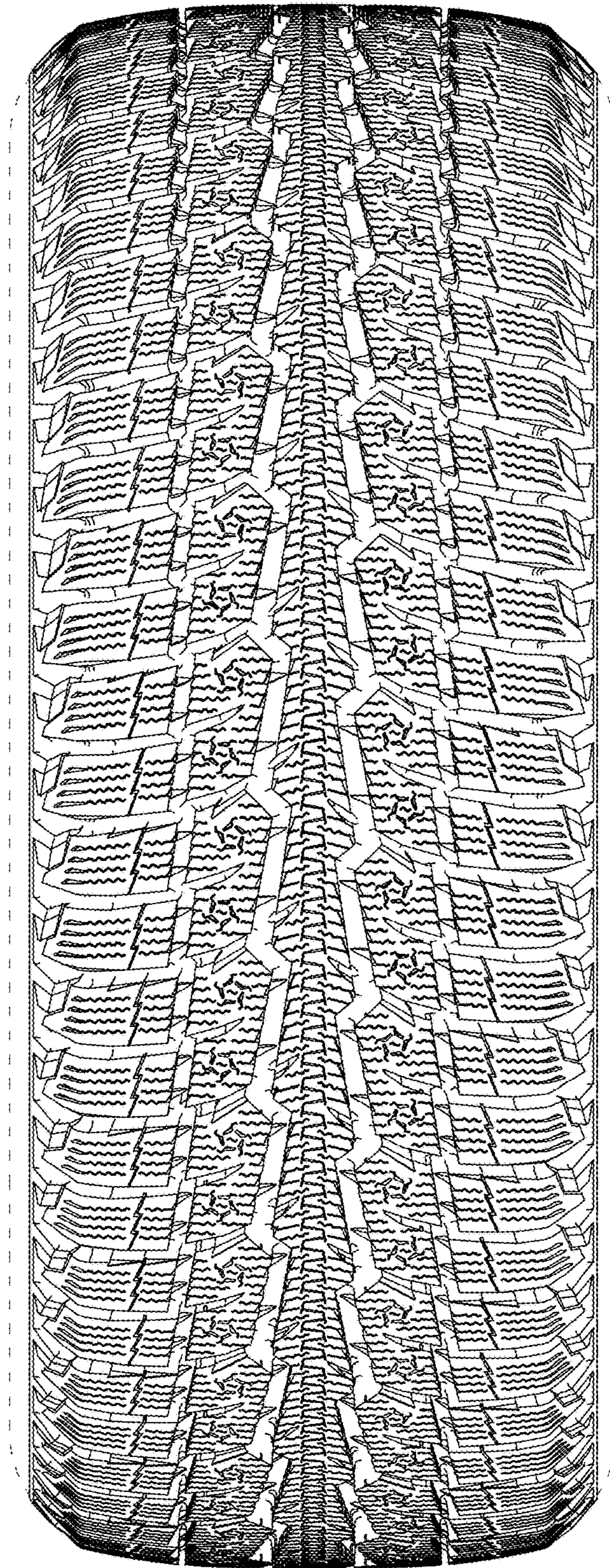

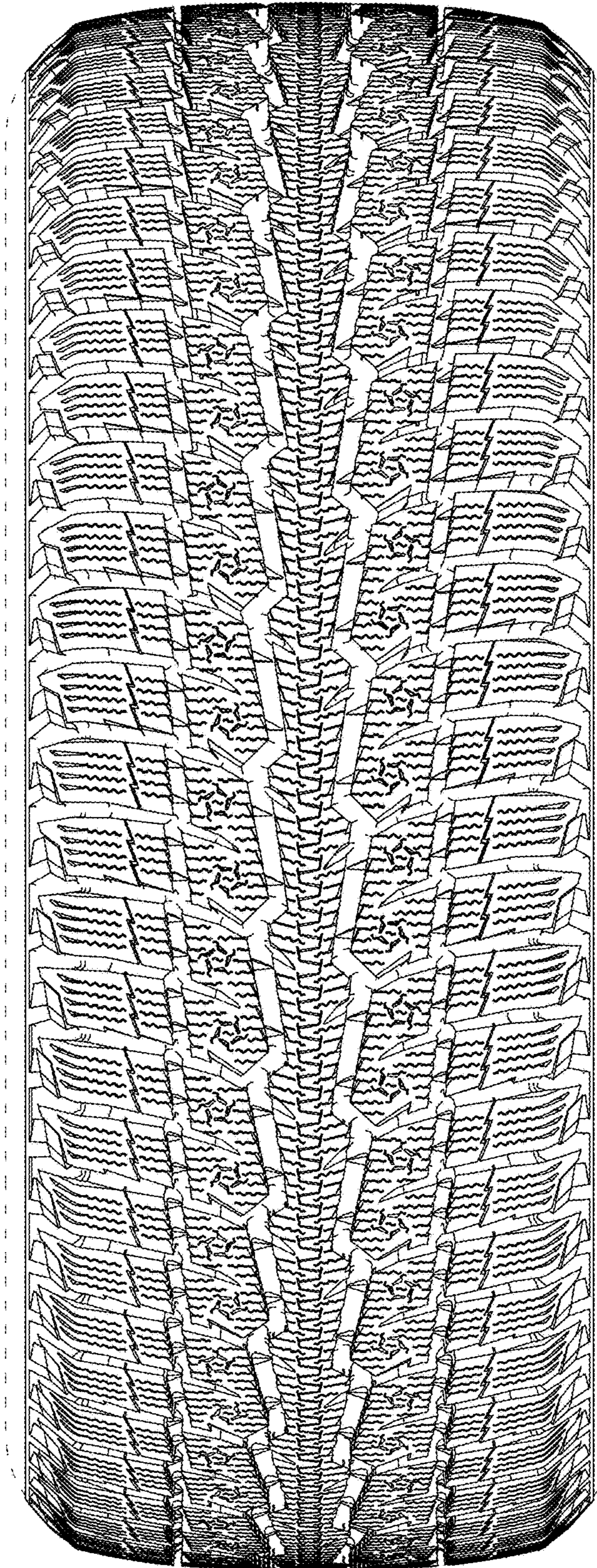

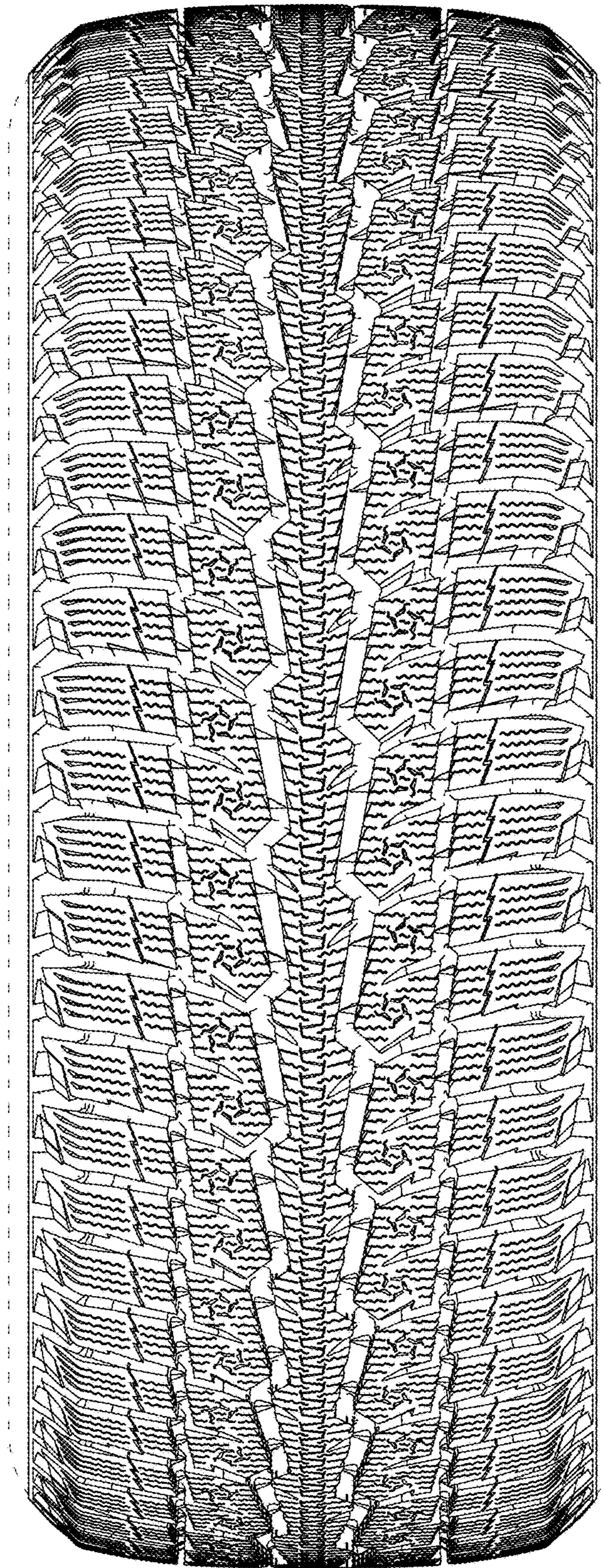

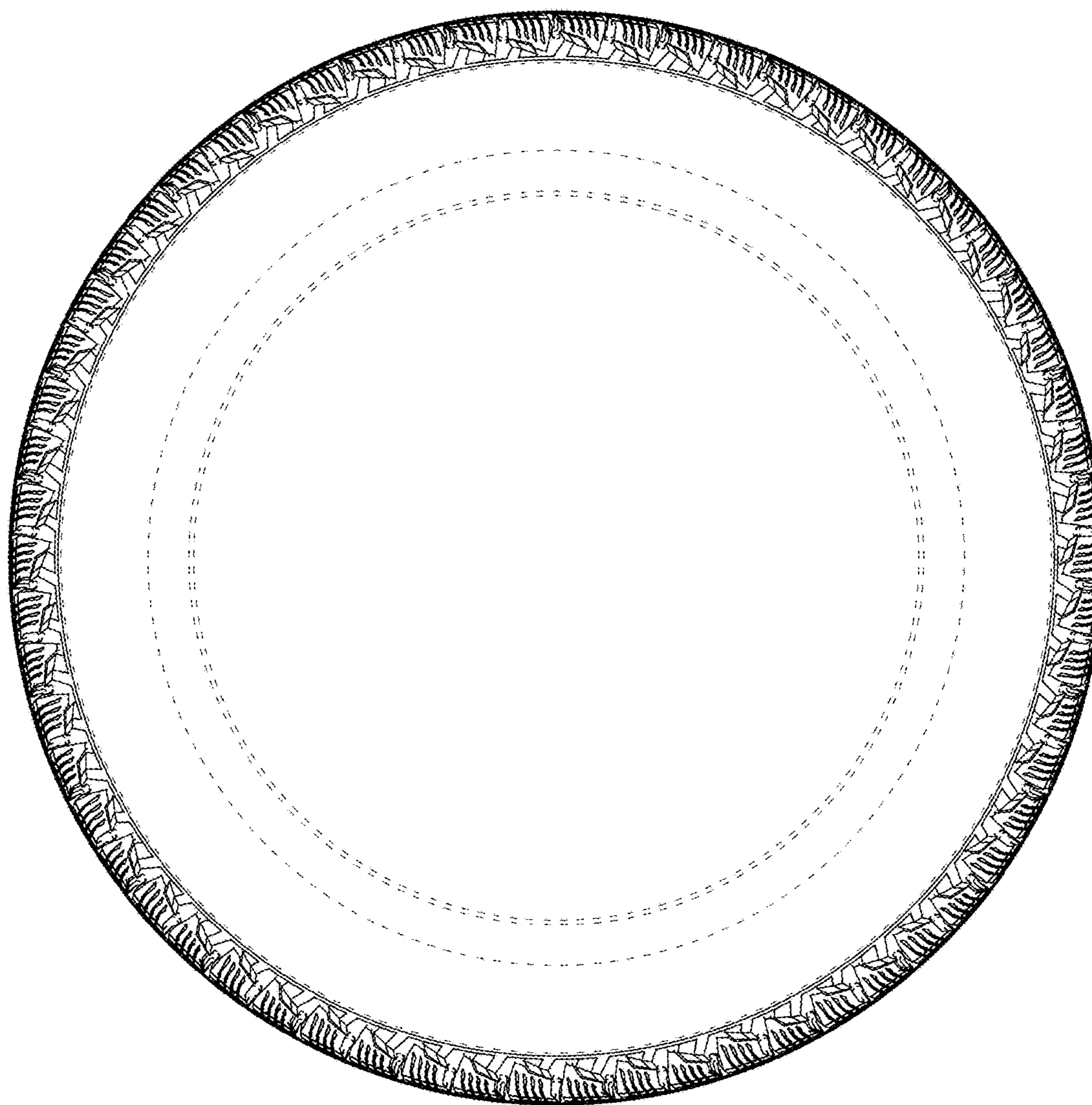

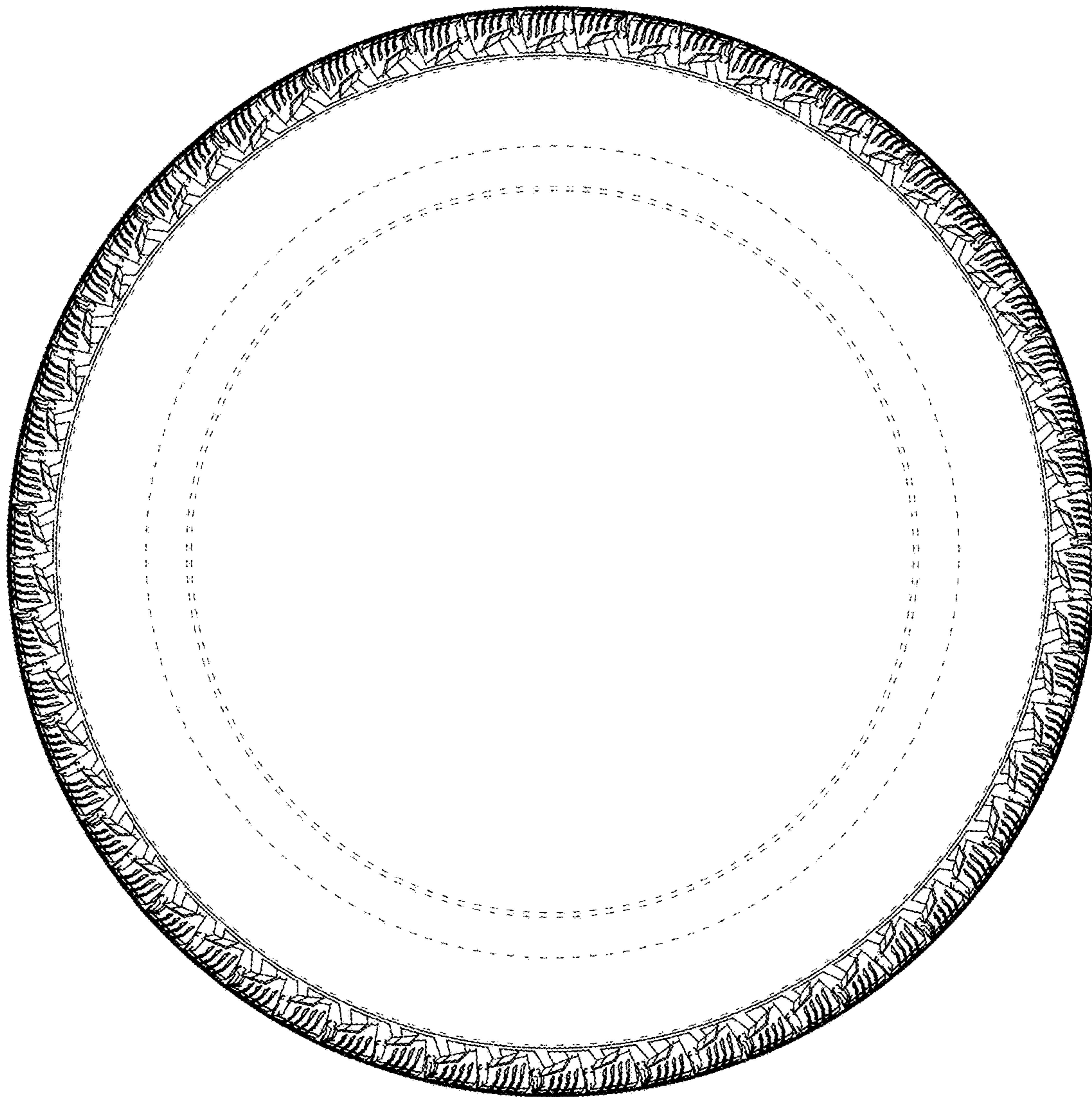

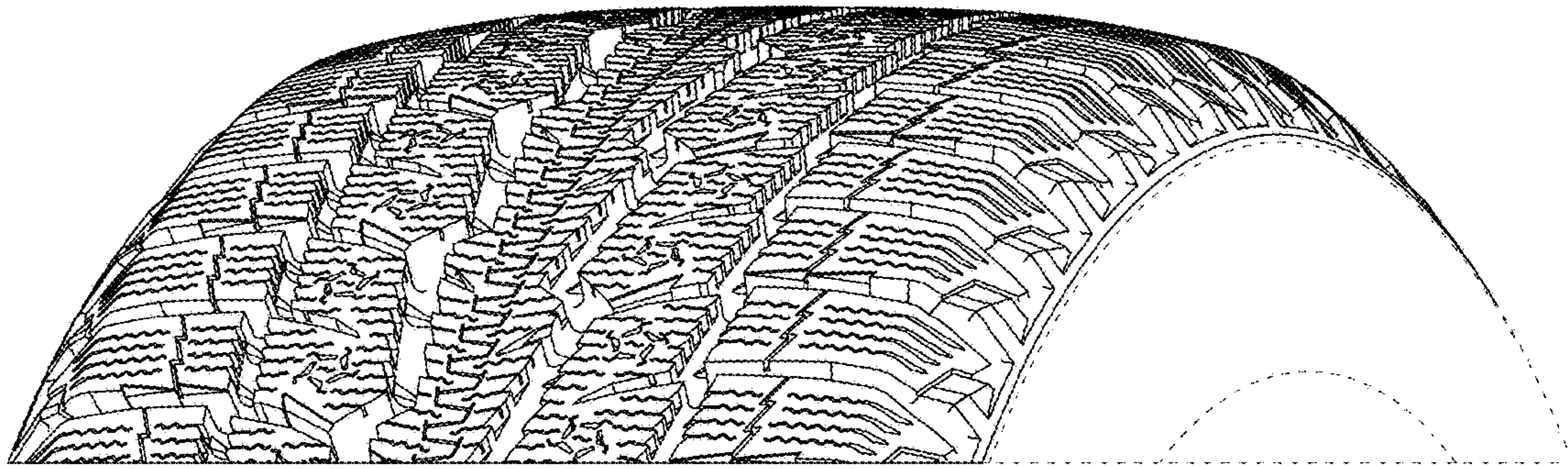

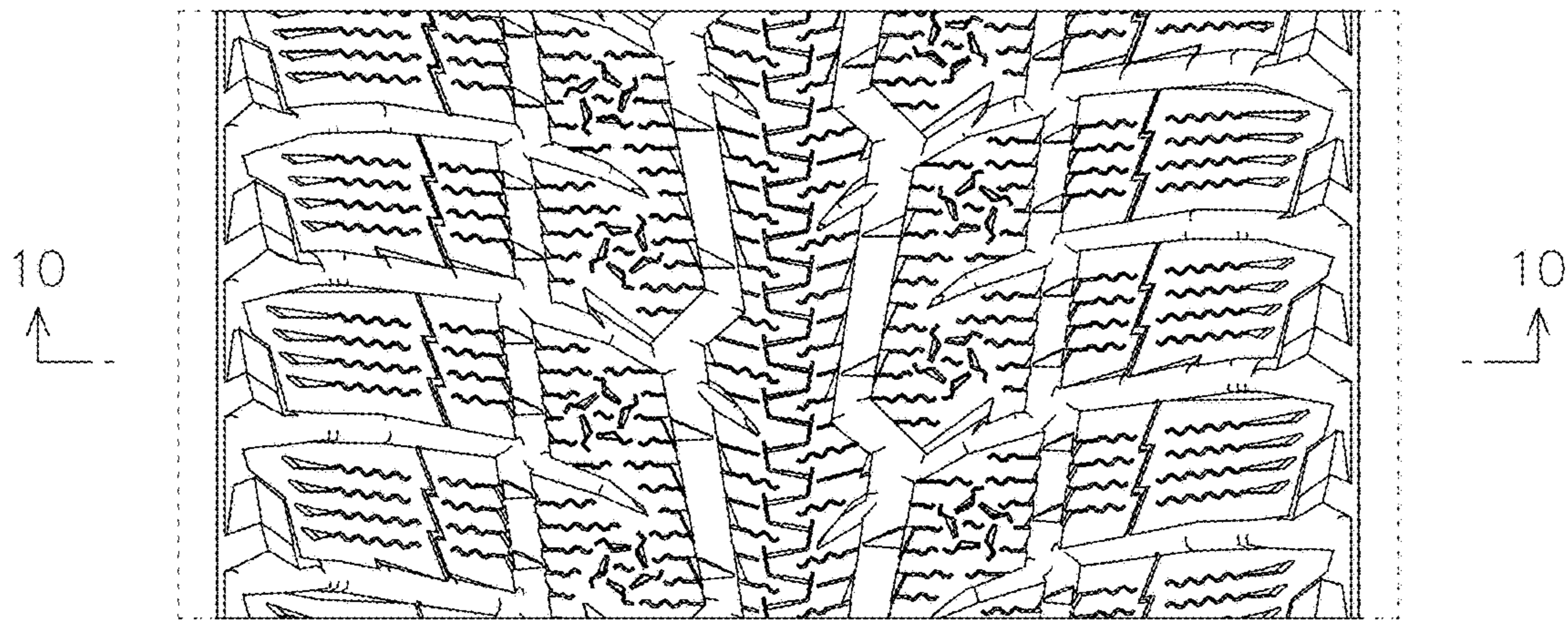

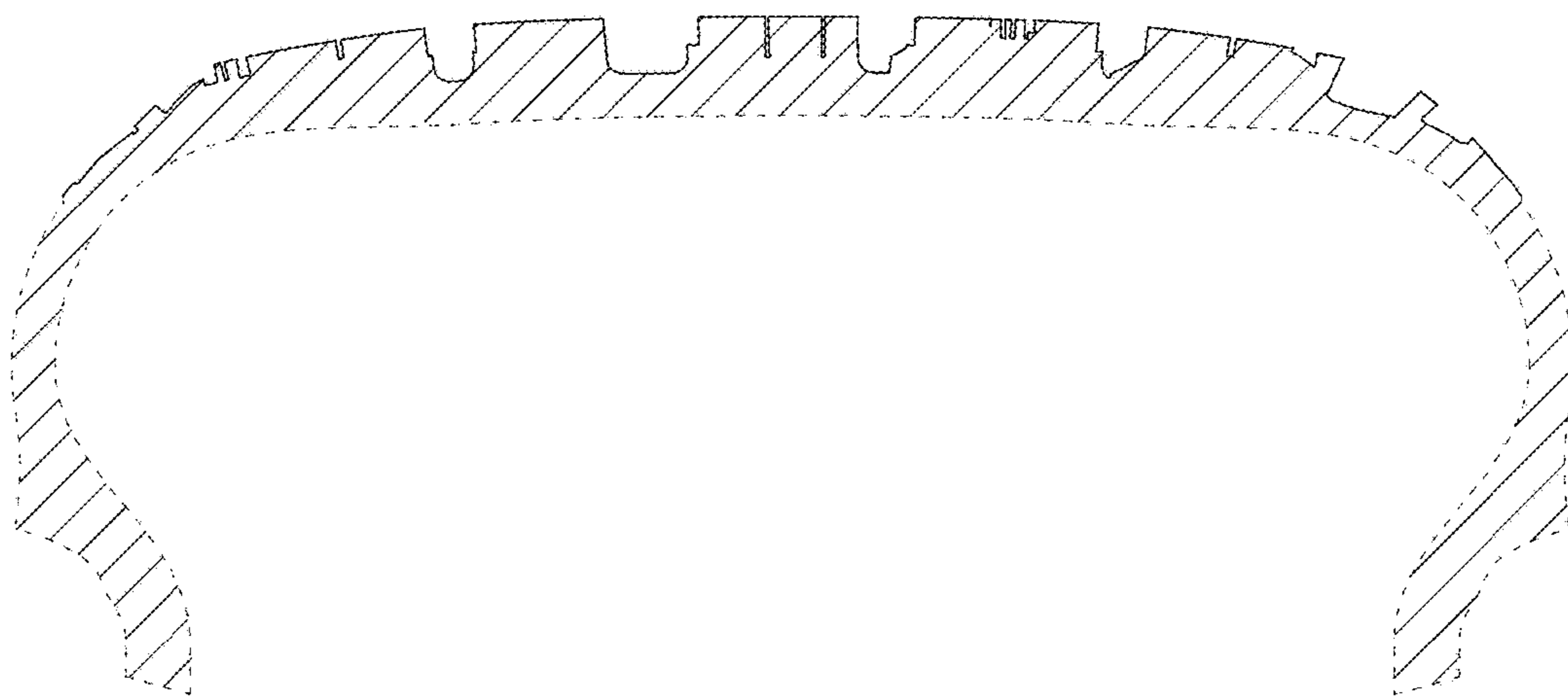
