(57) **CLAIM**

I claim the ornamental design for a mobile phone, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a mobile phone, showing our new design;

FIG. 2 is a rear perspective view of the mobile phone shown in FIG. 1;

FIG. 3 is a front elevation view of the mobile phone shown in FIG. 1;

FIG. 4 is a rear elevation view of the mobile phone shown in FIG. 1;

FIG. 5 is a left side elevation view of the mobile phone shown in FIG. 1;

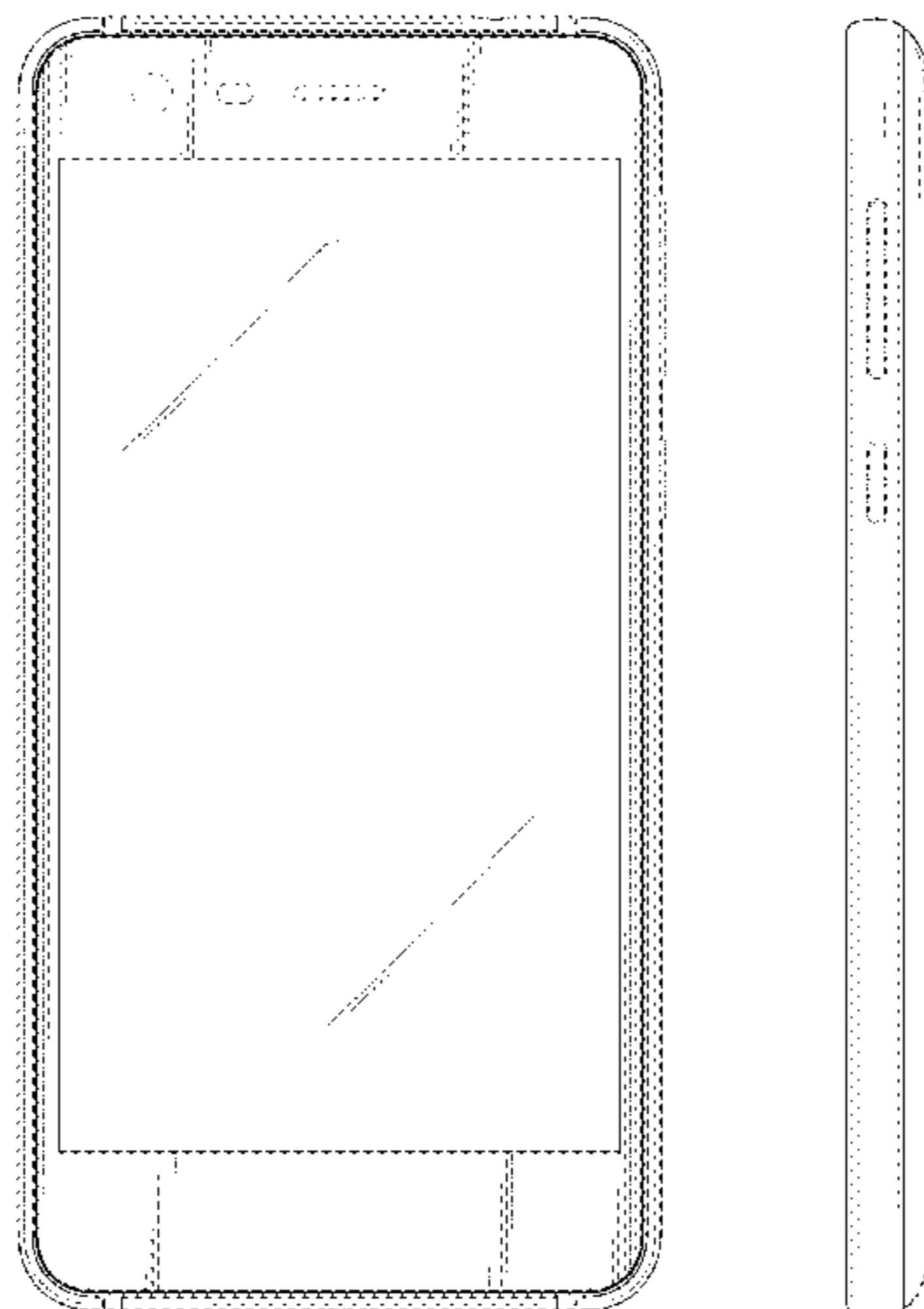
FIG. 6 is a right side elevation view of the mobile phone shown in FIG. 1;

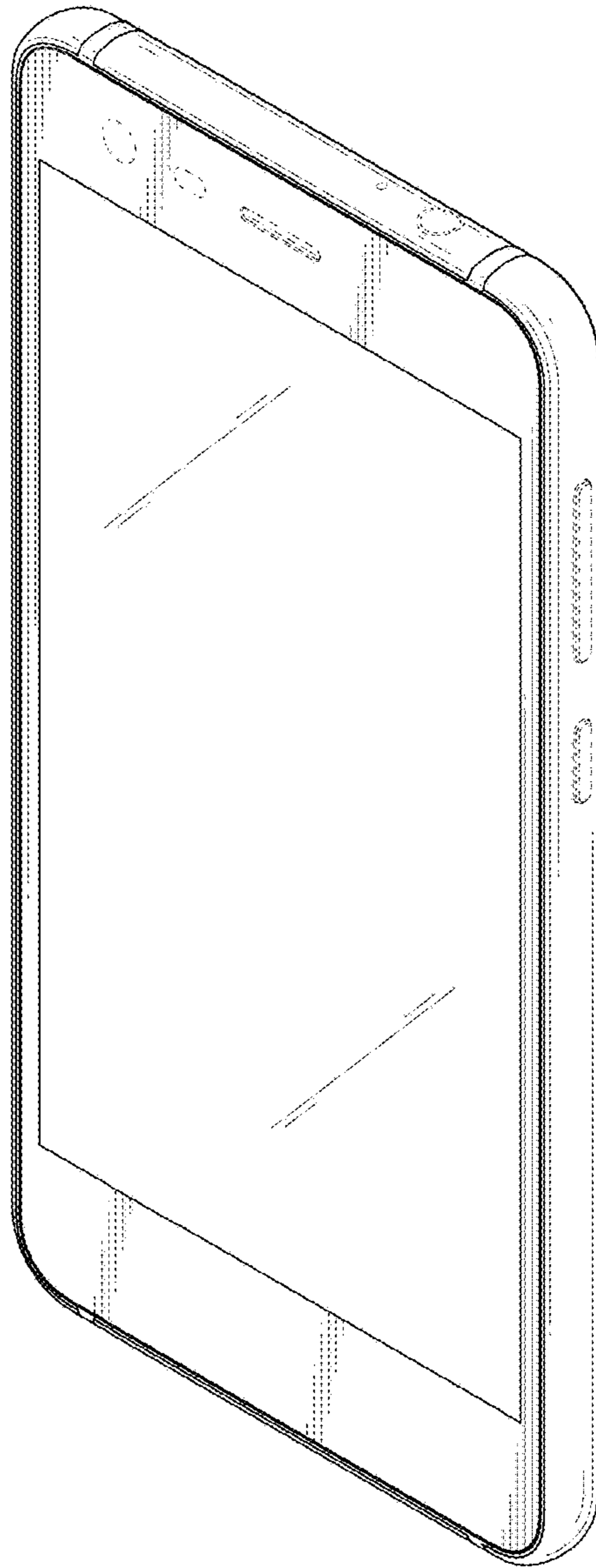

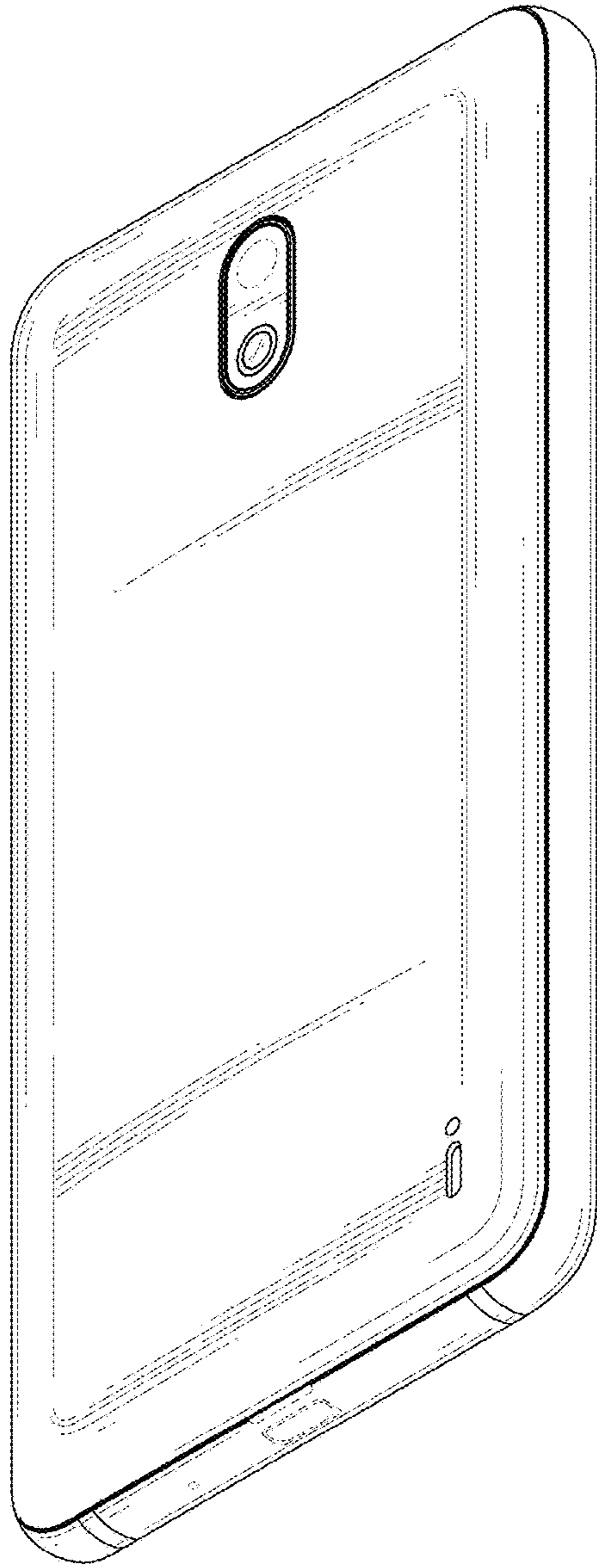

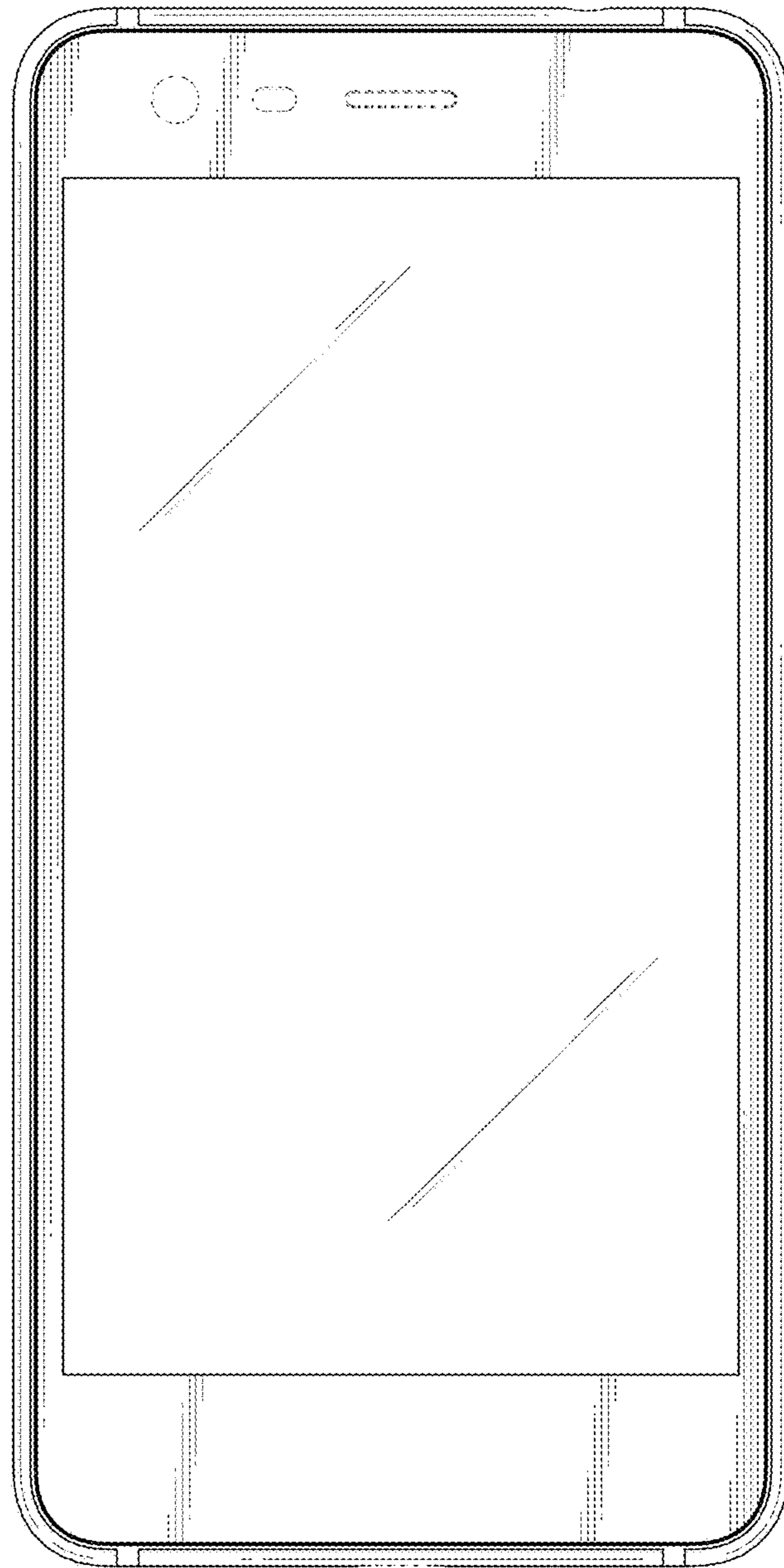

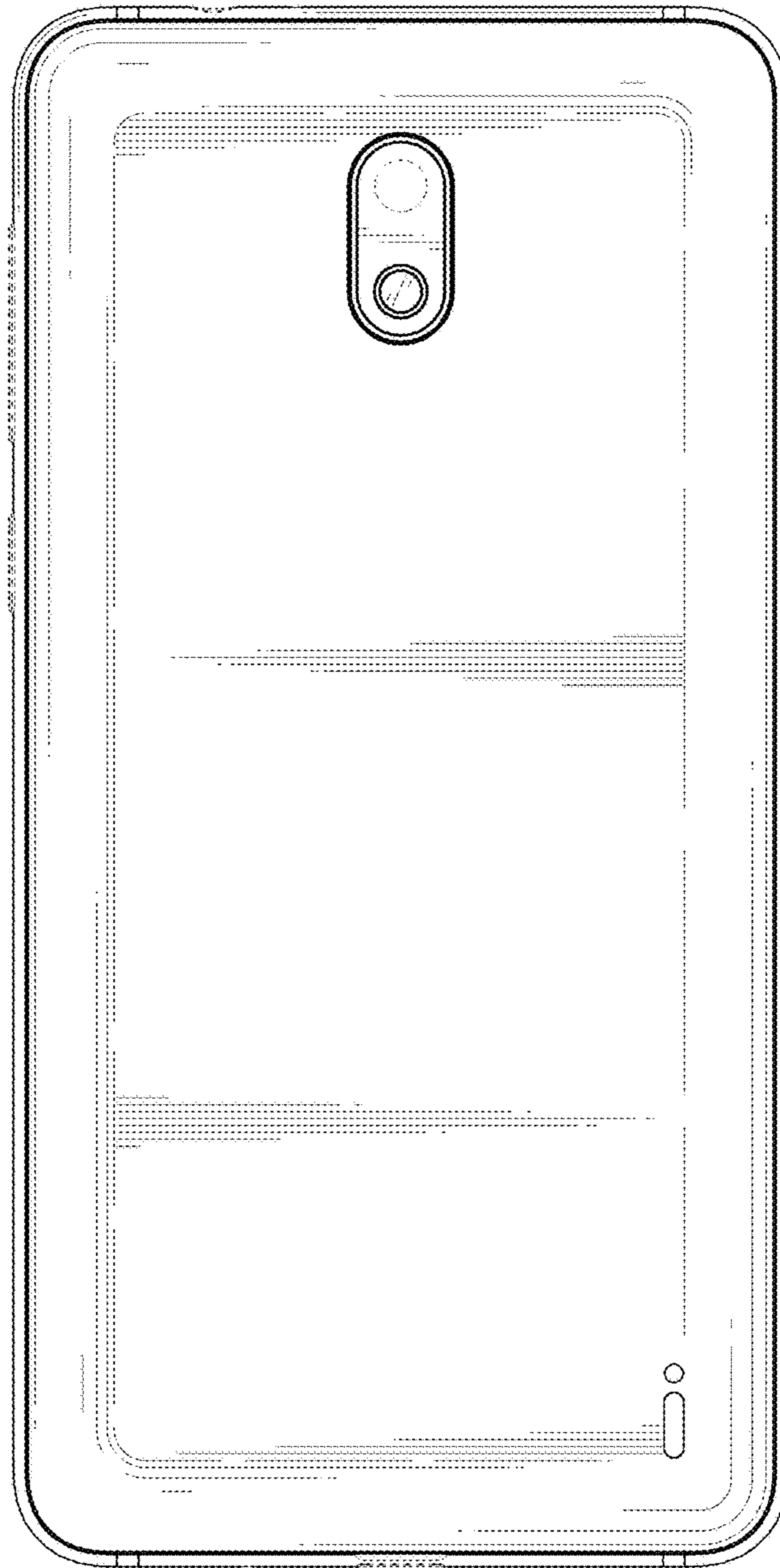

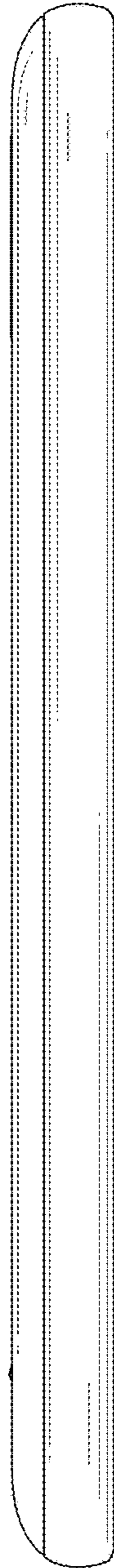

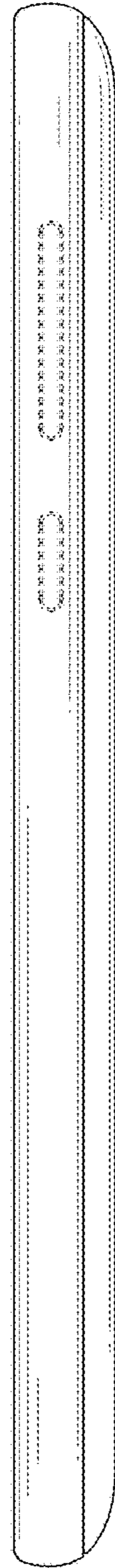

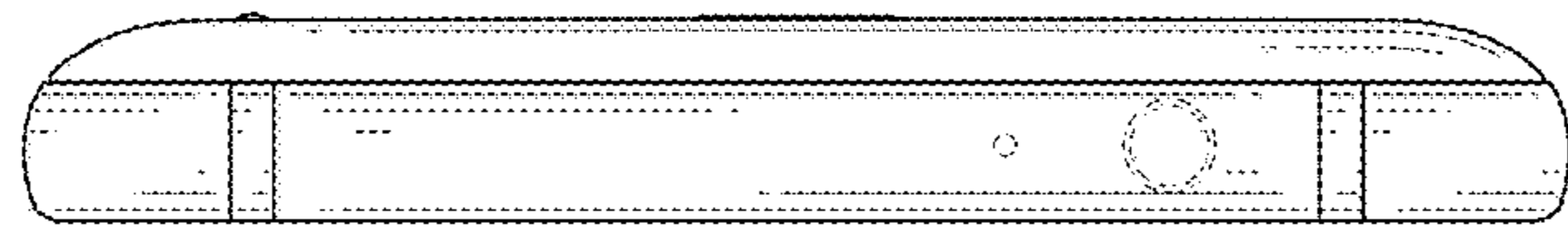

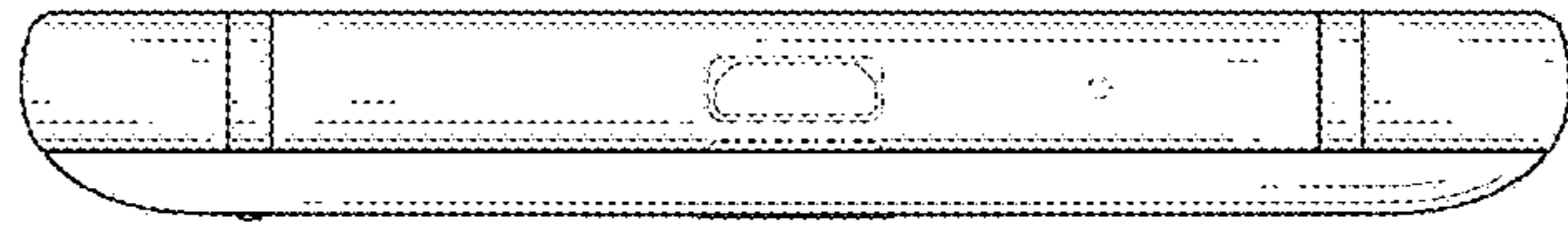
