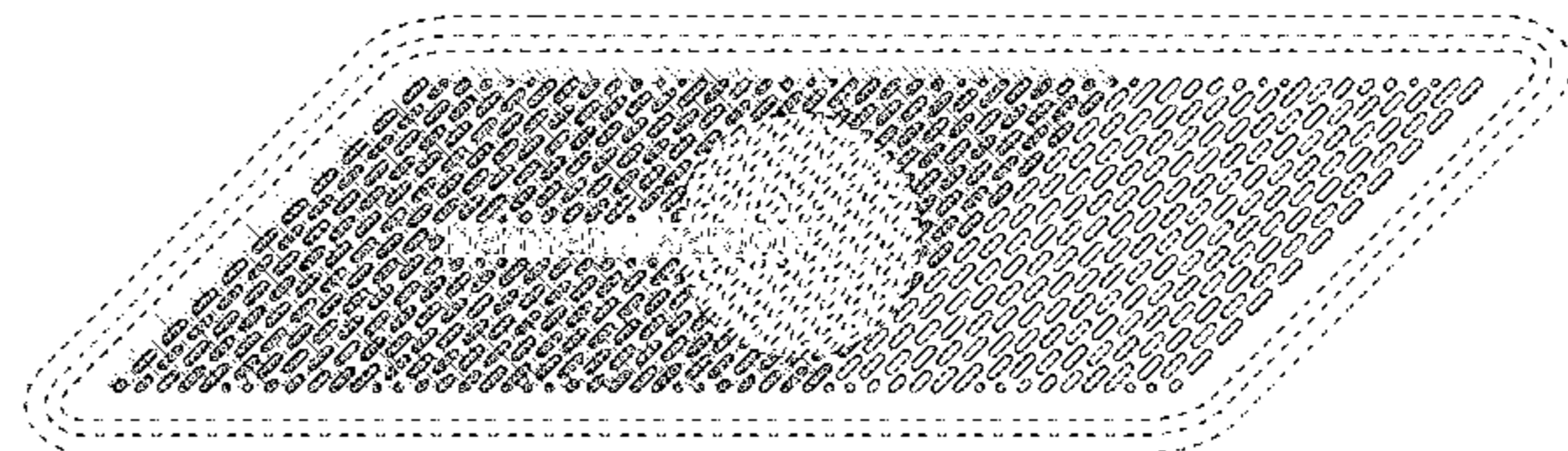
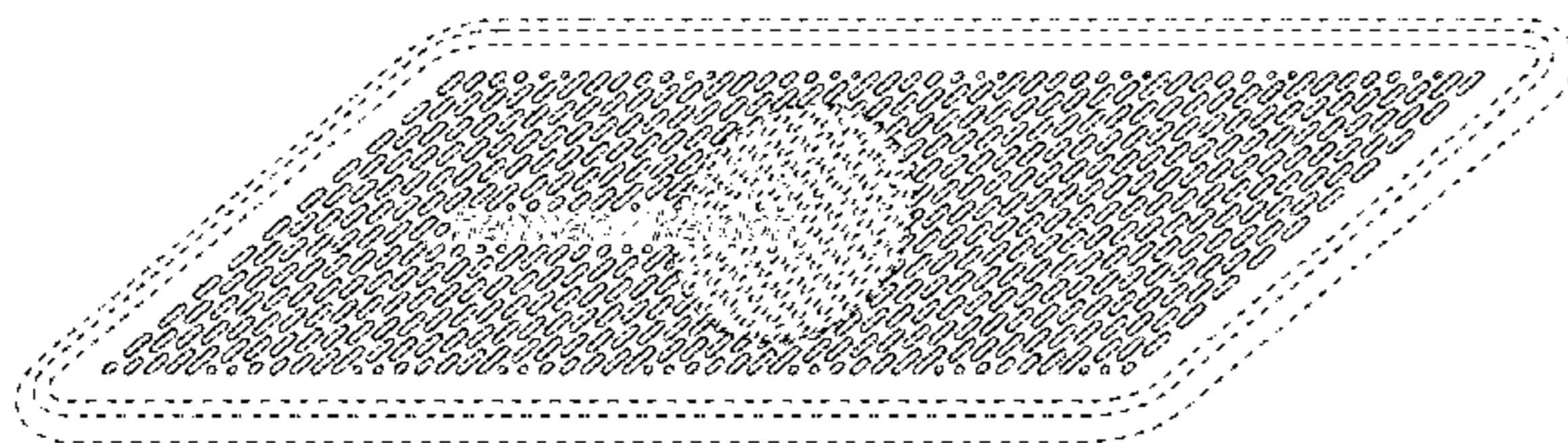
(57) **CLAIM**

The ornamental design for a speaker grille, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a speaker grille showing the new design in a first non-illuminated state; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a side elevational view thereof; FIG. 5 is an opposite side elevational view thereof; FIG. 6 is a top view thereof; FIG. 7 is a bottom view thereof; FIG. 8 is a front view of the speaker grille of FIGS. 1-7 showing the new design in a second partially illuminated state; FIG. 9 is a front view of the speaker grille of FIGS. 1-7 showing the new design in a third partially illuminated state; and, FIG. 10 is a front view of the speaker grille of FIGS. 1-7 showing the new design in a fourth fully illuminated state. The broken lines and unshaded areas form no part of the claimed design. The radiating lines and greyscale shading in FIGS. 8-10 depict an illuminated state of portions of the speaker grille.

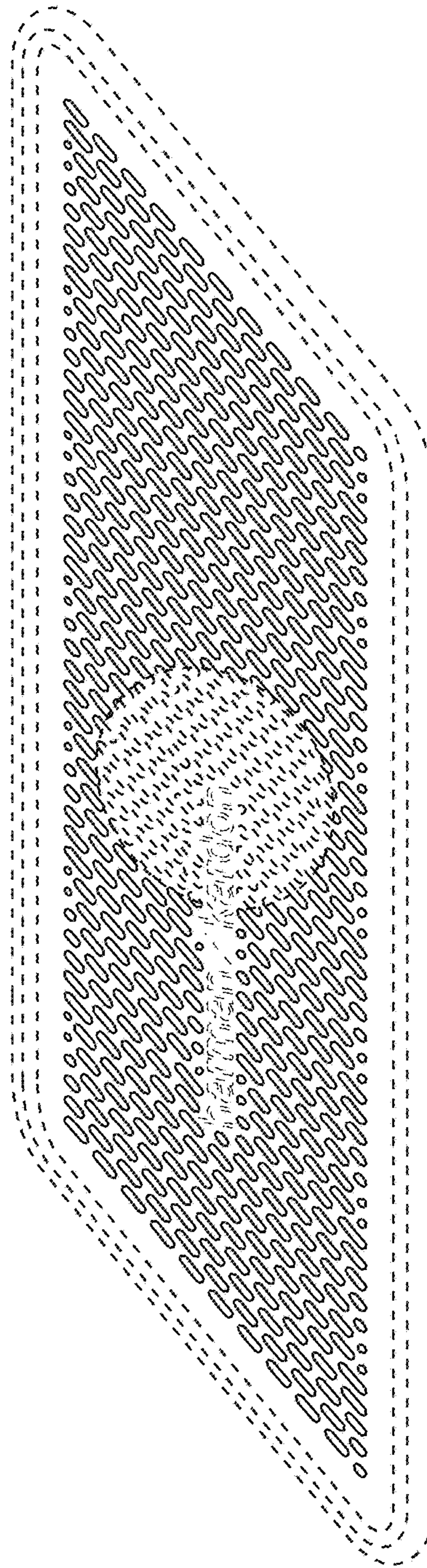

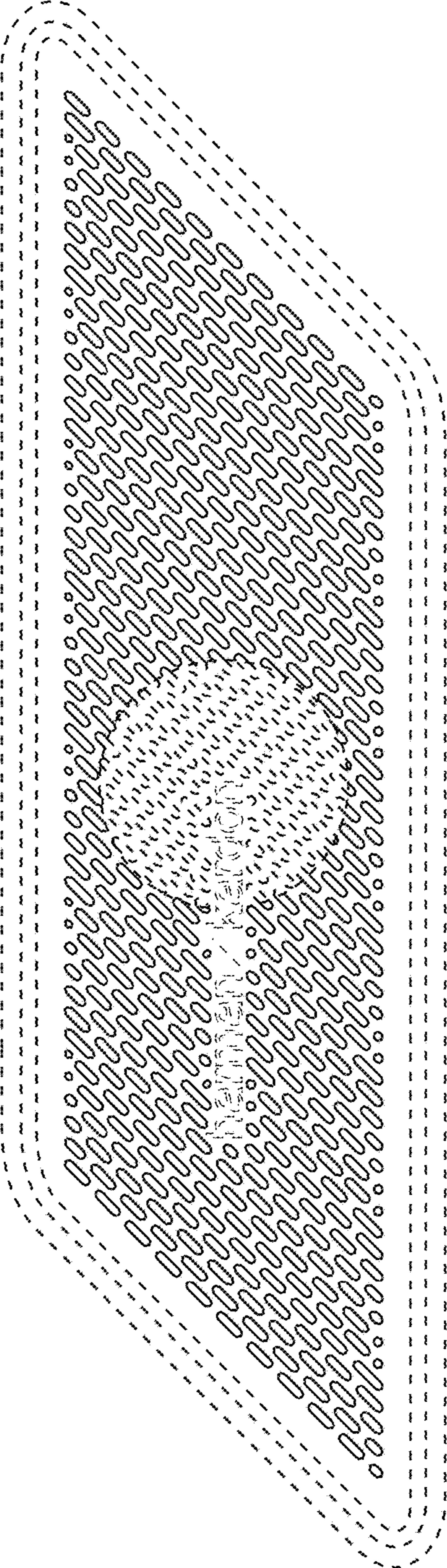

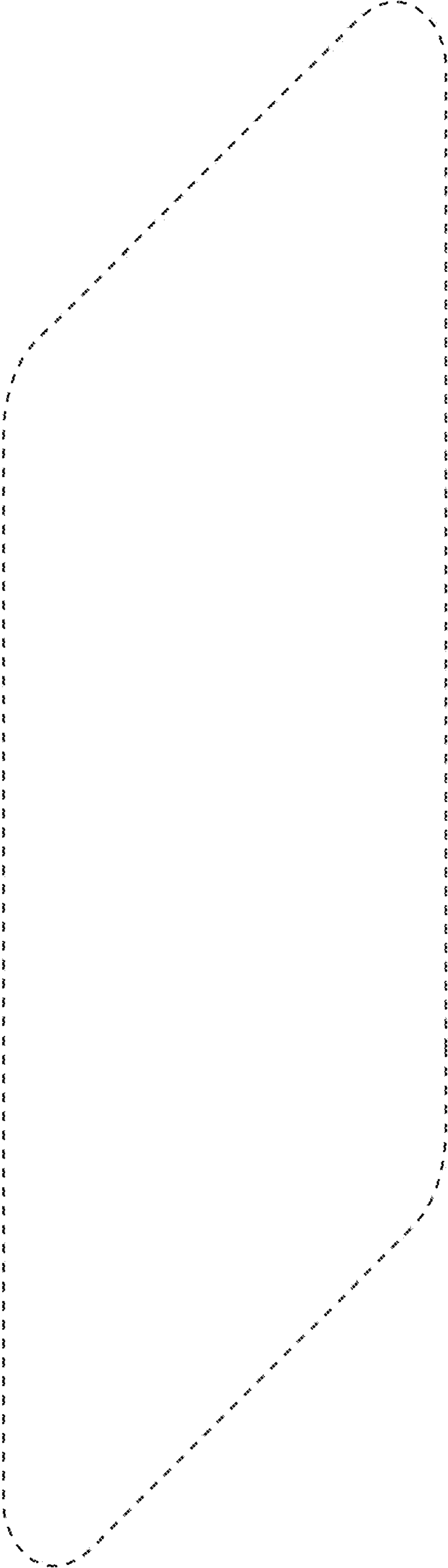

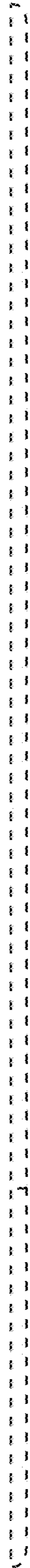

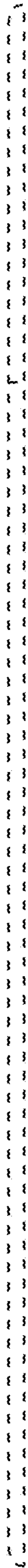

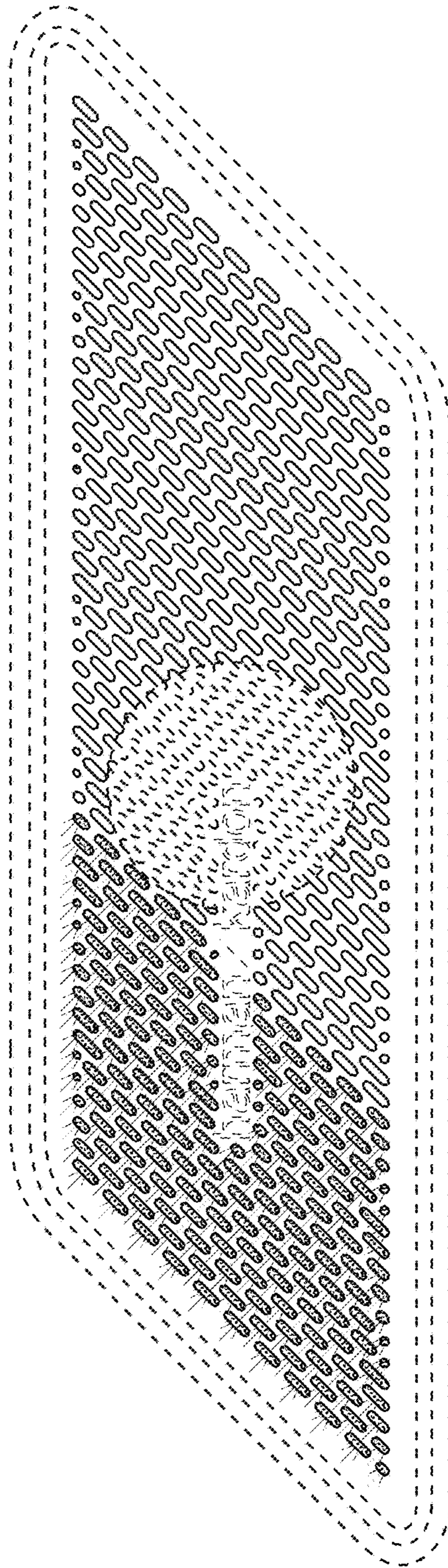

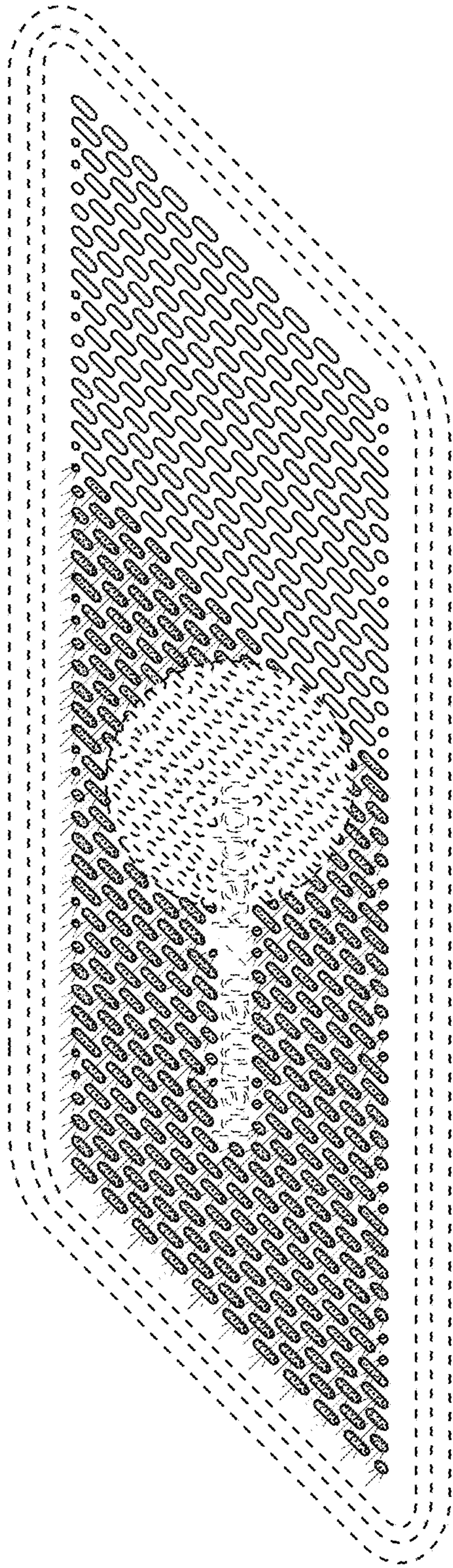




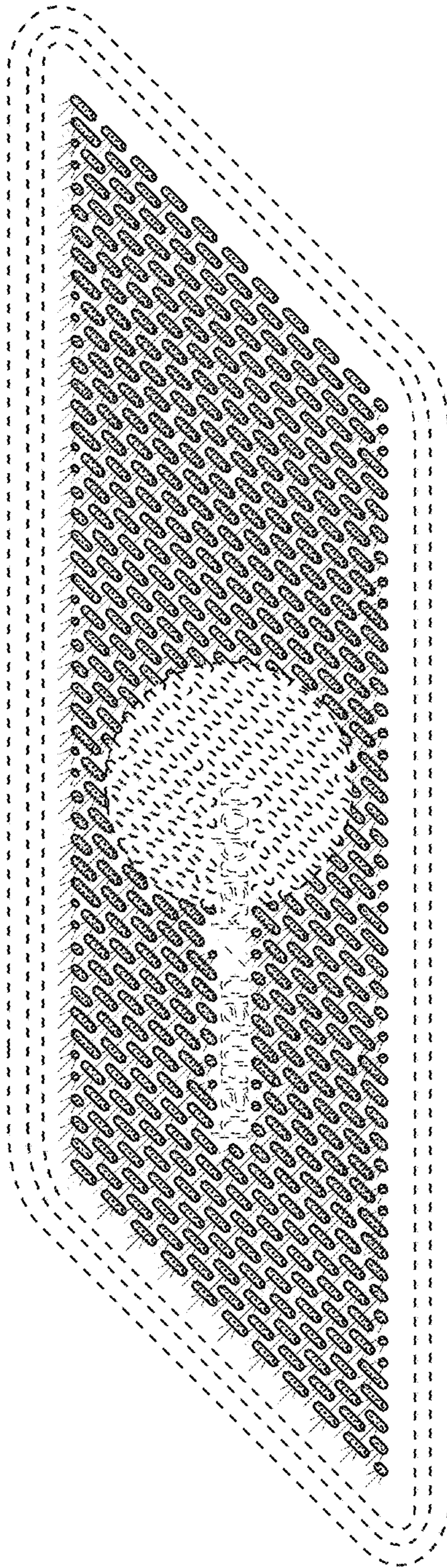
