The ornamental design for a compact multi-band antenna, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a first embodiment of a compact multi-band antenna showing the new design; and, FIG. 2 is a top plan view of a second embodiment thereof. The black areas comprise the entirety of the claimed design. All elements of the claimed design are flat and coplanar. The broken line showing of a circuit board forms no part of the claimed design.

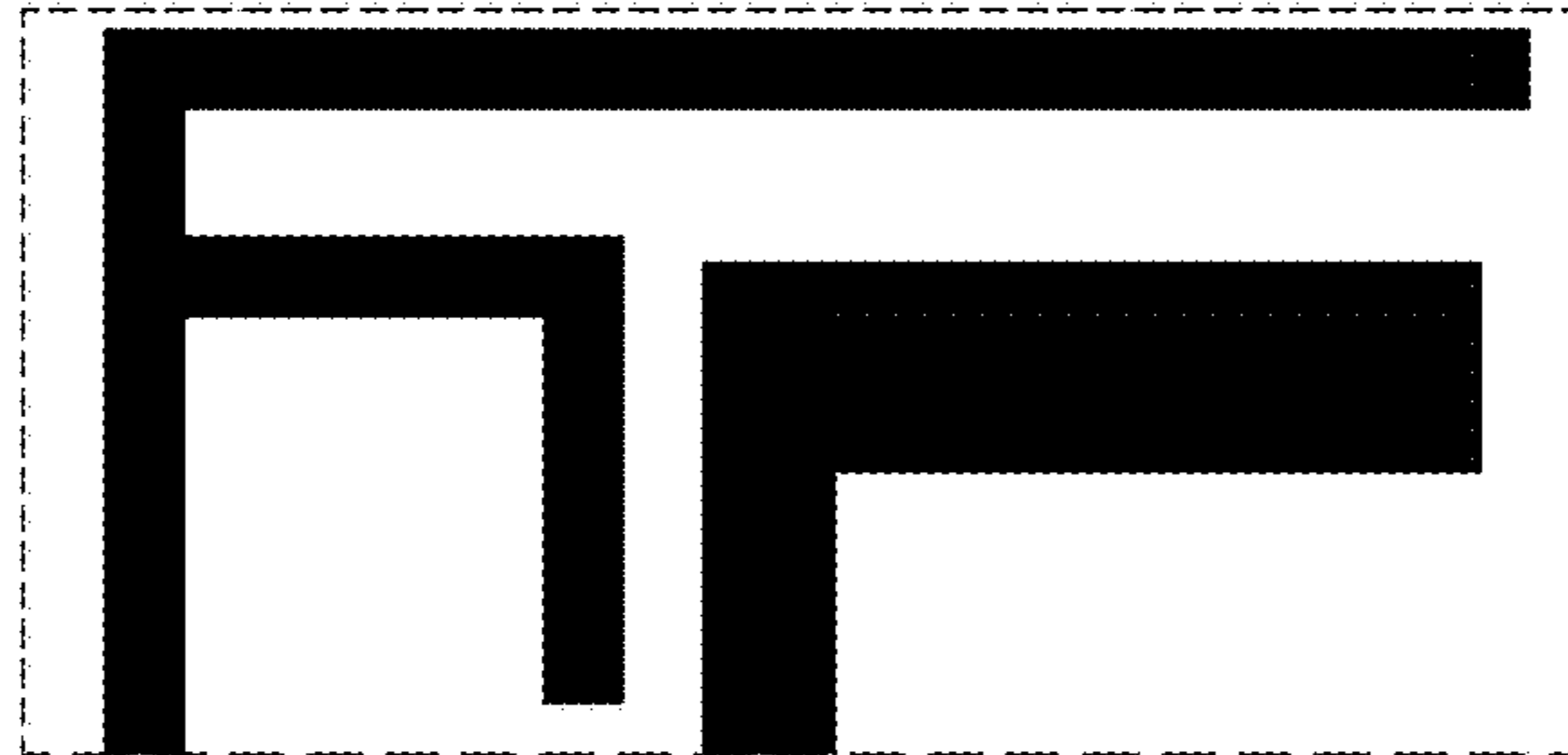
