DESCRIPTION

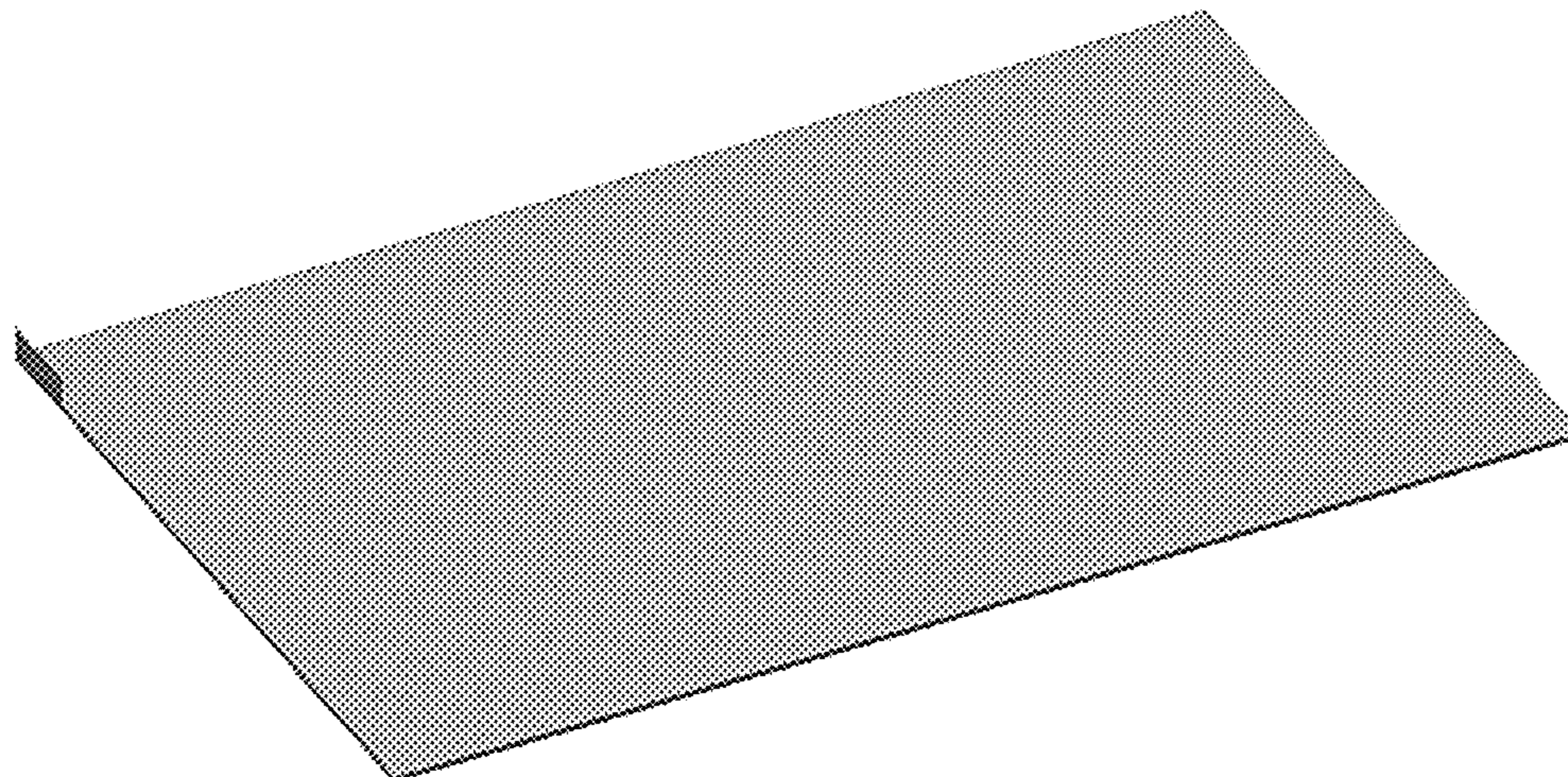

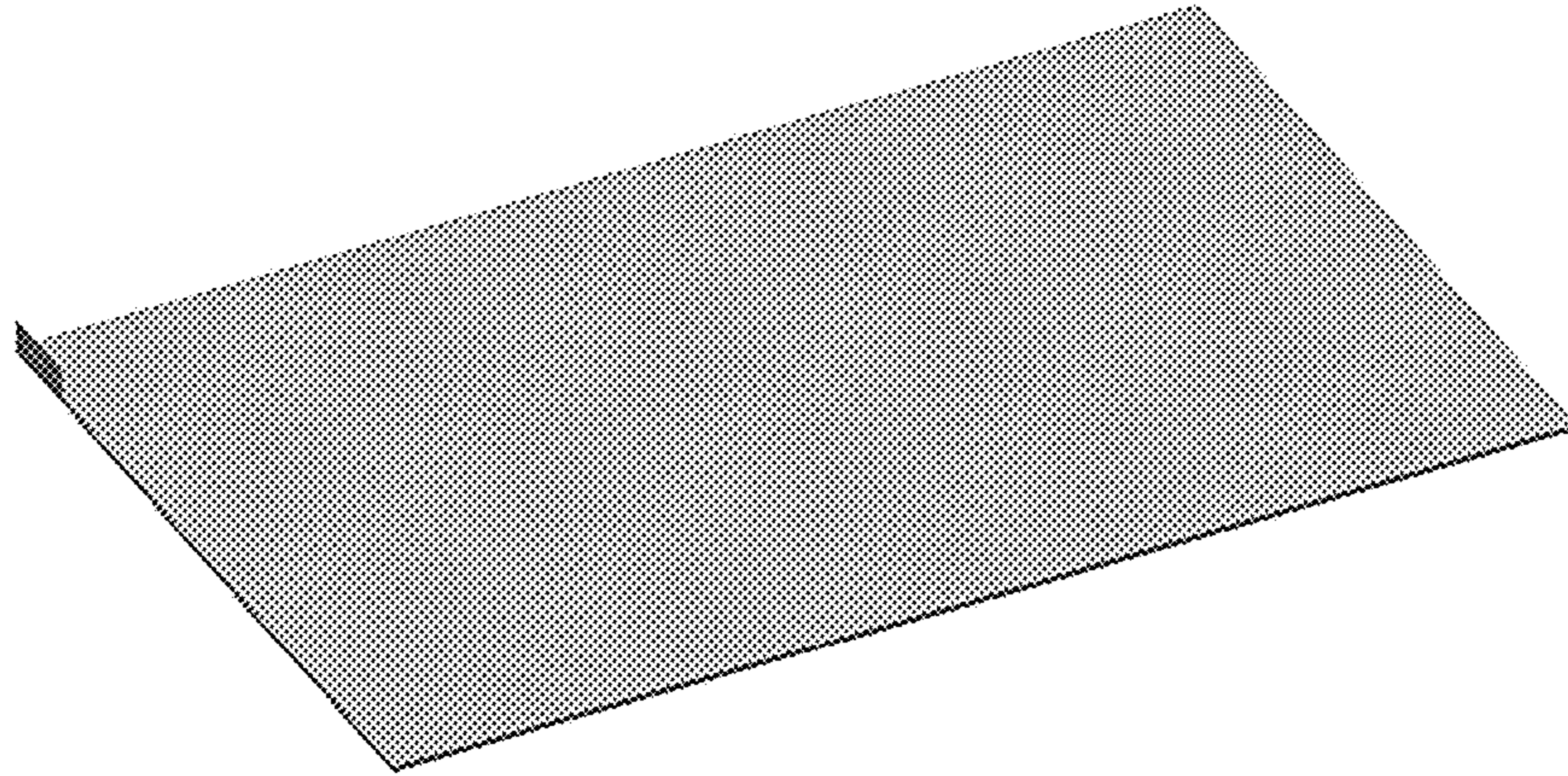

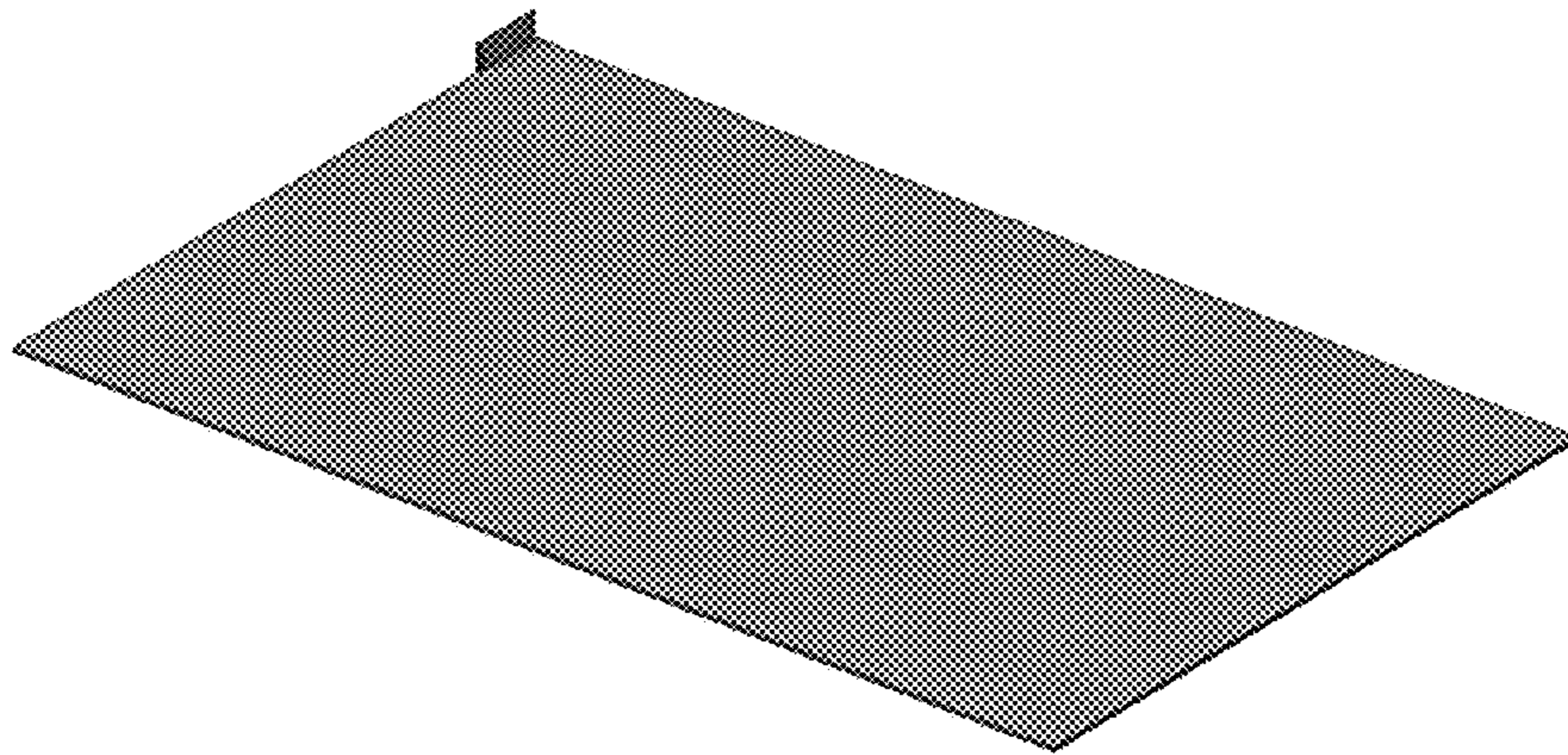

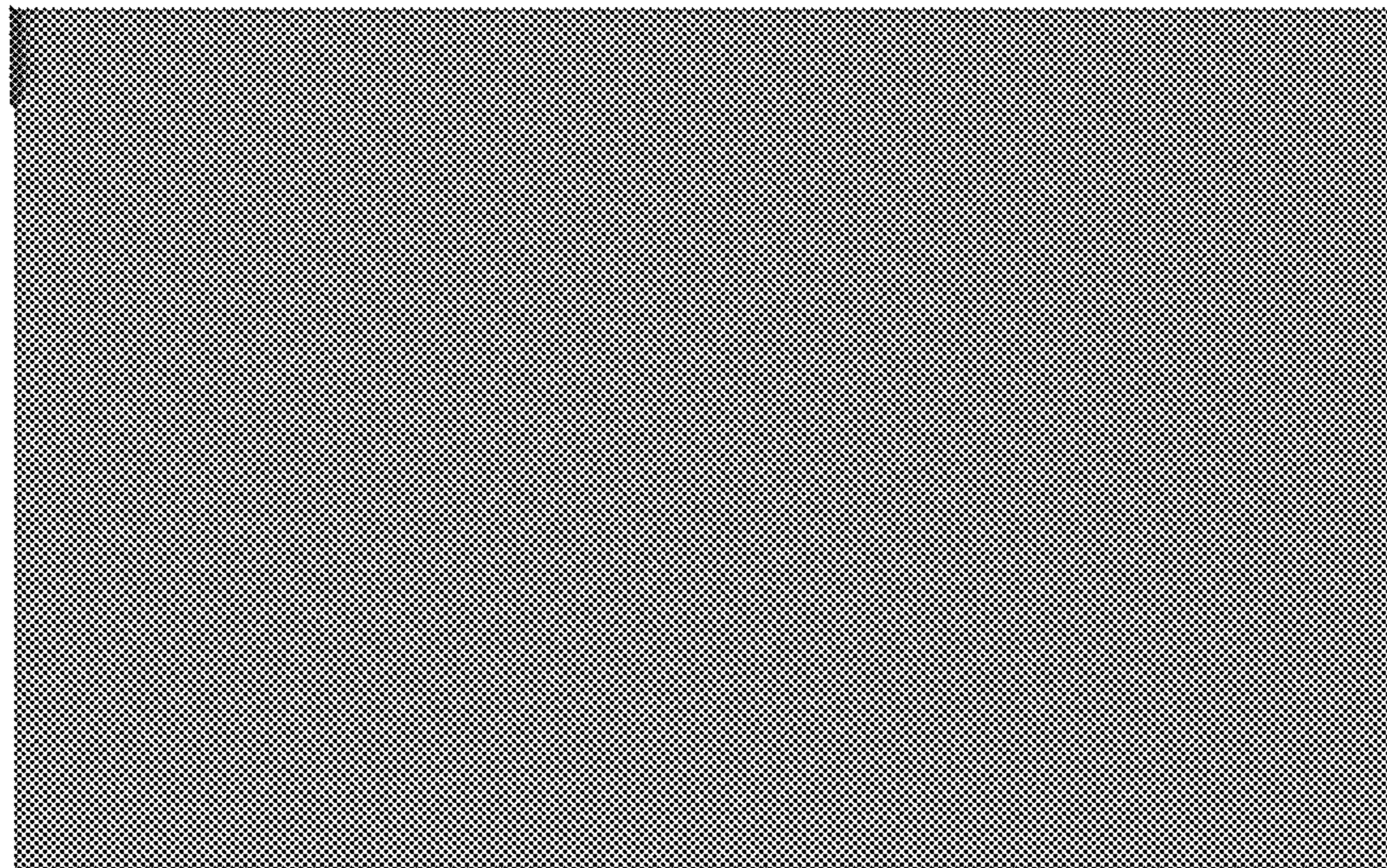

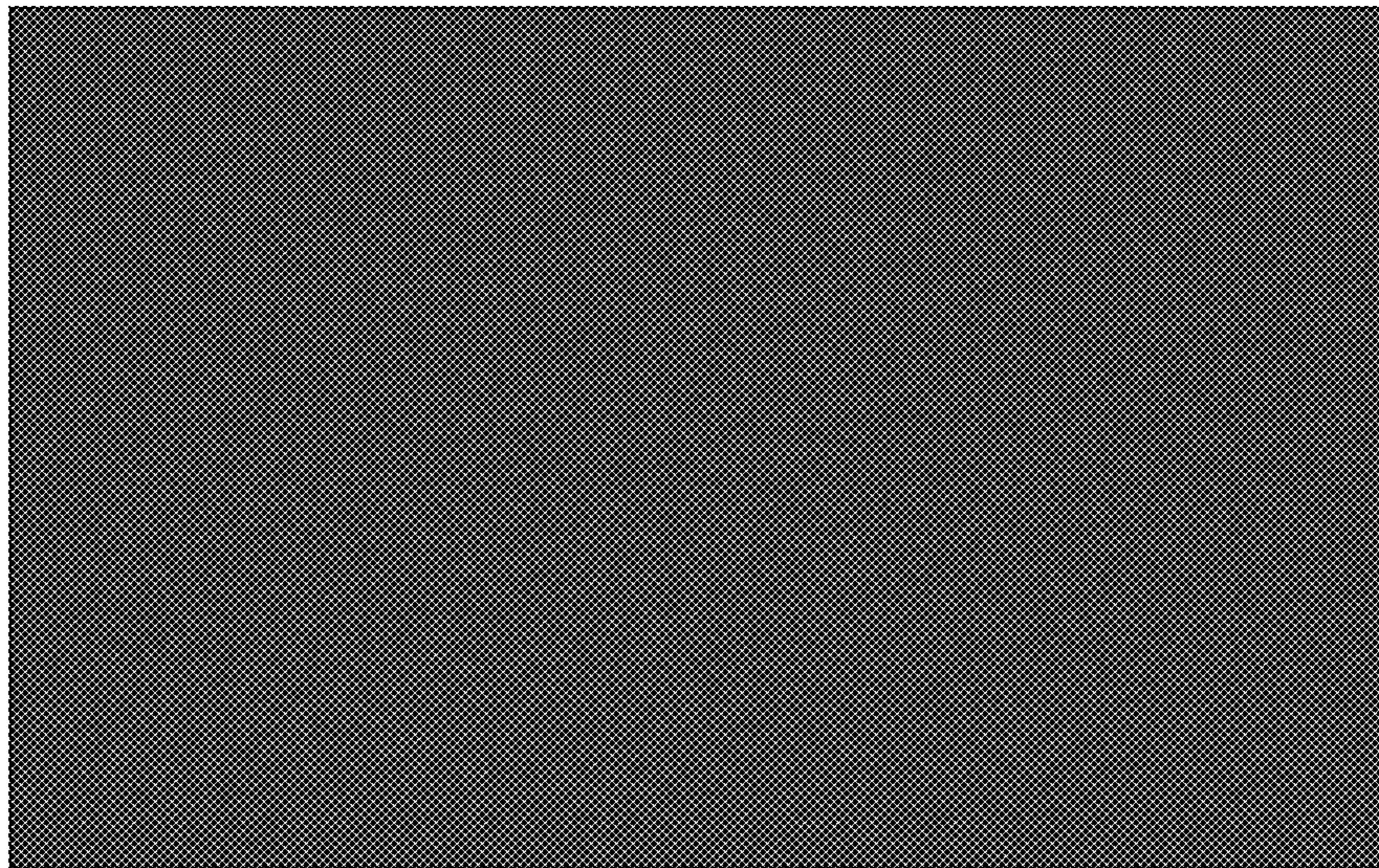
