(57) **CLAIM**

The ornamental design for a weighted skirt for a soft fishing lure, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the weighted skirt for a soft fishing lure;

FIG. 2 is a front elevation view, with the rear view being a mirror image thereof;

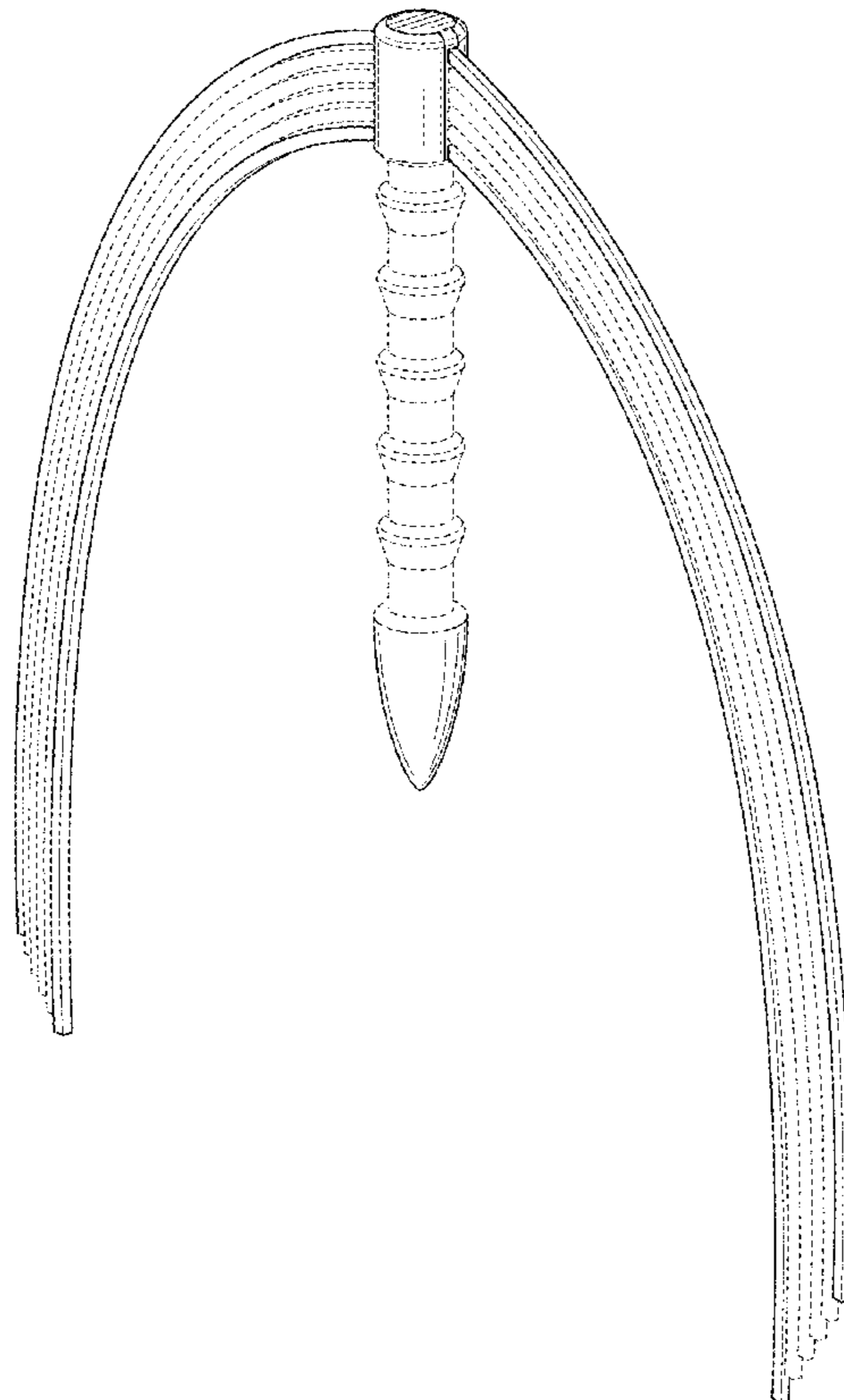
FIG. 3 is a side elevation view, with the opposite side being a mirror image thereof;

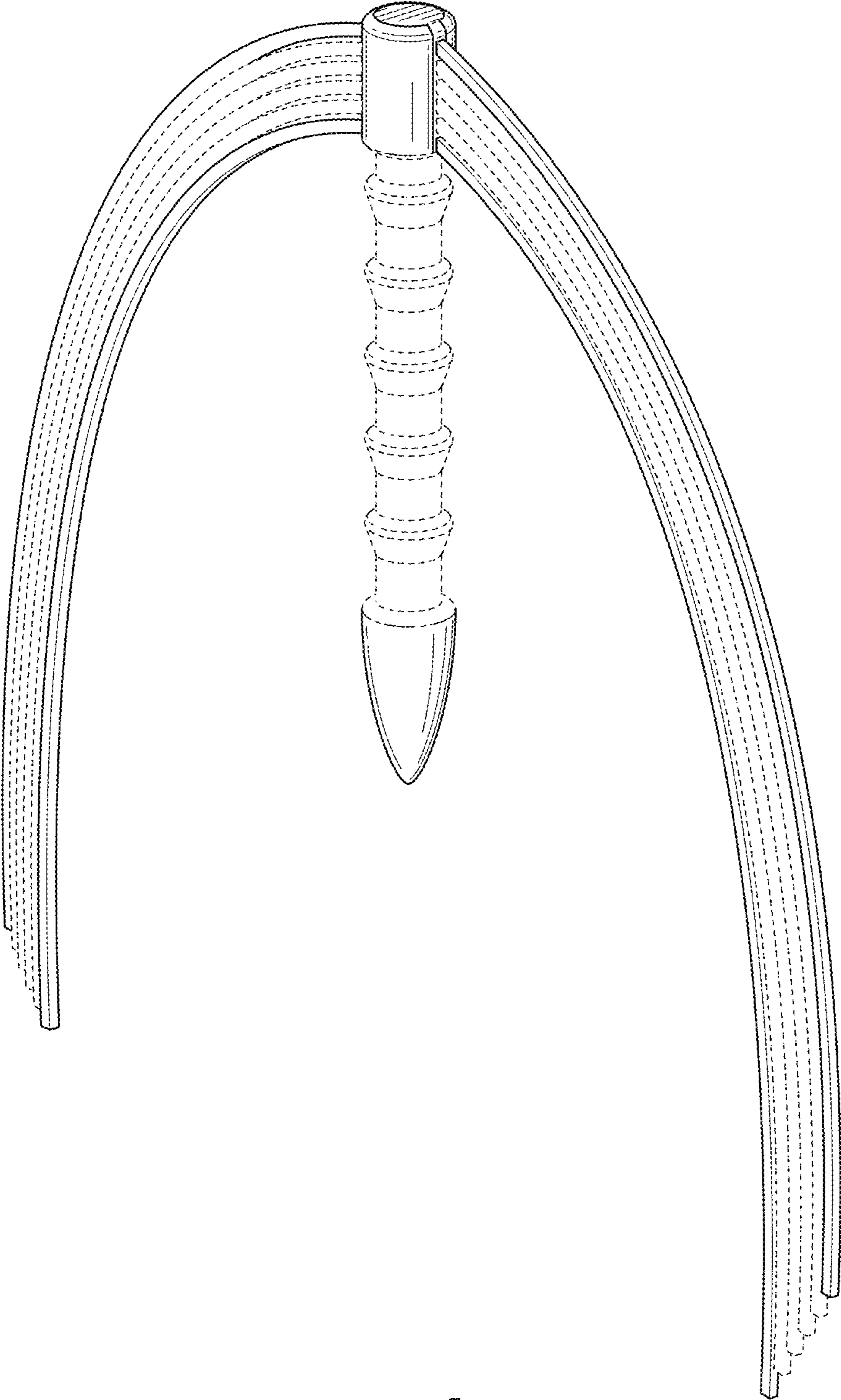
FIG. 4 is a top view of the weighted skirt illustrated in FIG. 1; and,

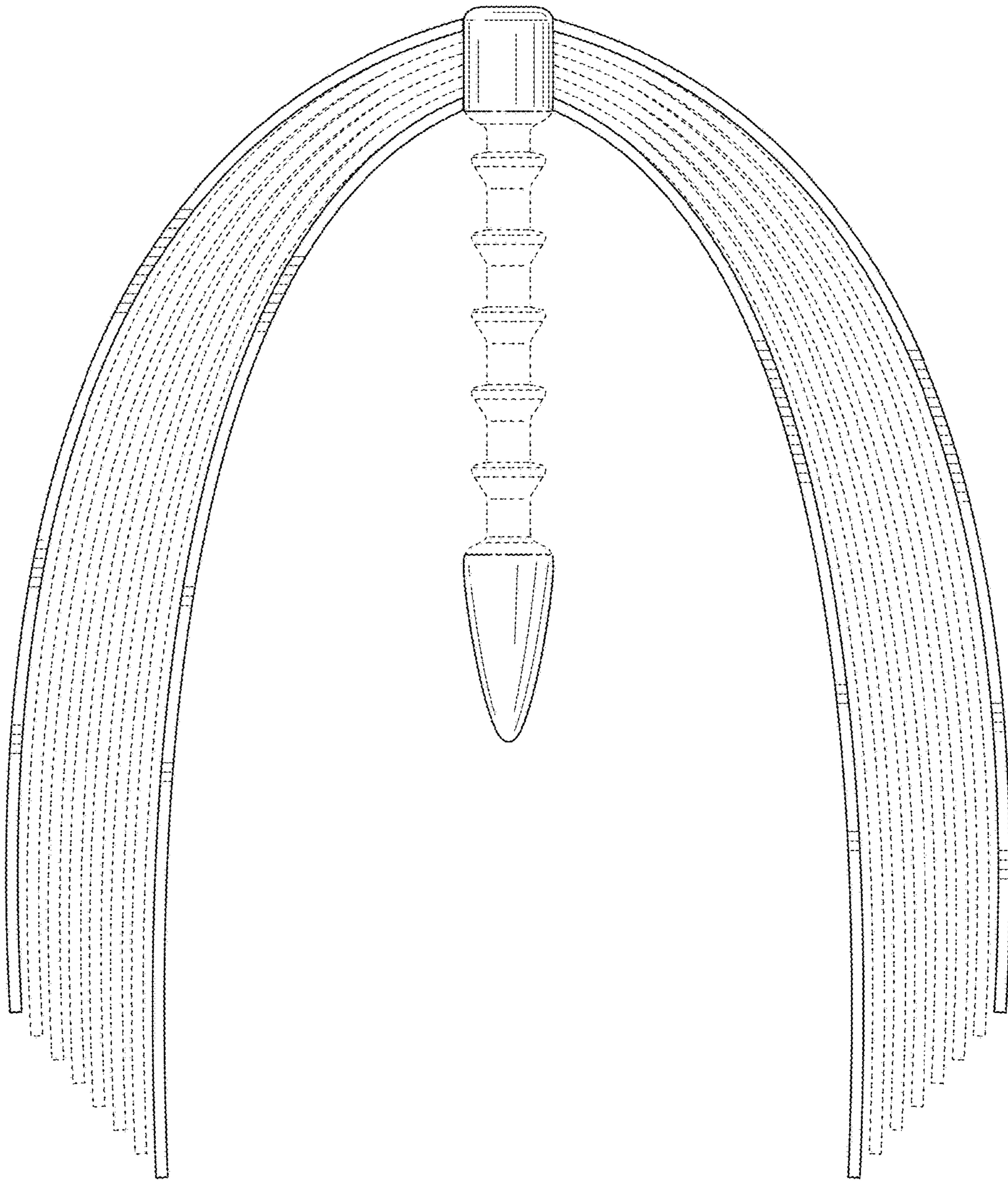
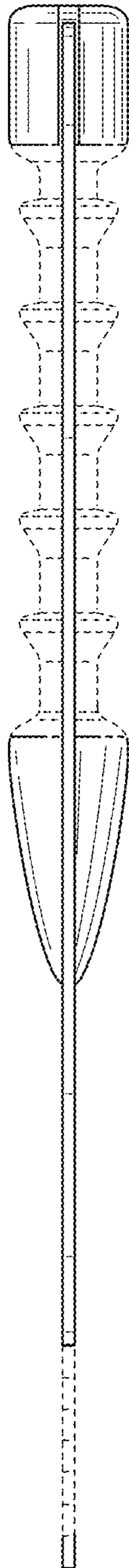

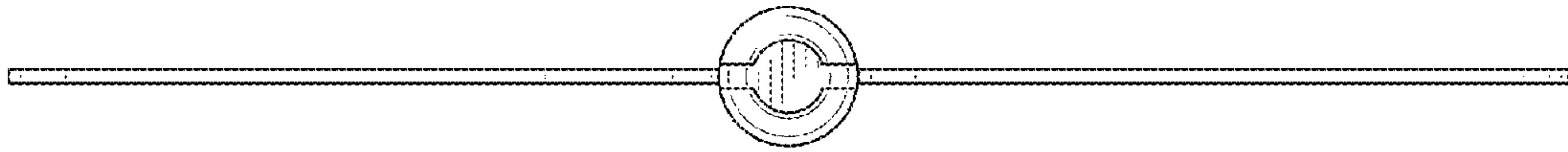

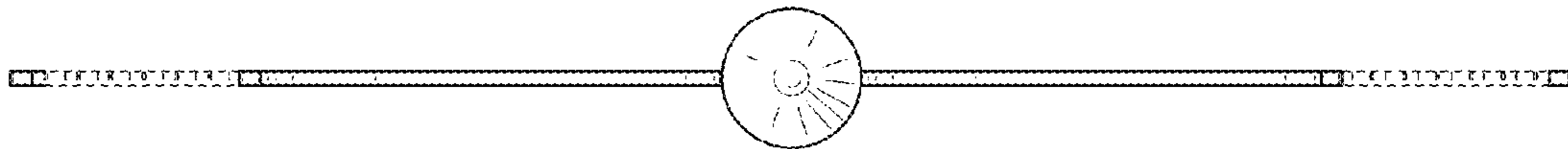
