FIG. 8 is a cross-sectional front elevation view of the pressed shredded potato product of FIG. 1, taken on the line 8-8 in FIG. 1.

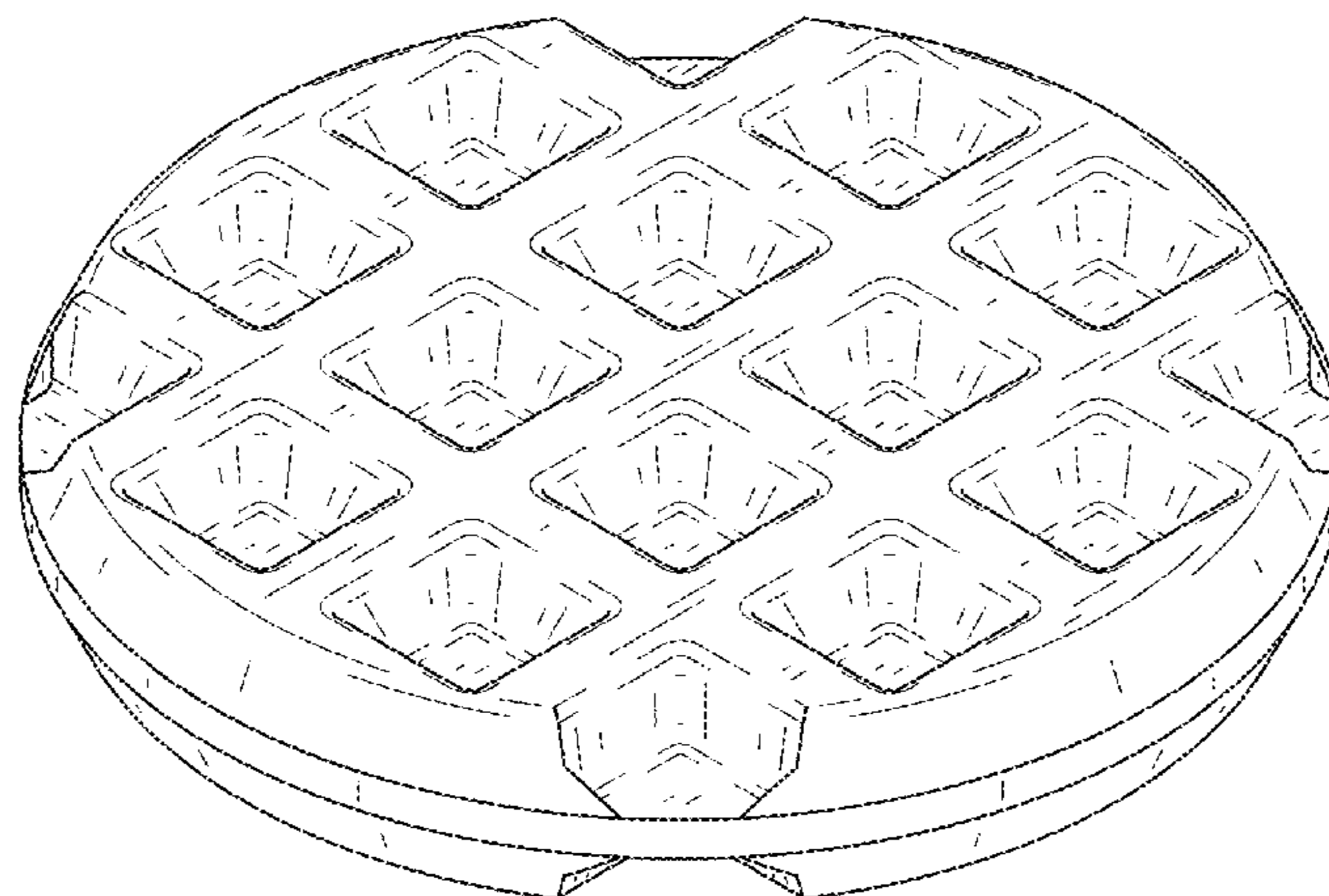
Portions of FIGS. 1 through 8 are shown in cross-sectional hatching illustrating portions of the article that form no part of the claimed design.

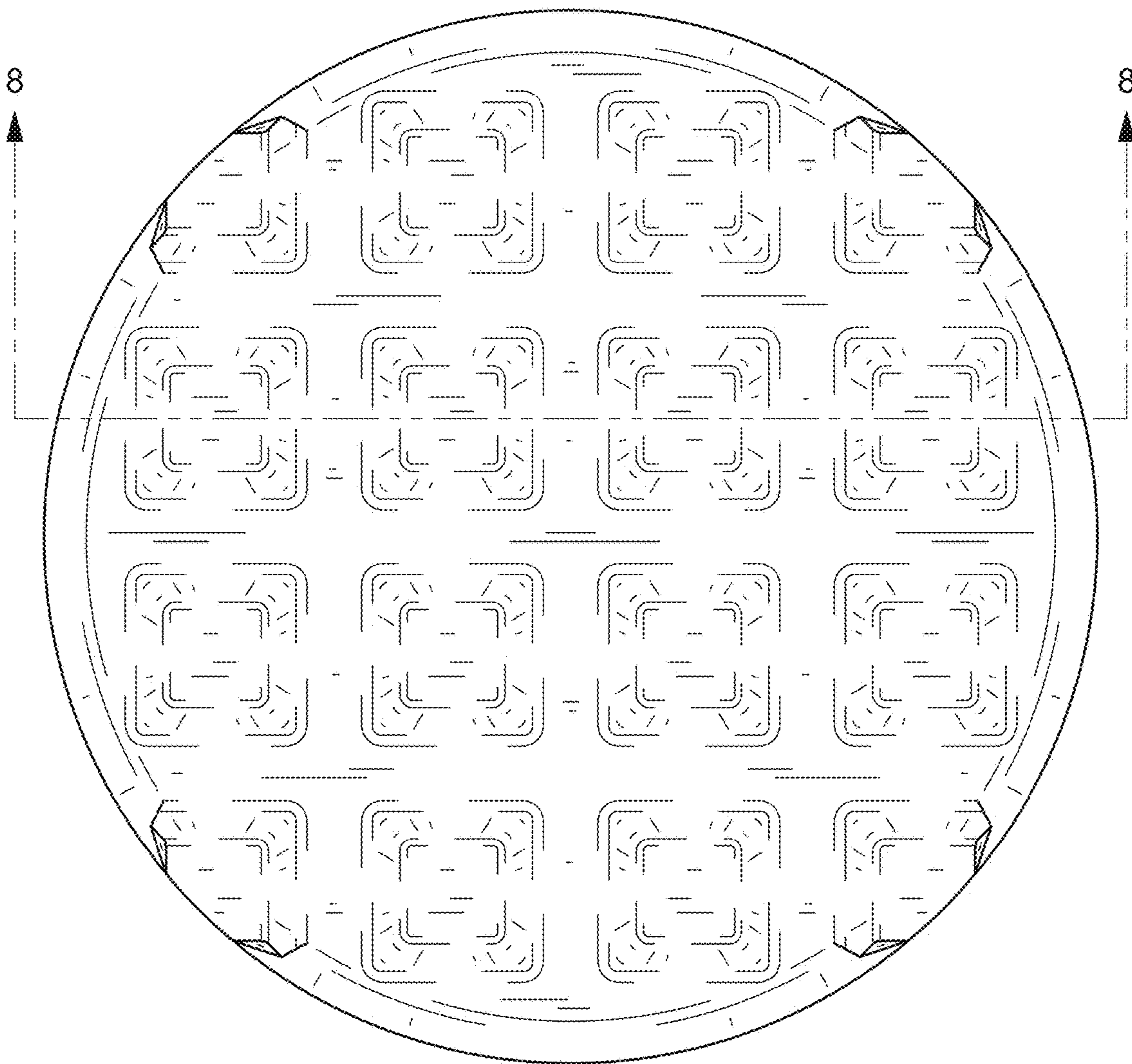

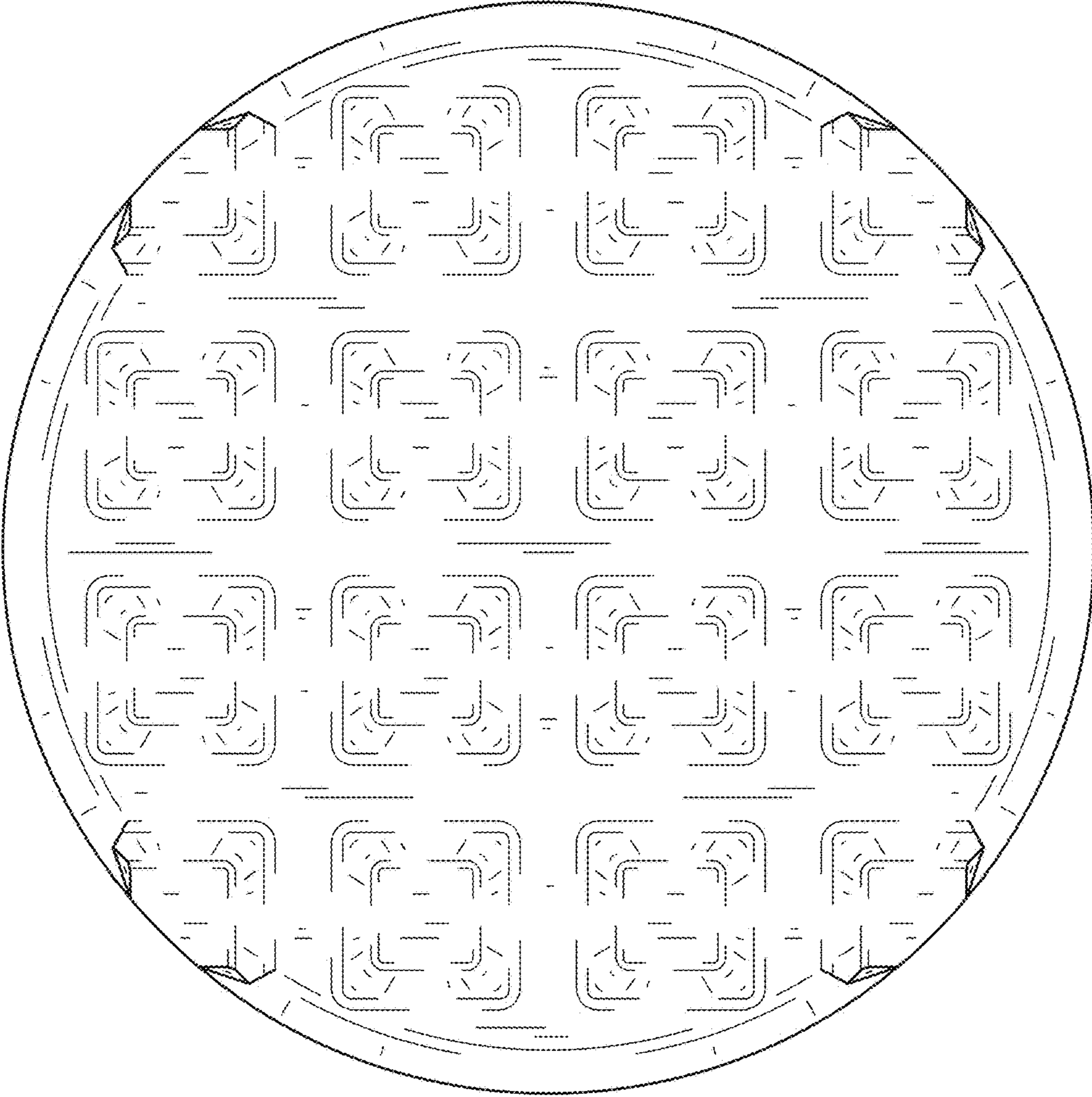

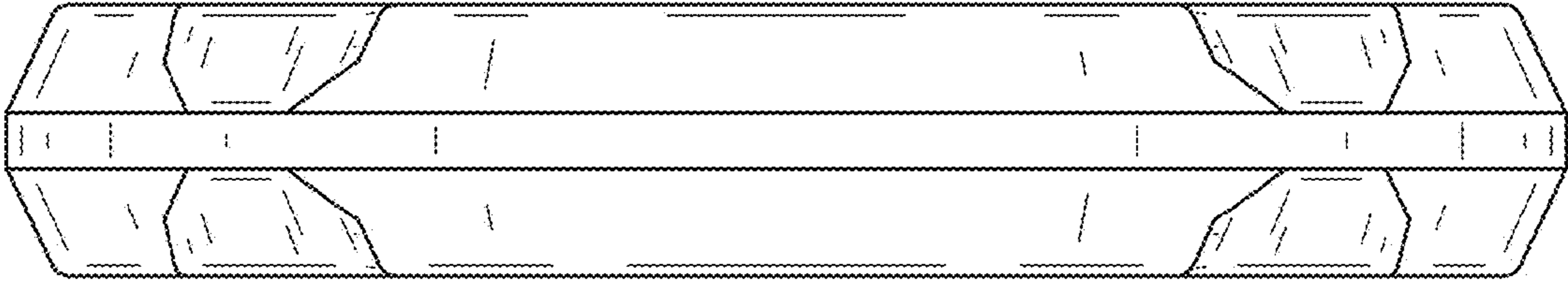

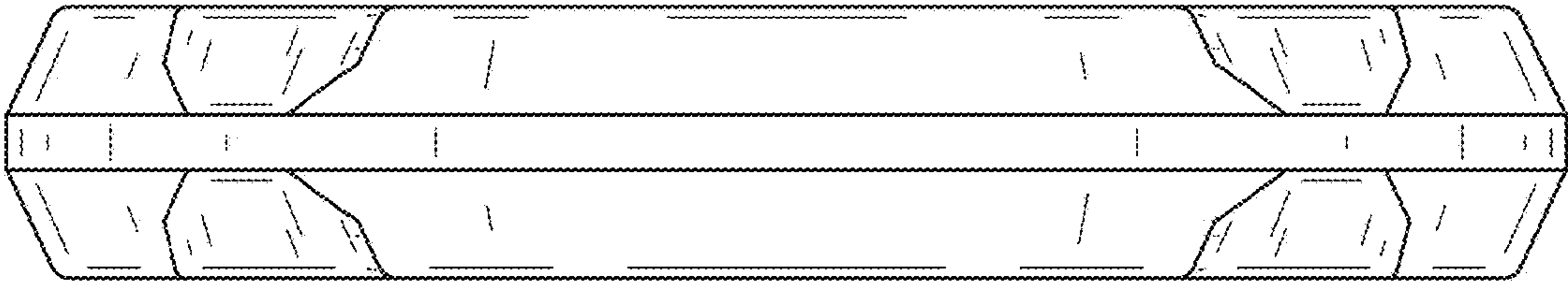

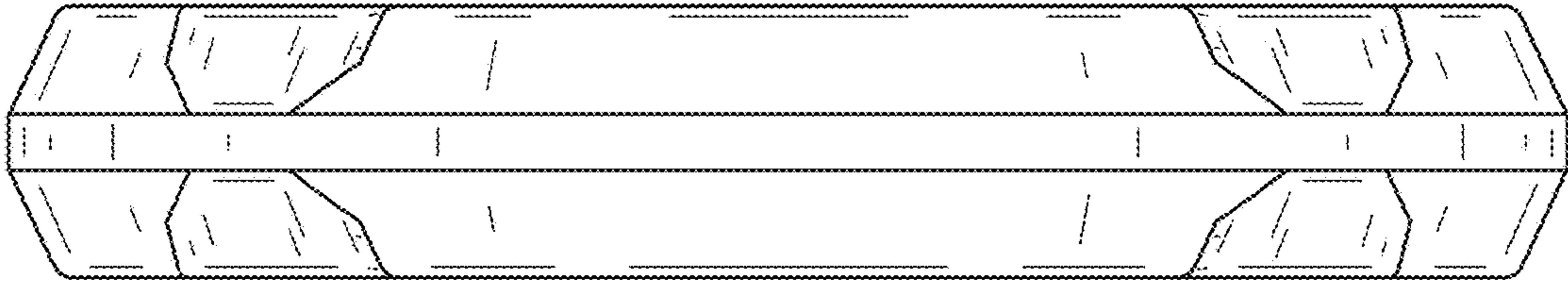

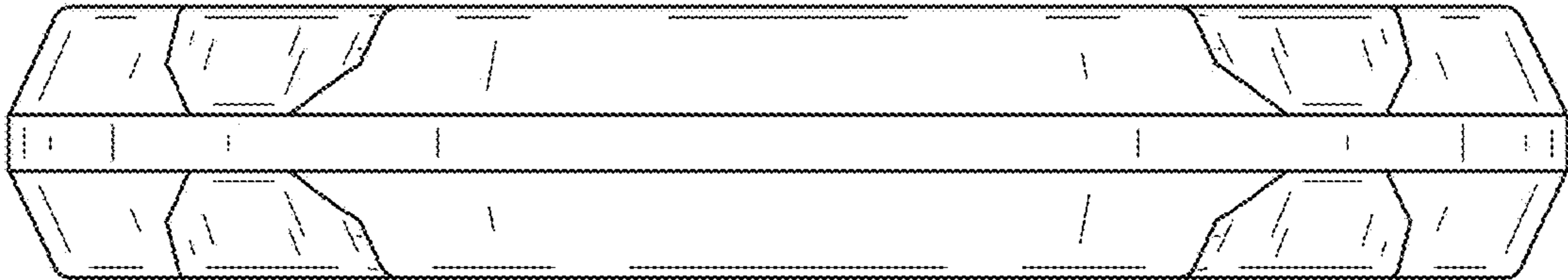

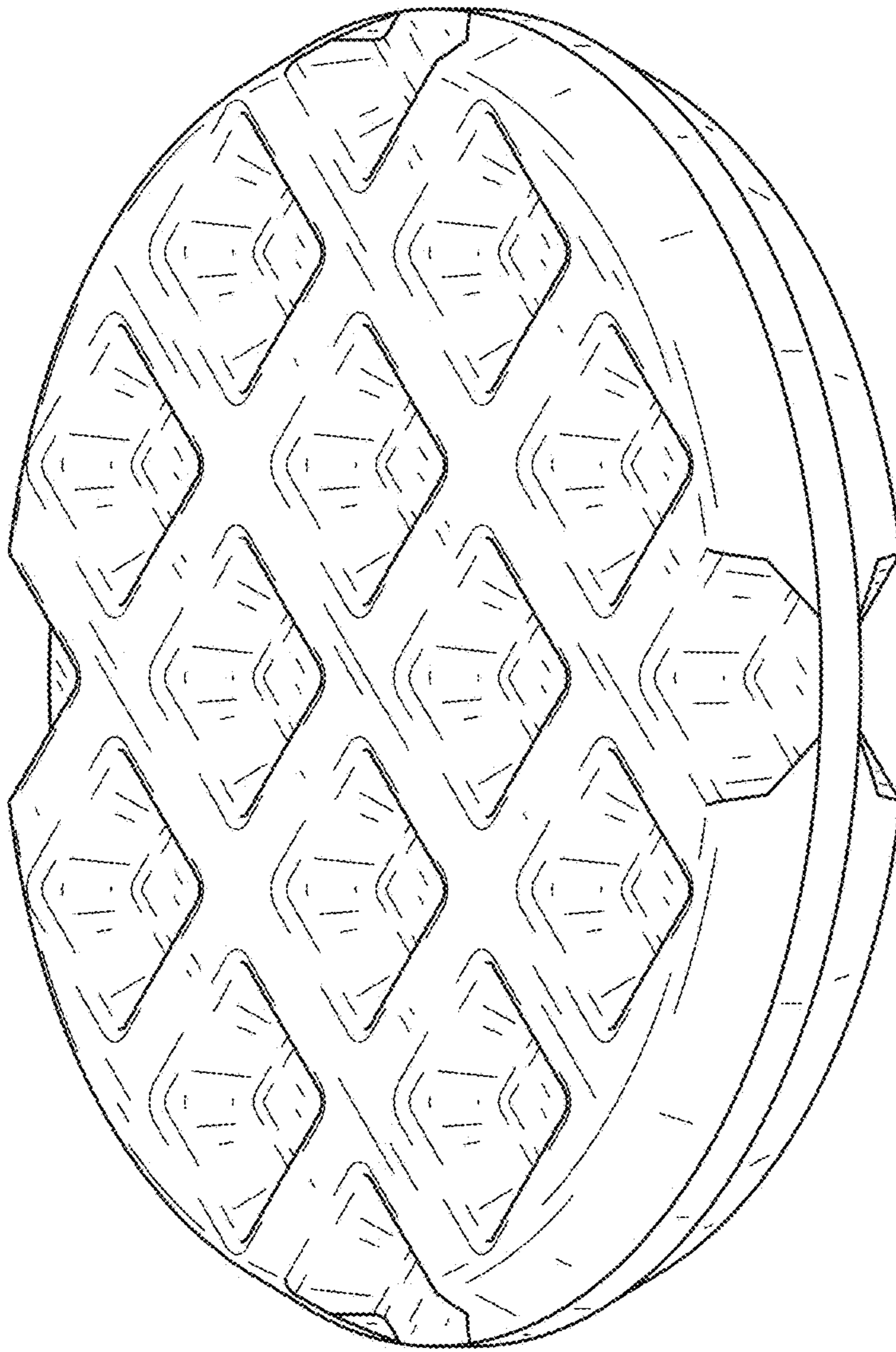

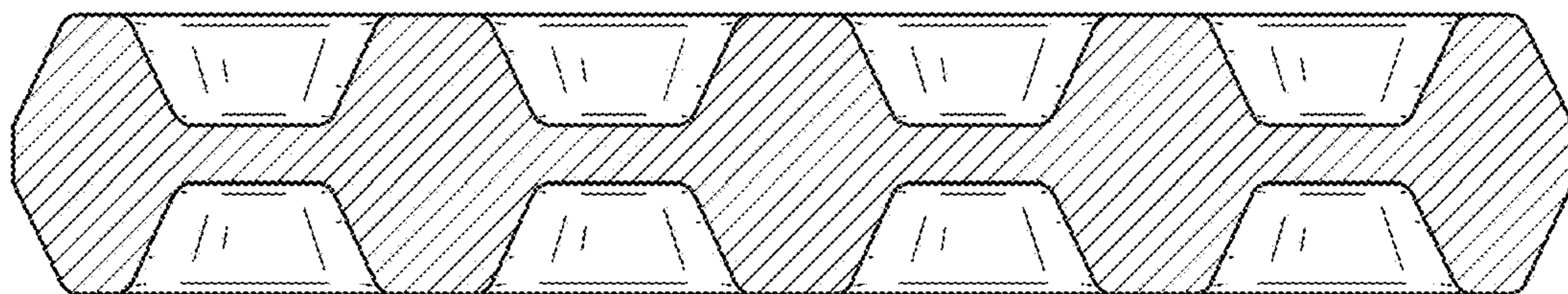
