FIG. 1 is a front view of pants according to the design; FIG. 2 is a rear view thereof; FIG. 3 is a right side view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a front perspective view thereof; FIG. 6 is a rear perspective view thereof; and, FIG. 7 is a rear view thereof shown in an environment of use. The portions of the pants shown in broken lines in FIGS. 1-7 do not form part of the claimed design. The broken line showing of the feet, arms, and torso in FIG. 7 is for the purpose of illustrating portions of the environmental structure and forms no part of the claimed design. The solid lines shown in FIGS. 1-7 illustrate the claimed design and also represent the boundary of the claimed design, that is, the portions of the surface of the pants adjacent to the solid lines do not form part of the claimed design.

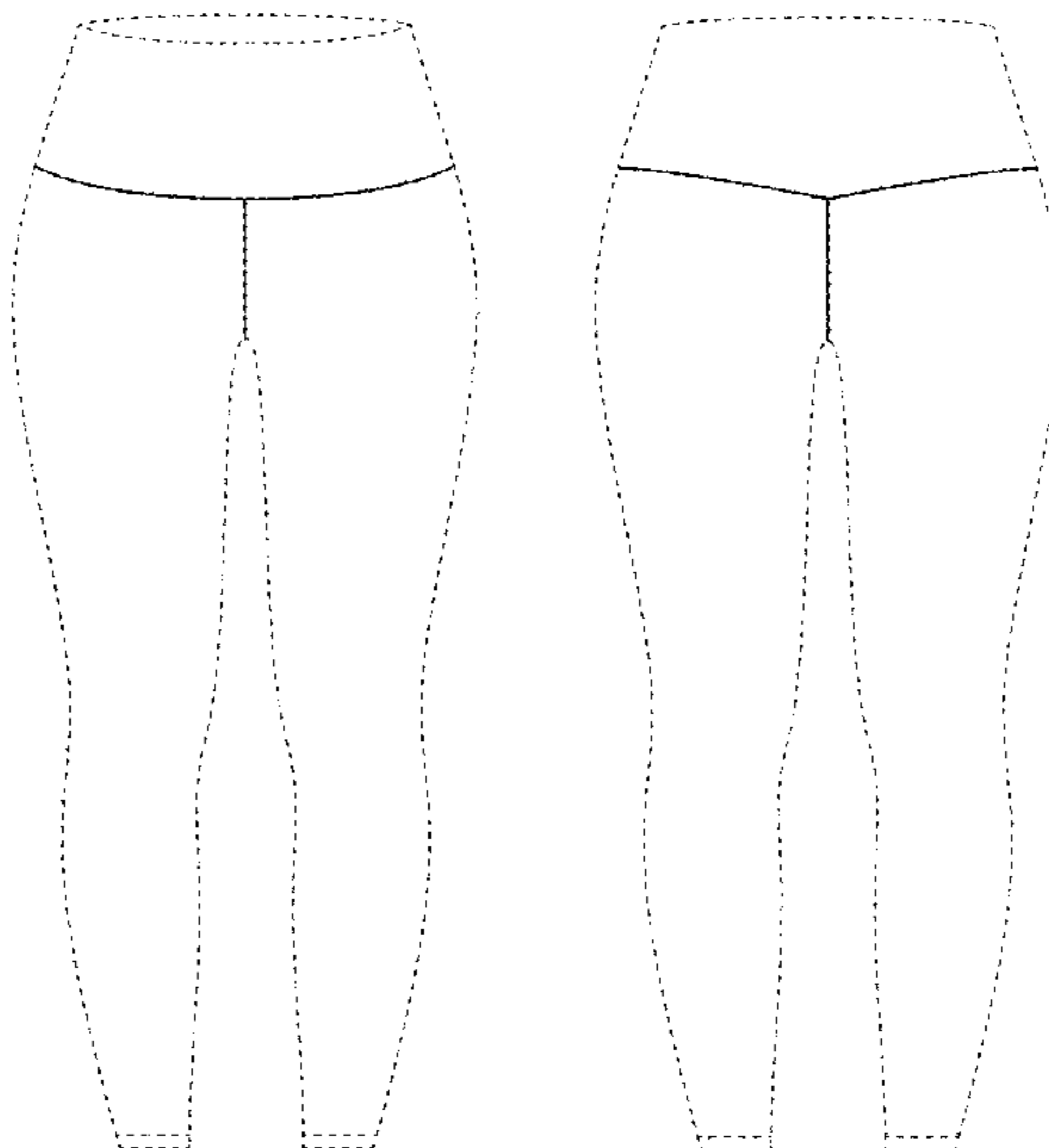

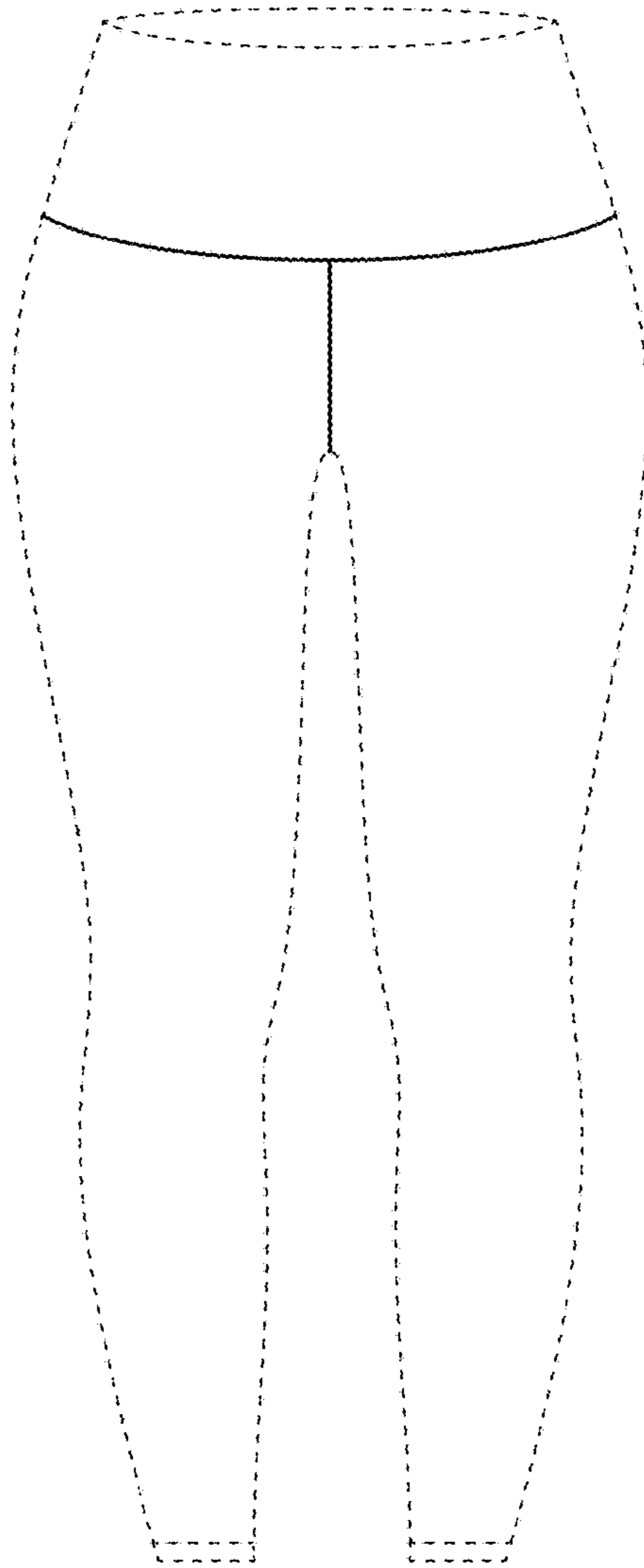

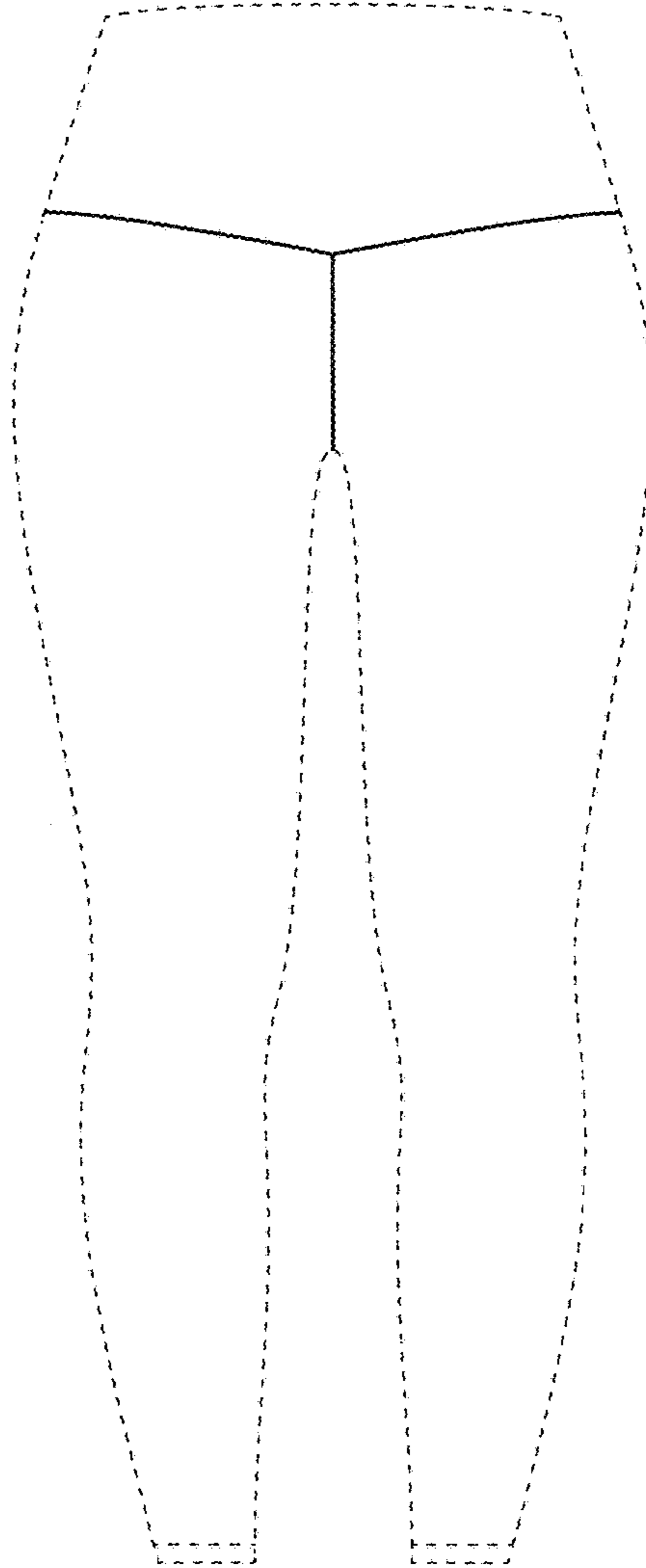

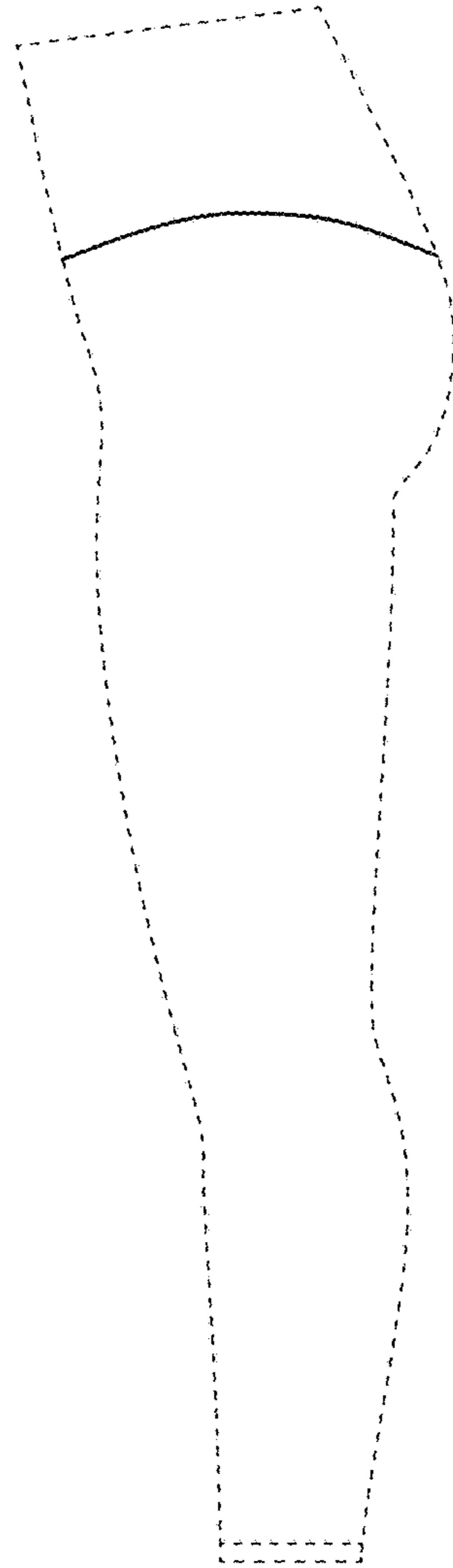

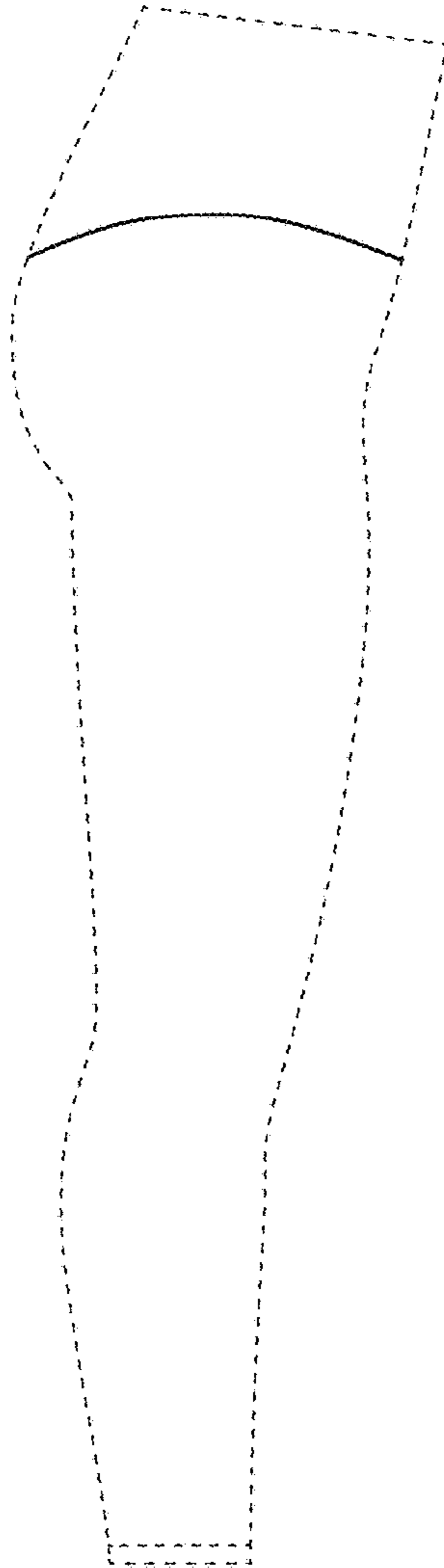

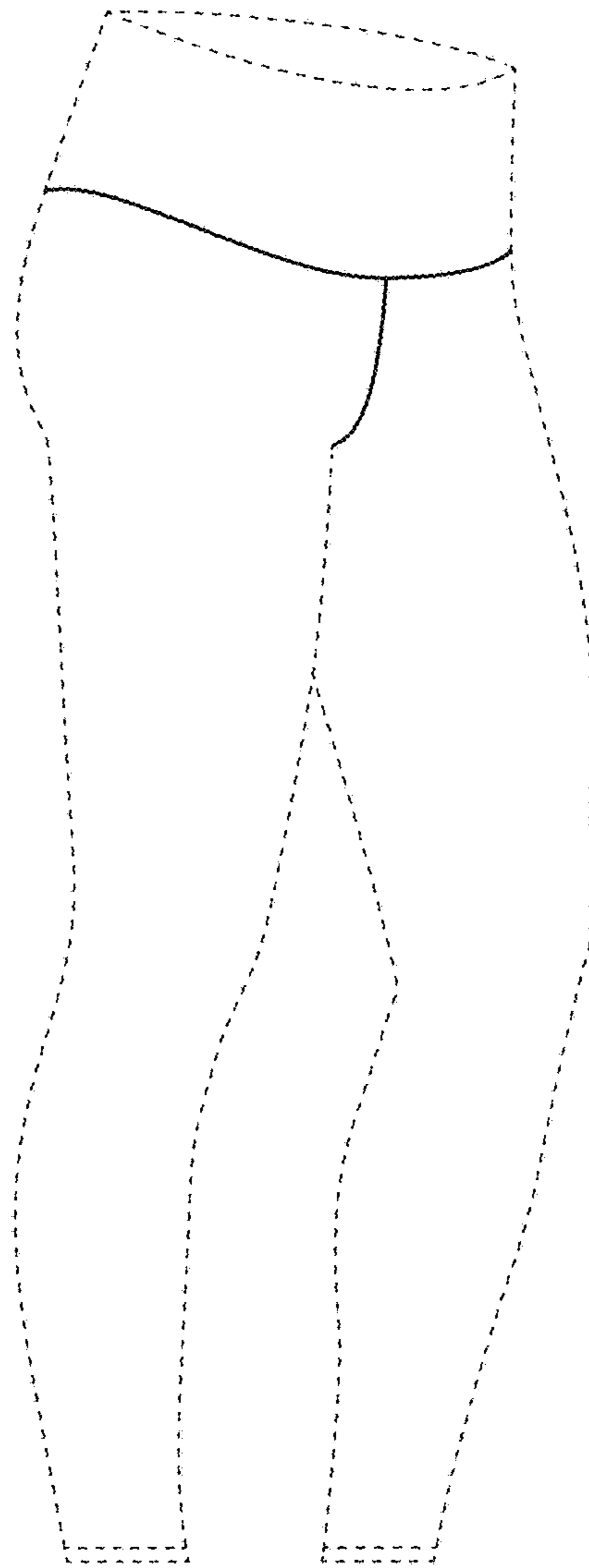

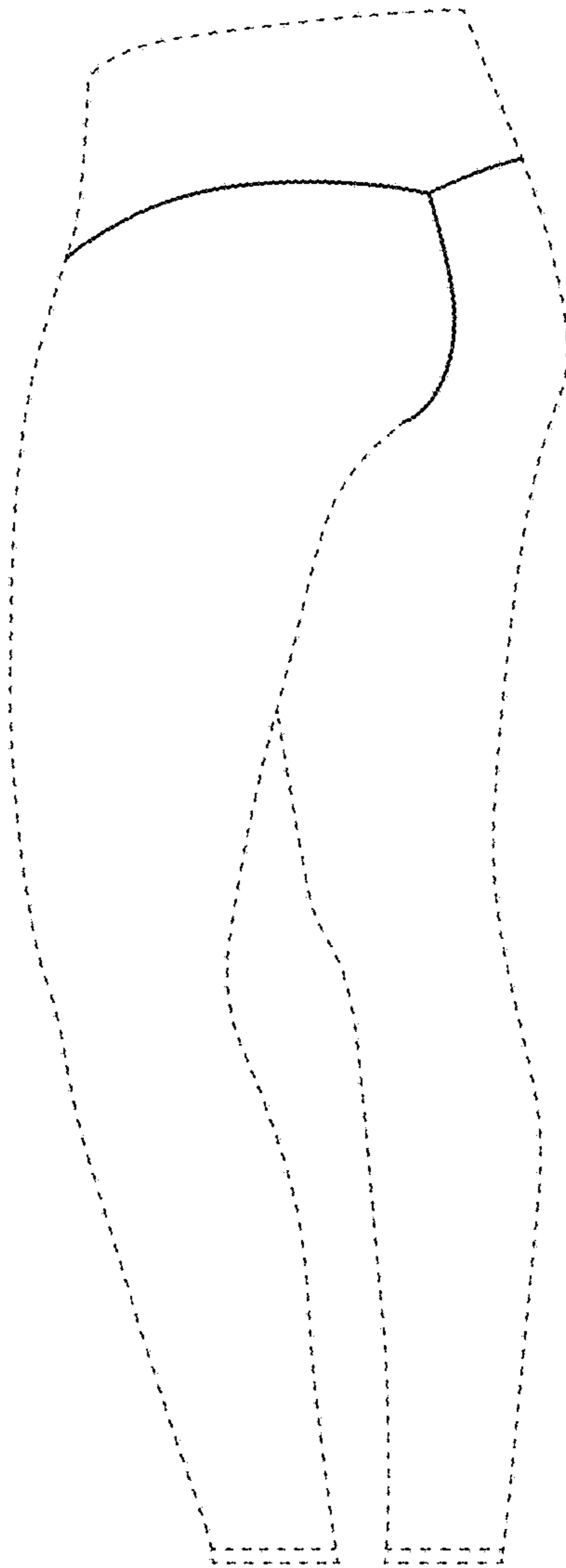

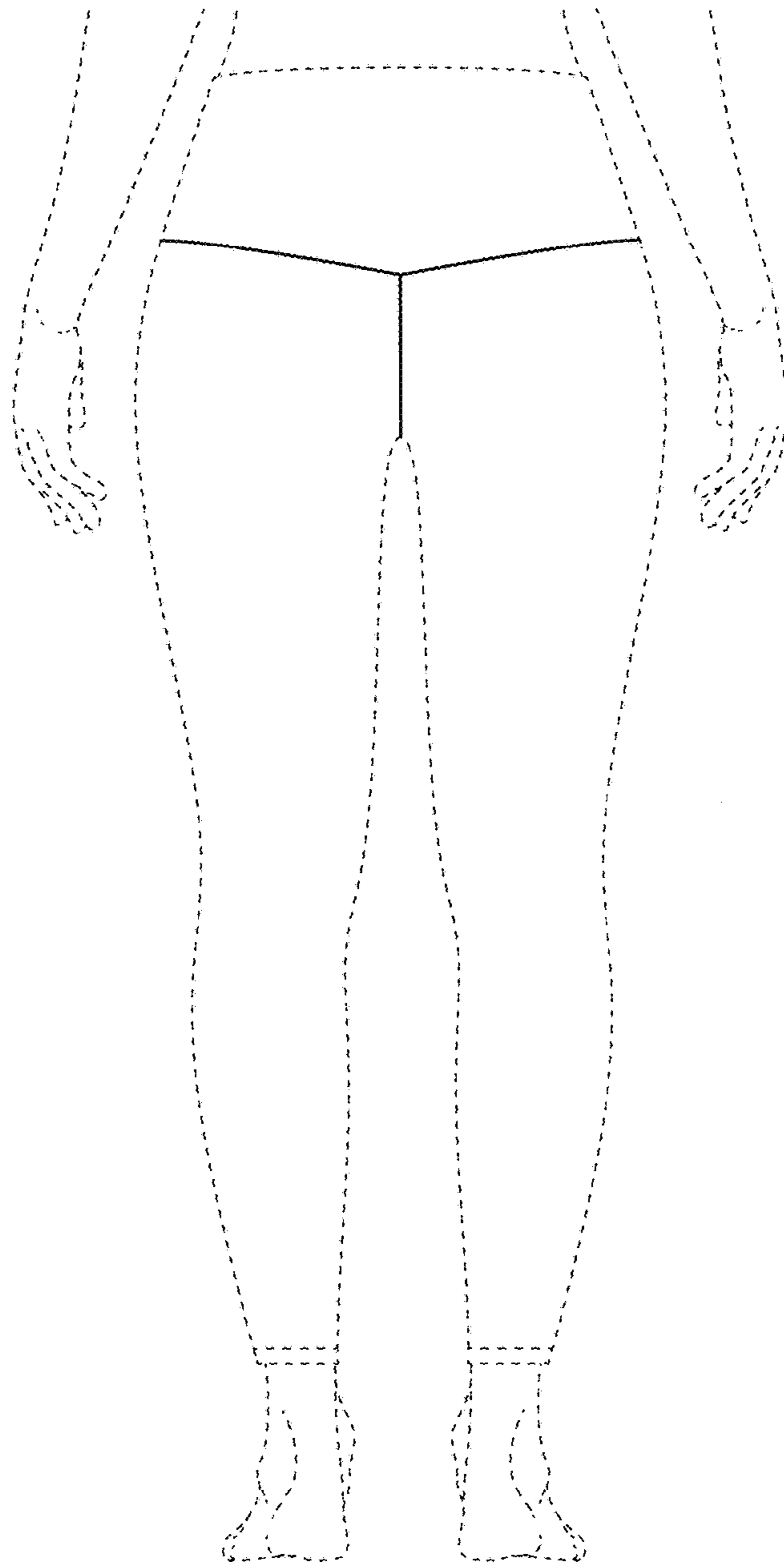
