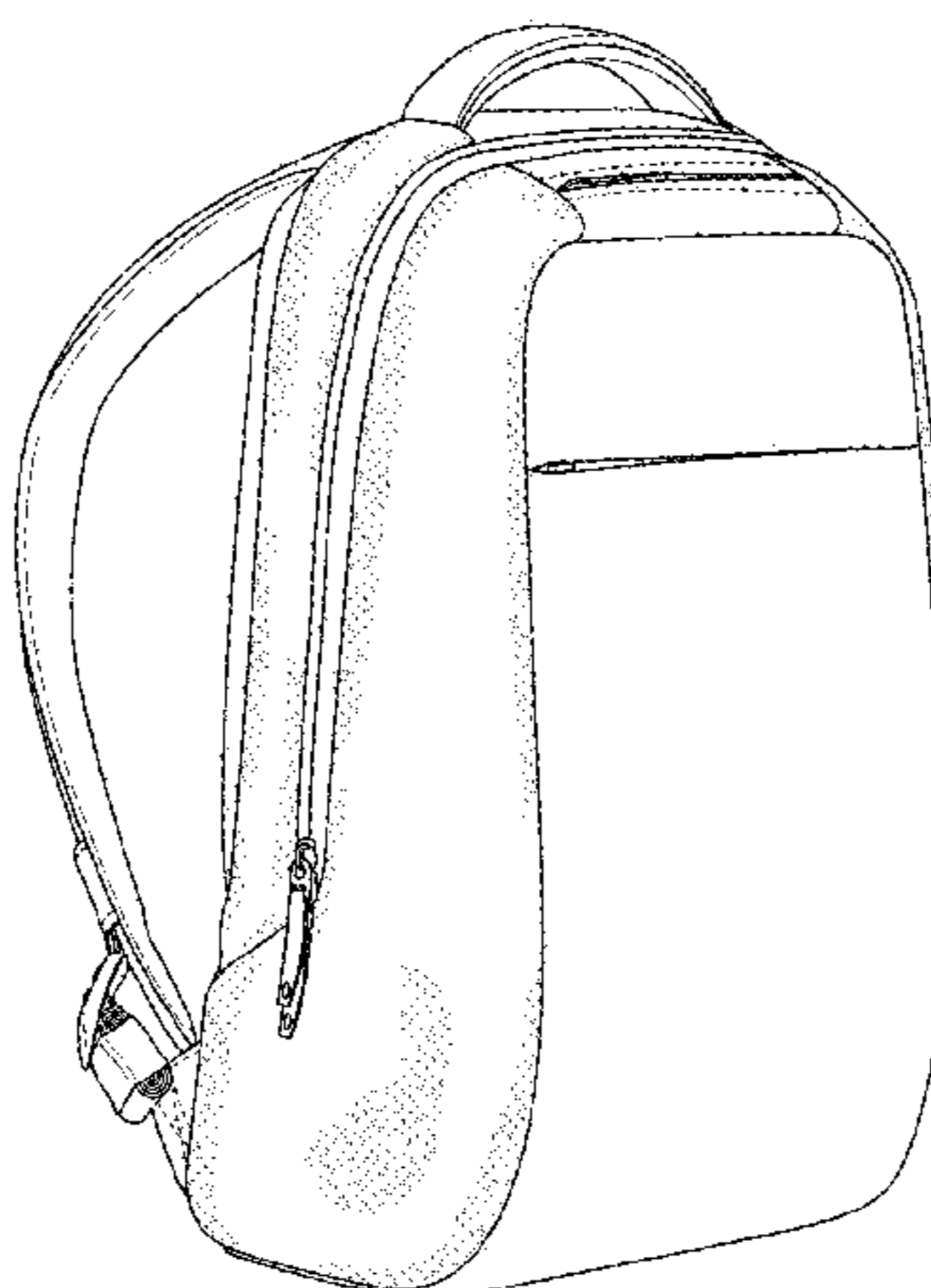
(57) **CLAIM**

I claim the ornamental design for a backpack, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a backpack showing one embodiment of a new design.
FIG. 2 is a perspective view thereof taken from the front side.

FIG. 4 is a perspective view thereof taken from the right side.
FIG. 5 is another perspective view thereof.

FIG. 9 is a perspective view of a backpack showing another embodiment of the new design.

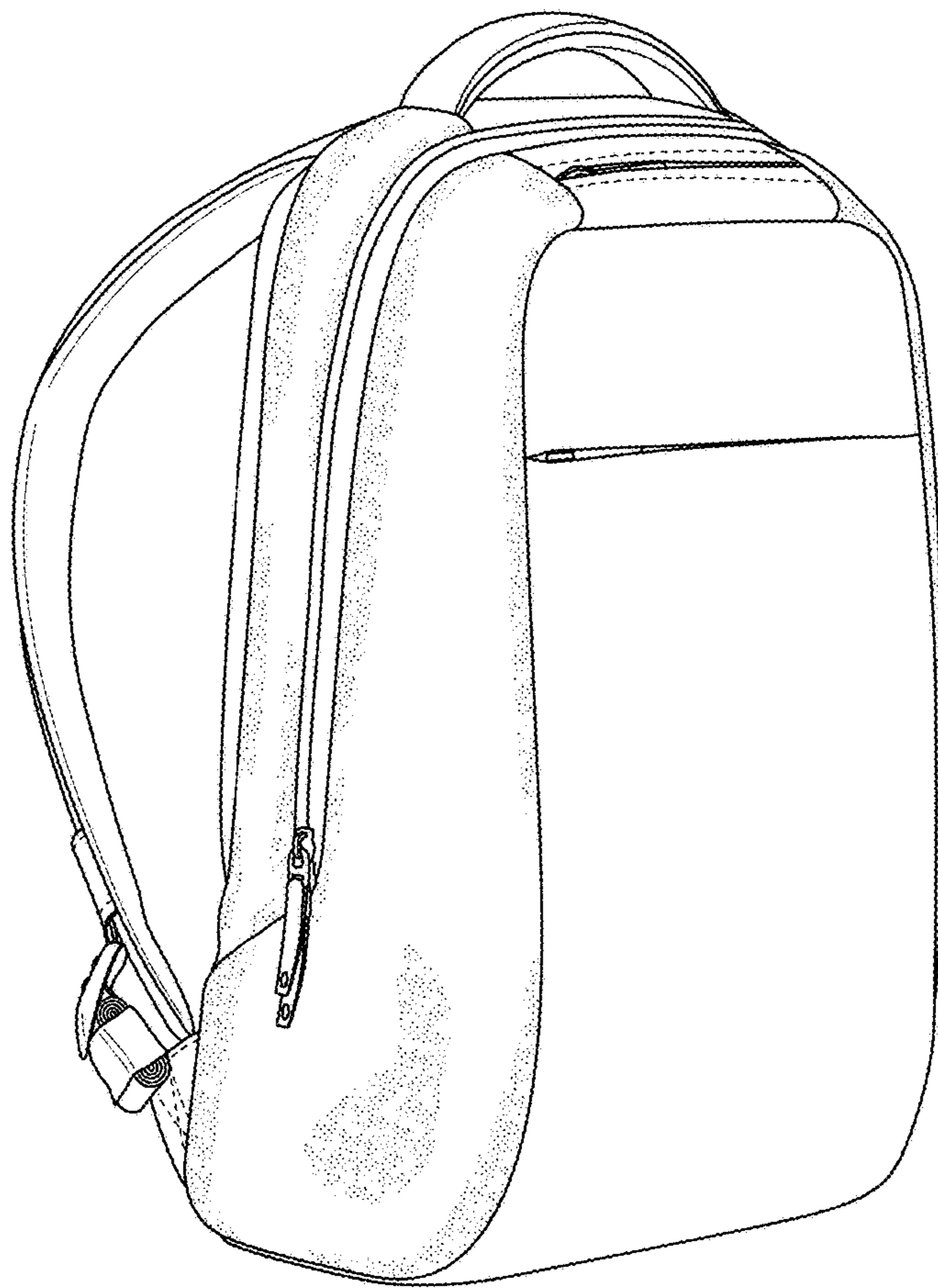

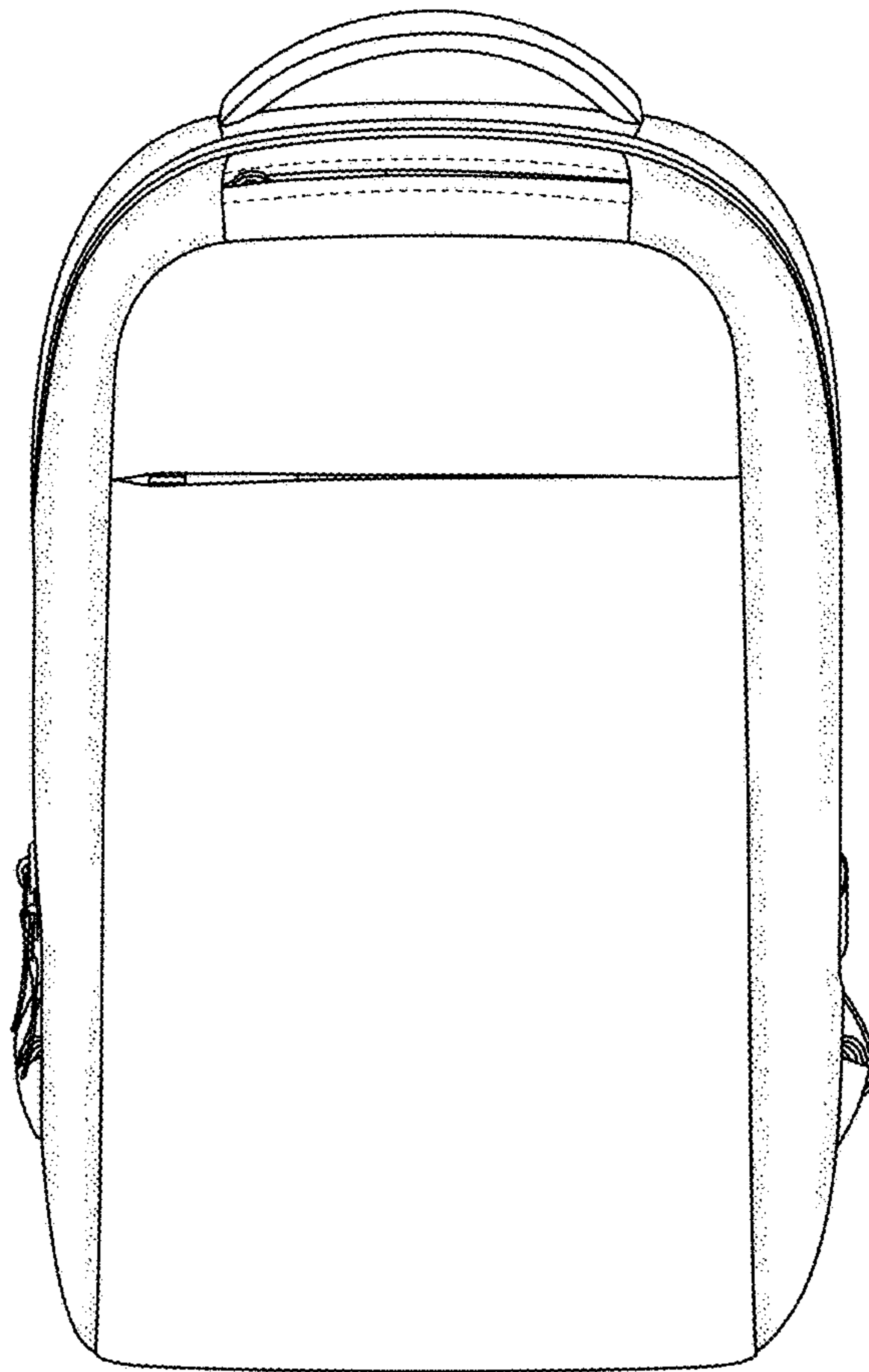

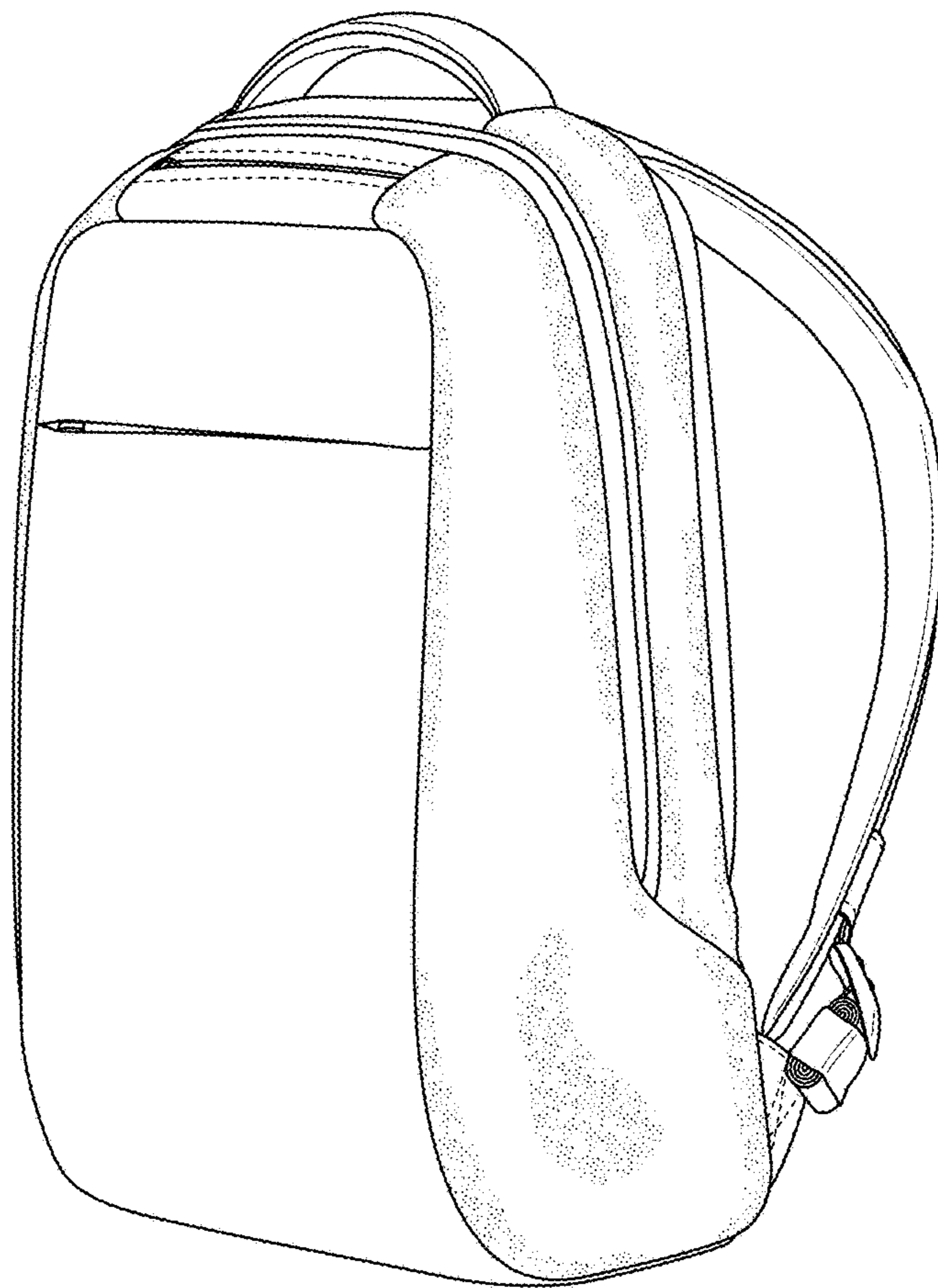

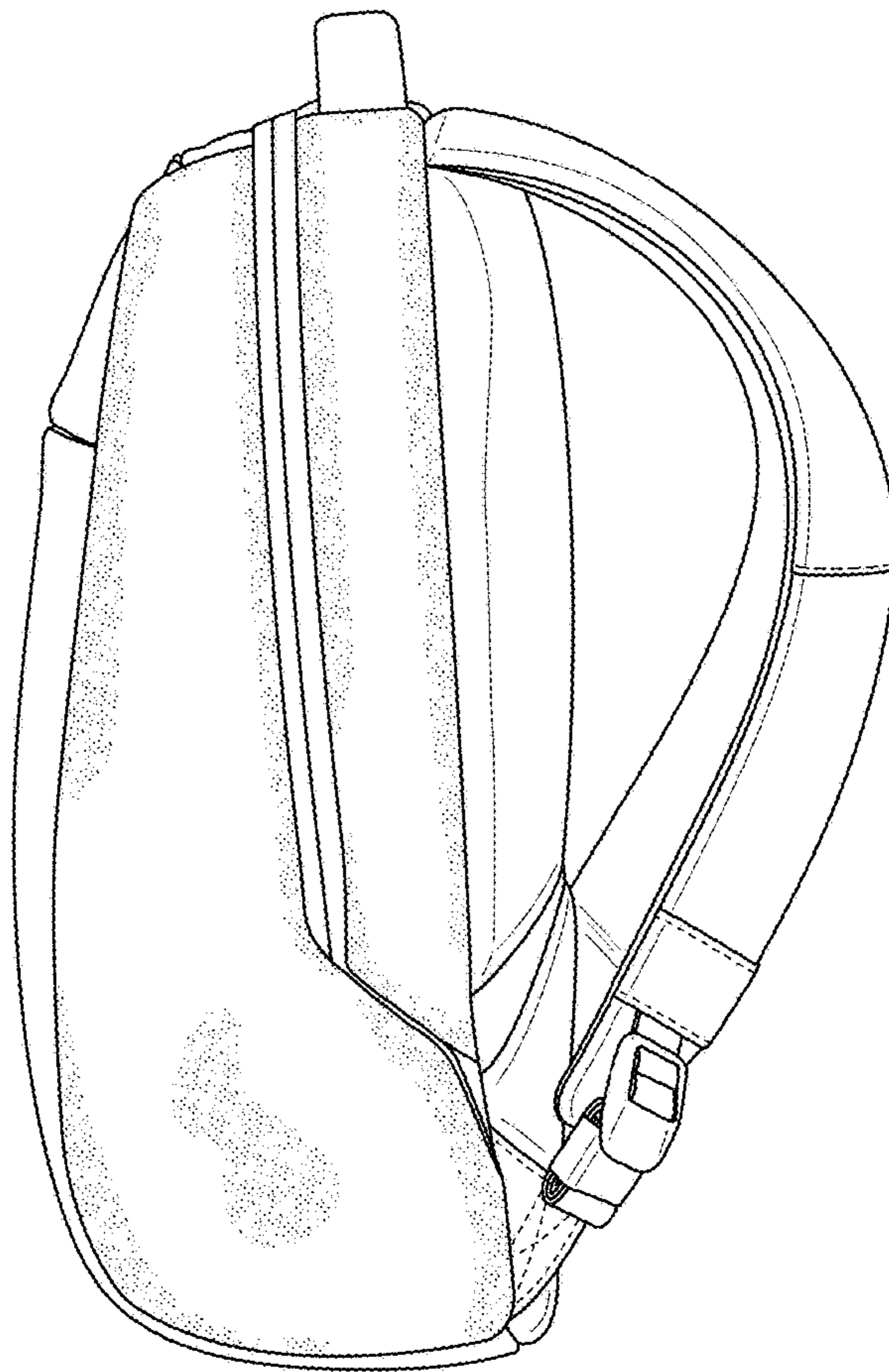

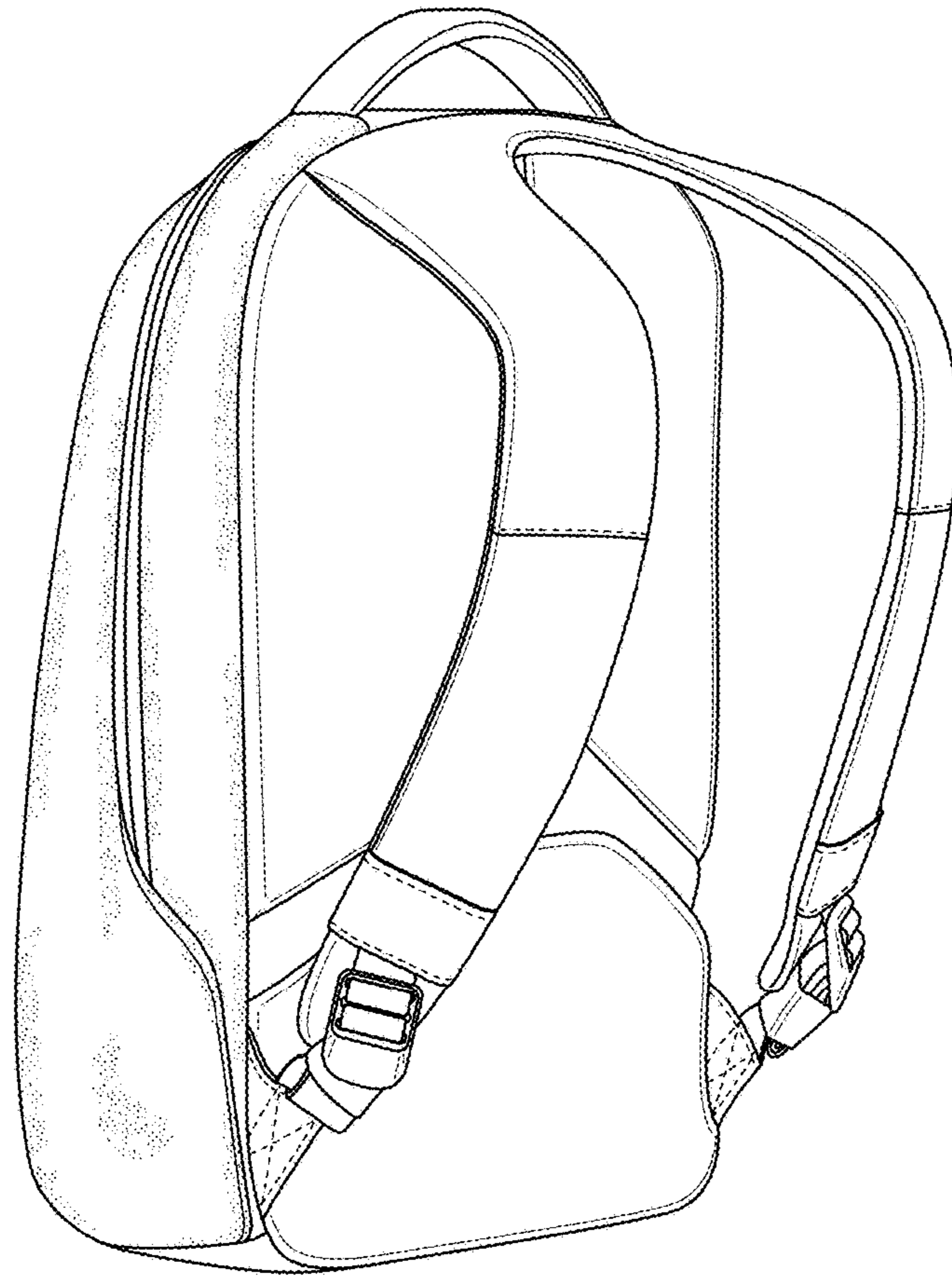

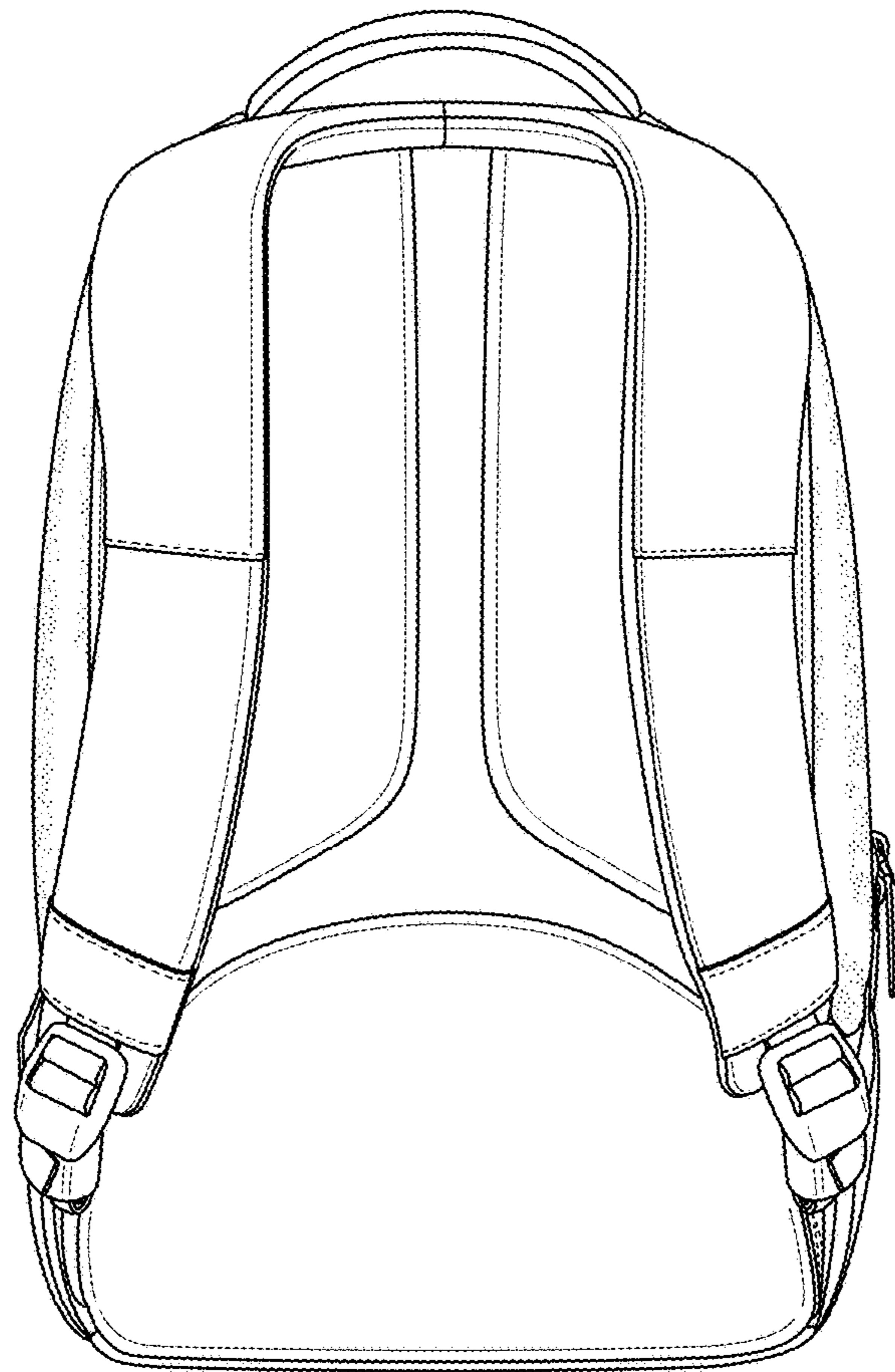

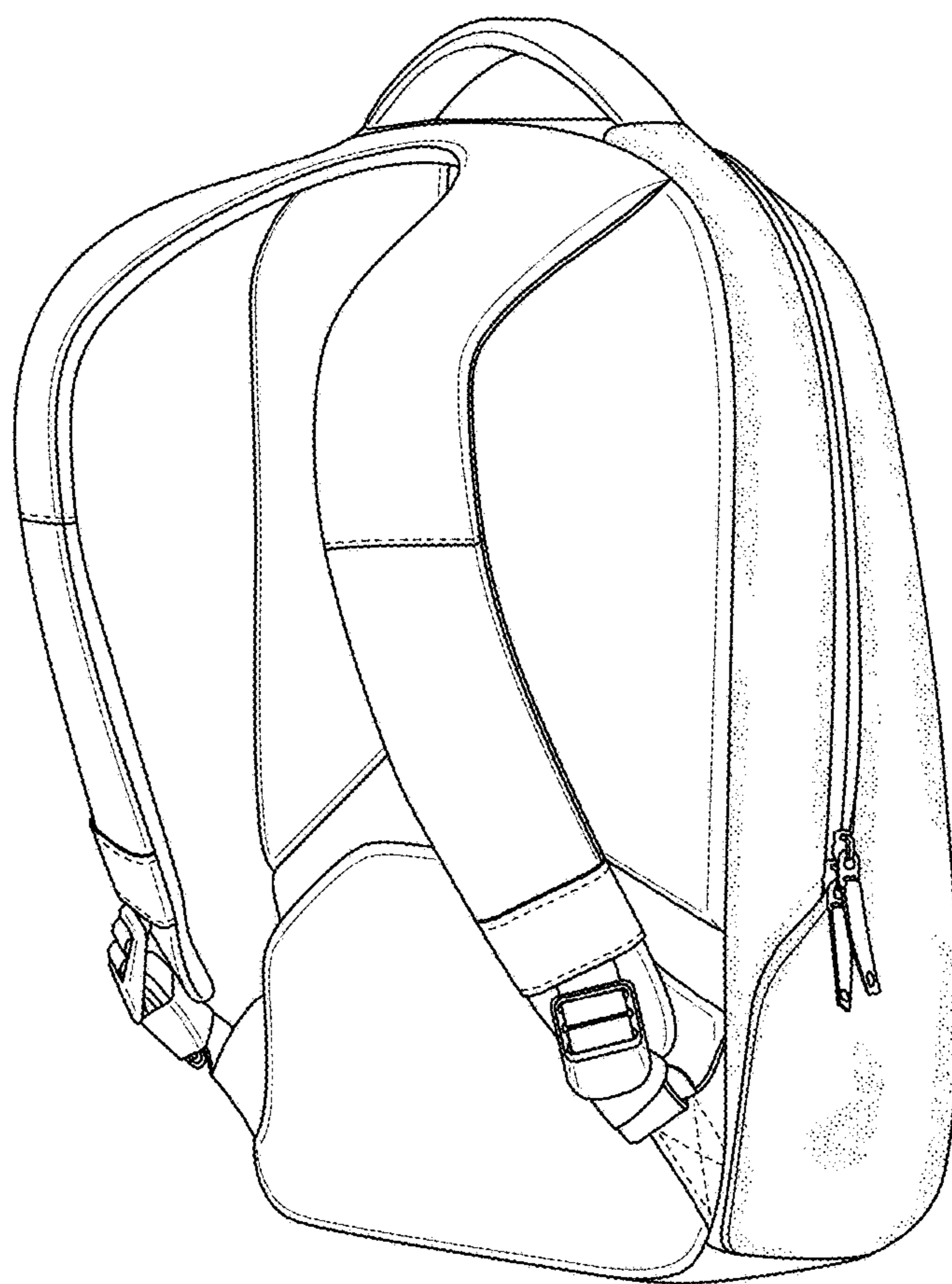

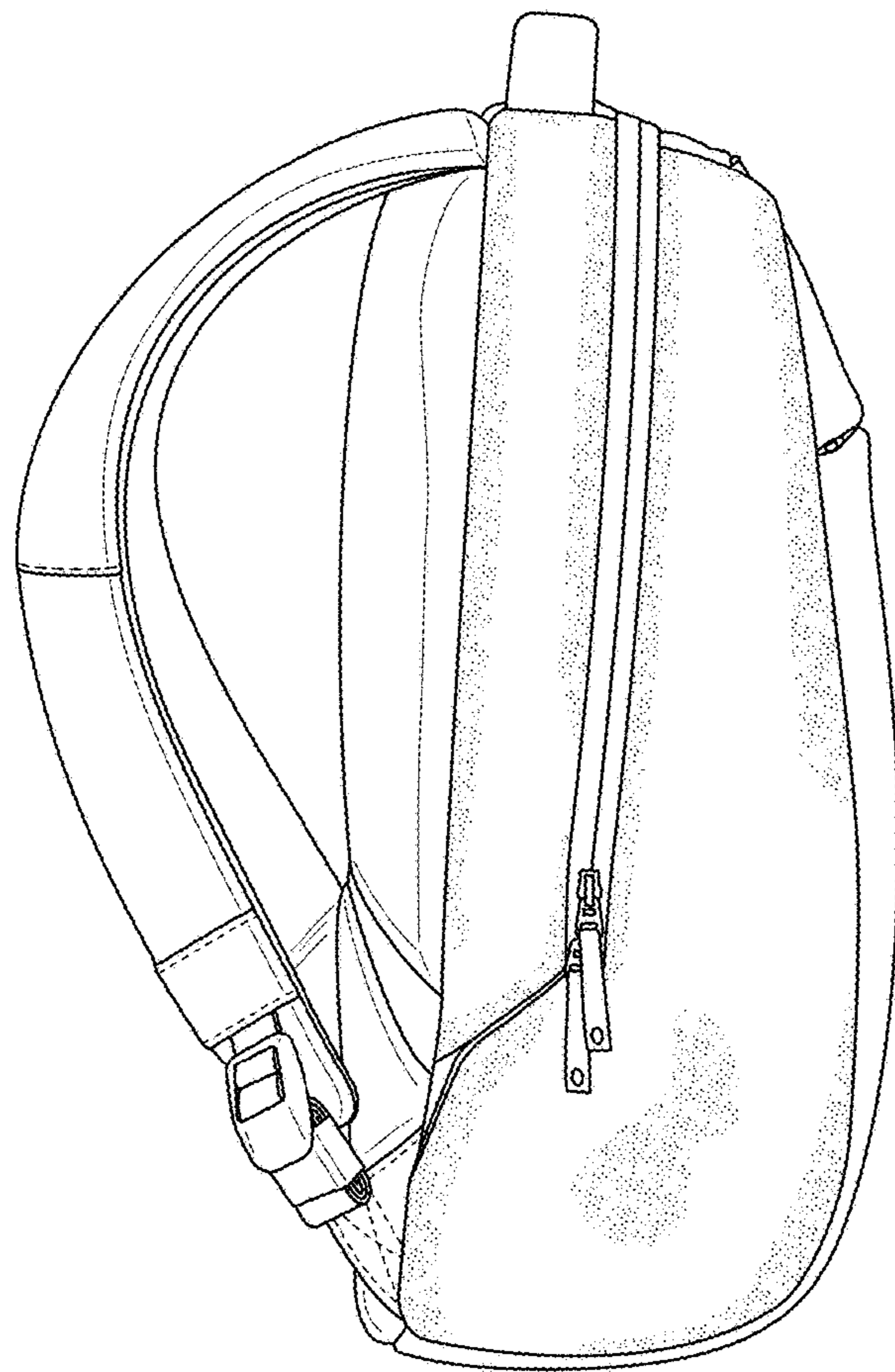

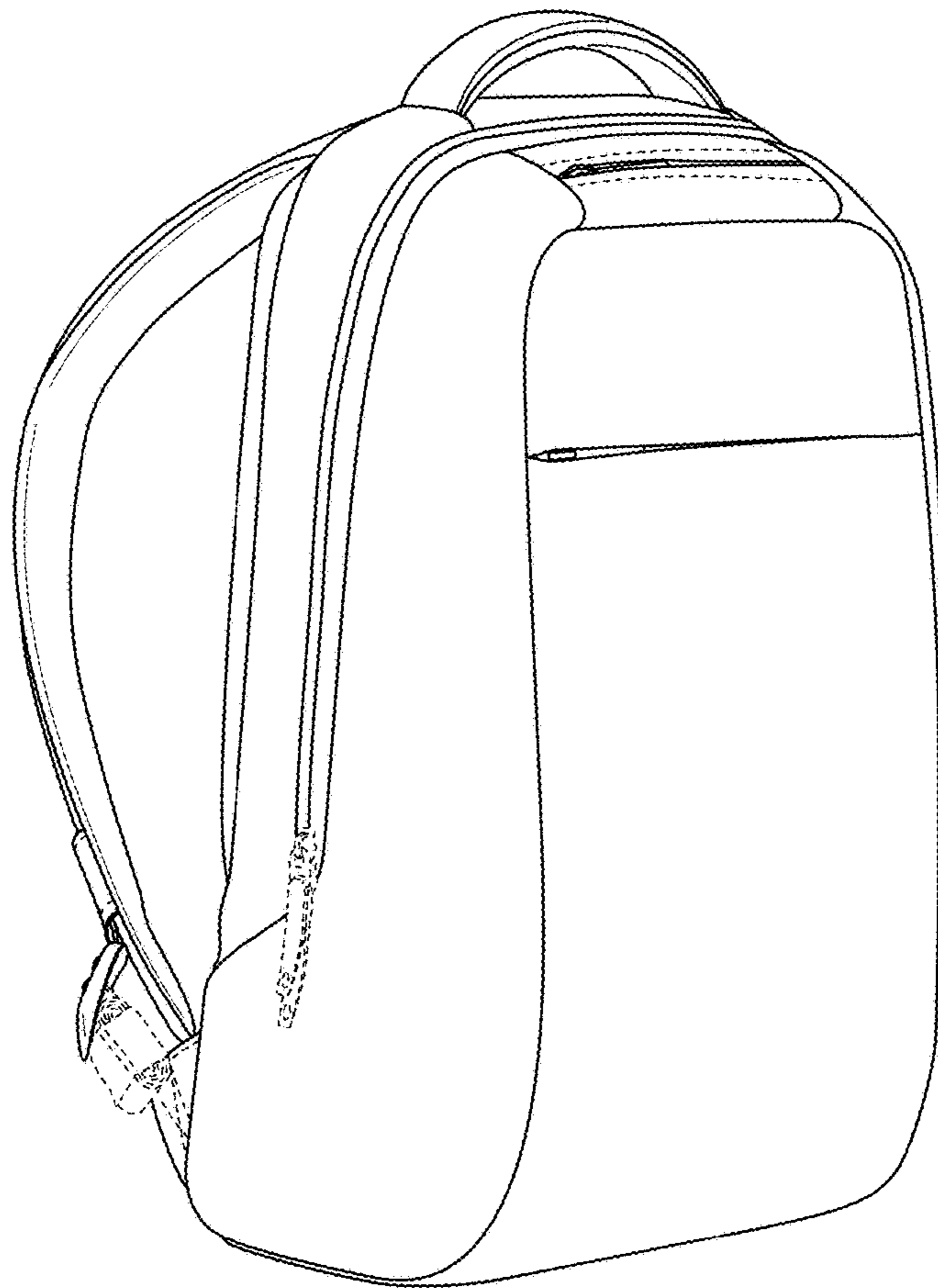

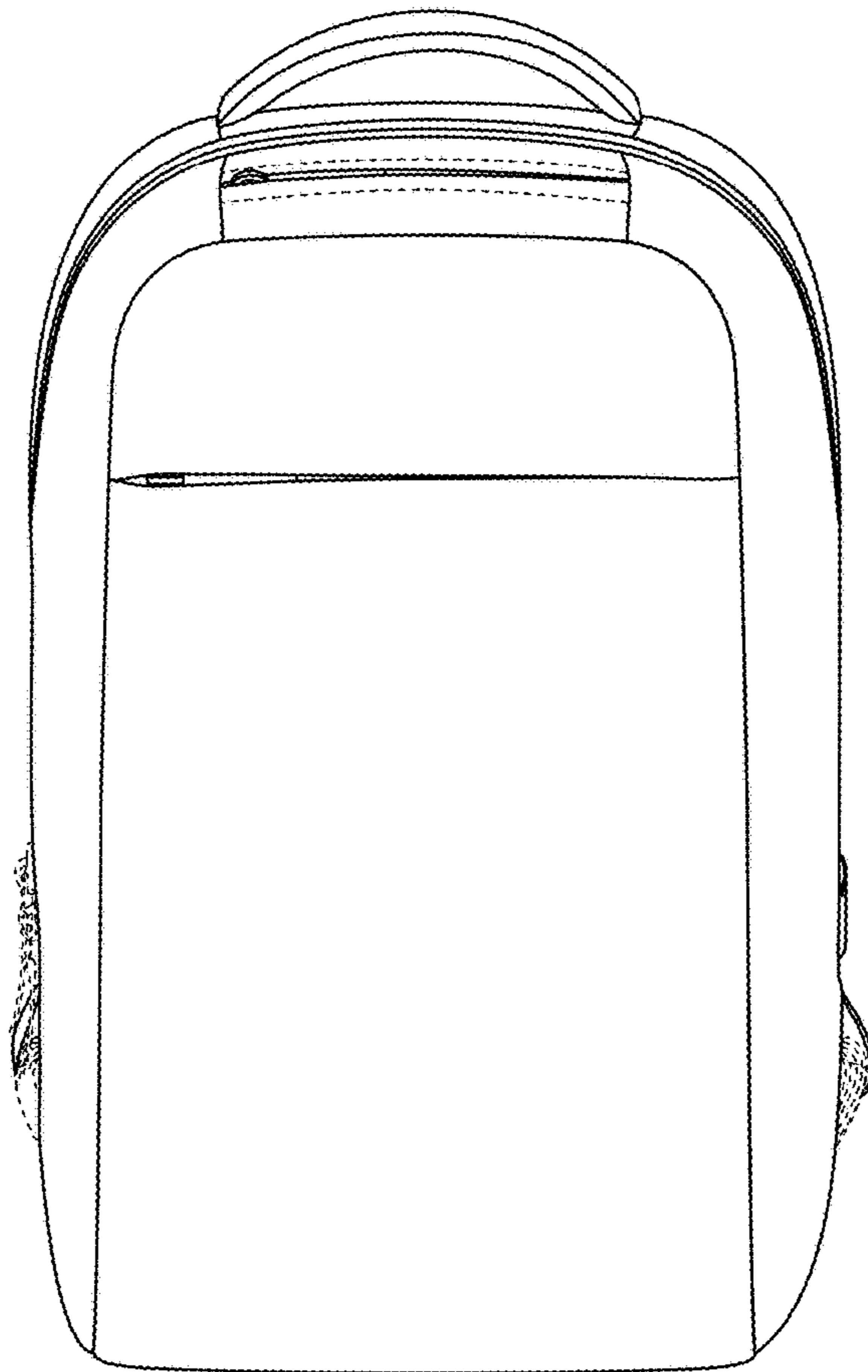

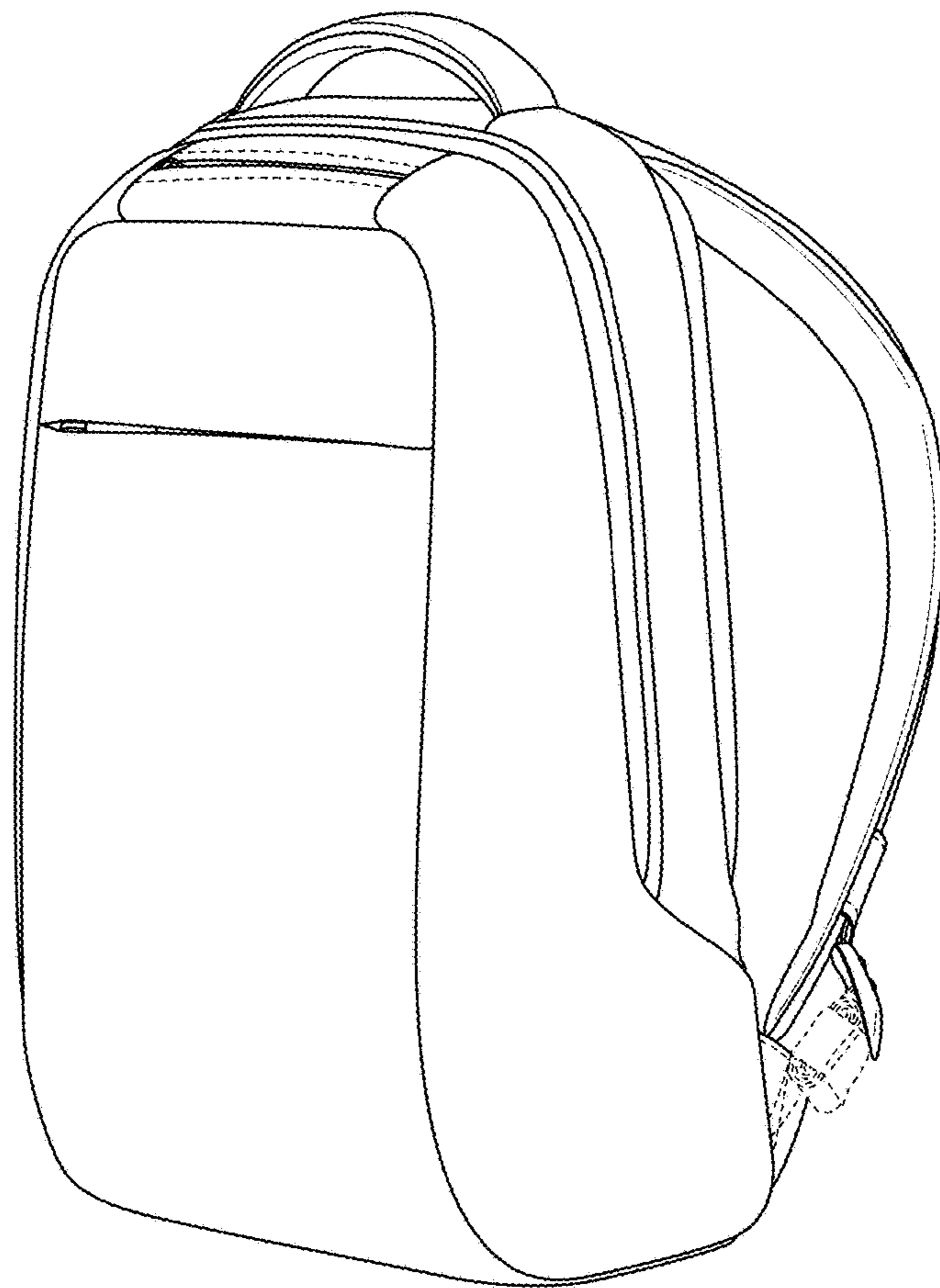

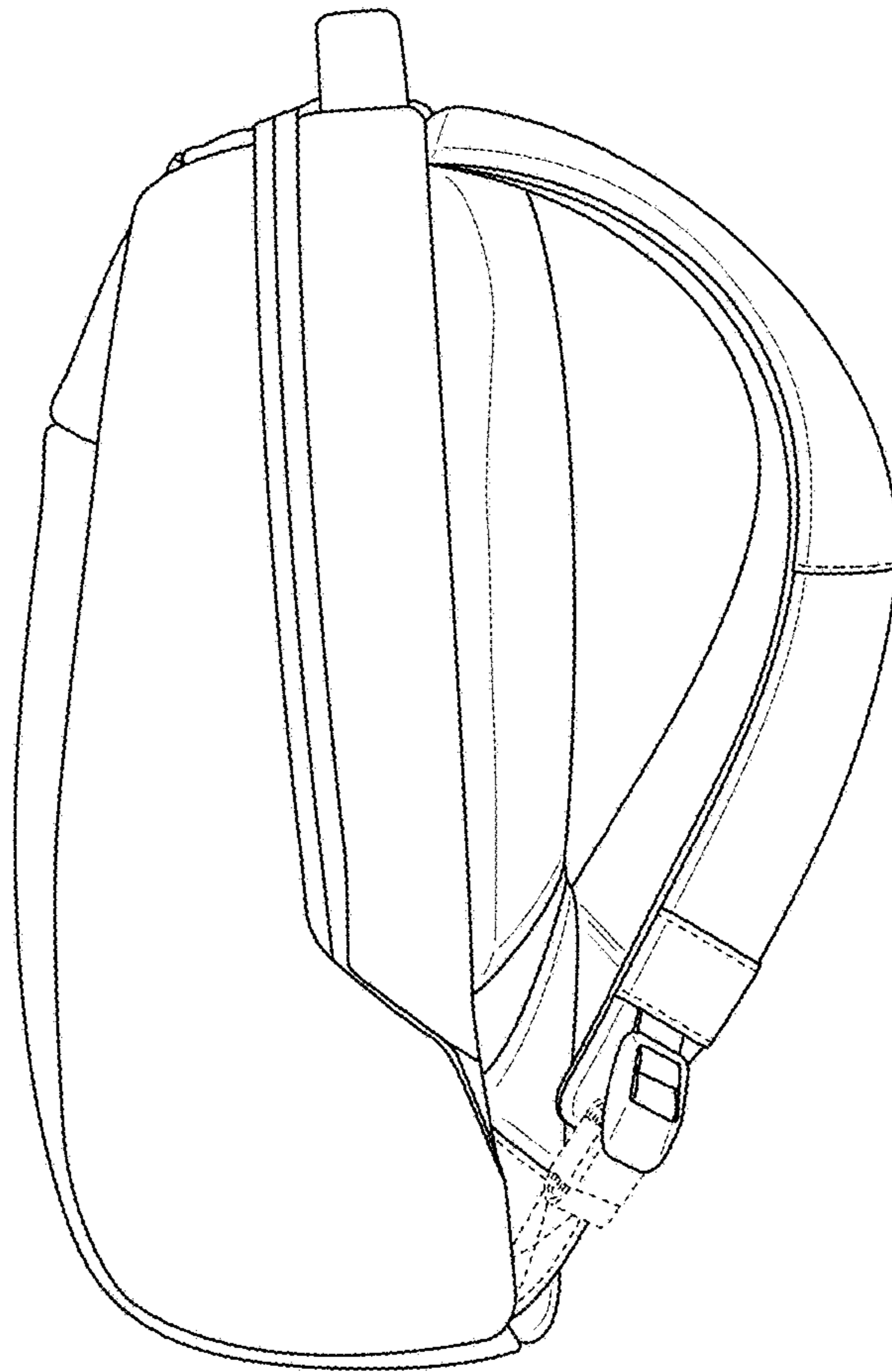

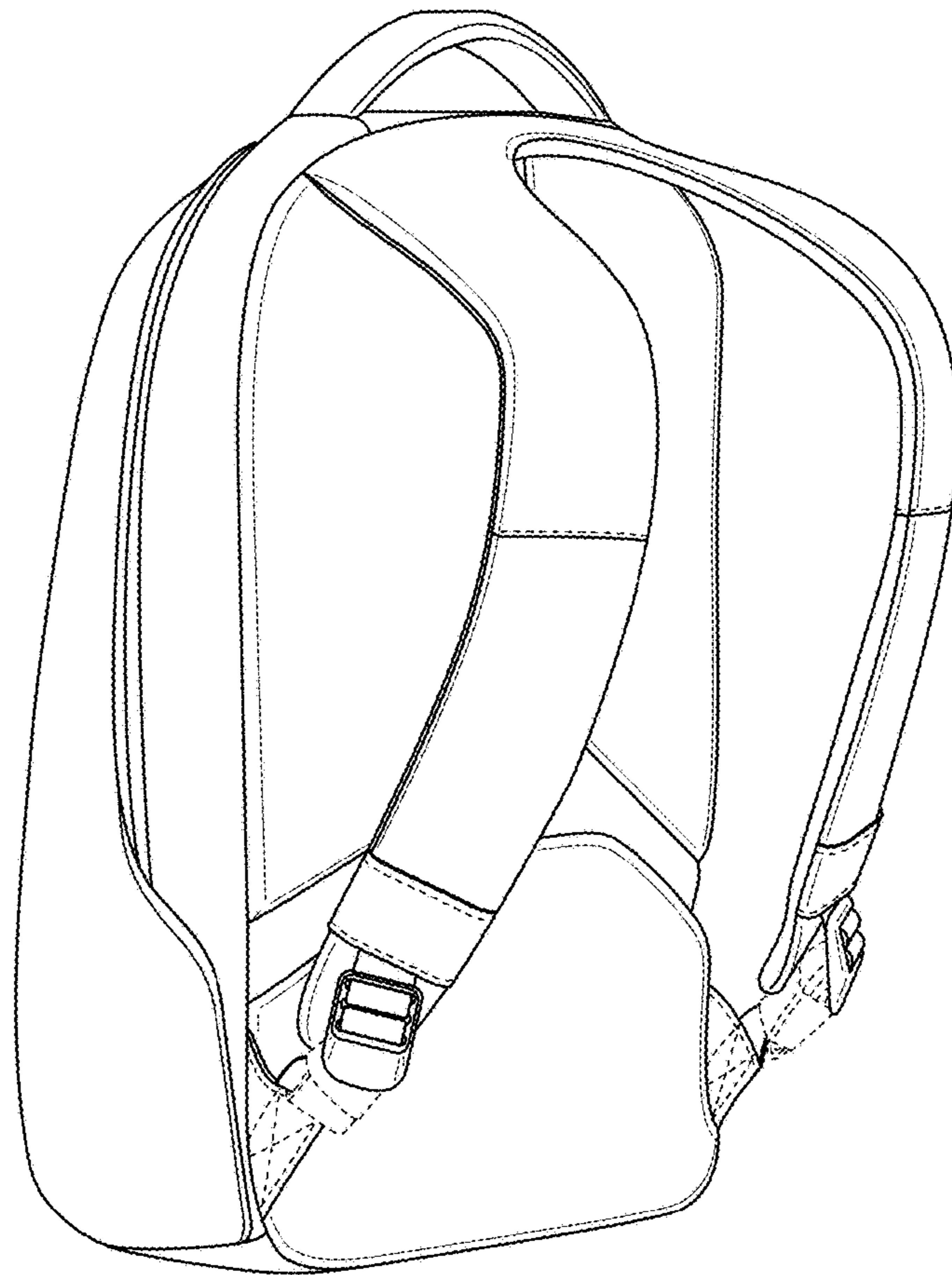

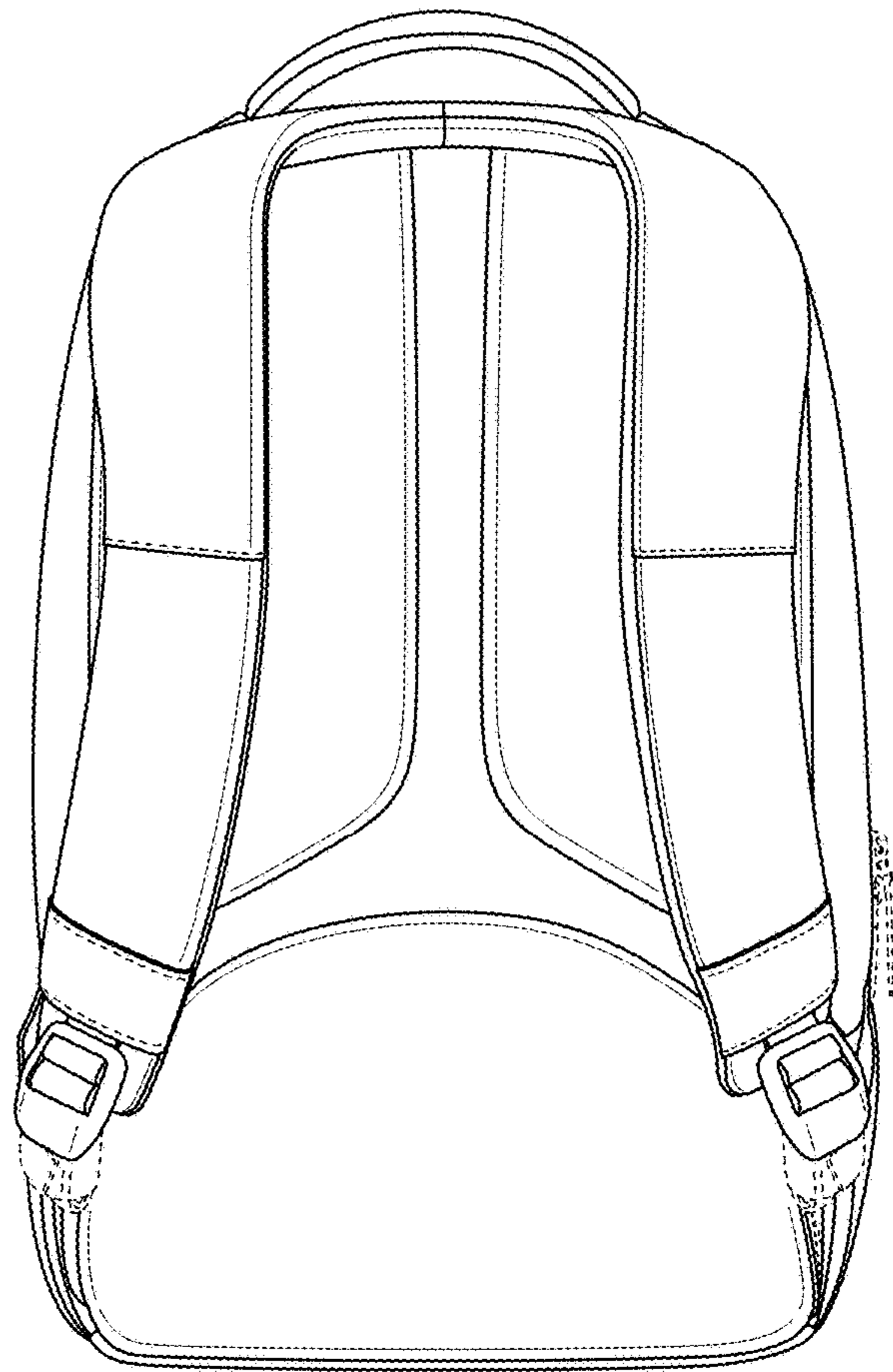

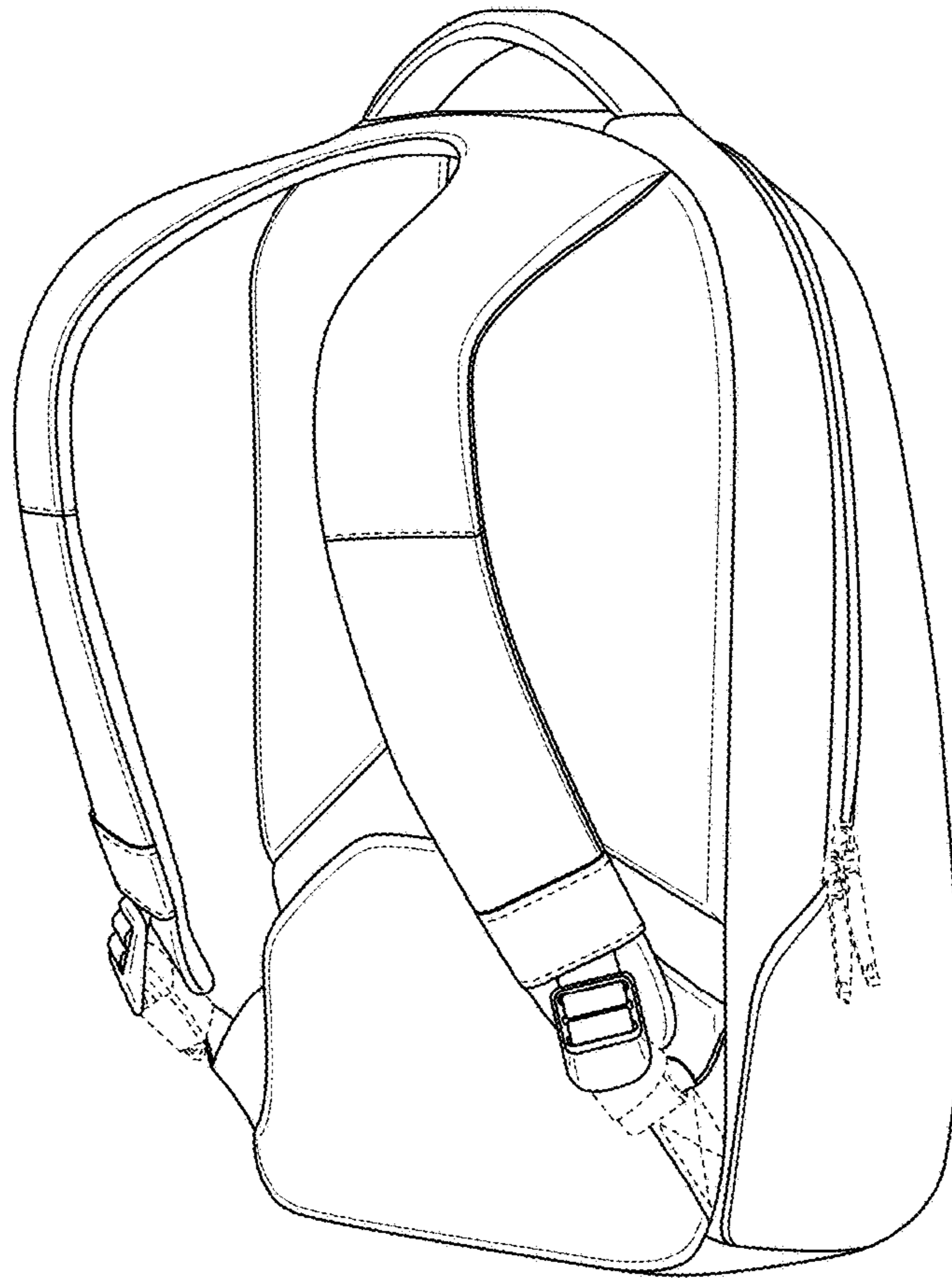

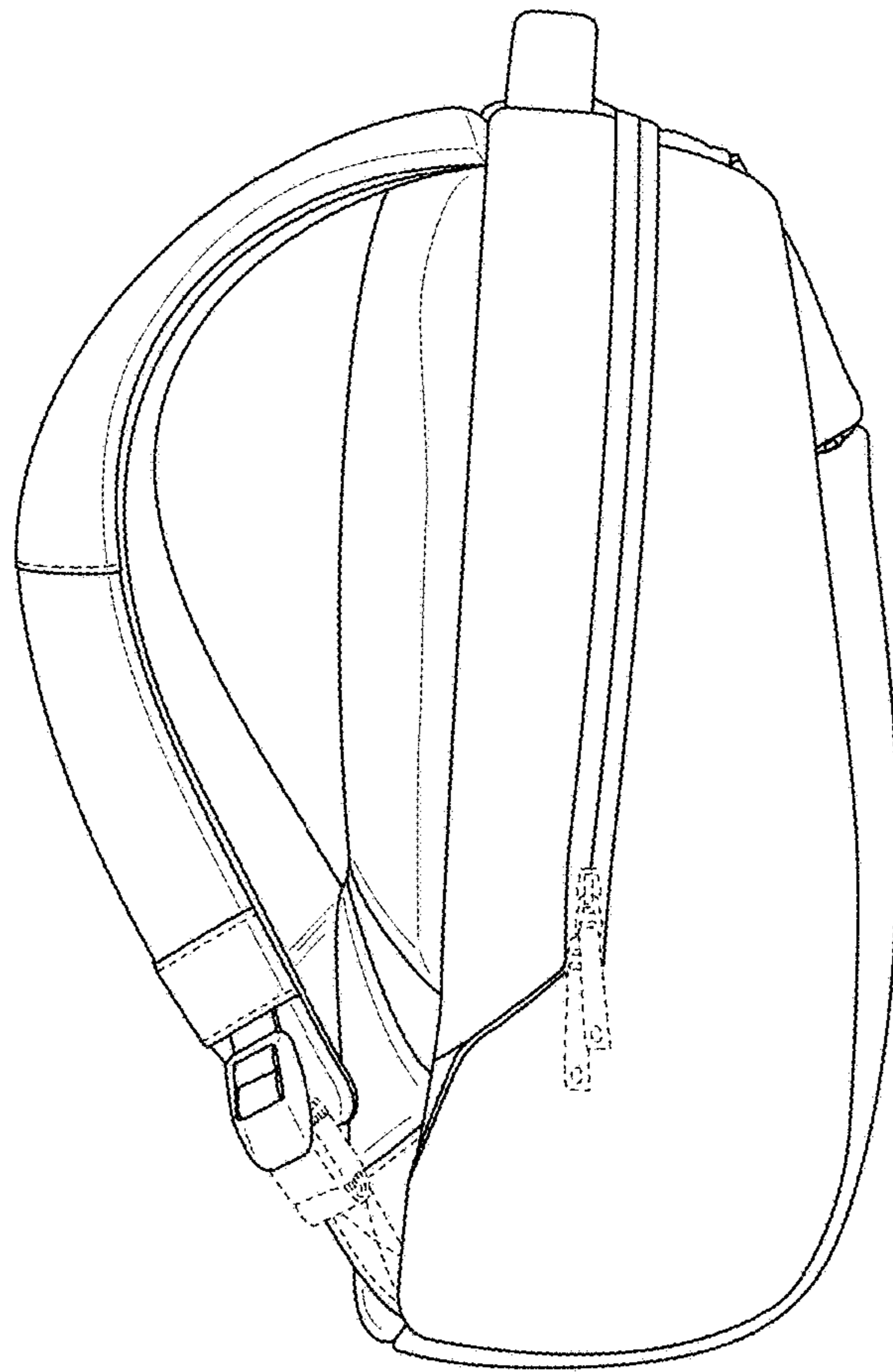
