The ornamental design for a yoga mat, as shown and described.

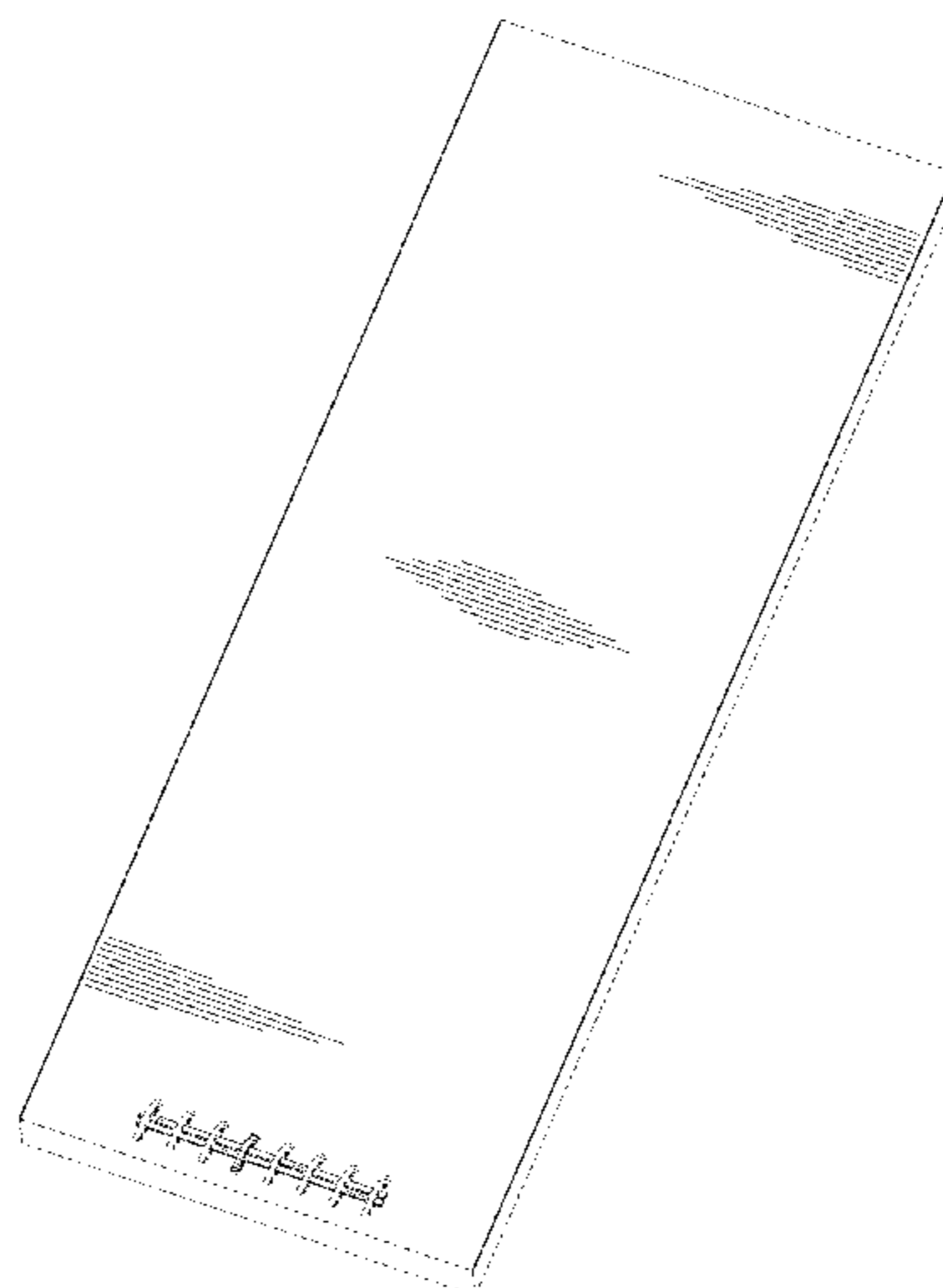
DESCRIPTION

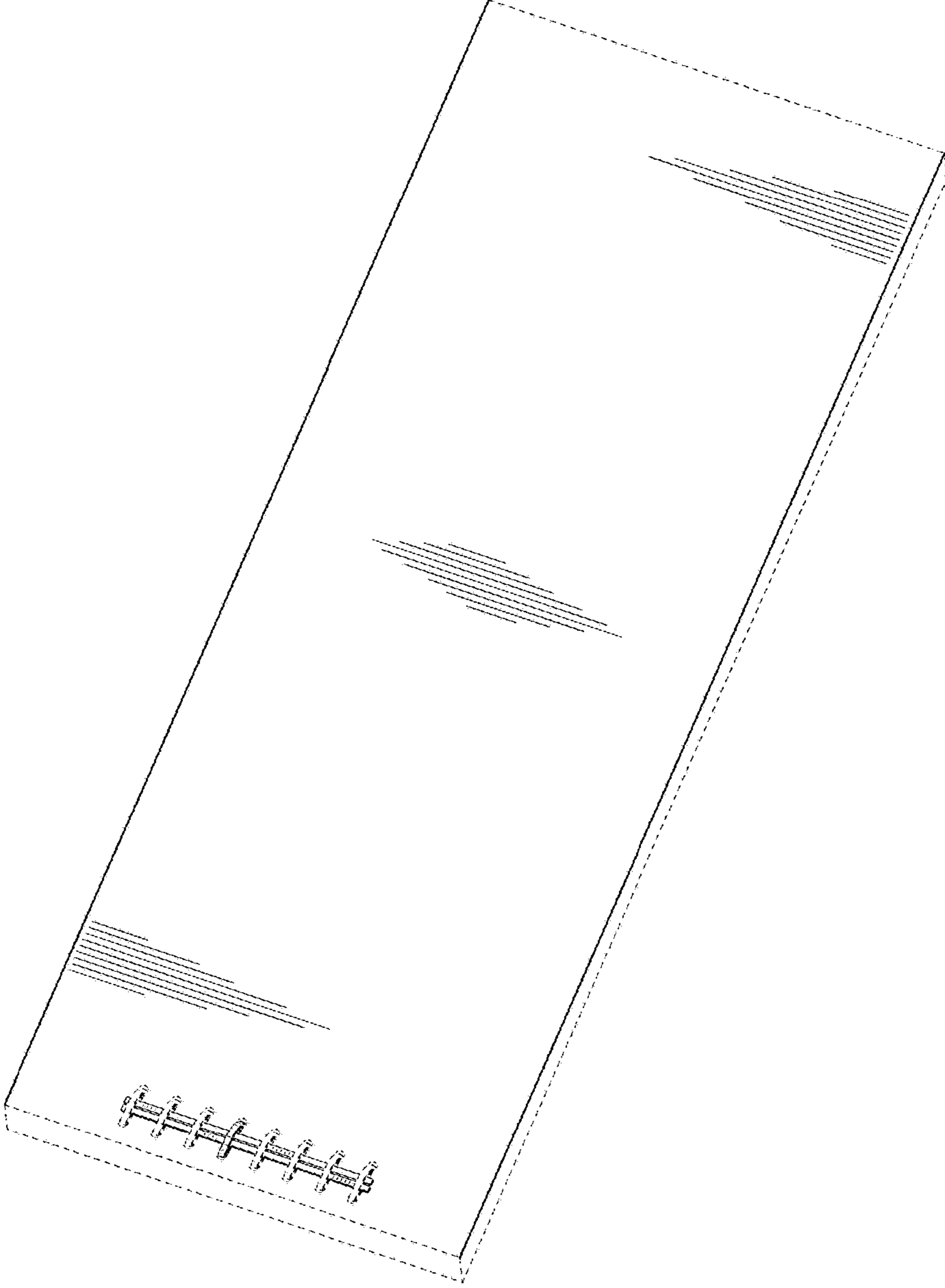

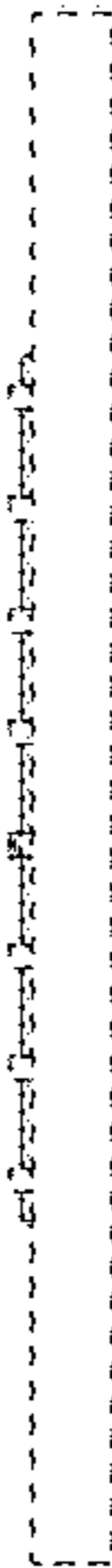

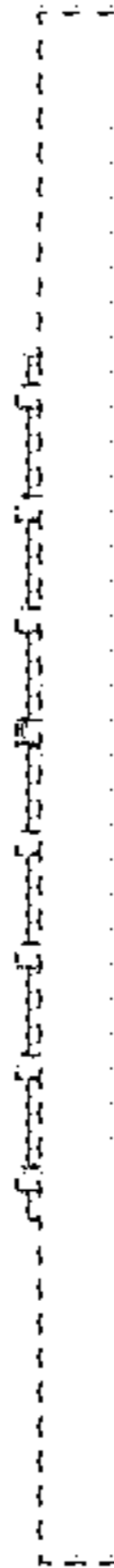

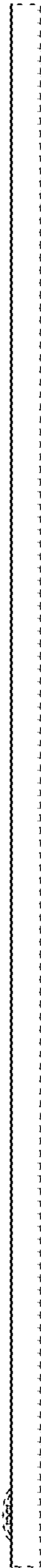

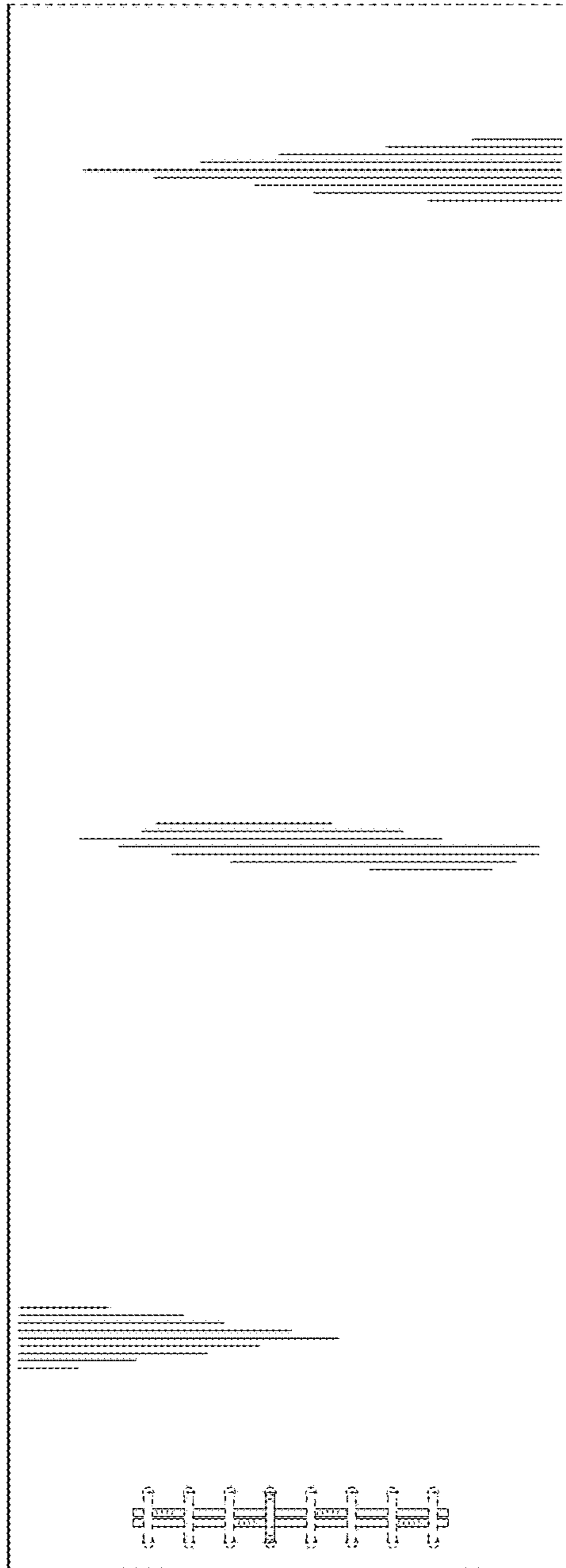

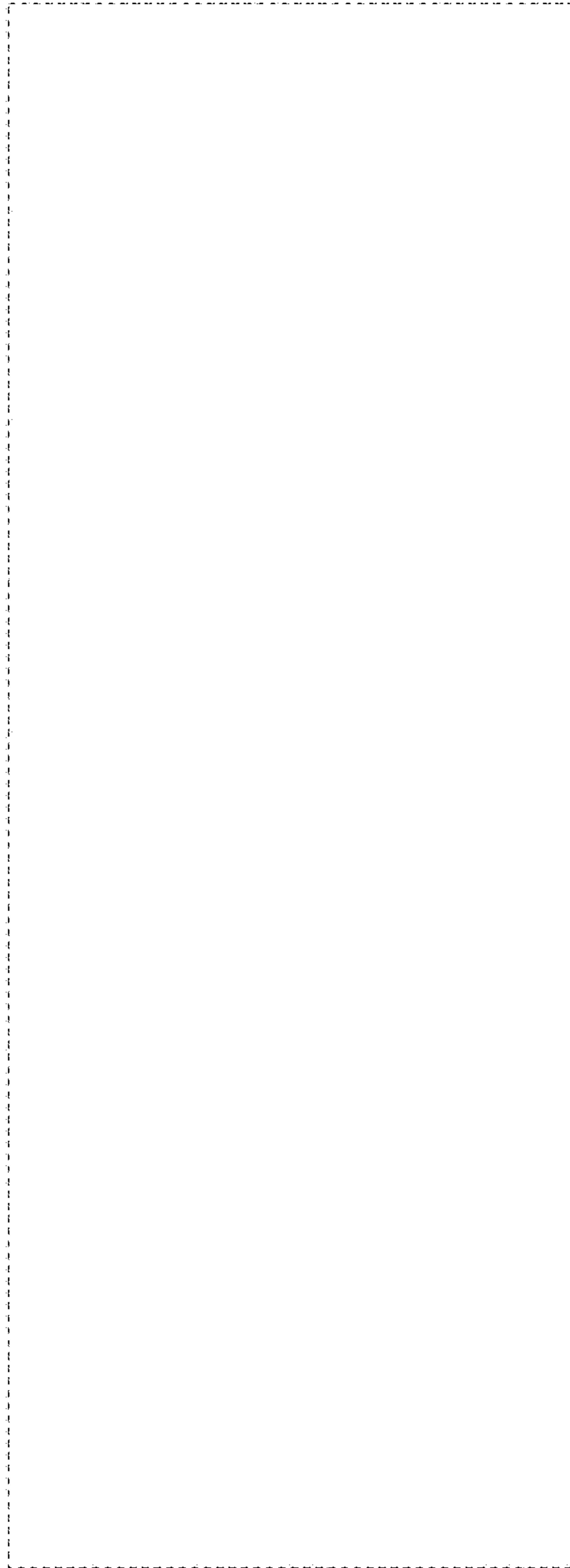
