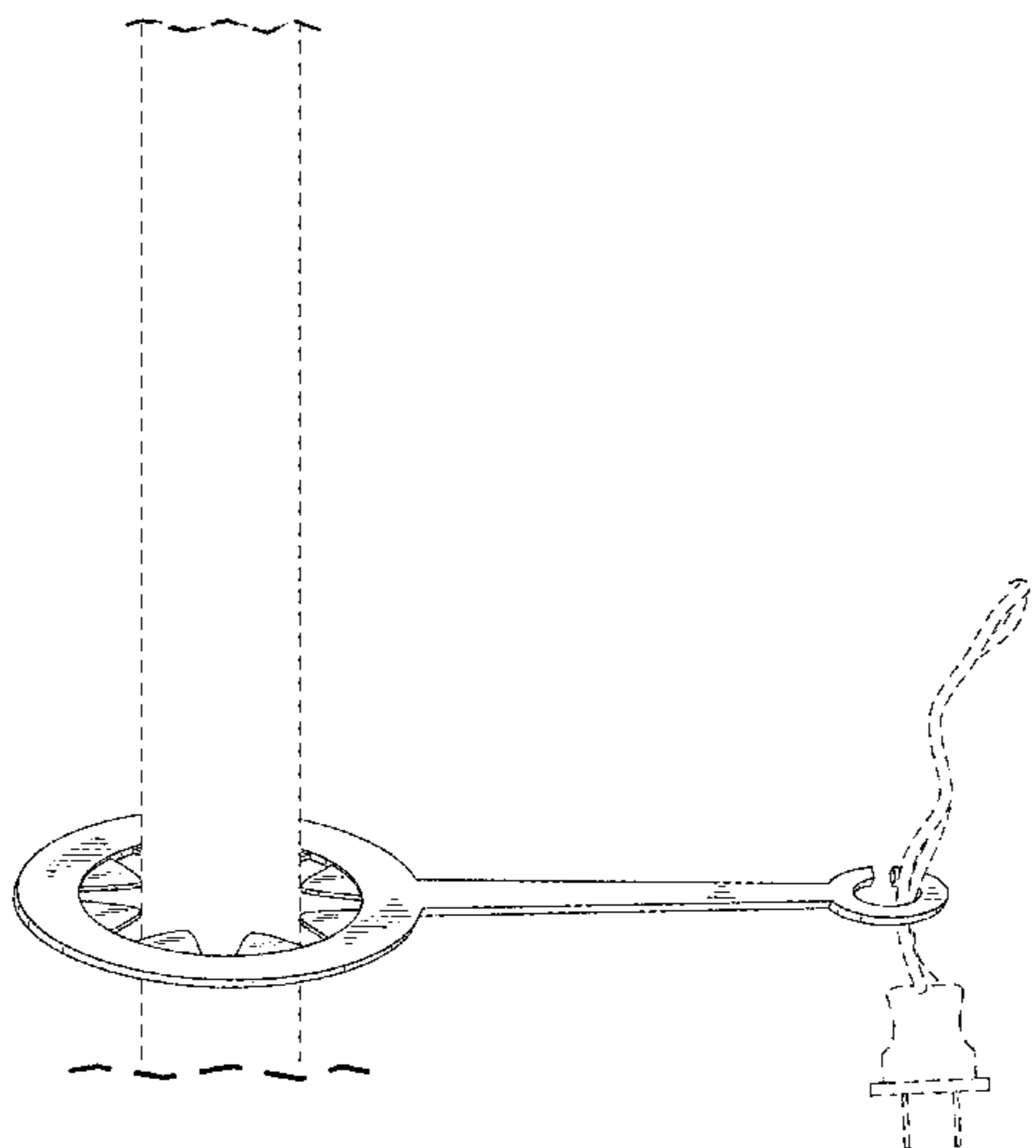
(57) **CLAIM**

DESCRIPTION

FIG. 1 is an environmental perspective view of the claimed design with a support pole and power cord disclaimed. FIG. 2 is a perspective view thereof. FIG. 3 is a top plan view thereof. FIG. 4 is a bottom plan view thereof. FIG. 5 is a right side elevation view thereof. FIG. 6 is a left side elevation view thereof. 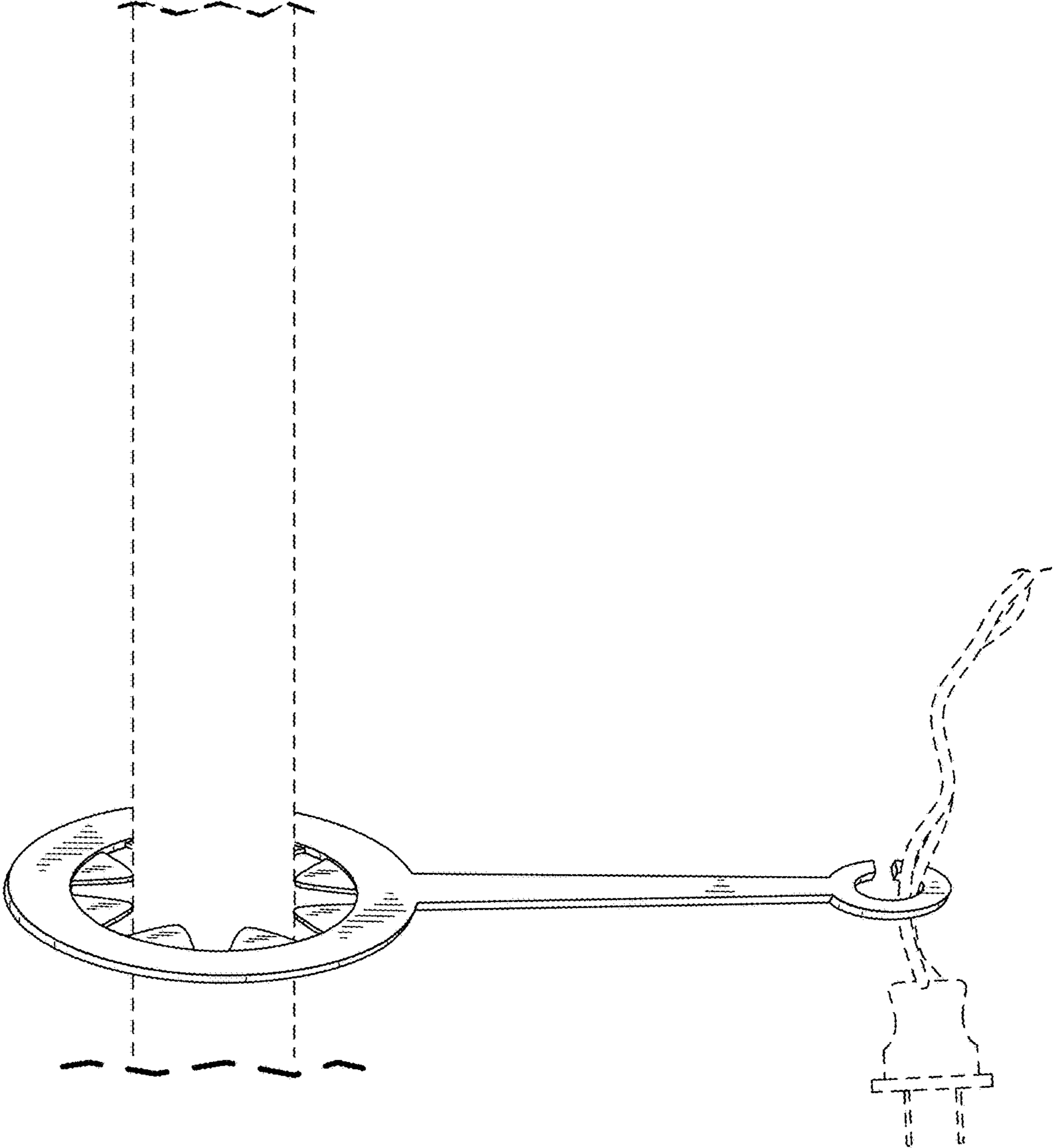

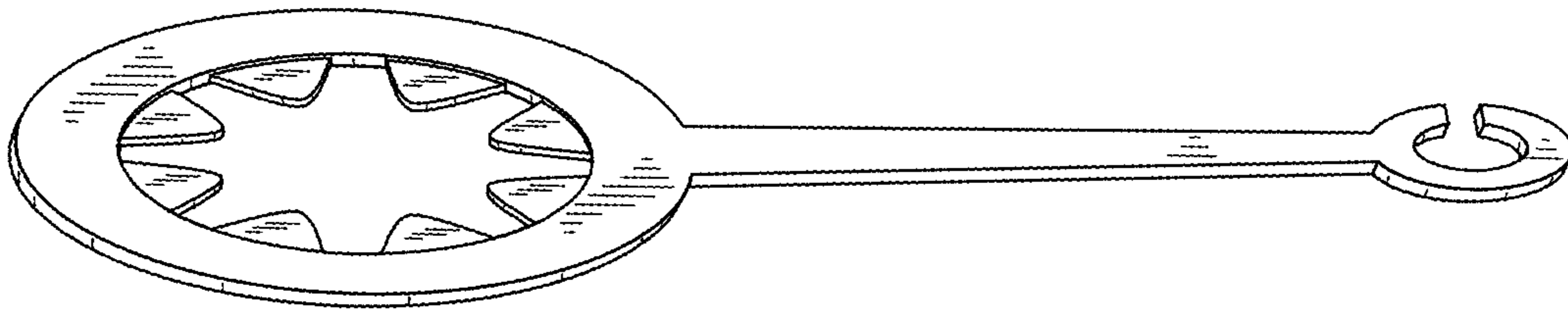

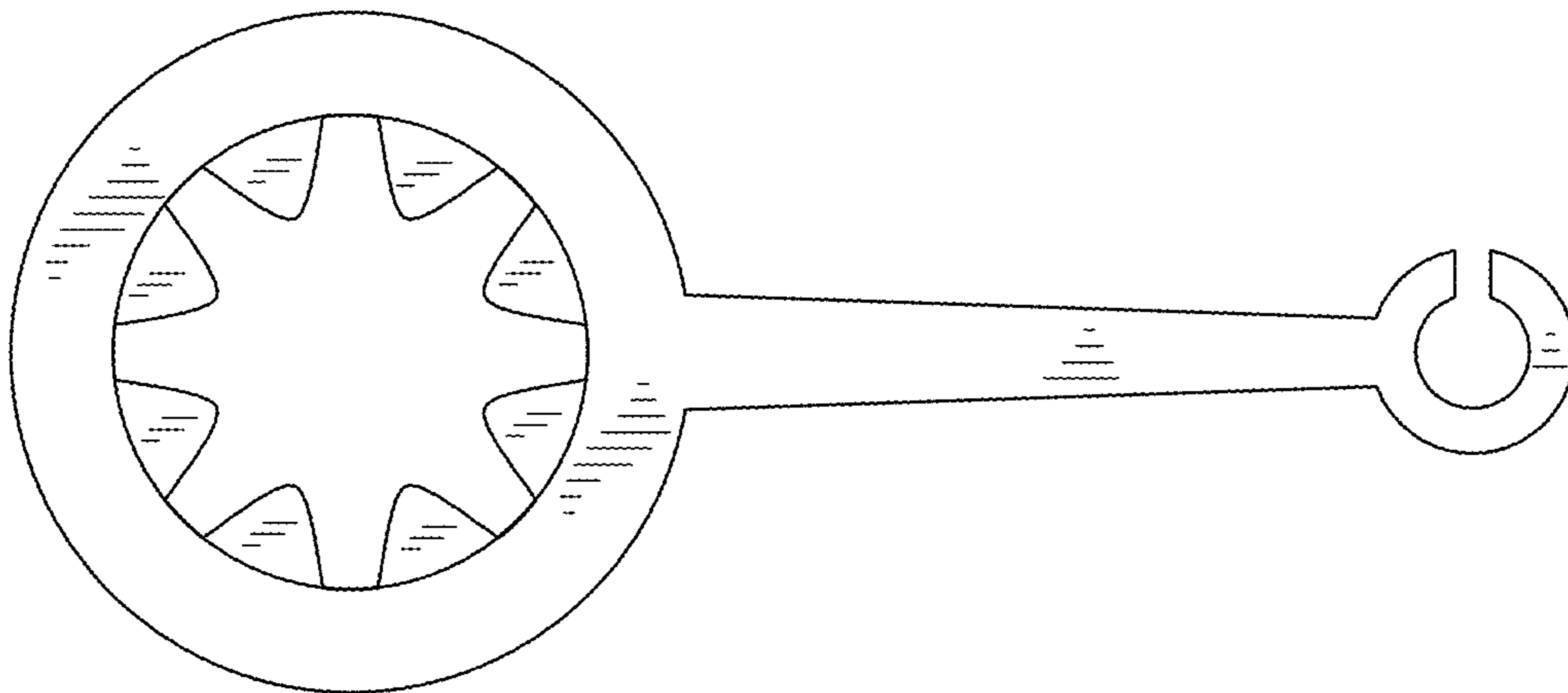

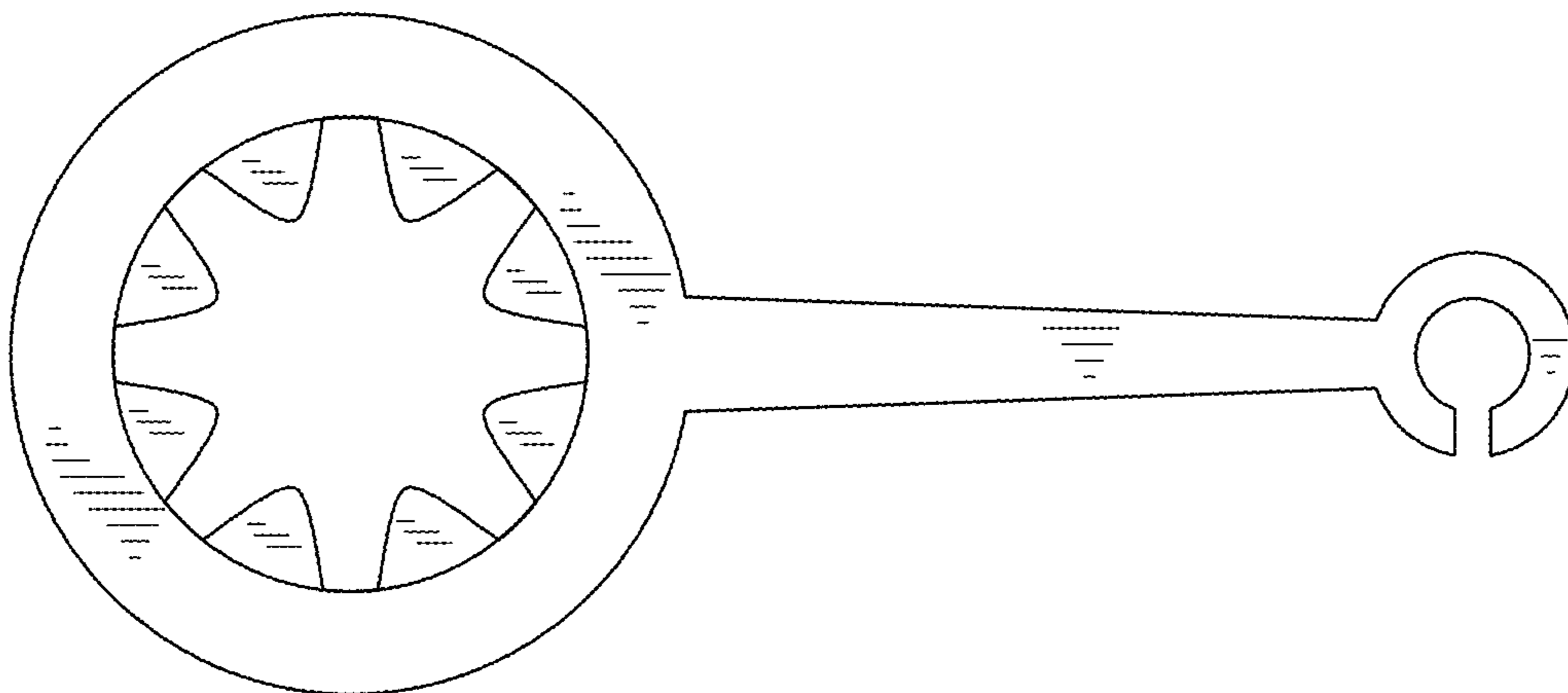

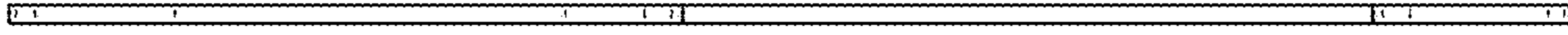

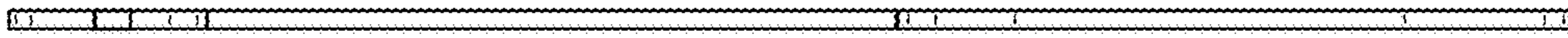

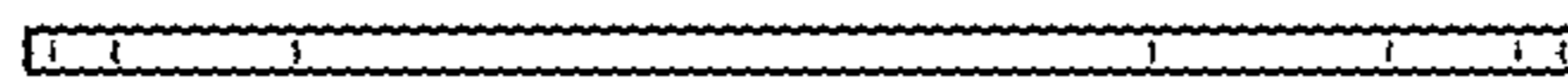

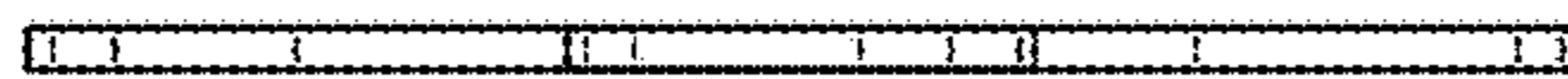
