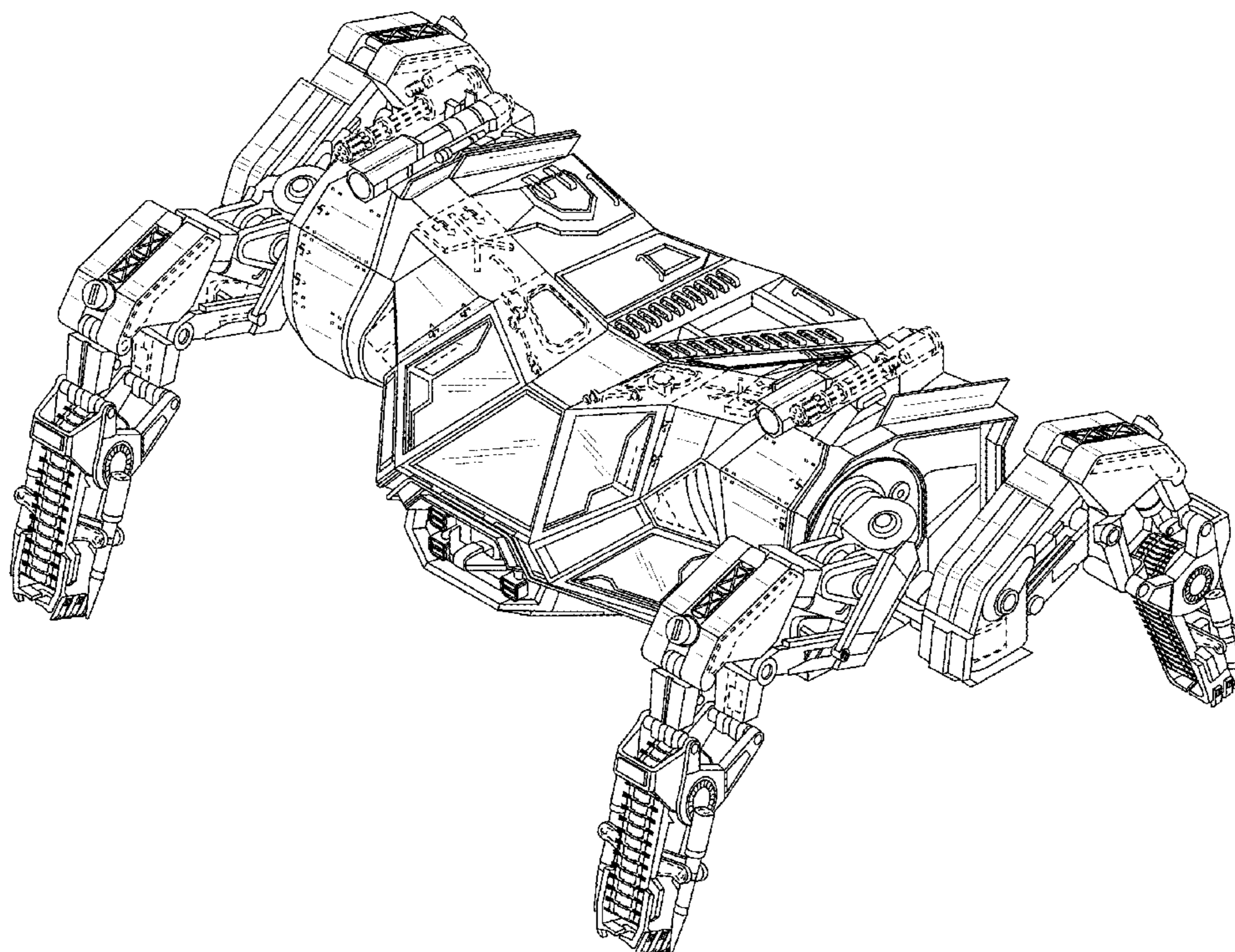
The ornamental design for a vehicle and toy vehicle, as shown and described.

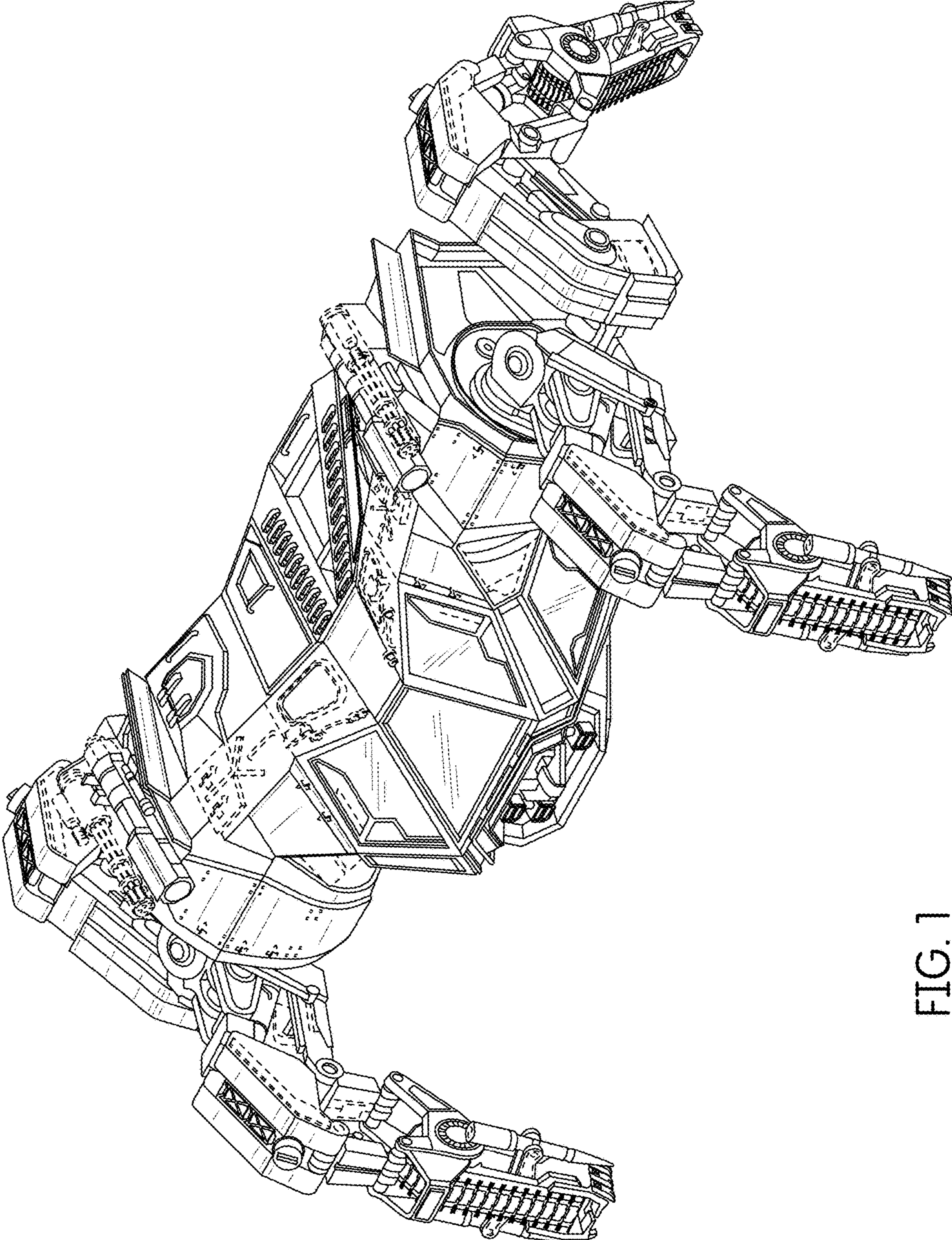

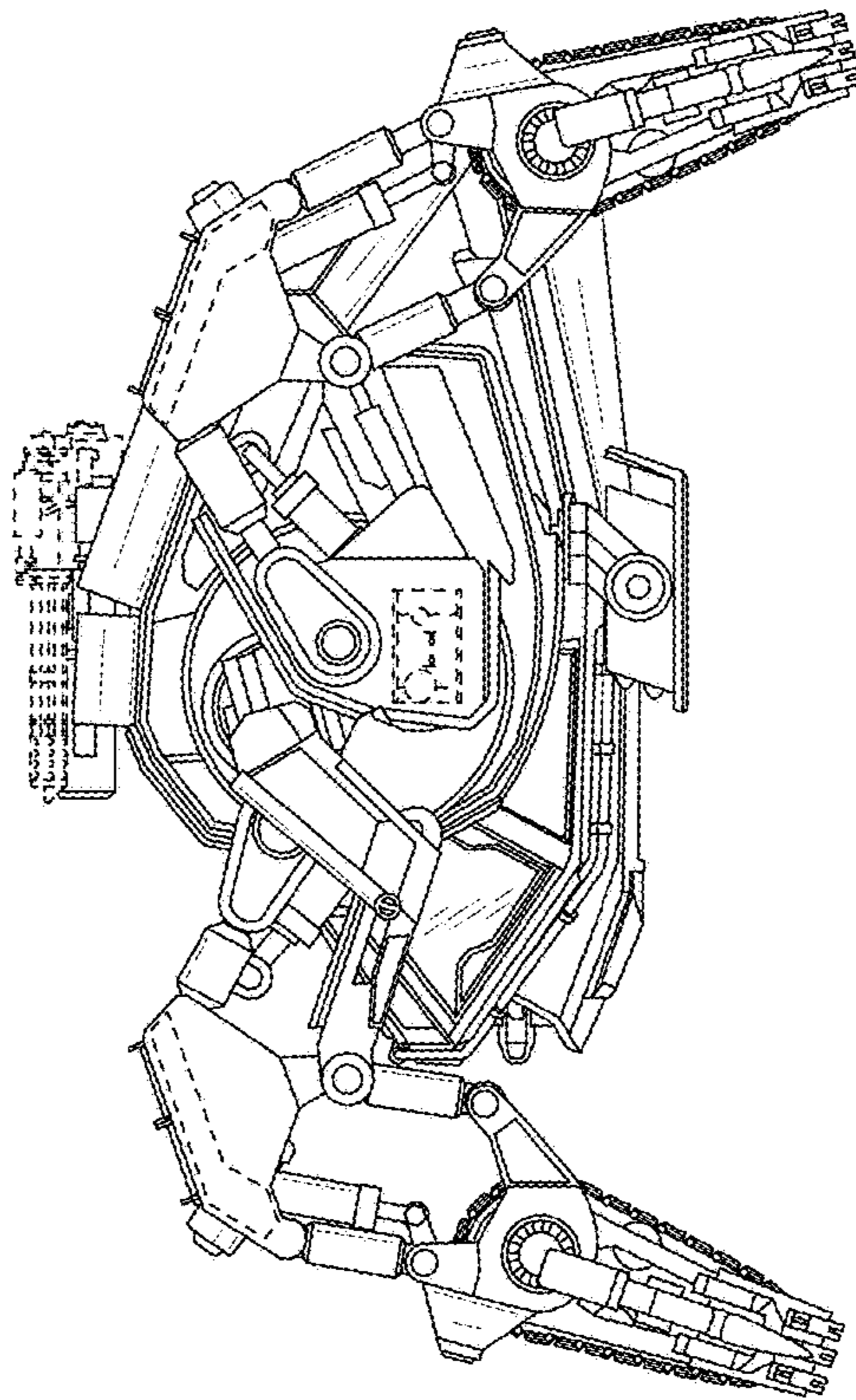

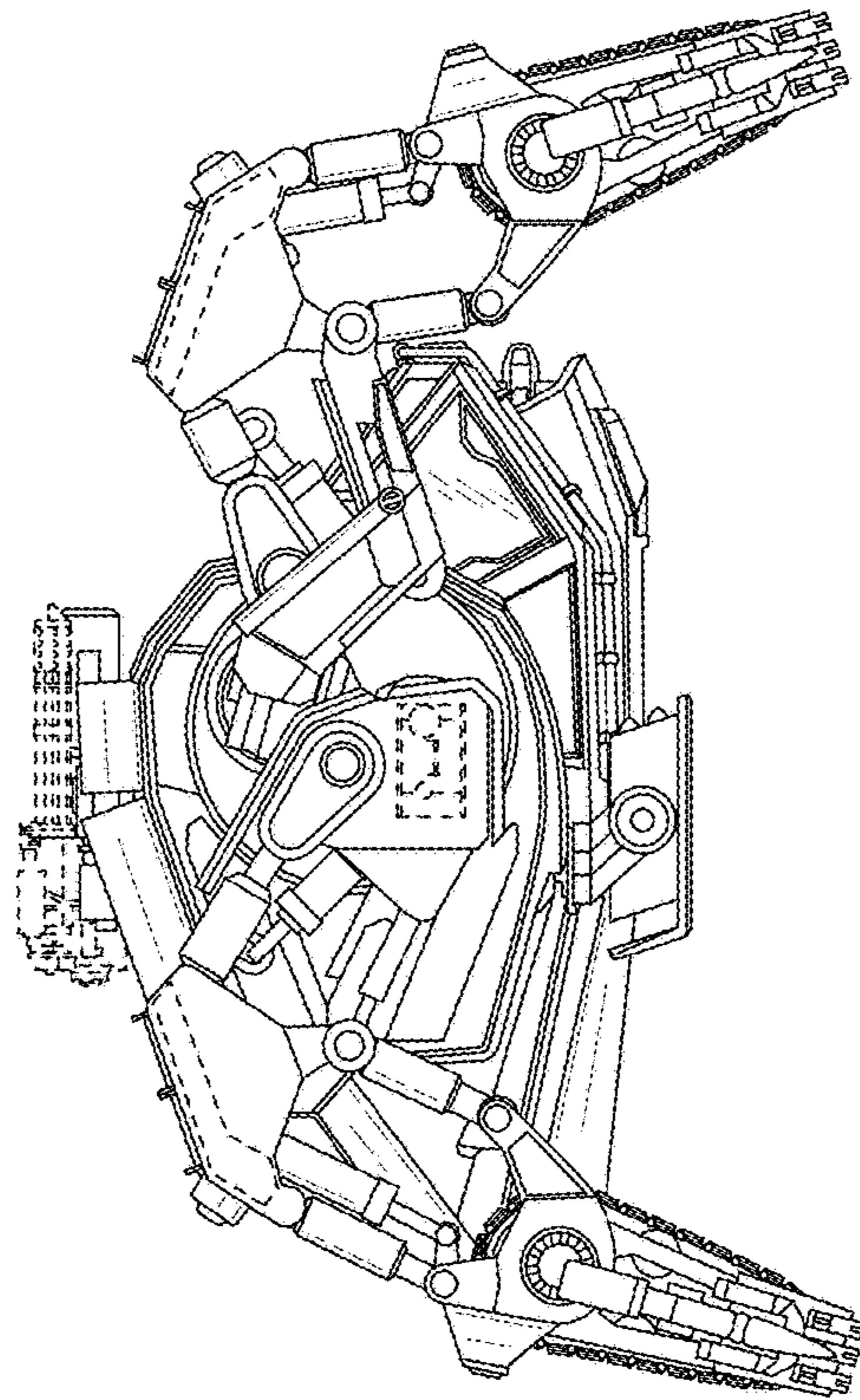

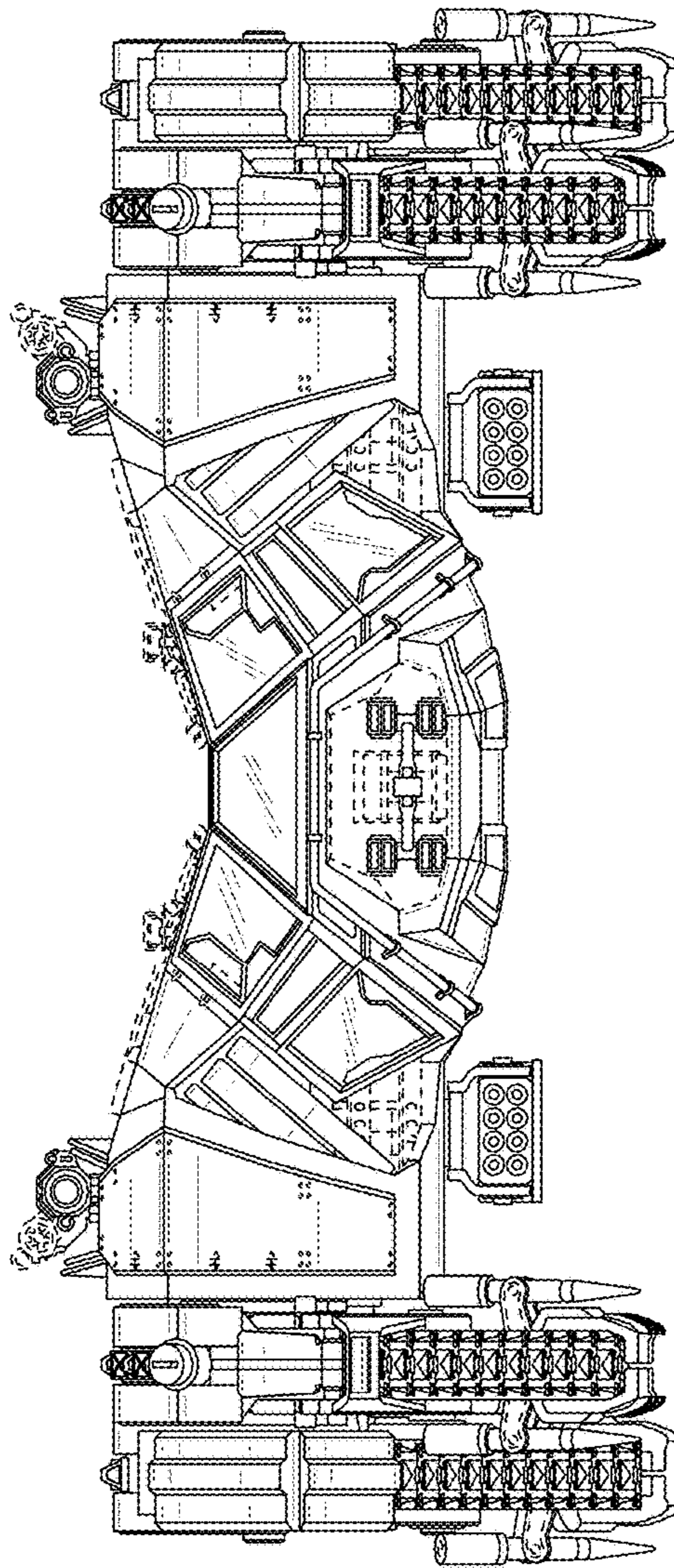

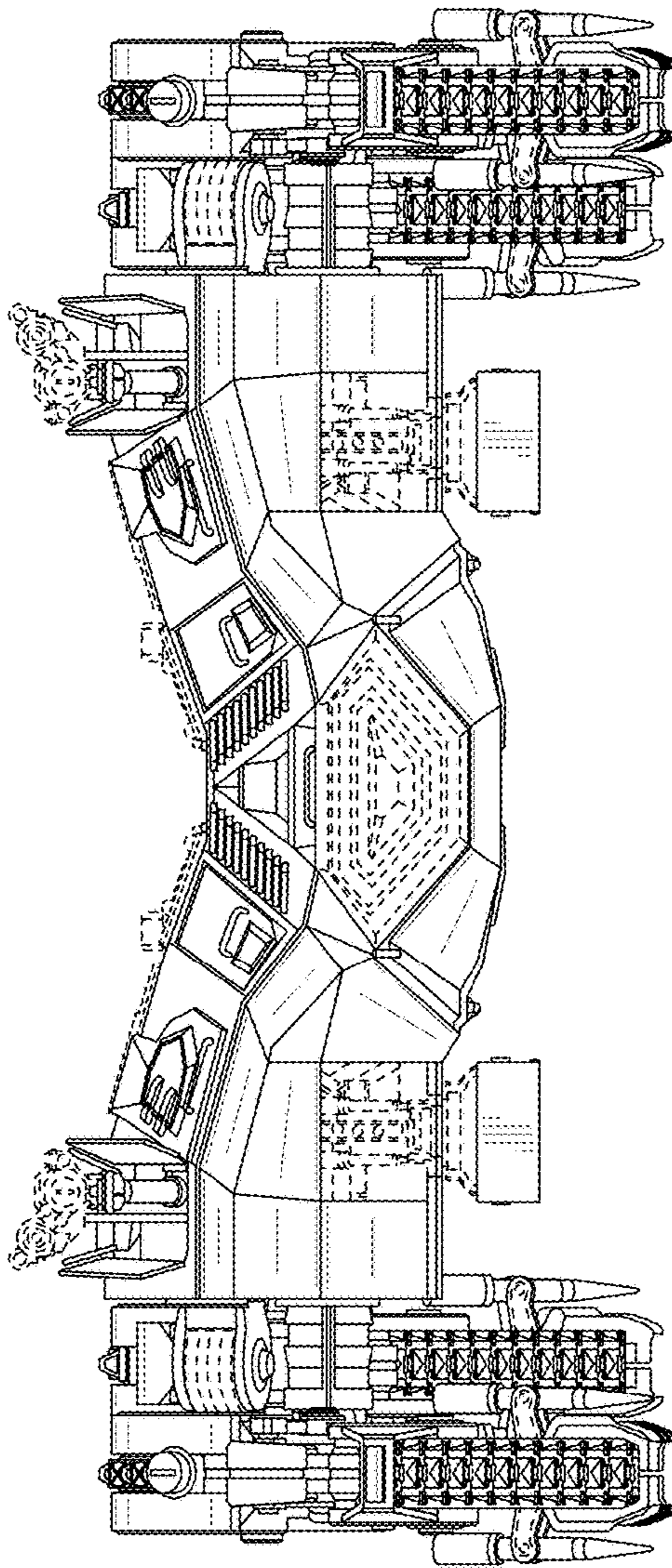

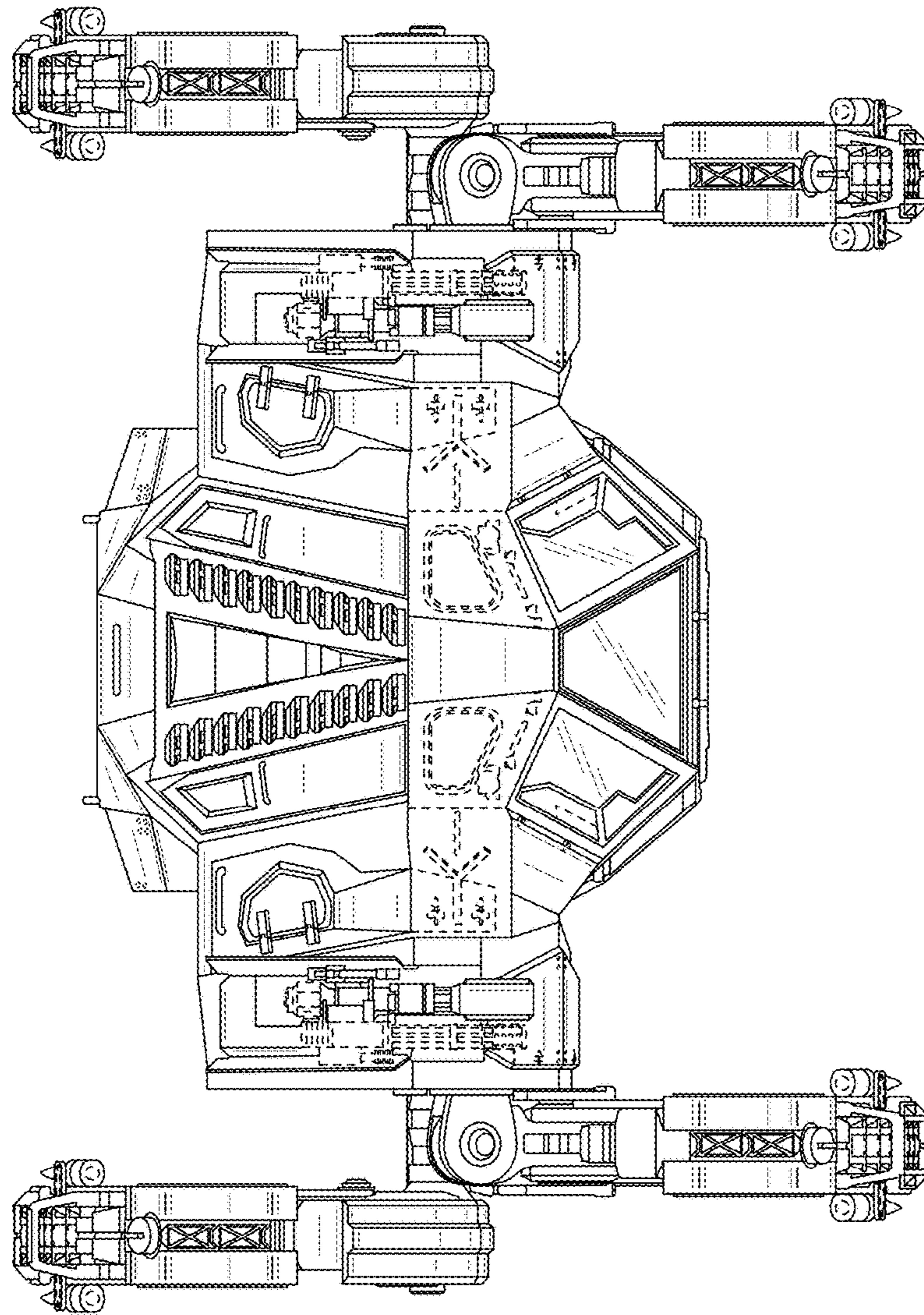

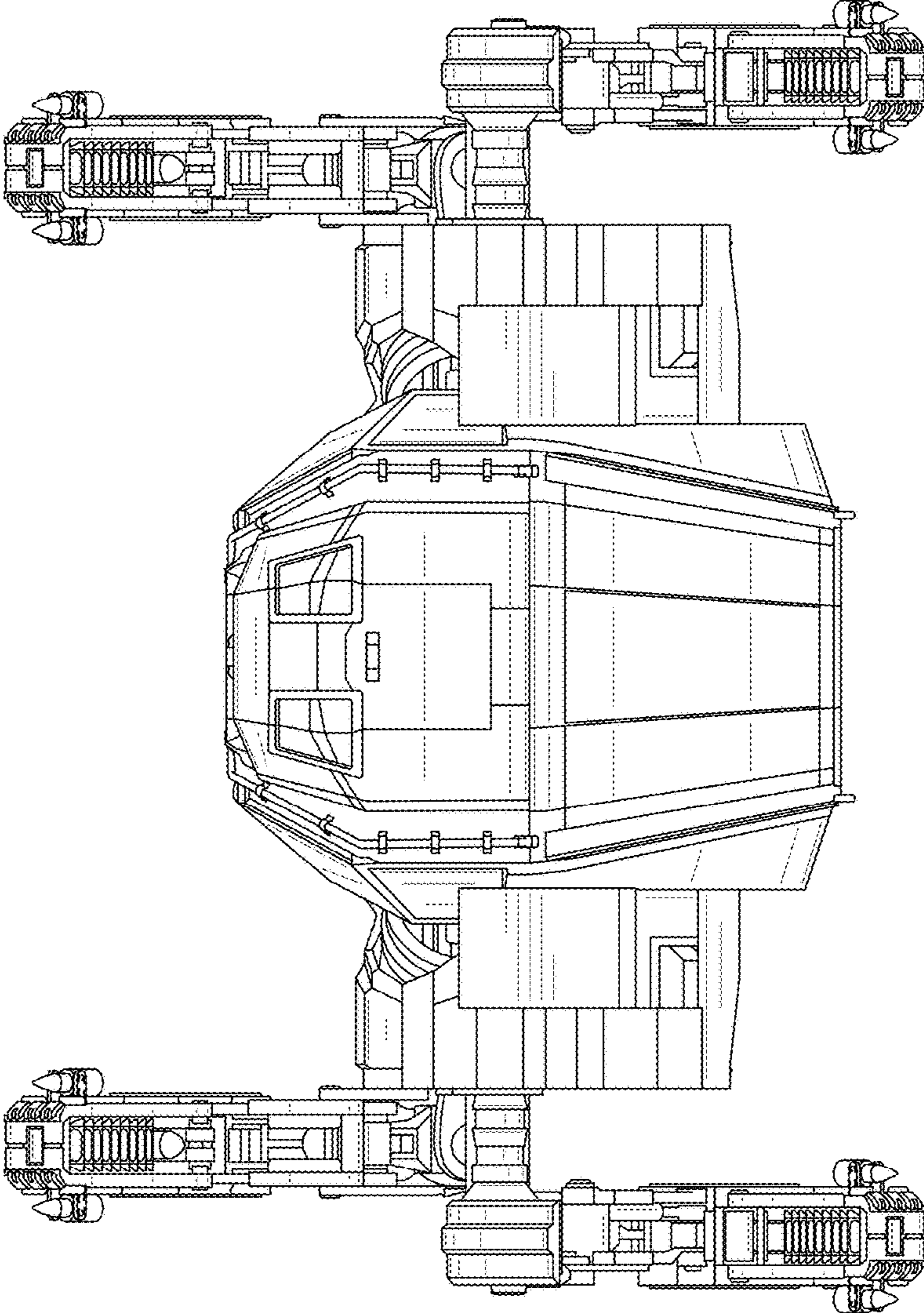
