FIG. 4 is an elevation view thereof from the left side;

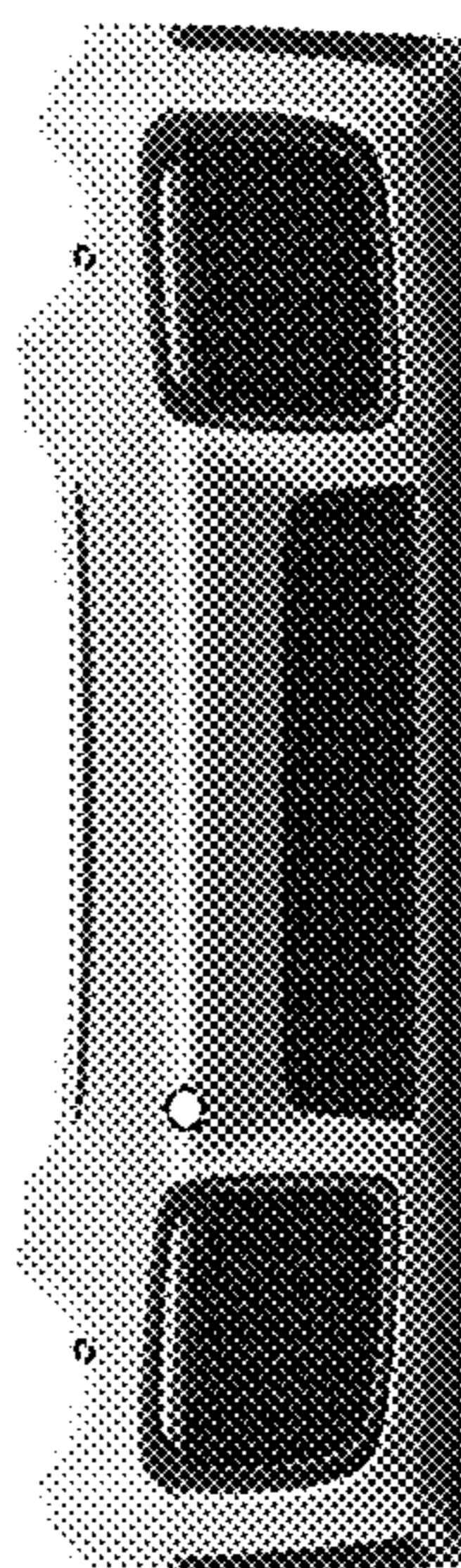
FIG. 5 is an elevation view thereof from the right side; and,

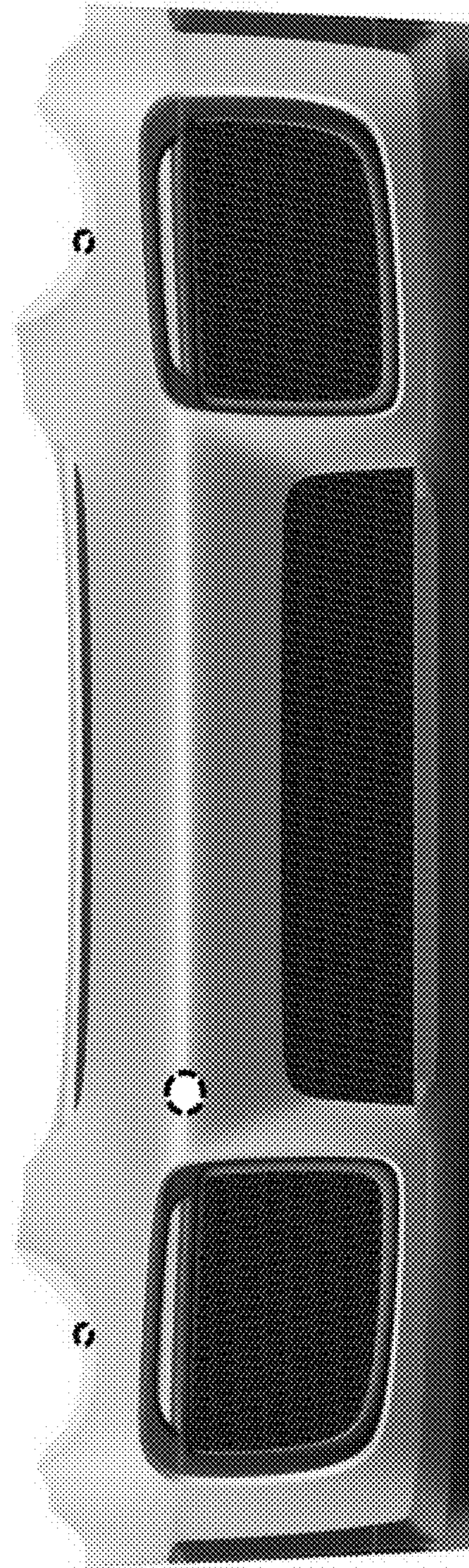

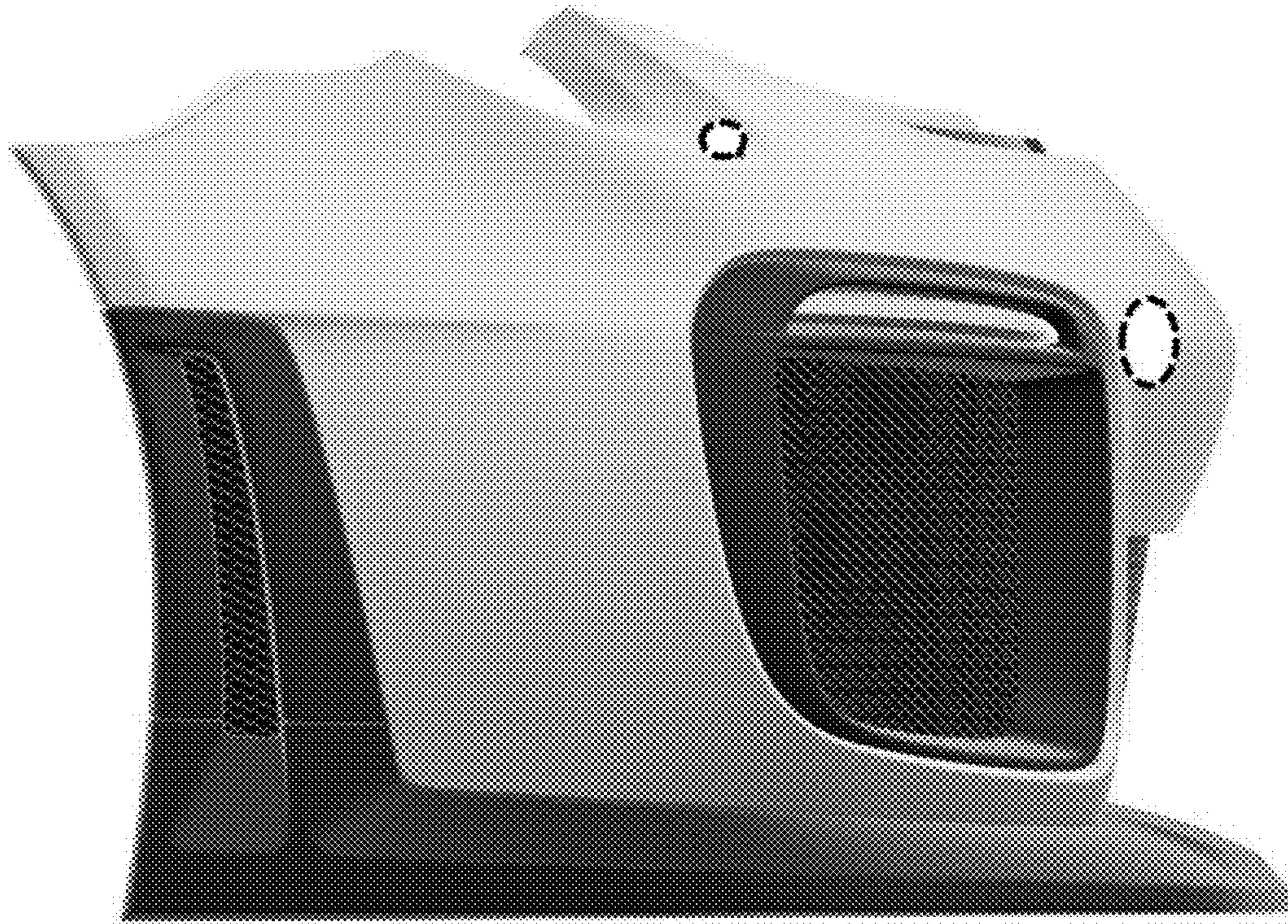

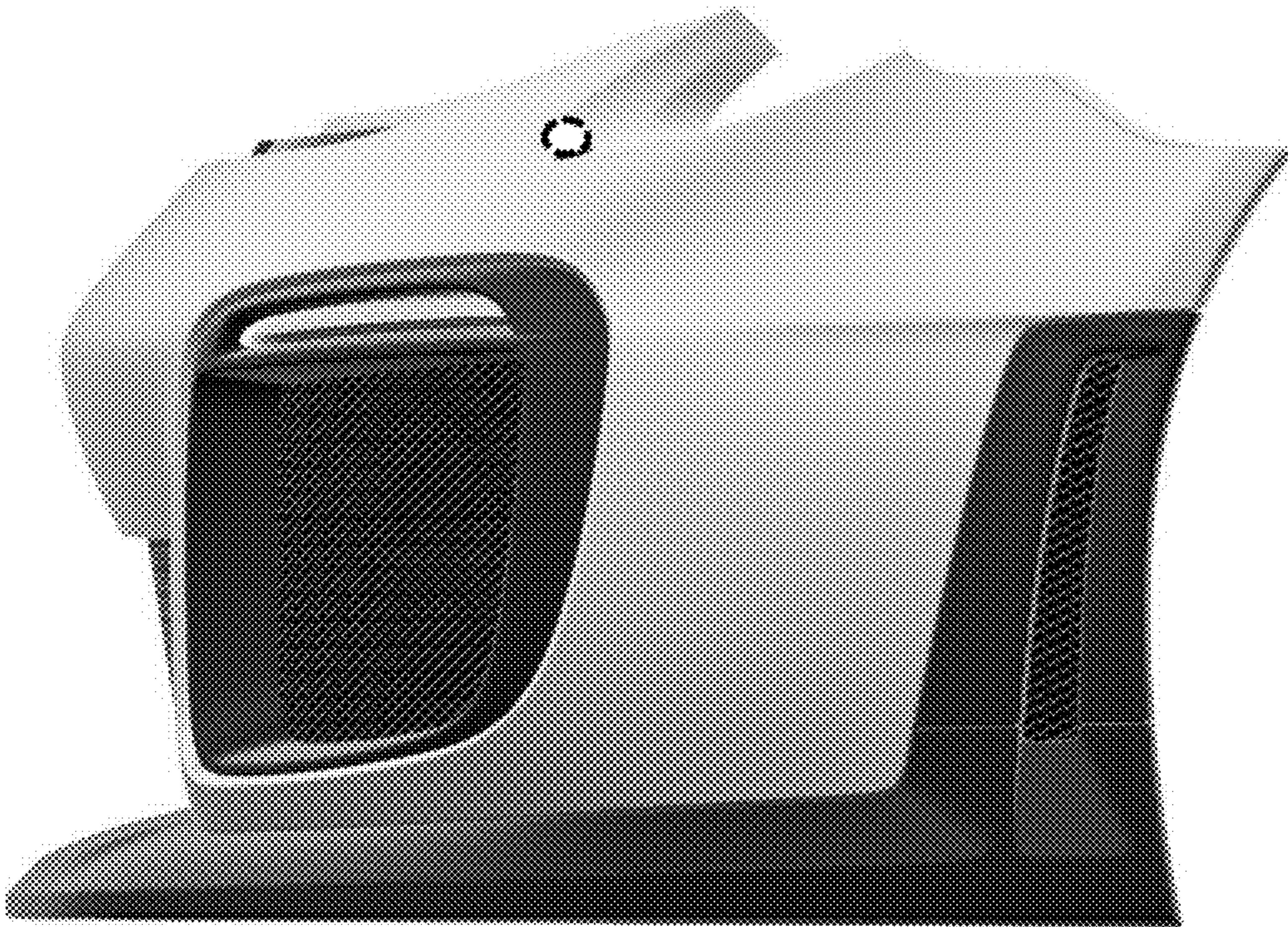
