(57) **CLAIM**

The ornamental design for a tailgate liftback for a vehicle,
as shown and described.

DESCRIPTION

FIG. 1 is a front right perspective view of a tailgate liftback
for a vehicle according to the present invention.

FIG. 2 is a front left perspective view of the tailgate liftback
shown in FIG. 1.

FIG. 3 is a rear left bottom perspective view thereof.

FIG. 4 is a rear right bottom perspective view thereof.

FIG. 5 is a front view thereof.

FIG. 6 is a rear view thereof.

FIG. 7 is a left side view thereof.

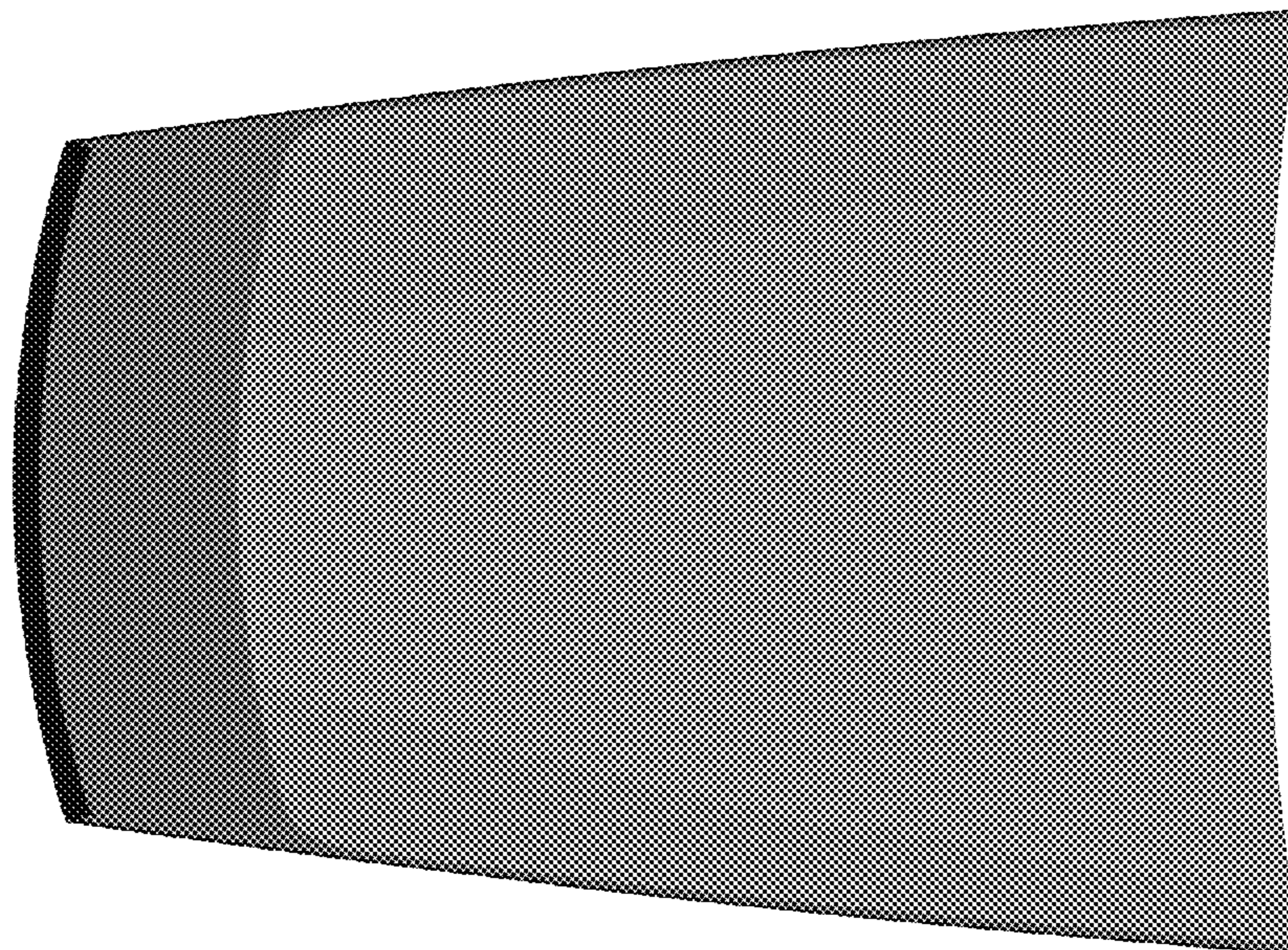
FIG. 8 is a right side view thereof.

FIG. 9 is a top view thereof.

FIG. 10 is a bottom view thereof; and,

FIG. 11 is a top view of the tailgate liftback shown in FIG.
1-10, but with the tailgate liftback mounted on a vehicle, and
the rest of the vehicle shown in de-emphasized and half-tone
portions so as to illustrate environmental structure. These
portions form no part of the claimed invention. More par-
ticularly, in FIG. 11, the inventive tailgate liftback is shown
within the broken line, and the elements shown outside the
broken line form no part of the claimed invention, but are
instead included to show environmental aspects thereof.

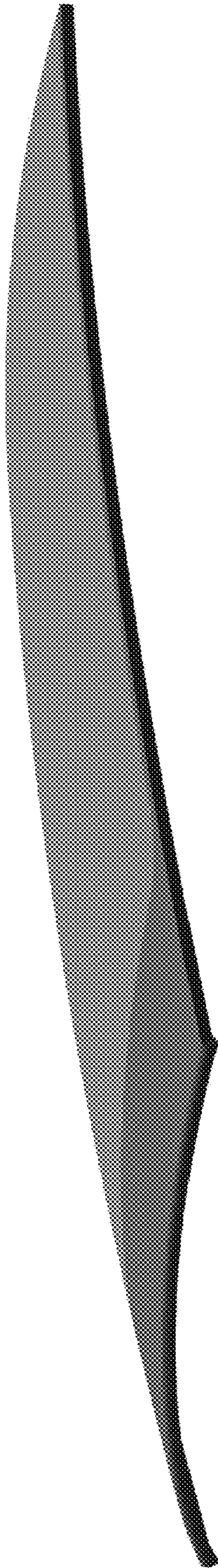

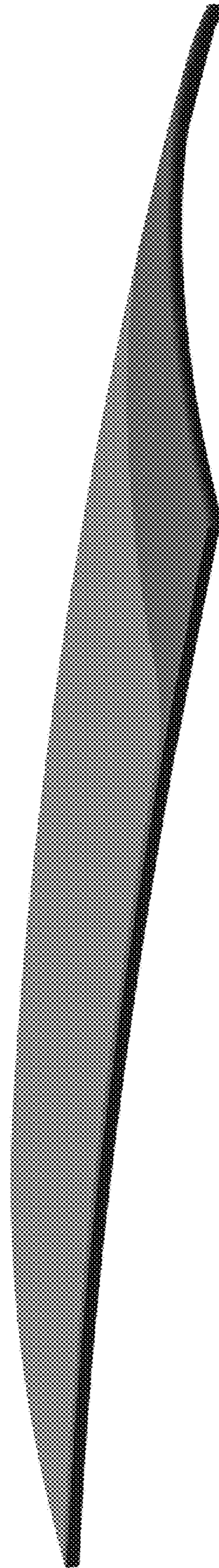

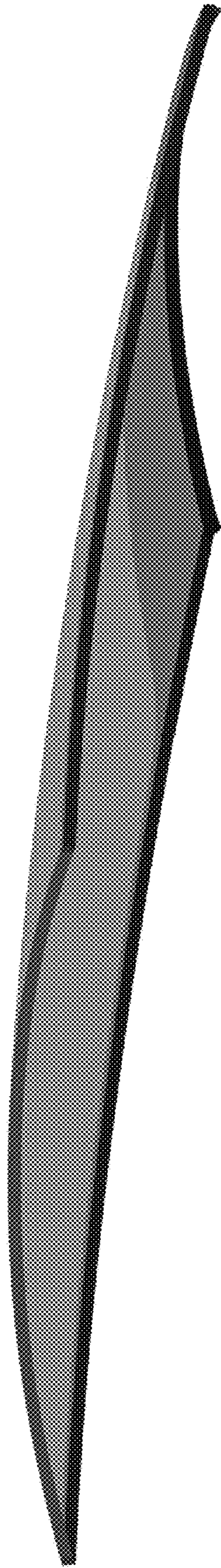

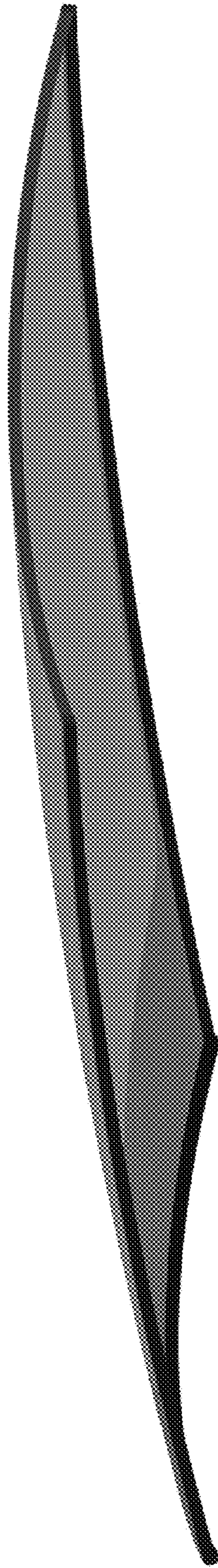

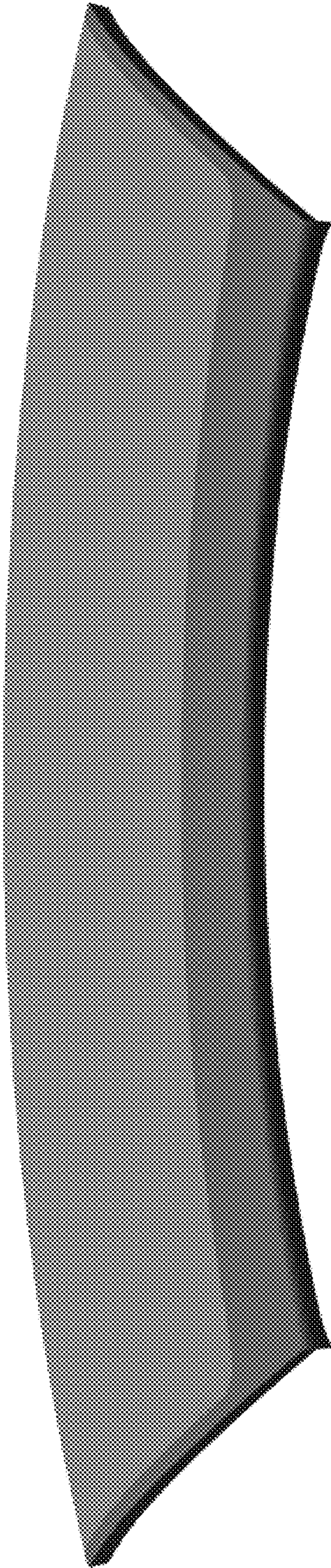

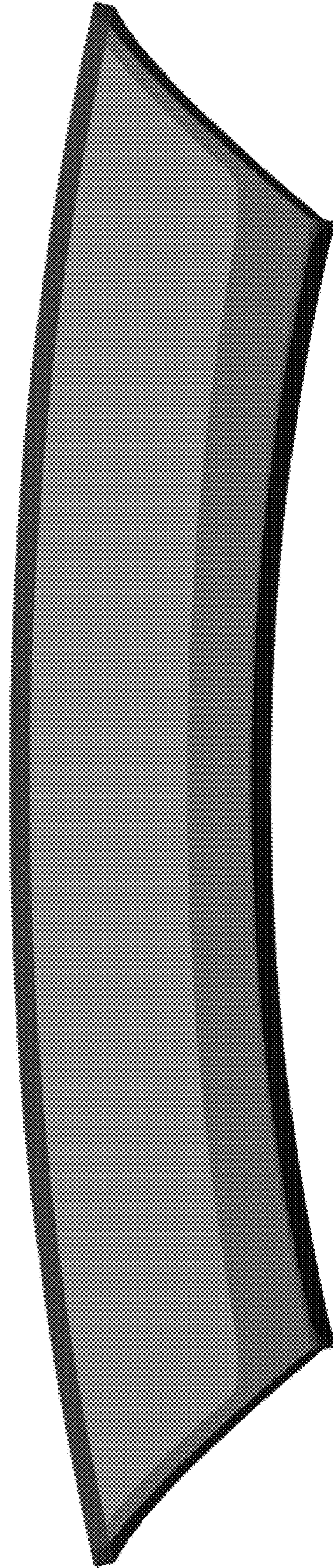

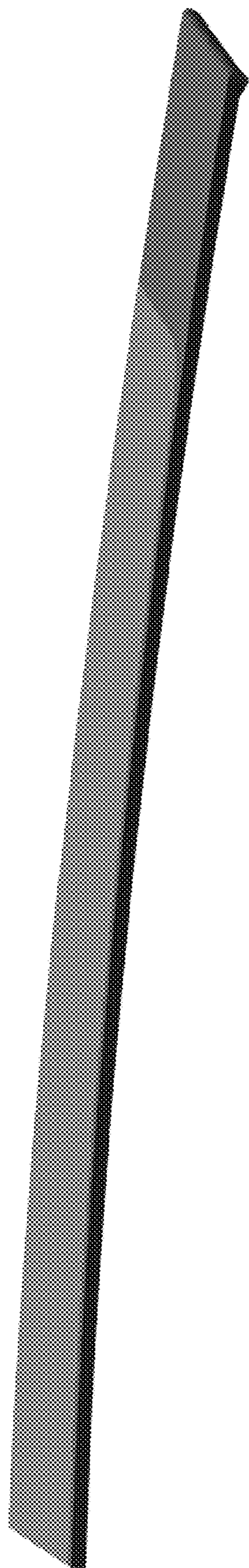

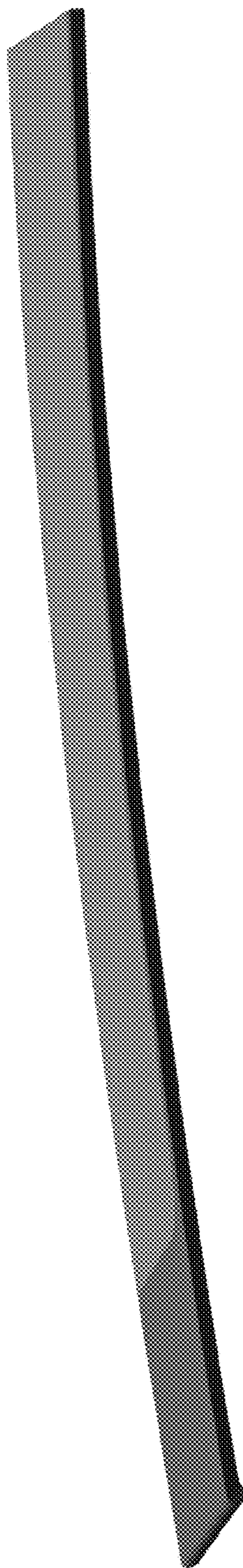

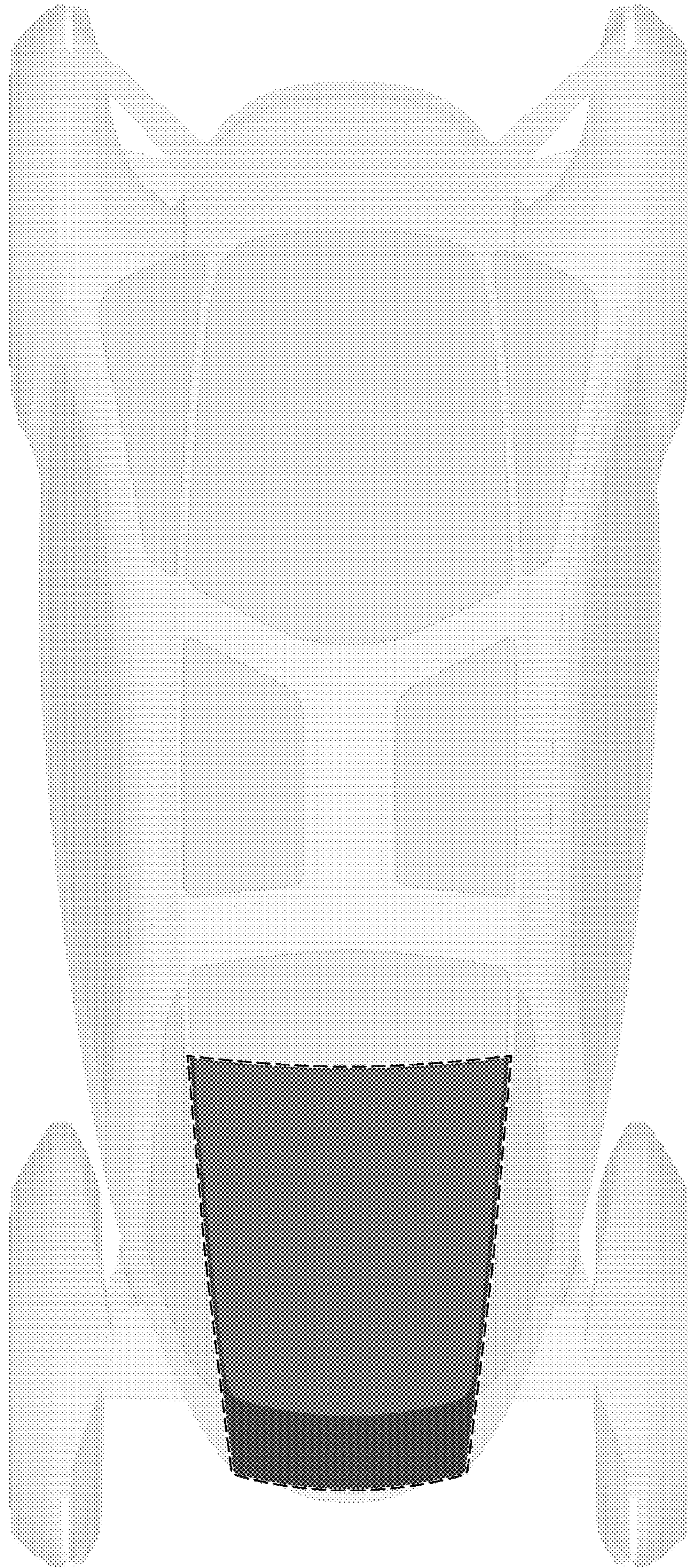
