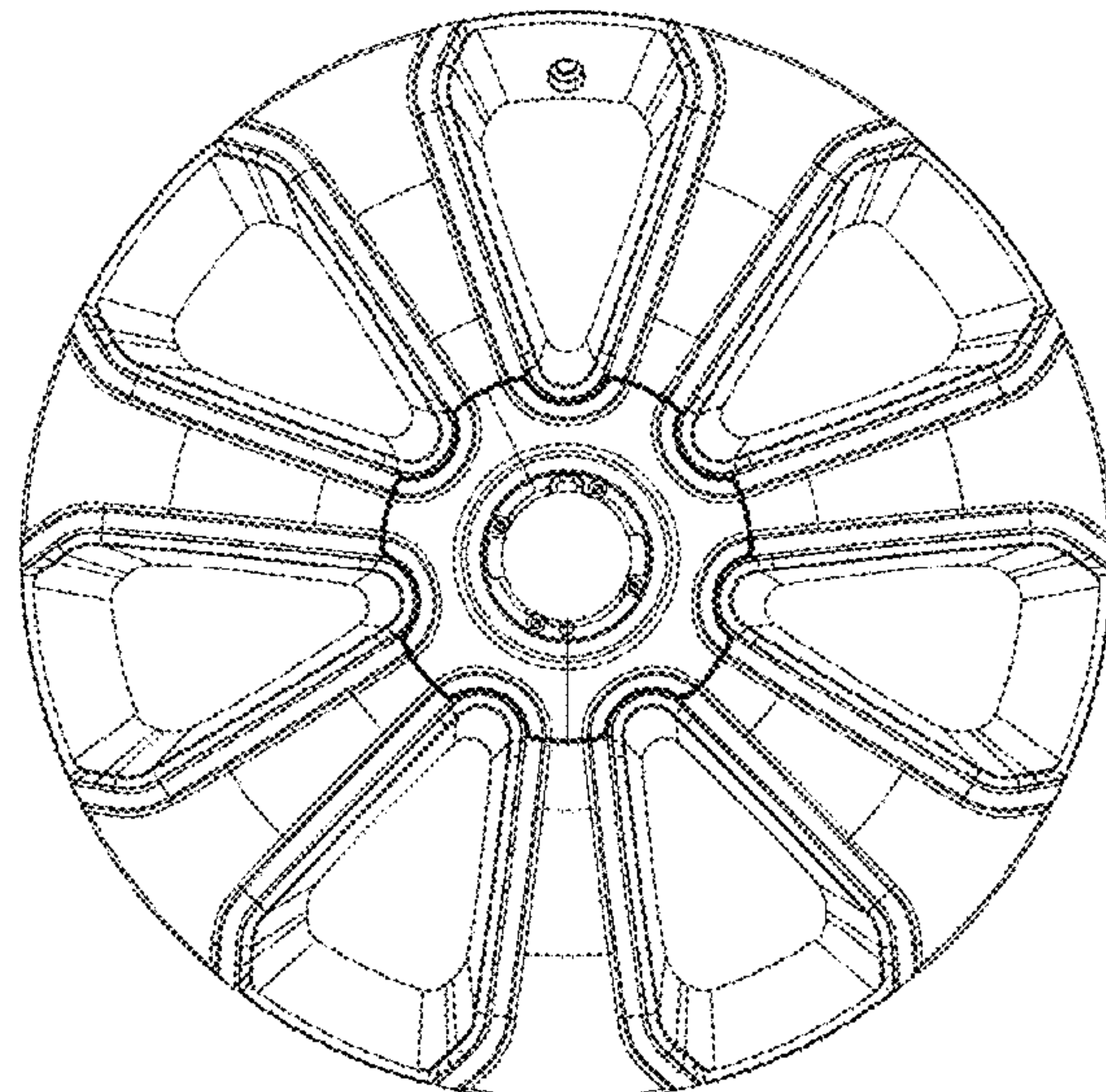
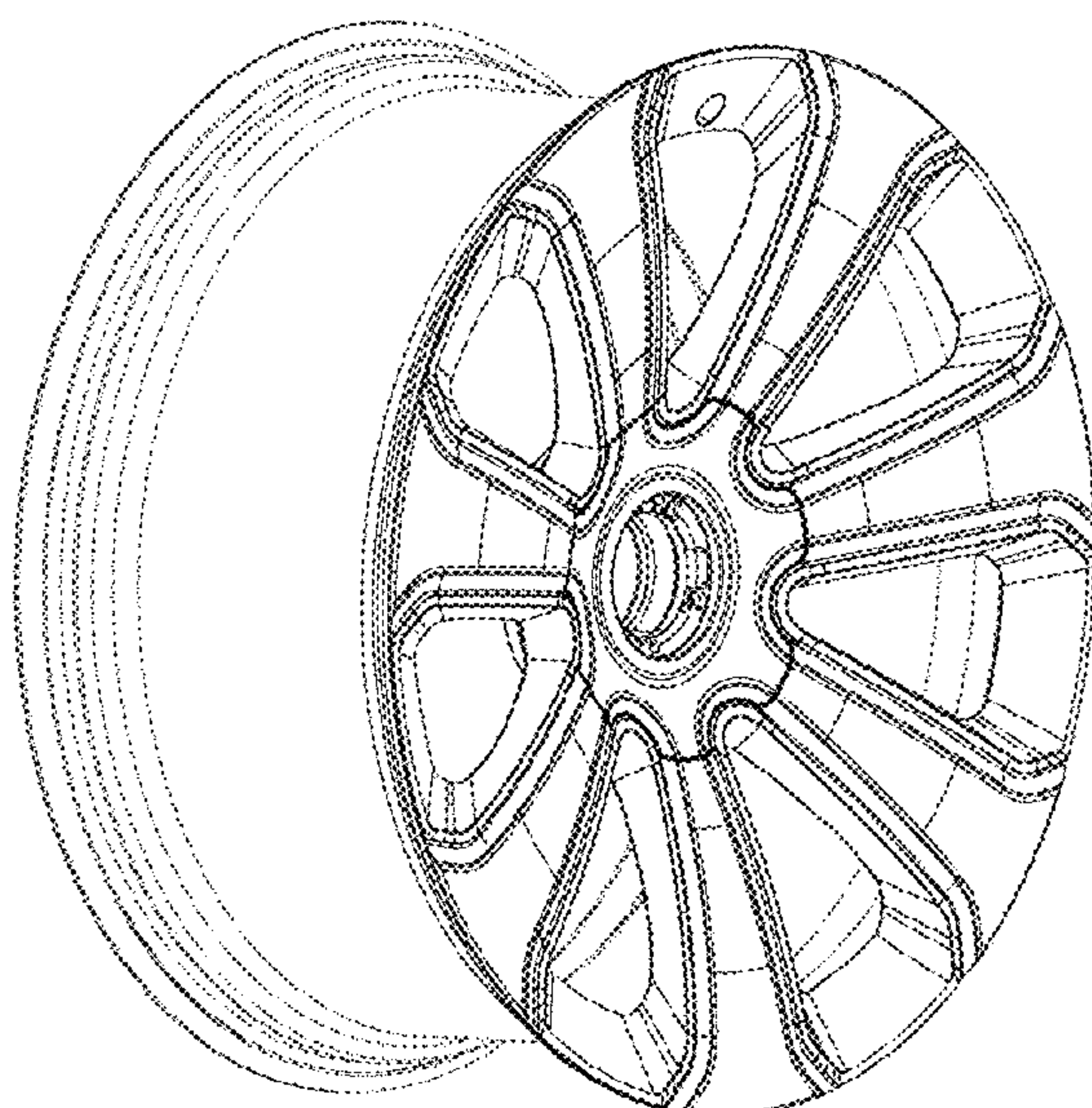
I claim the ornamental design for a wheel for motor vehicle,

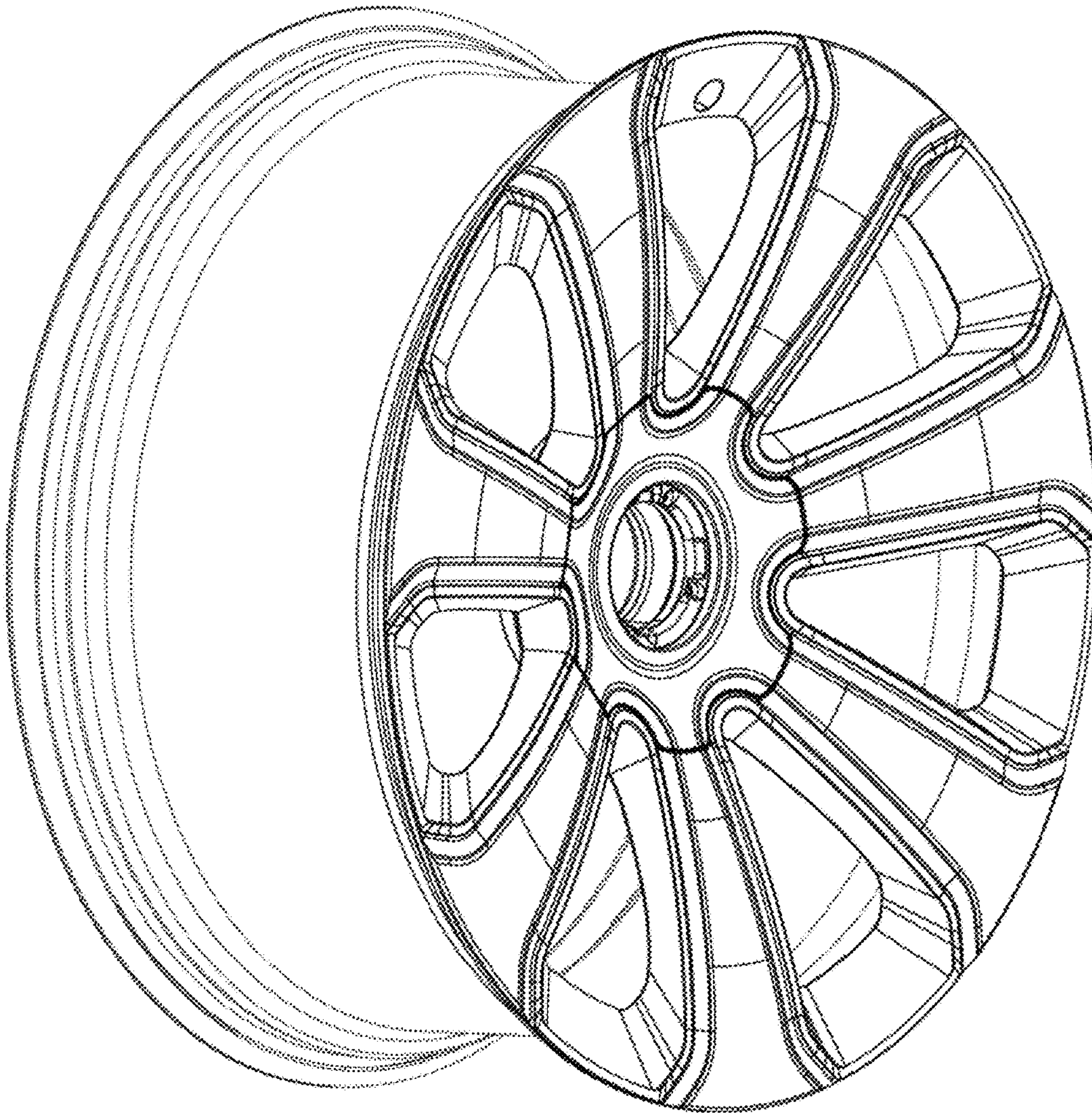

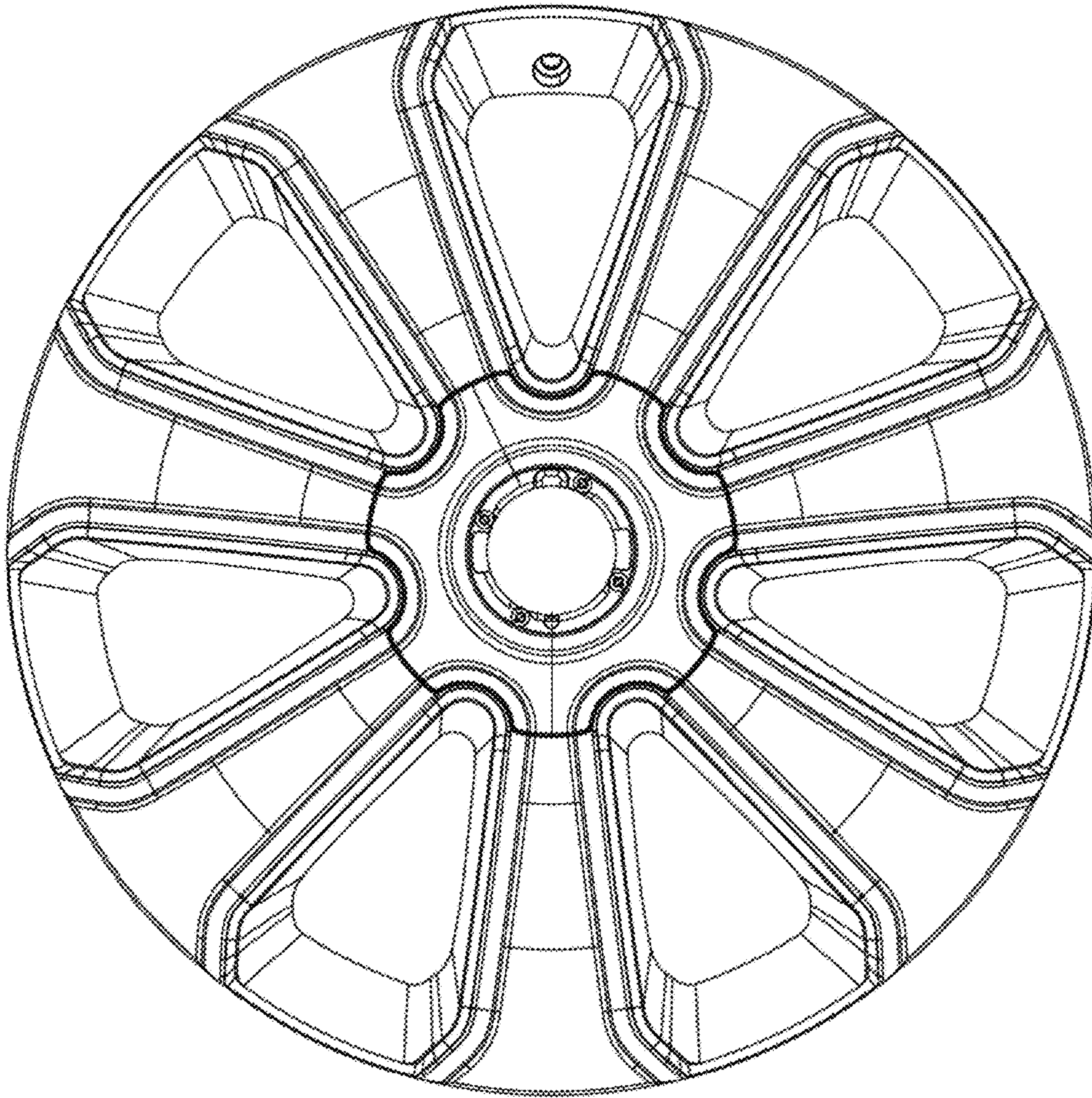

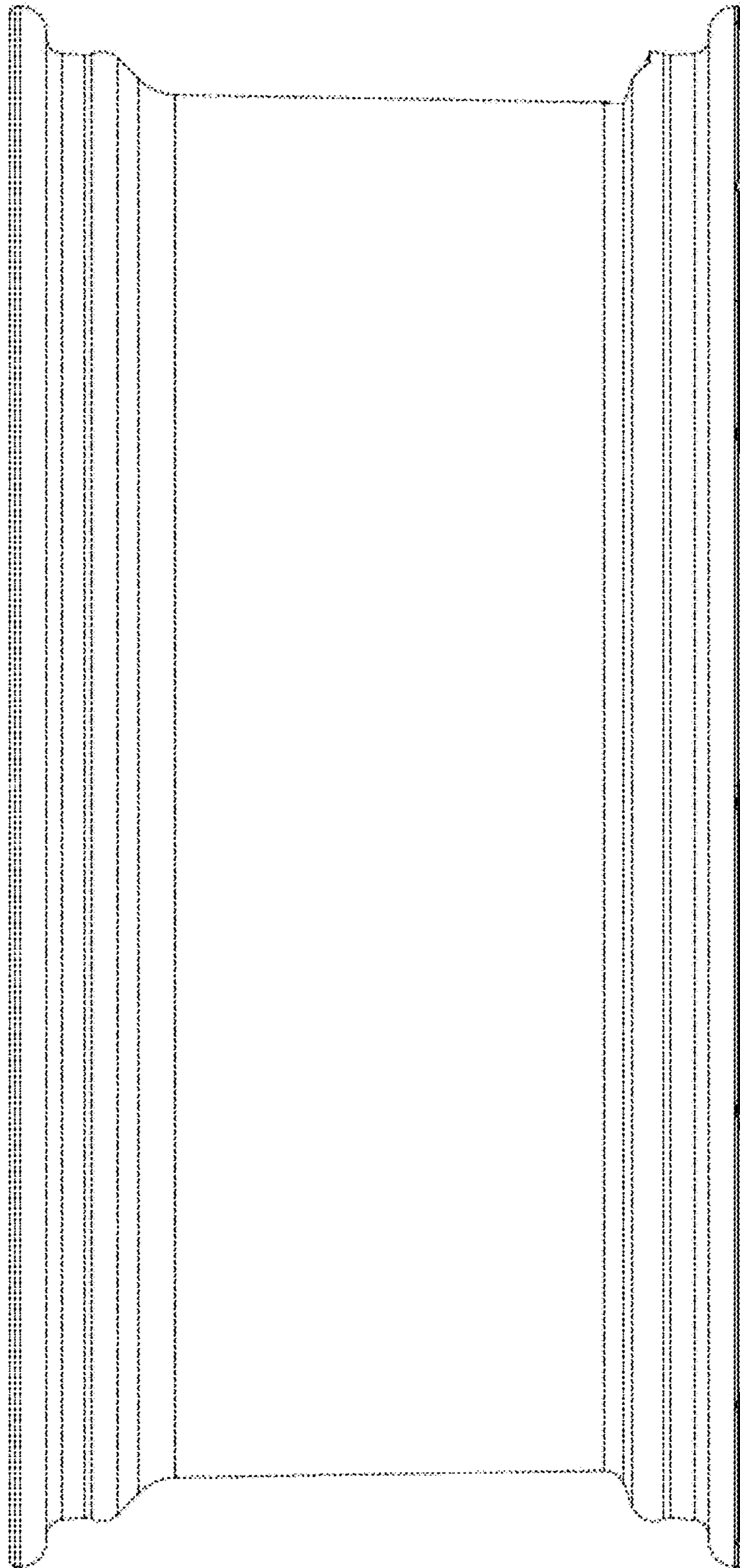
