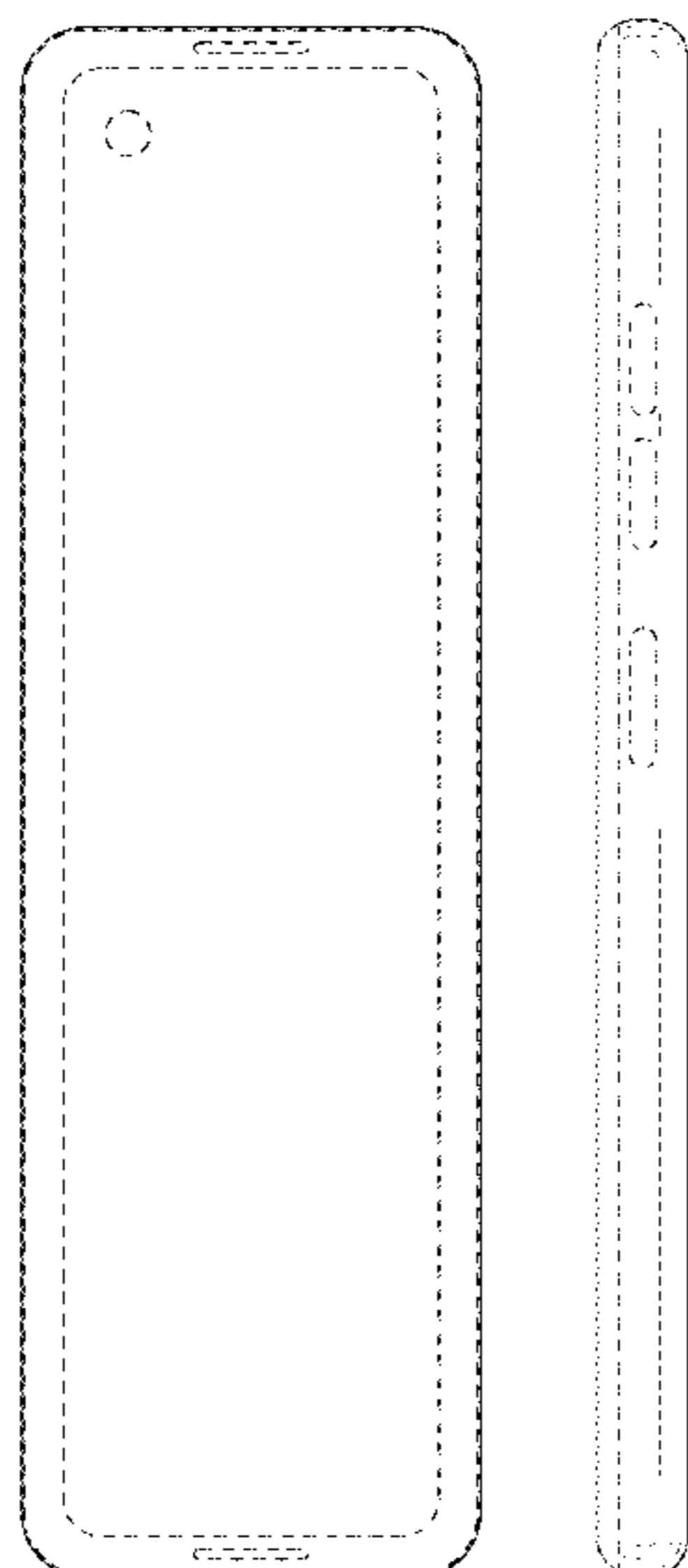
The ornamental design for a mobile device, as shown and described.

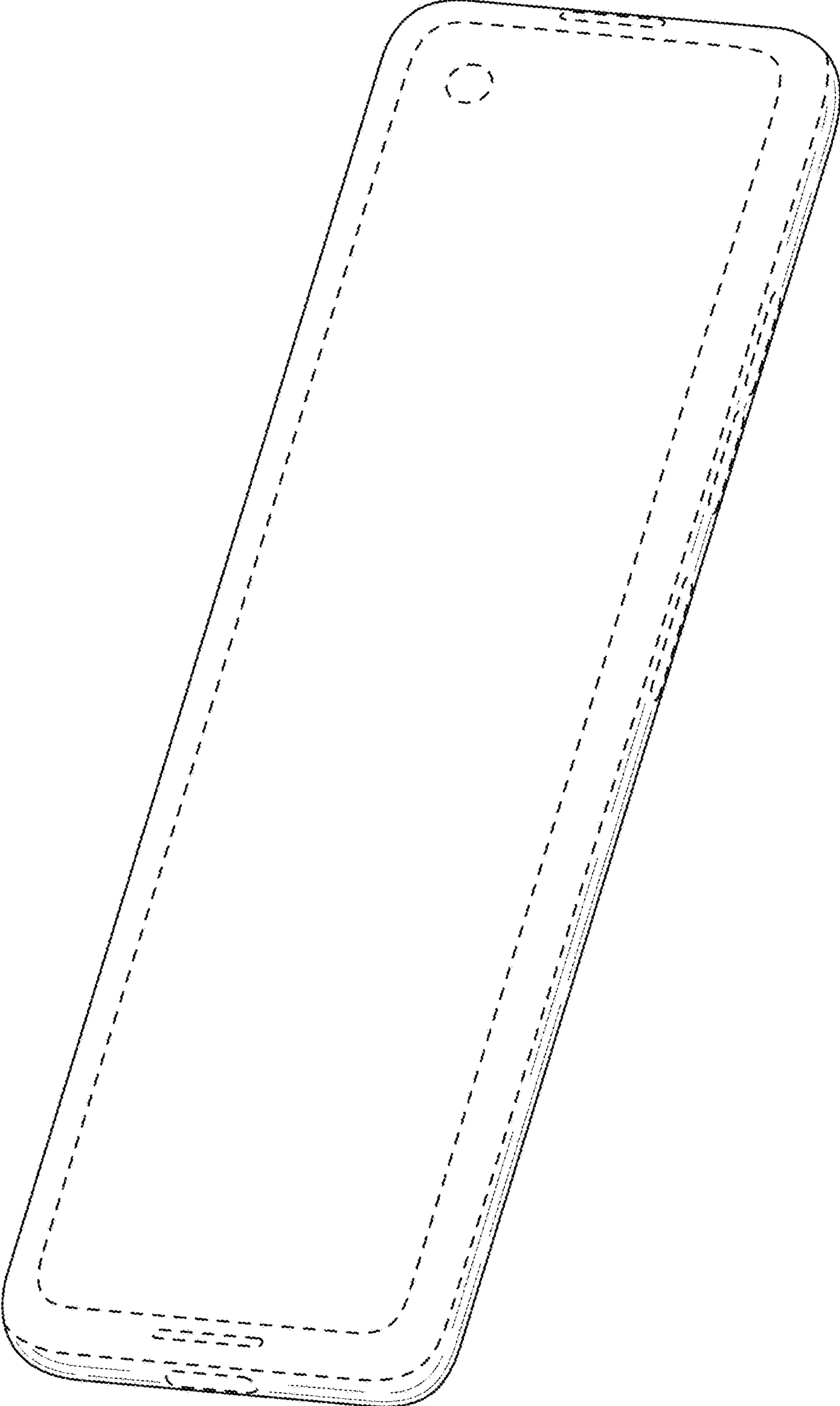

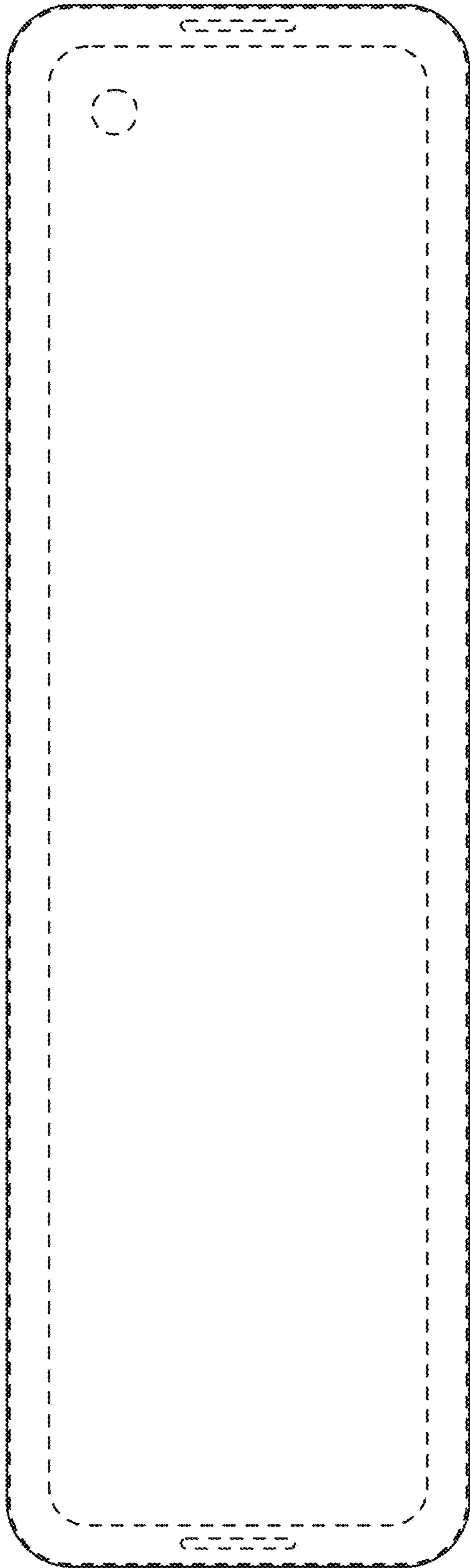

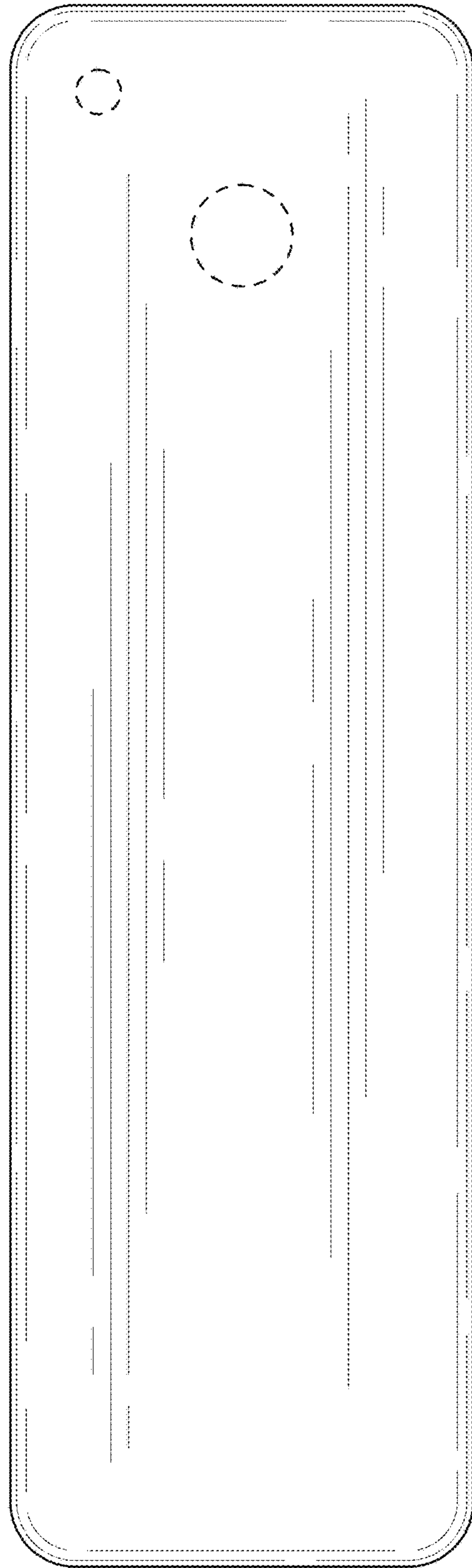

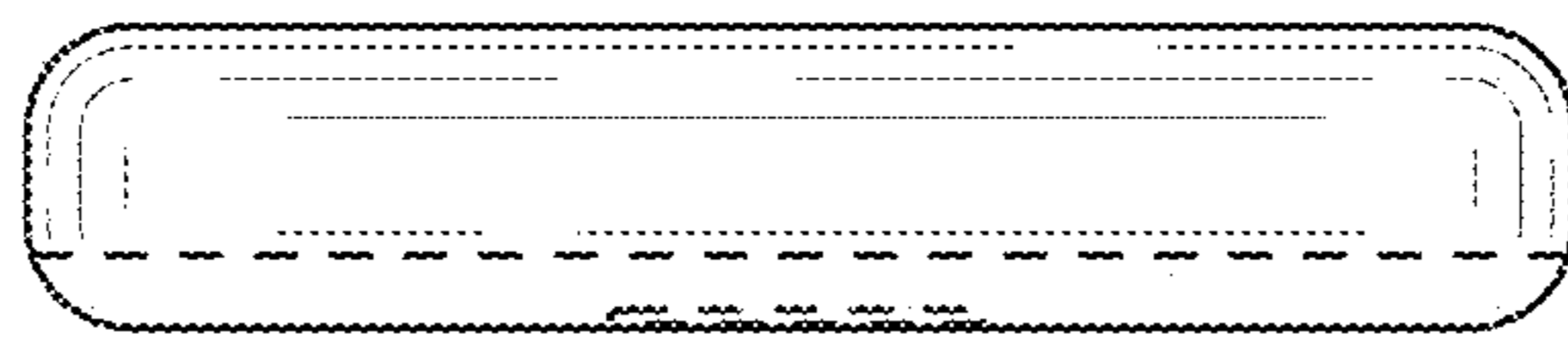

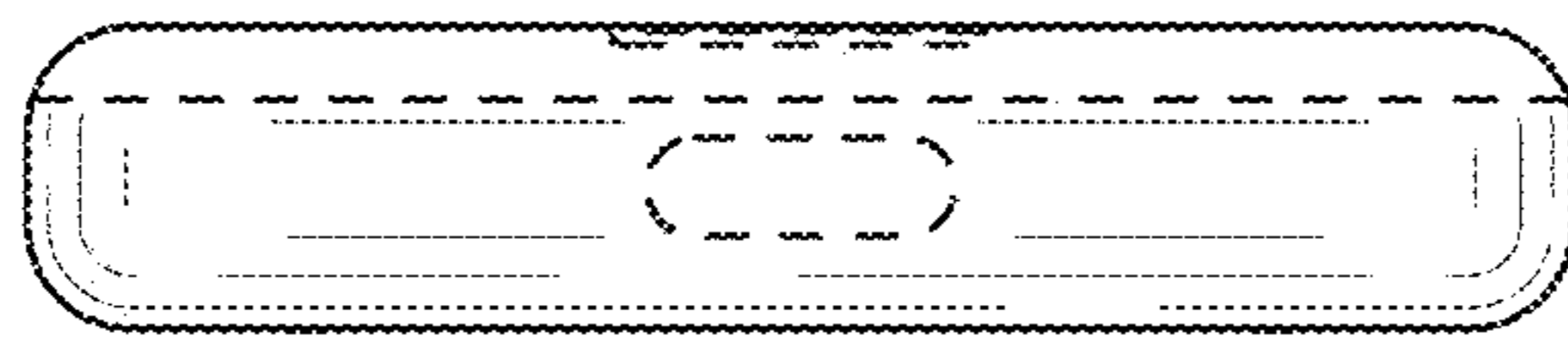
