DESCRIPTION

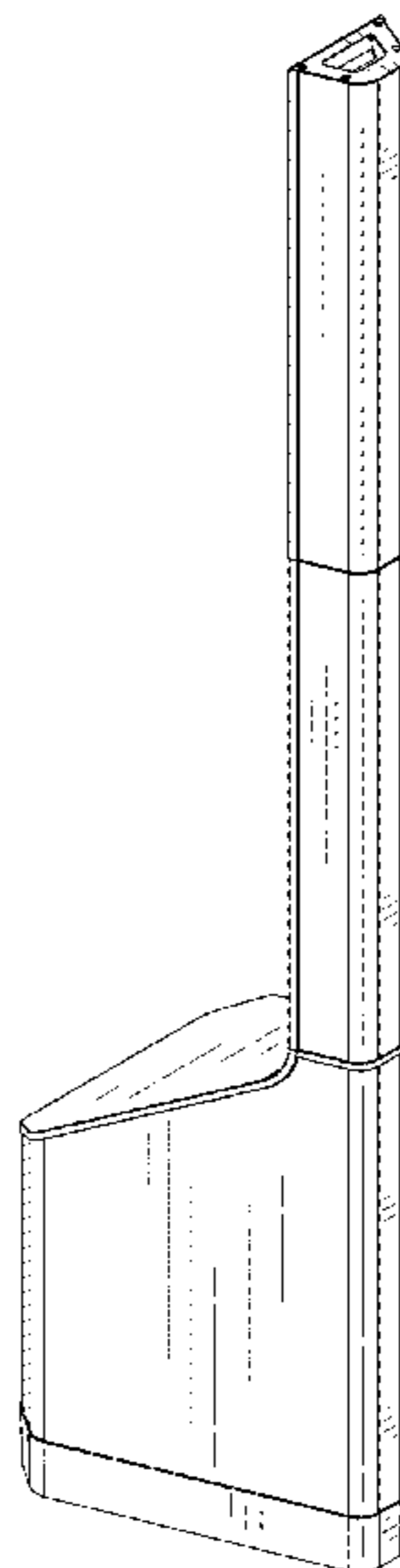
FIG. 1 is a front perspective view of a loudspeaker, showing our new design;

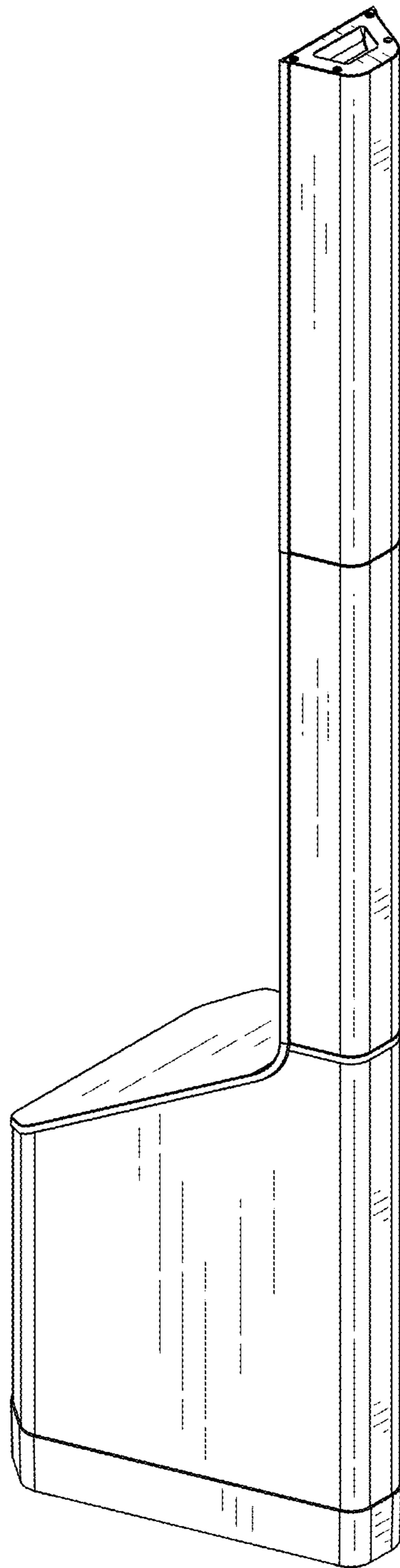

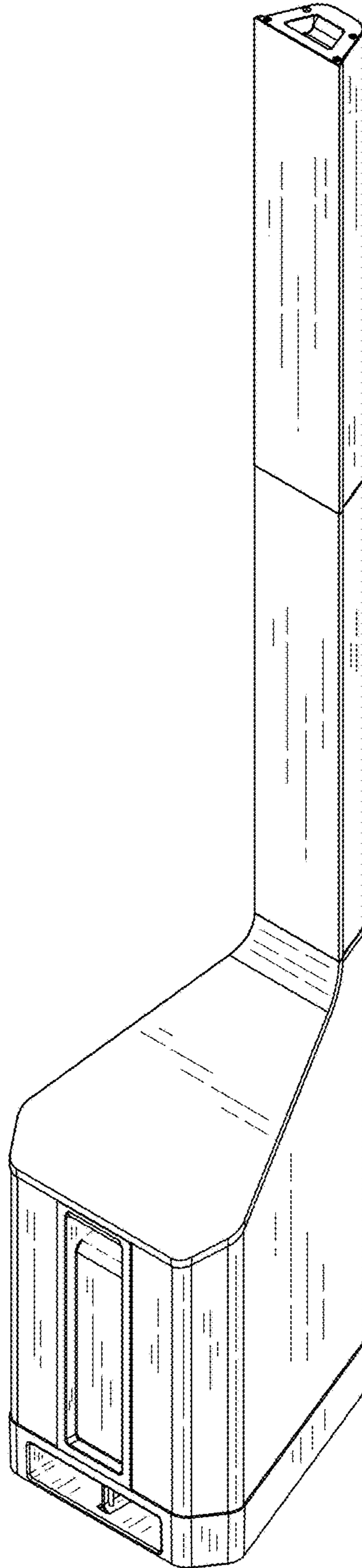

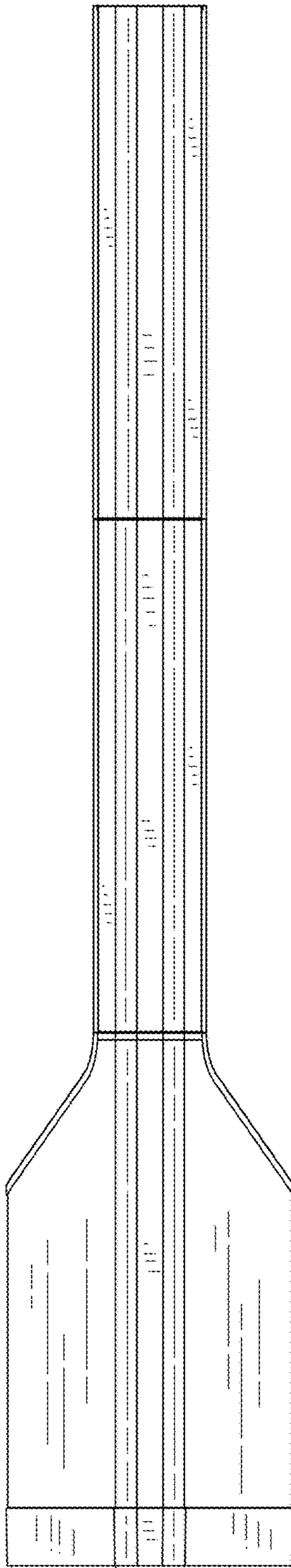

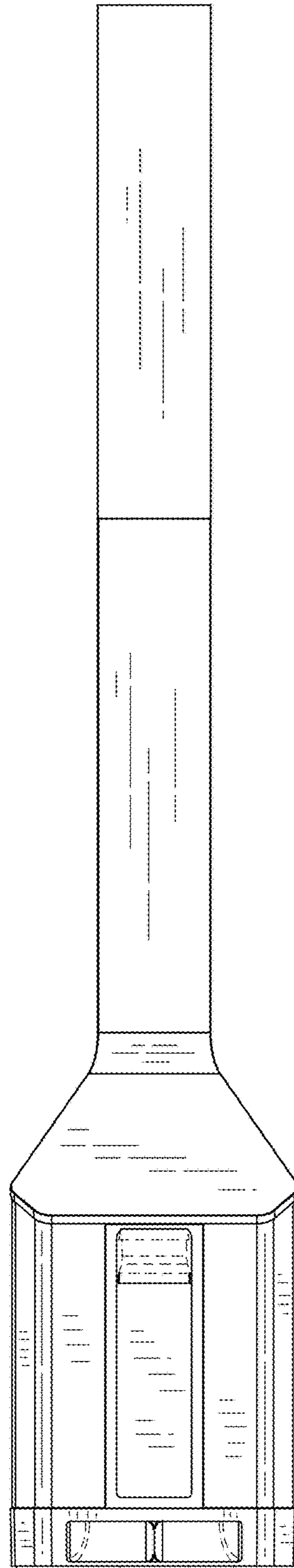

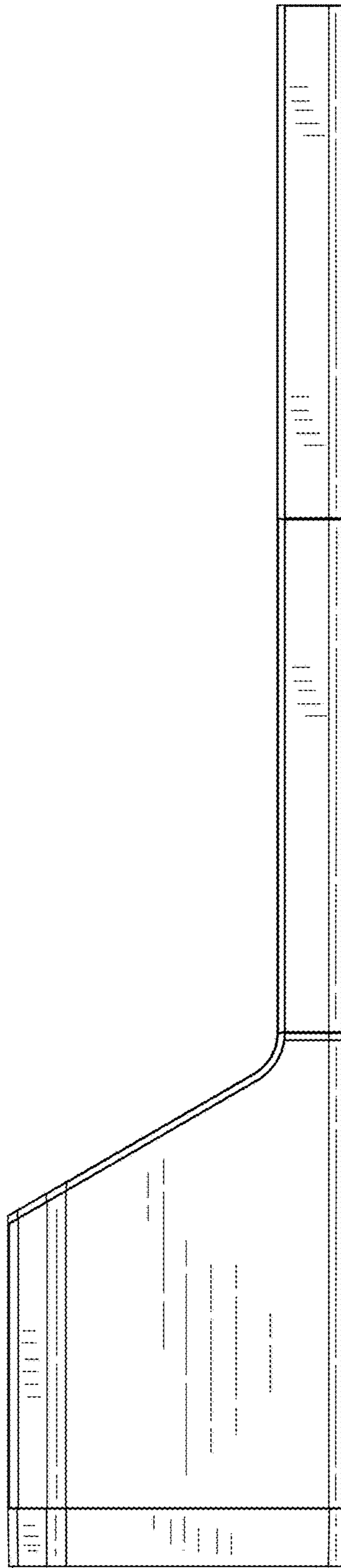

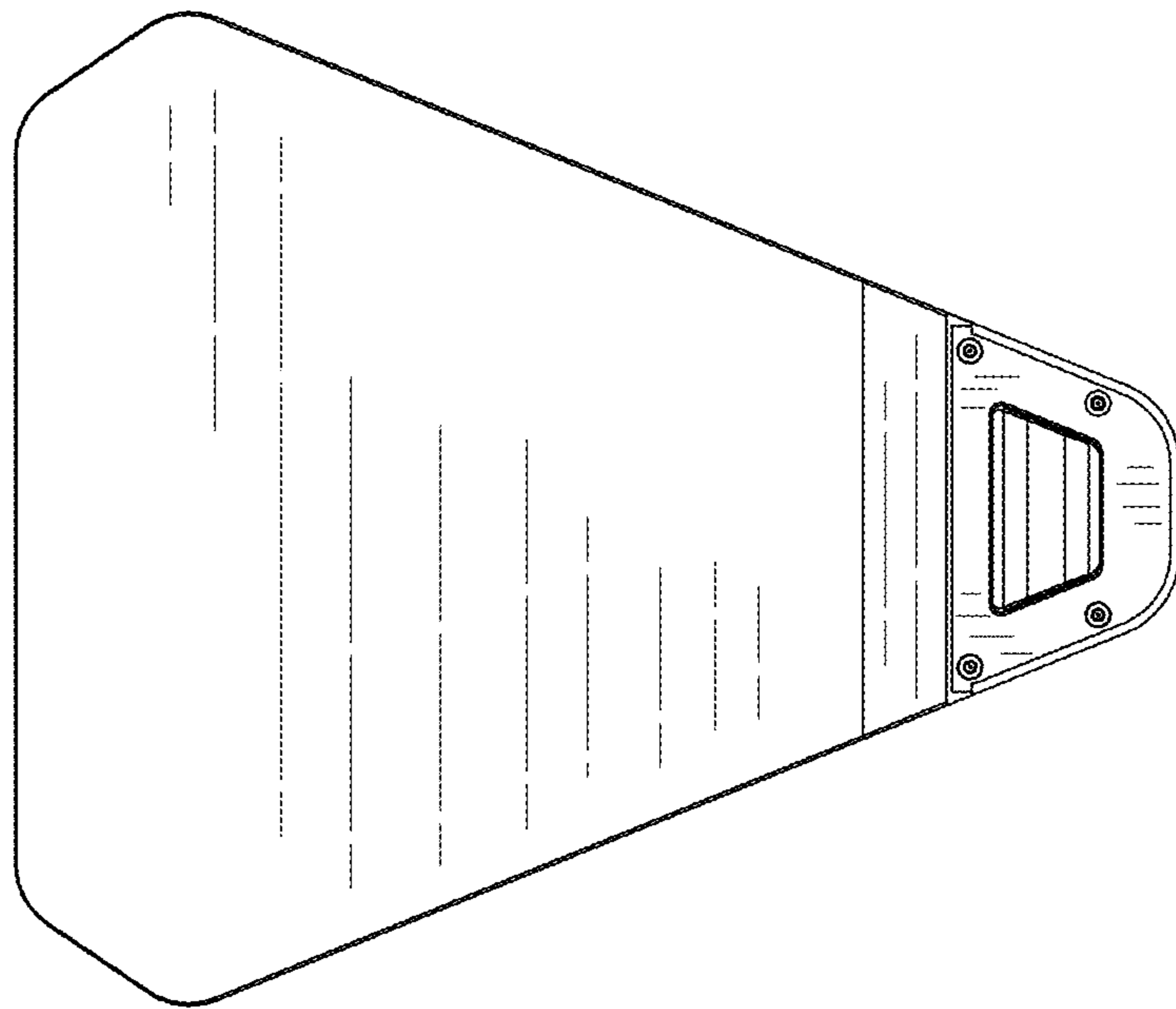

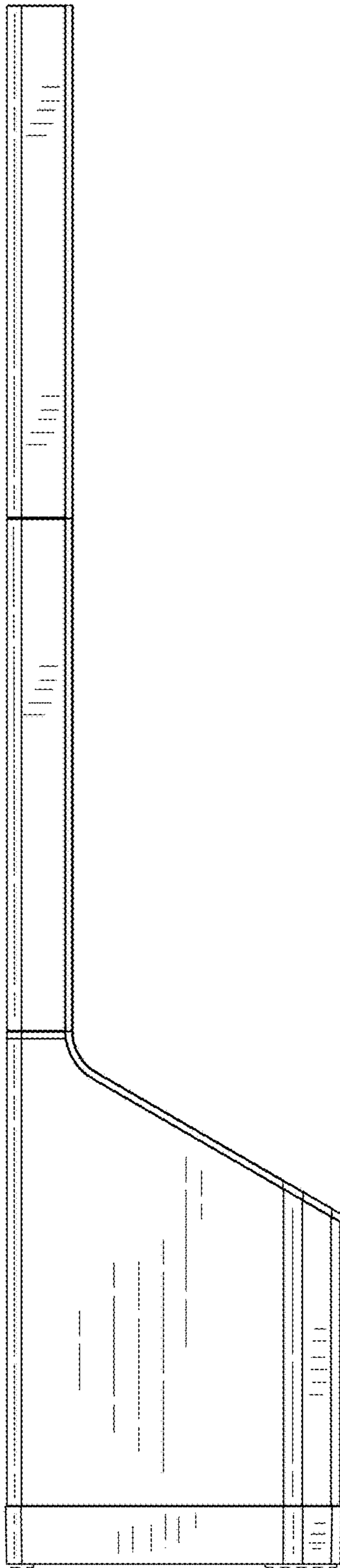
