(57) **CLAIM**

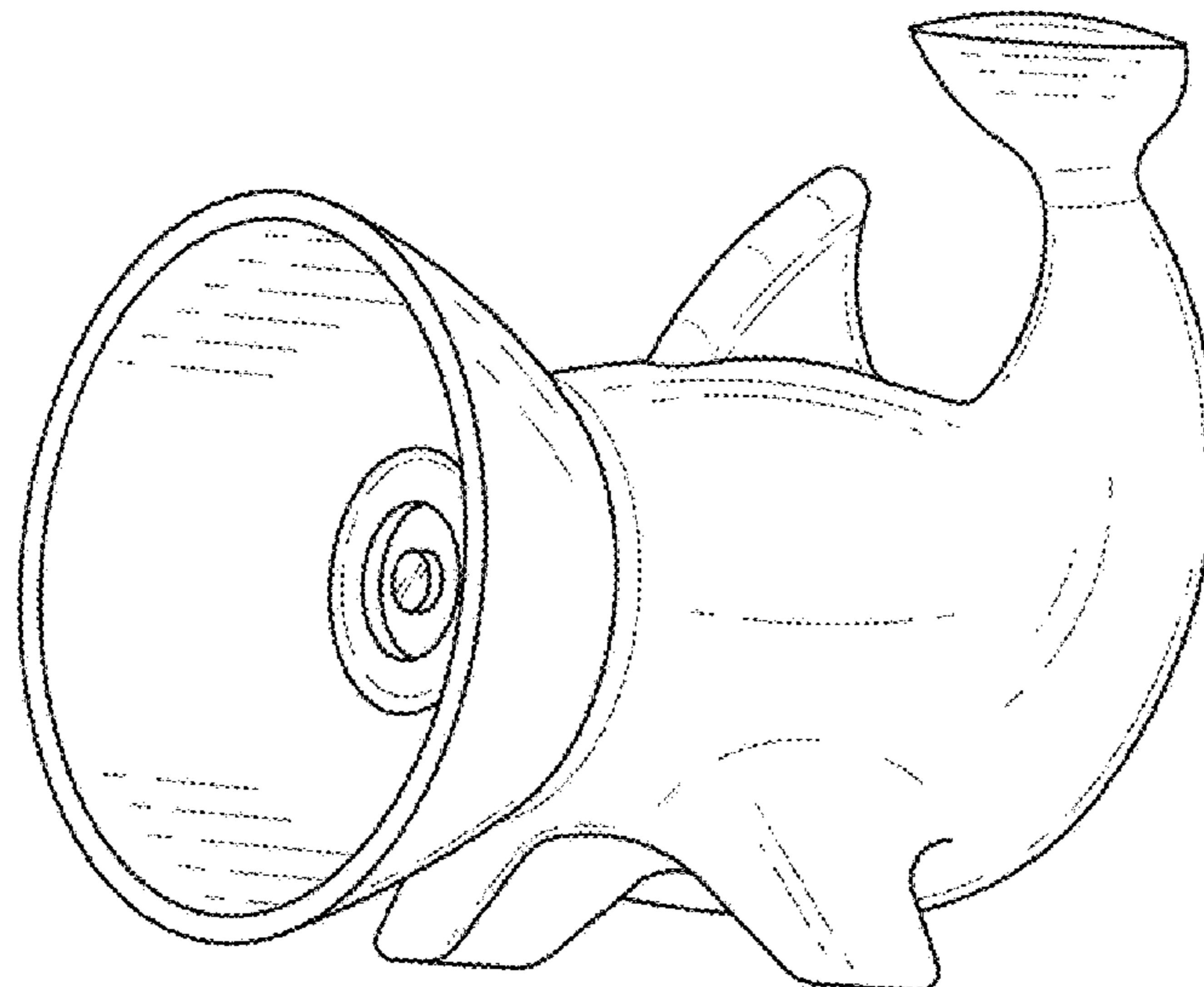
The ornamental design for a stand for a mobile device, as shown and described.

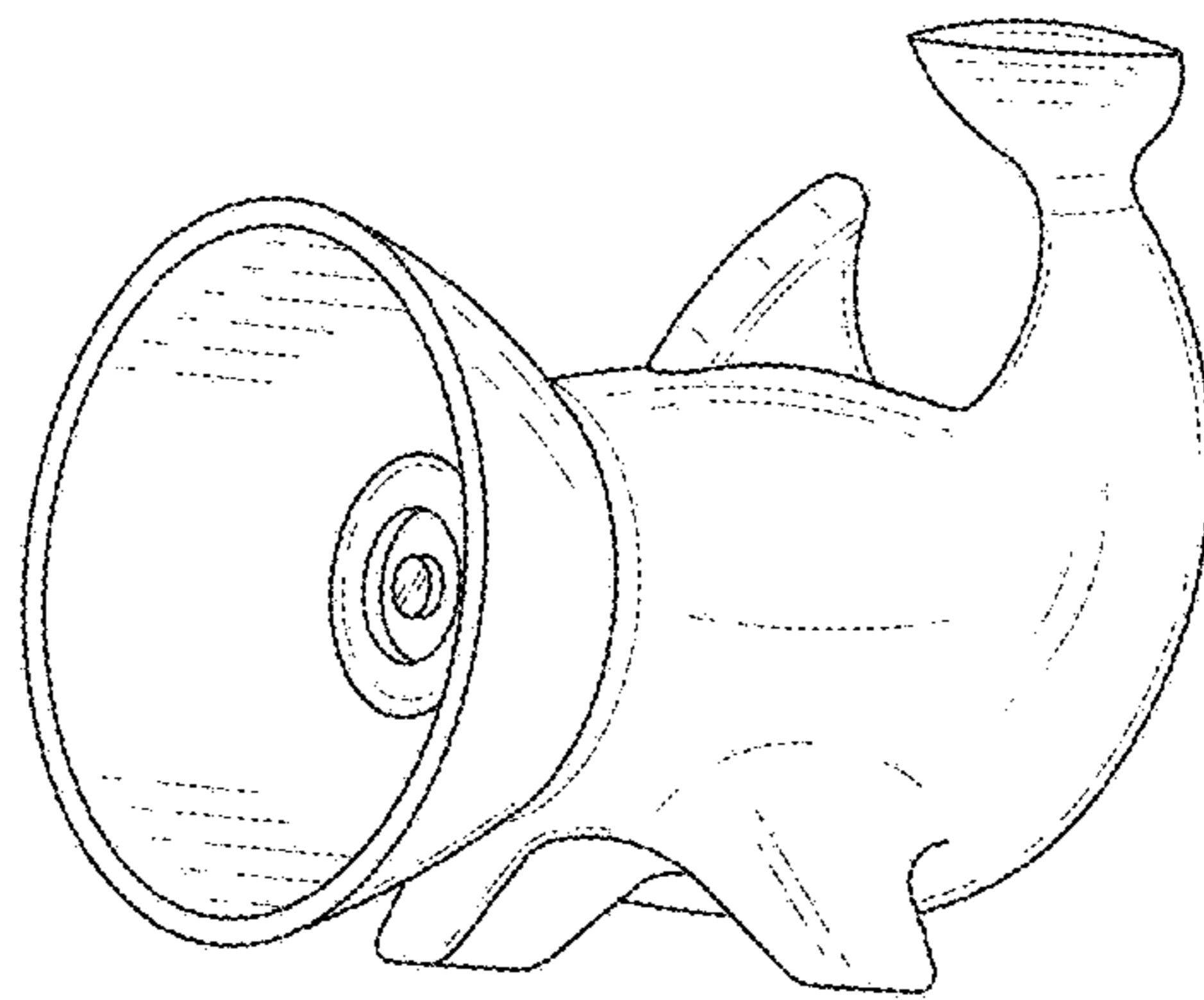

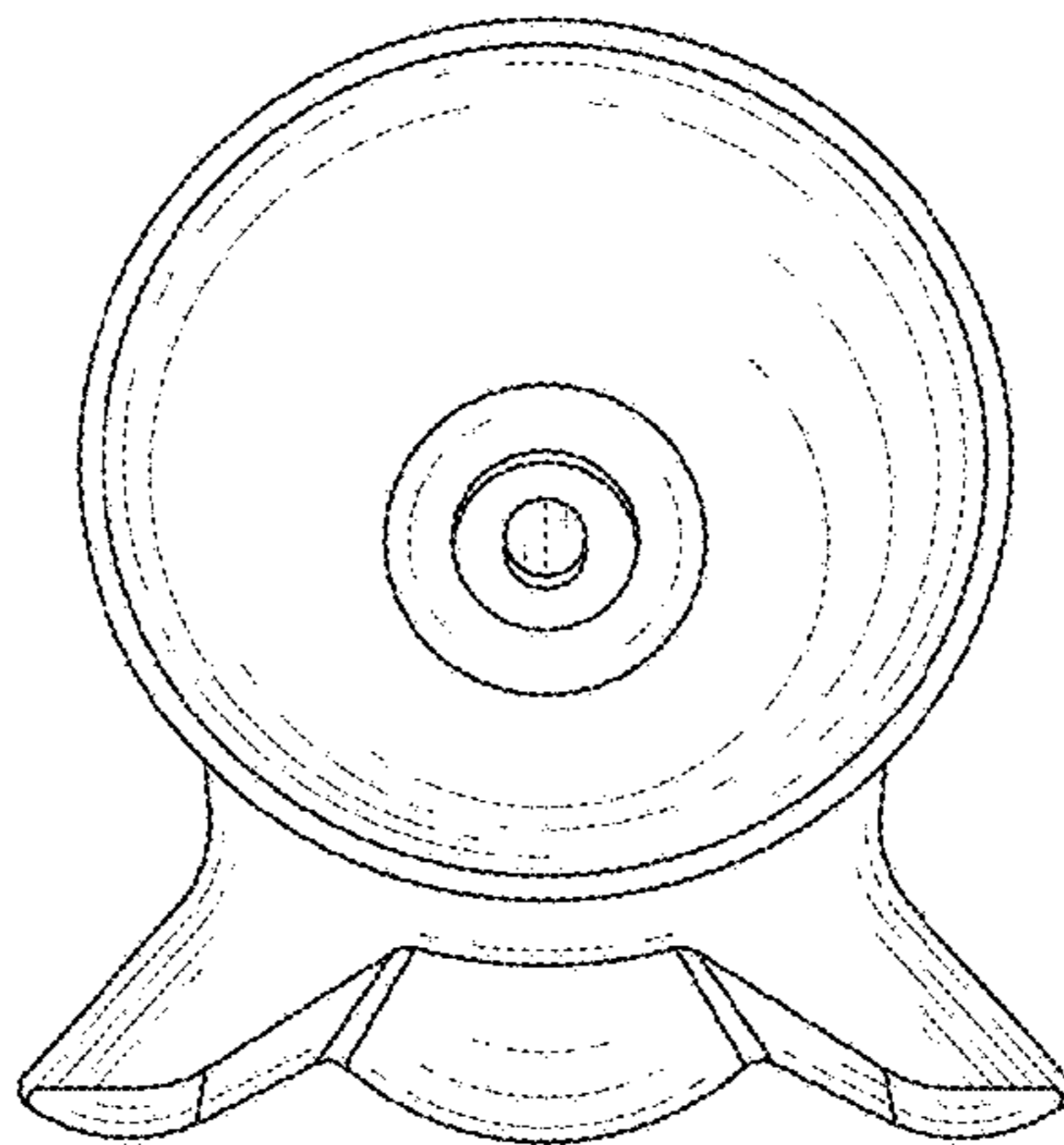

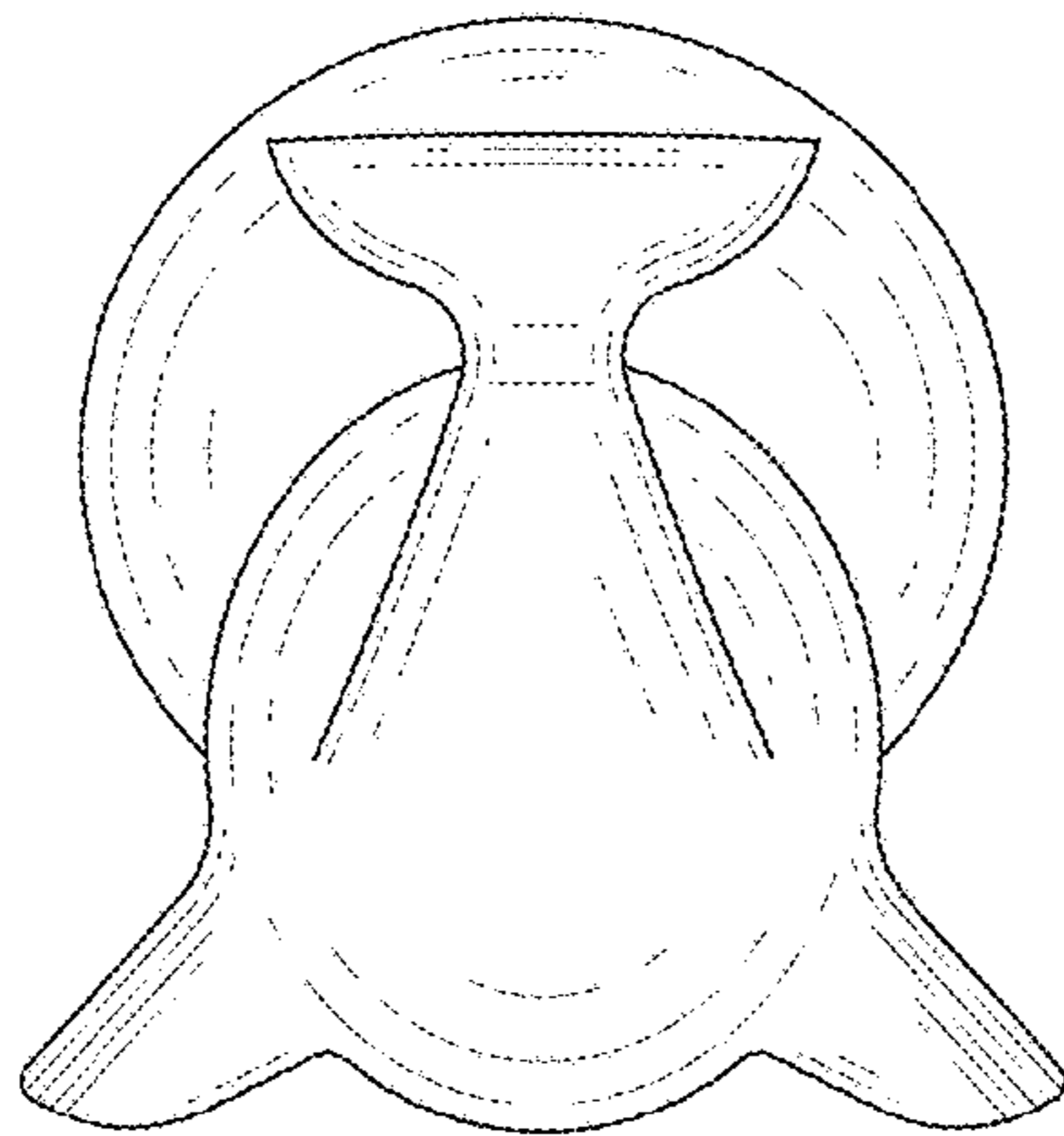

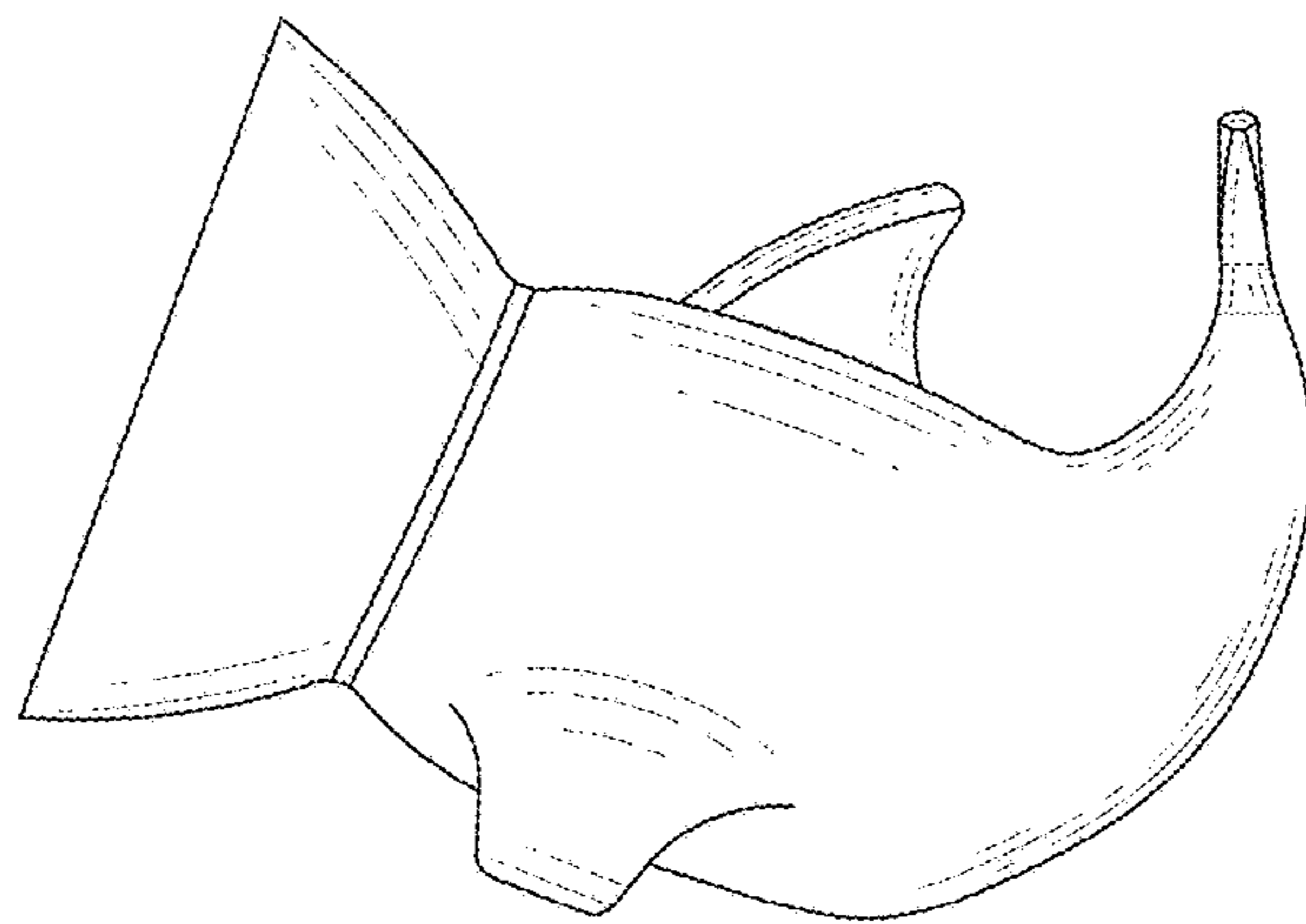

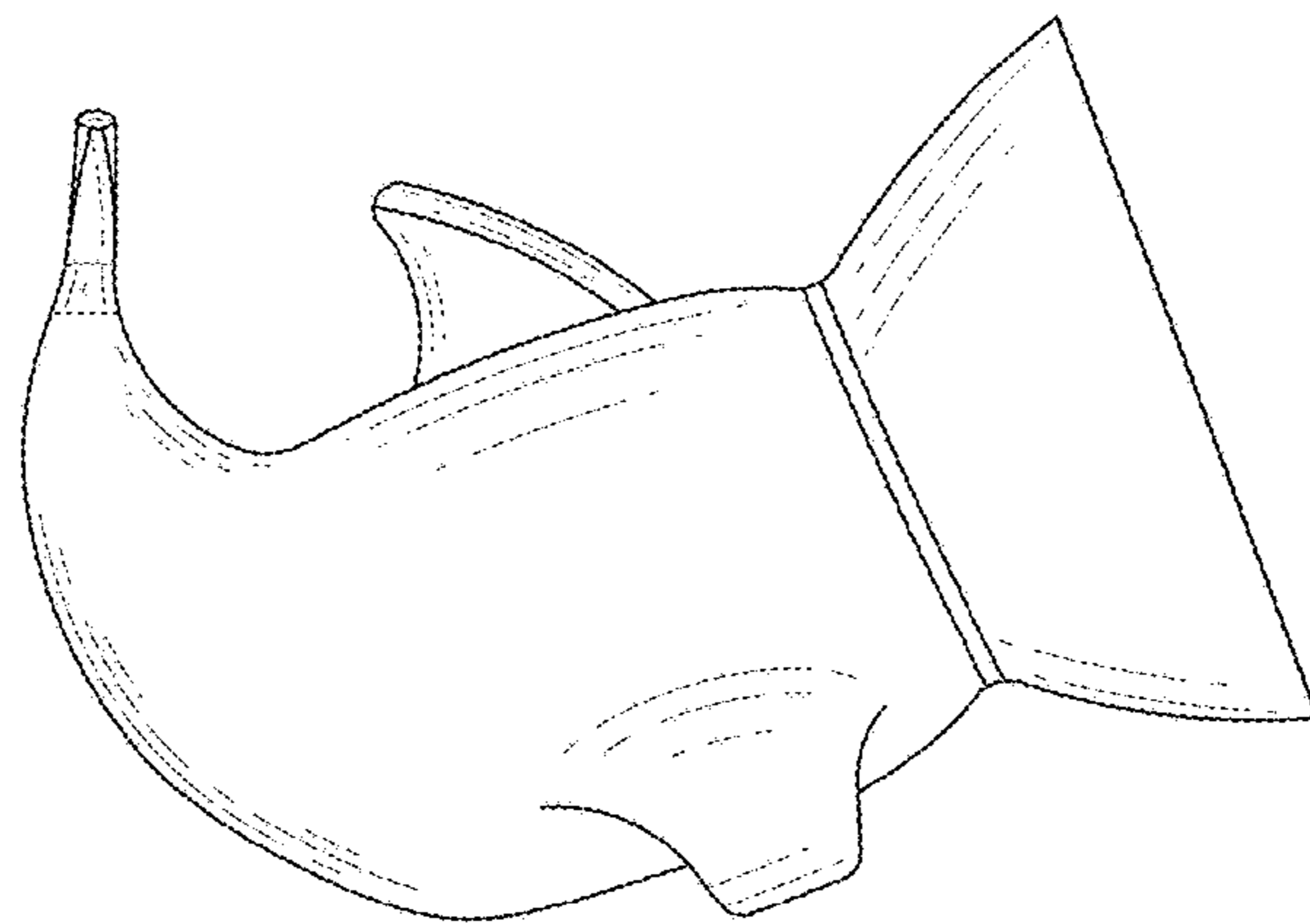

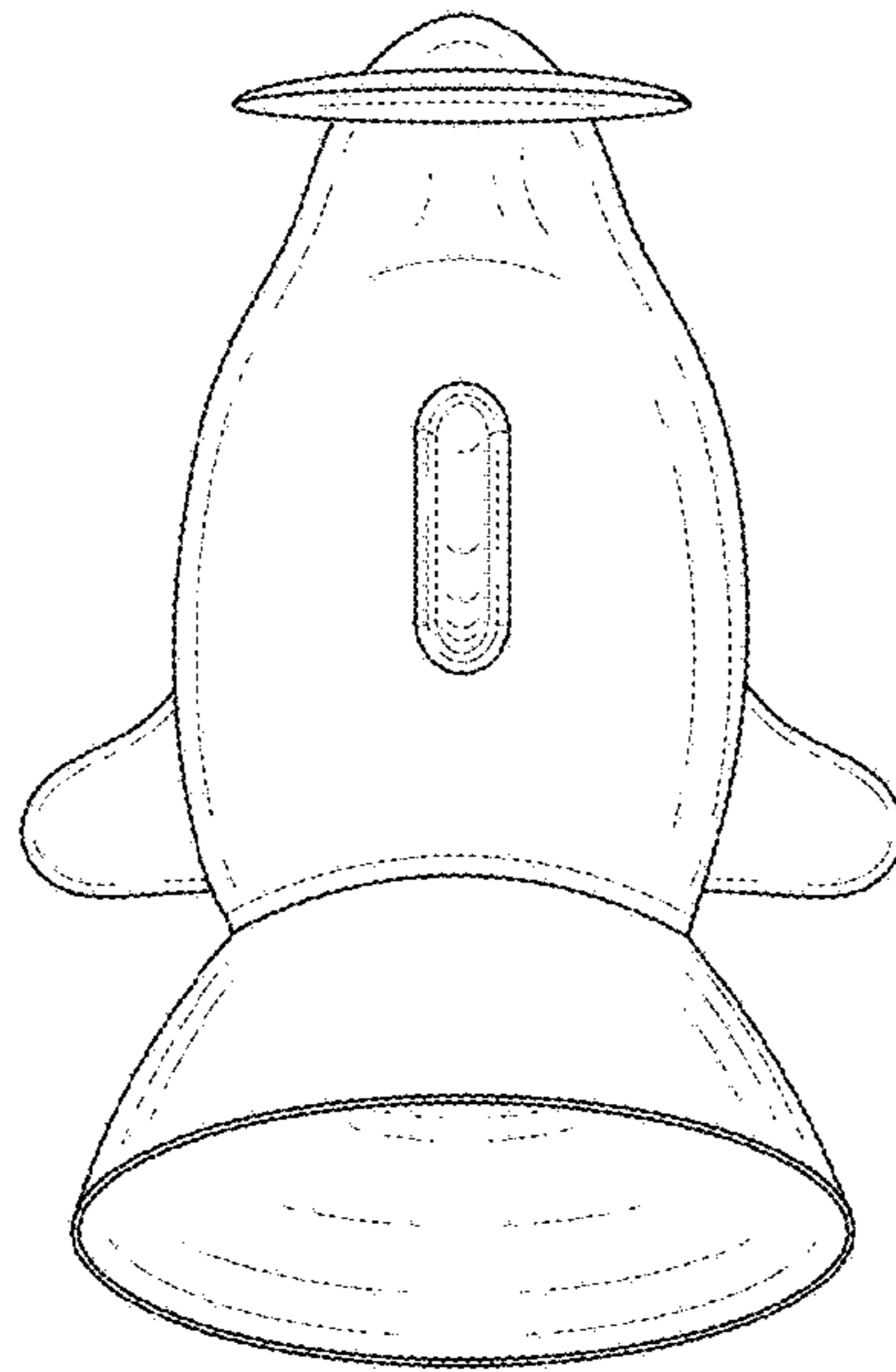

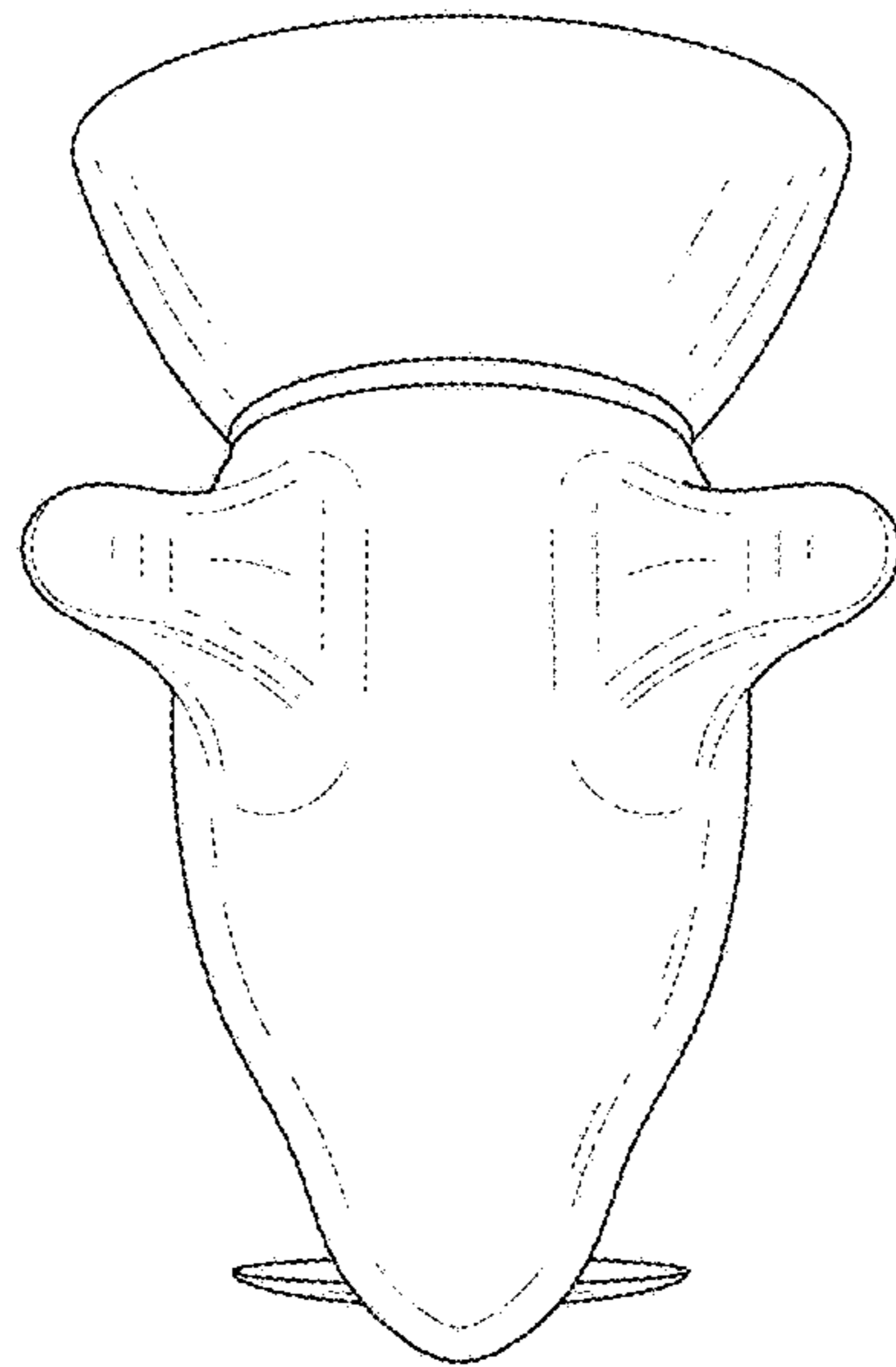
