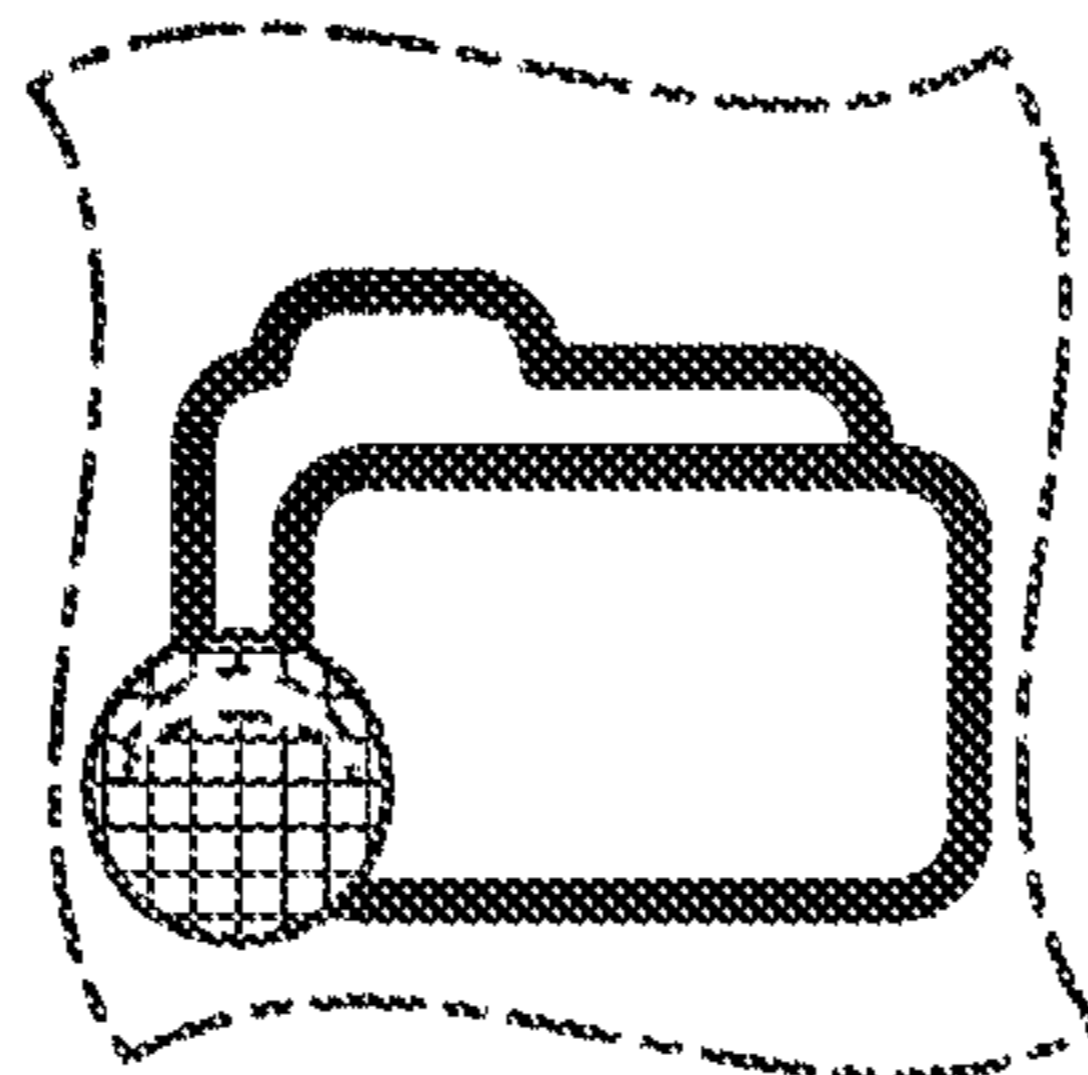
(57) **CLAIM**

The ornamental design for an icon for a display screen or a portion thereof with an icon, as shown and described.

DESCRIPTION

FIG. 1 is a front view of an embodiment of an display screen or portion thereof with an icon;
FIG. 2 is a front view of a second embodiment thereof;
FIG. 3 is a front view of a third embodiment thereof;
FIG. 4 is a front view of a fourth embodiment thereof;
FIG. 5 is a front view of a fifth embodiment thereof; and,
FIG. 6 is a front view of a sixth embodiment thereof.
The uneven broken line showing of the display screen or portion thereof forms no part of the claimed design. The broken line showing of a portion of the icon in FIGS. 1 and 2 form no part of the claimed design.

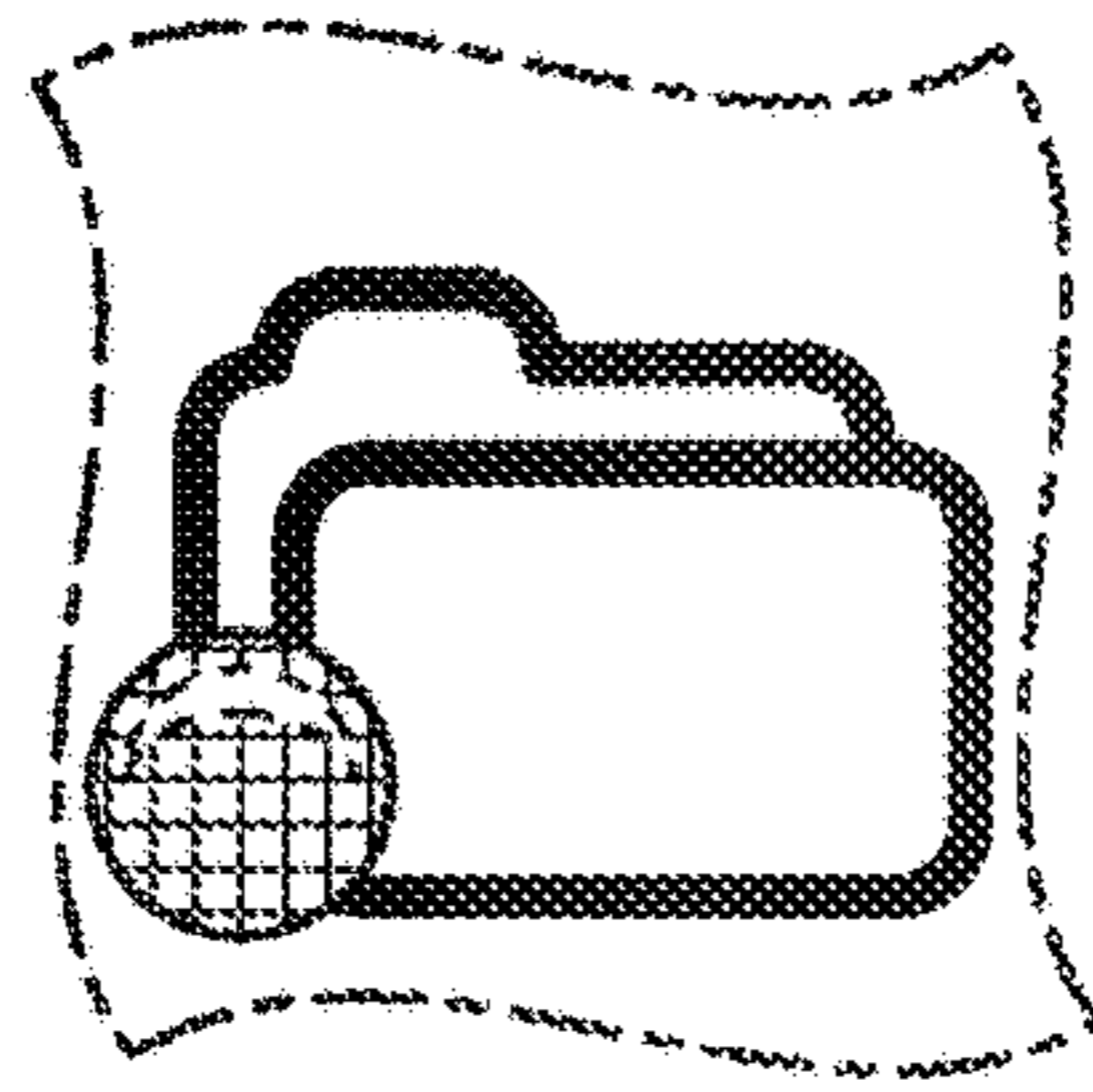

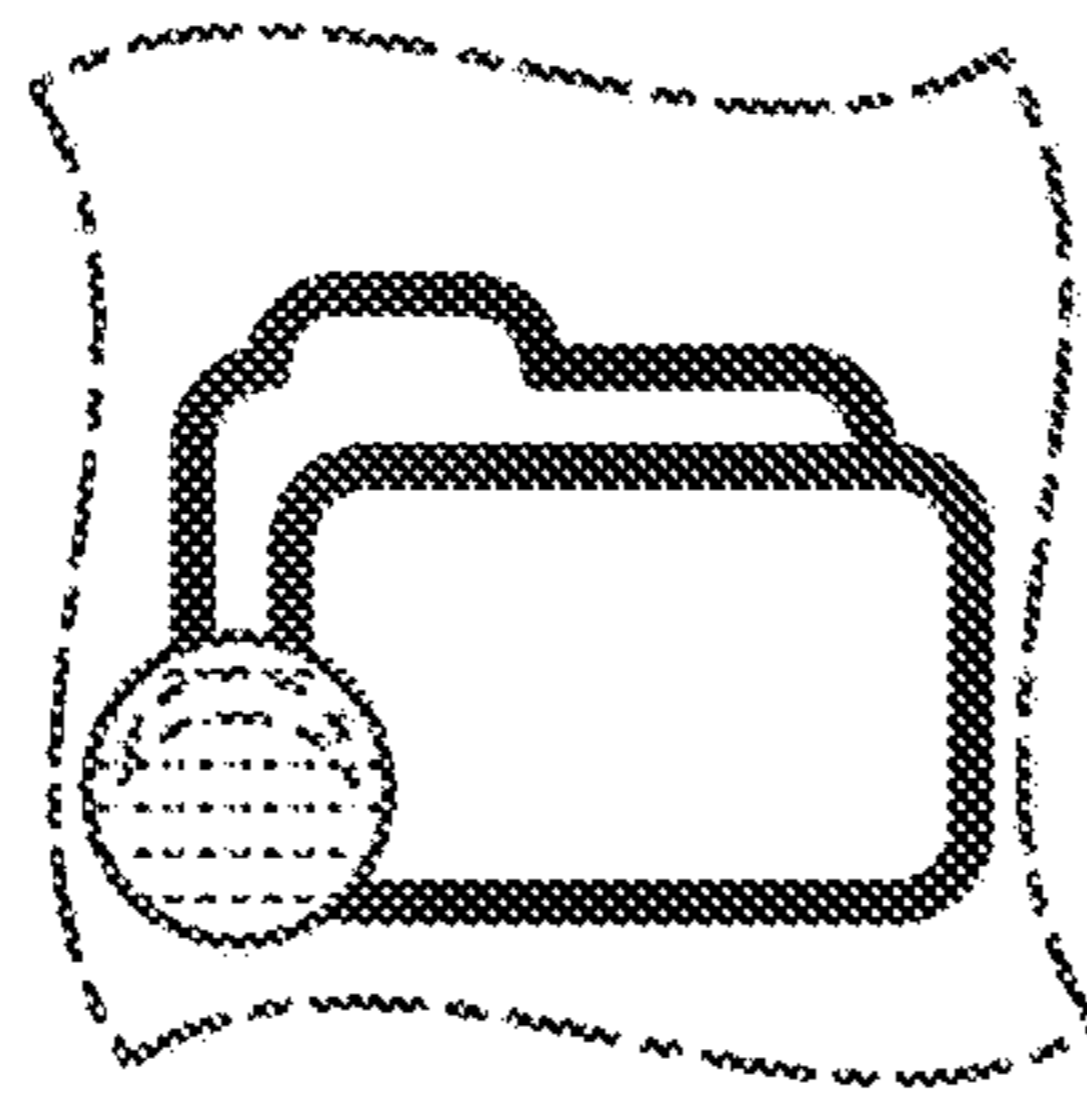

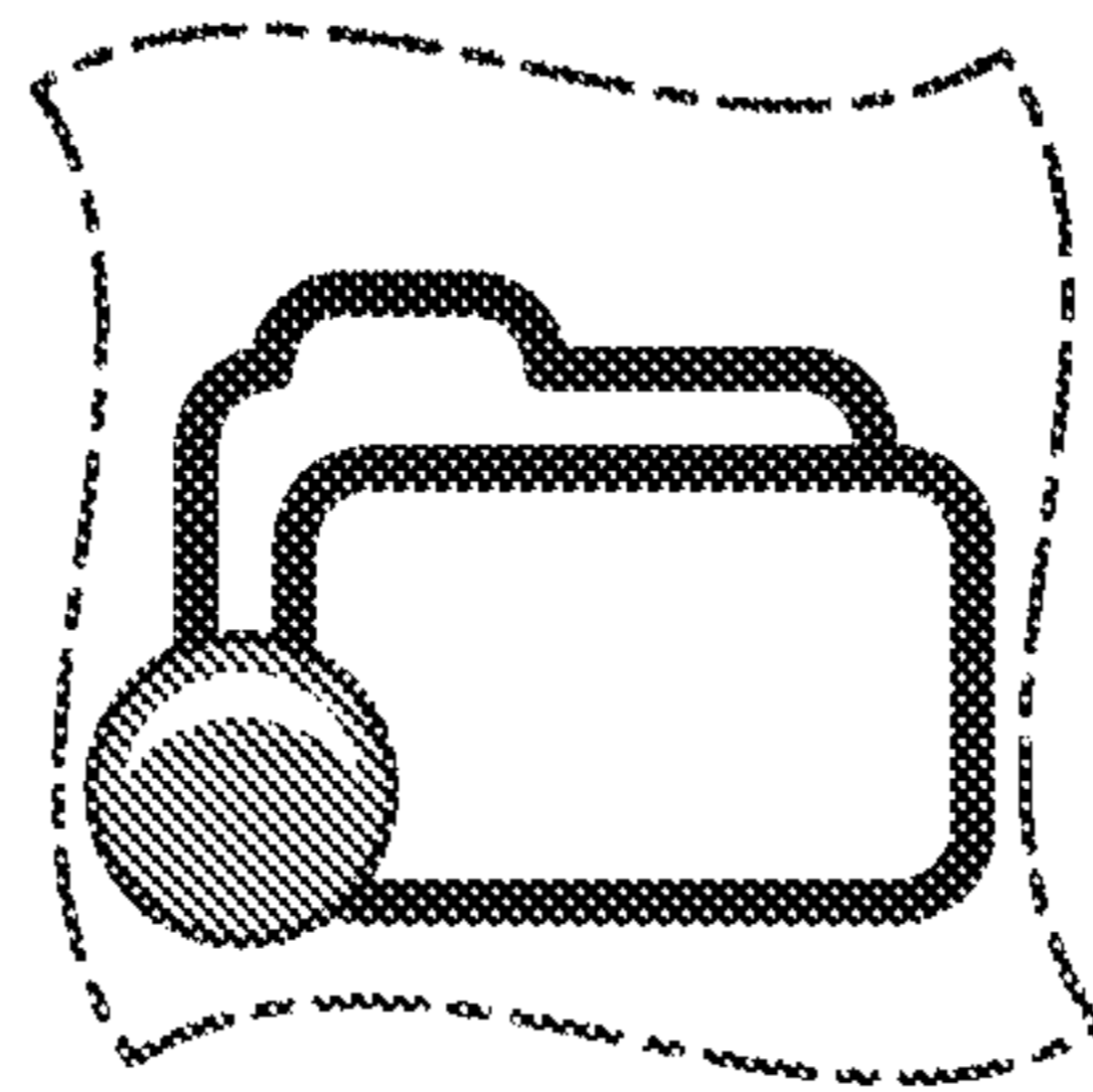

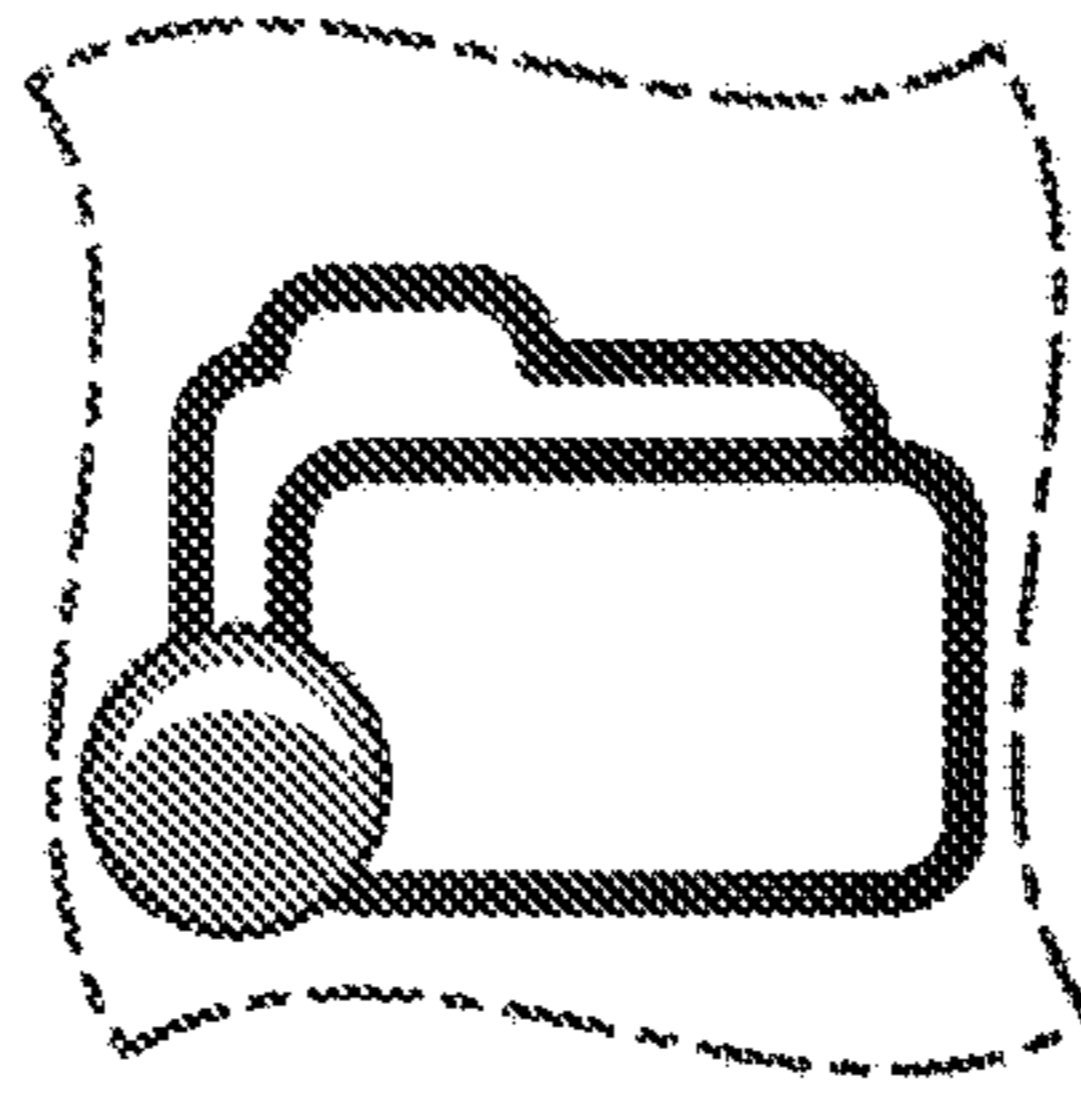

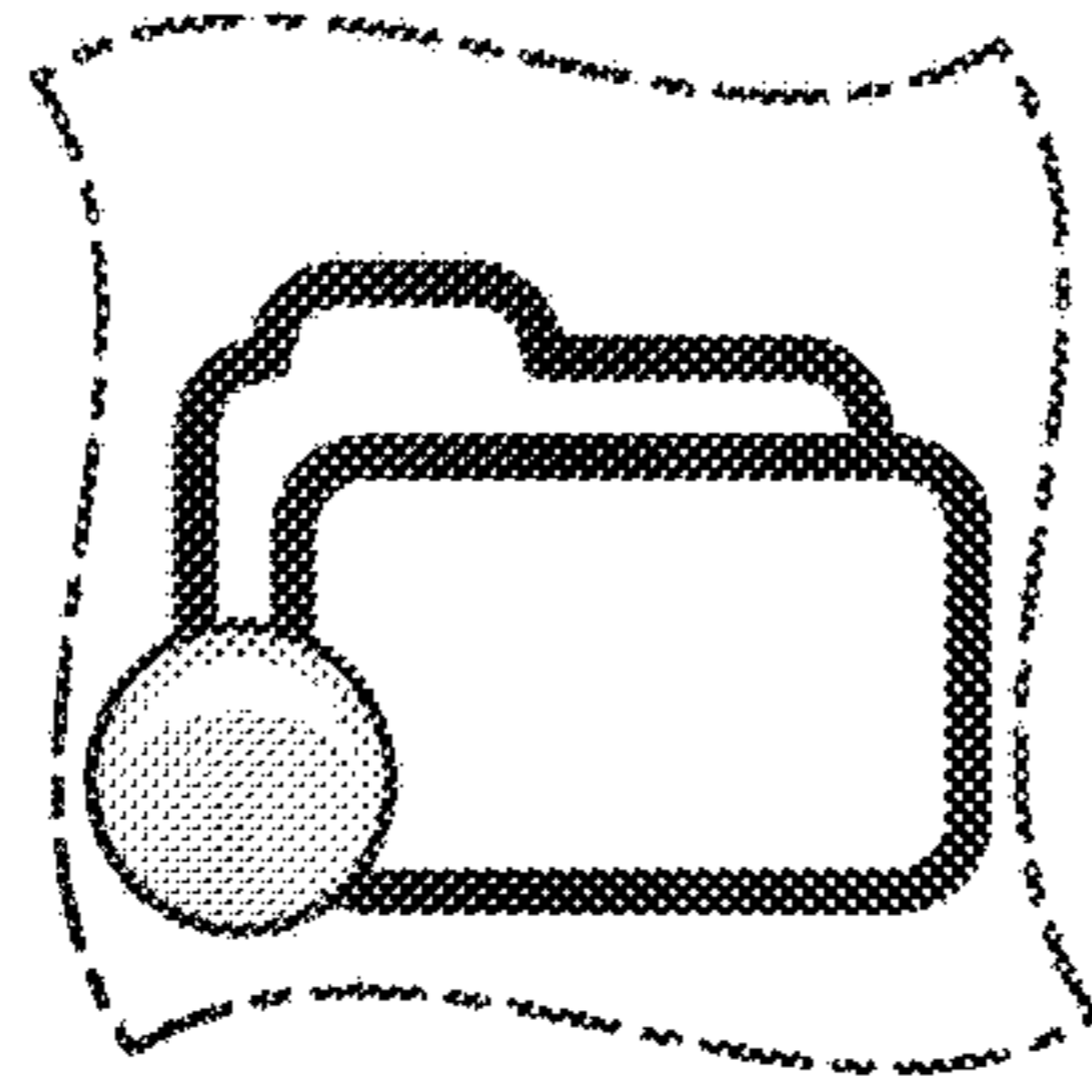

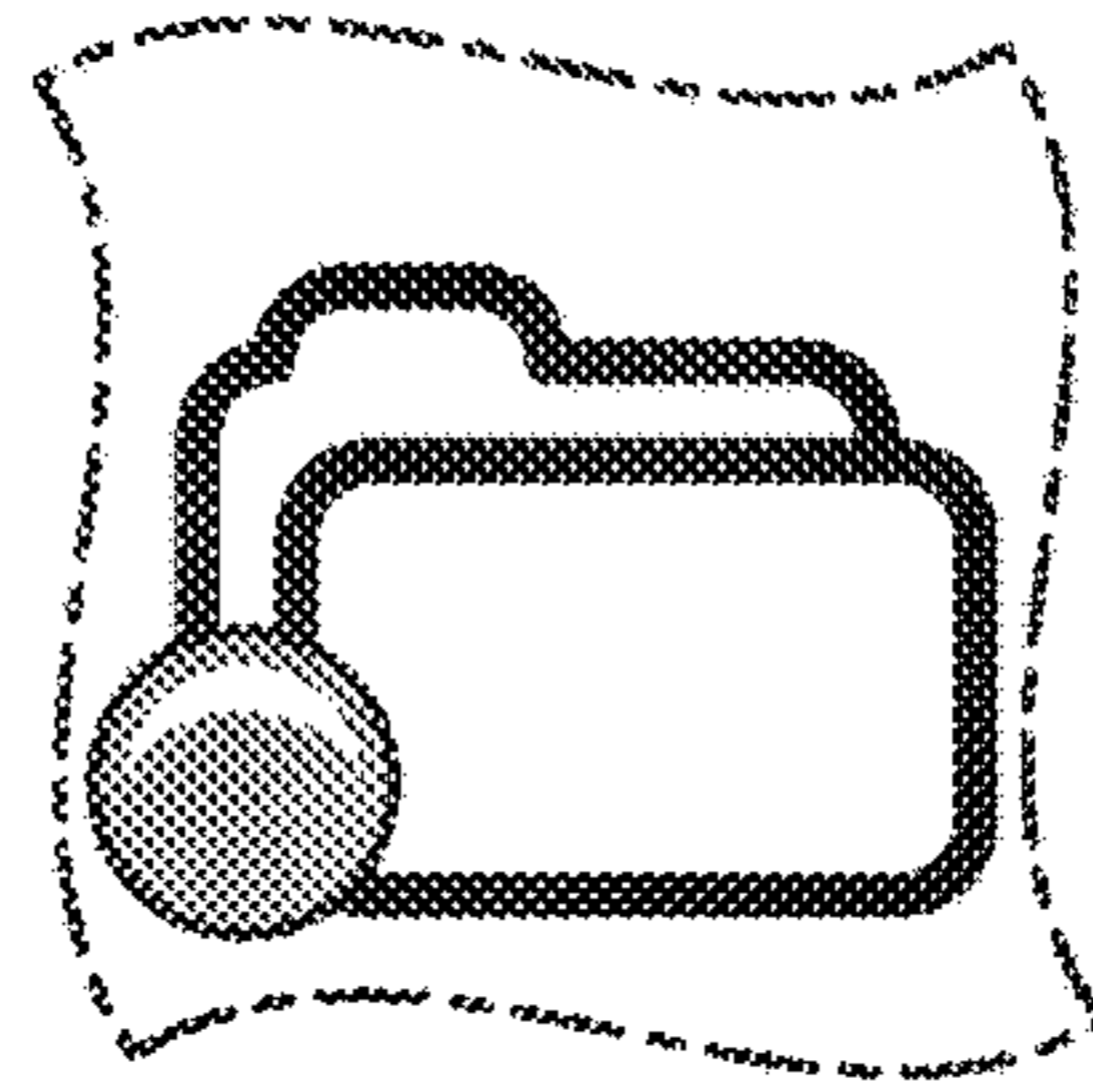
