(57) **CLAIM**

The ornamental design for a tine attachment, as shown and described.

DESCRIPTION

FIG. 1 is a reduced perspective view of a tine attachment showing our new design, in use condition attached as a pair, with one shown in broken lines, attached to a spring tine also shown in broken lines;

FIG. 2 is a perspective view of a tine attachment showing our new design, attached to a tine shown in broken lines;

FIG. 3 is a front elevation view of the tine attachment in FIG. 2;

FIG. 4 is a rear elevation view of the tine attachment of FIG. 2;

FIG. 5 is a left-side elevation view of the tine attachment of FIG. 2;

FIG. 6 is a right-side elevation view of the tine attachment of FIG. 2;

FIG. 7 is a top view of the tine attachment of FIG. 2;

FIG. 8 is a bottom plan view of the tine attachment of FIG. 2; and,

FIG. 9 is a reduced top view of the tine attachment and tine of FIG. 2.

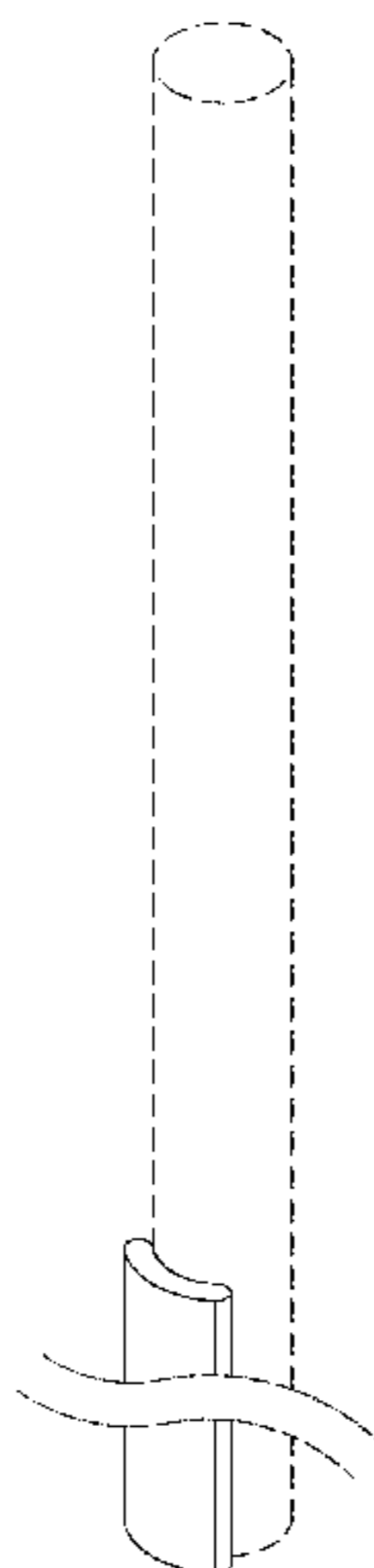

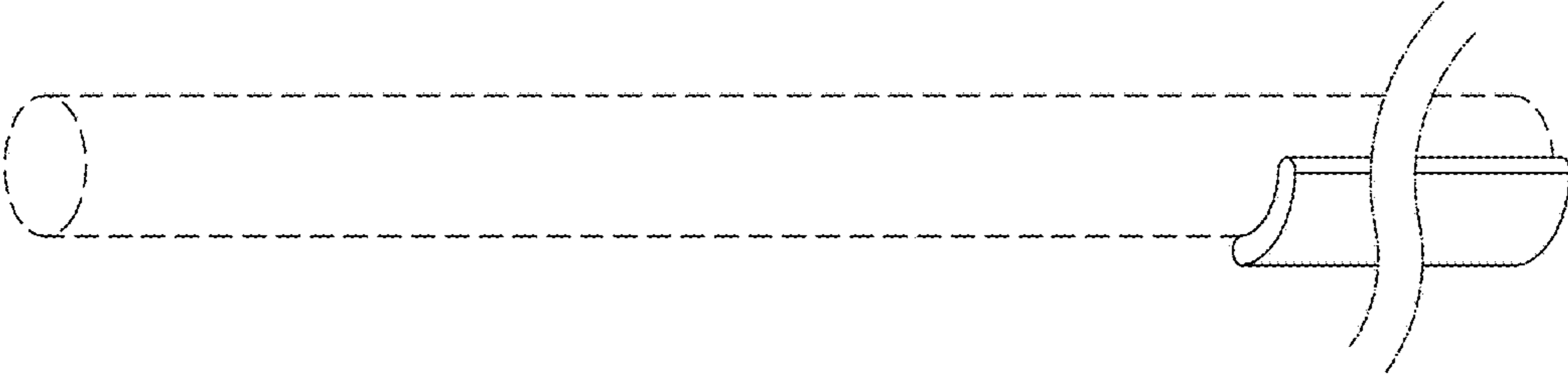

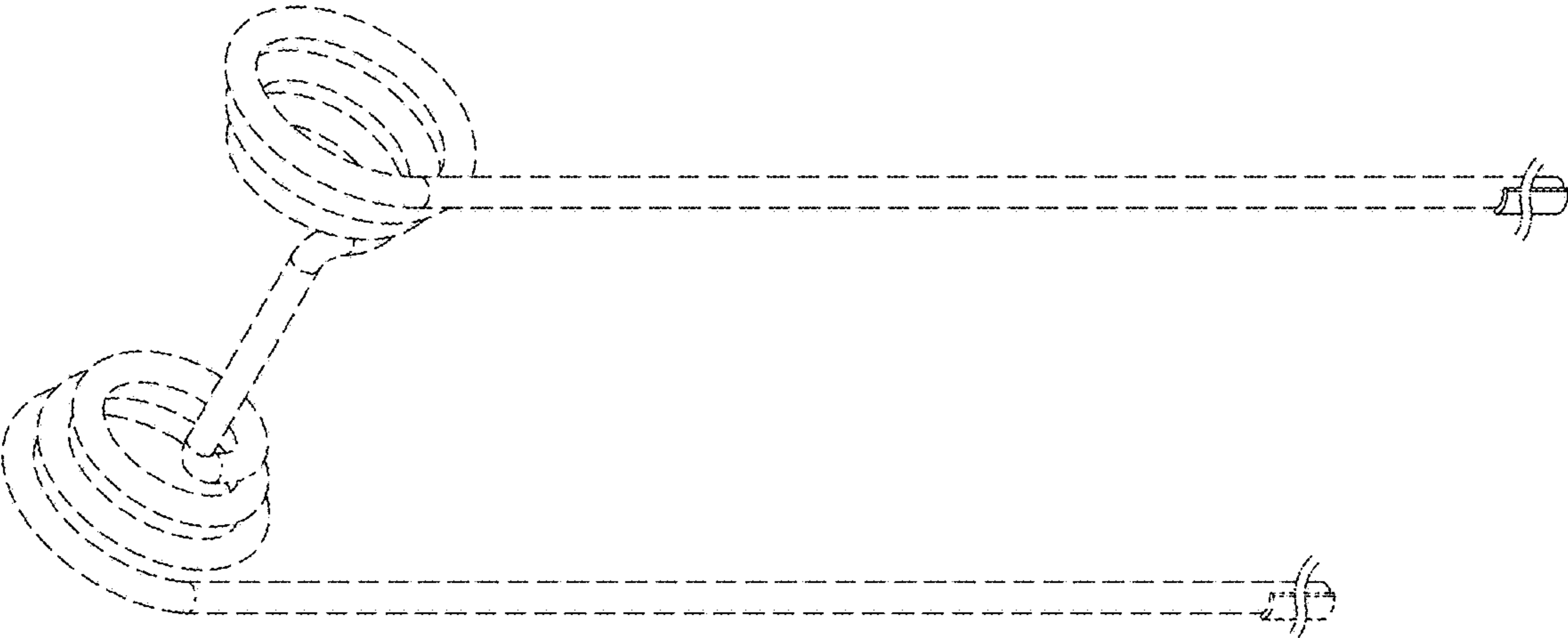

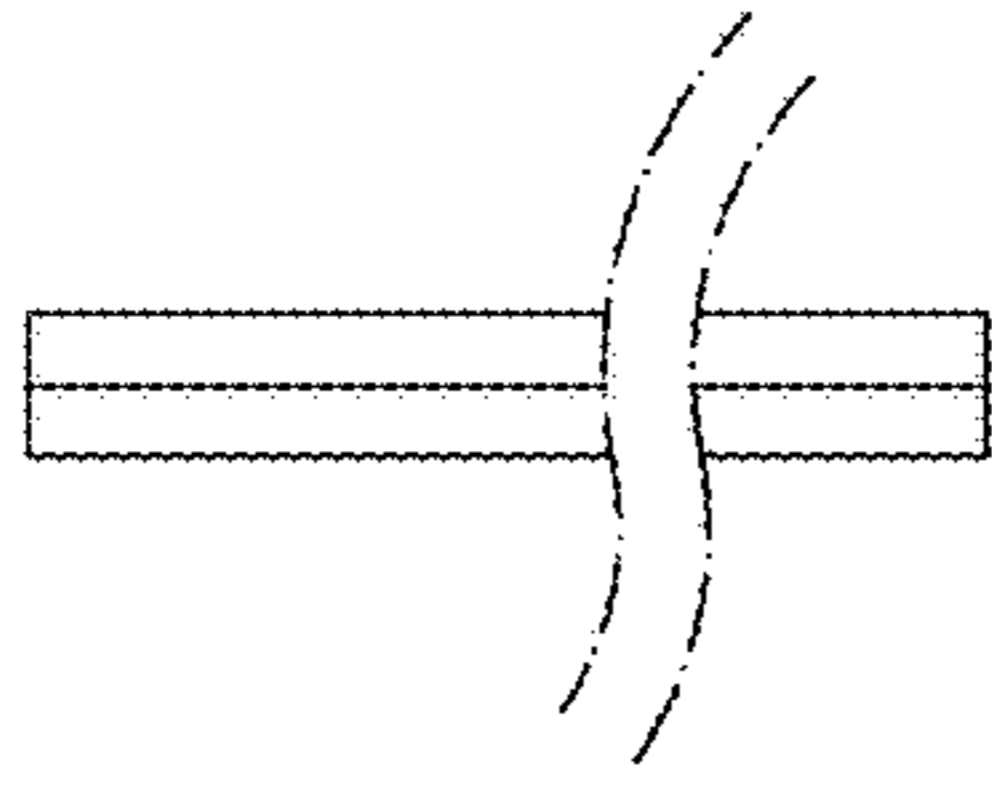

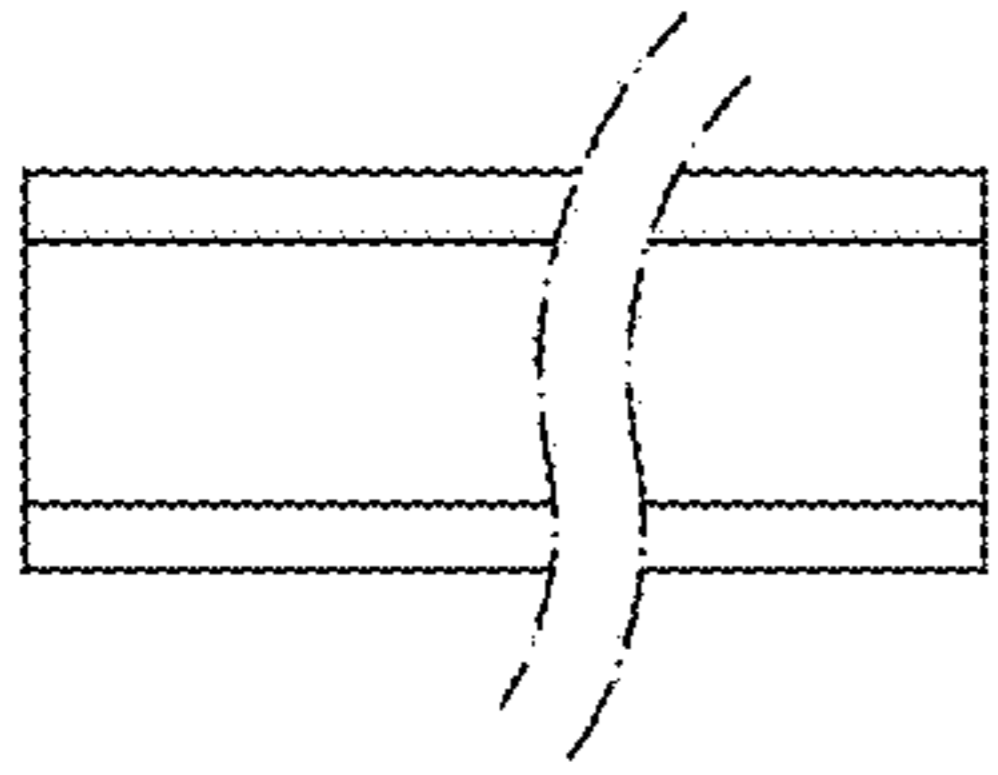

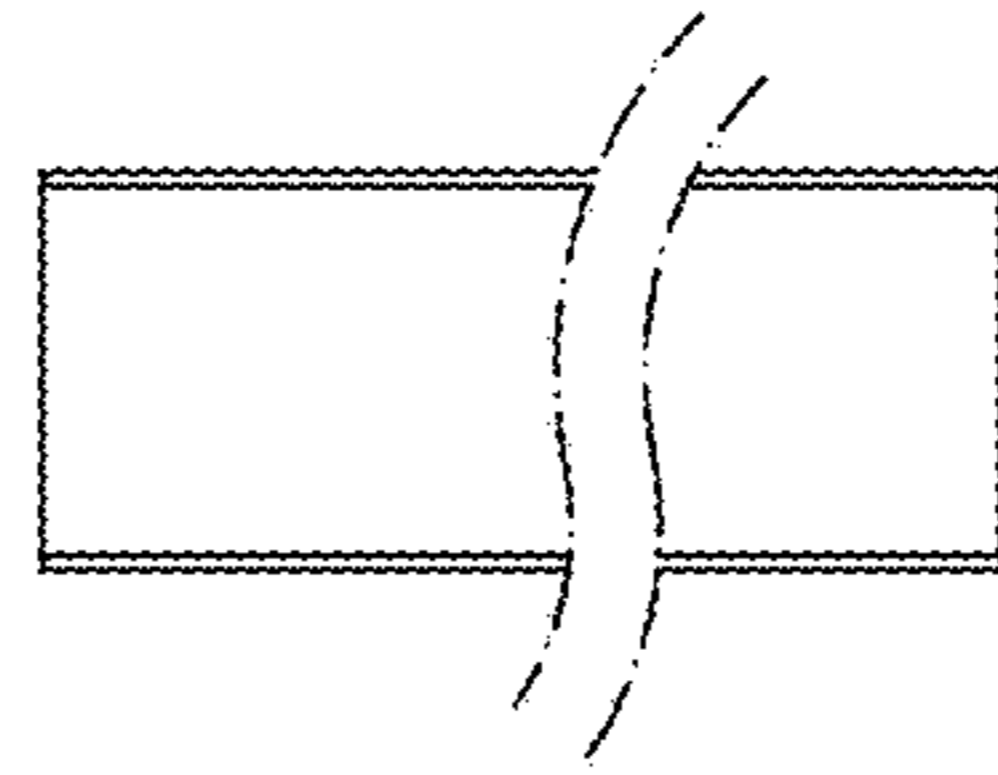

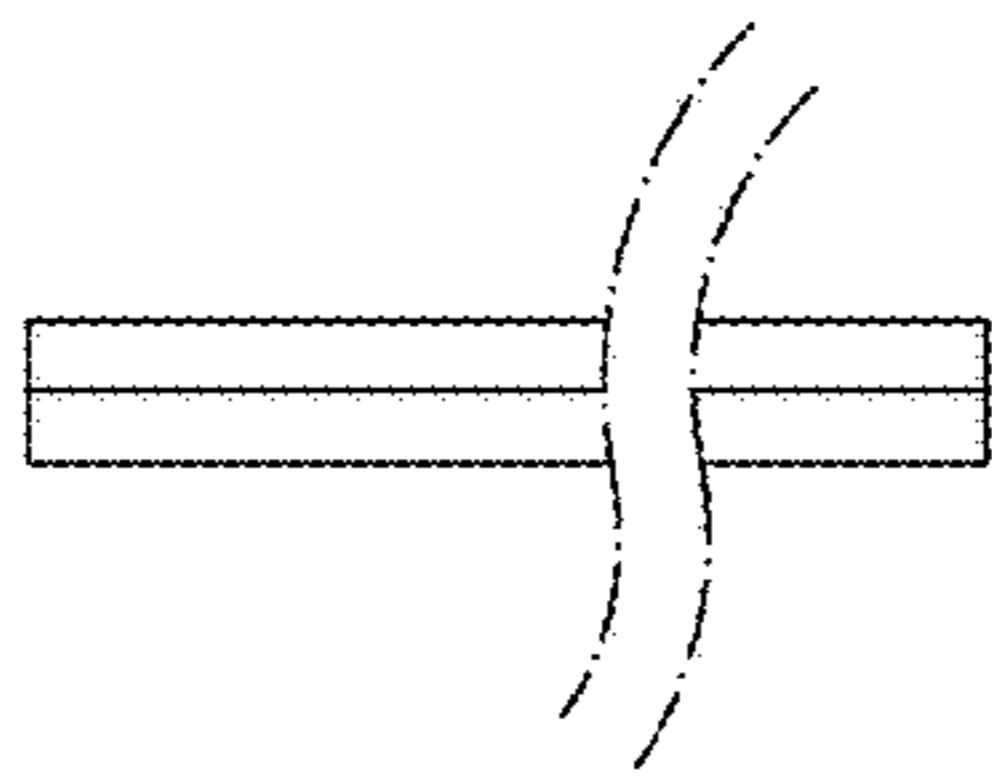
