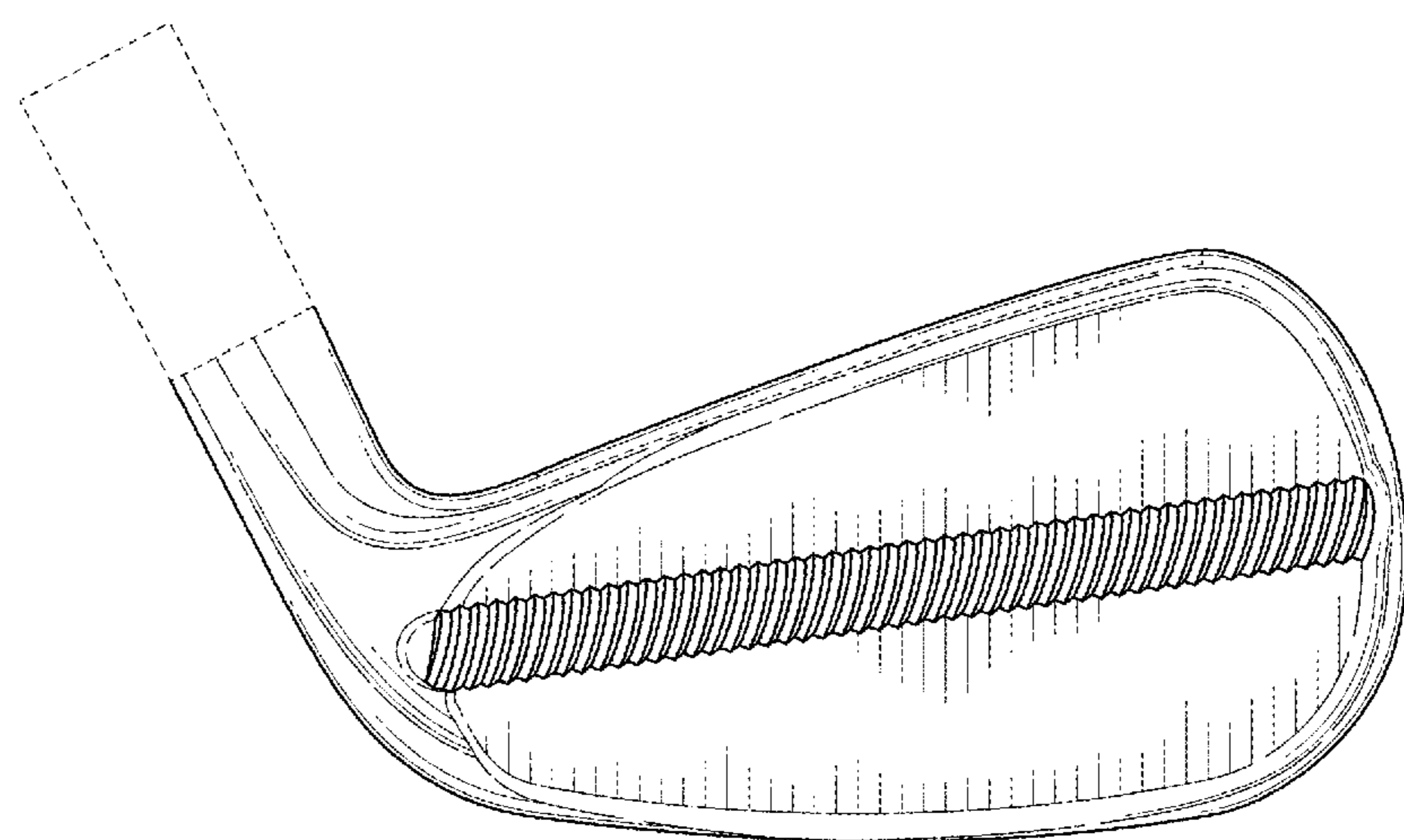

(57) **CLAIM**
We claim the ornamental design for a iron club head, as shown and described.

DESCRIPTION
FIG. 1 is a front elevation view of a iron club head, according to one embodiment.
FIG. 2 is a rear elevation view of a iron club head of FIG. 1.
FIG. 3 is a side elevation view of a toe side of the iron club head of FIG. 1.
FIG. 4 is a side elevation view of a heel side of the iron club head of FIG. 1.
FIG. 5 is a top plan view of the iron club head of FIG. 1.
FIG. 6 is a bottom plan view of the iron club head of FIG. 1; and,
FIG. 7 is a perspective view of the iron club head of FIG. 1, as viewed from the rear and one side.
The dashed lines in the drawings are for purposes of illustrating environmental structure as well as portions of the design that form no part of the present claimed design.

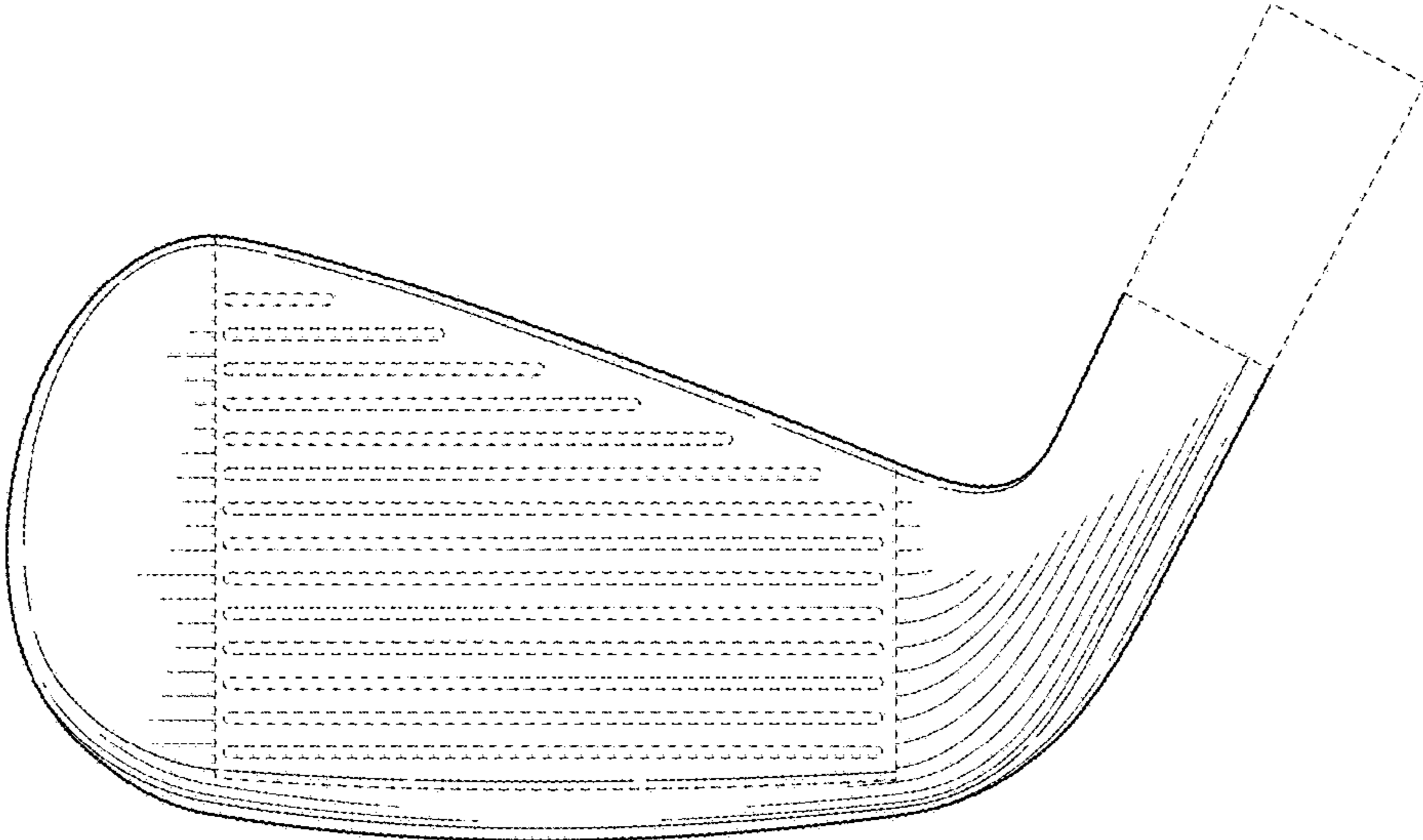

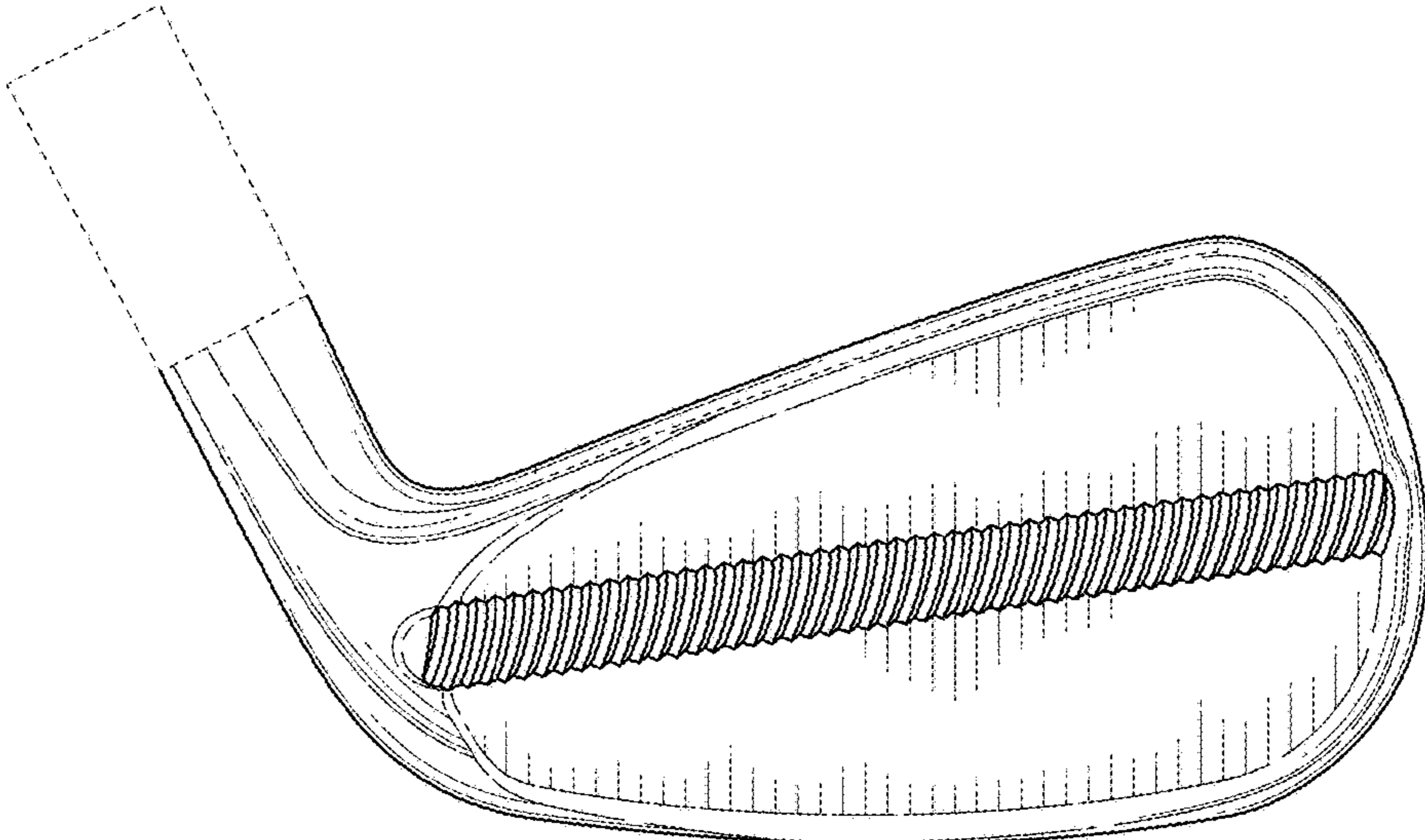

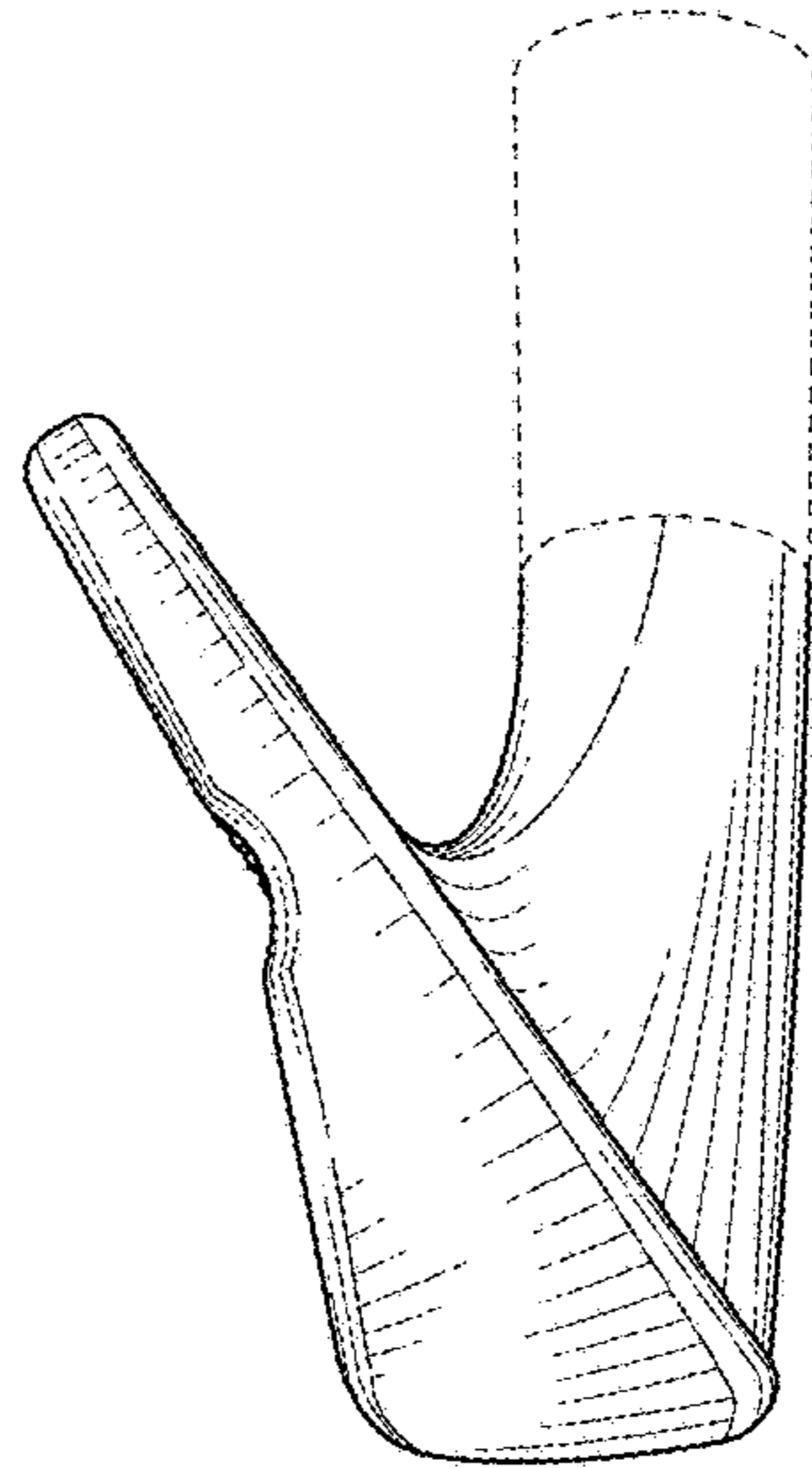

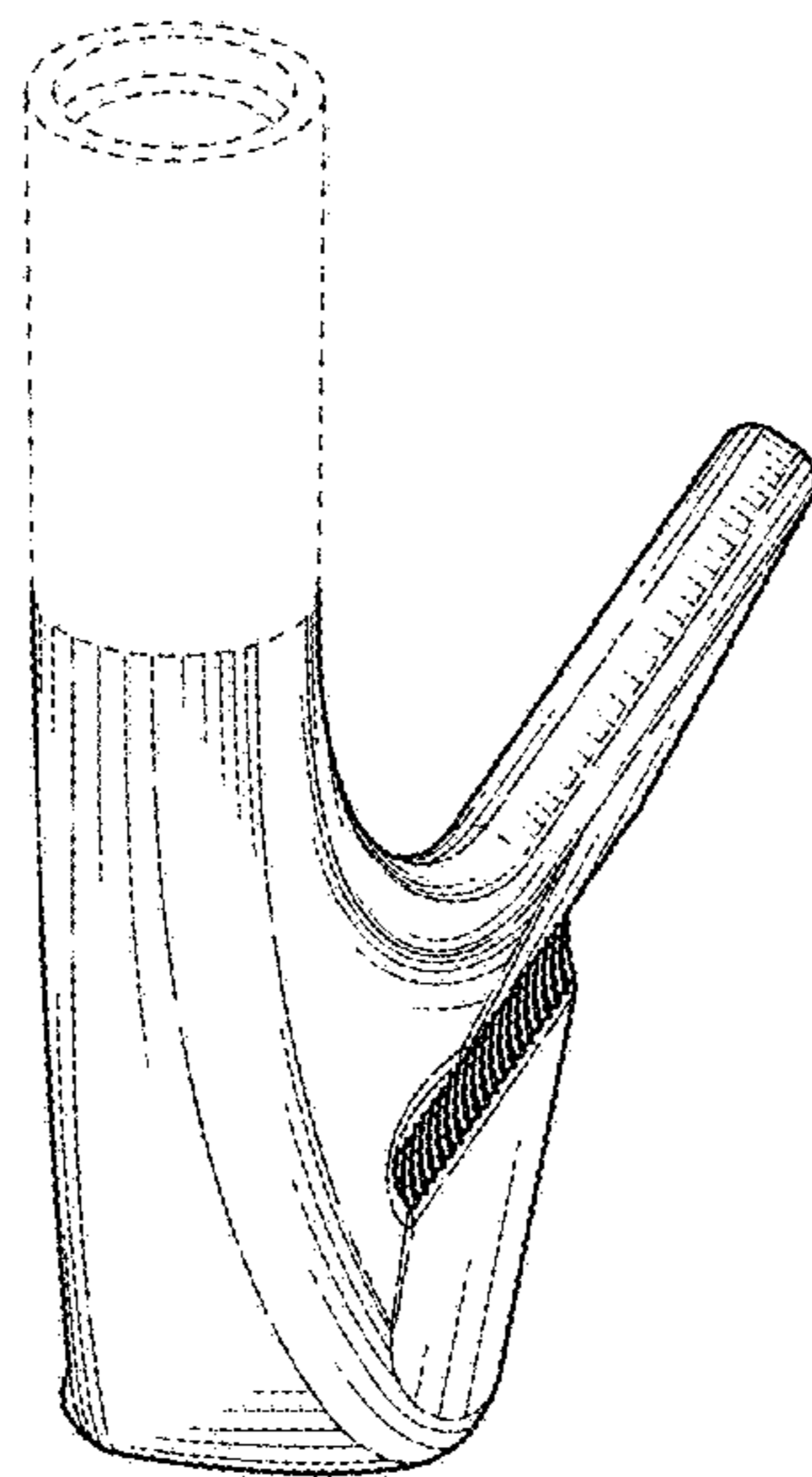

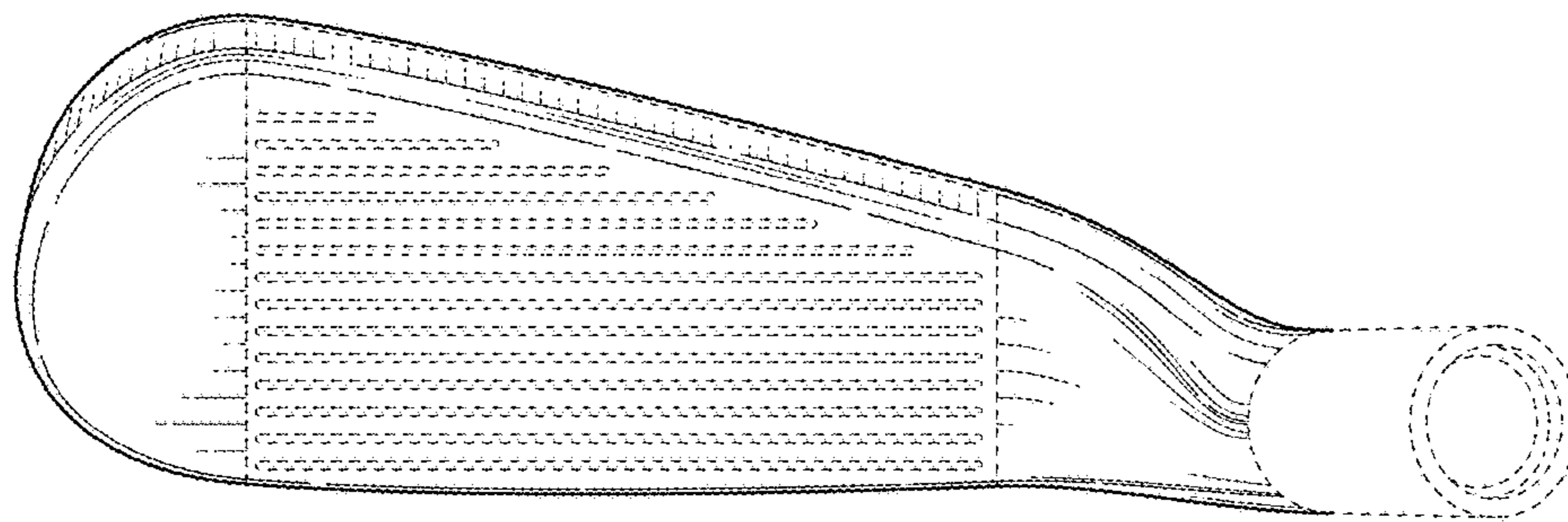

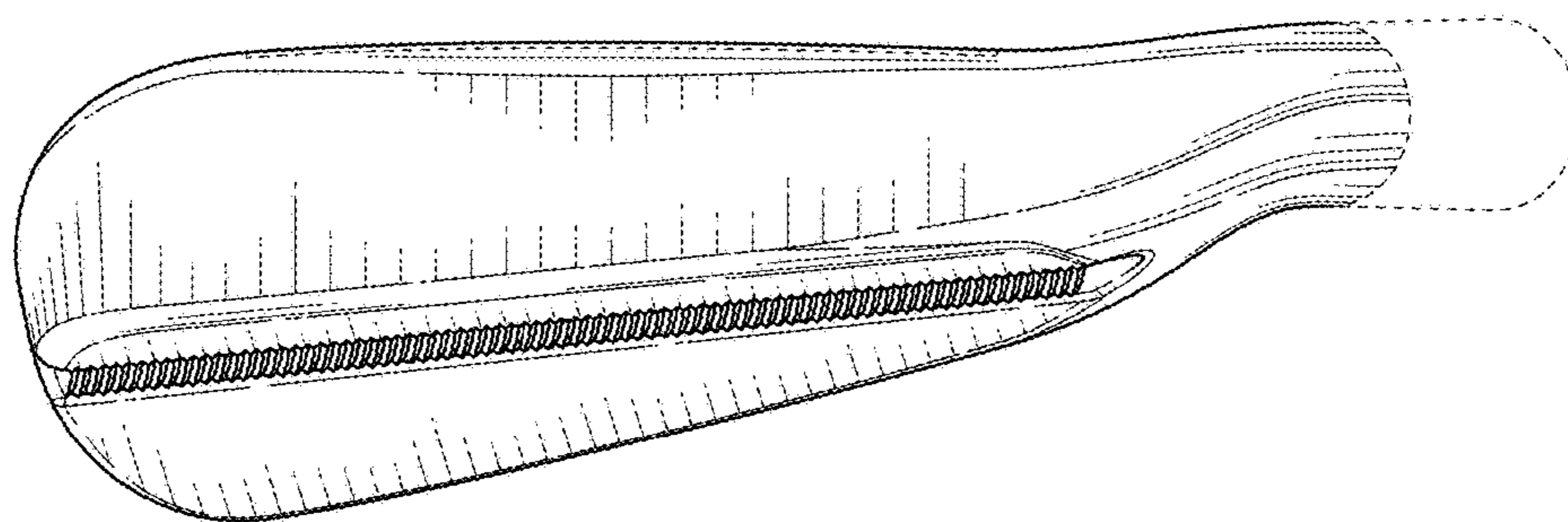

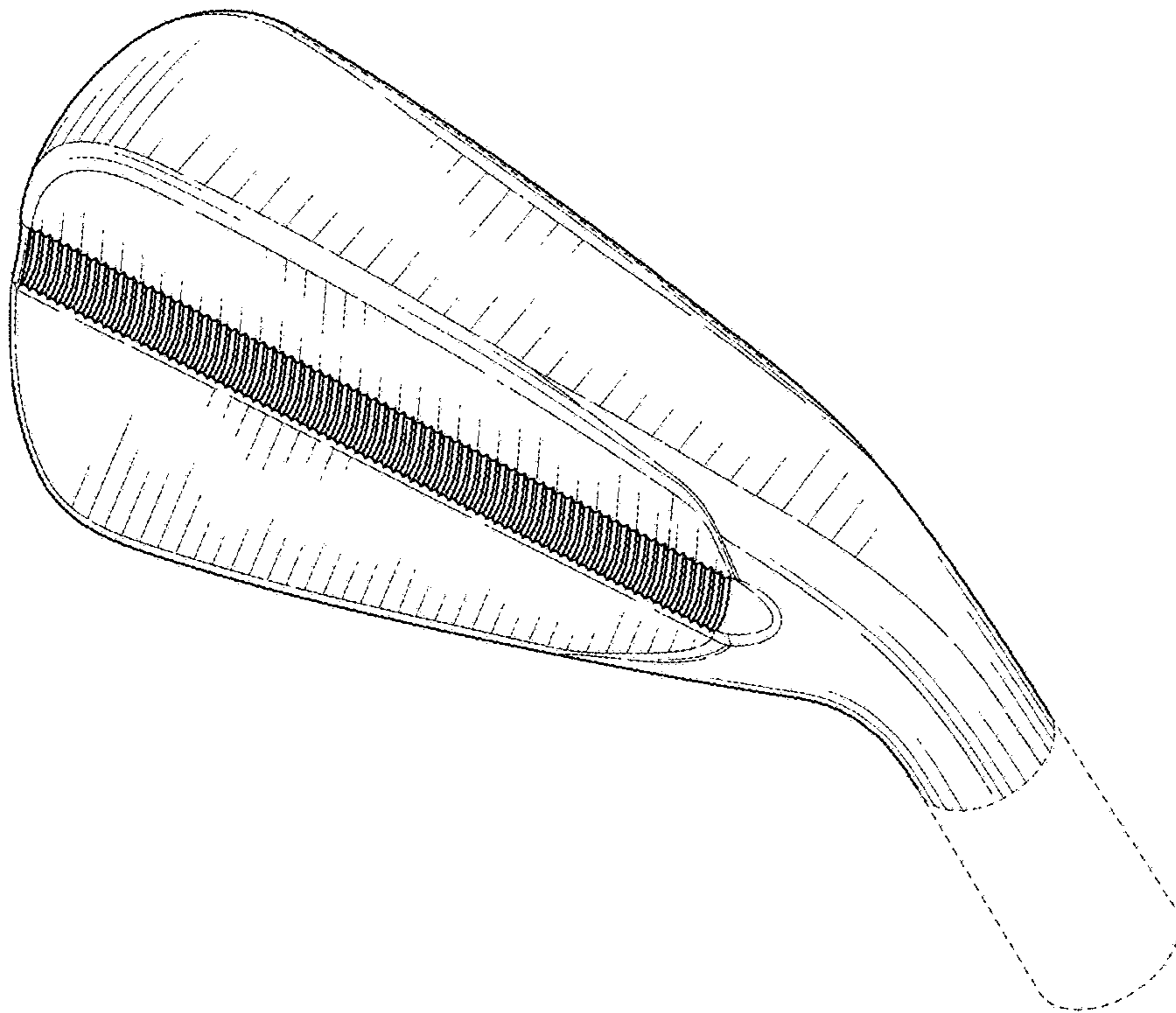
