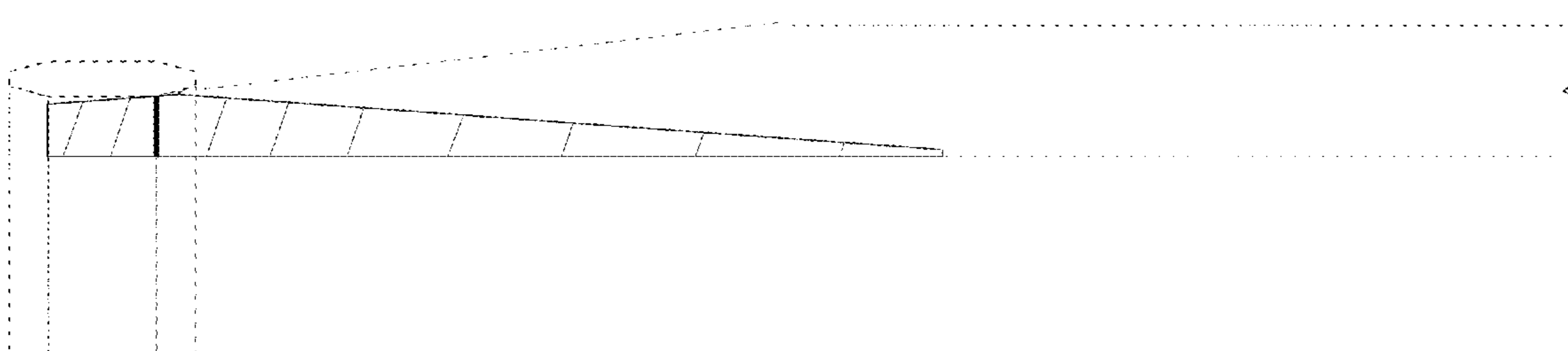
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a frontal elevational view of wrap guide showing my new design; and, FIG. 2 is a frontal elevational view thereof, shown with an unclaimed equipment handle. The claimed design has no substantial thickness and therefor is not claimed or shown. The broken lines disclosing the grip wrap and equipment handle is for illustrative purposes only and forms no part of the claimed design.

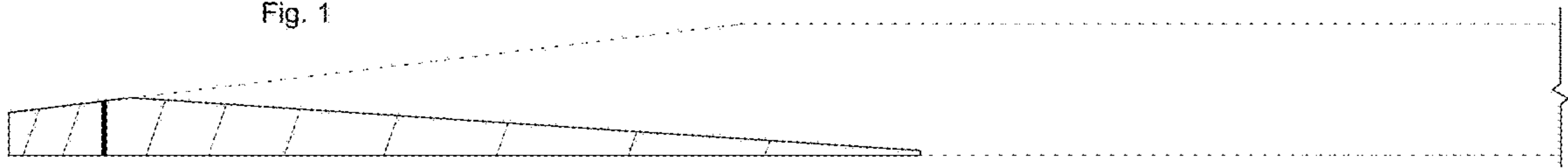
