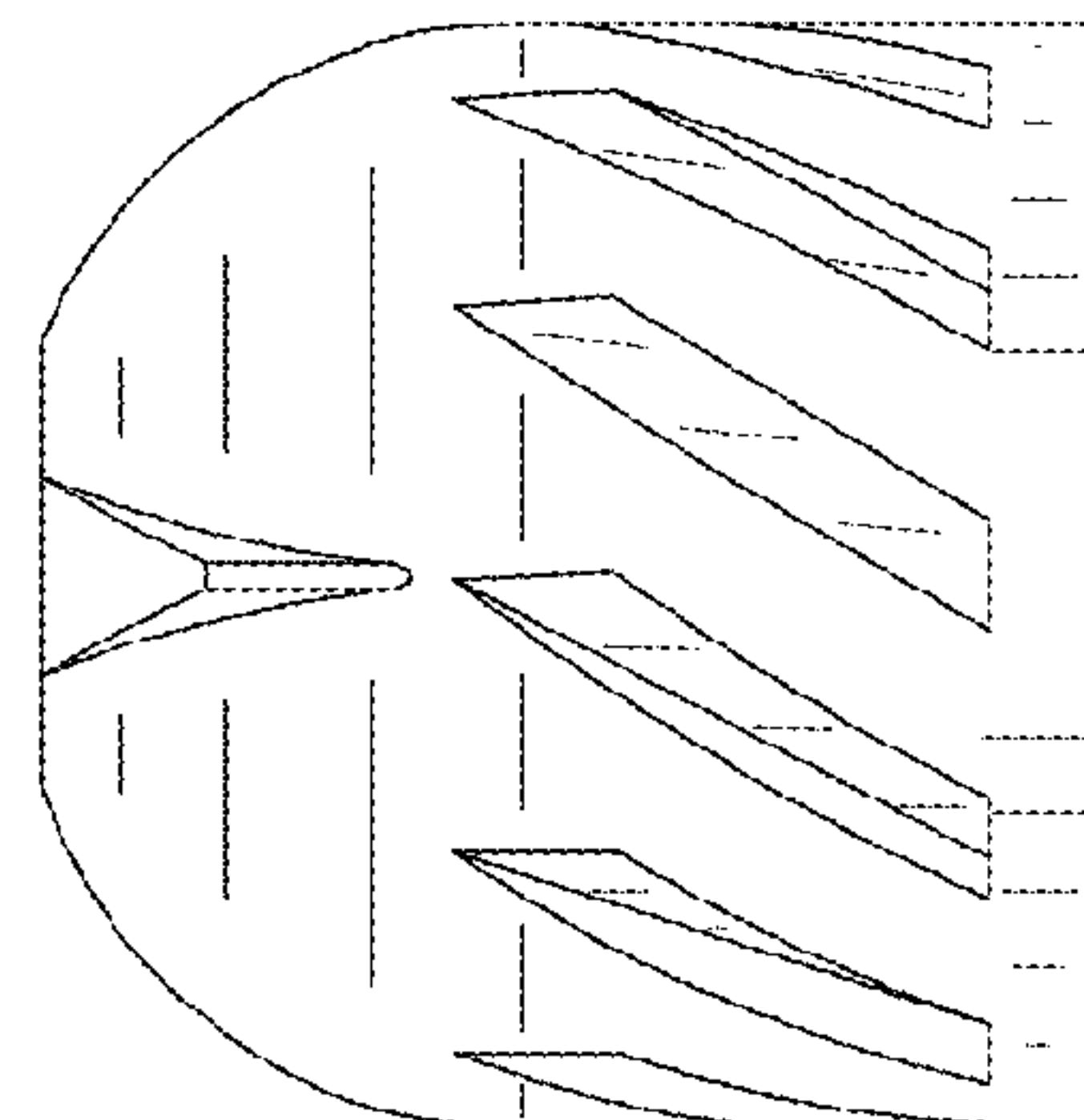
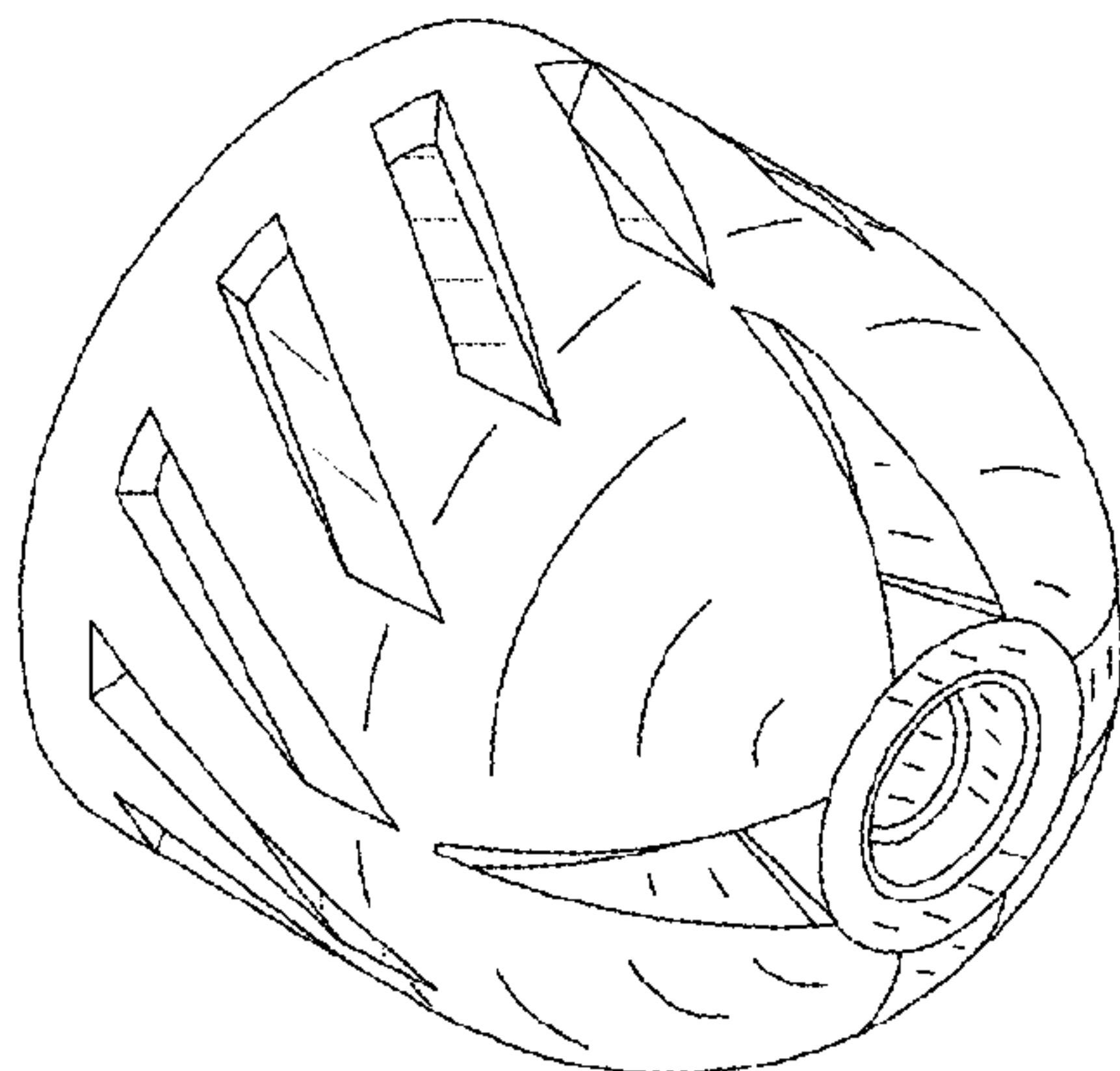
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the segmentable slug in accordance with my design;
 FIG. 2 is a left side elevation view of the segmentable slug as shown on FIG. 1,

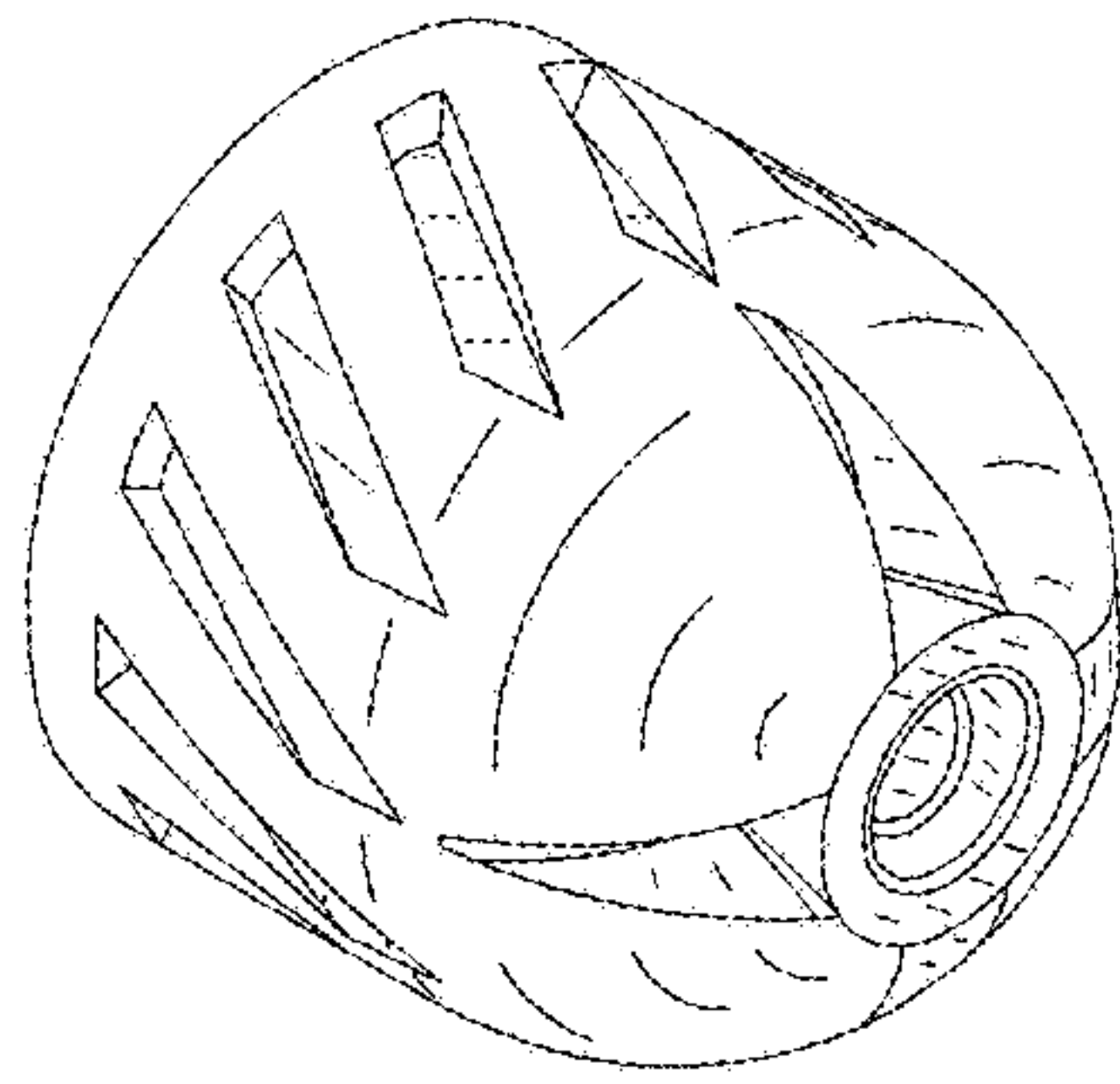

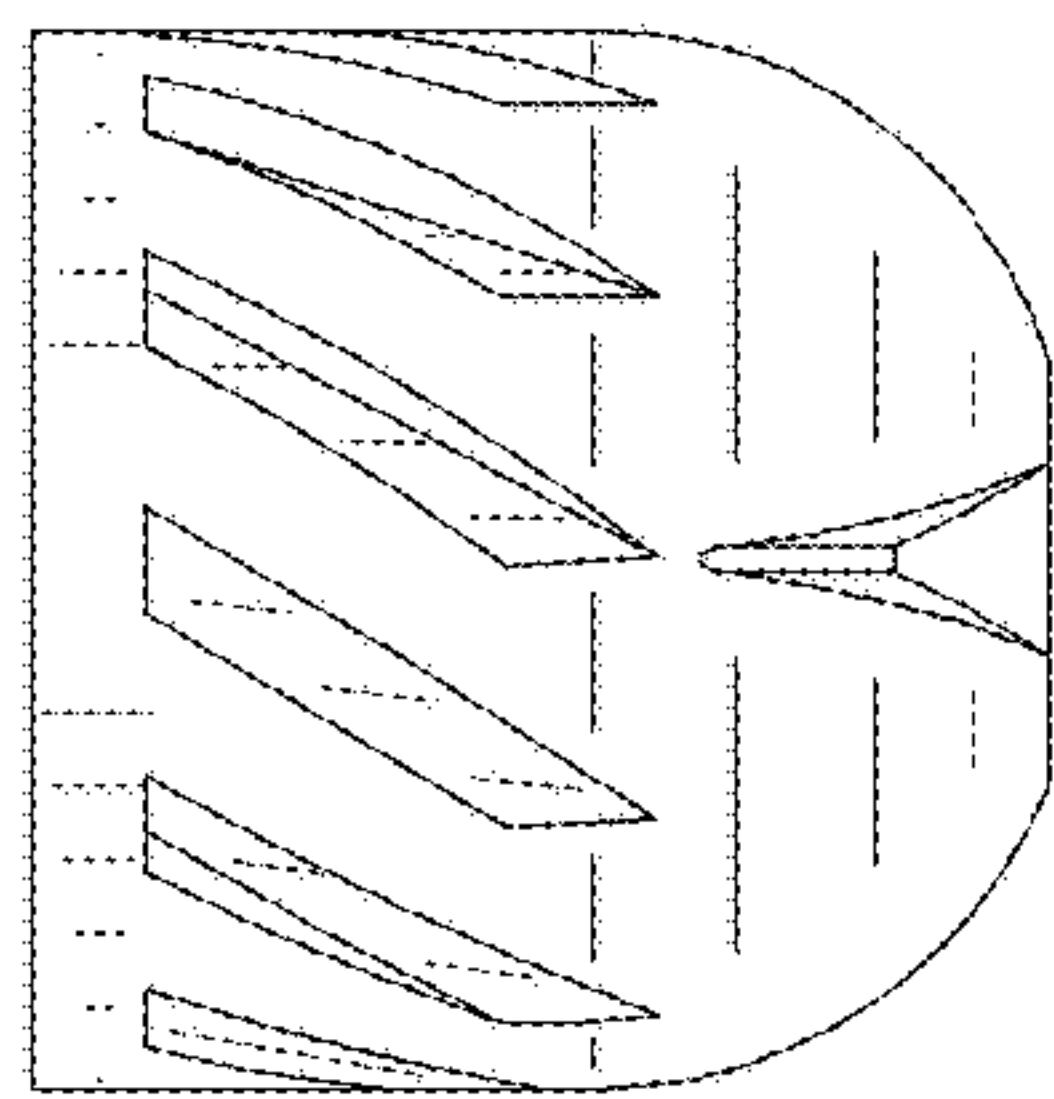

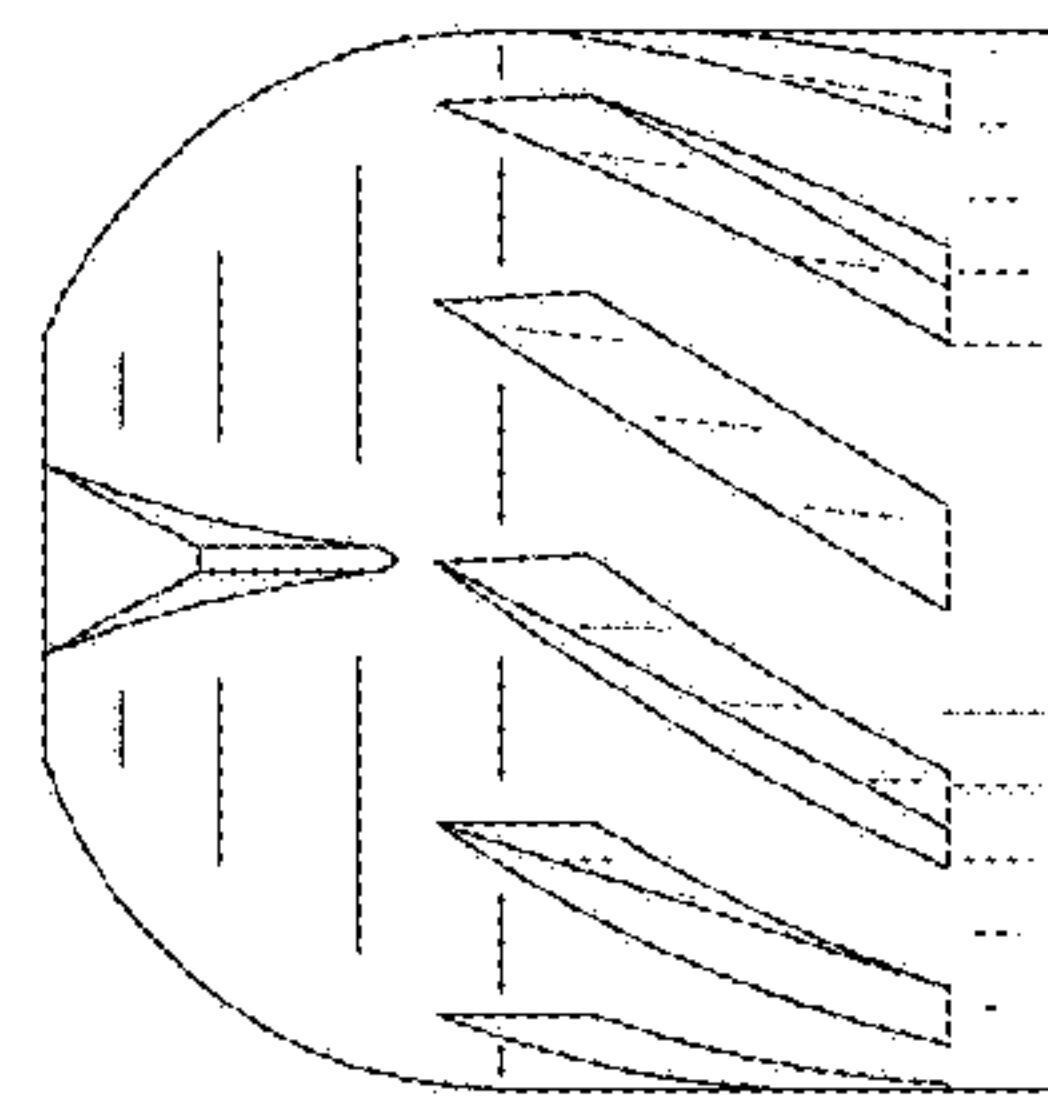

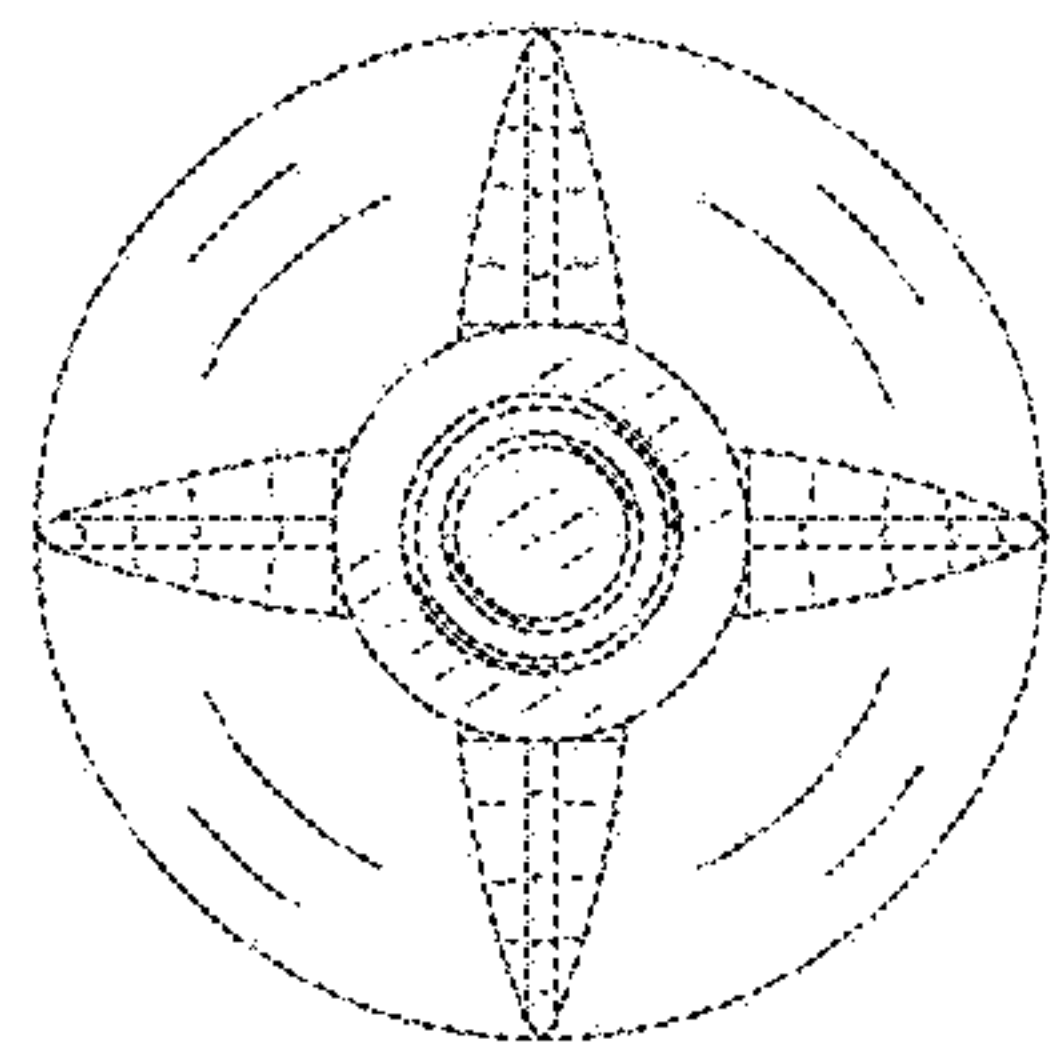

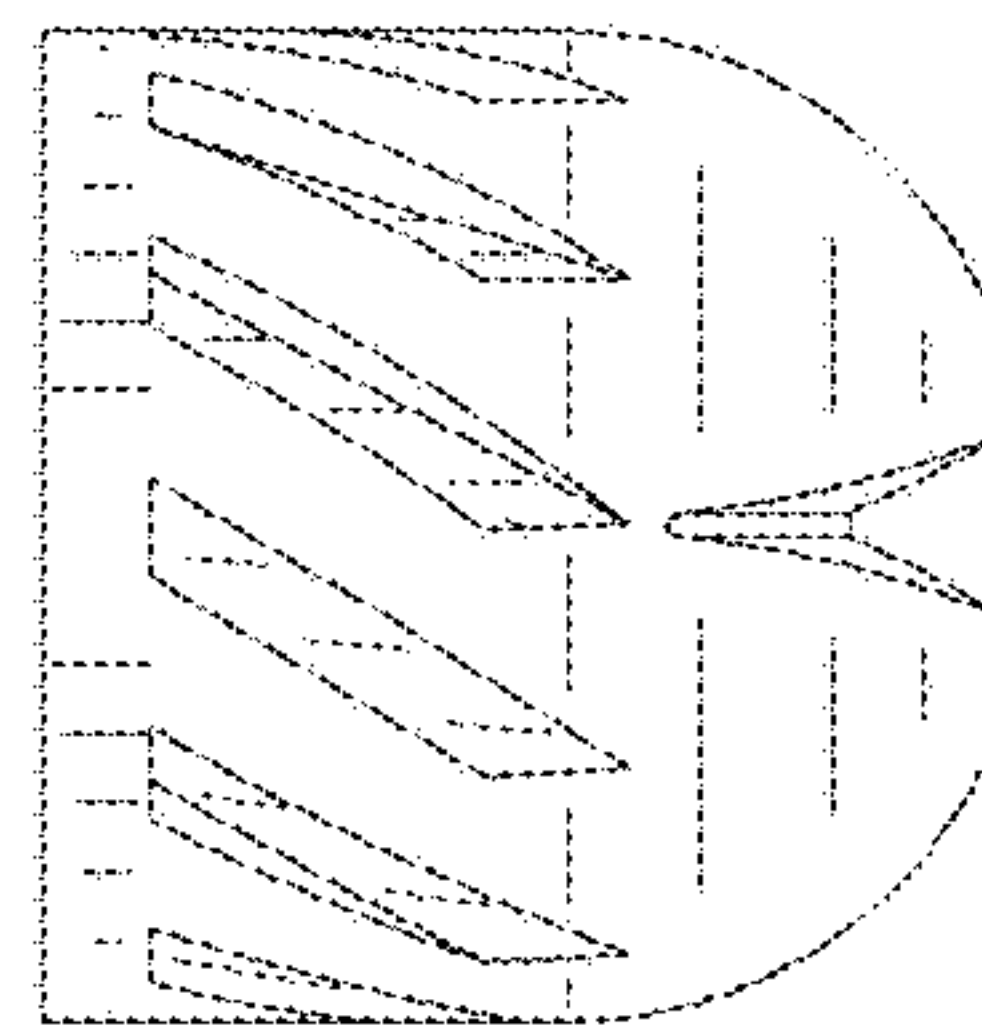

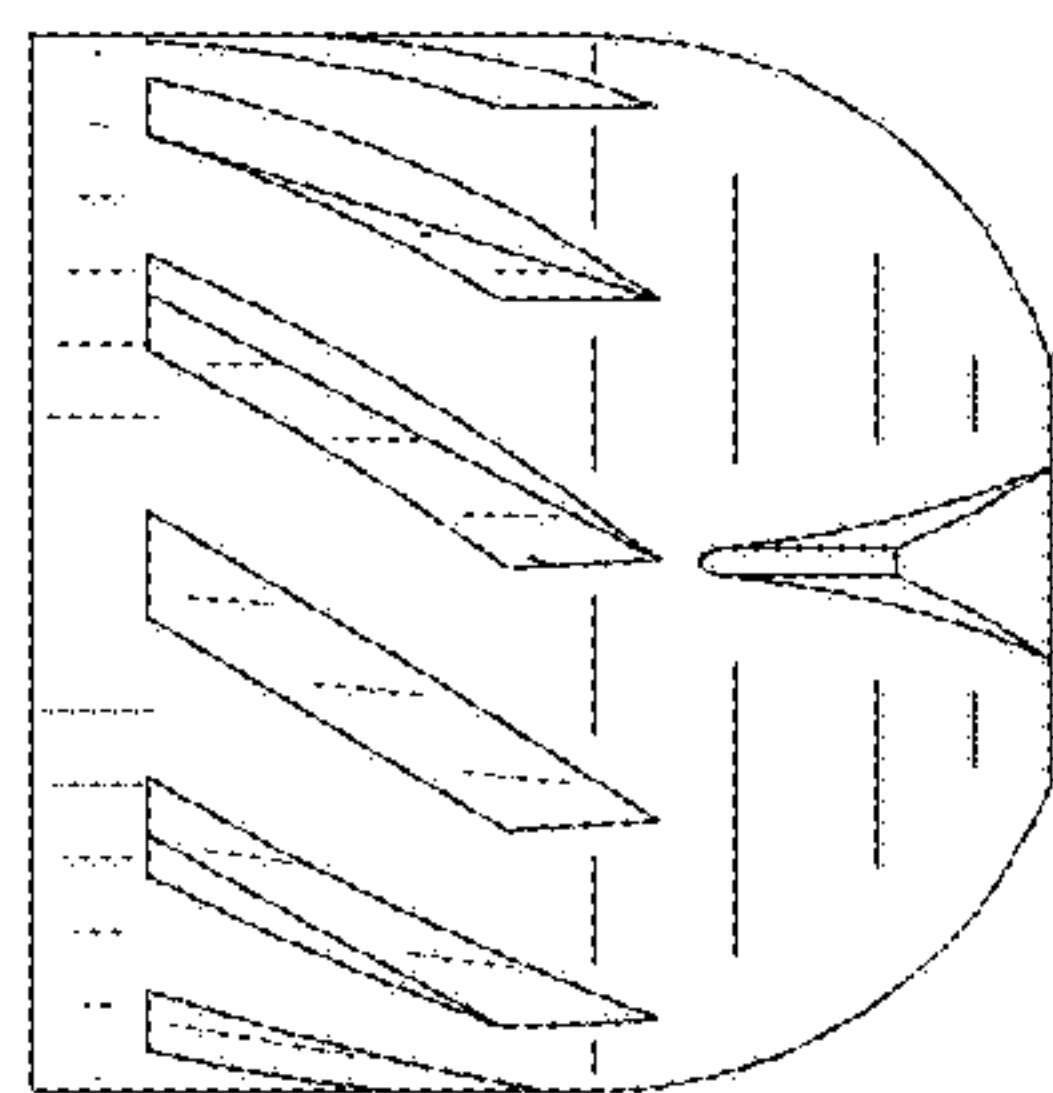
