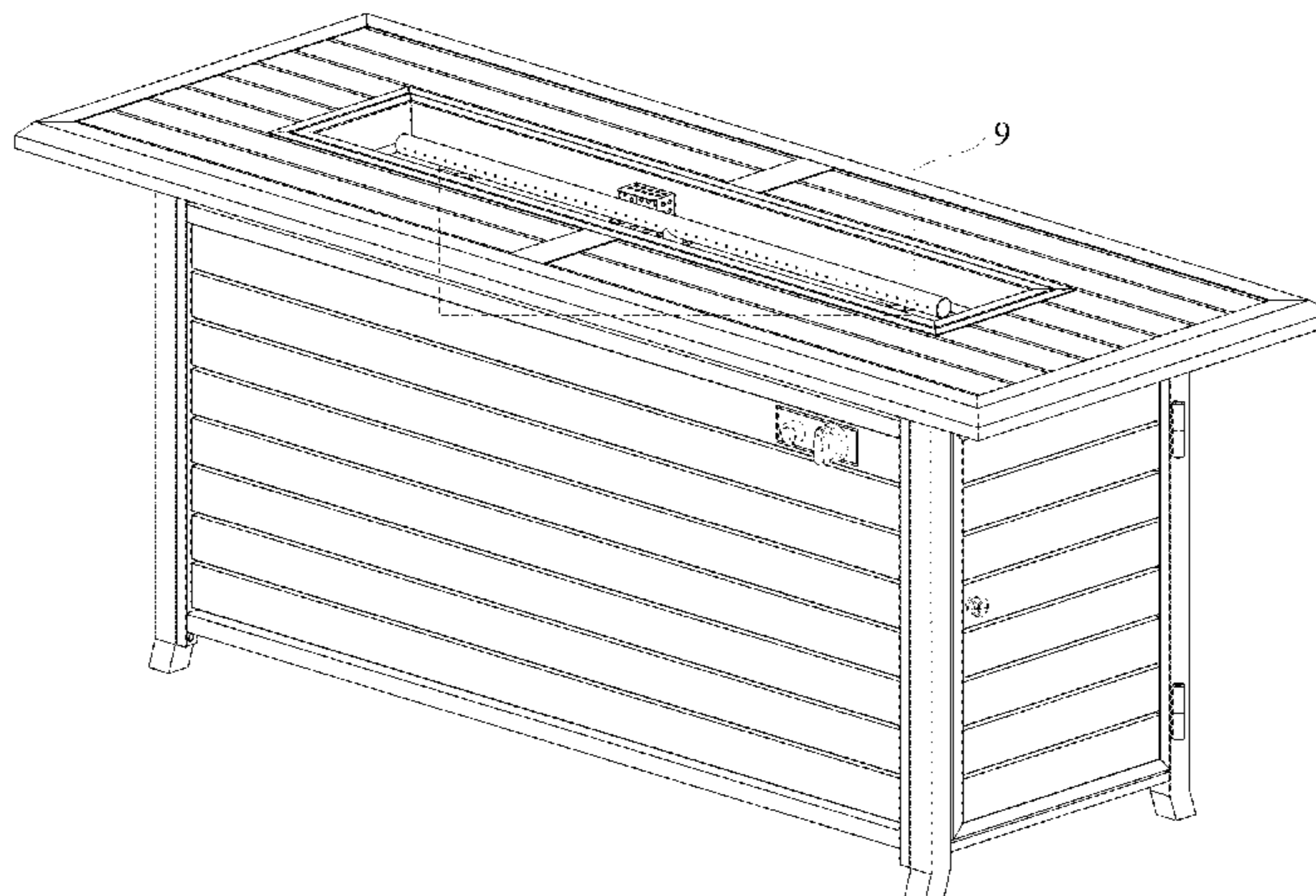
The ornamental design for a brazier heater, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a brazier heater showing the new design;
 FIG. 2 is a front view thereof;
 FIG. 3 is a rear view thereof;
 FIG. 4 is a top view thereof;
 FIG. 5 is a bottom view thereof;
 FIG. 6 is a left side view thereof;
 FIG. 7 is a right side view thereof;
 FIG. 8 is a fly enlarged view of the indicated area “8” in the FIG. 2;
 FIG. 9 is a partially enlarged view of the indicated area “9” in the FIG. 1;
 FIG. 10 is a partially enlarged view of the indicated area “10” in the FIG. 4;
 FIG. 11 is a partially enlarged view of the indicated area “11” in the FIG. 6;
 FIG. 12 is a partially enlarged view of the indicated area “12” in the FIG. 6; and,
 FIG. 13 is a partially enlarged view of the indicated area “13” in the FIG. 7.

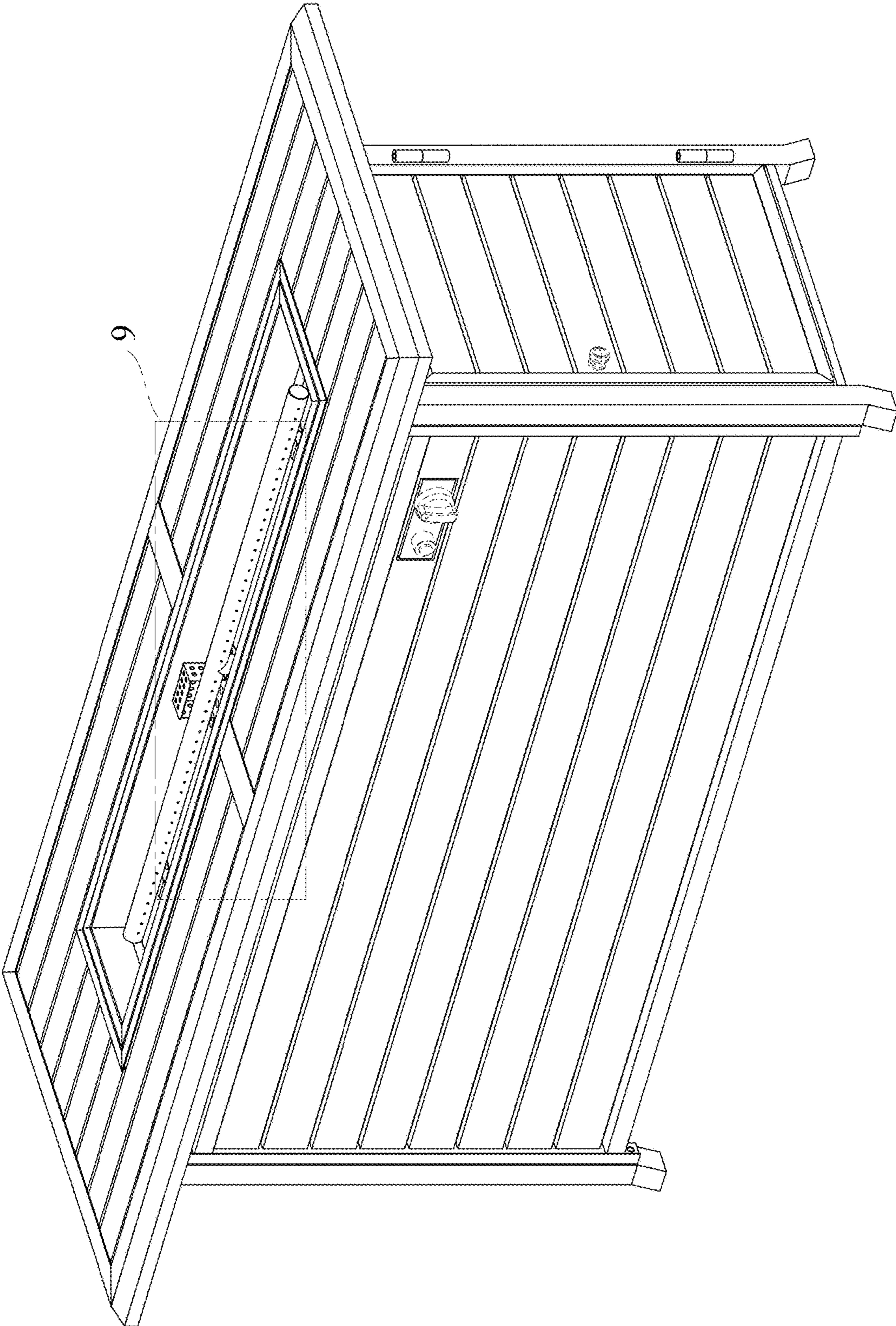

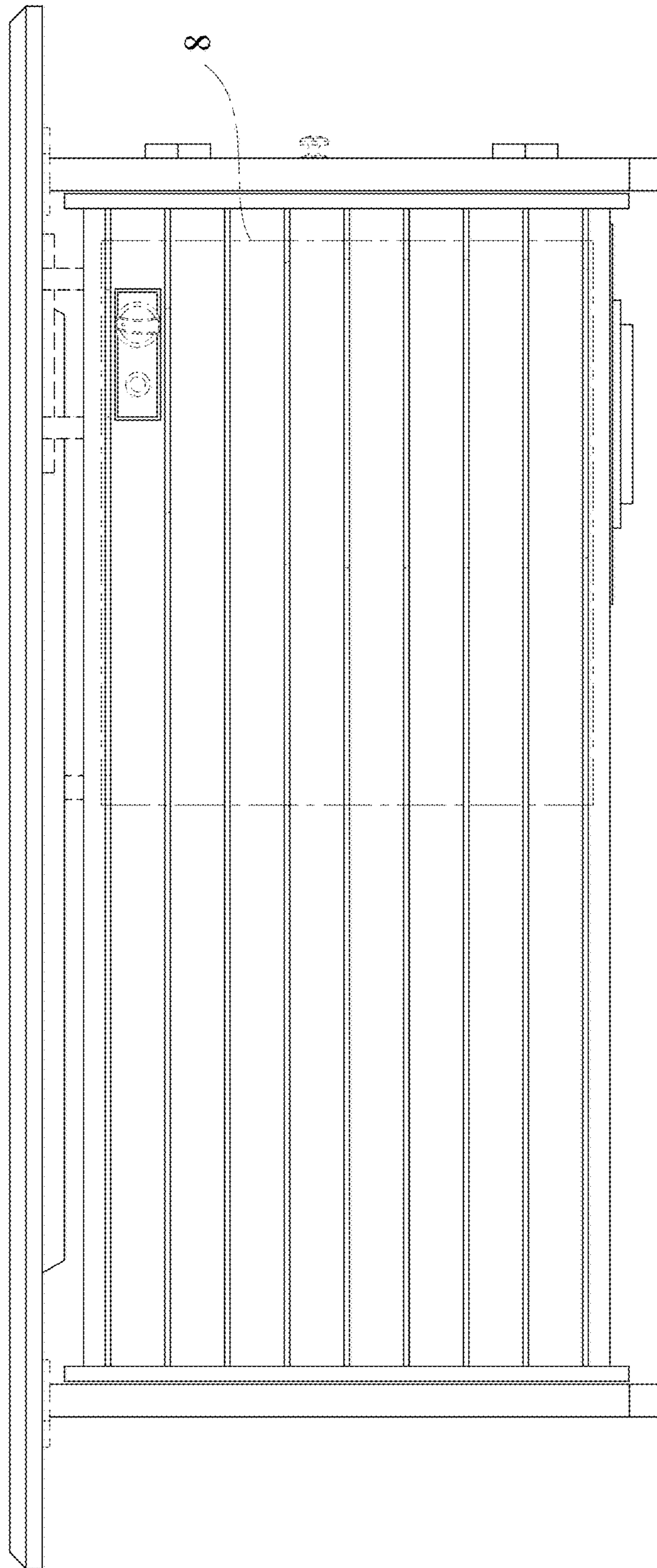

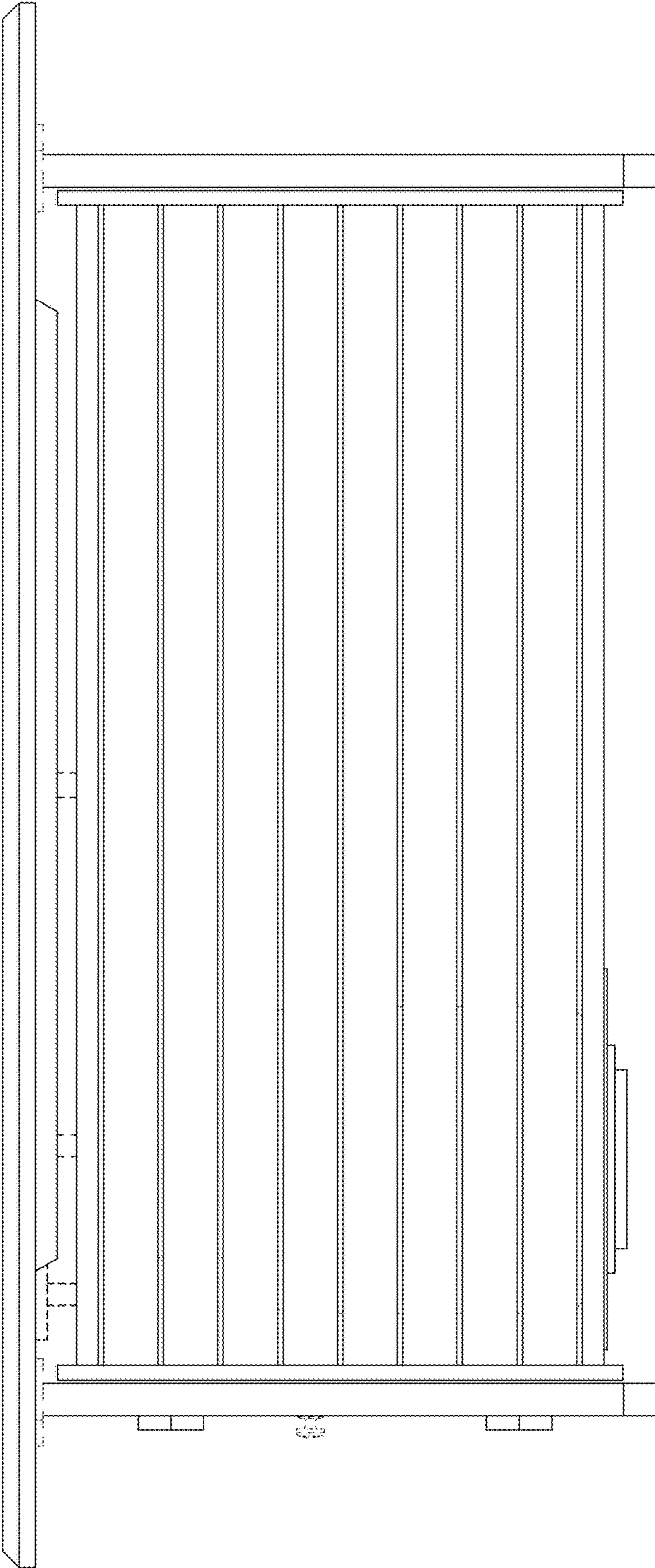

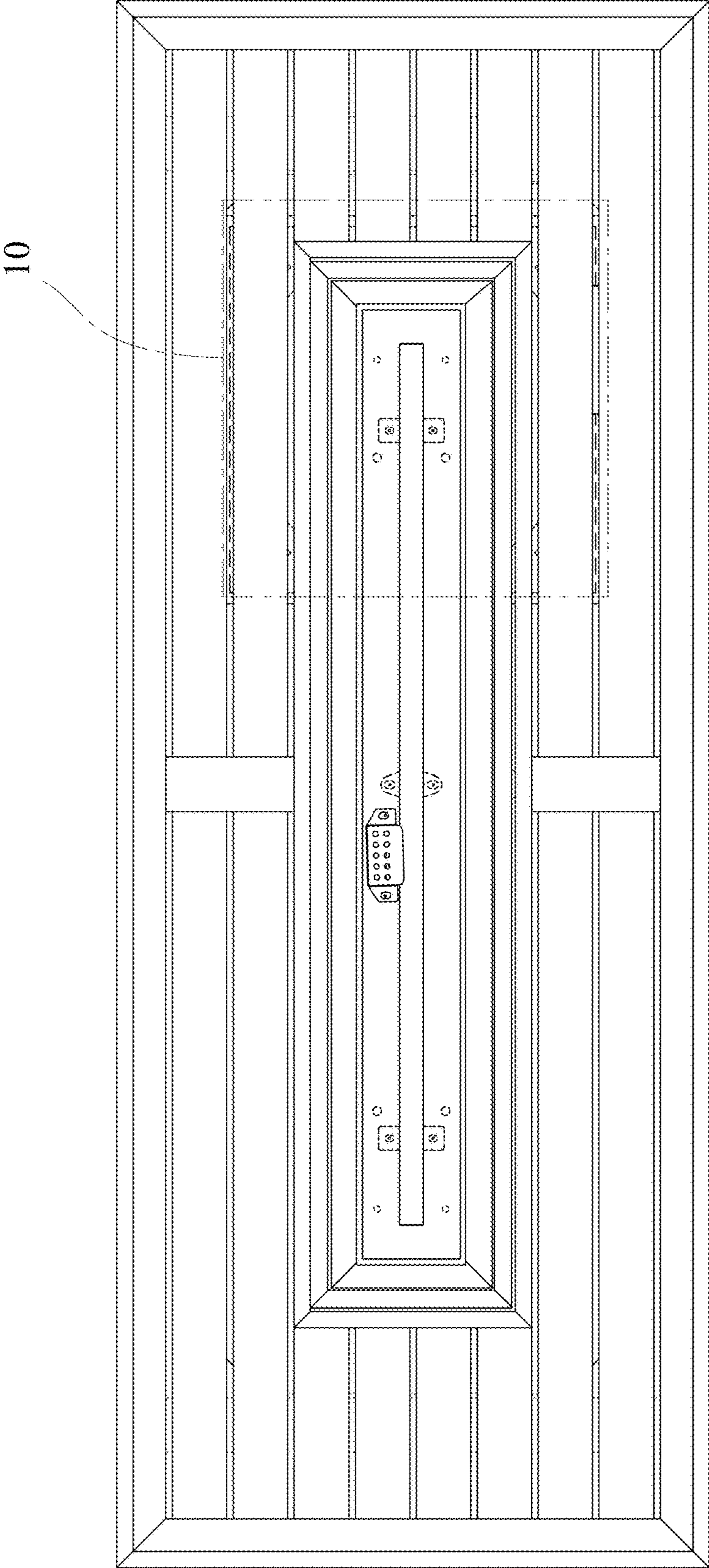

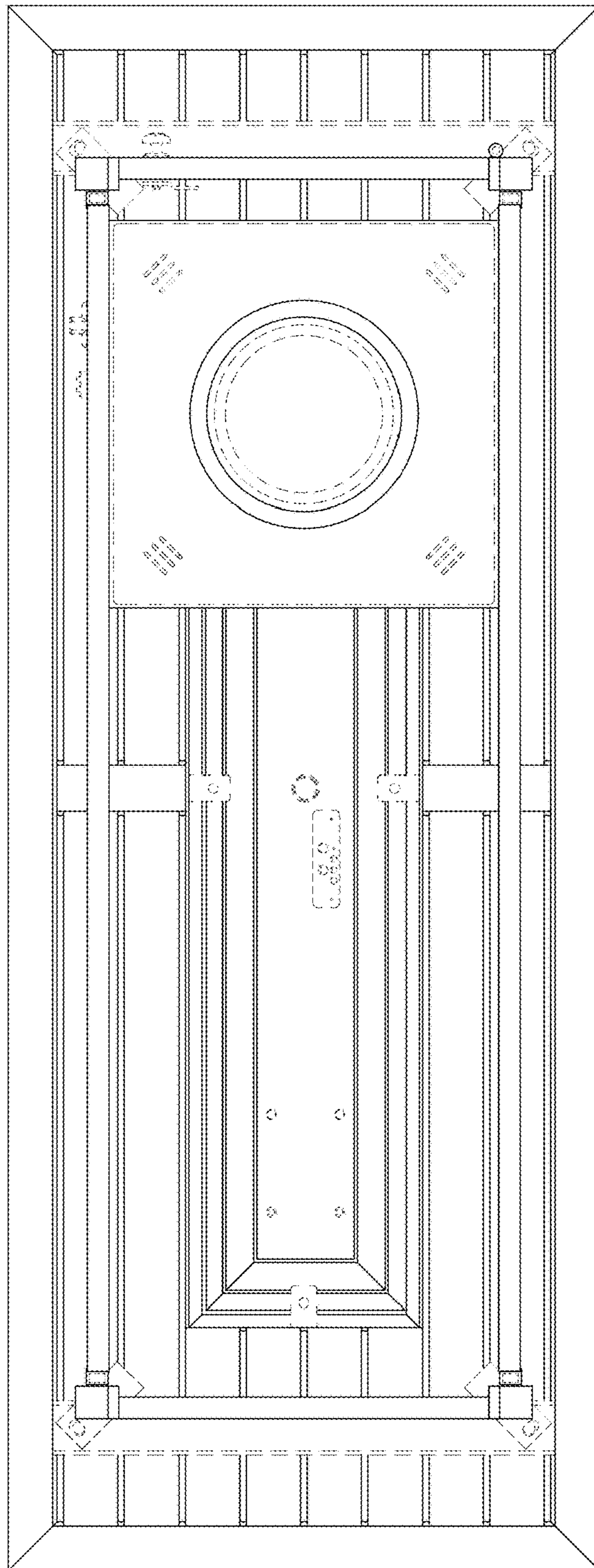

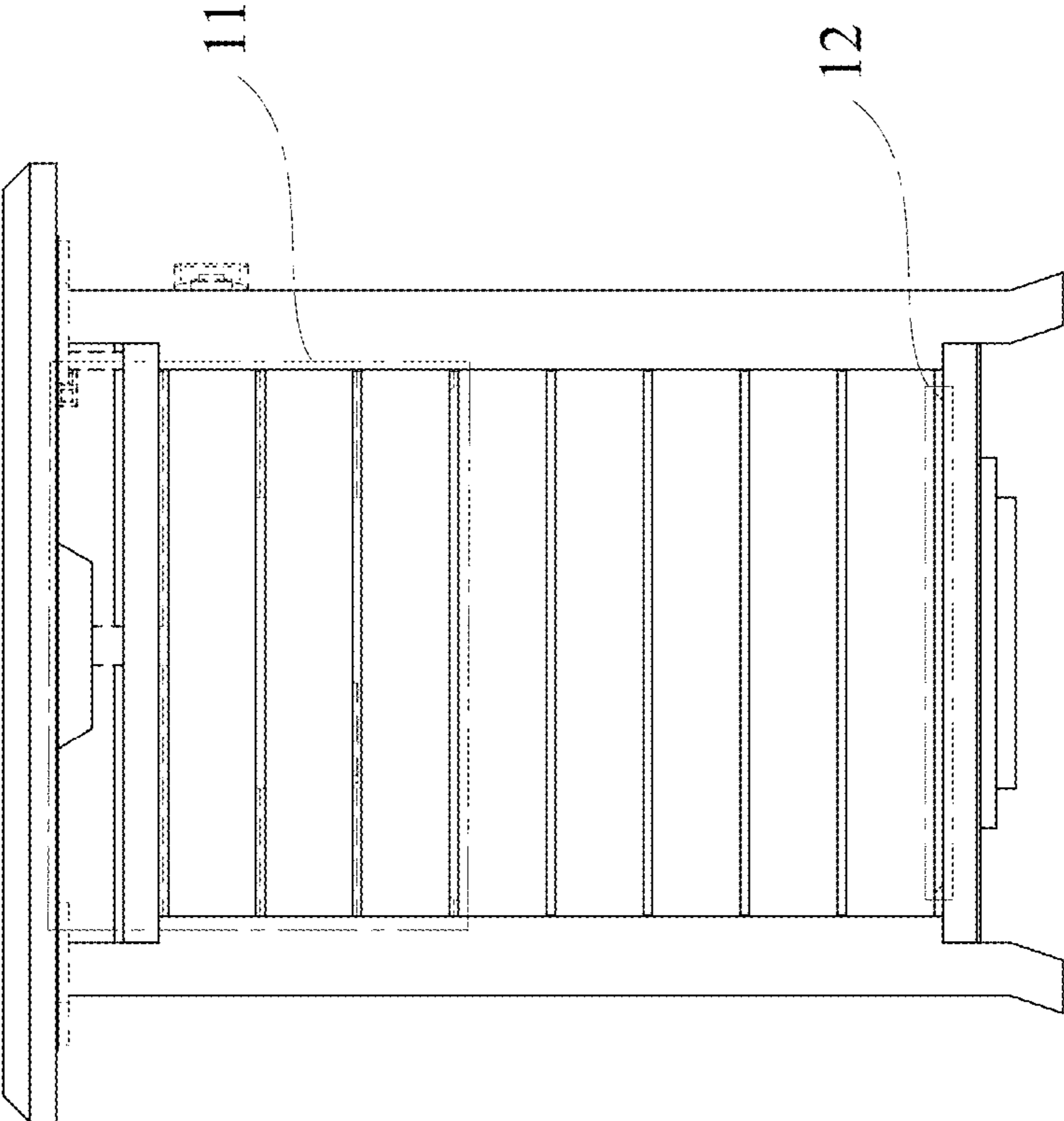

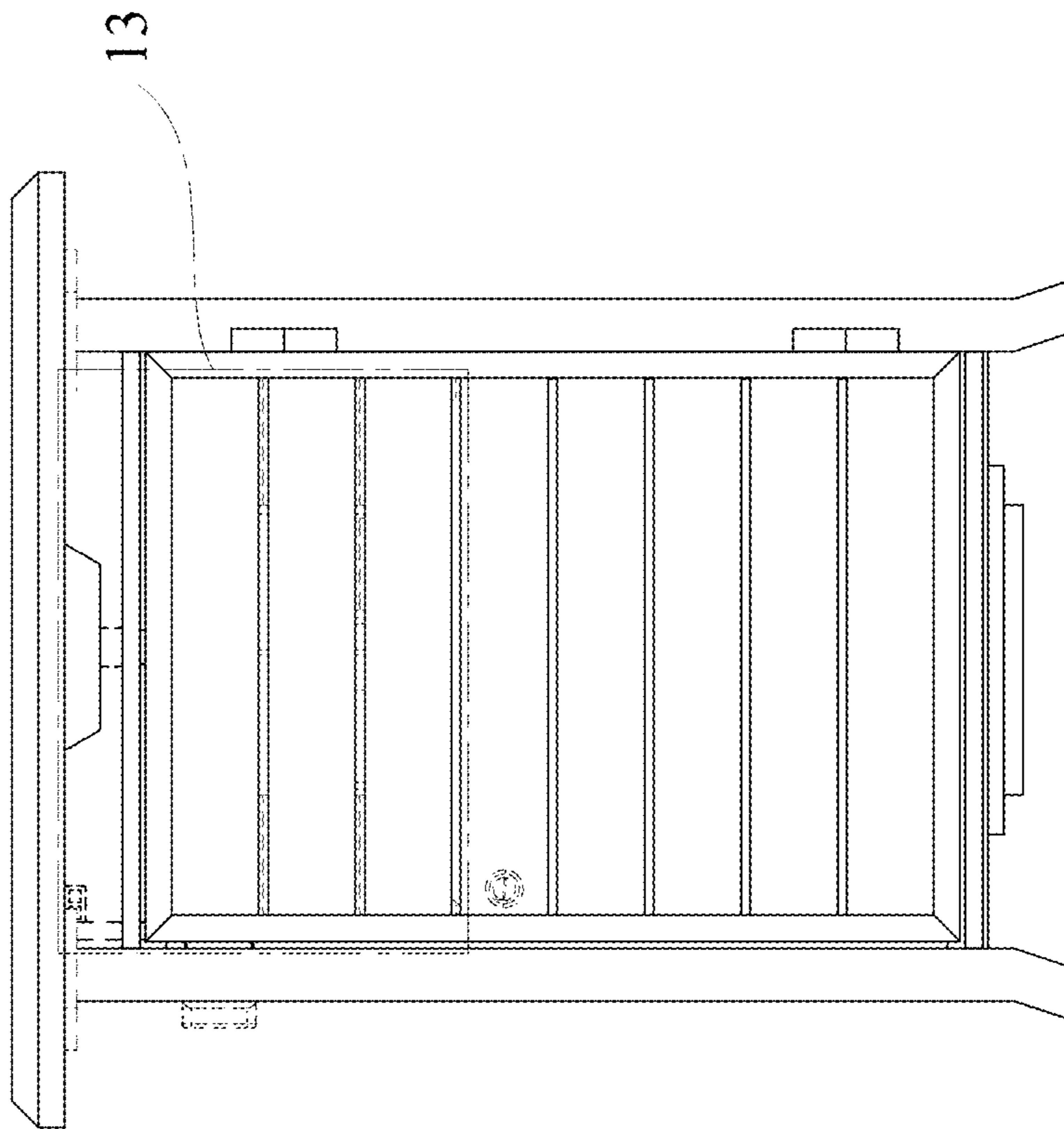

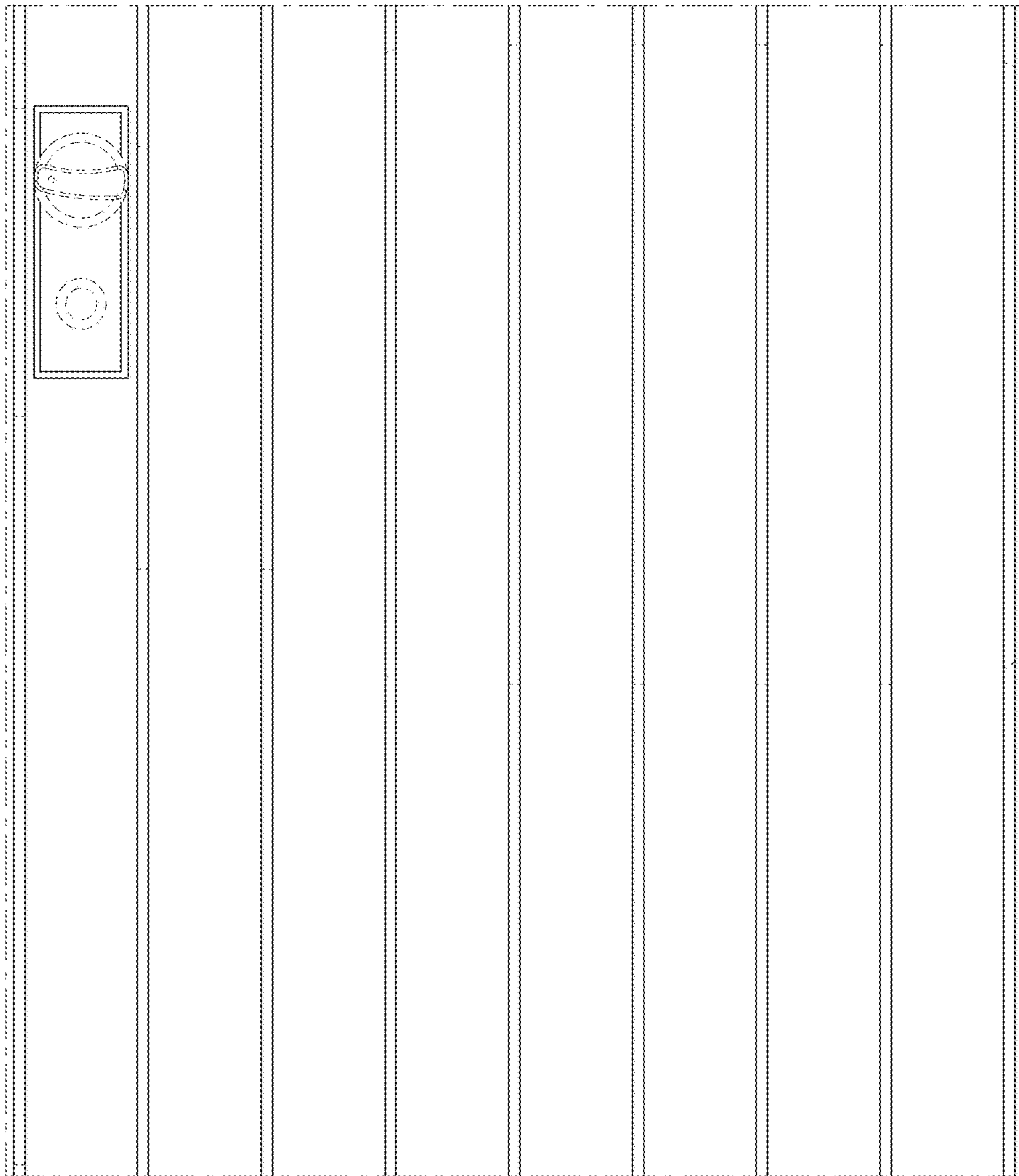

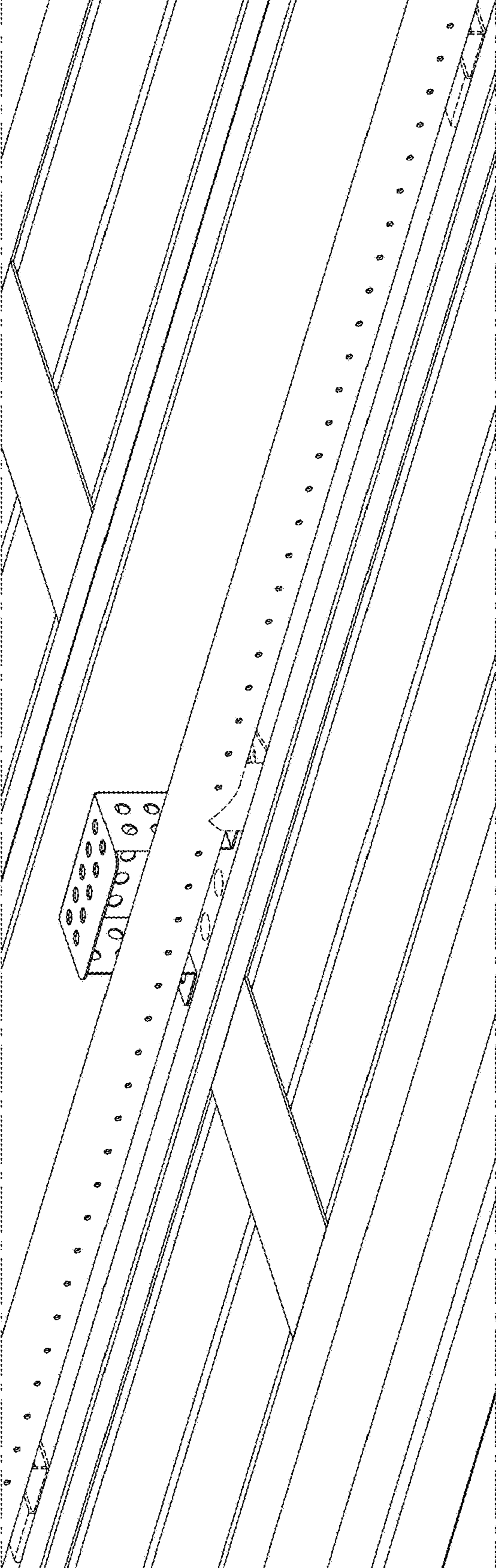

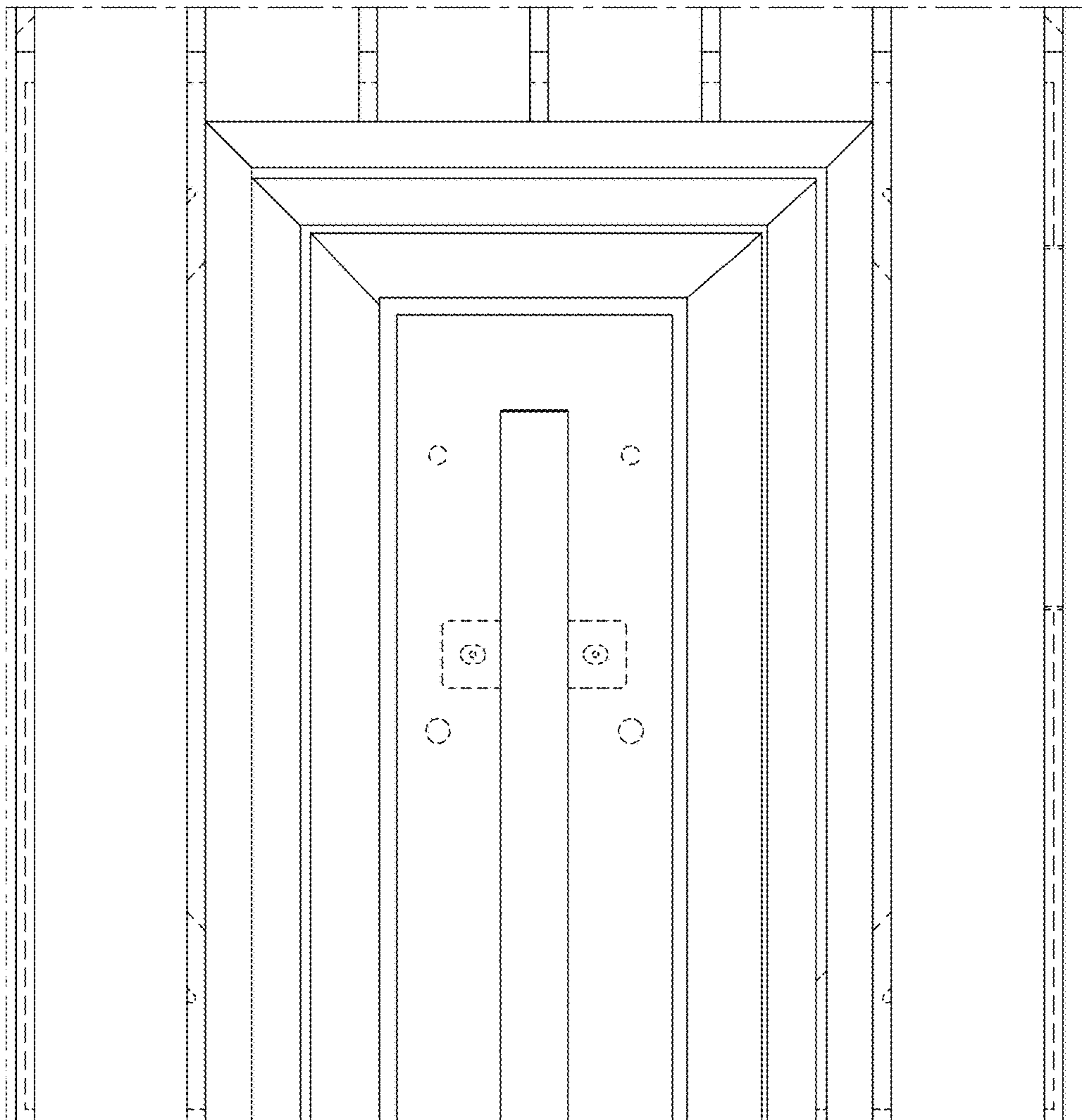

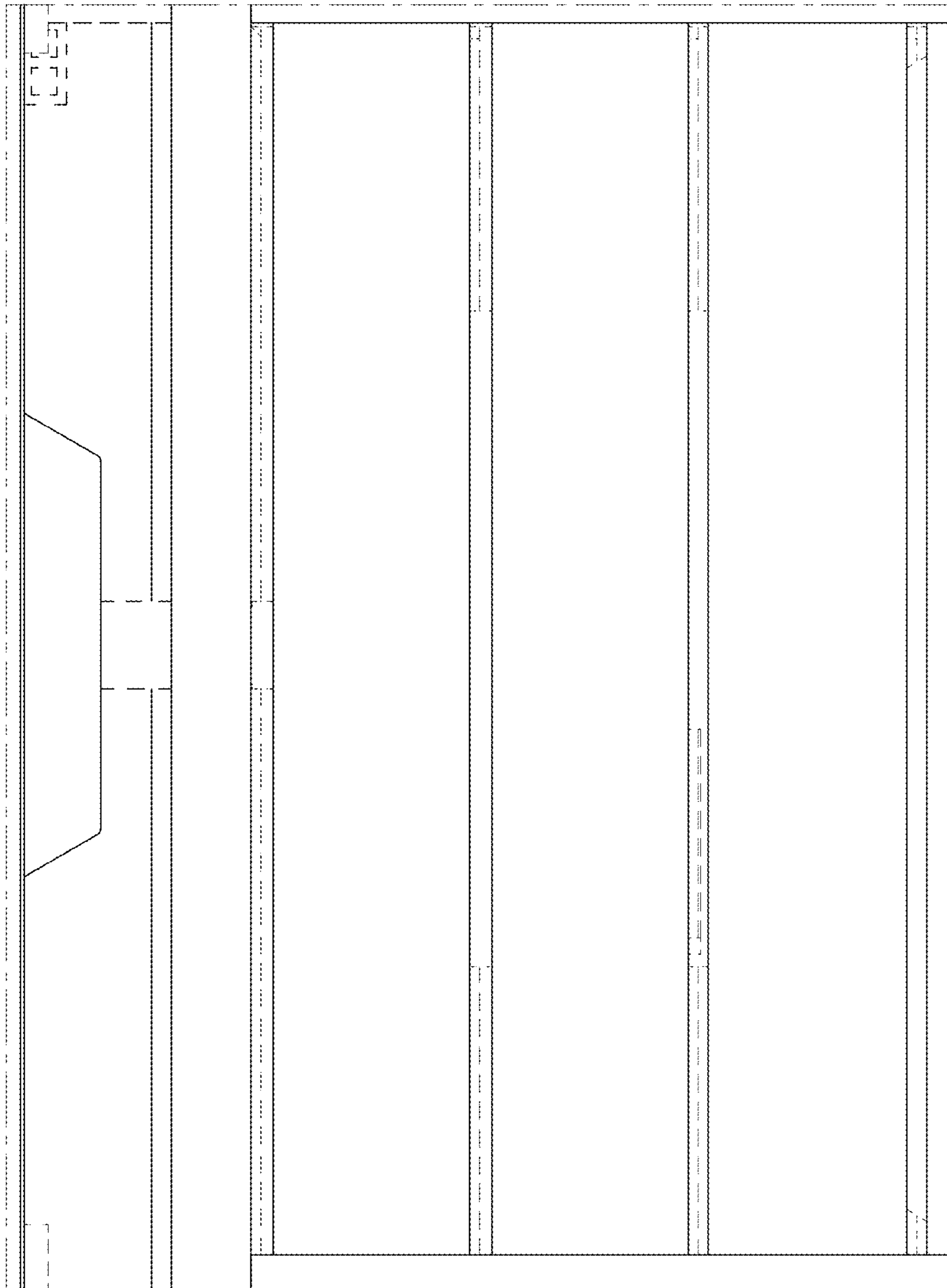

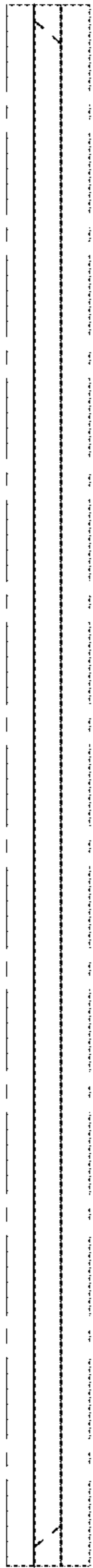

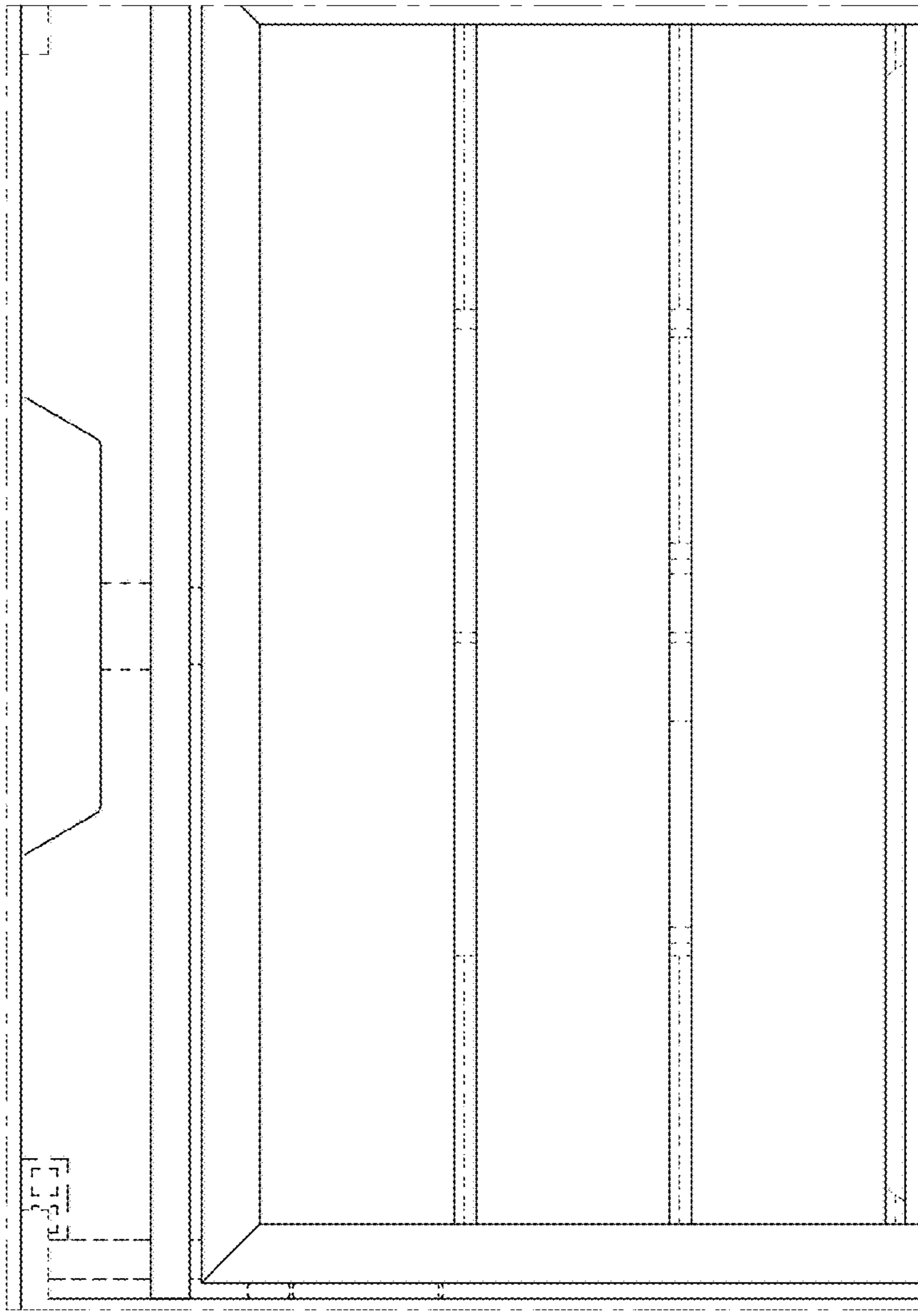
