FIG. 12 a front elevational view thereof;

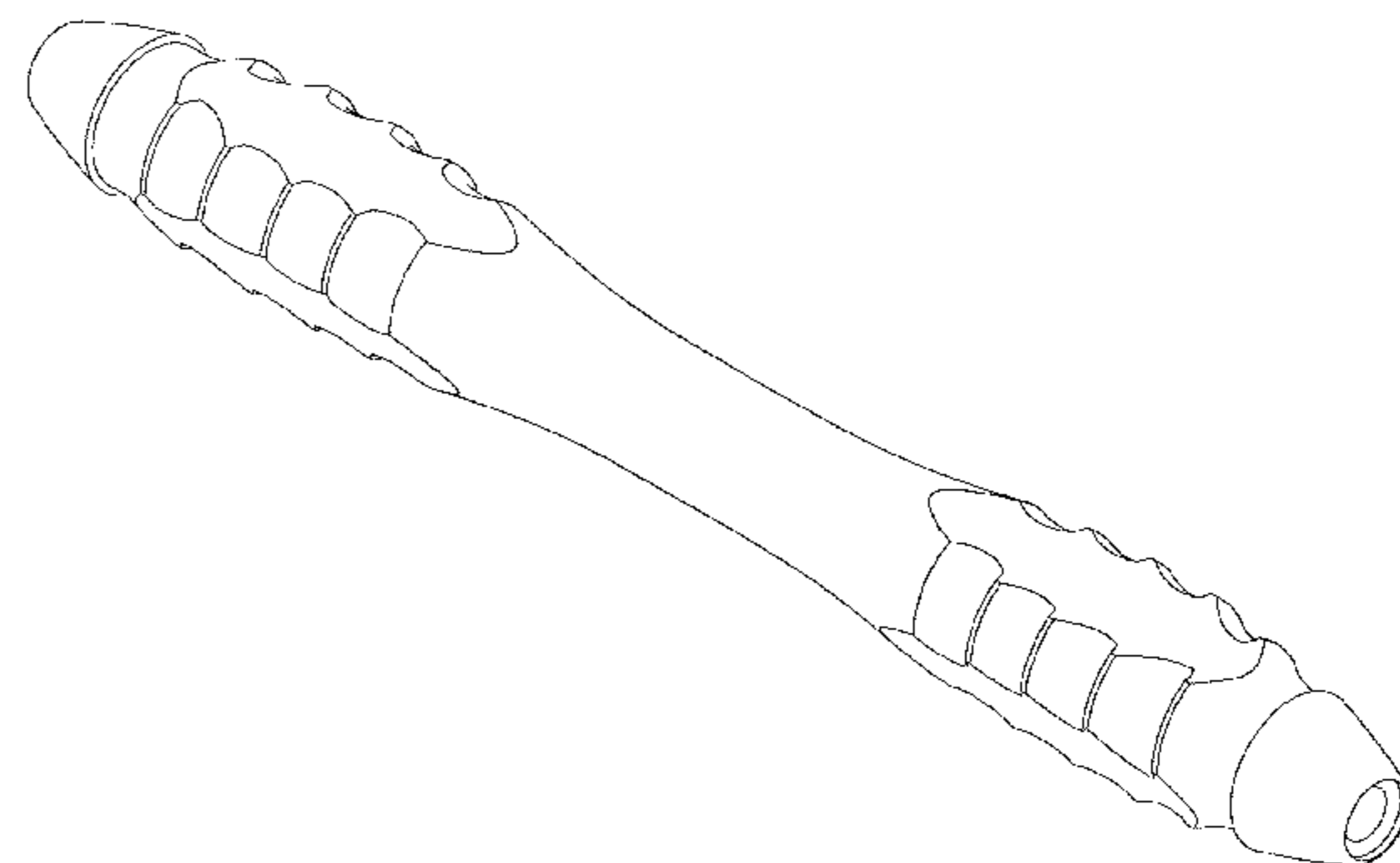
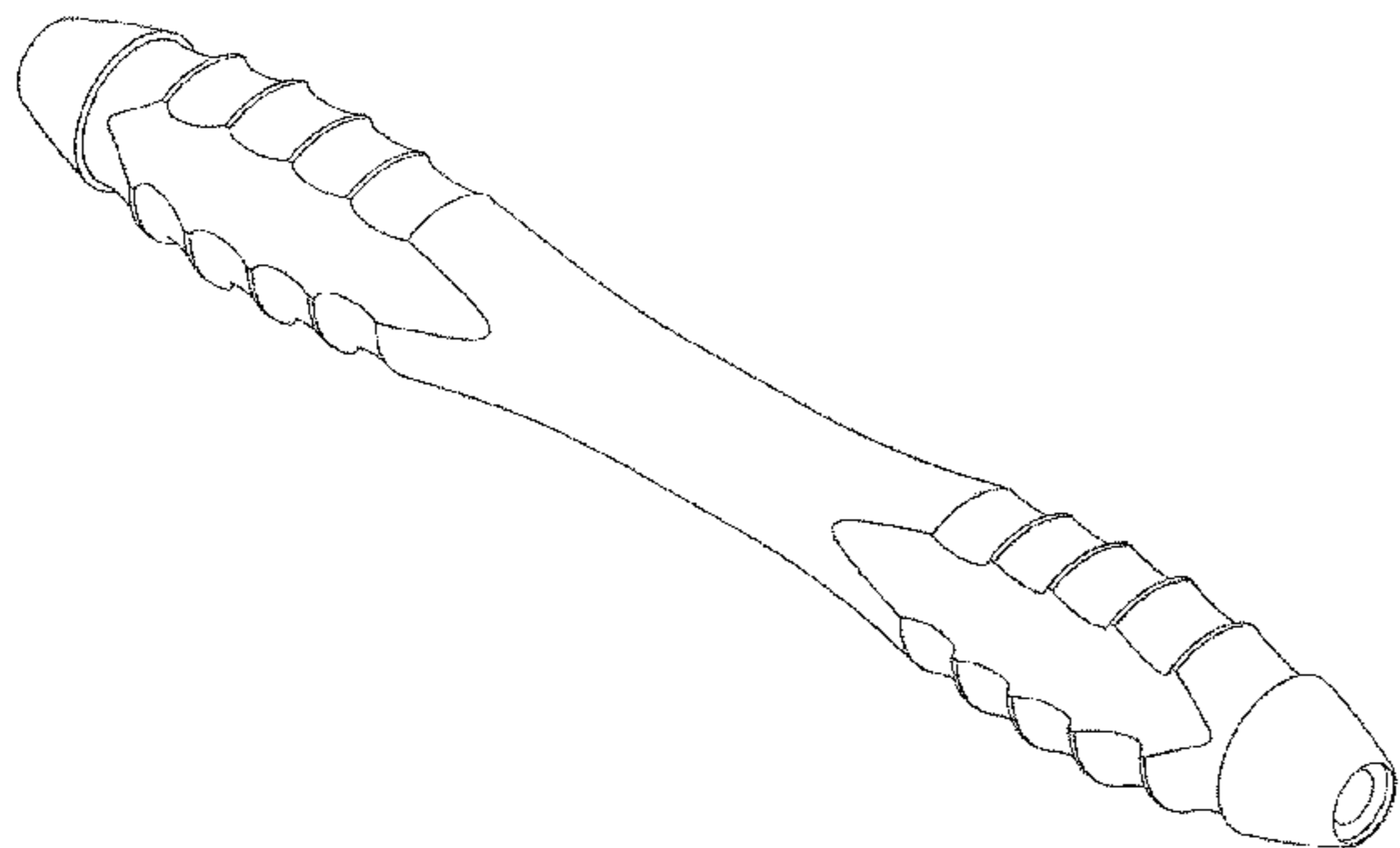
FIG. 13 is a top perspective view of a handle for a surgical

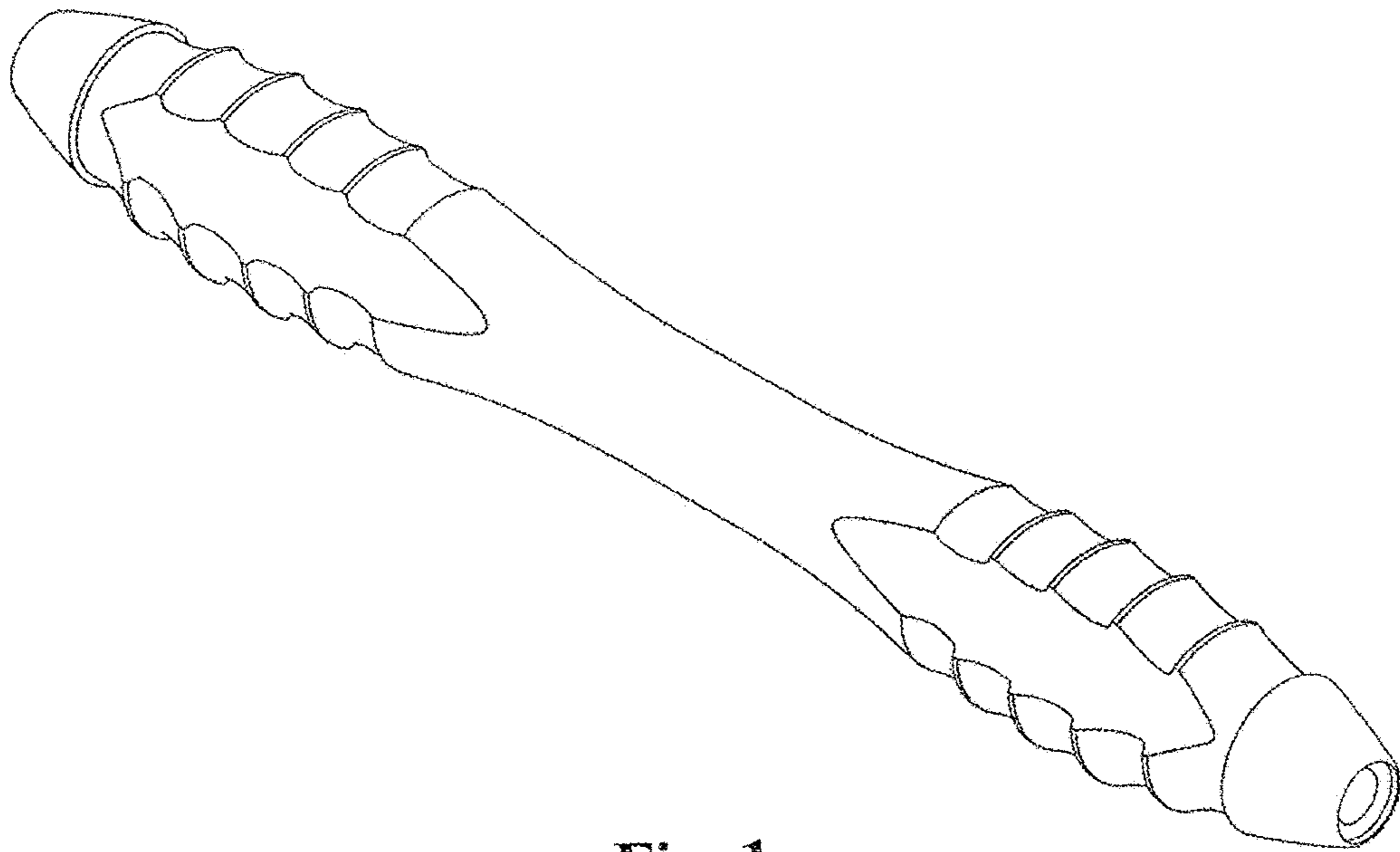

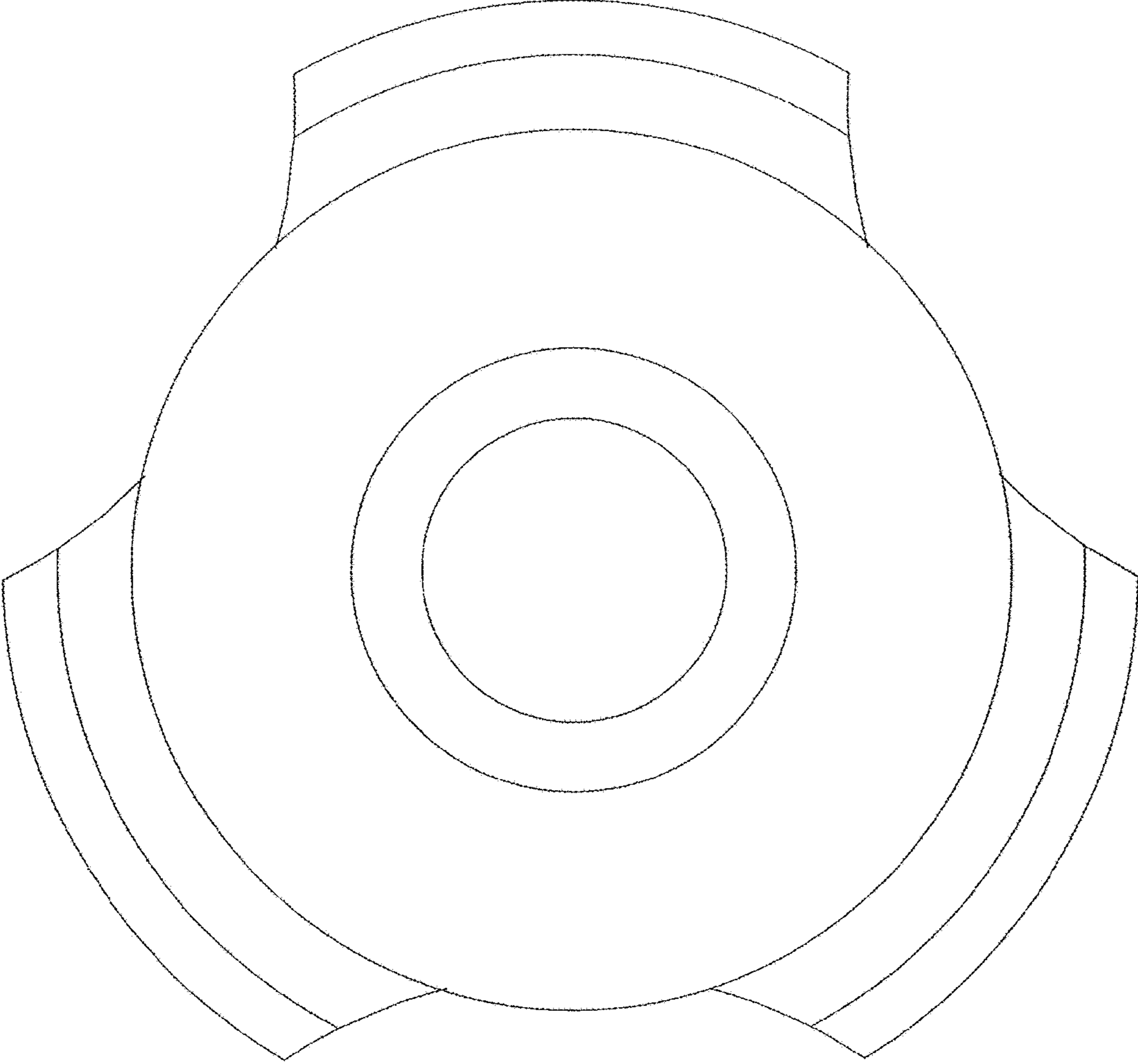

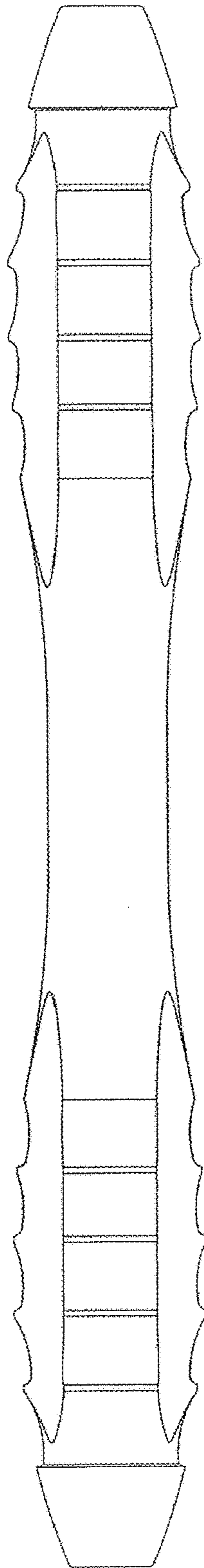

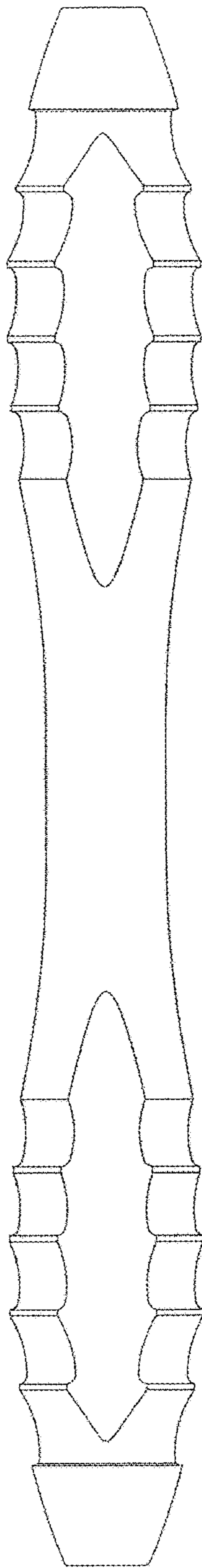

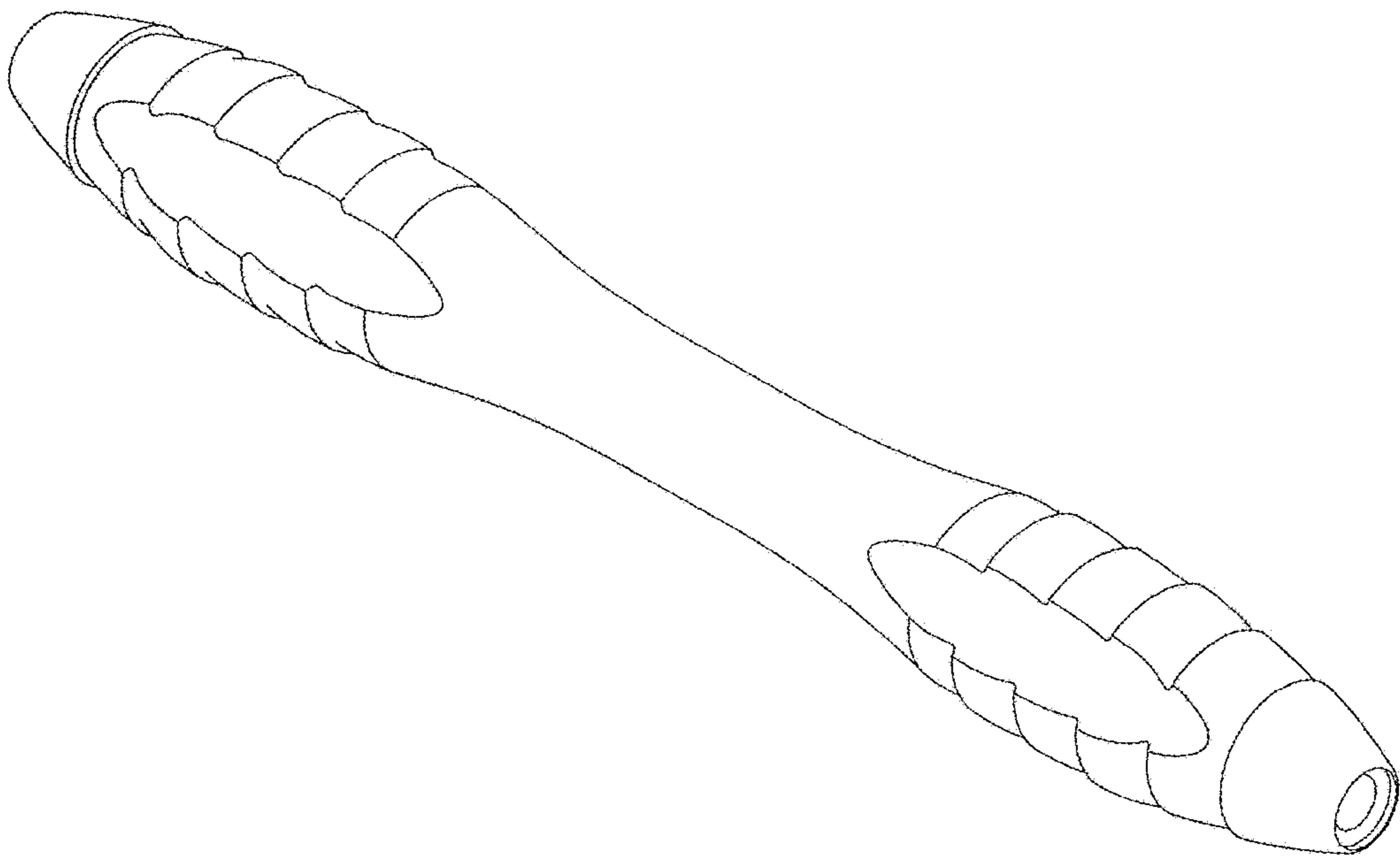

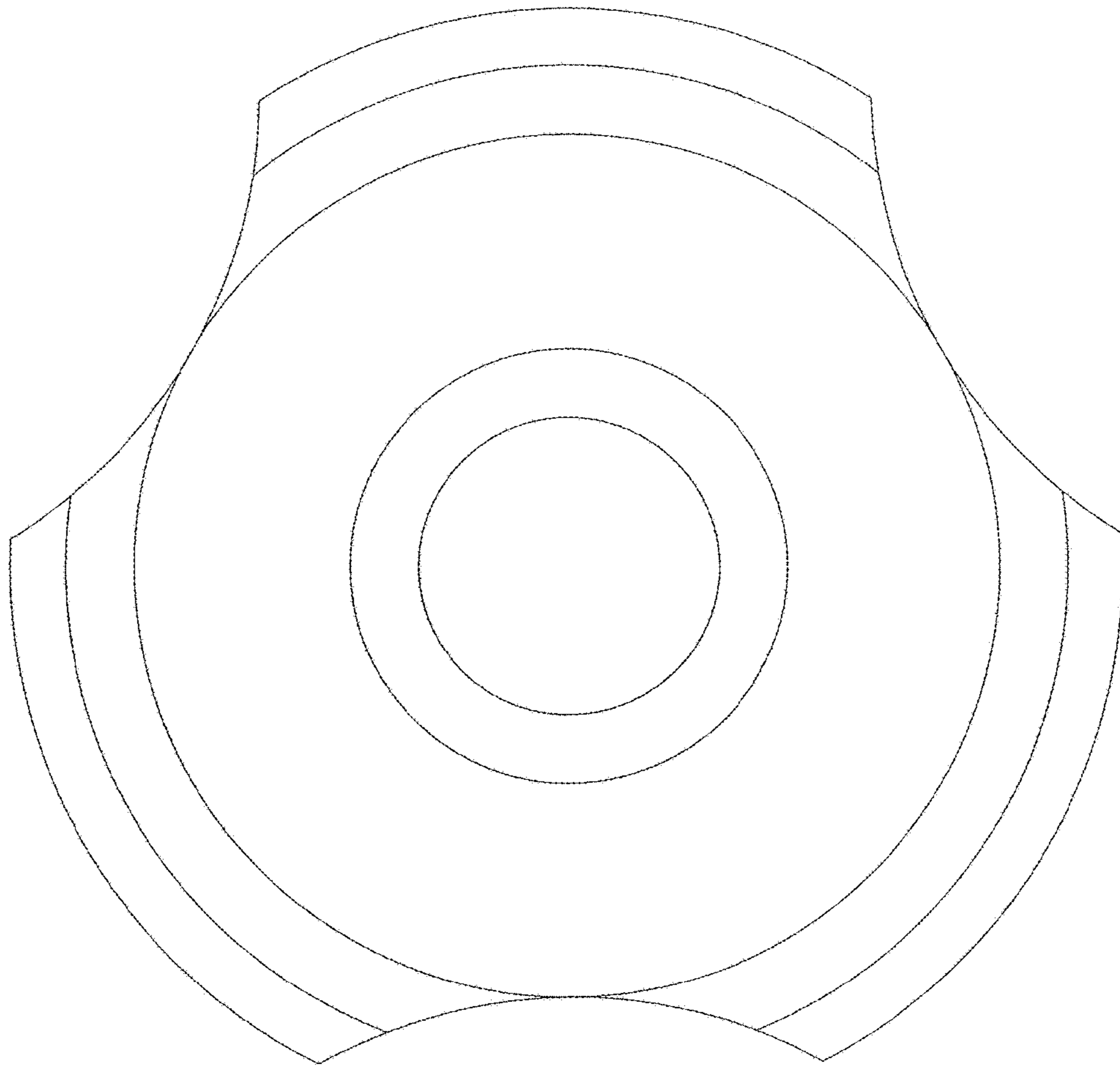

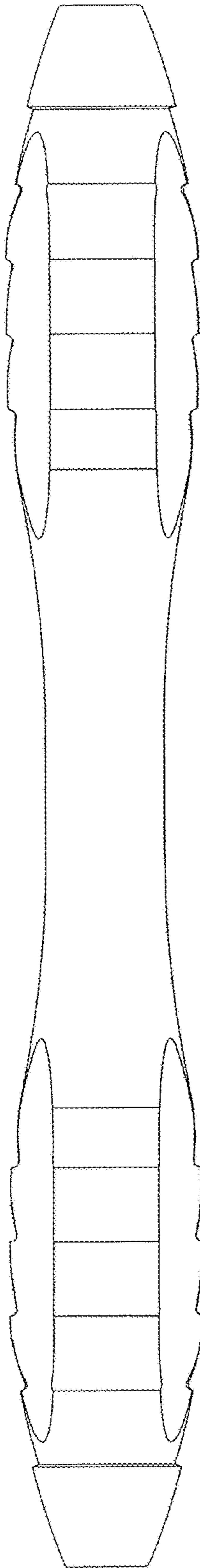

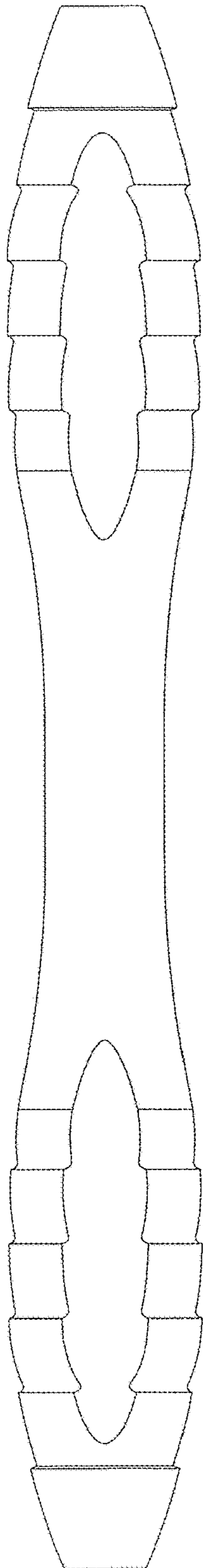

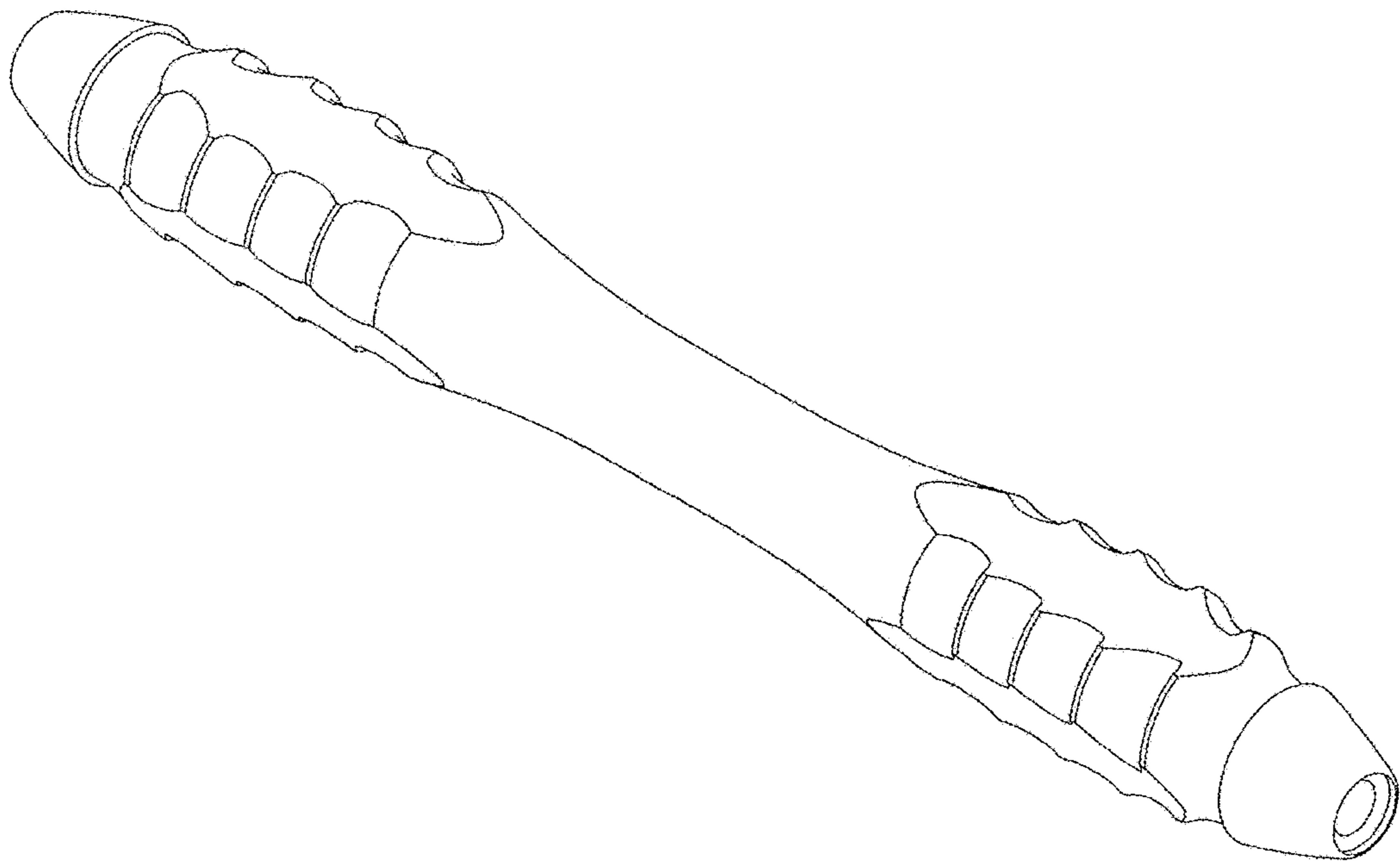

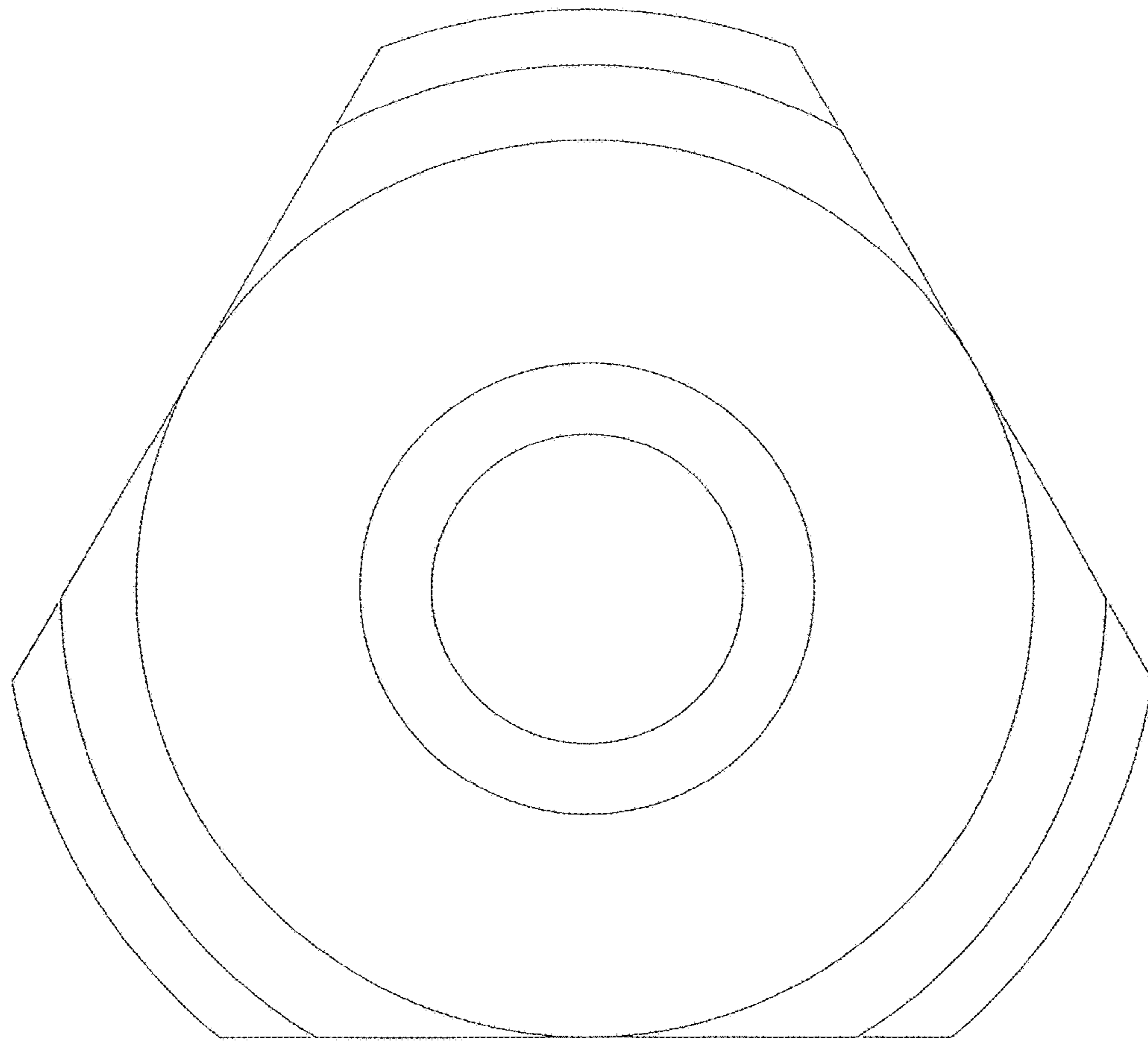

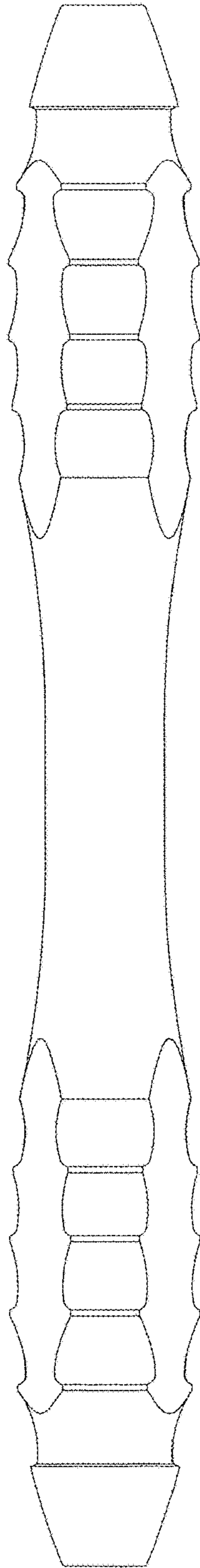

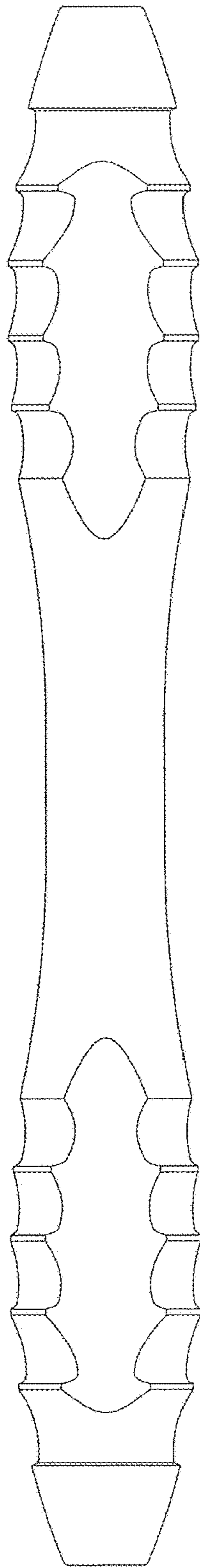

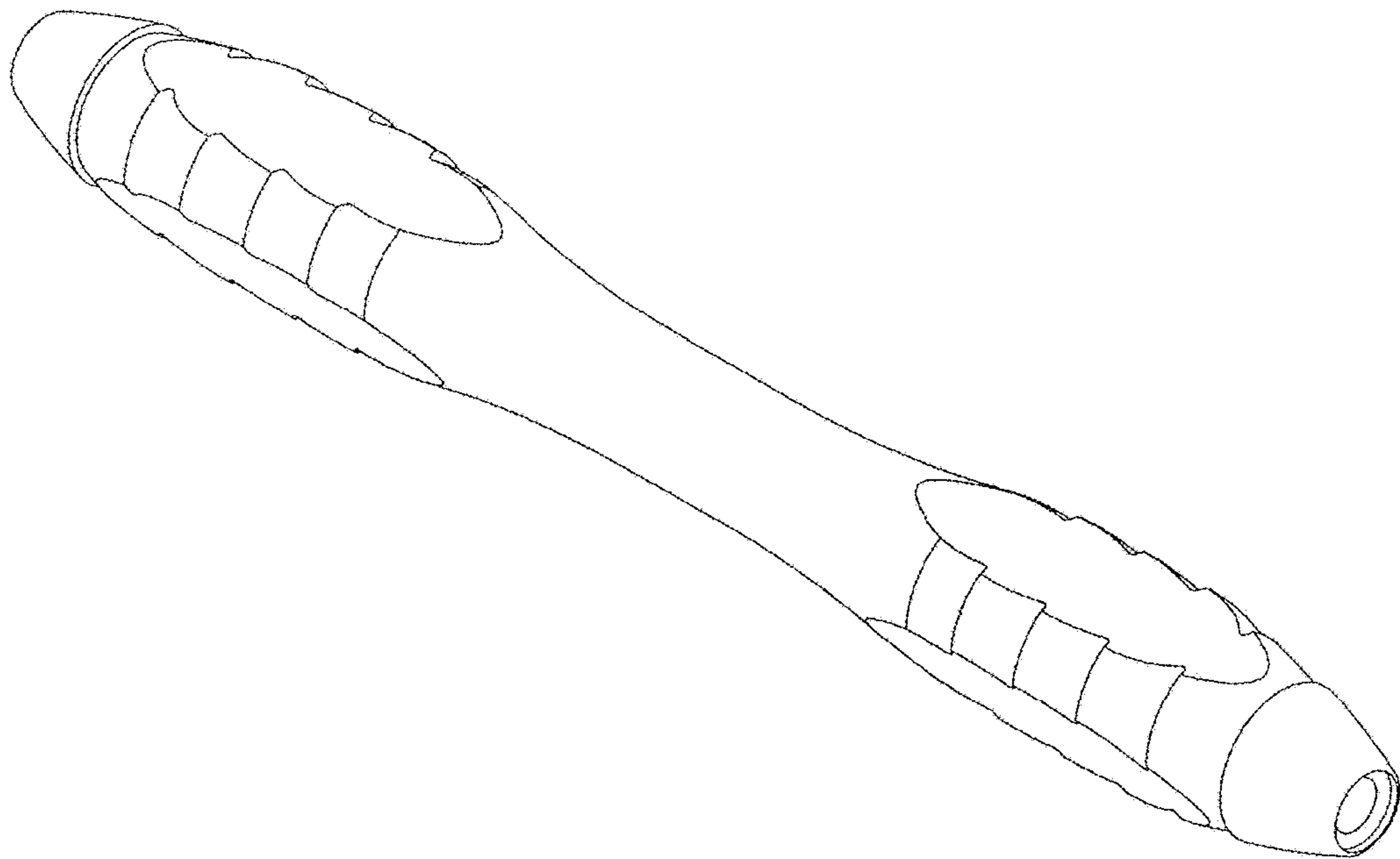

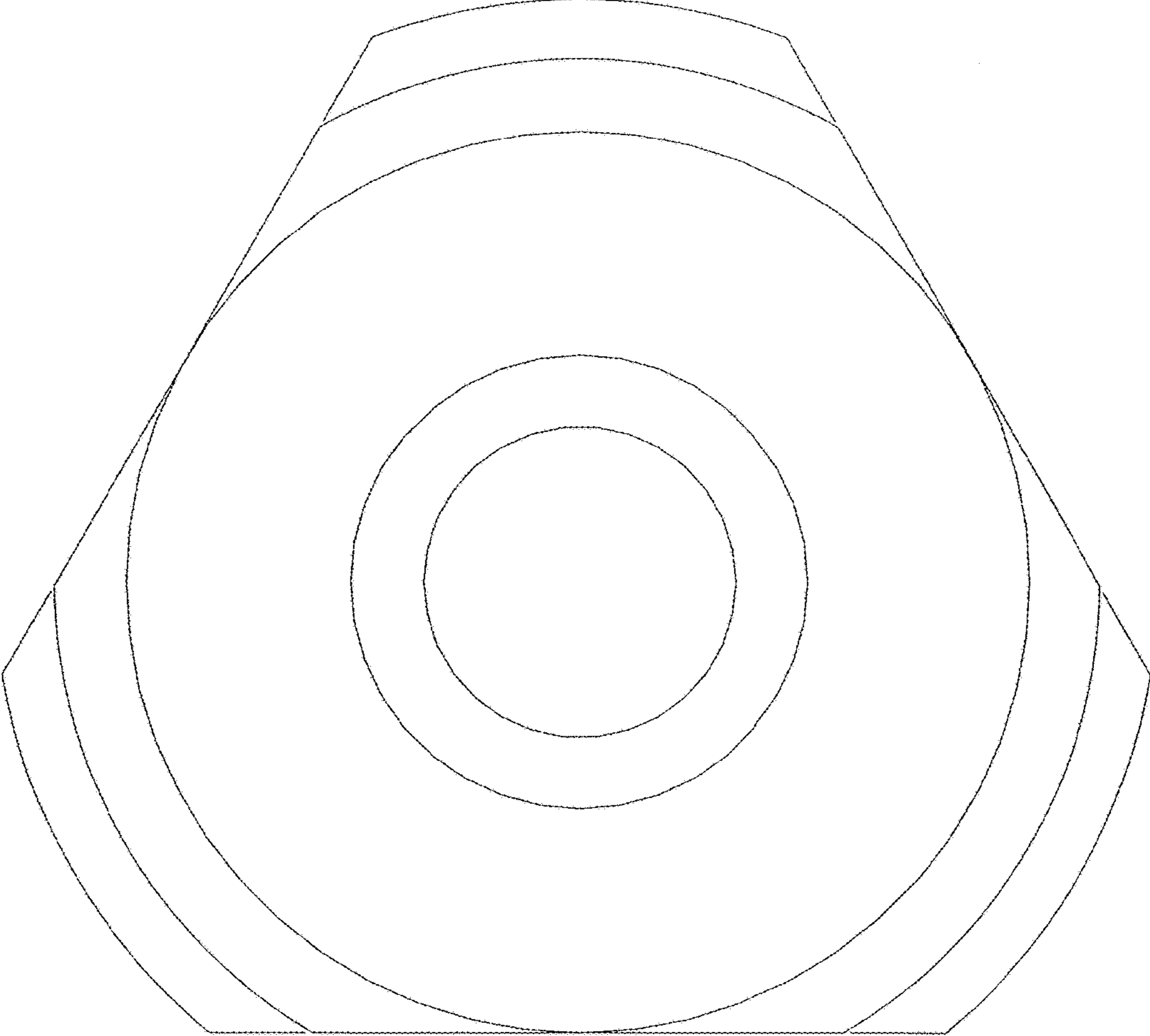

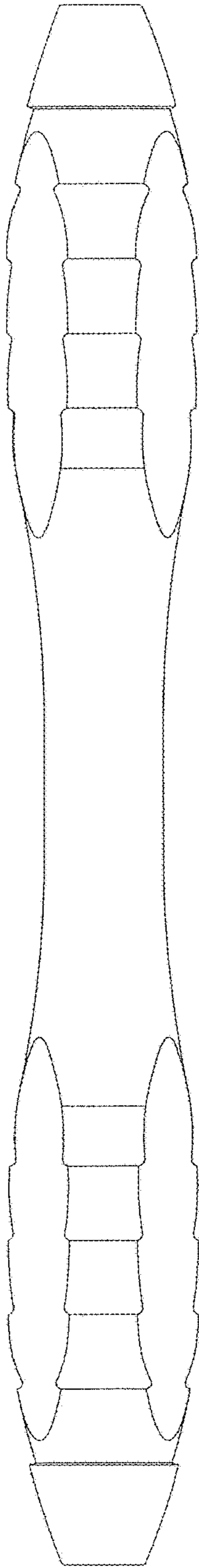

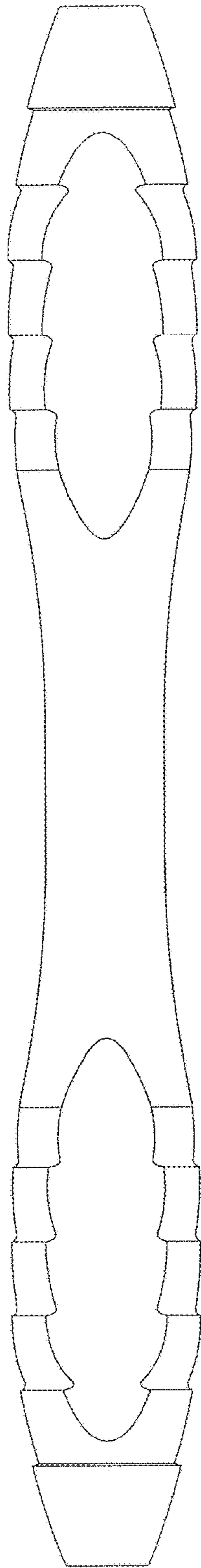
