lator of FIG. 1.

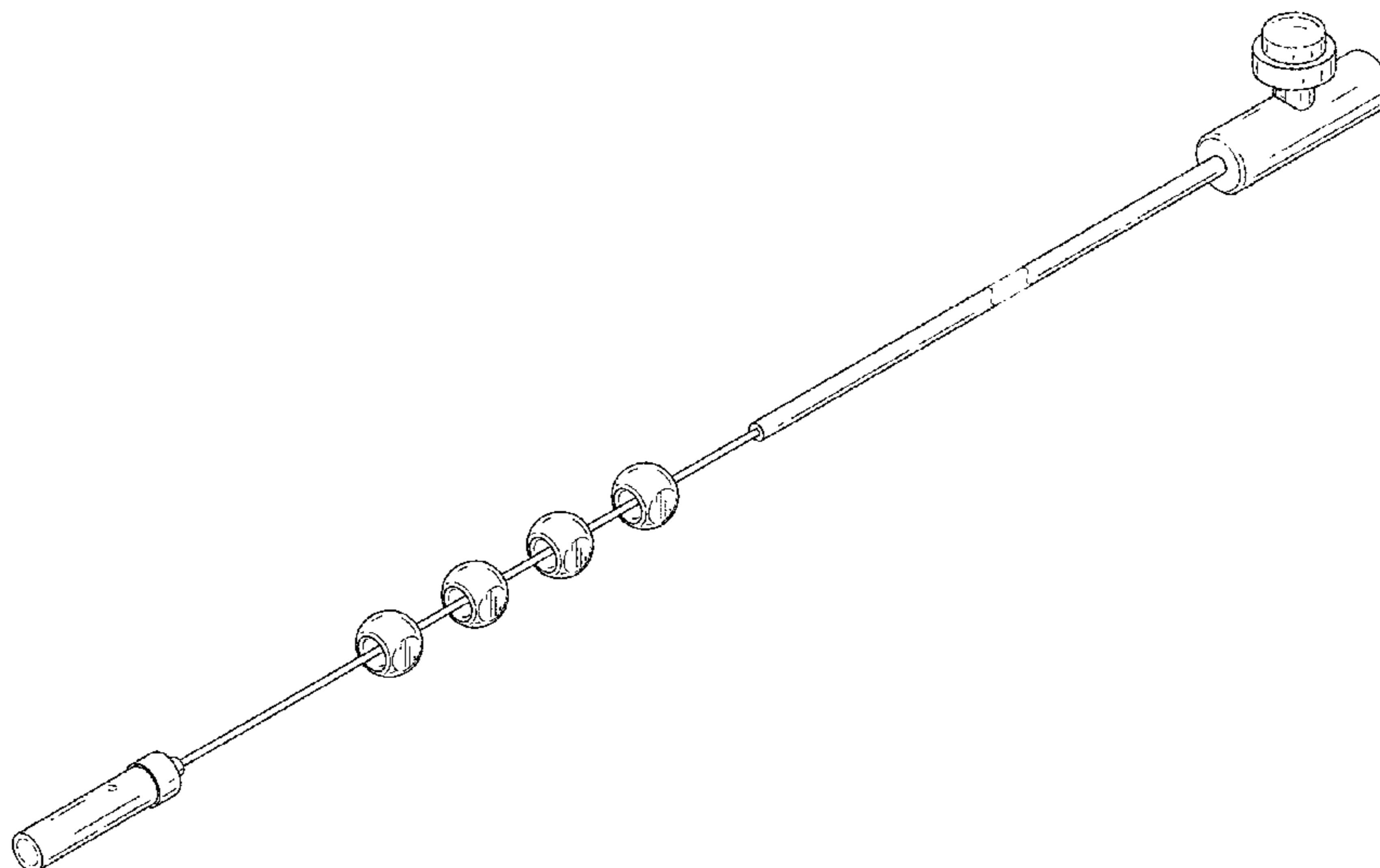
FIG. 6 is a top view of the sacrocolpopexy manipulator of

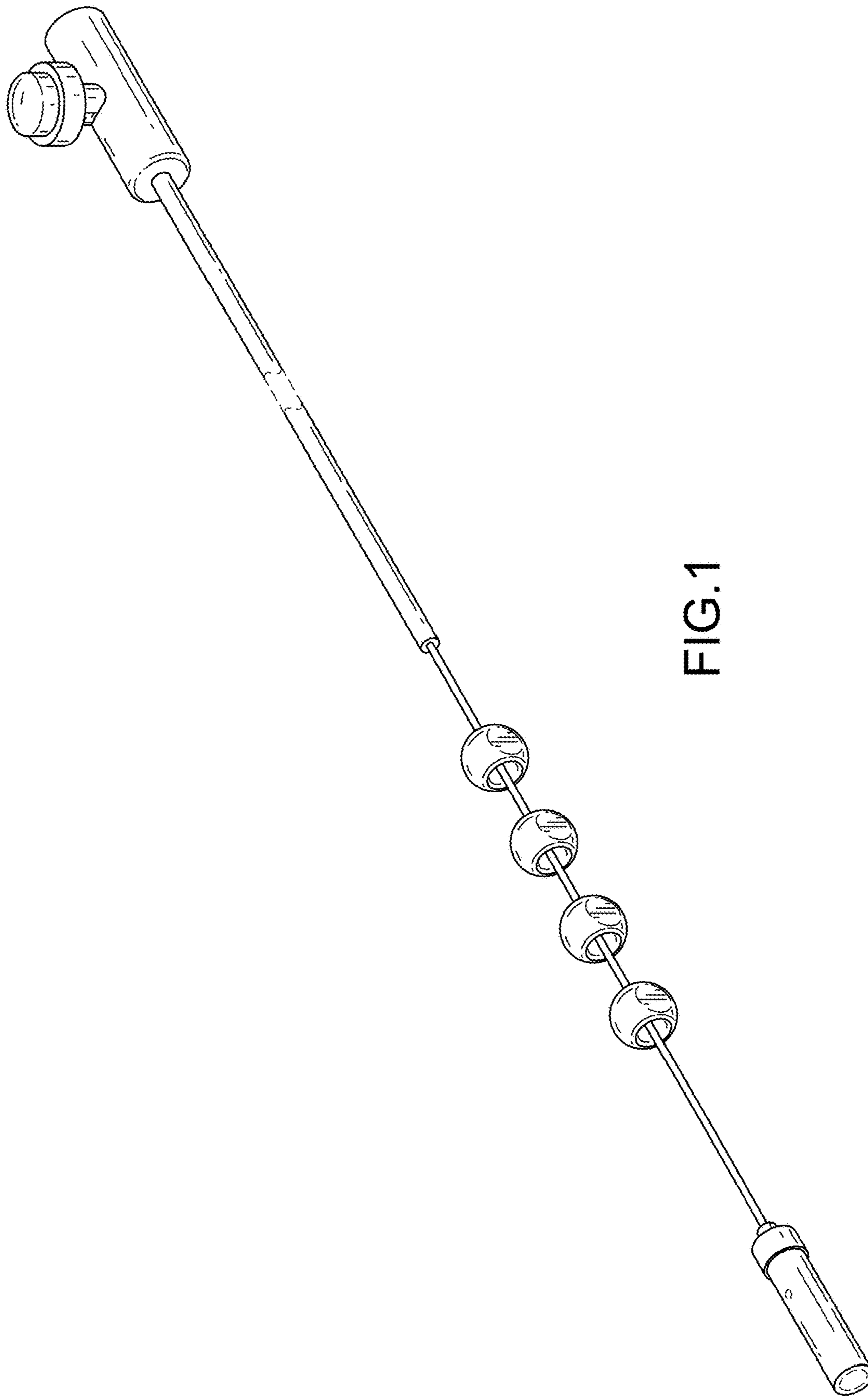

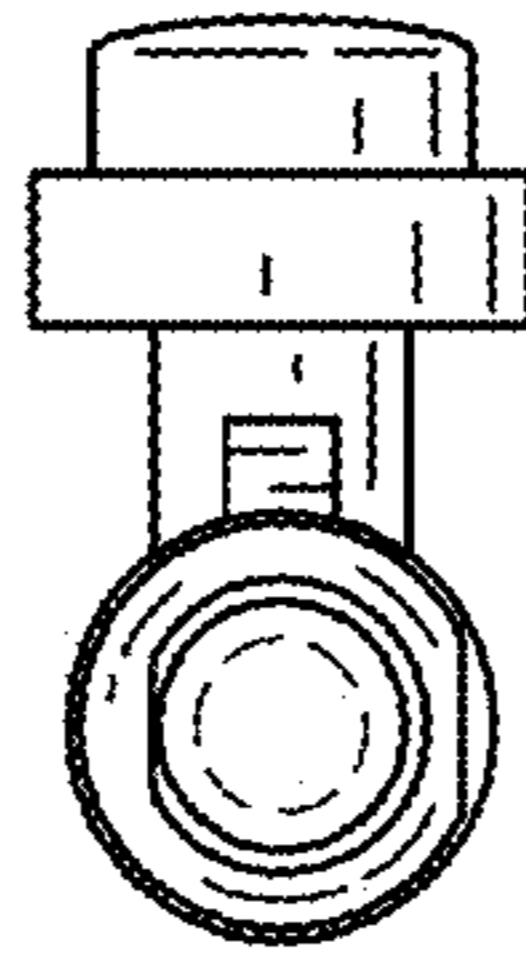

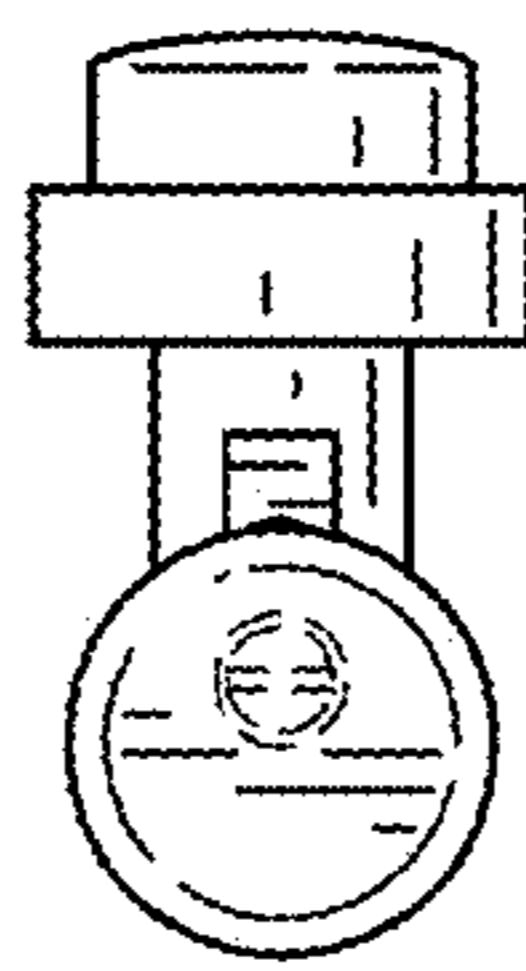

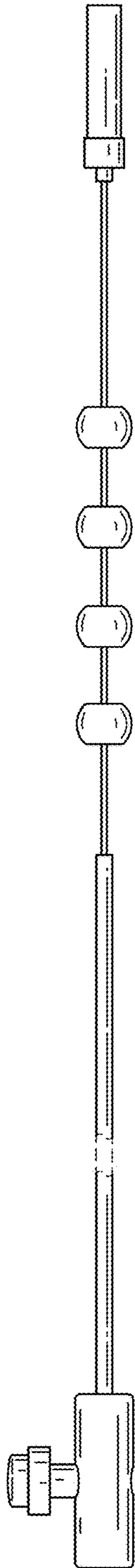

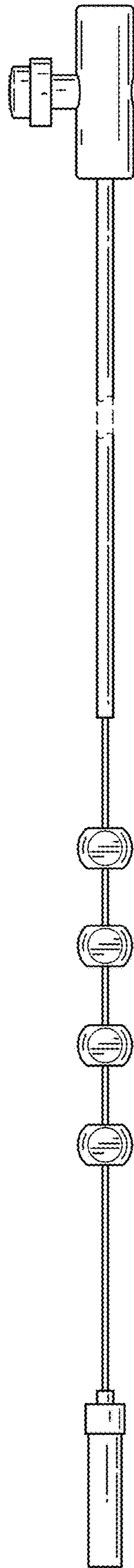

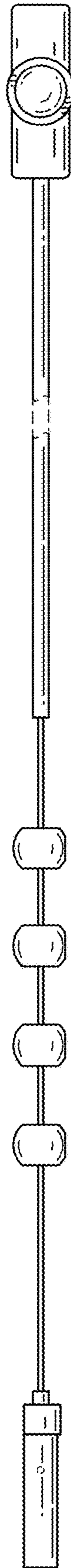

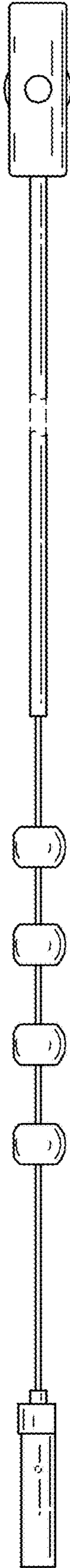
